The ornamental design for a beverage bottle, as shown and described.

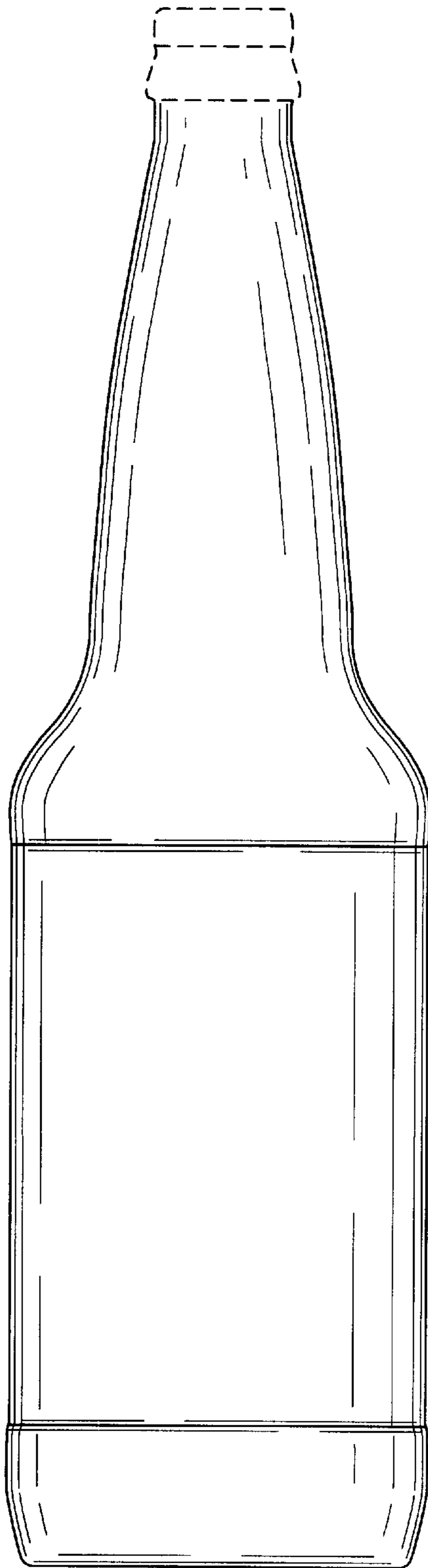
**DESCRIPTION**

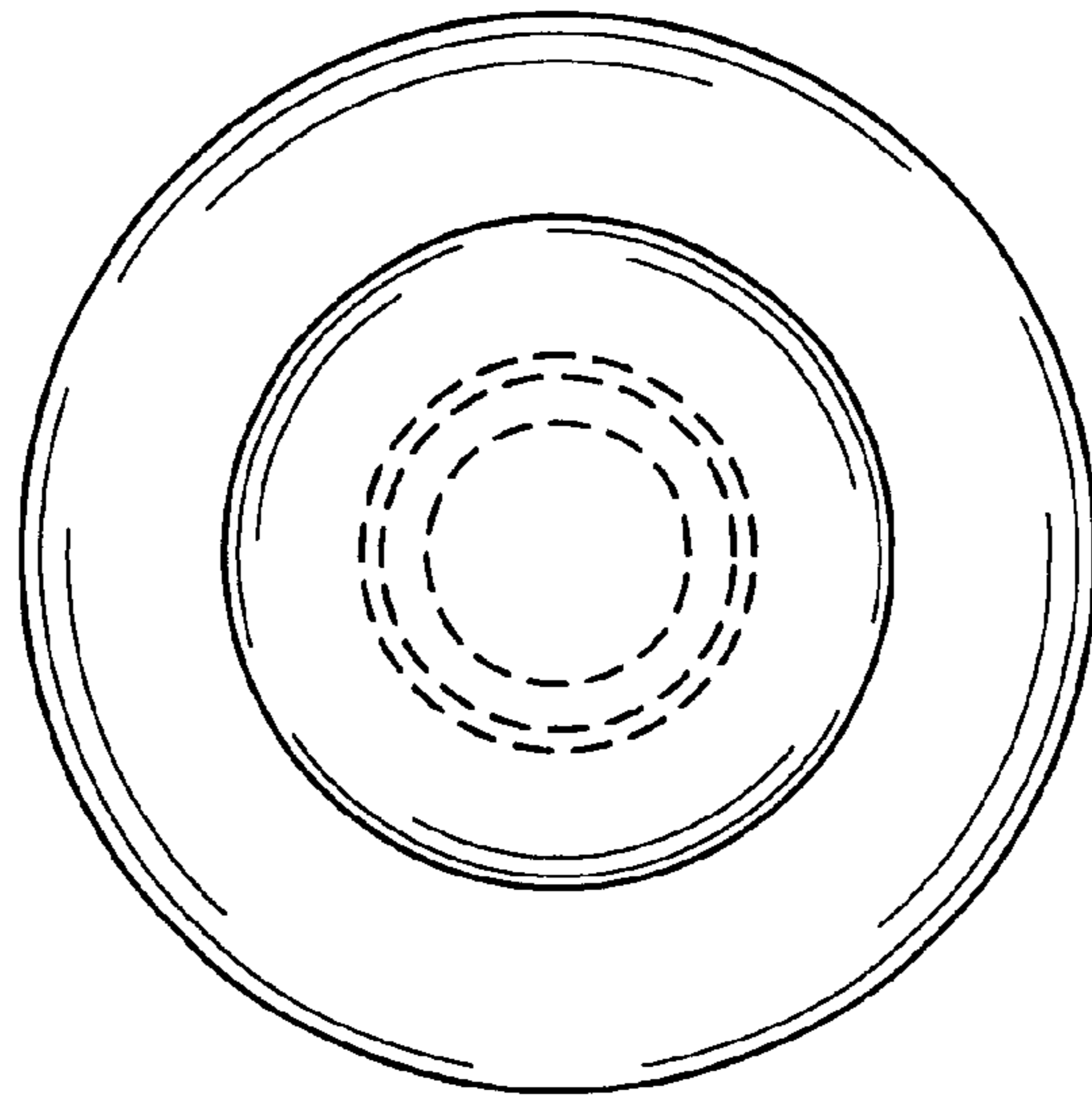
The broken lines shown in FIGS. 1-3 are for environmental purposes only and form no part of the claimed design.

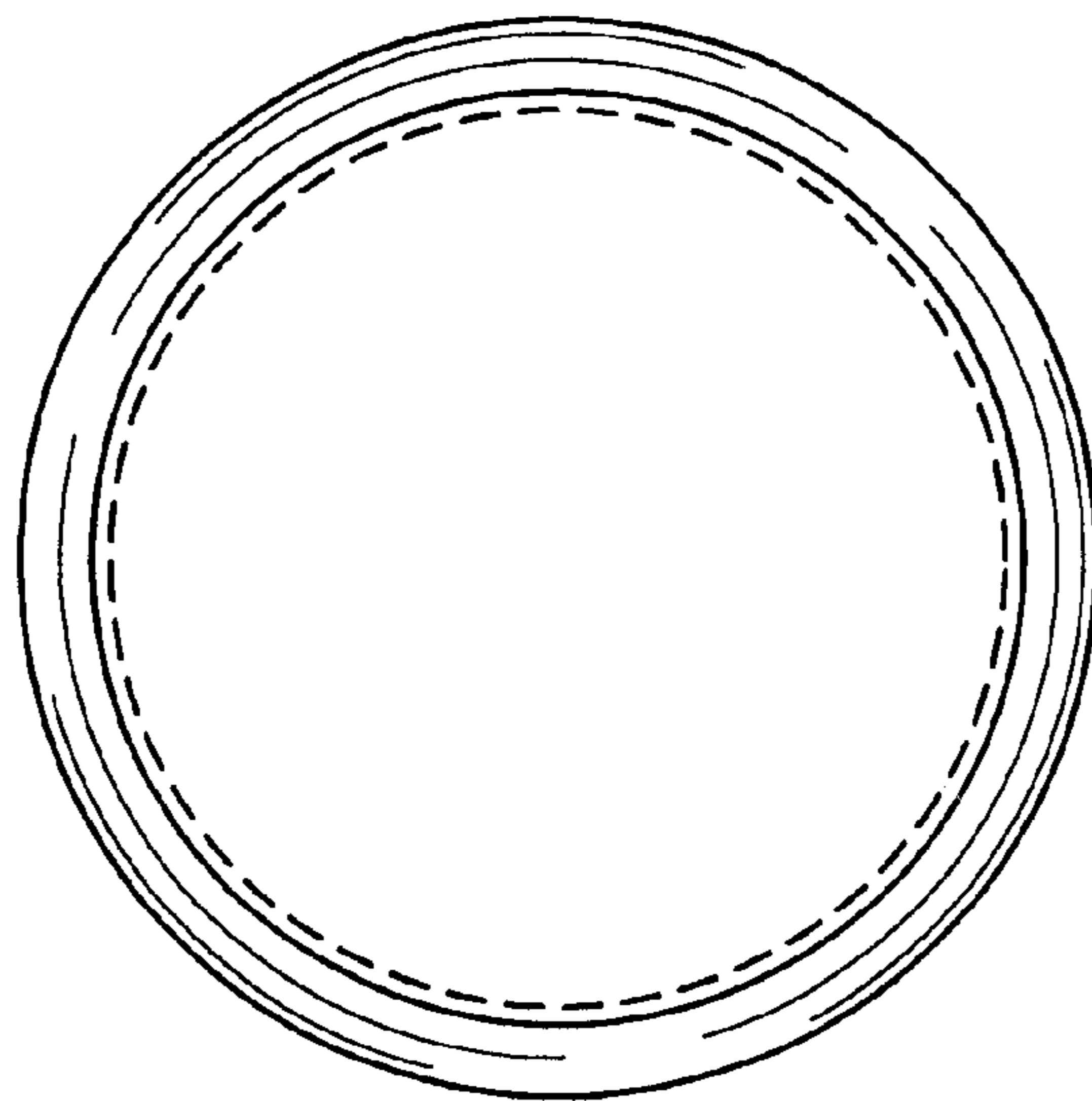
