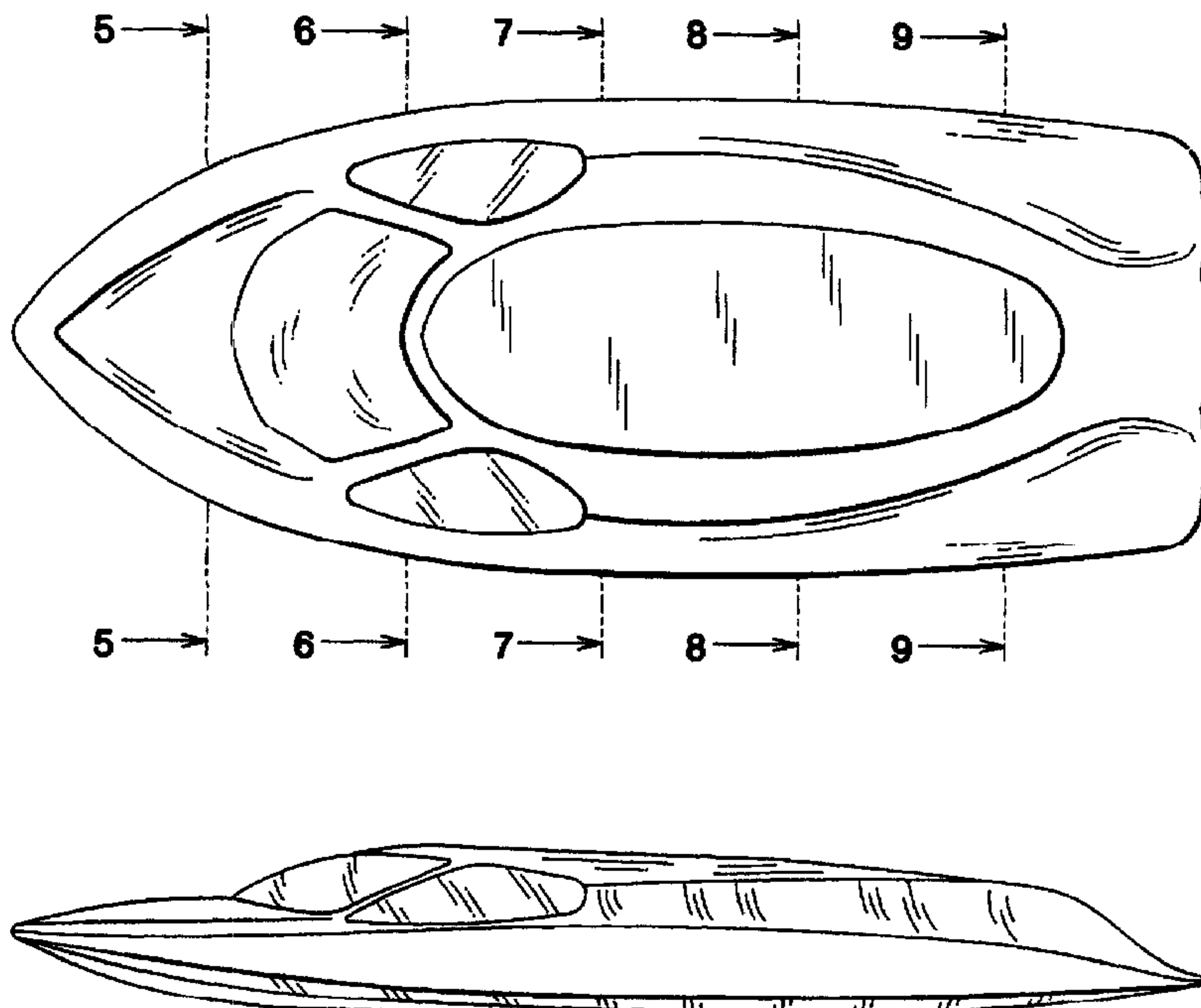
(57) **CLAIM**

I claim the ornamental design for a surface/underwater vehicle, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a surface/underwater vehicle showing my new design;
FIG. 2 is a side elevation view thereof;
FIG. 3 is a bottom plan view thereof;
FIG. 4 is a front elevation view thereof;
FIG. 5 is a sectional view taken along line 5—5 of FIG. 3;
FIG. 6 is a sectional view taken along line 6—6 of FIG. 3;
FIG. 7 is a sectional view taken along line 7—7 of FIG. 3;
FIG. 8 is a sectional view taken along line 8—8 of FIG. 3;
FIG. 9 is a sectional view taken along line 9—9 of FIG. 3; and,
FIG. 10 is a rear elevation view thereof.

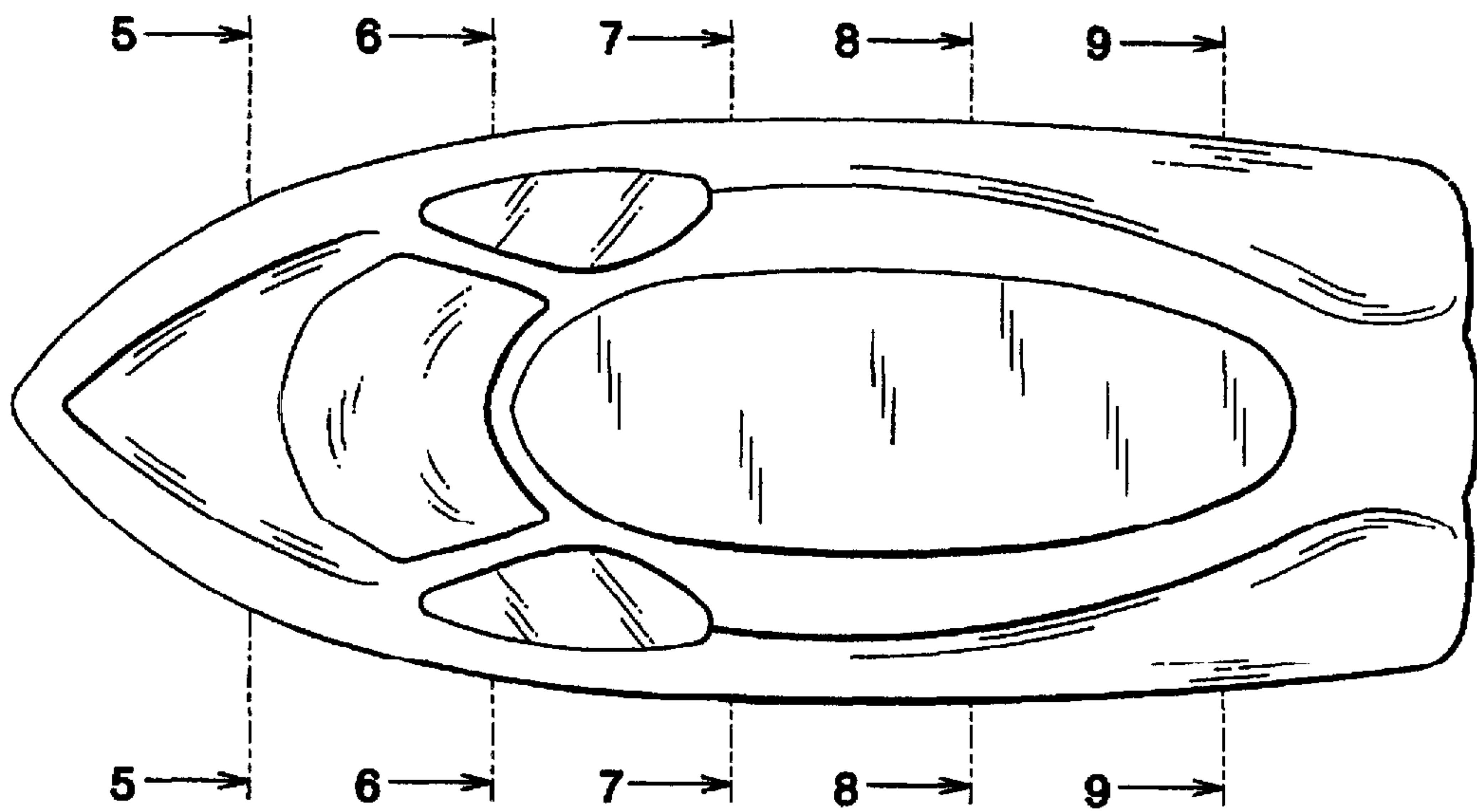

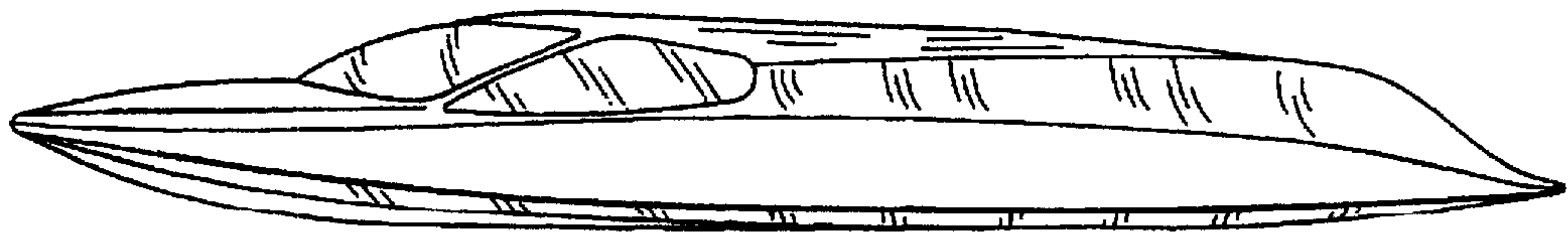

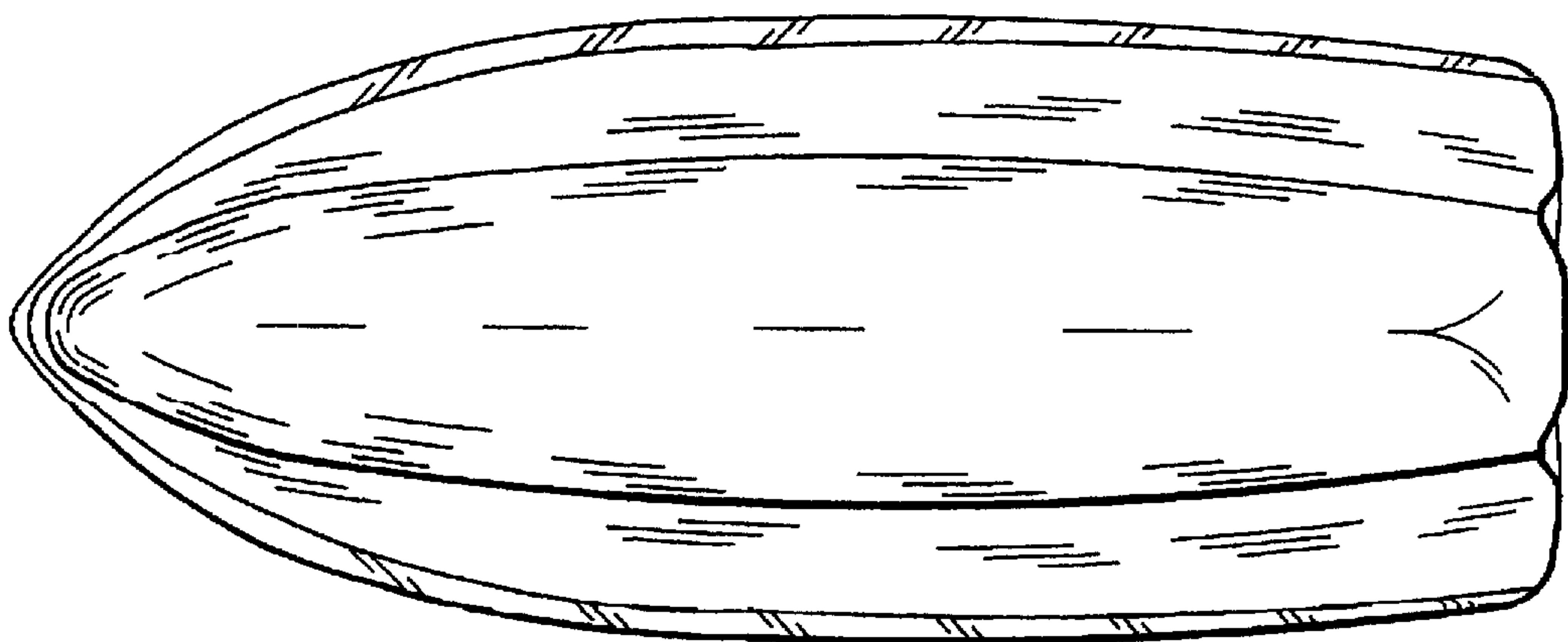

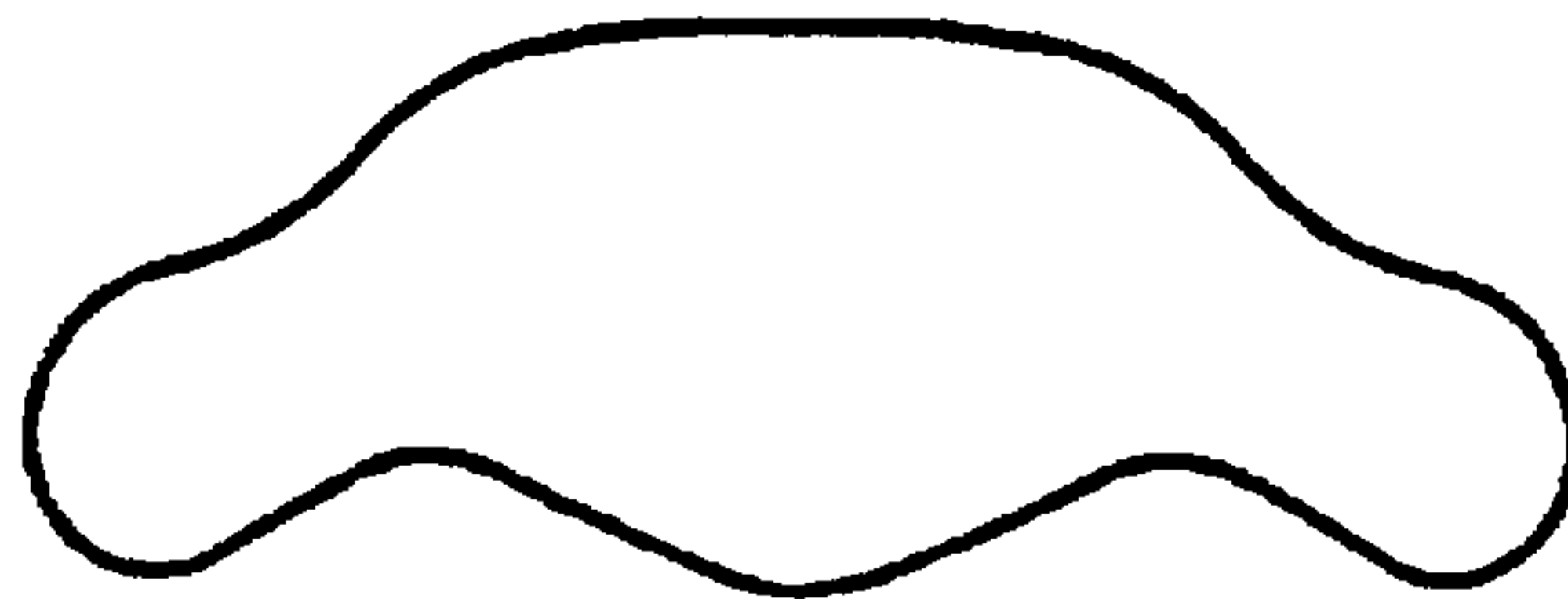

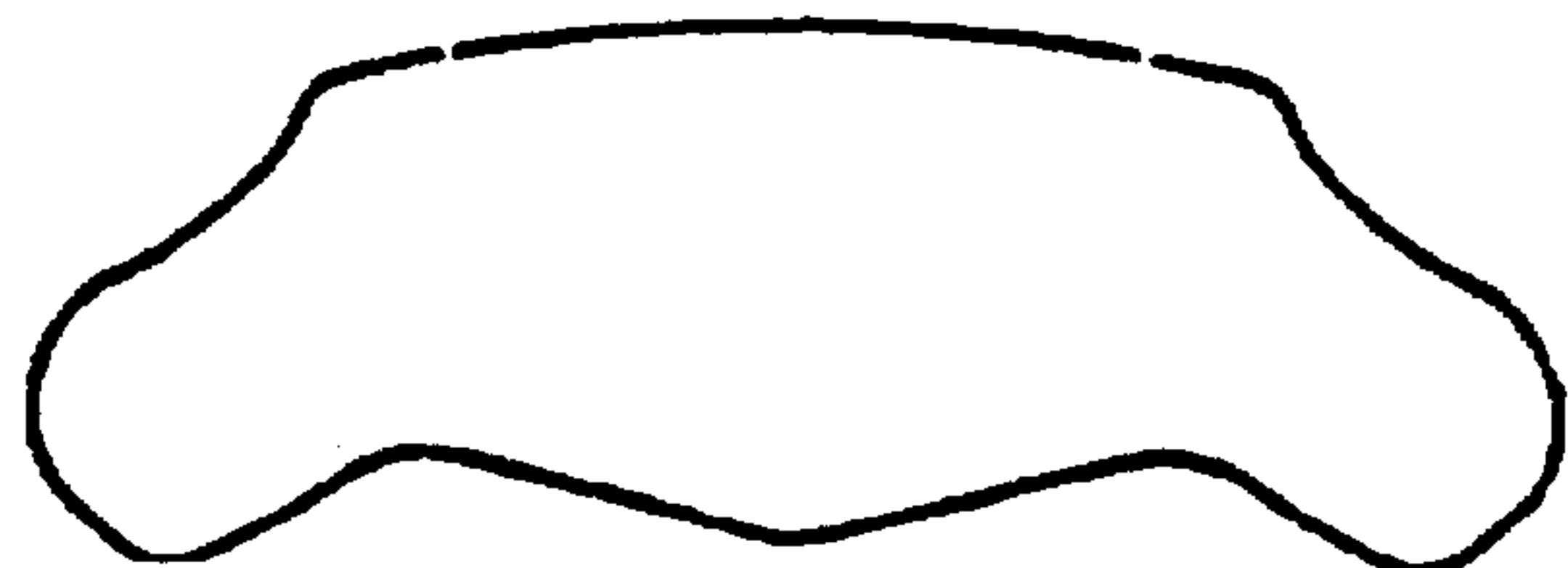

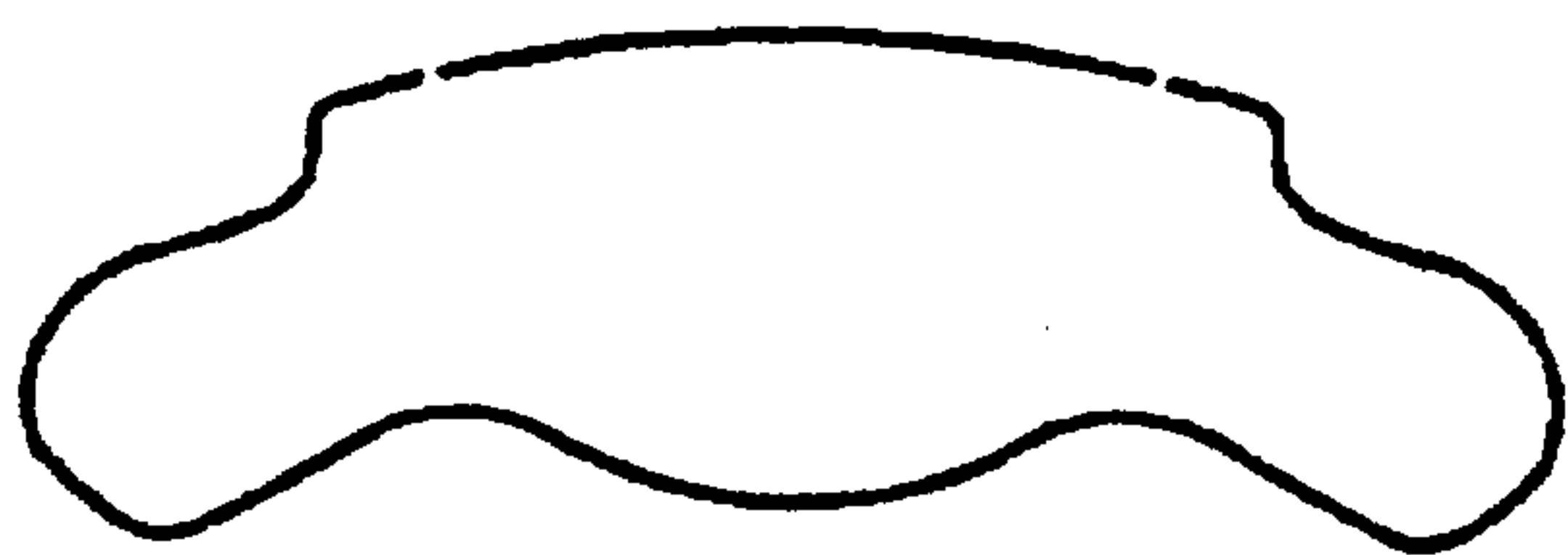

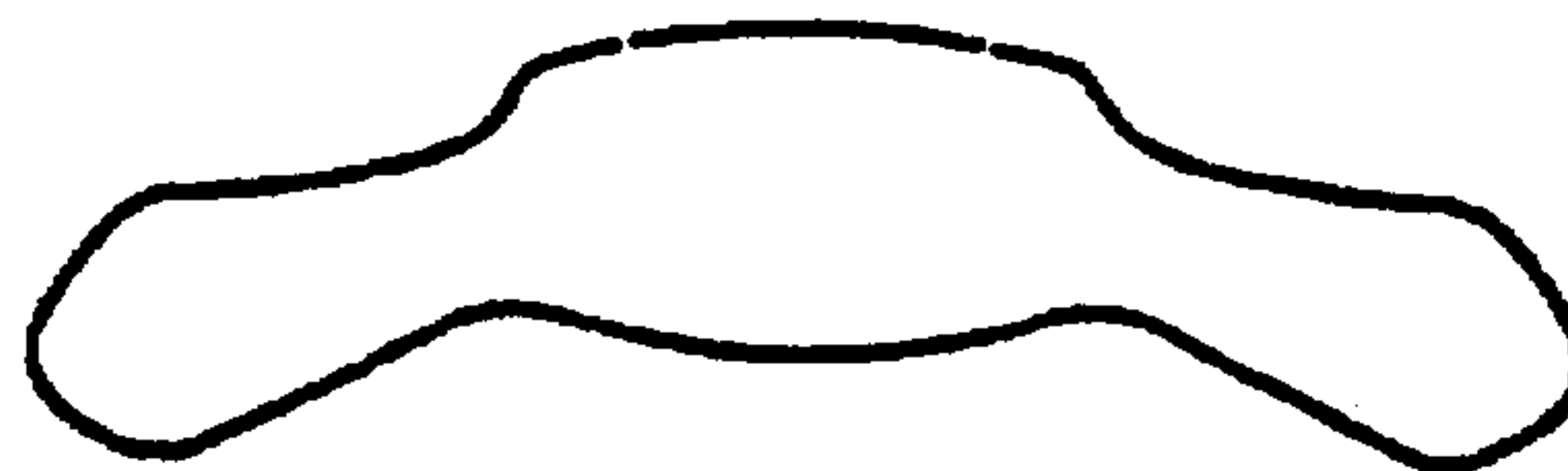

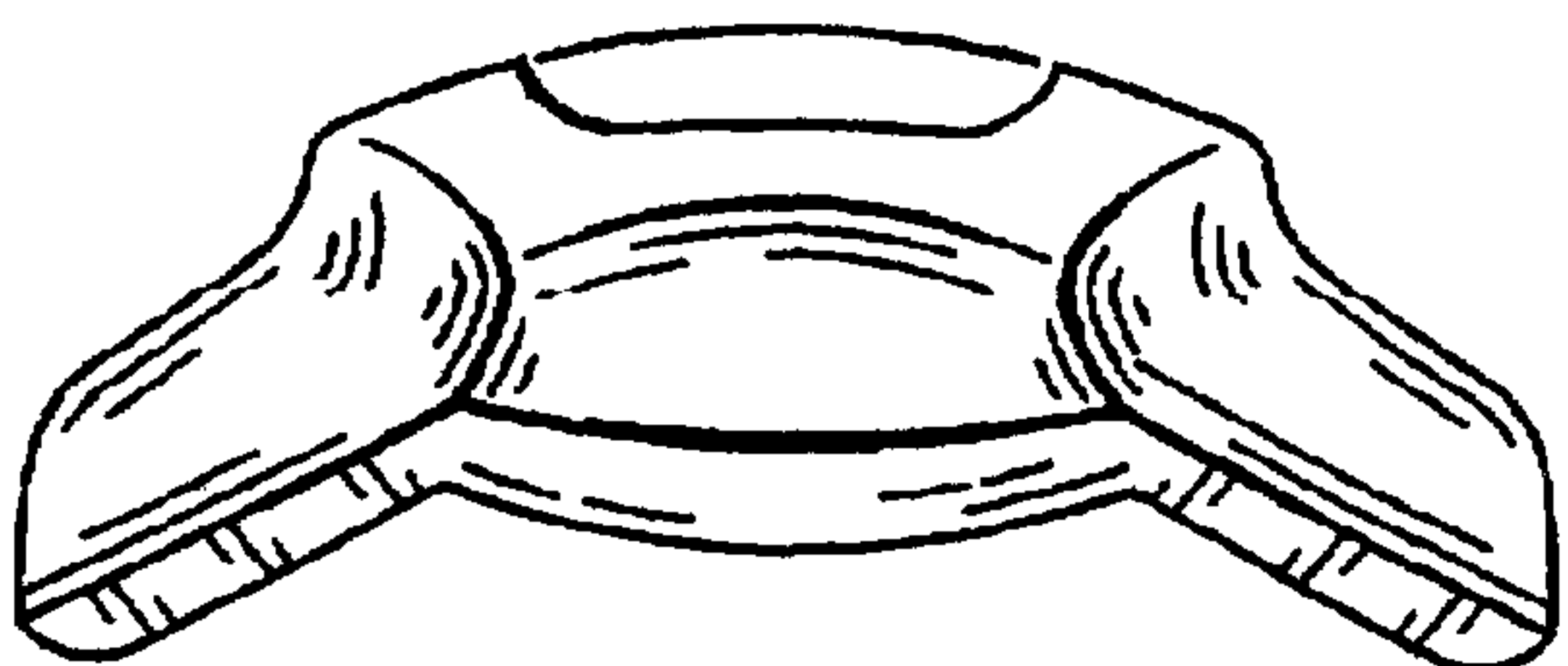
