FIG. 1 is a perspective view of the battery showing the new design.

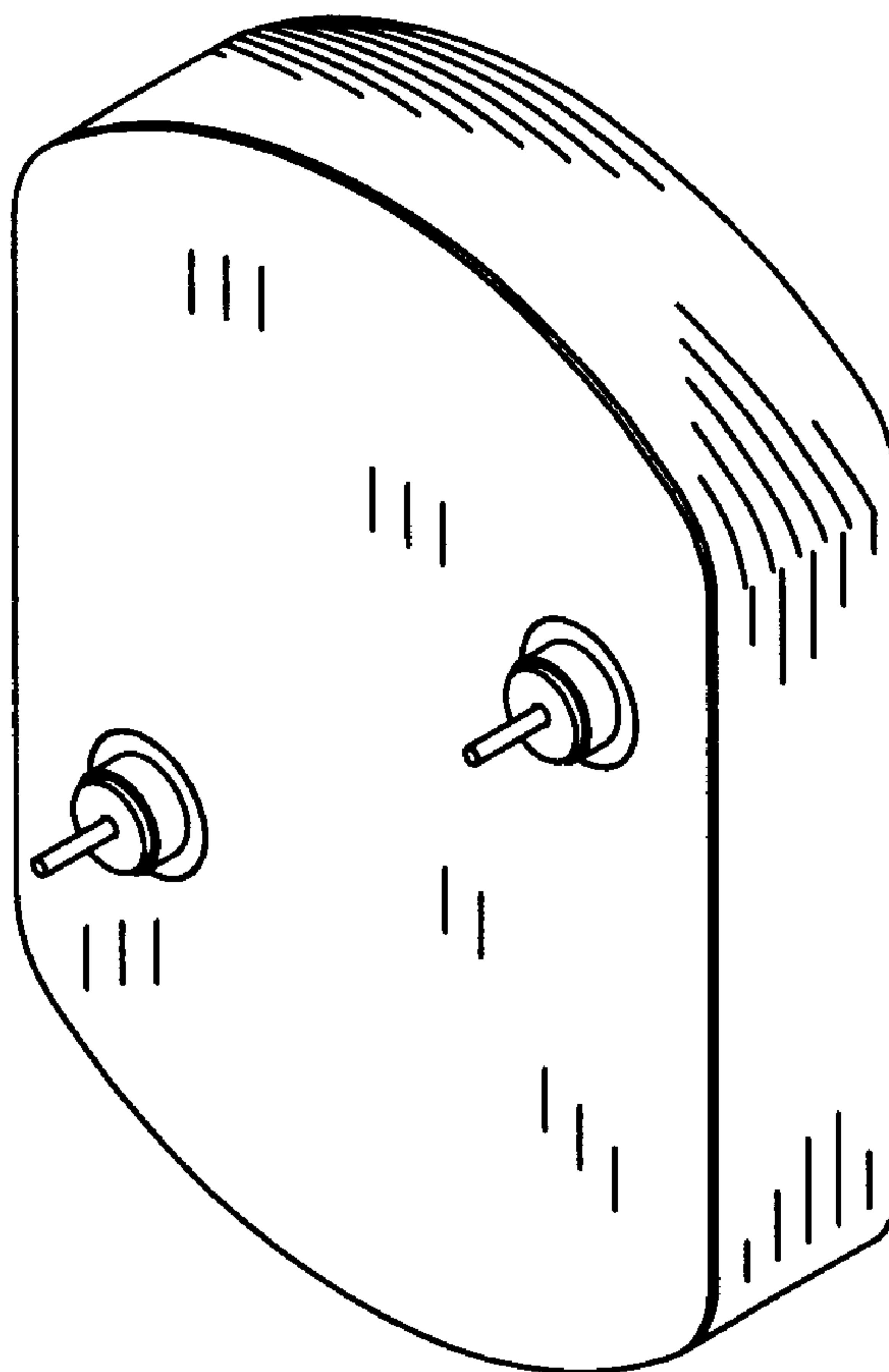
FIG. 2 is a front view of the battery.

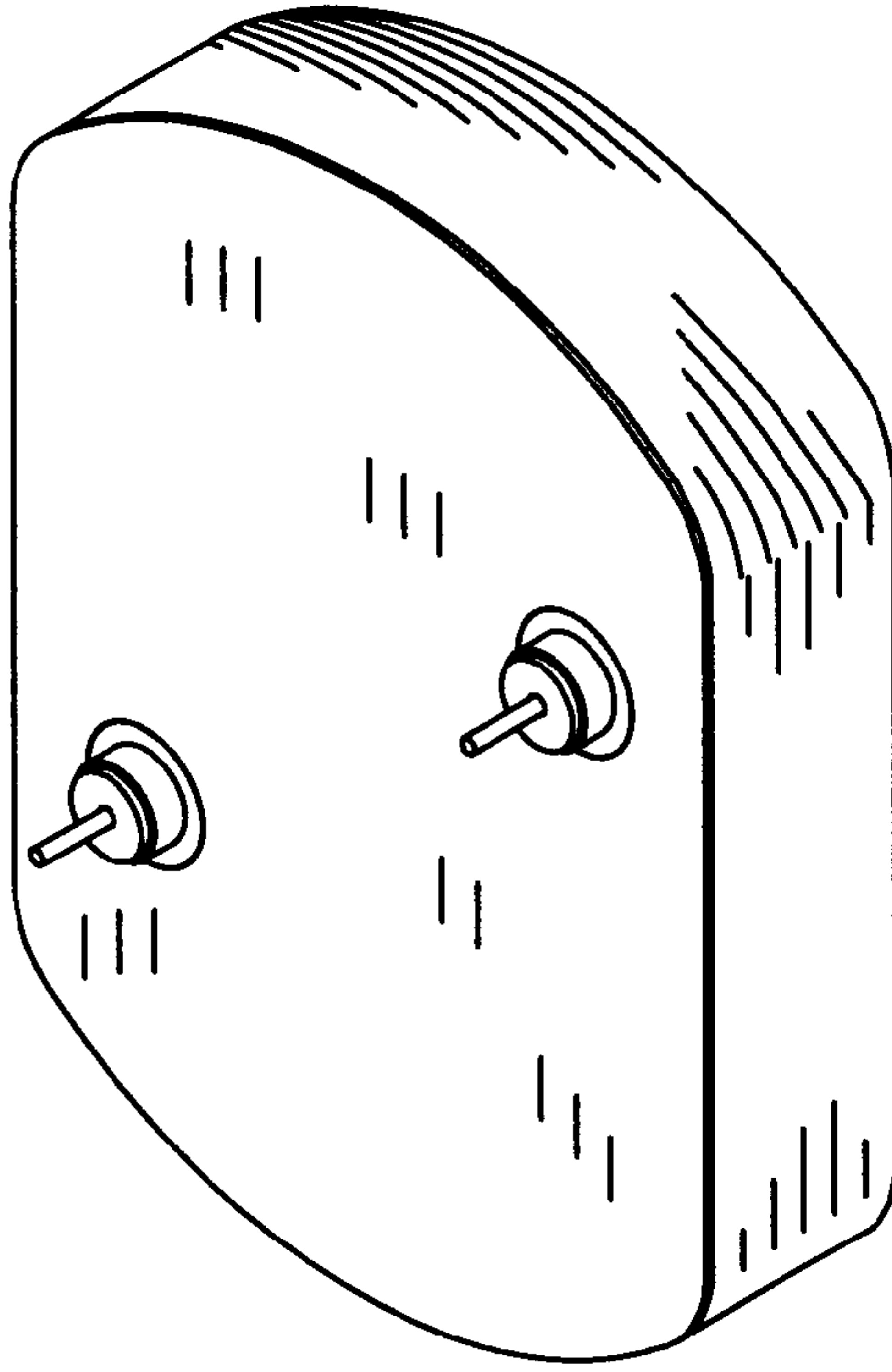

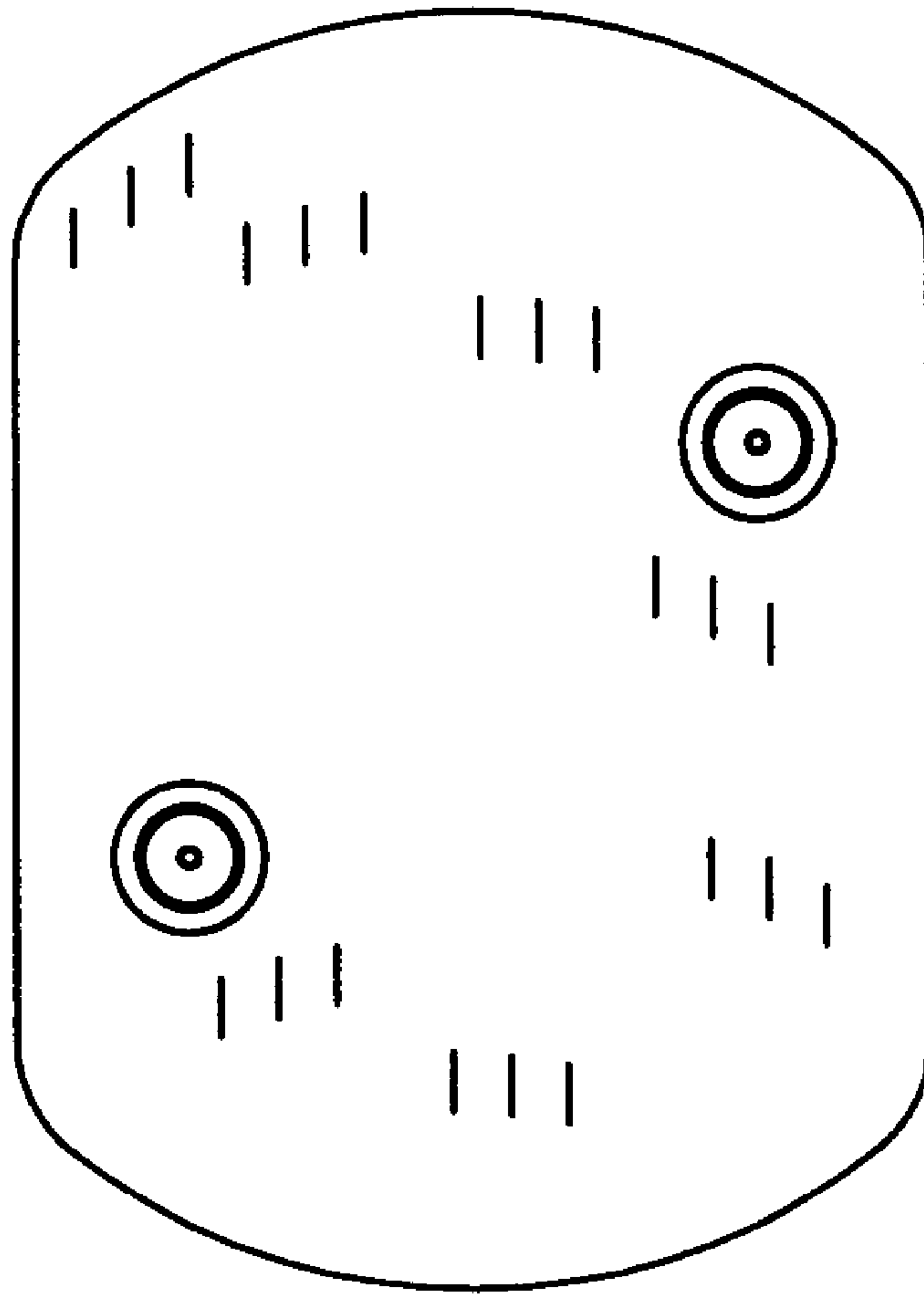

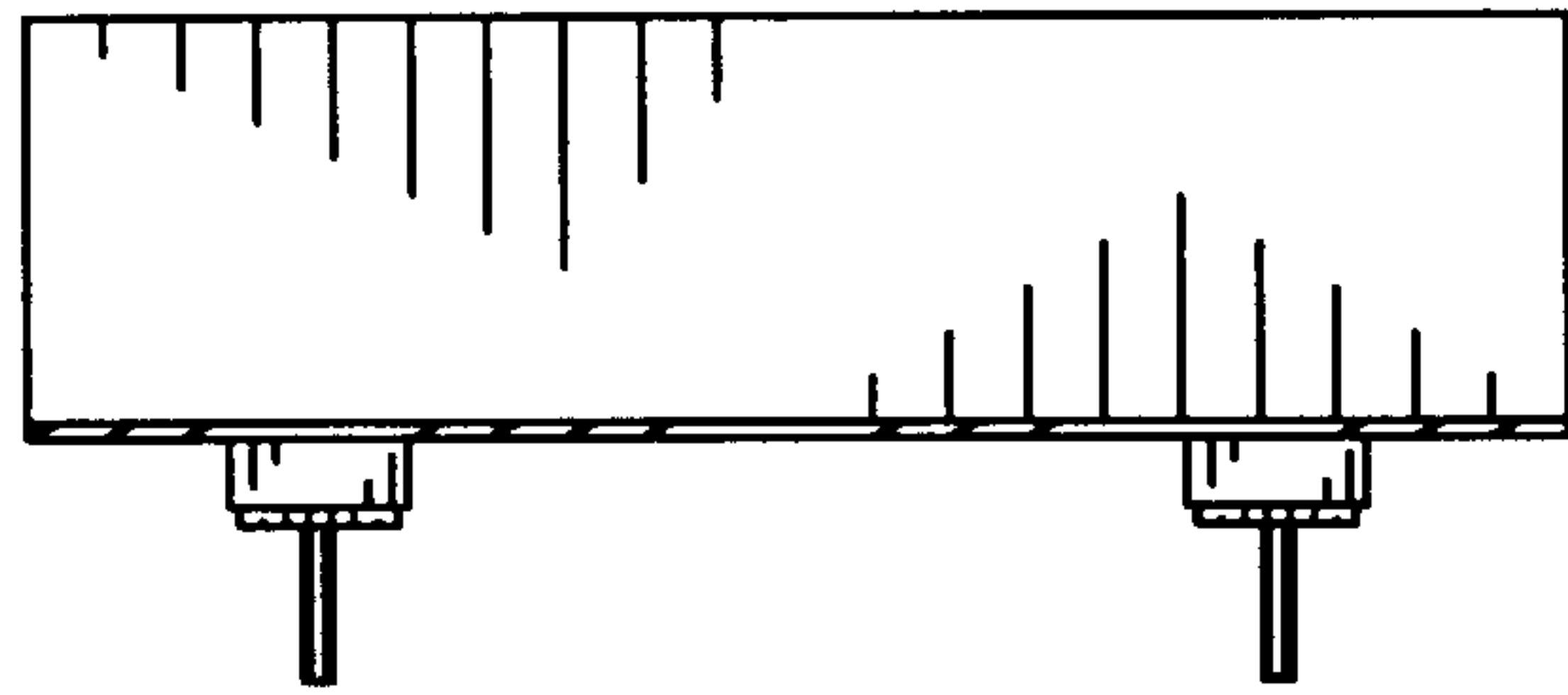

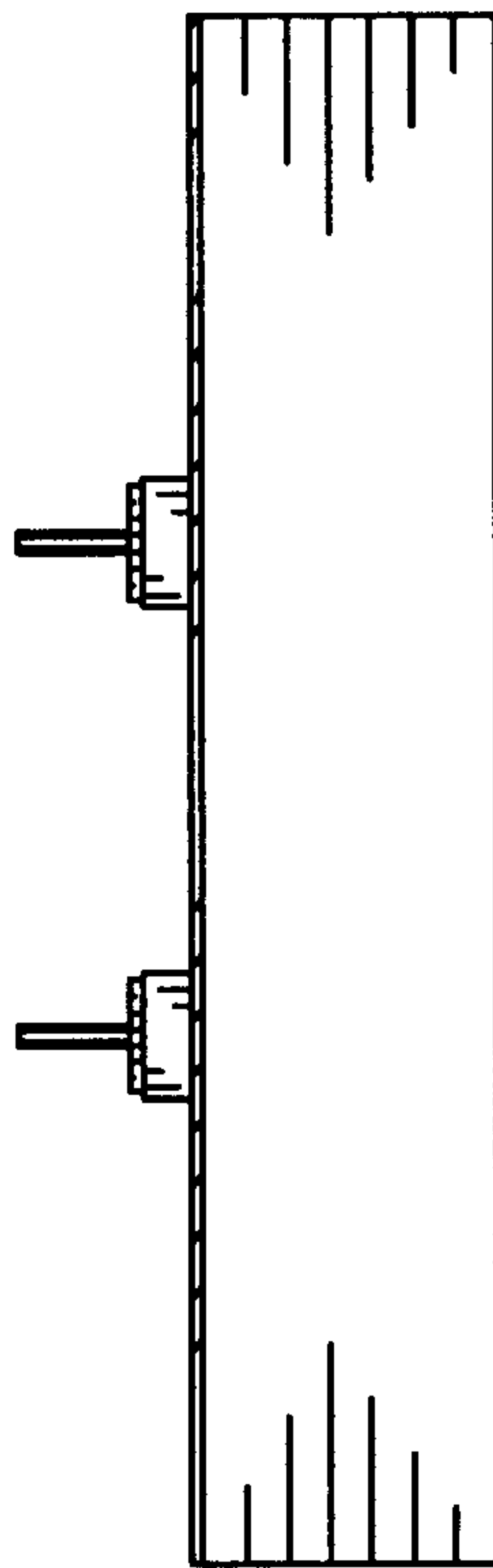

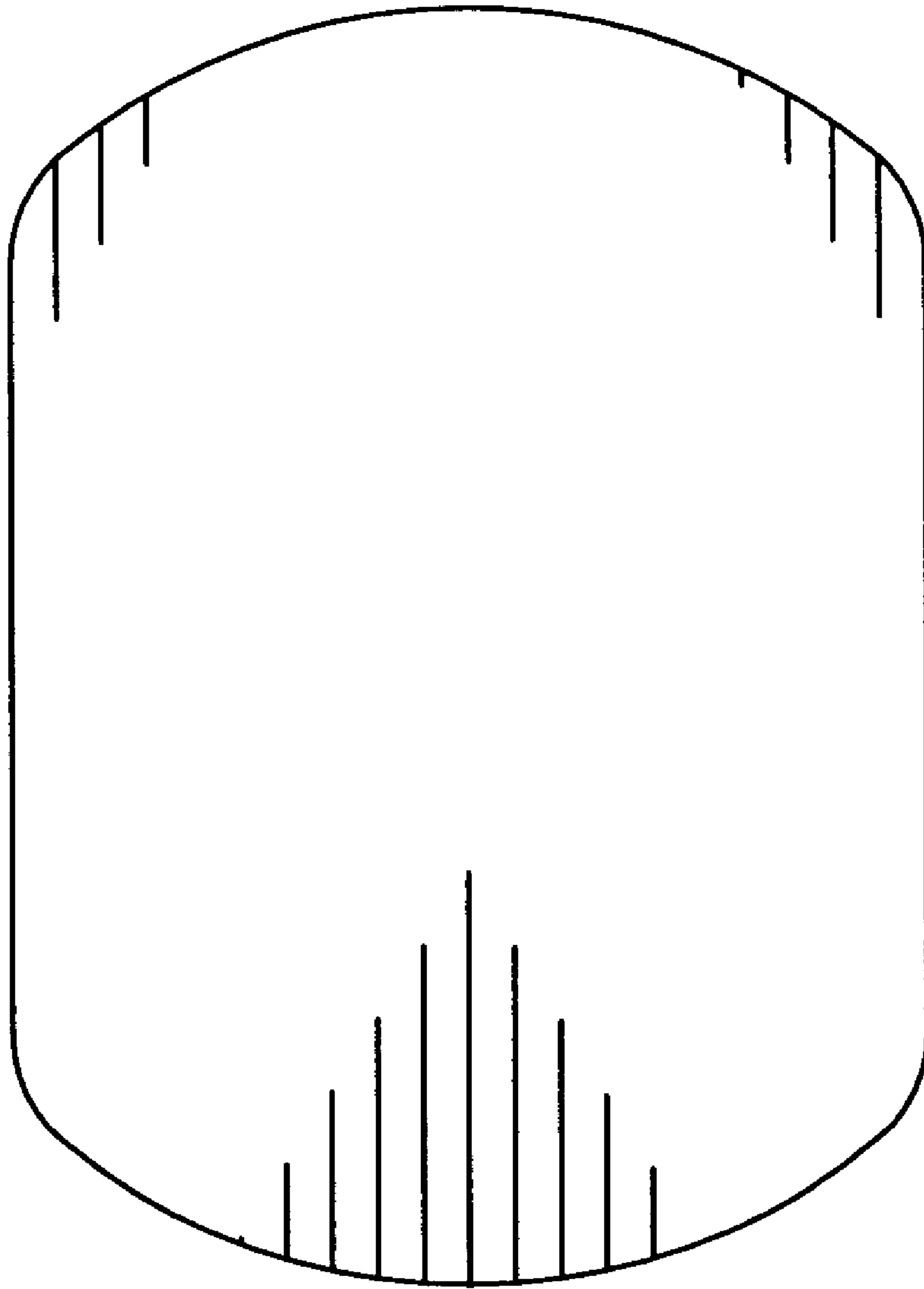
