(57) **CLAIM**

The ornamental design for a steam iron, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, top and left side perspective view of a steam iron showing my new design;

FIG. 2 is a rear, top and right side perspective view thereof;

FIG. 3 is a right side elevational view thereof;

FIG. 4 is a top plan view thereof;

FIG. 5 is a front elevational view thereof;

FIG. 6 is a rear elevational view thereof;

FIG. 7 is a front, top and left side perspective view of a second embodiment of a steam iron showing my new design;

FIG. 8 is a rear, top and right side perspective view thereof;

FIG. 9 is a right side elevational view thereof;

FIG. 10 is a top plan view thereof;

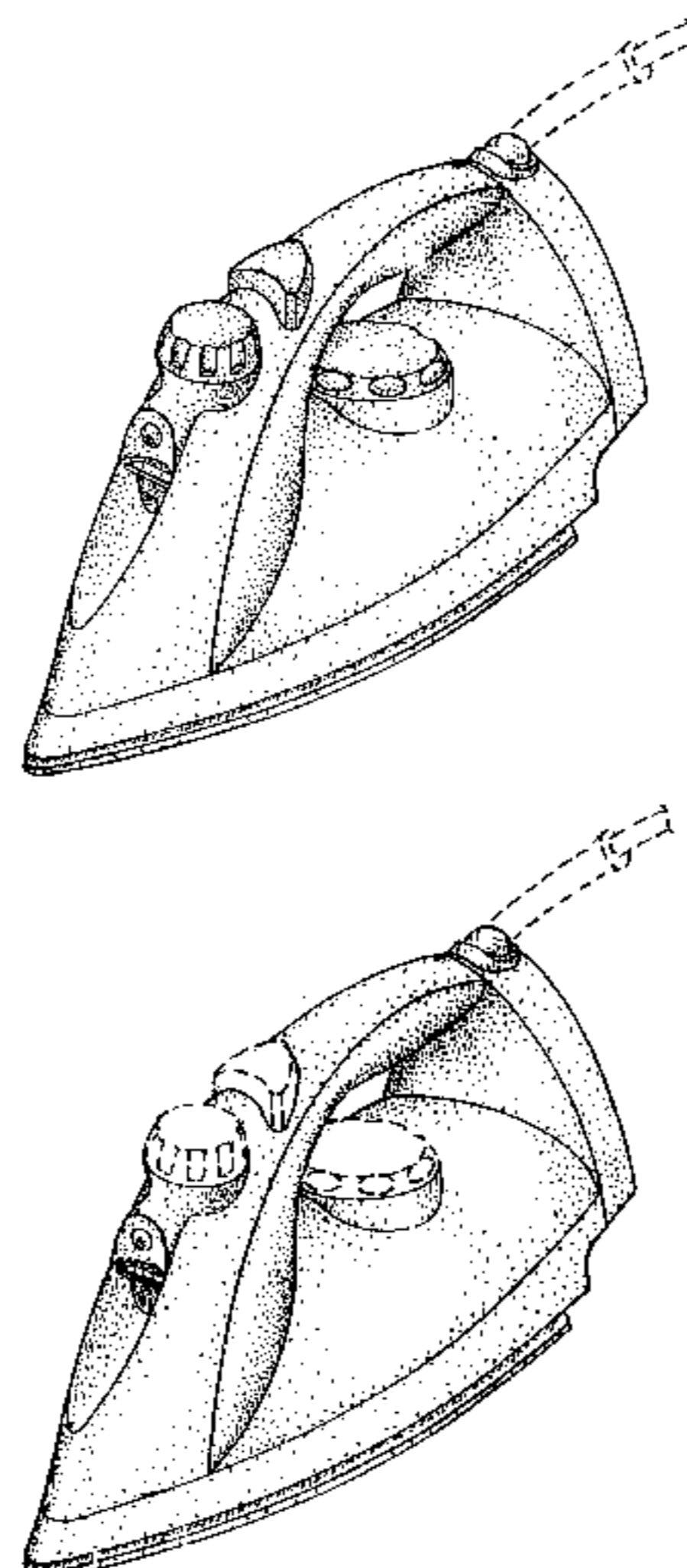
FIG. 11 is a front elevational view thereof; and,

FIG. 12 is a rear elevational view thereof.

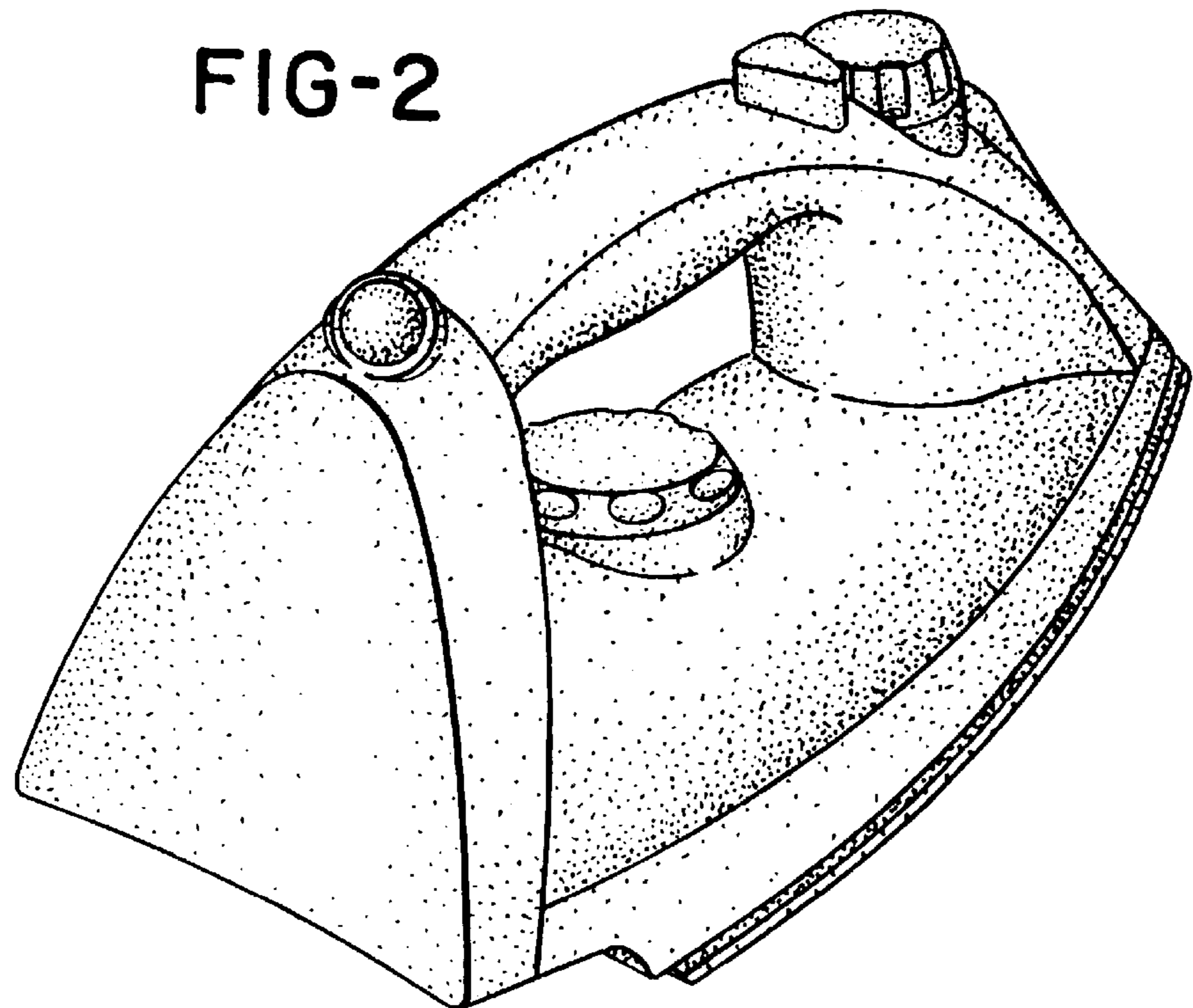
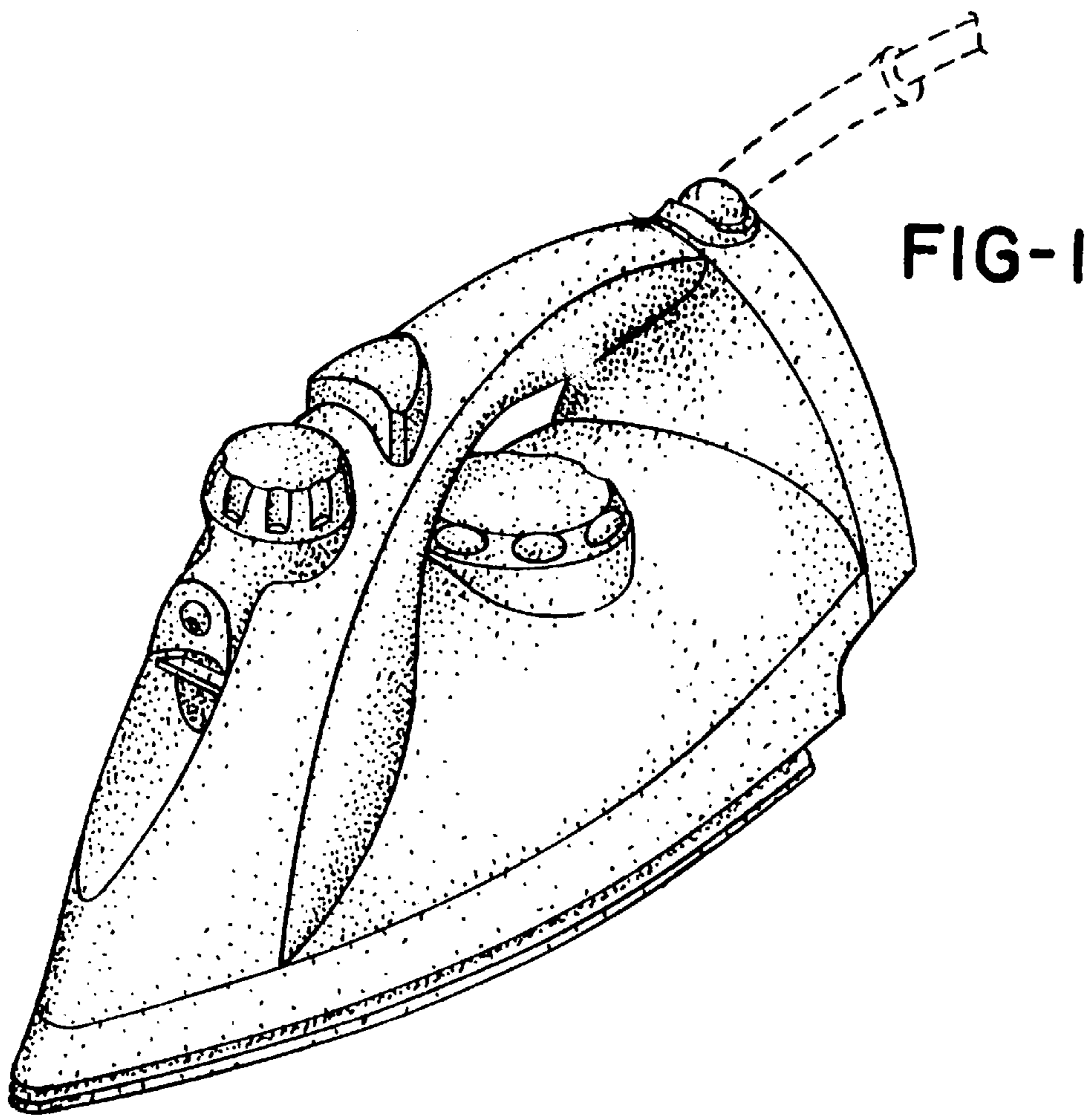

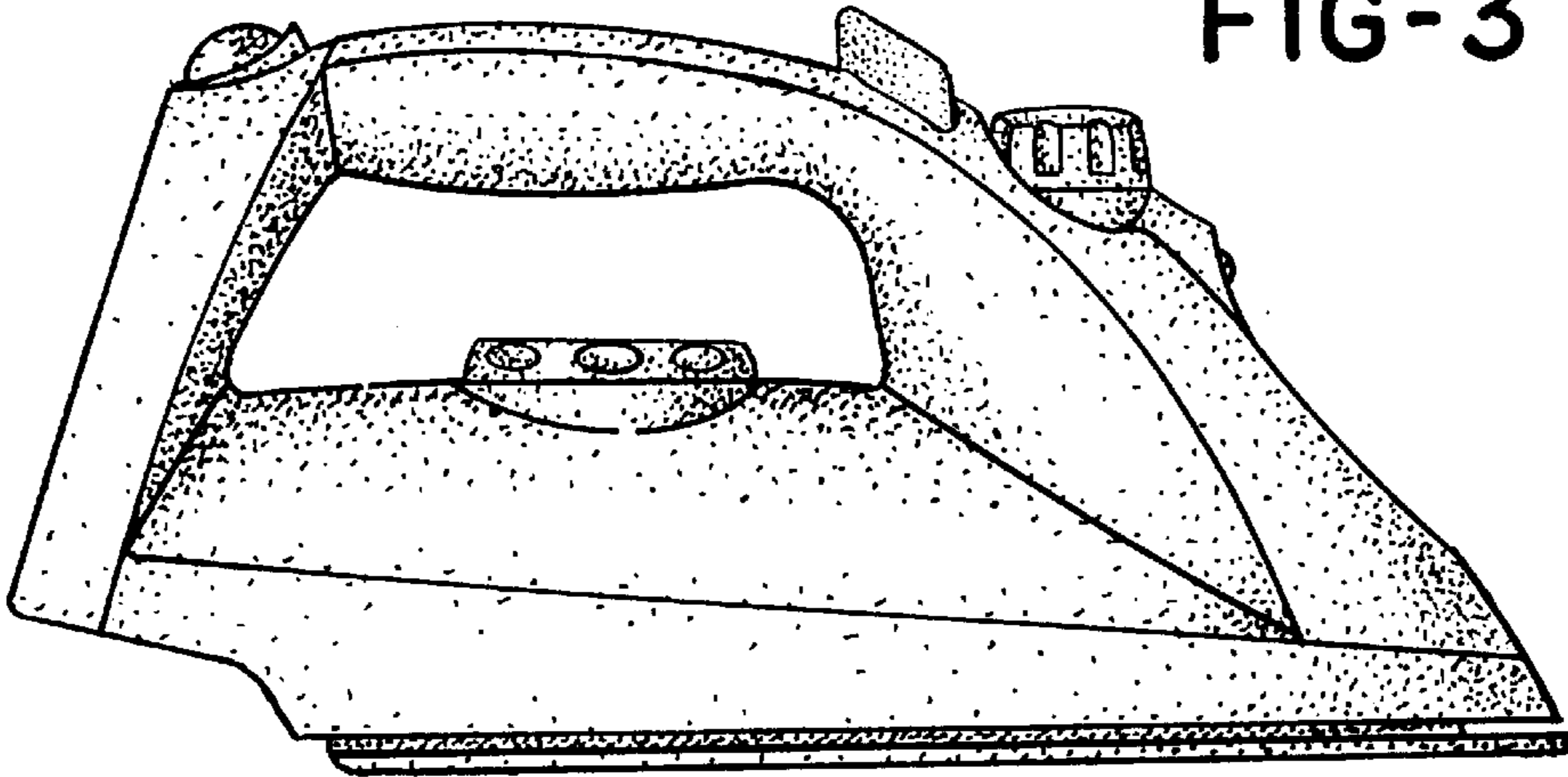

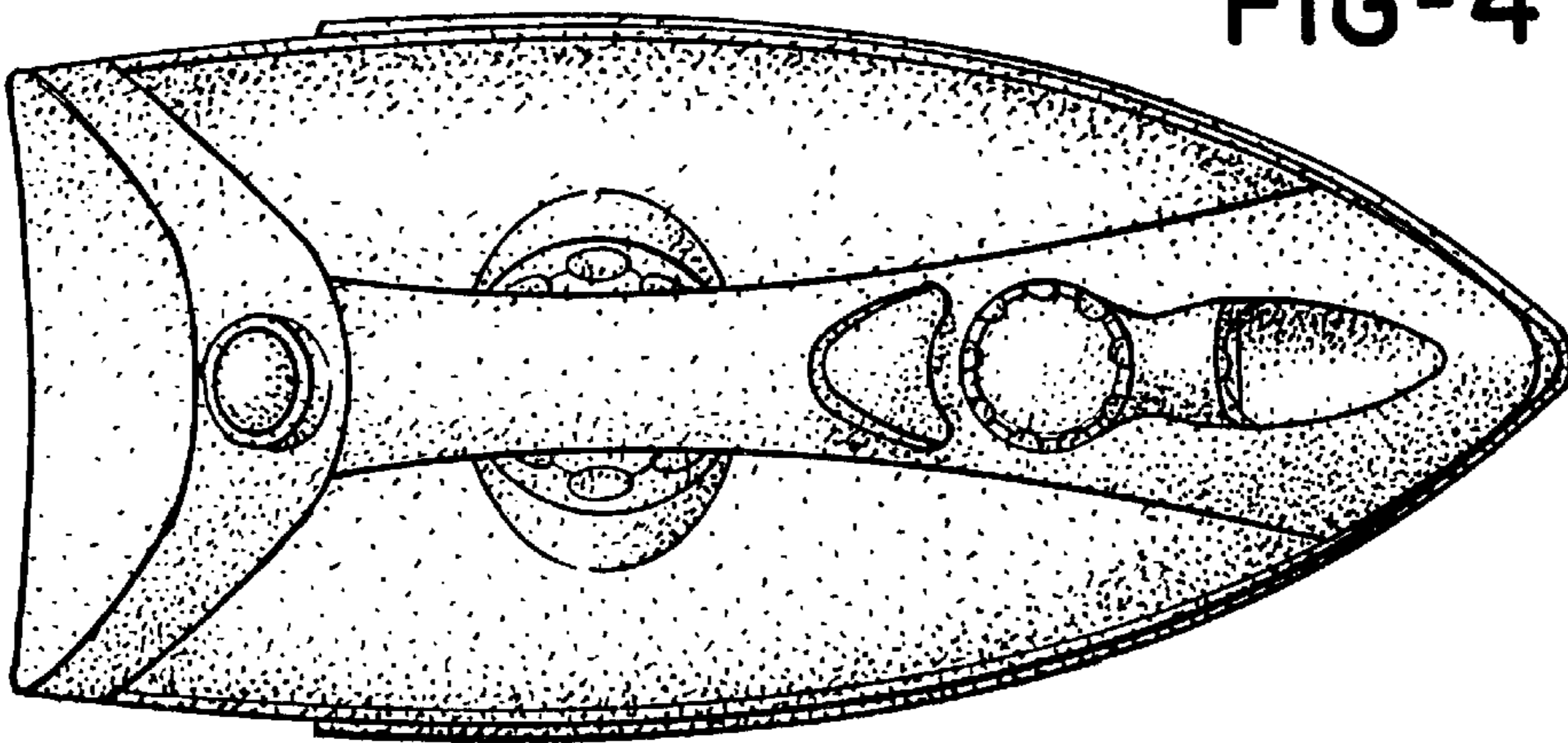

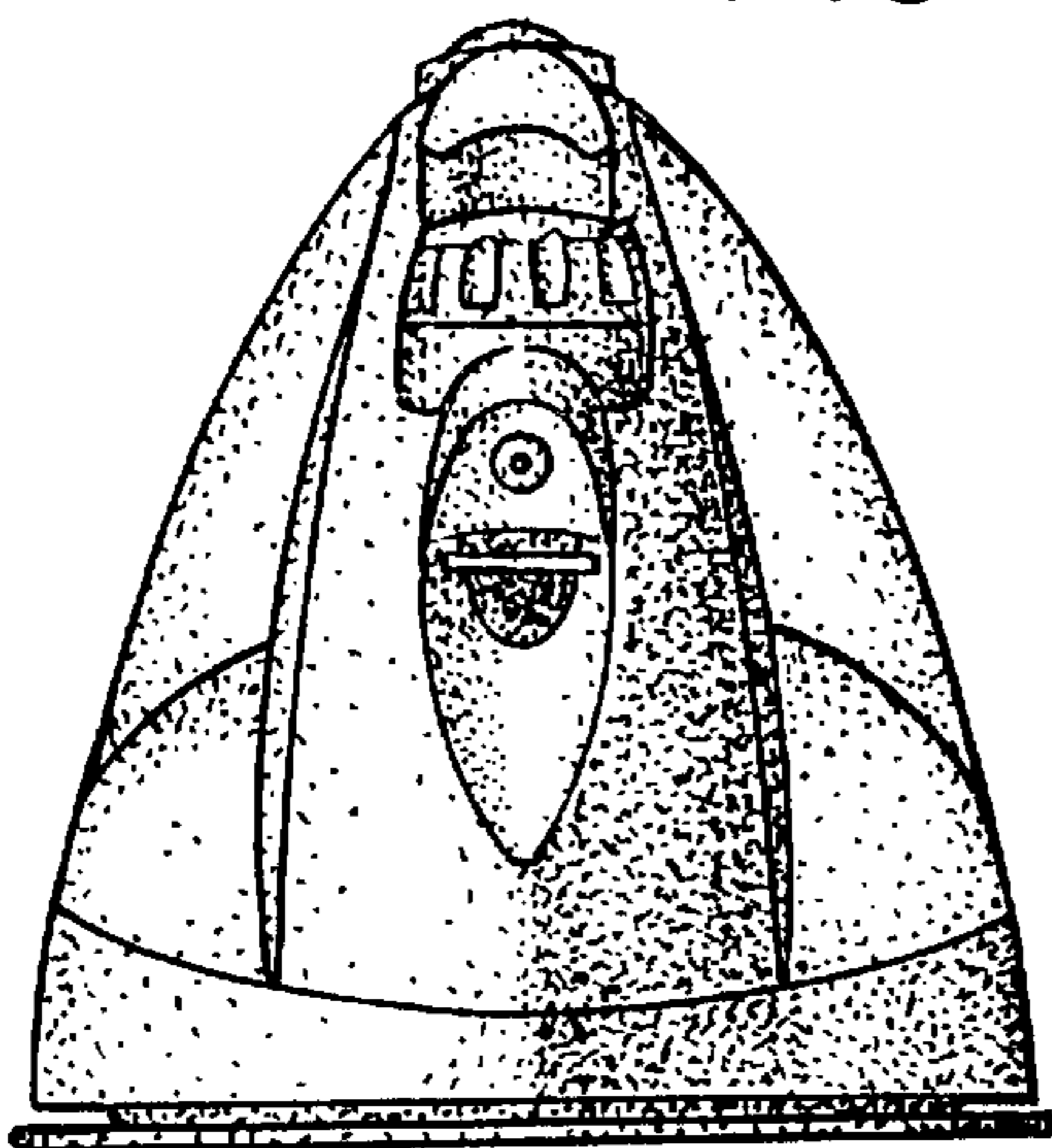
