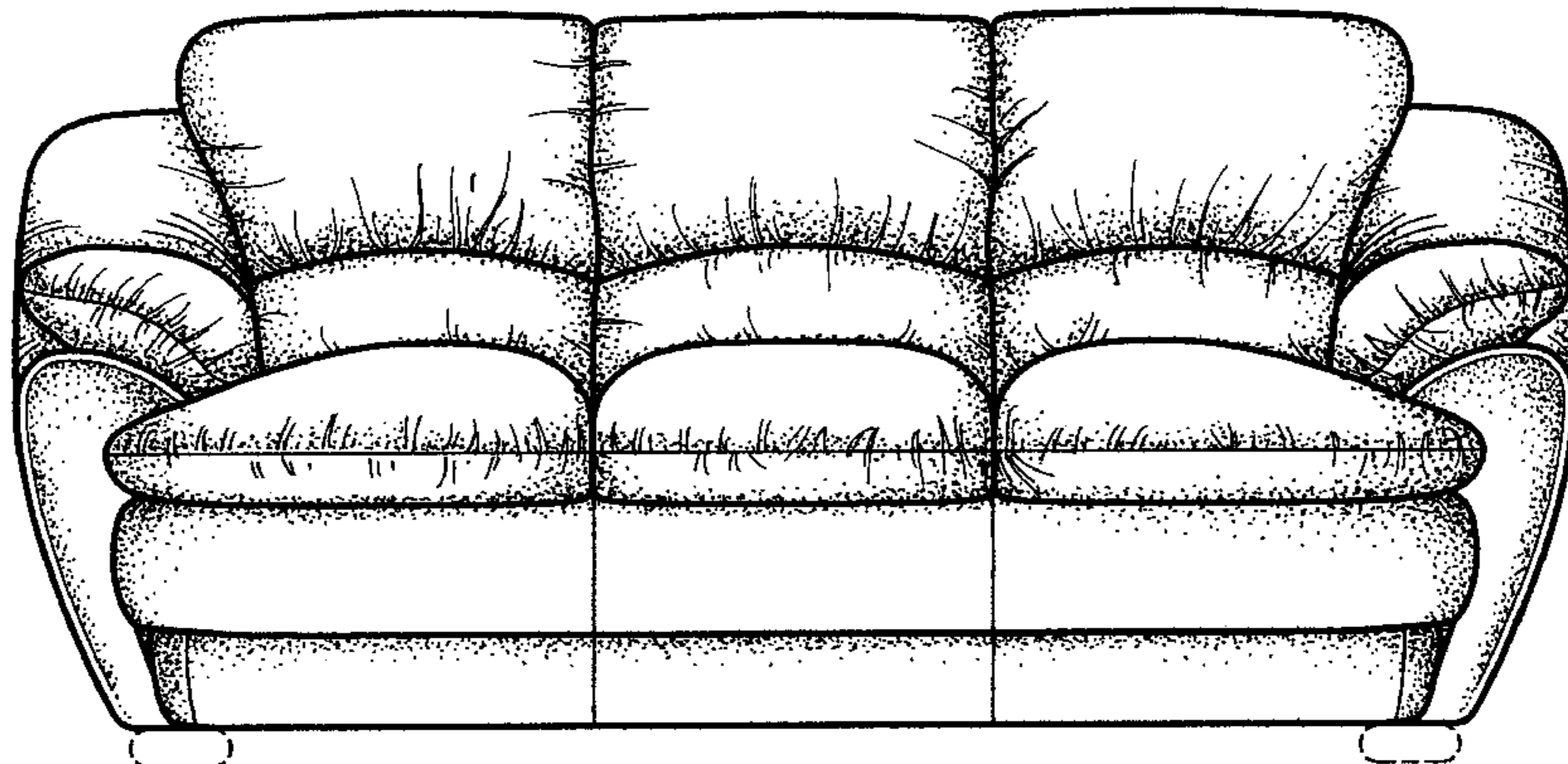
The ornamental design for a sofa, as shown and described.

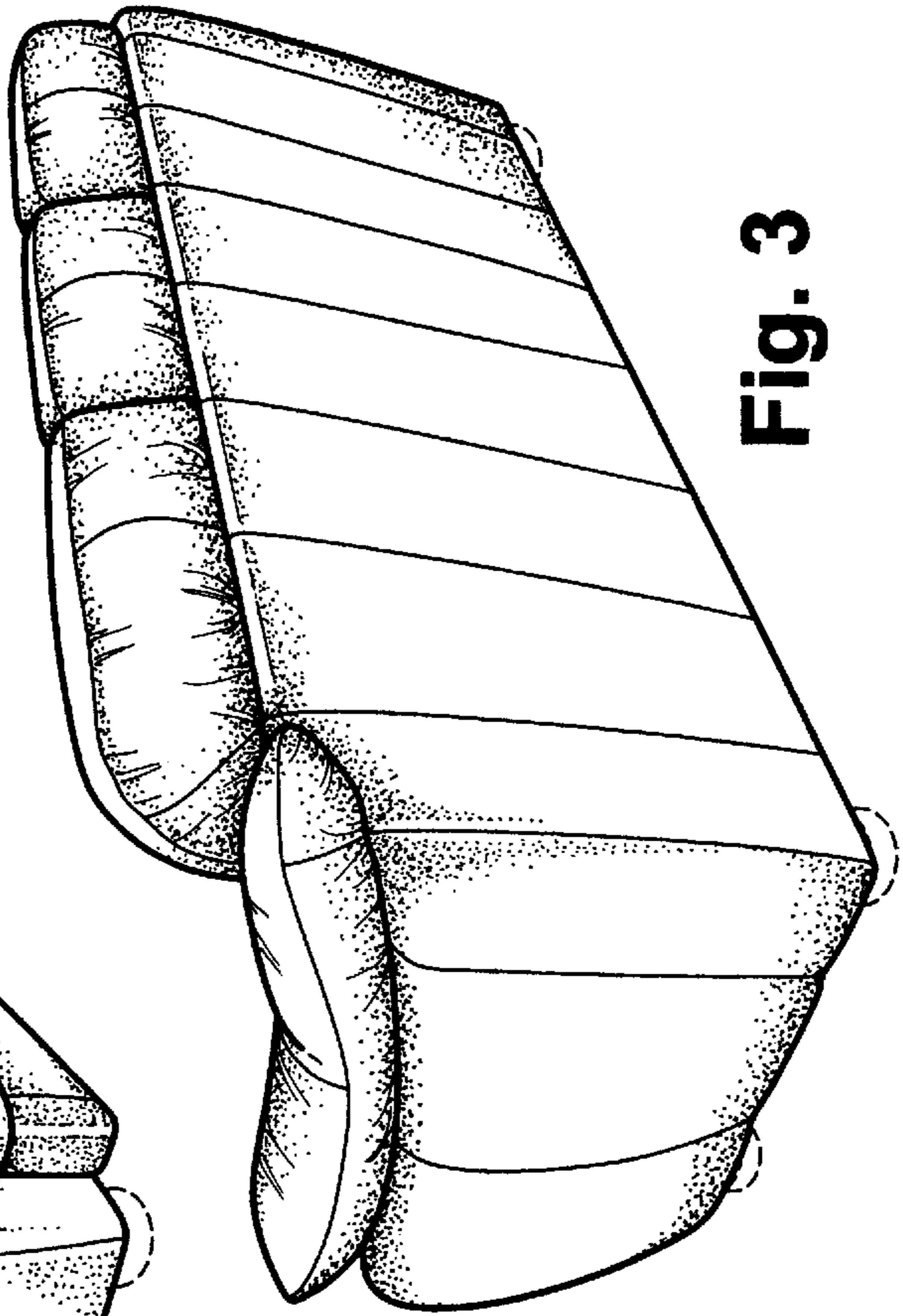
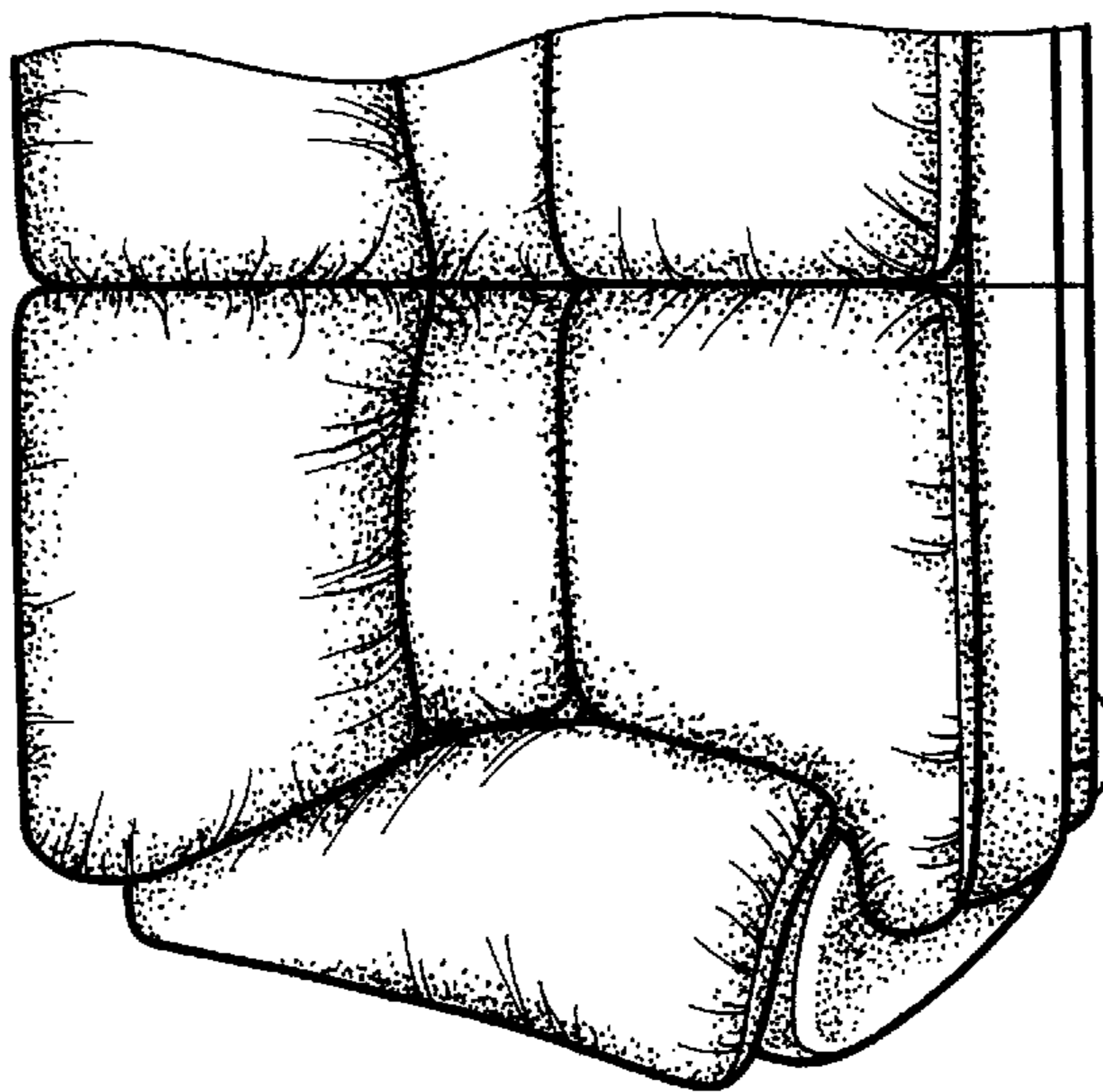
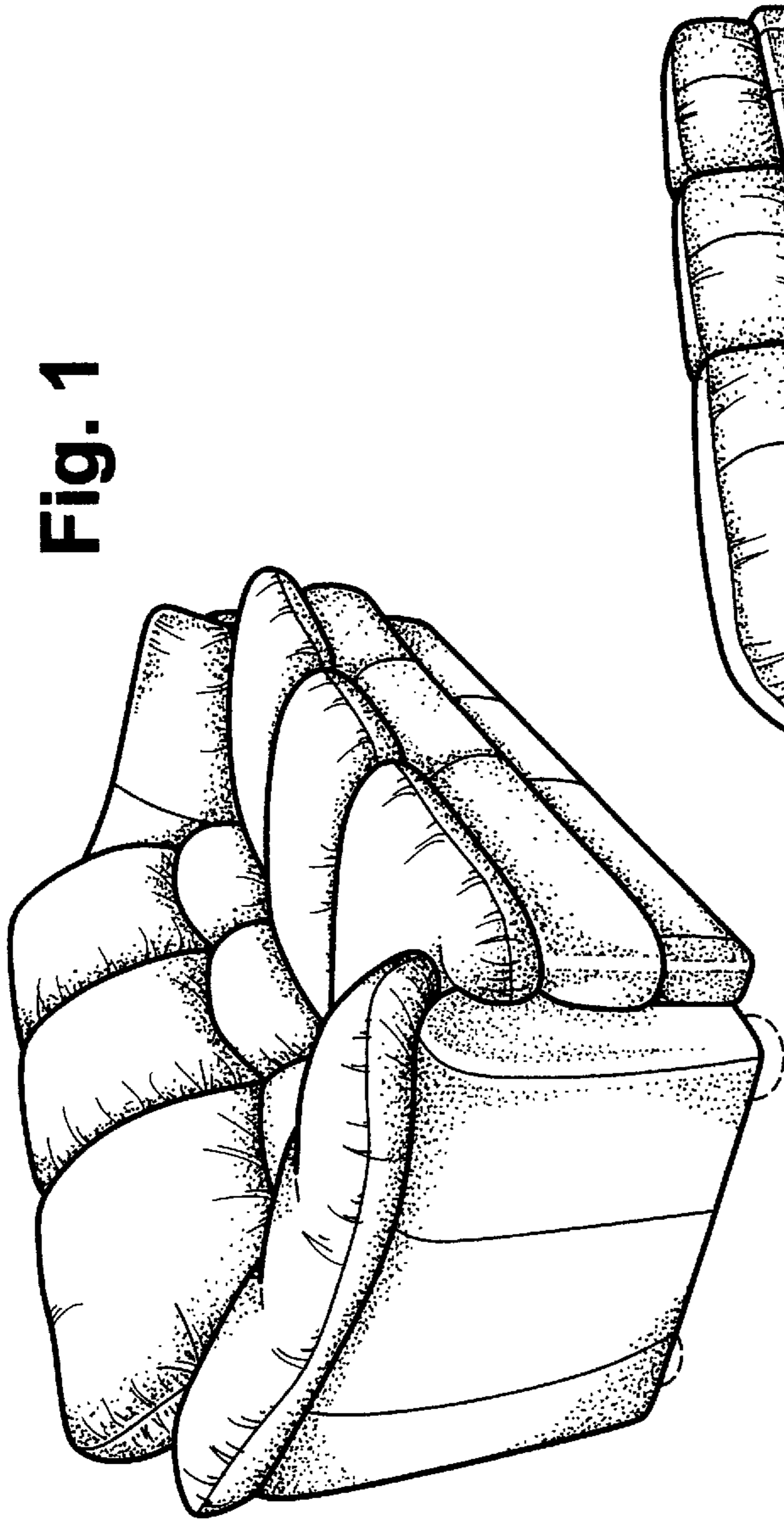
DESCRIPTION

FIG. 1 is a left, front perspective view of a sofa showing my new design;
FIG. 2 is a left, partial front perspective view of the embodiment of FIG. 1;
FIG. 3 is a right, rear perspective view of the embodiment of FIG. 1;
FIG. 4 is a front elevation view of the embodiment of FIG. 1;
FIG. 5 is a left, side elevation view of the embodiment of FIG. 1, with the right side elevational view being a mirror image thereof;
FIG. 6 is a rear elevation view of the embodiment of FIG. 1;
FIG. 7 is a front elevation view of a second embodiment of the sofa depicted in FIG. 1;
FIG. 8 is a left, side elevation view of the embodiment of FIG. 7, with the right side elevational view being a mirror image thereof; and,
FIG. 9 is a rear elevation view of the embodiment of FIG. 7.

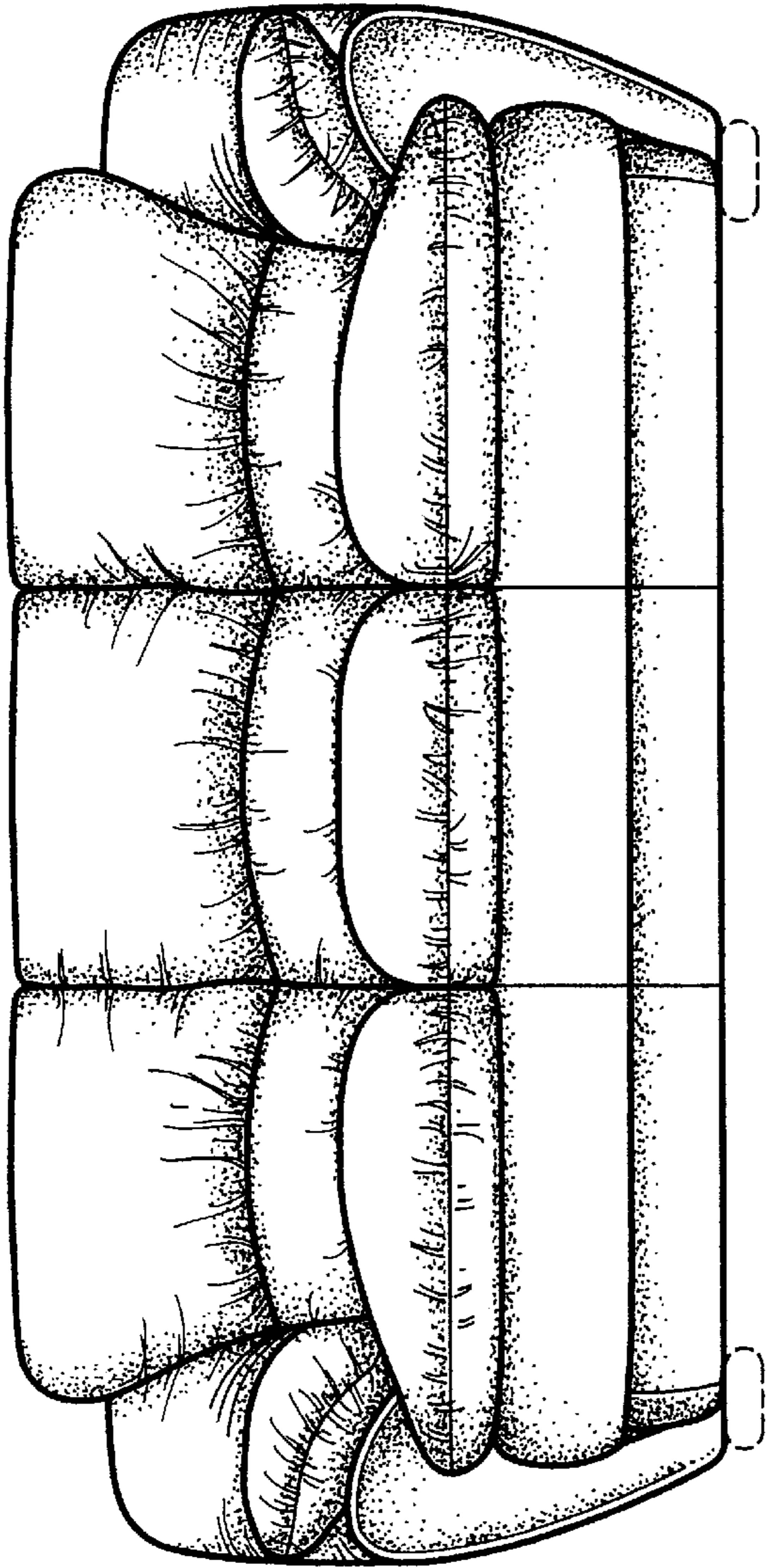

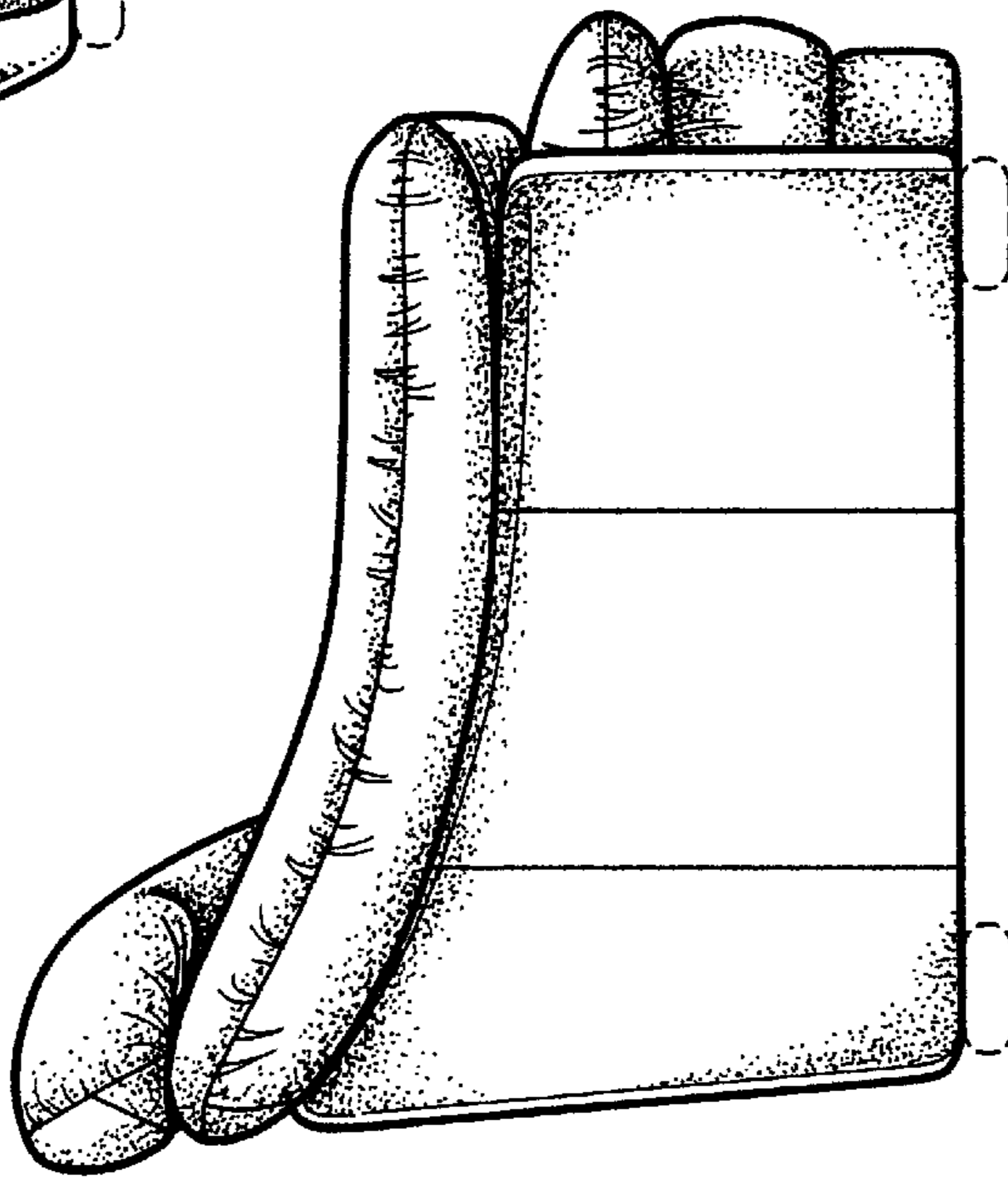

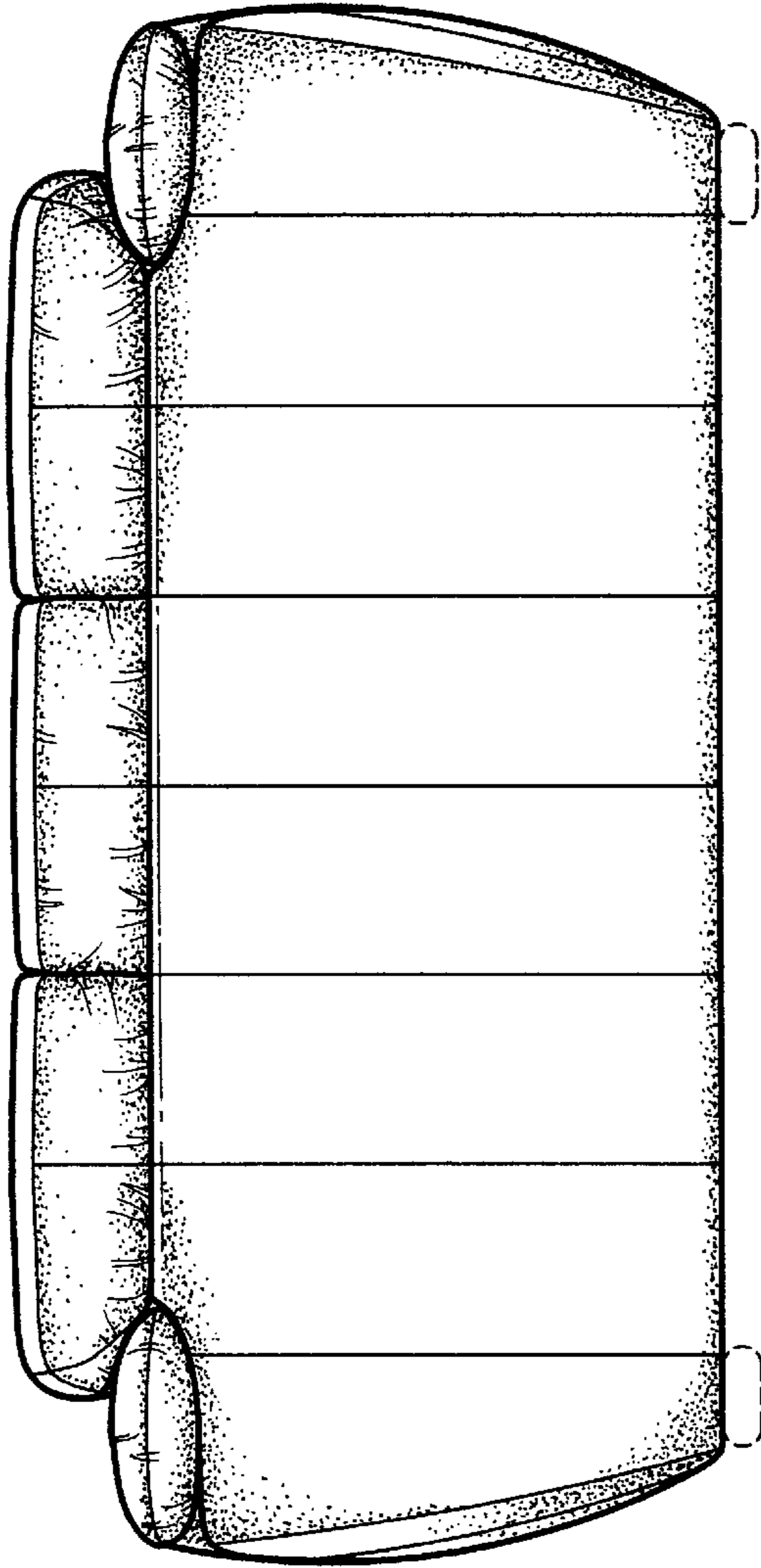

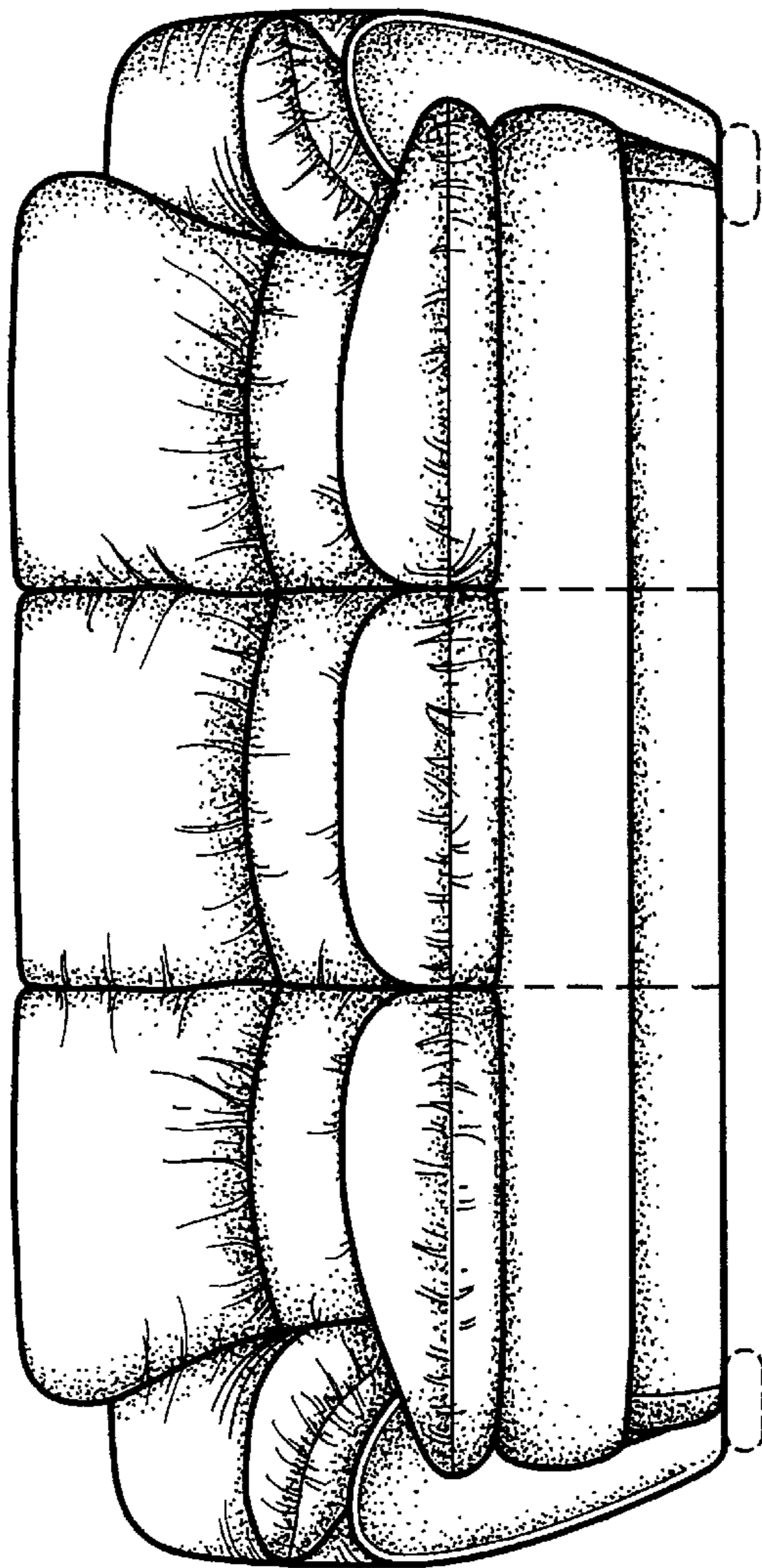

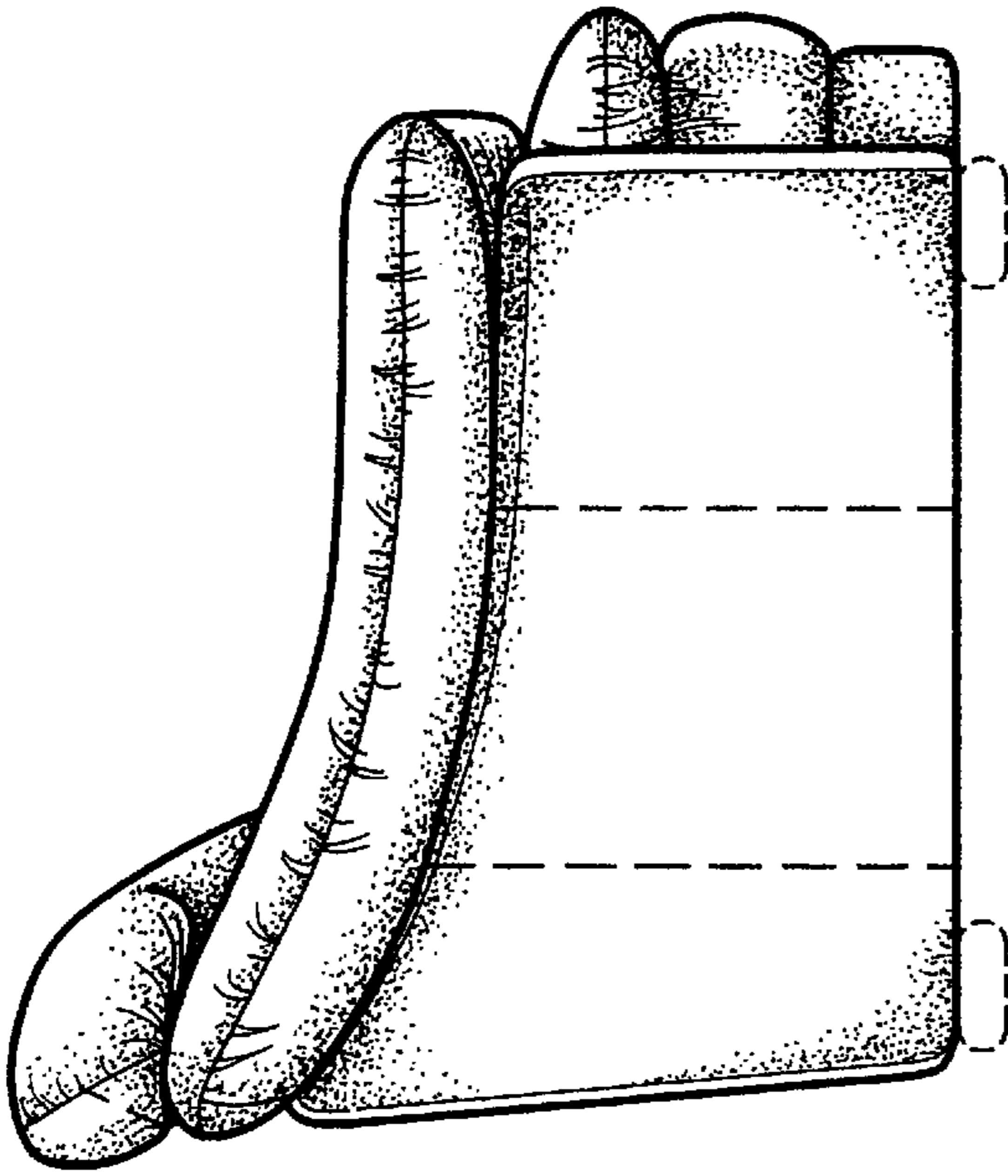

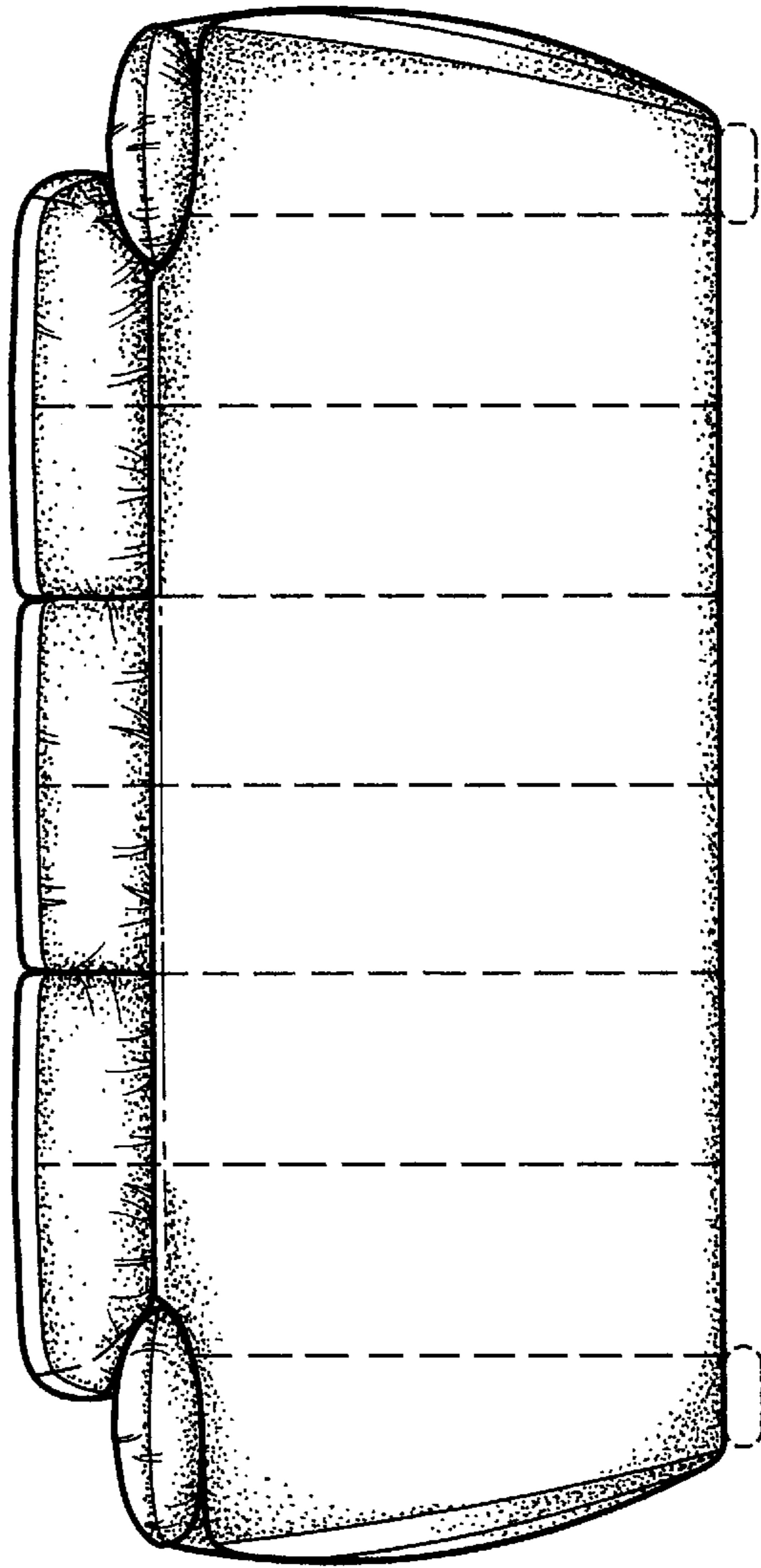
