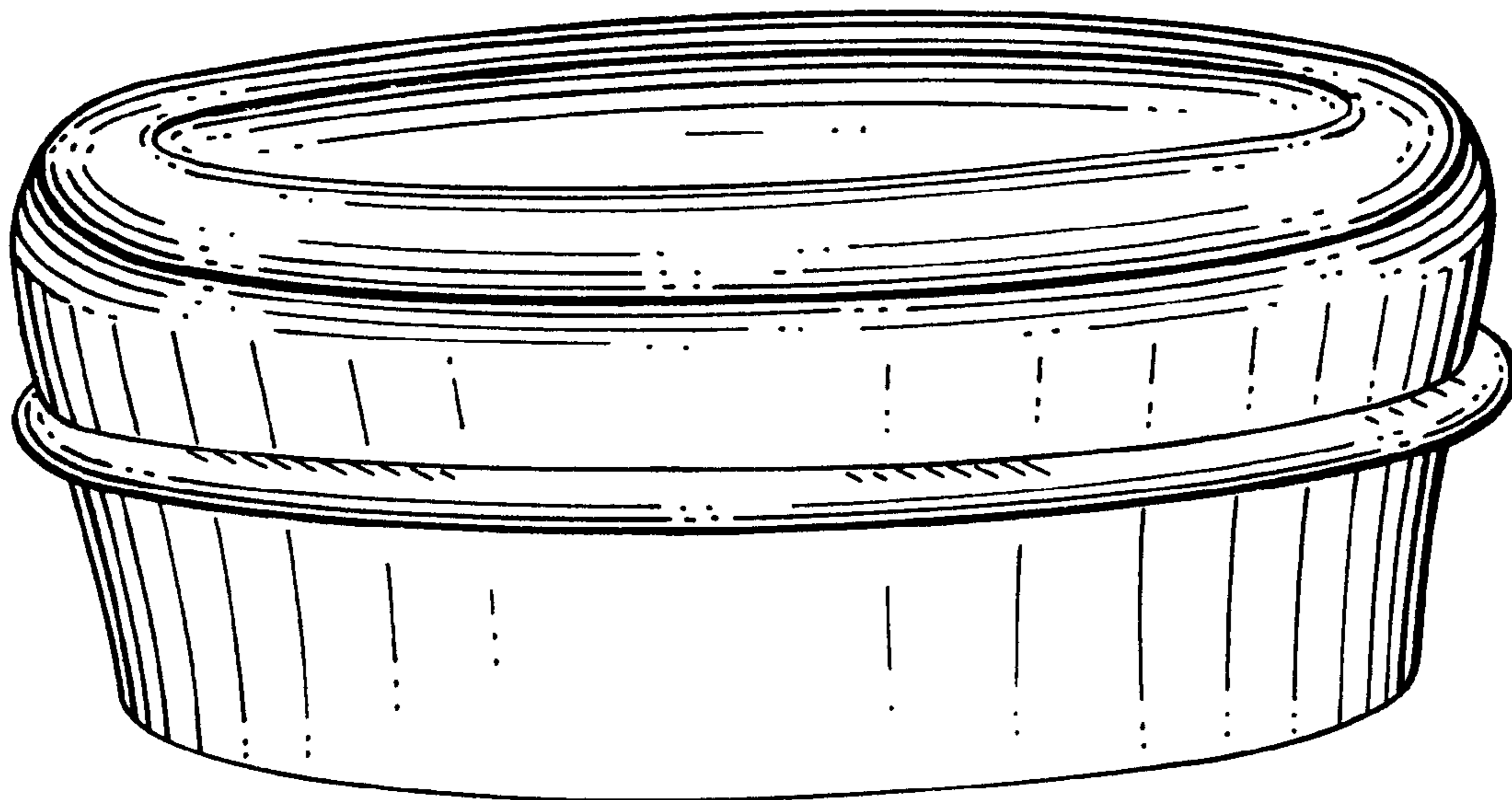

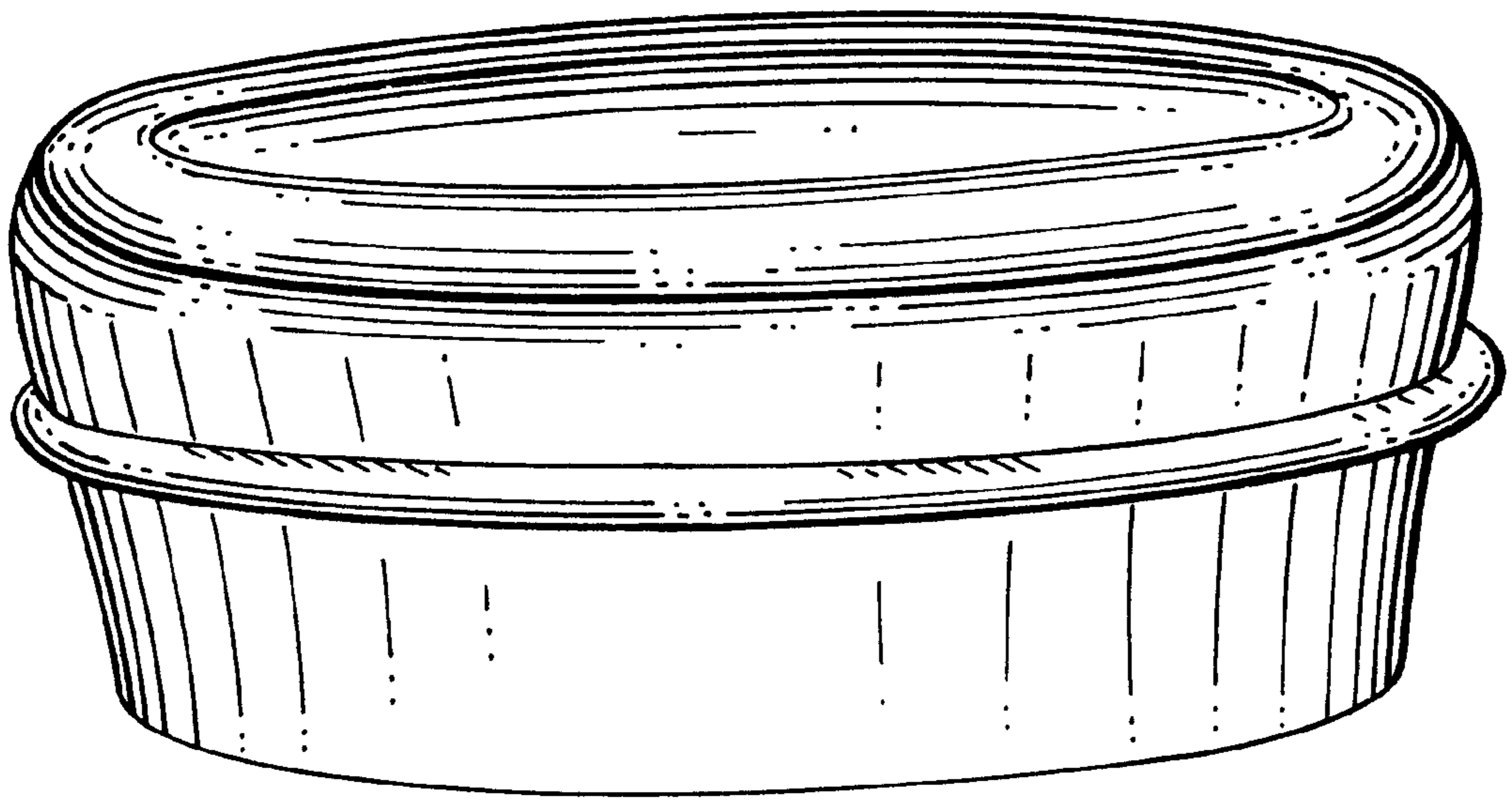
The ornamental design for a container for cosmetics, substantially as shown and described.

**DESCRIPTION**

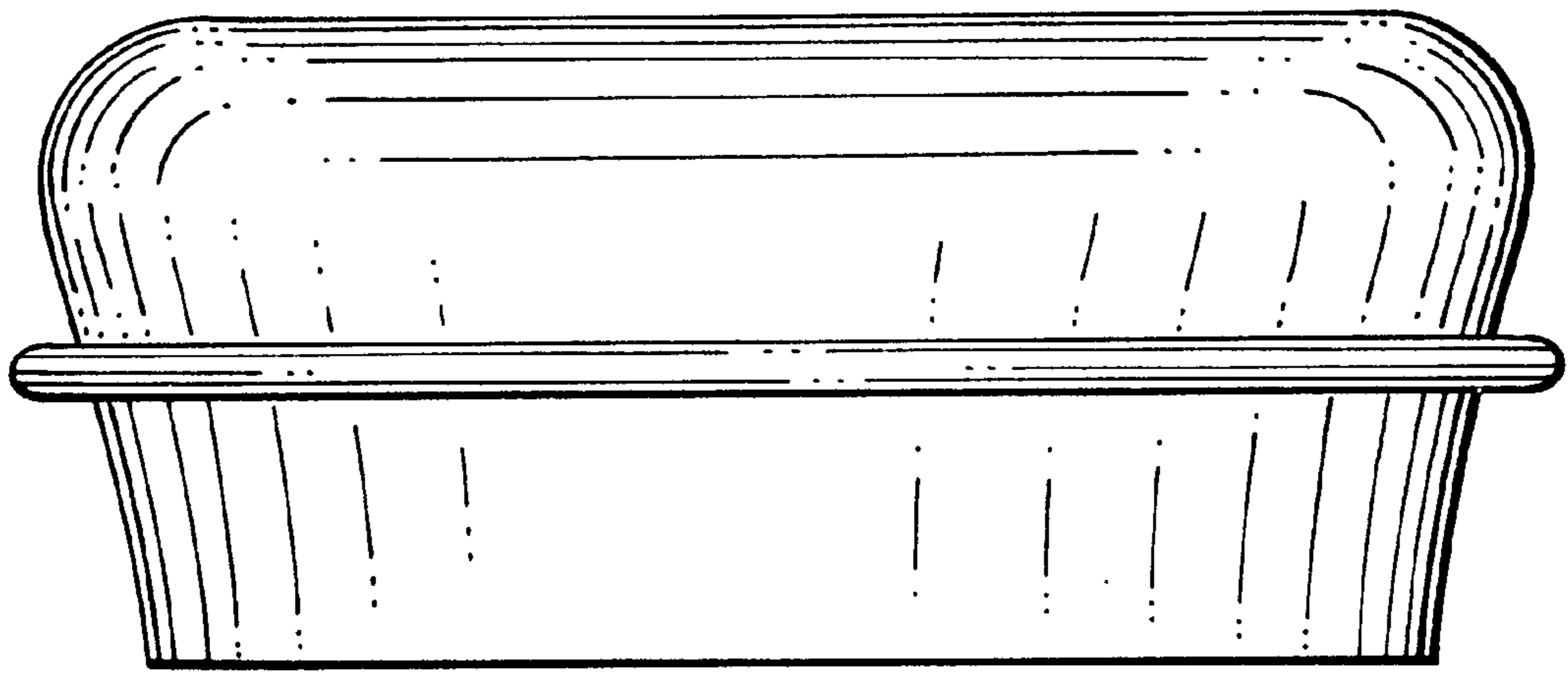
FIG. 1 is a perspective view of the container for cosmetics of the present invention;

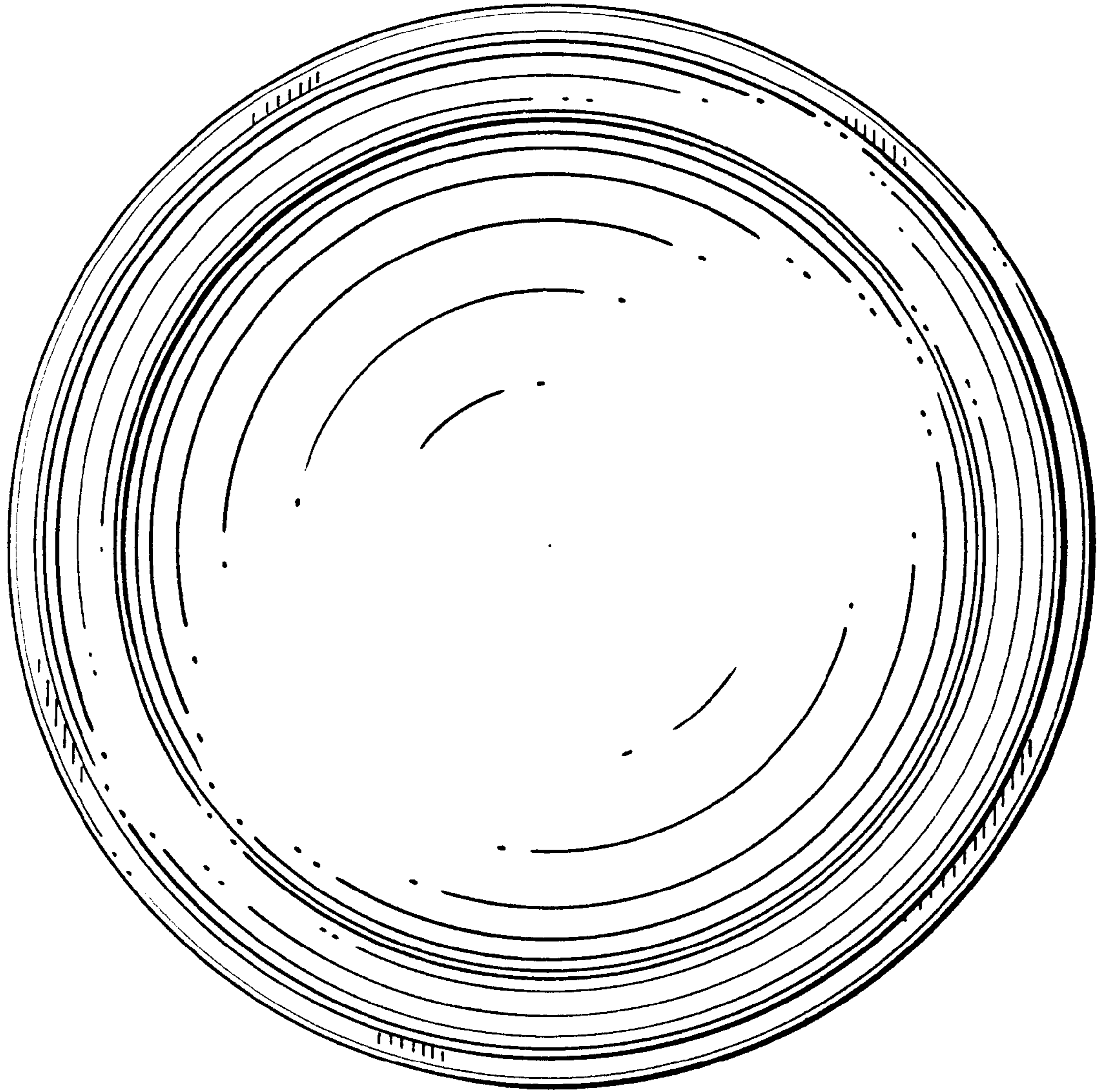




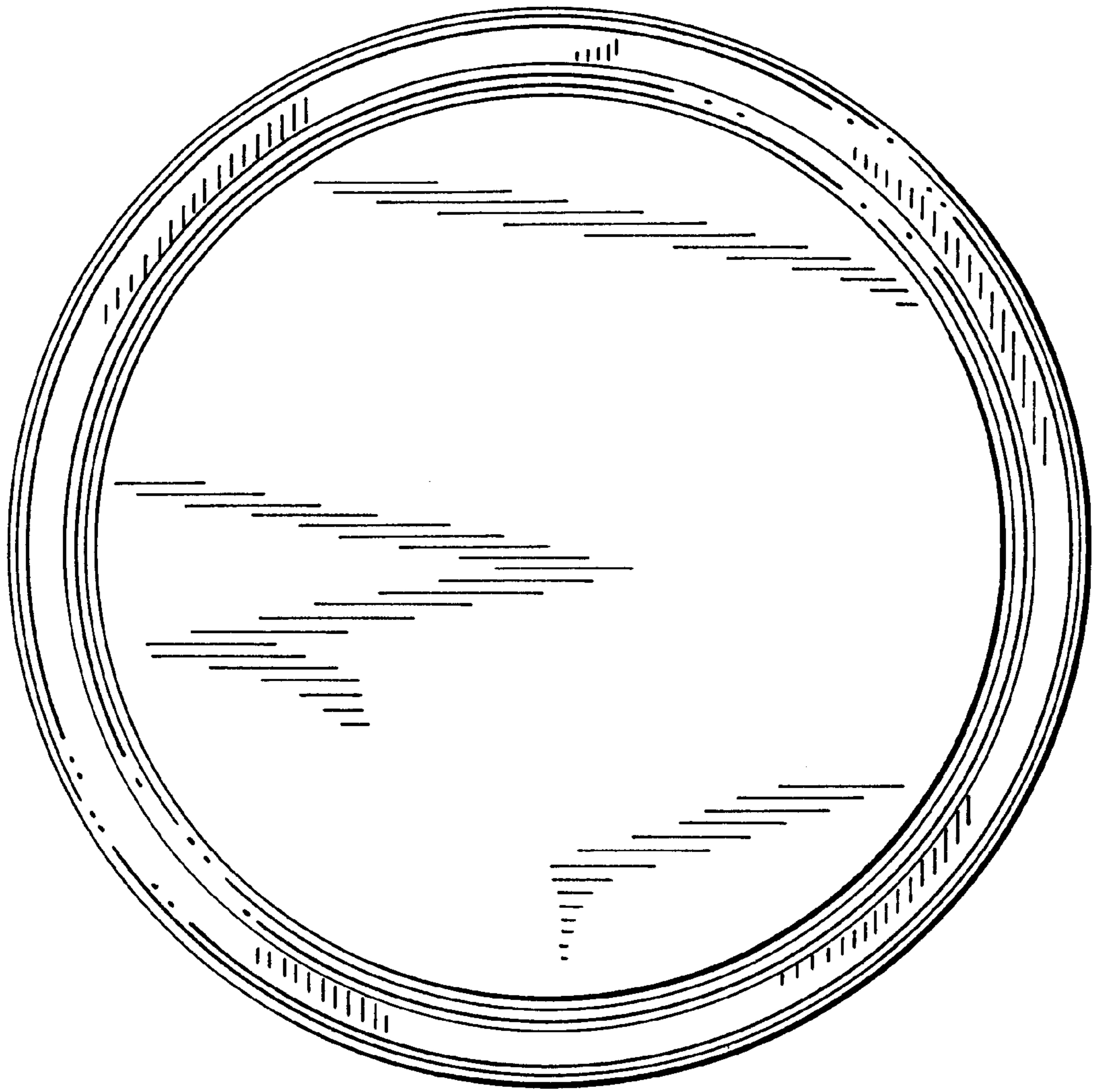
