**DESCRIPTION**

FIG. 8 is a three-quarter rear perspective view thereof;

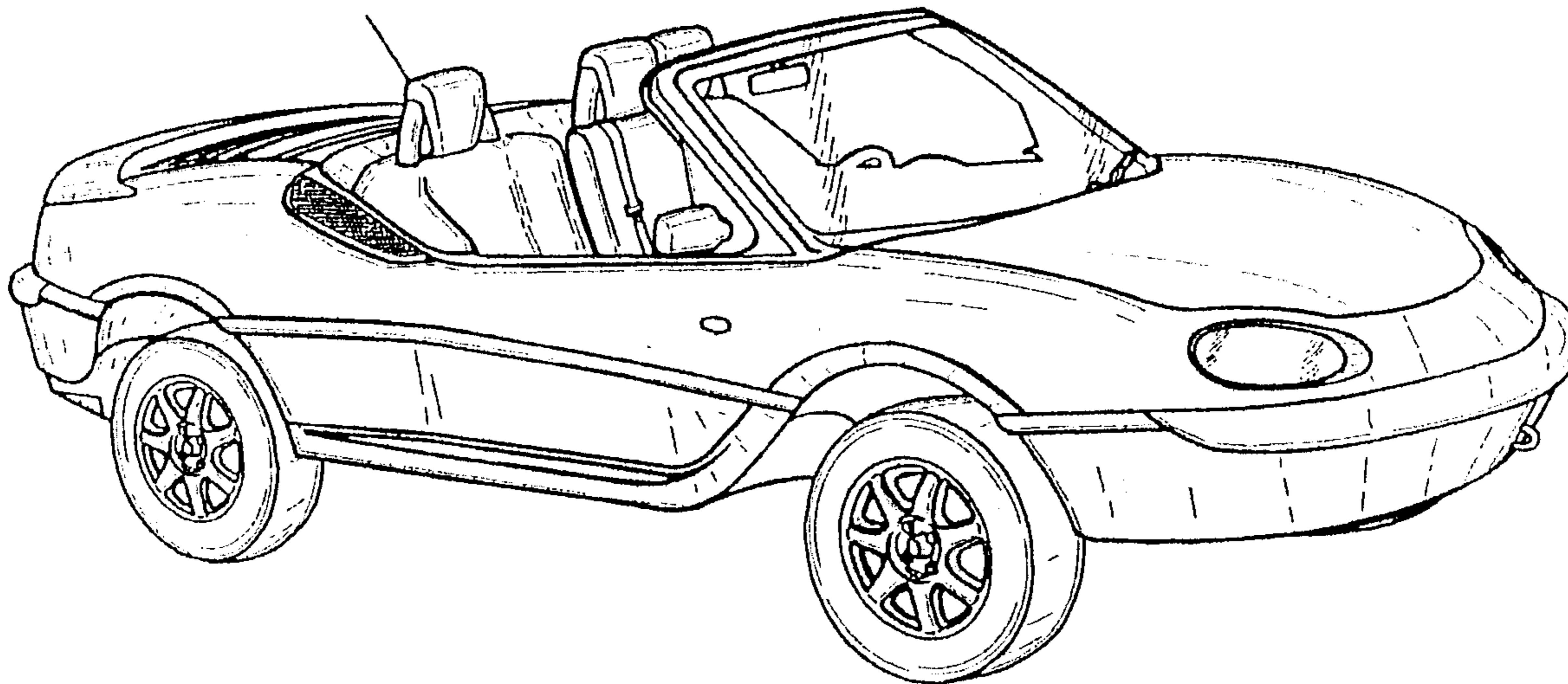
FIG. 9 is a rear interior perspective view thereof;

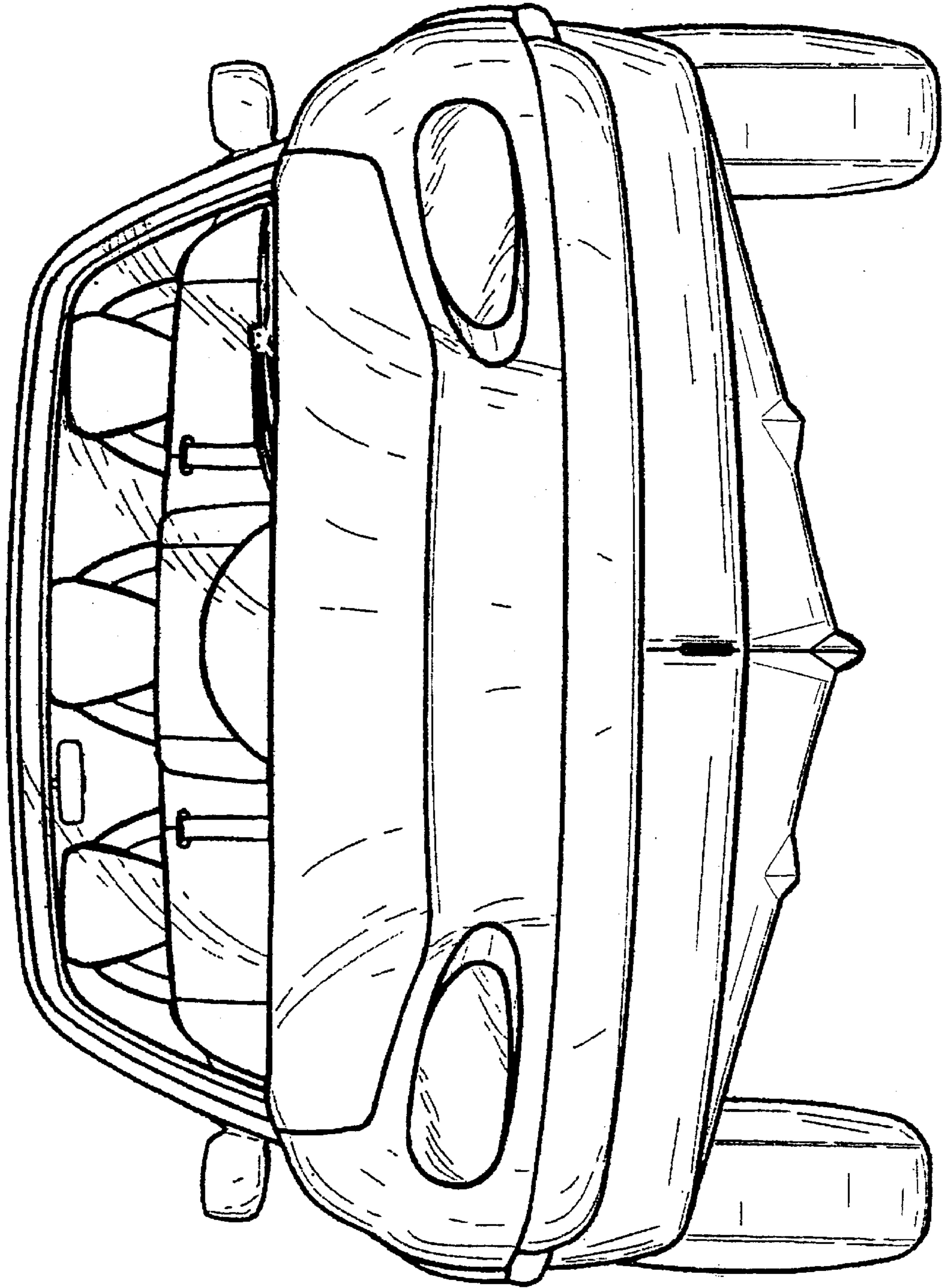

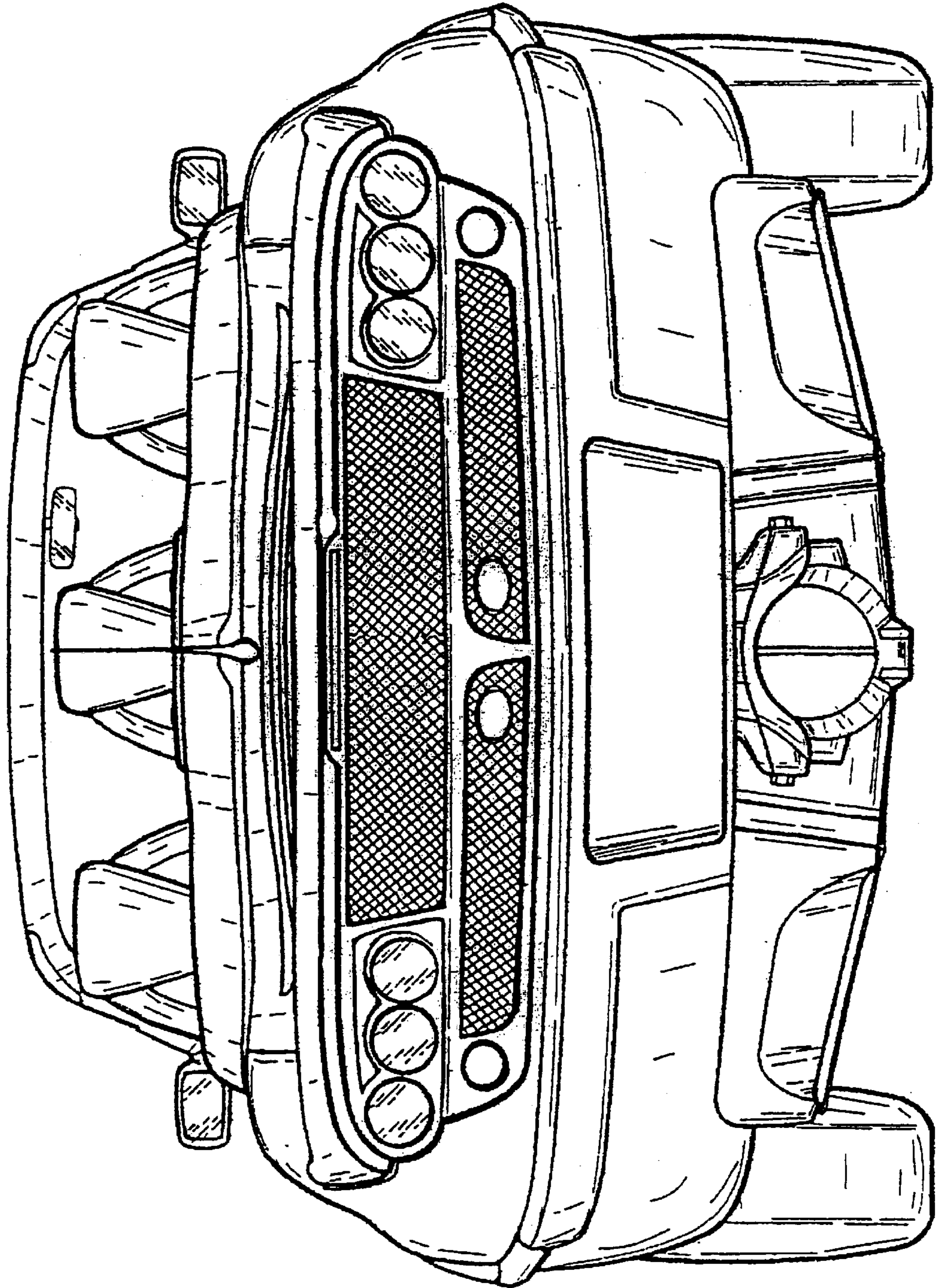

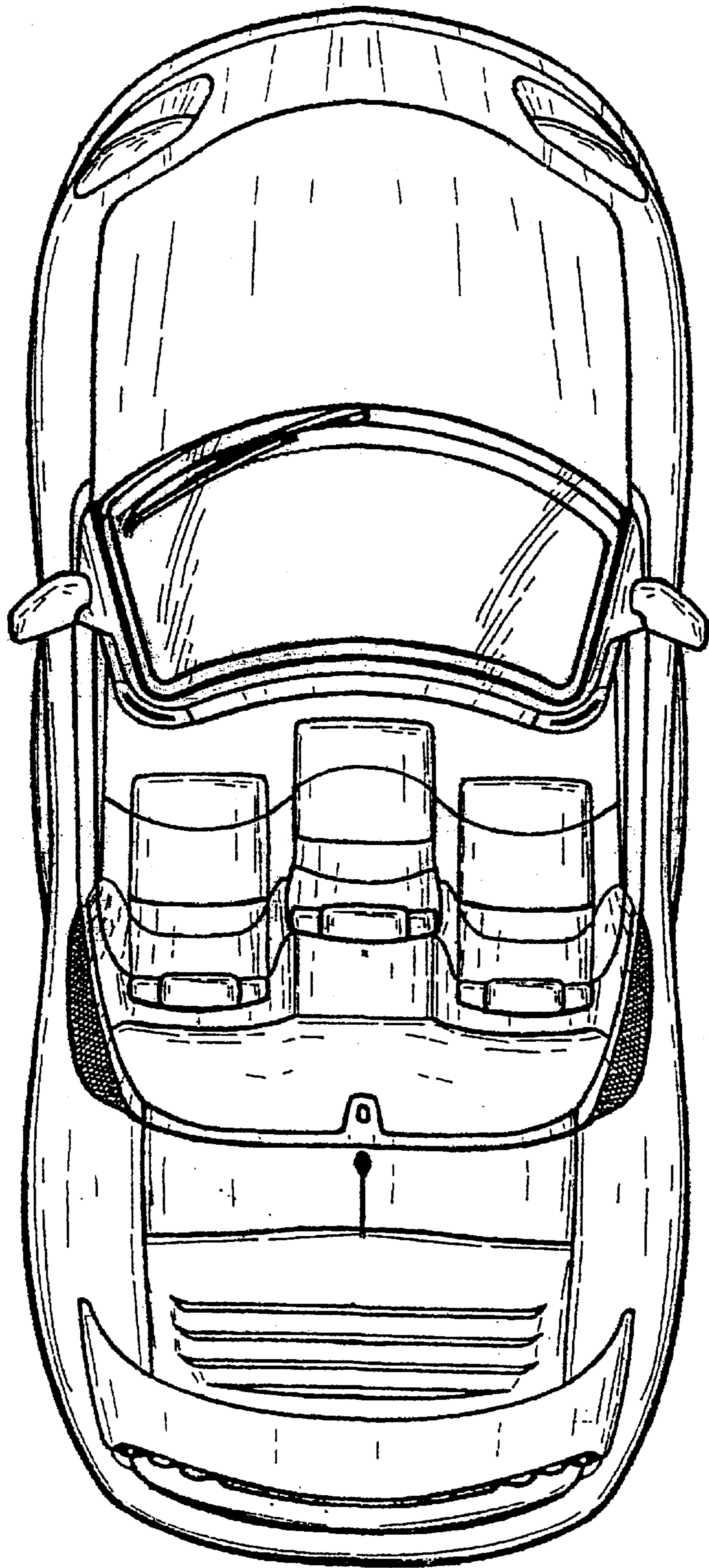

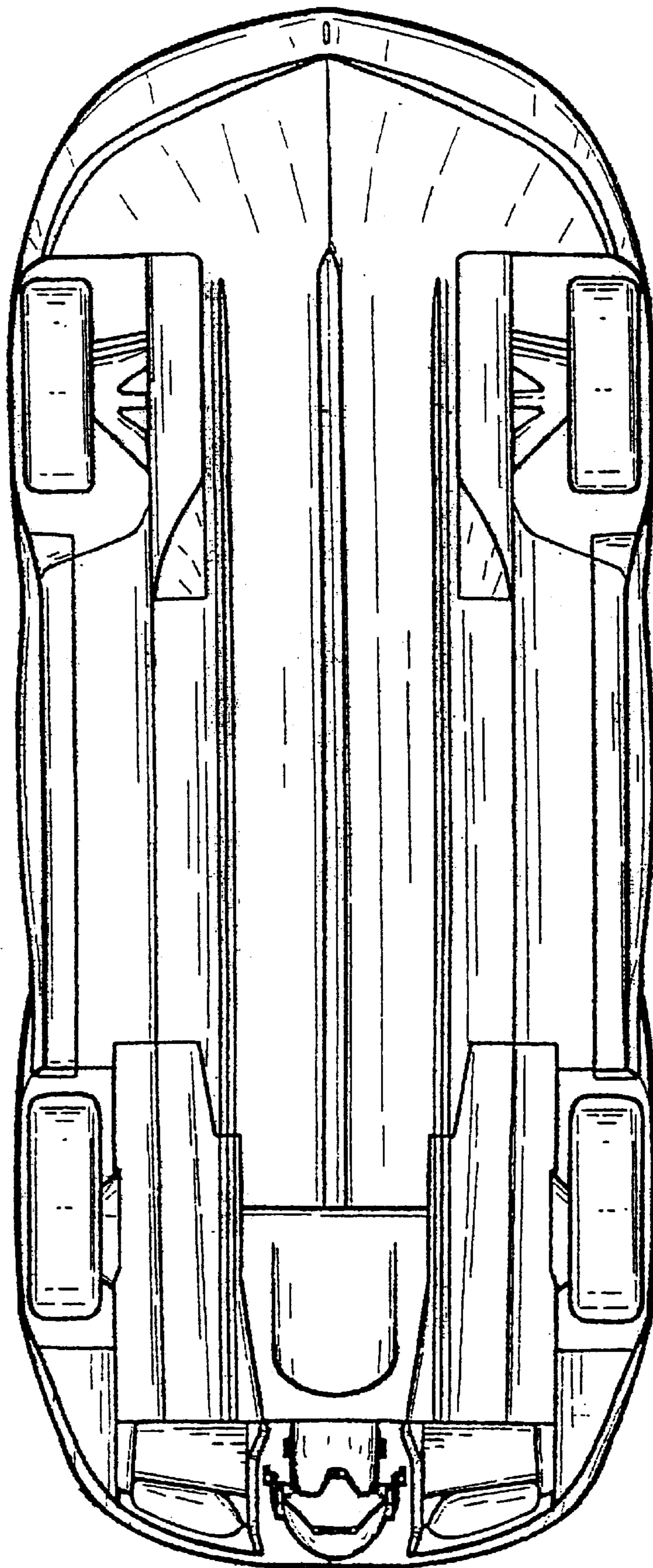
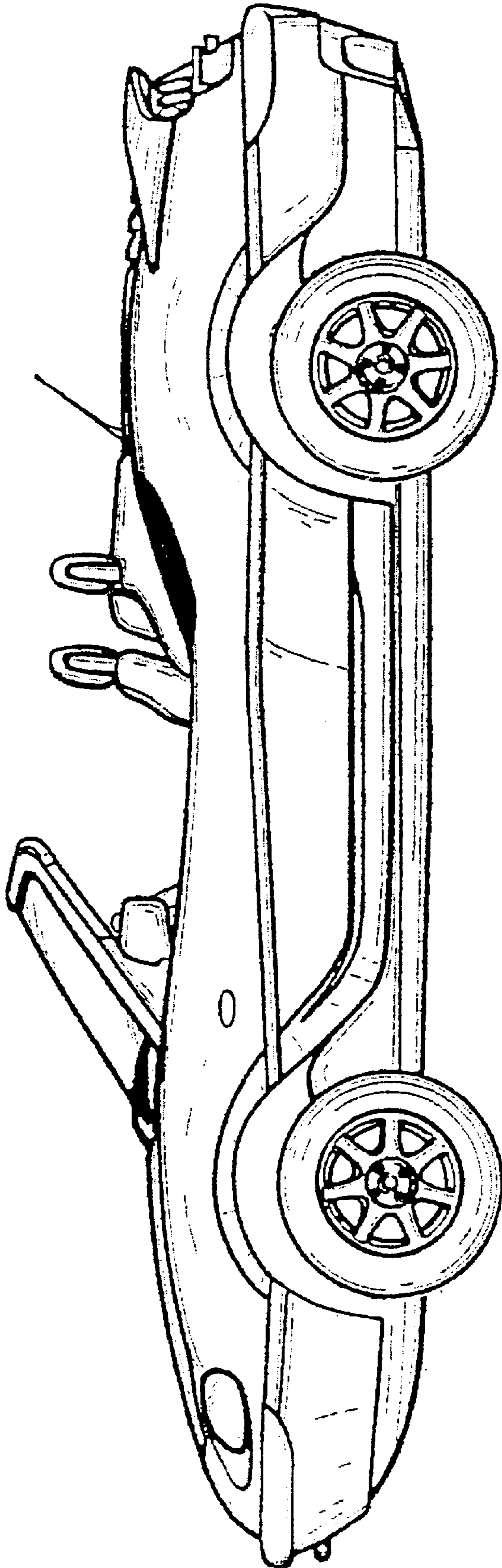

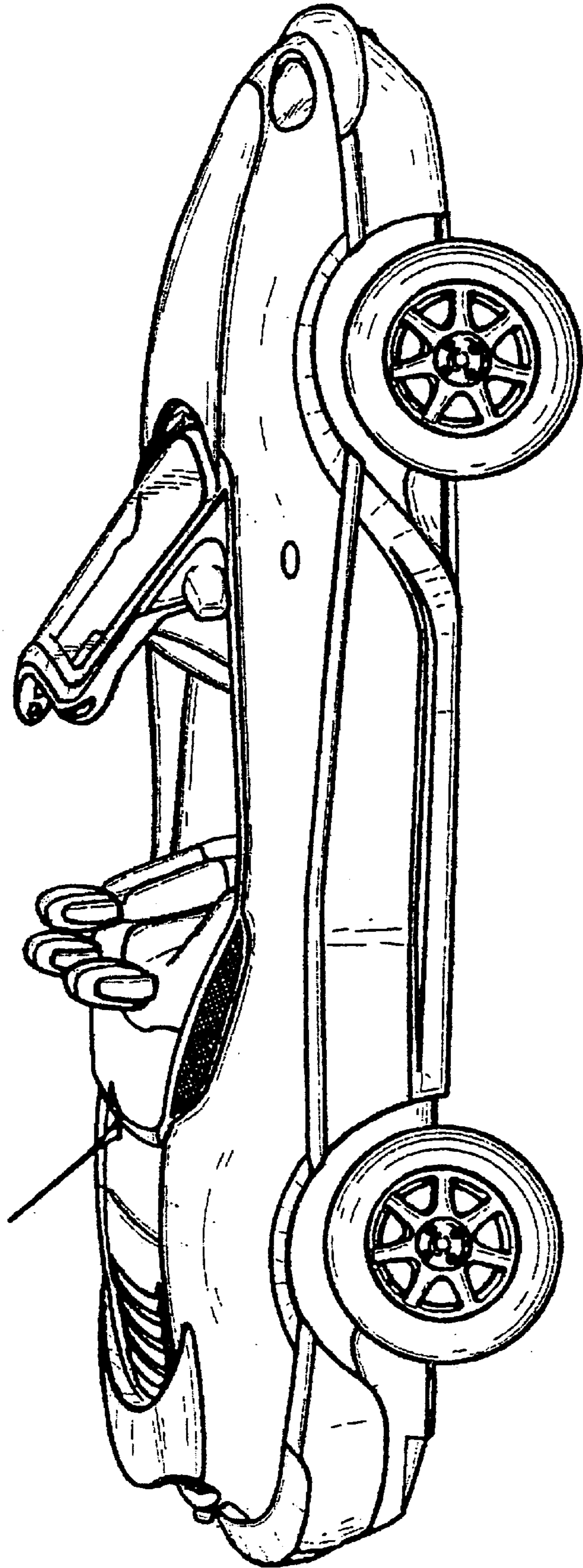
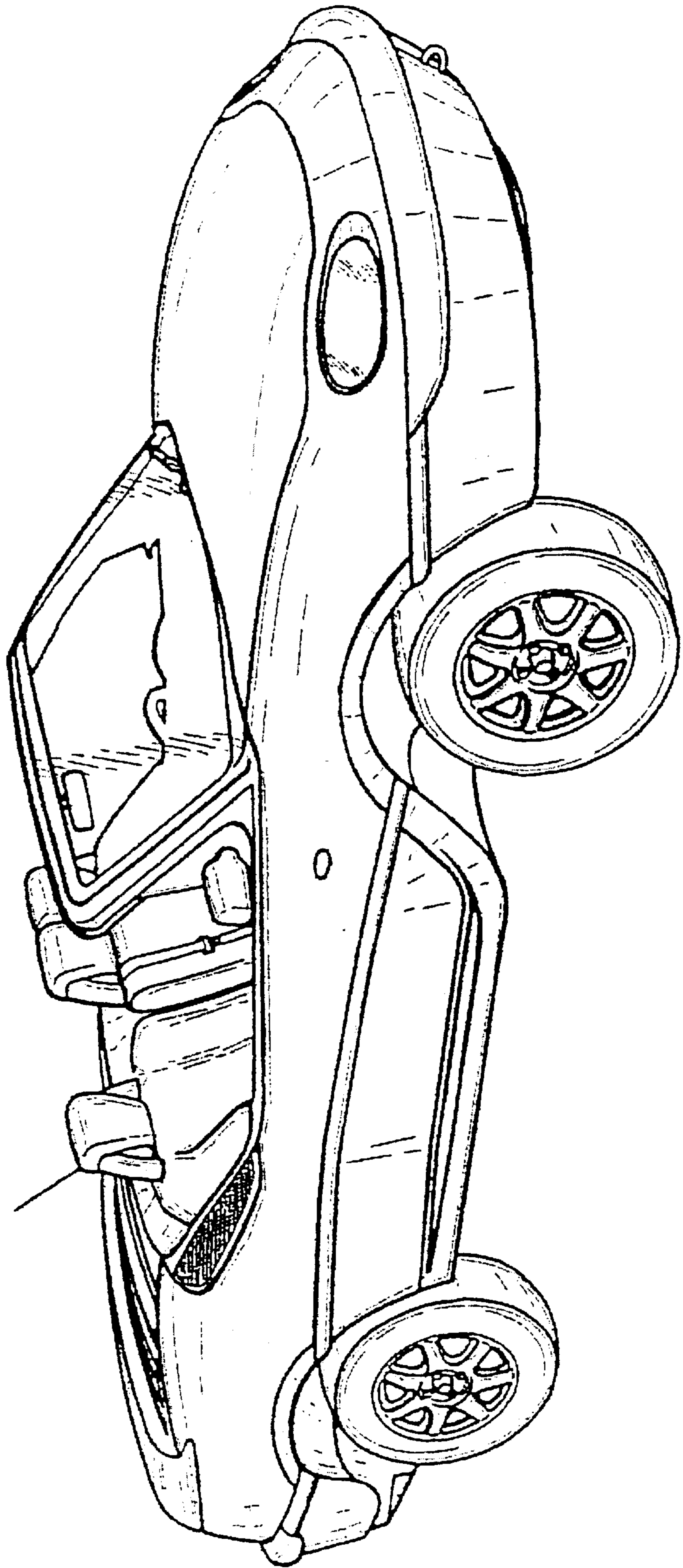

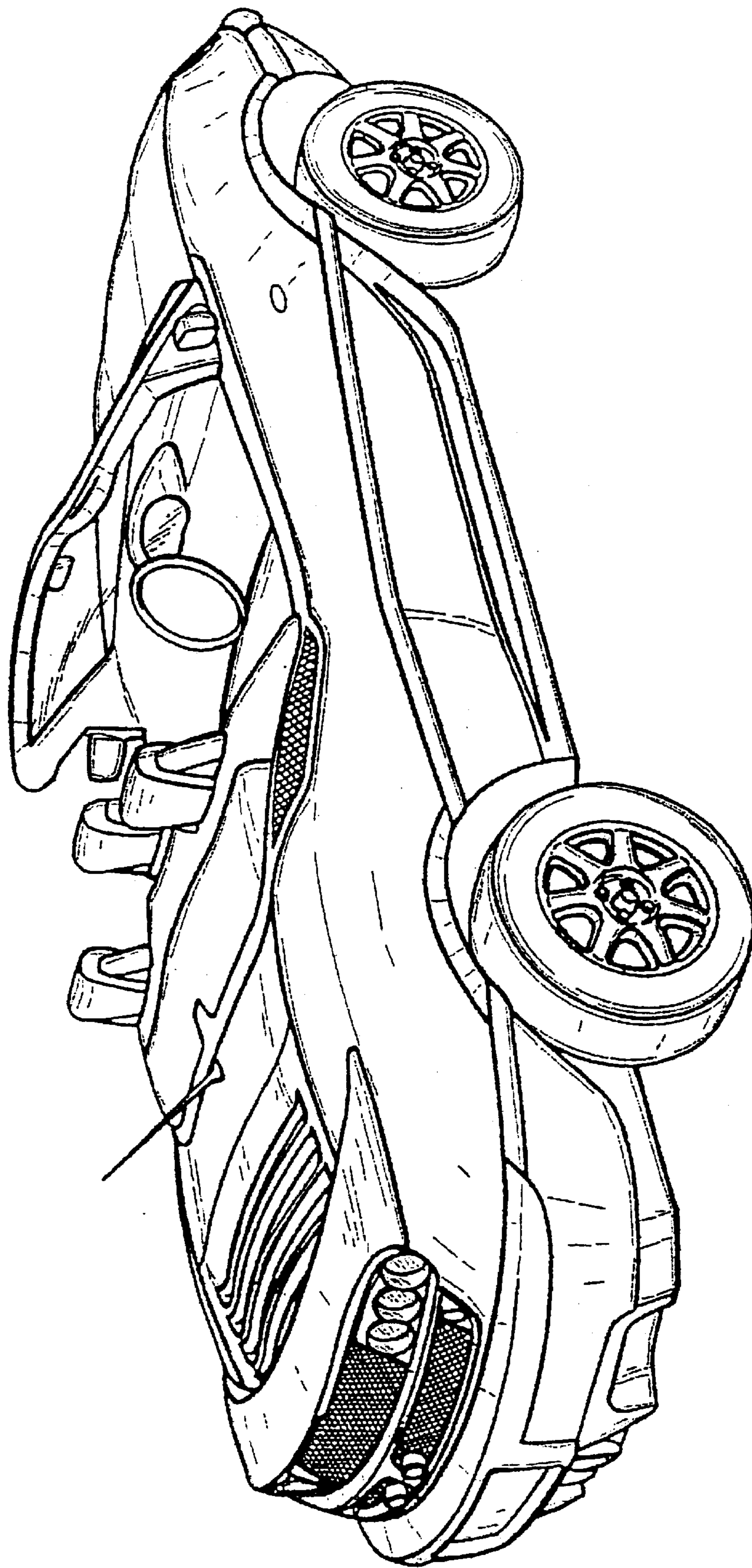
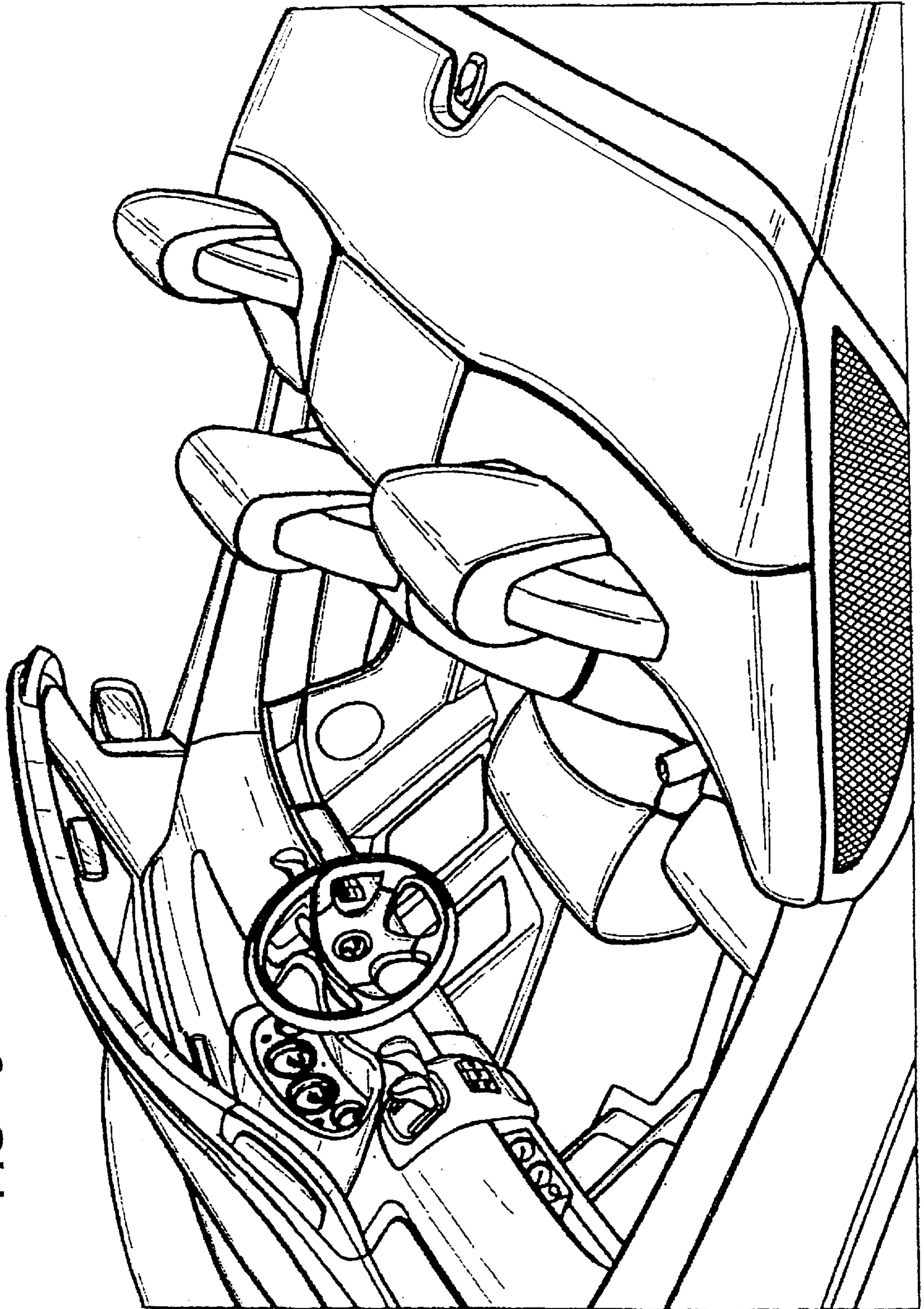

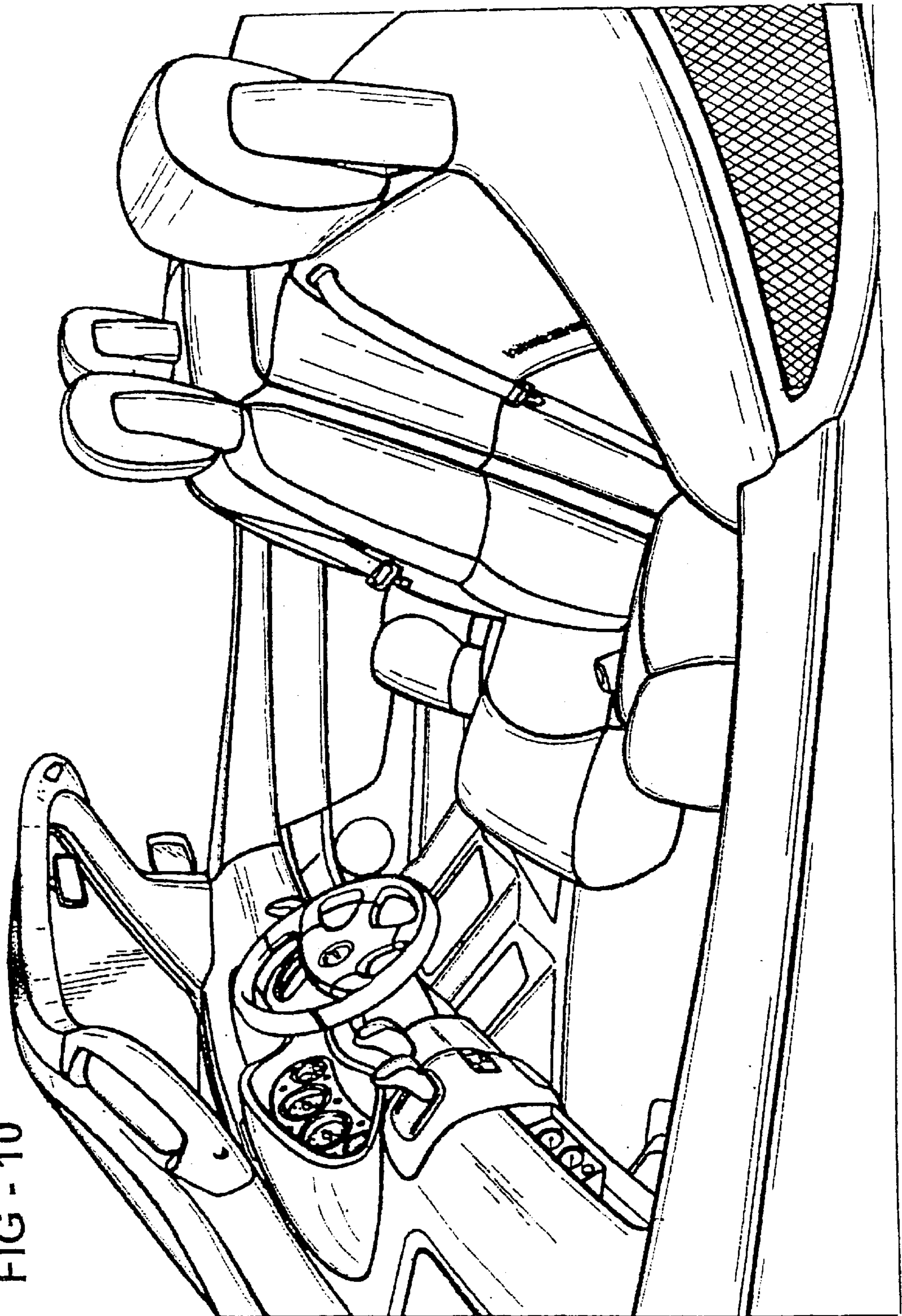

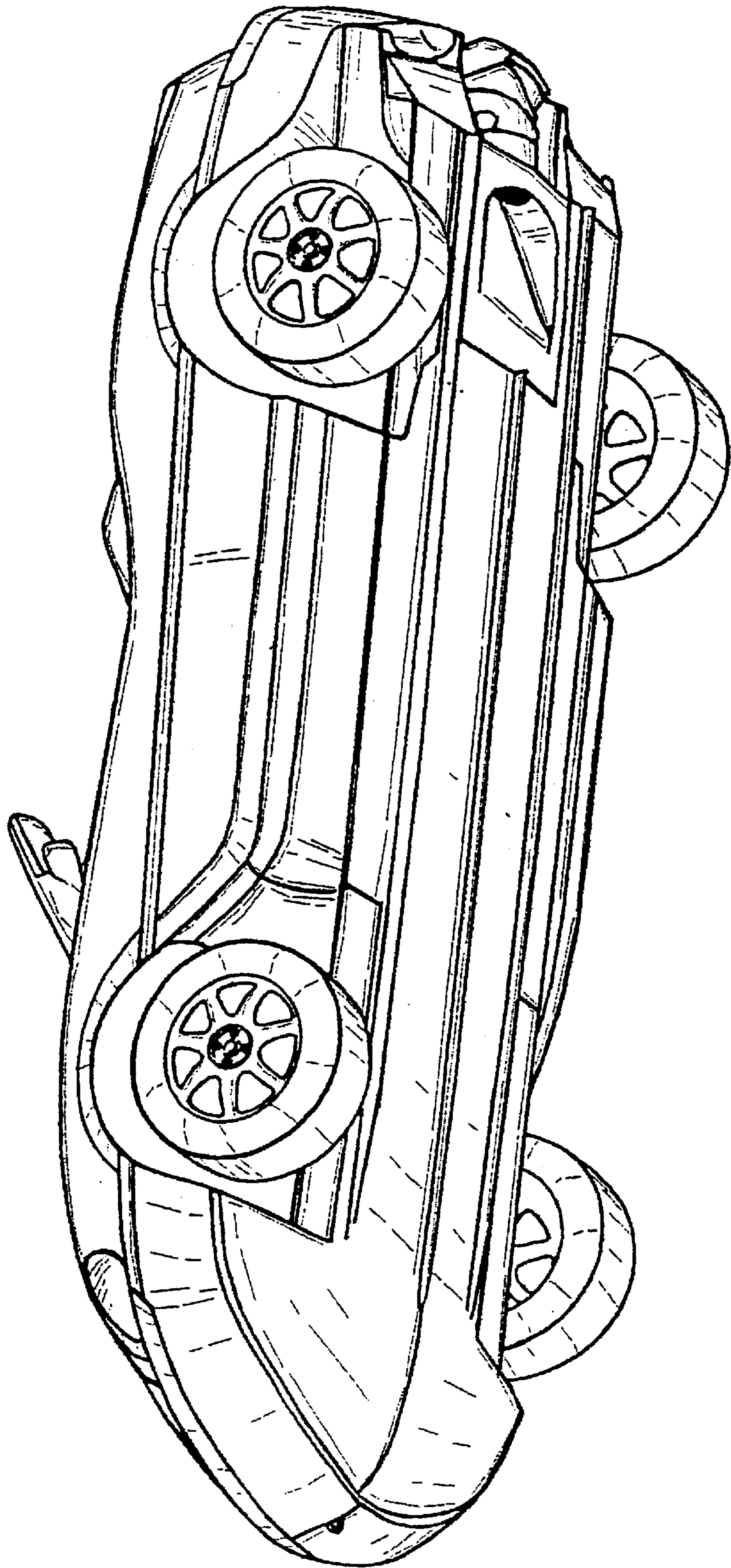
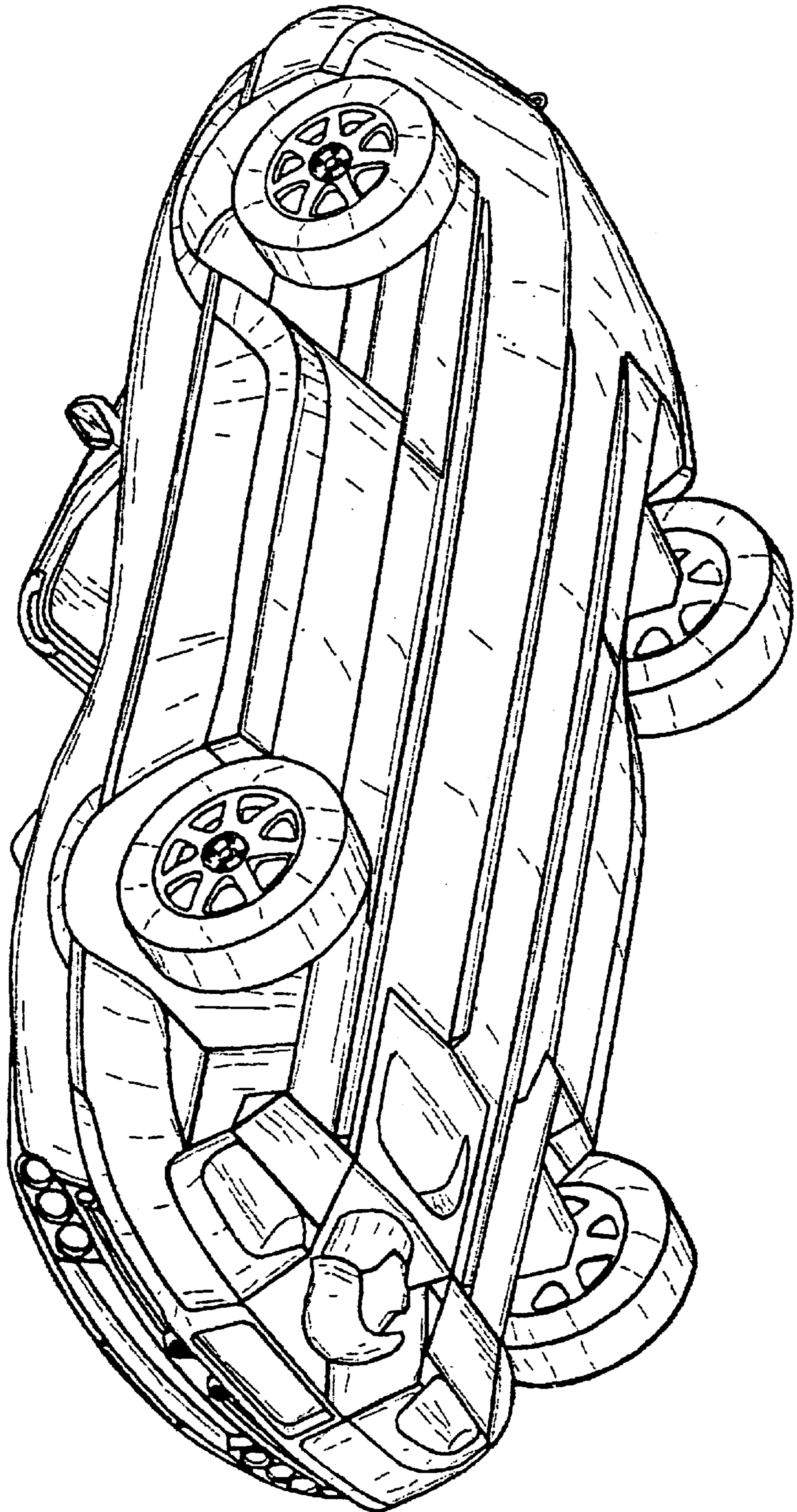
