The ornamental design for a wheel for motor vehicle, as shown and described.

DESCRIPTION

FIG. 1 is a left front perspective view of a wheel for motor vehicle;

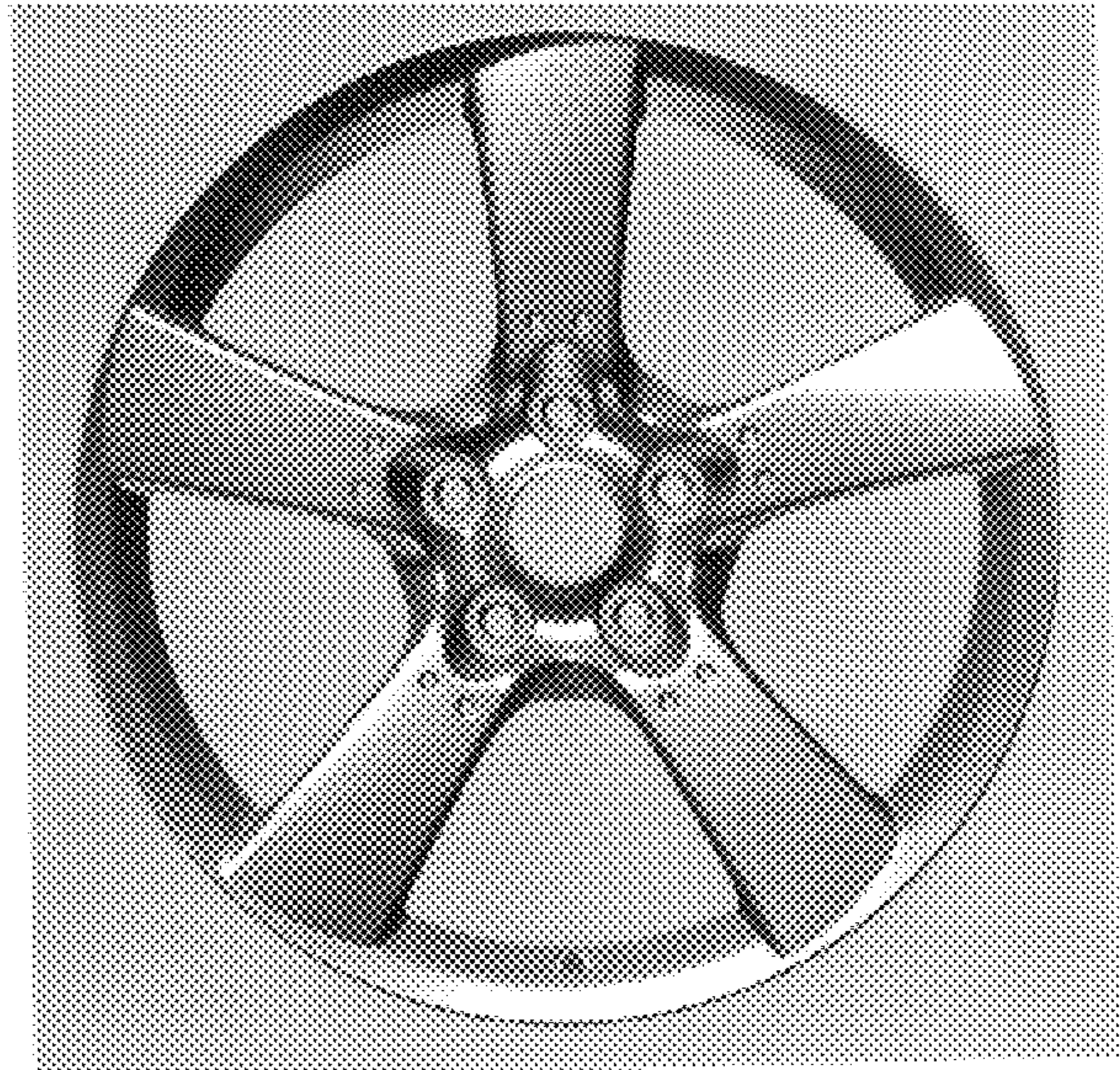
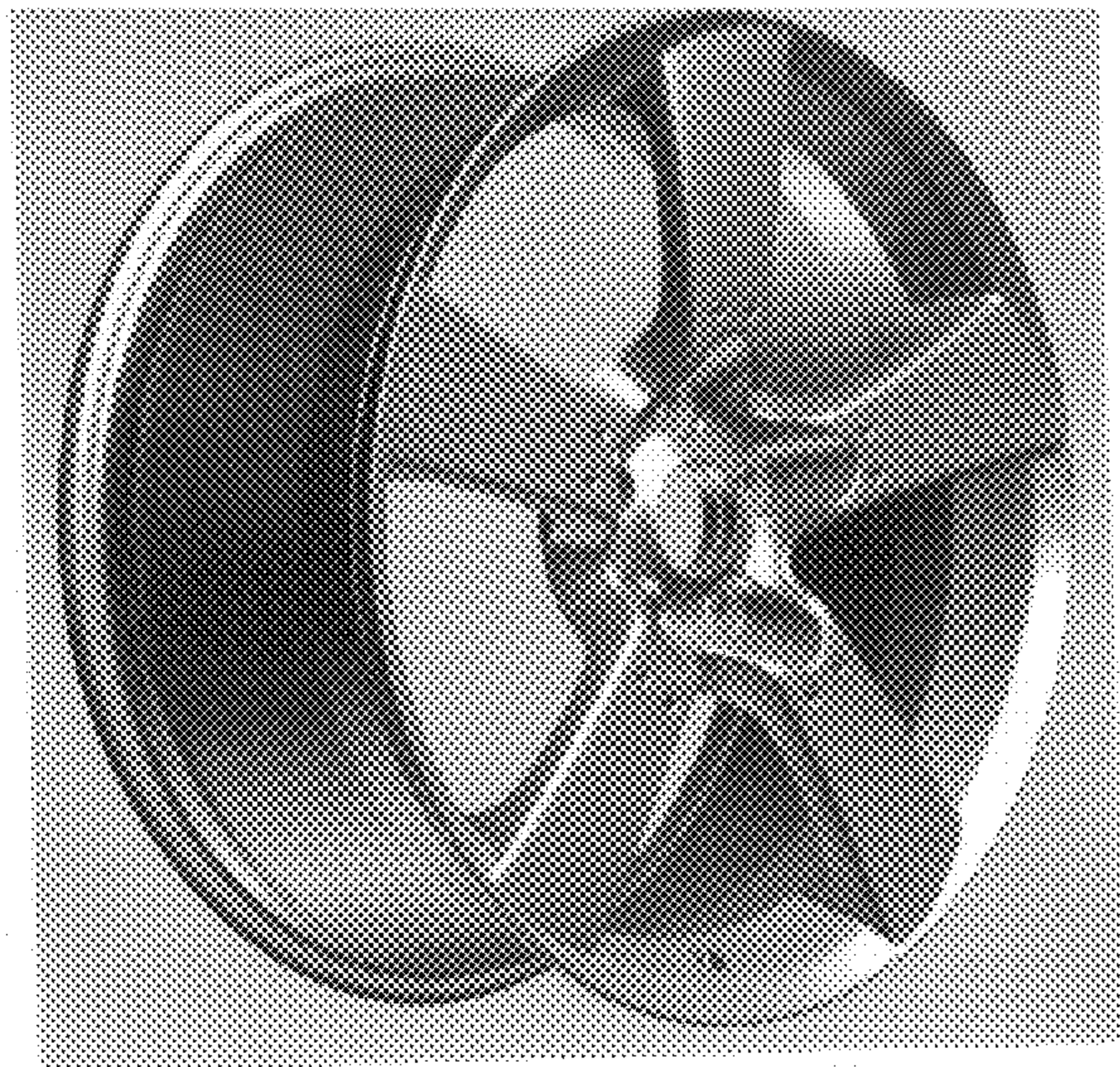

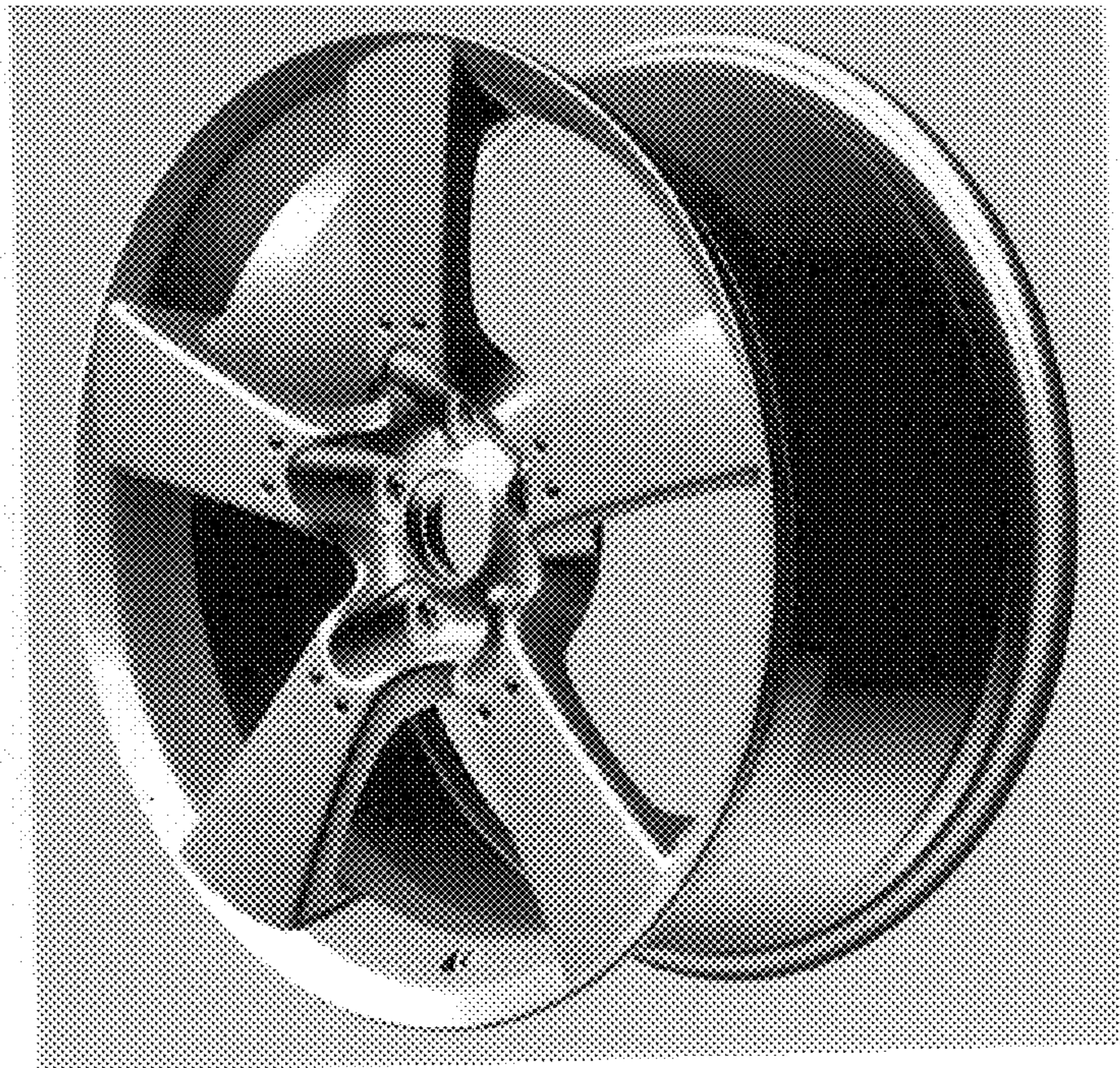

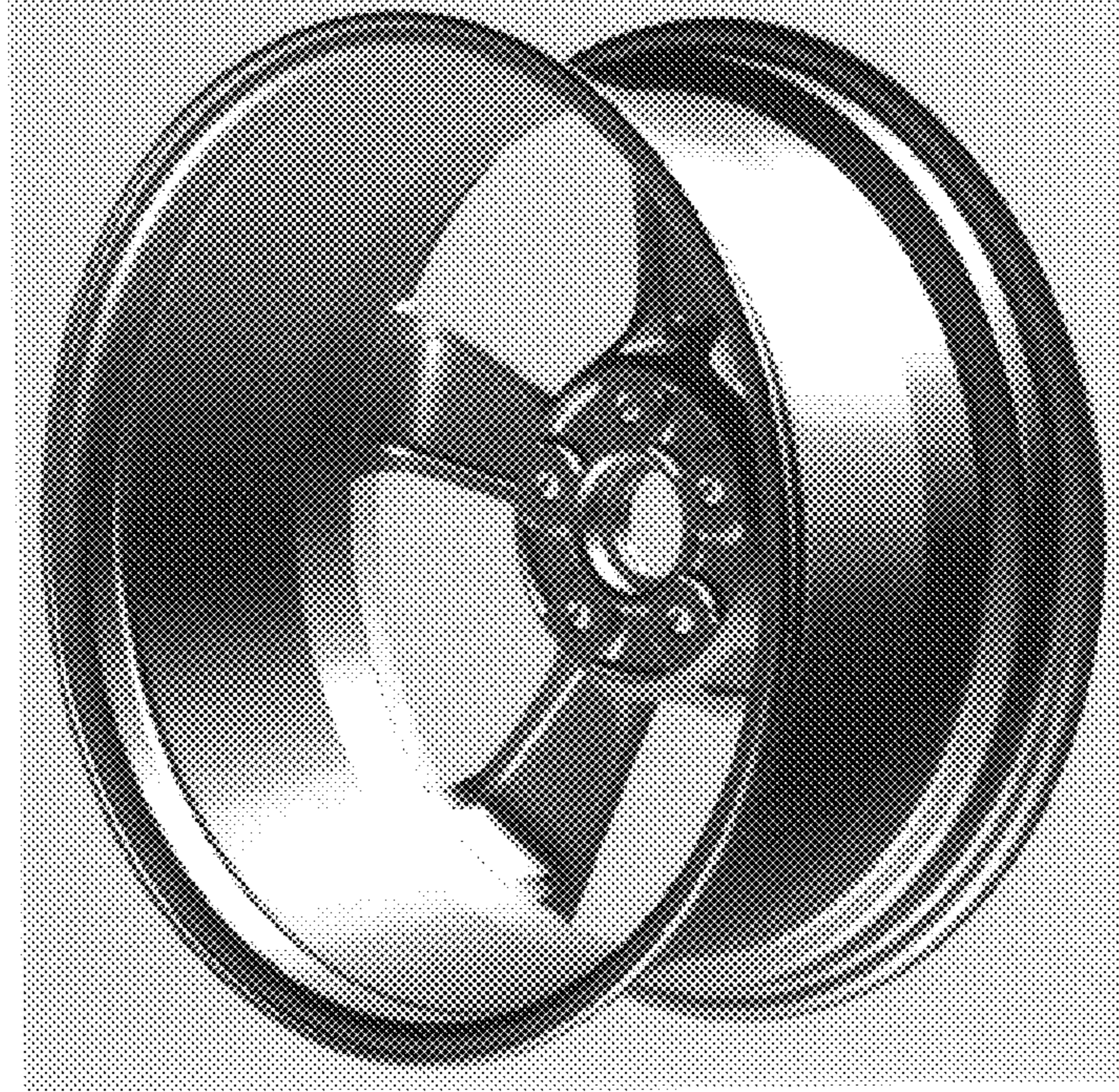

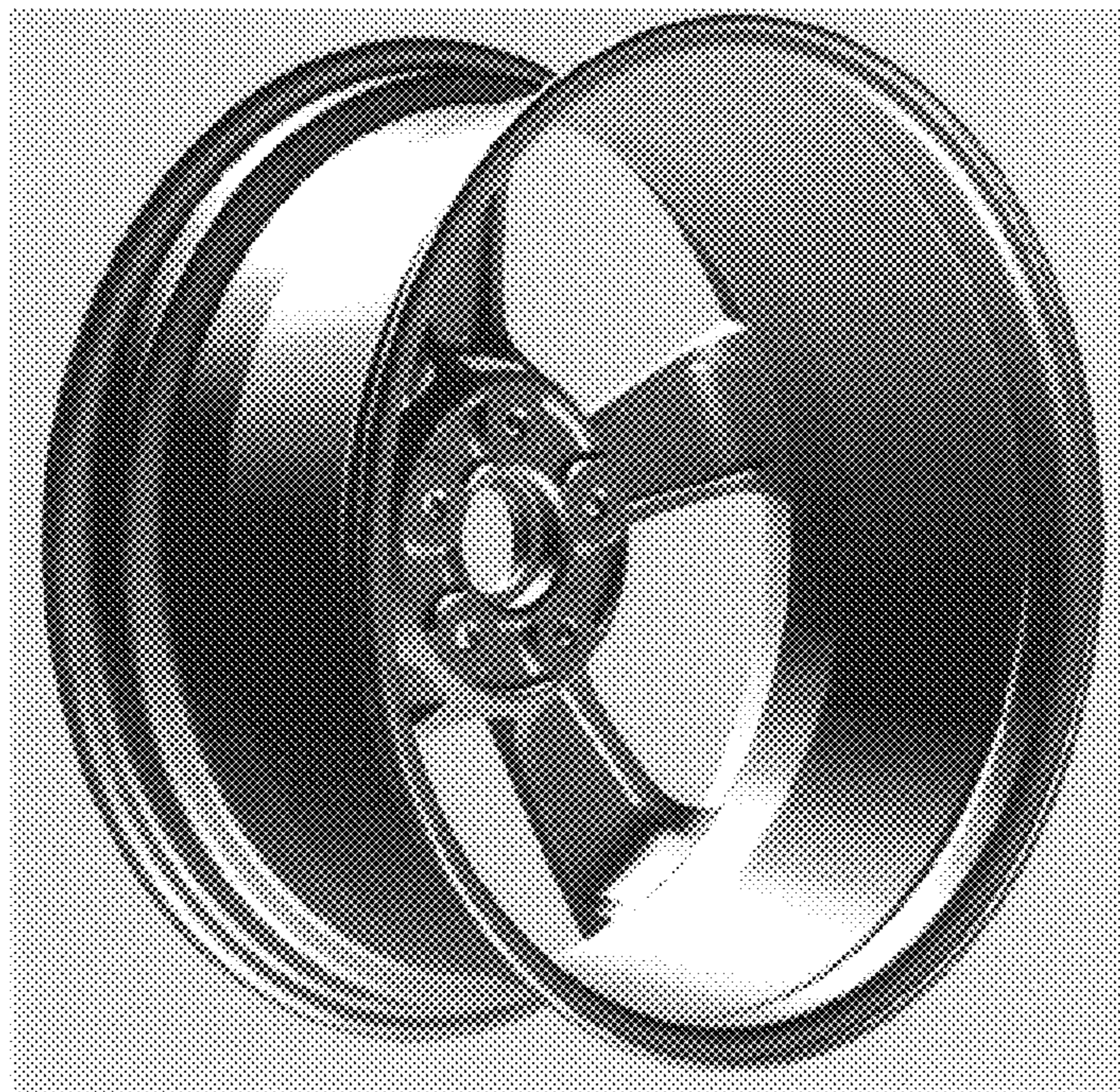

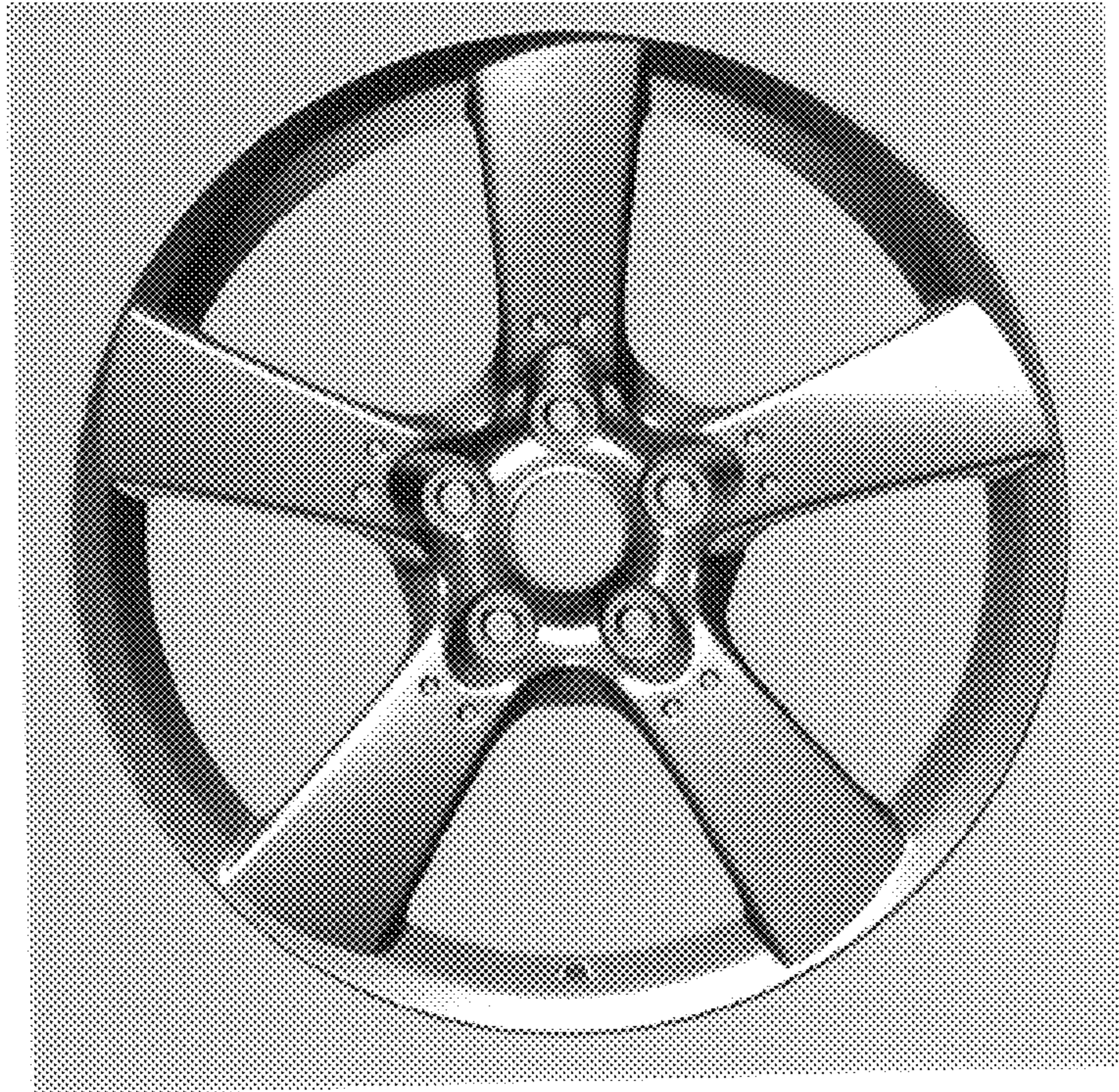

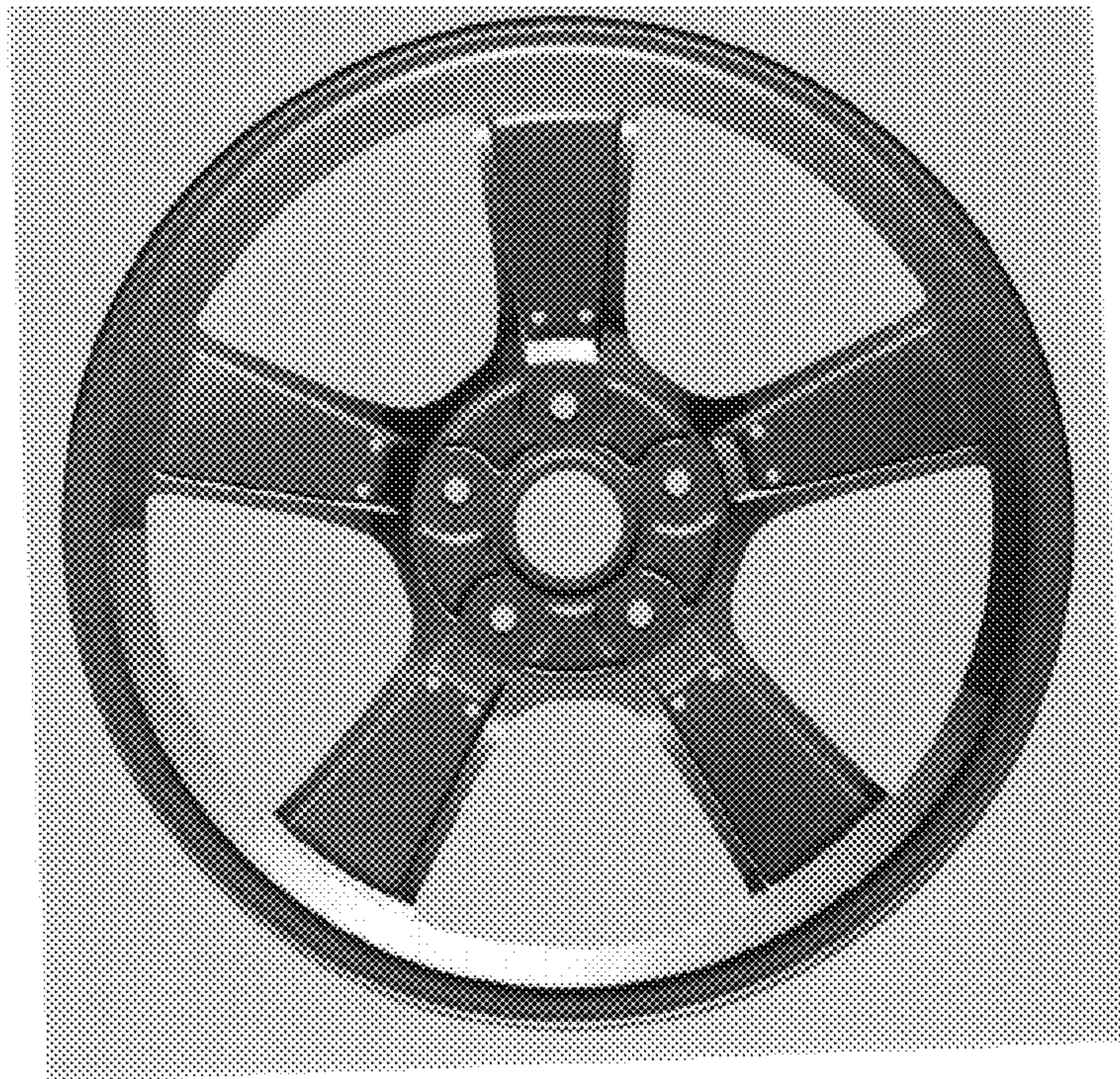

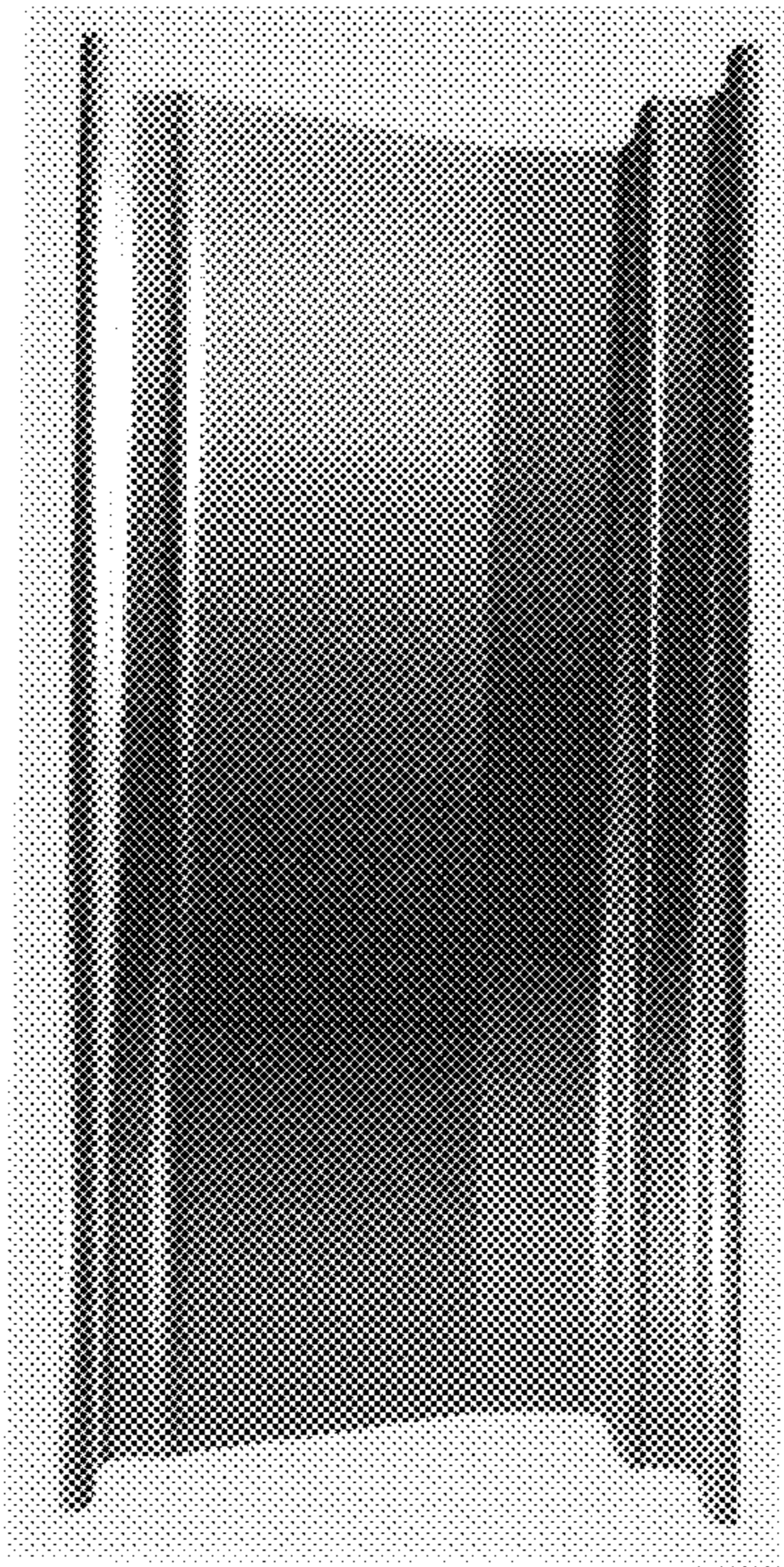

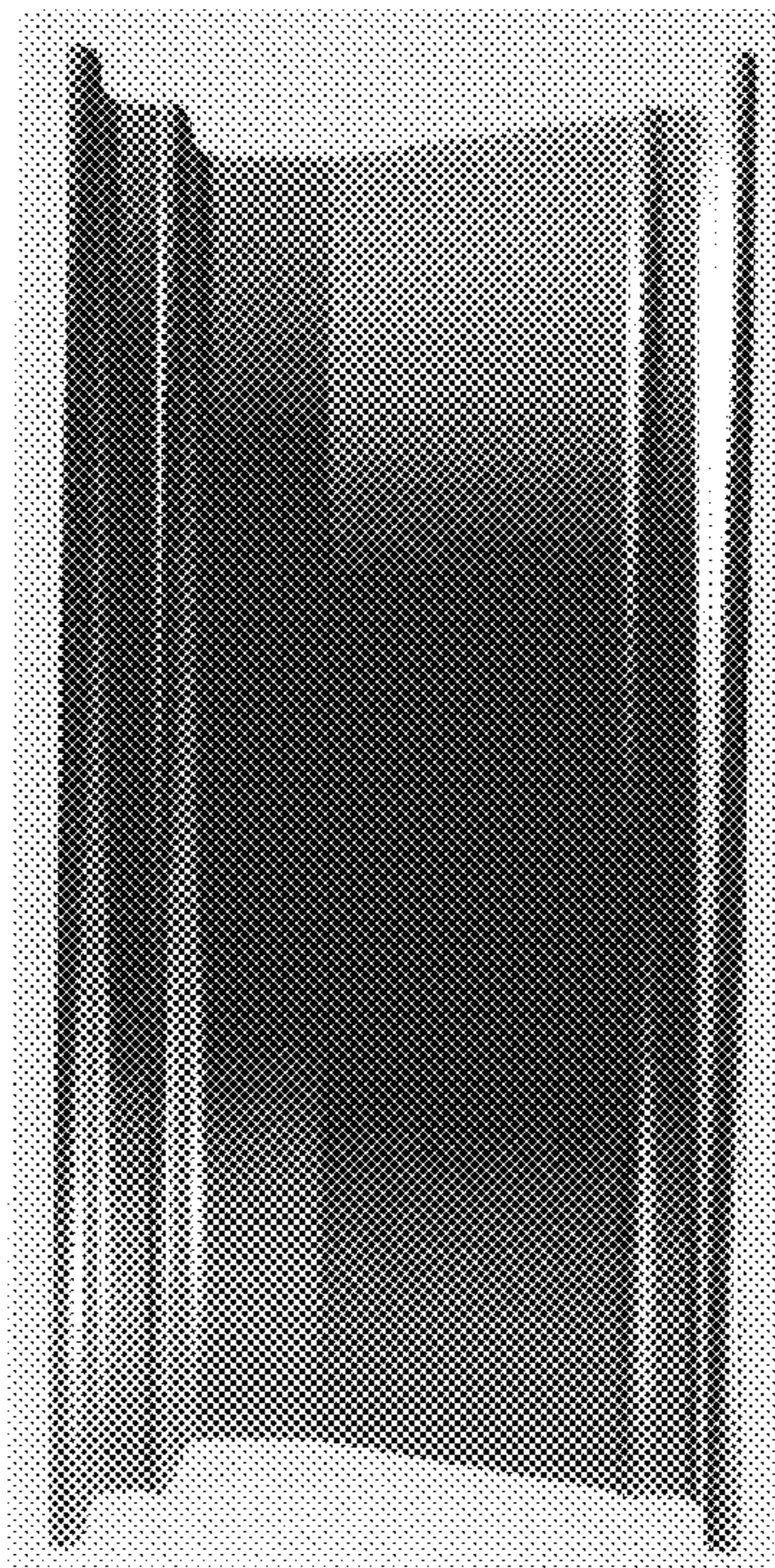

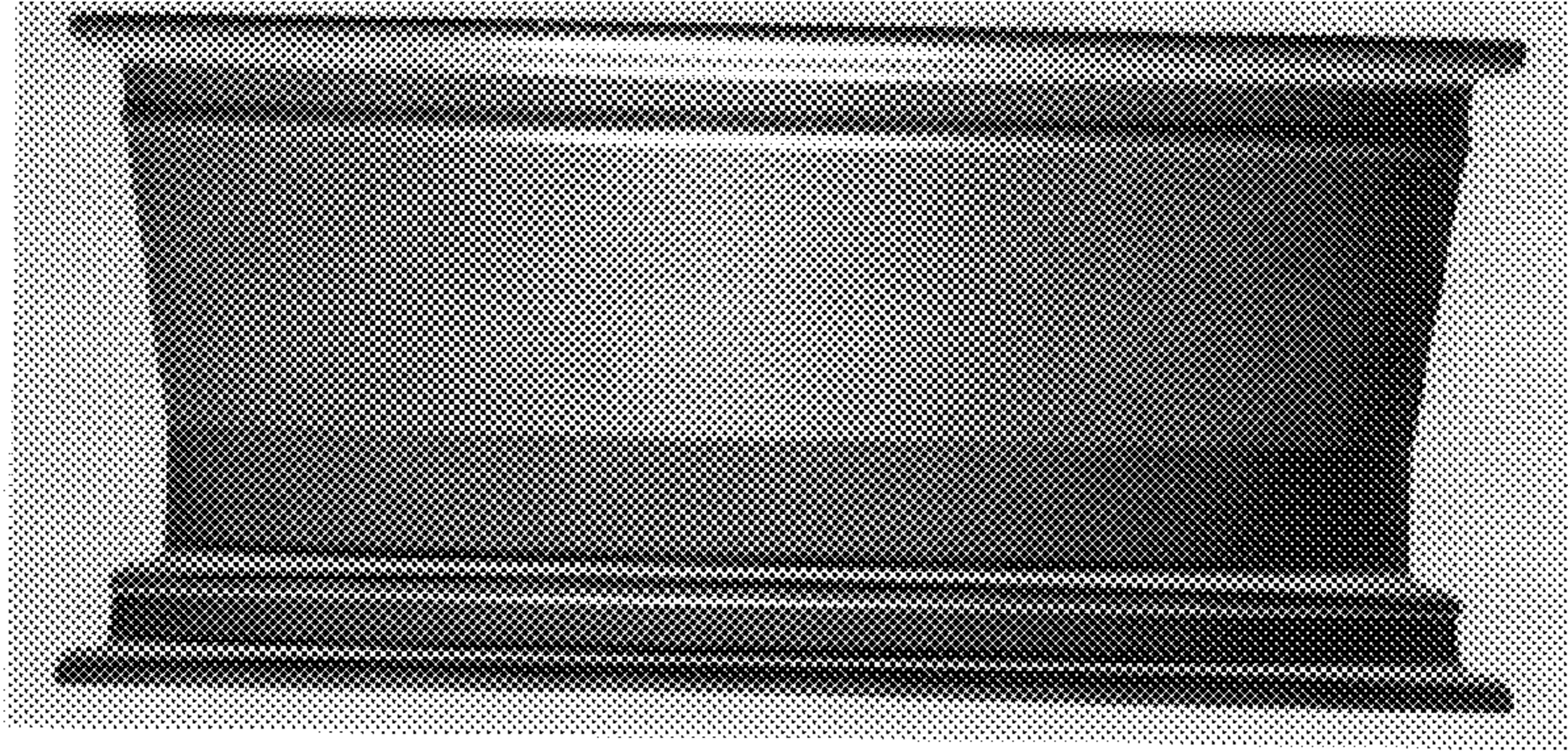
