(57) **CLAIM**

The ornamental design for a housing for a communications device or similar articles, as shown.

DESCRIPTION

FIG. 1 is a front, bottom and first side perspective view of an ornamental design for a housing for a communication device or similar articles.

FIG. 2 is a second side elevation view thereof.

FIG. 3 is a front elevation view thereof.

FIG. 4 is a bottom plan view thereof.

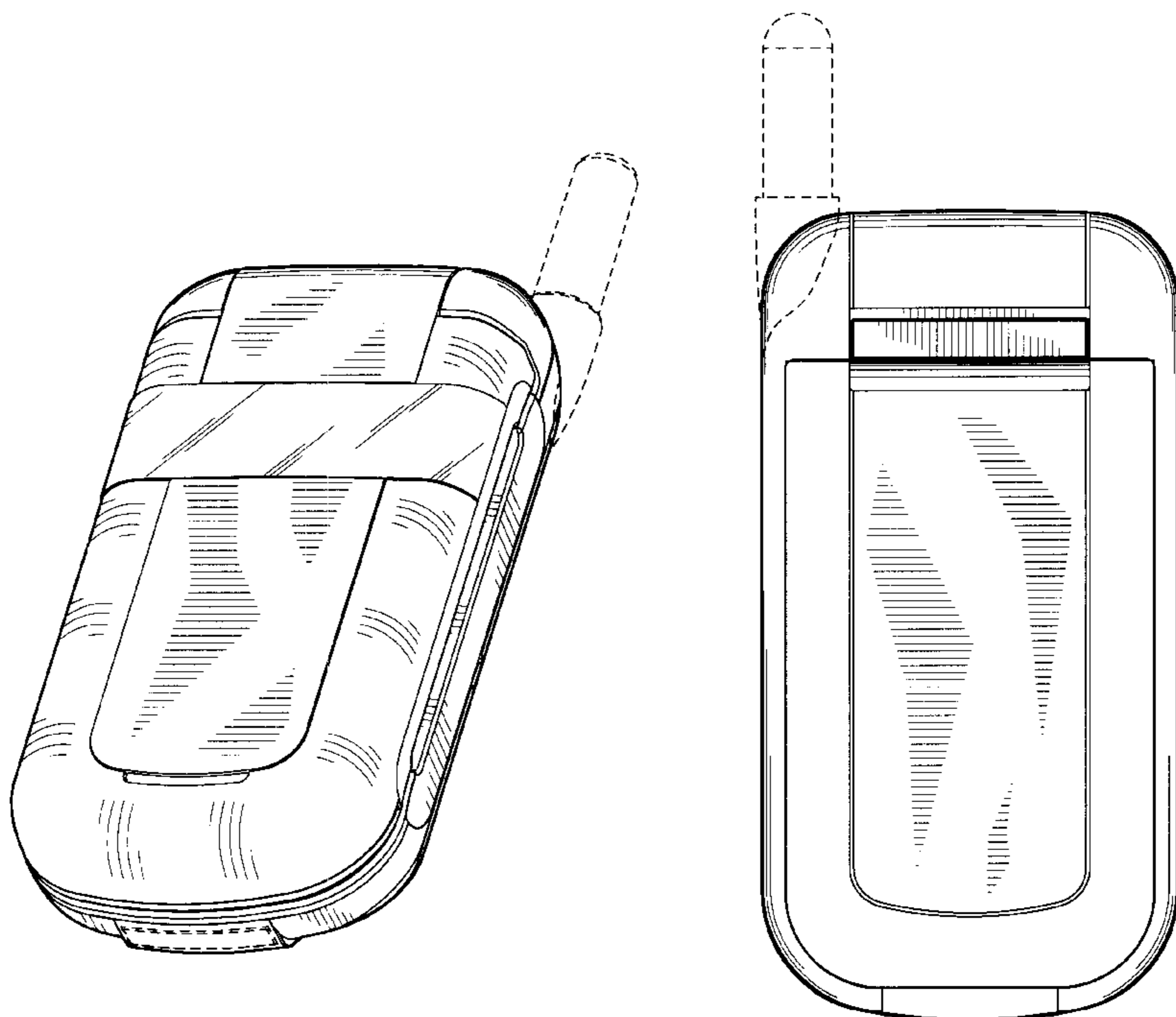
FIG. 5 is a top plan view thereof.

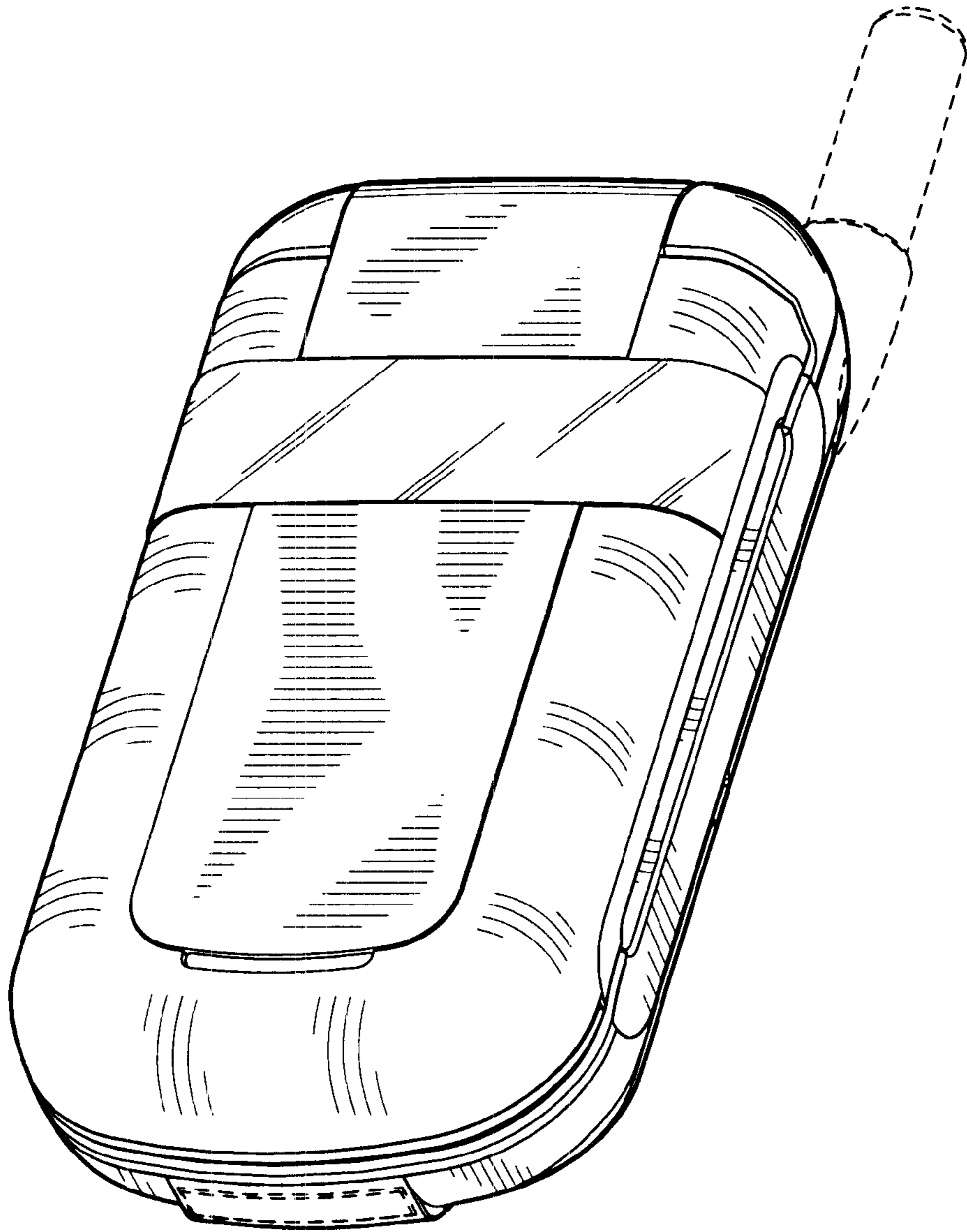

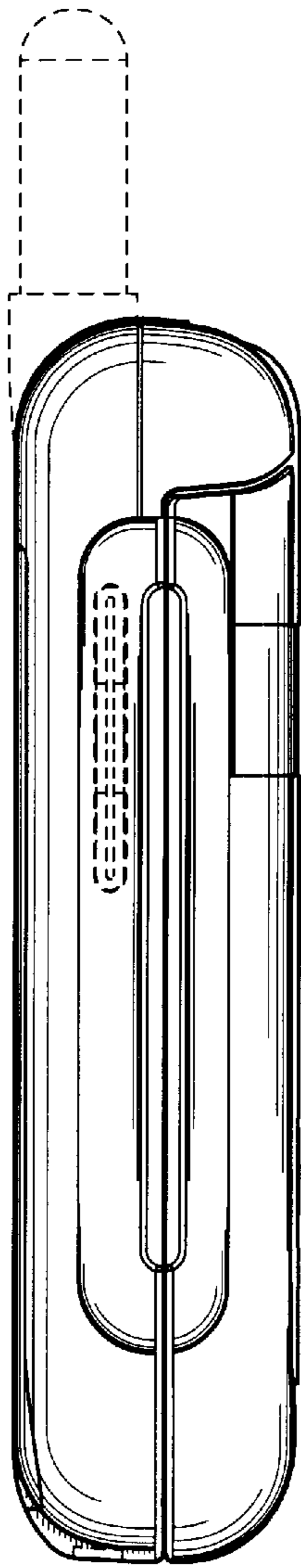

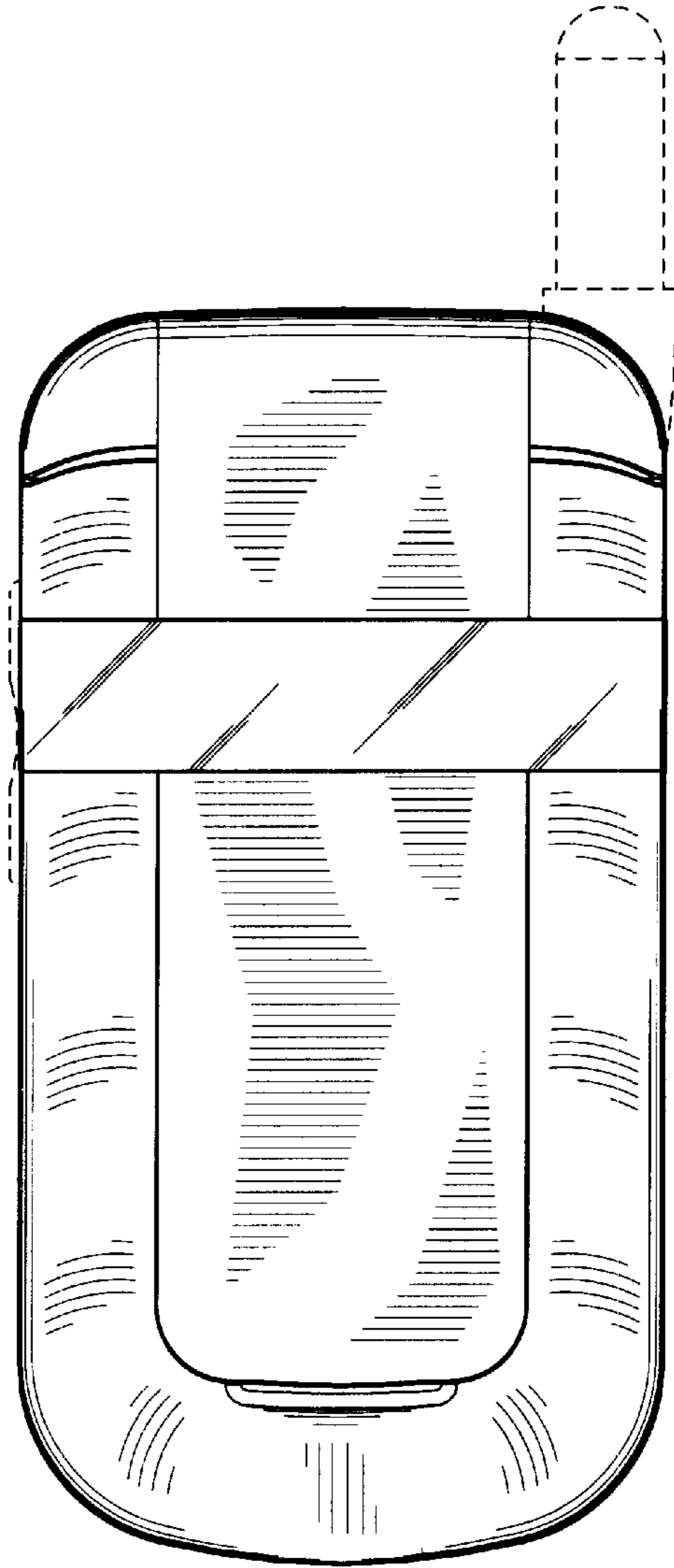

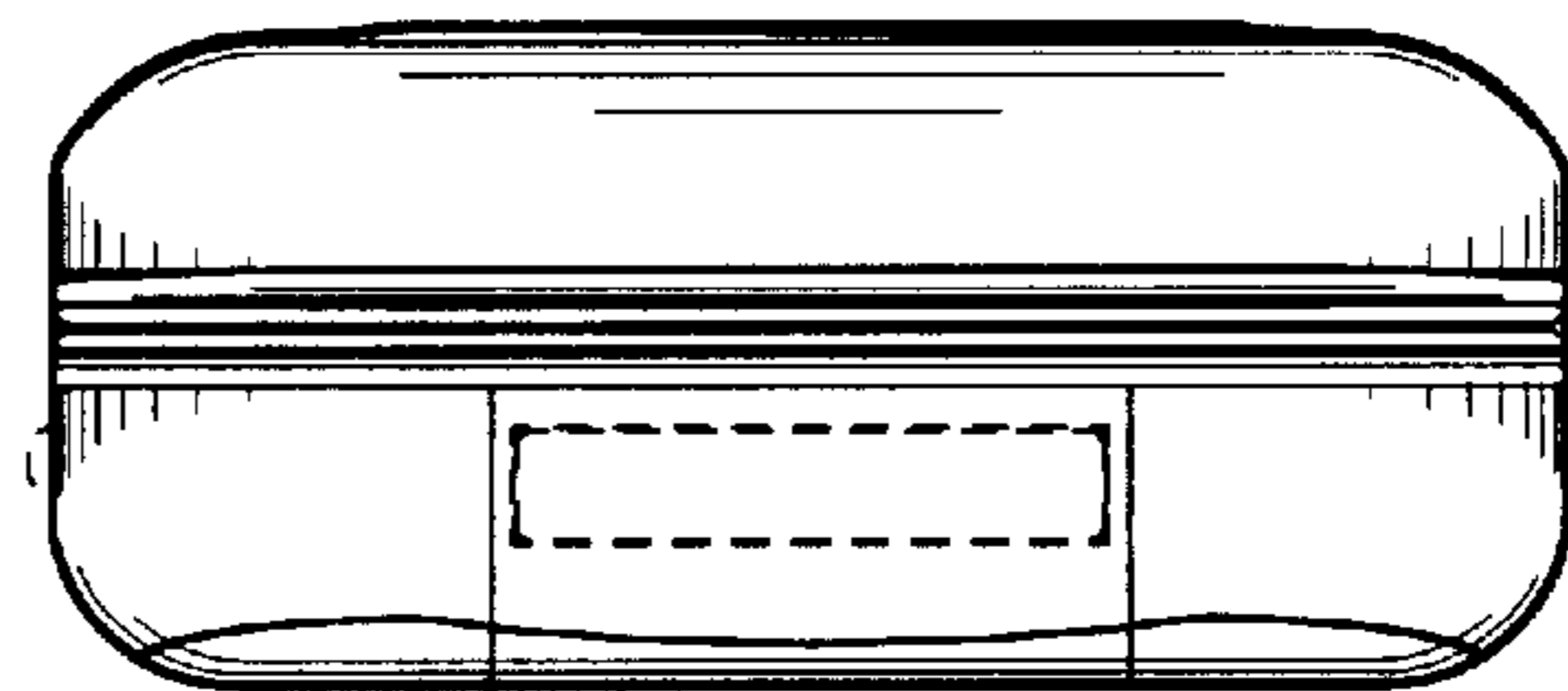

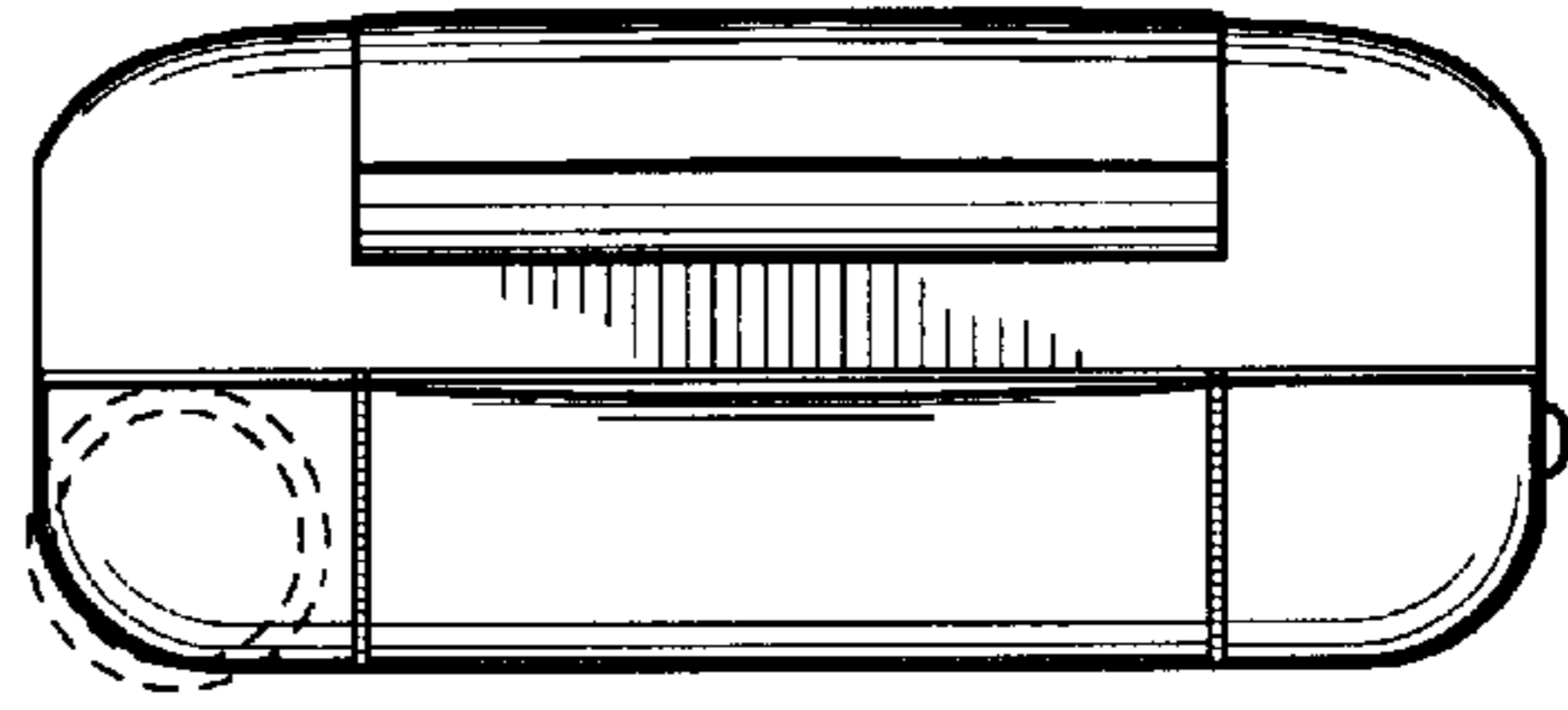

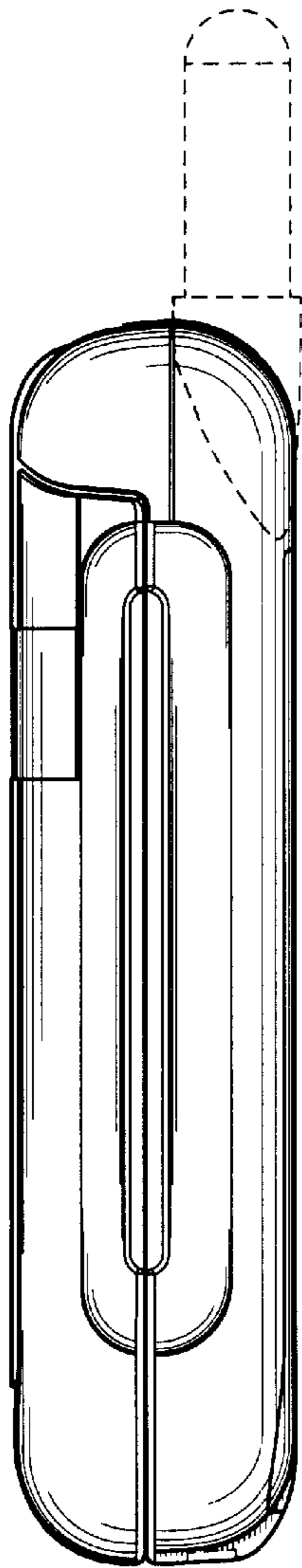

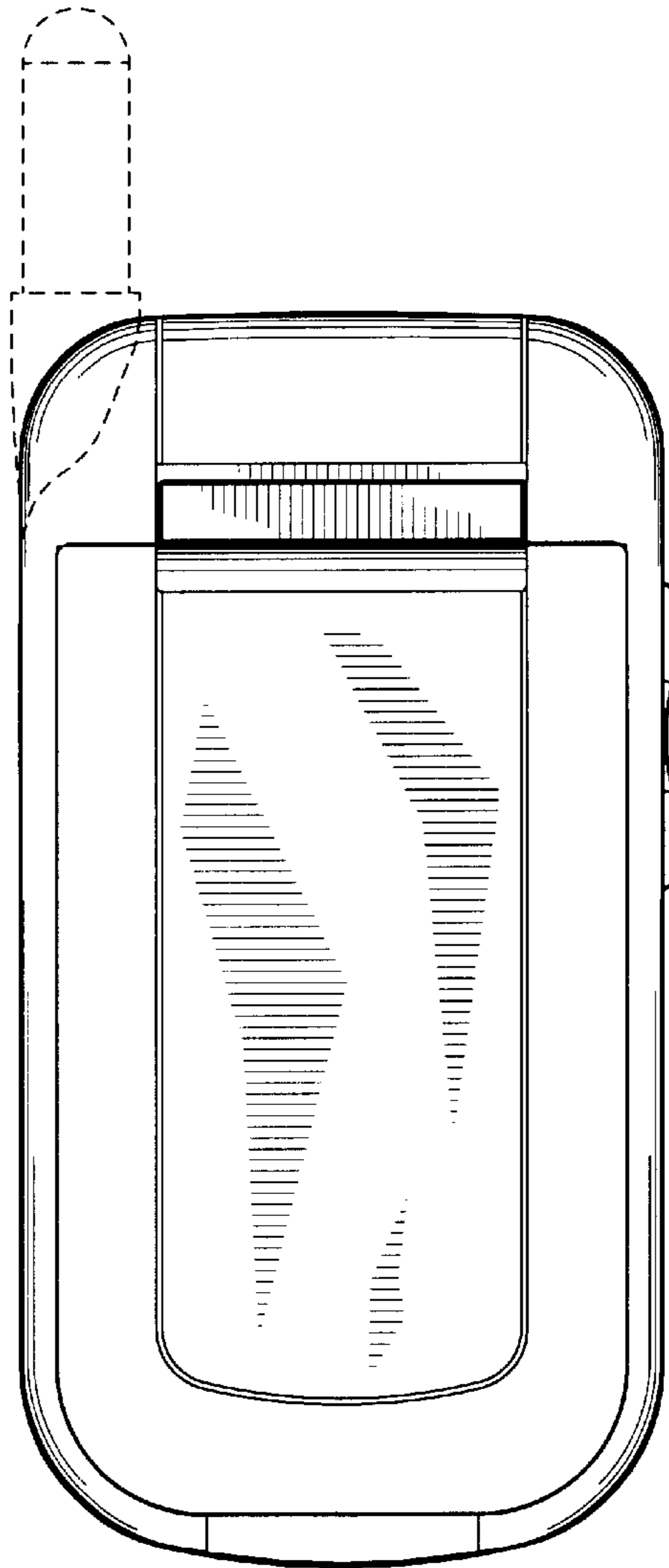
