(57) **CLAIM**

I claim the ornamental design for a multipoint marker, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a multipoint marker in an exploded condition;
FIG. 2 is a perspective view with the cap member in place;
FIG. 3 is a front elevational view of FIG. 2;
FIG. 4 is a rear elevational view of FIG. 2;
FIG. 5 is a left side elevational view of FIG. 2;
FIG. 6 is a top plan view of FIG. 2; and,
FIG. 7 is a bottom plan view of FIG. 2.

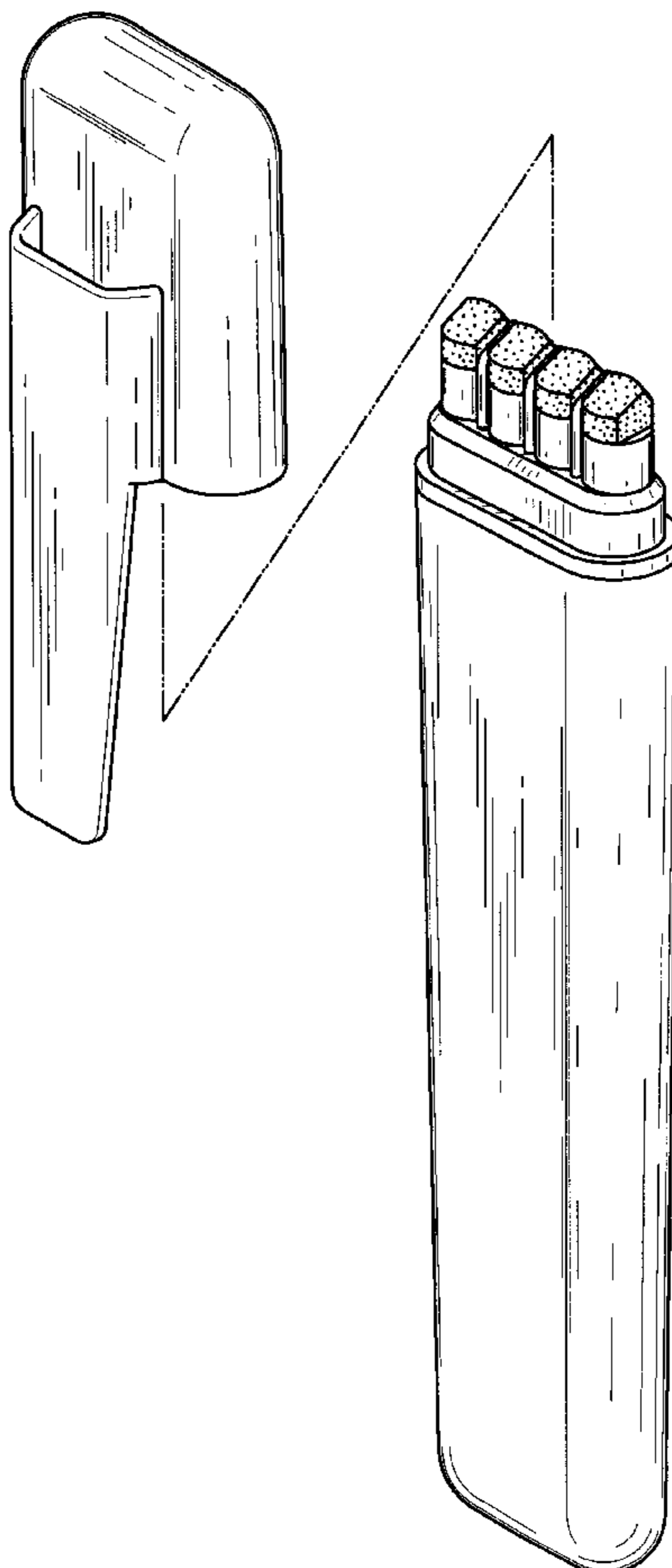

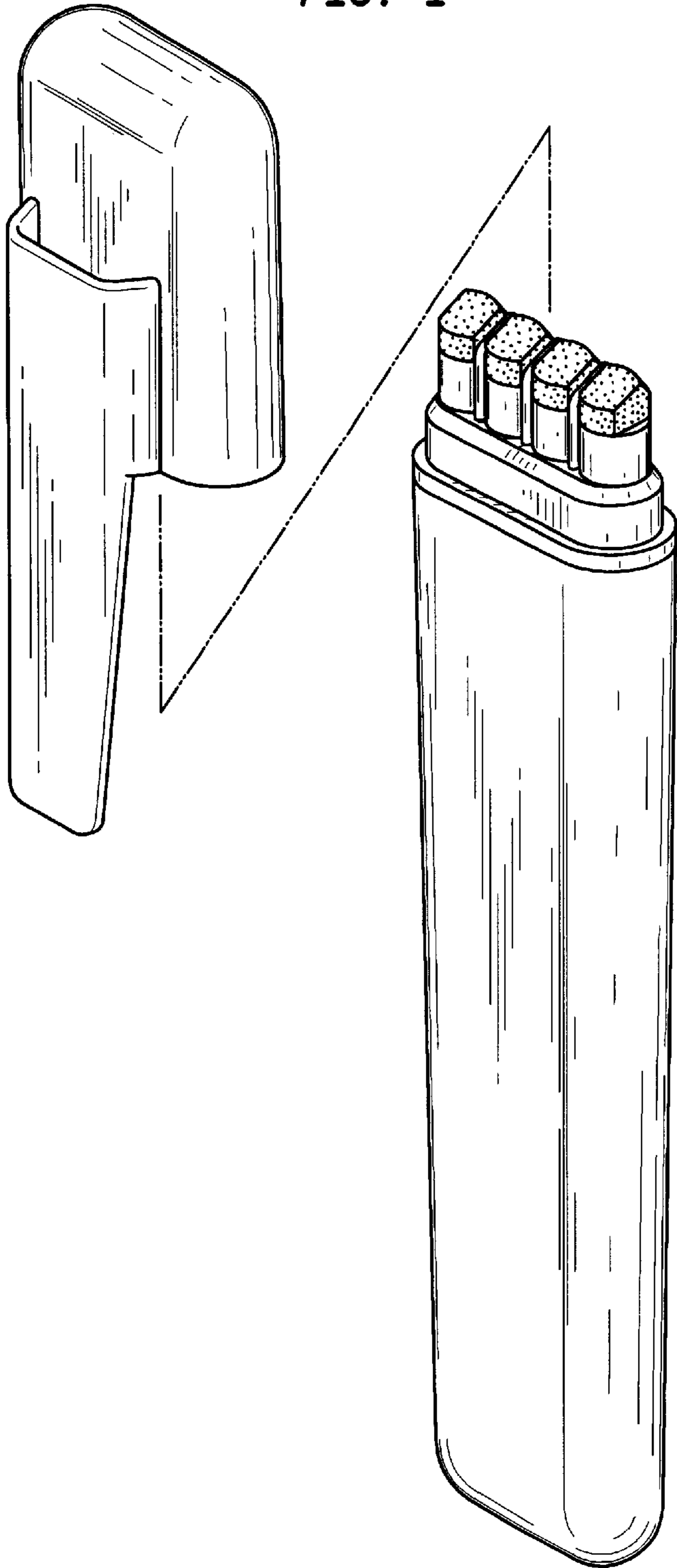

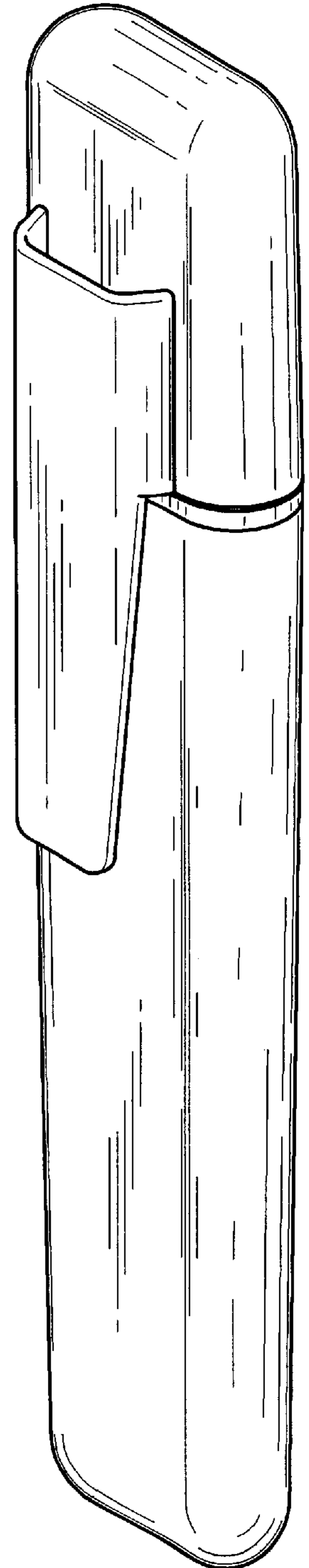

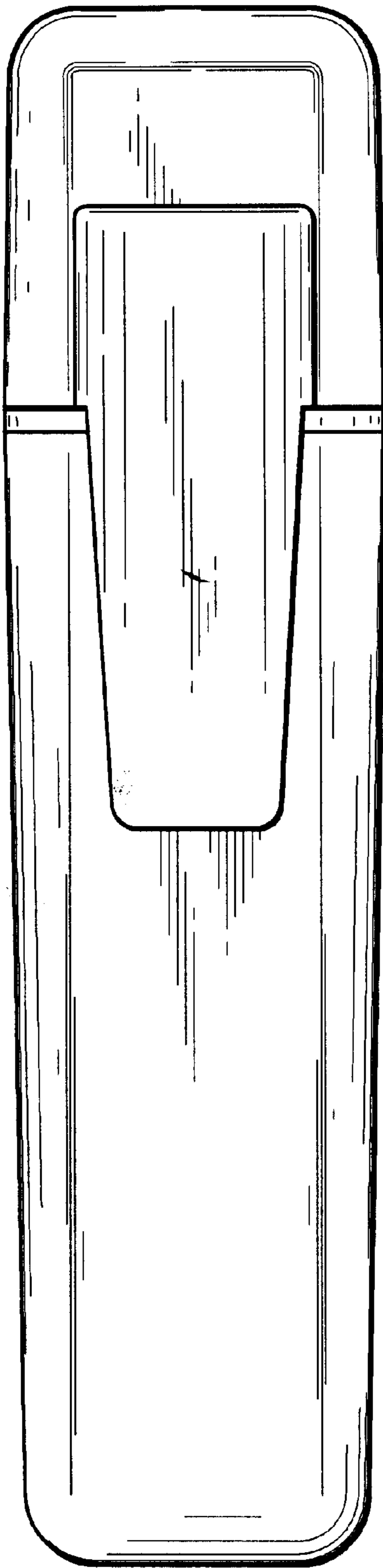

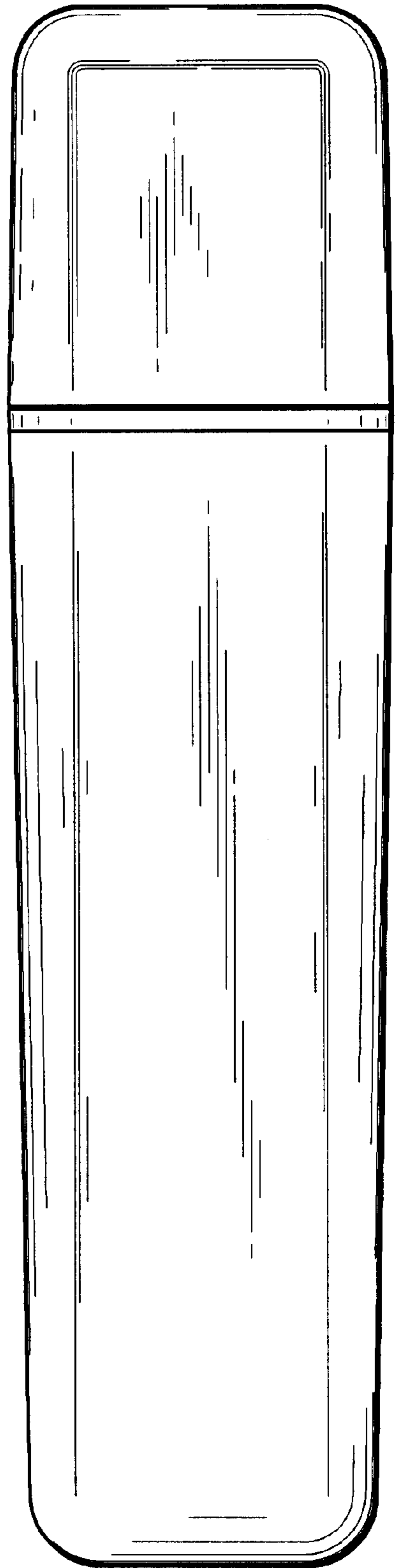

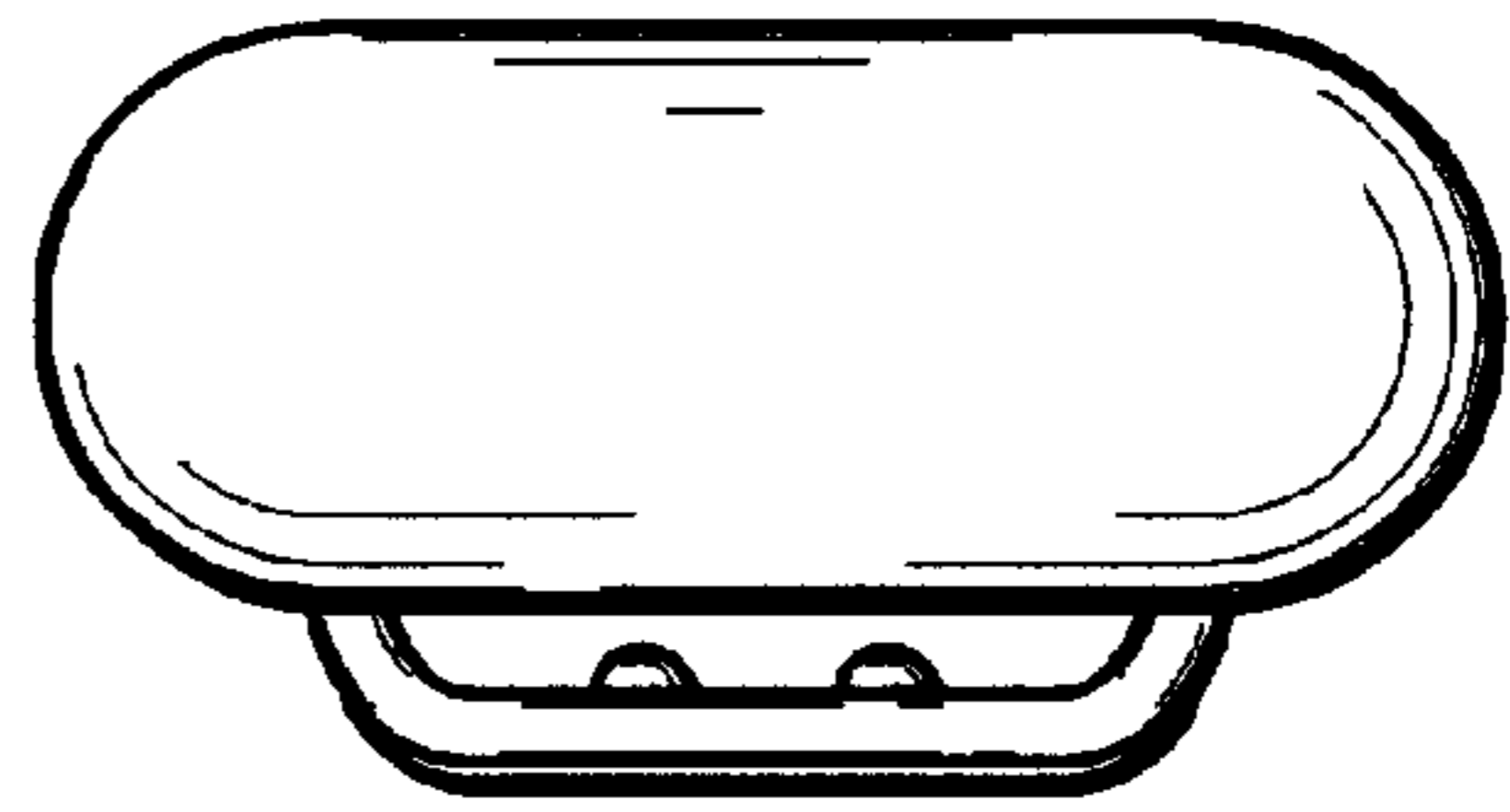
