FIG. 4 of a right side elevation view thereof

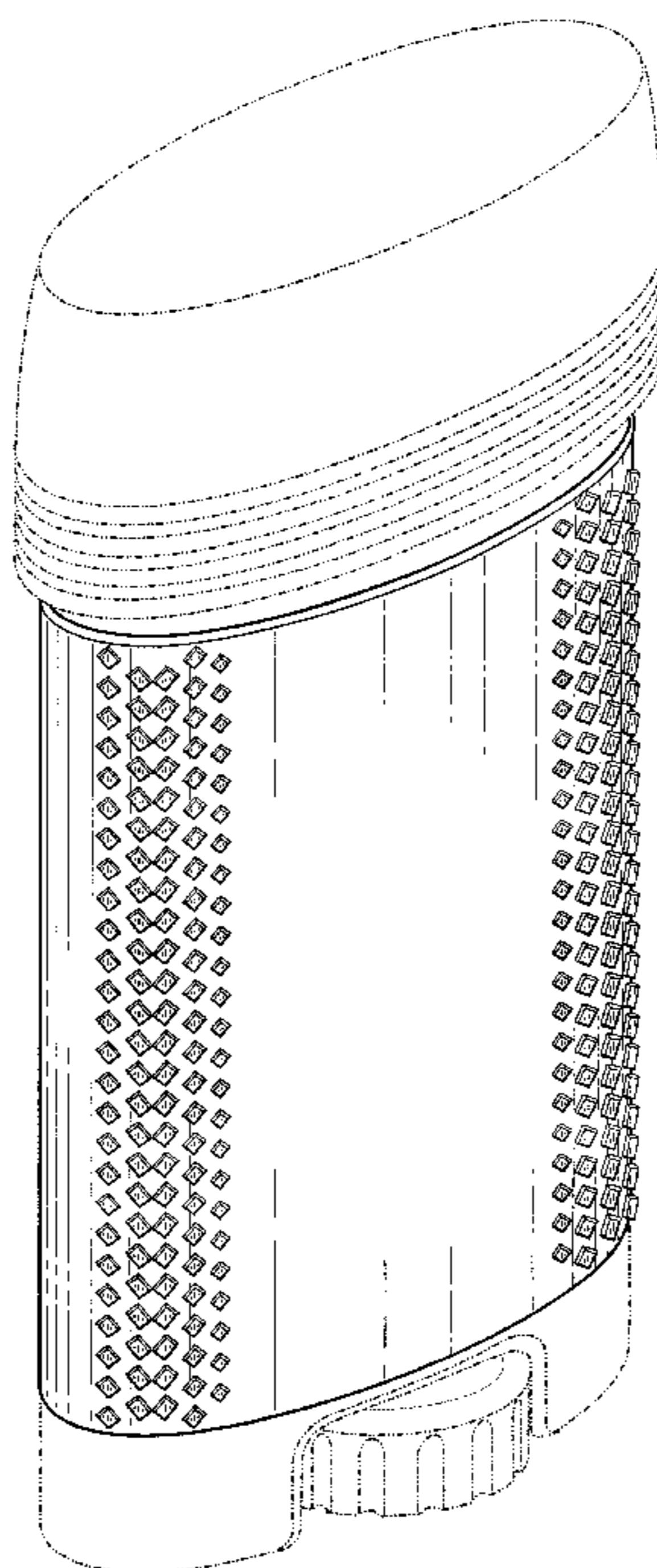
FIG. 5 is a left side elevation view thereof

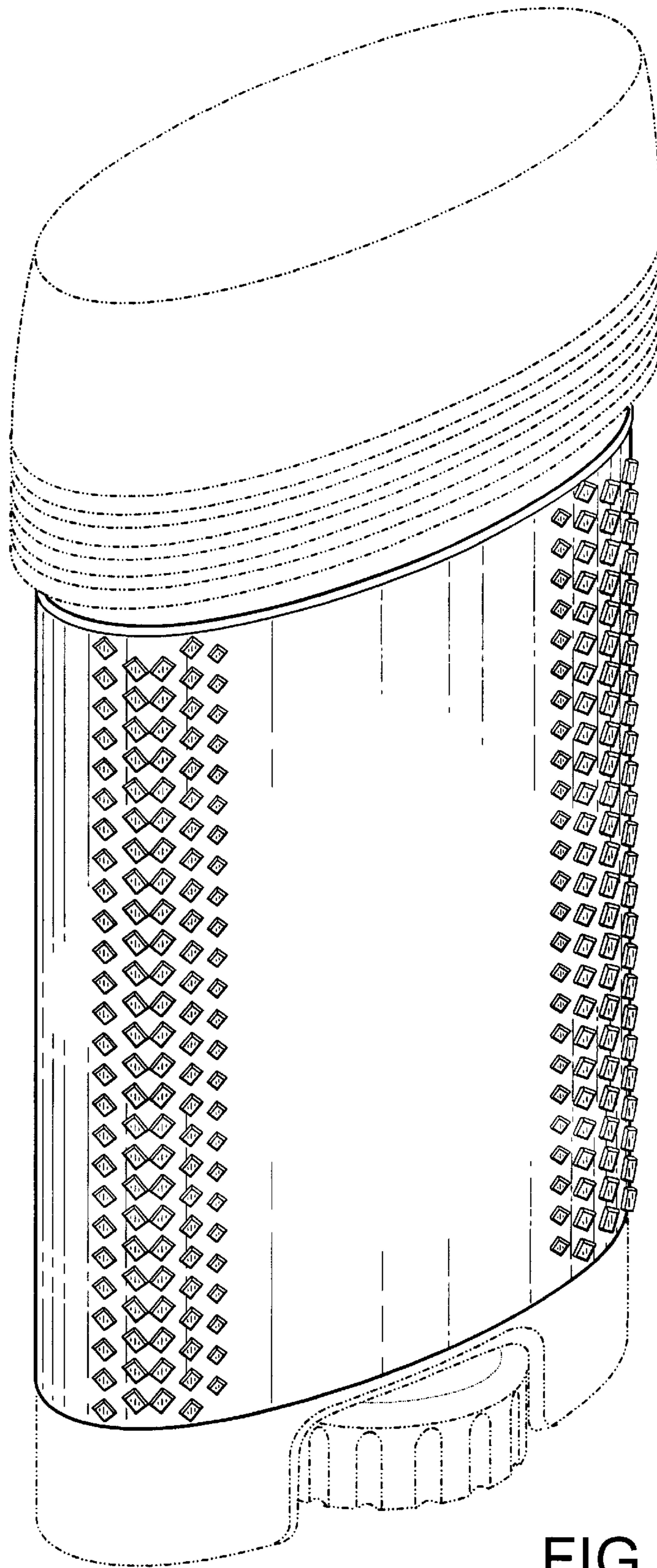

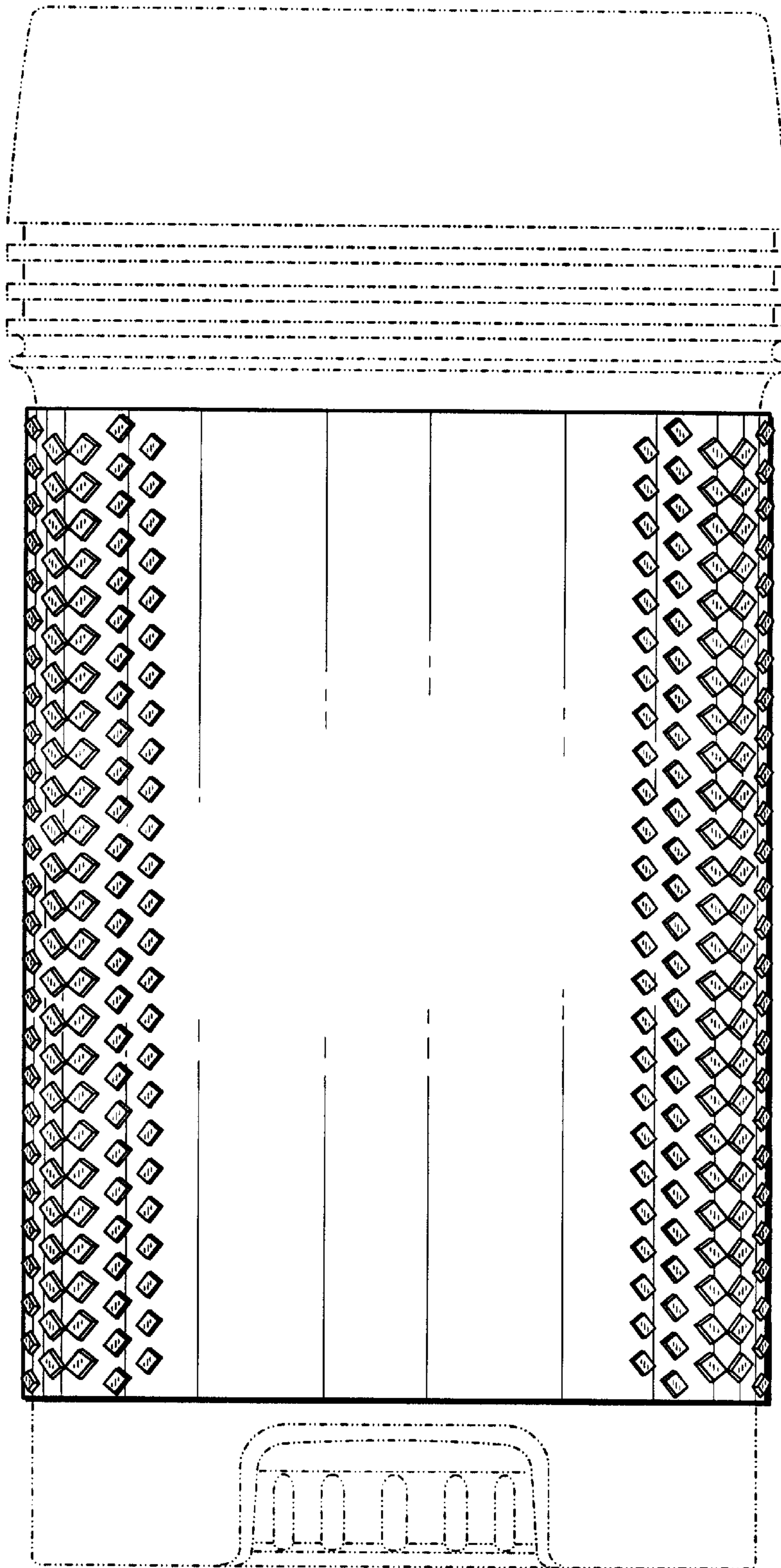

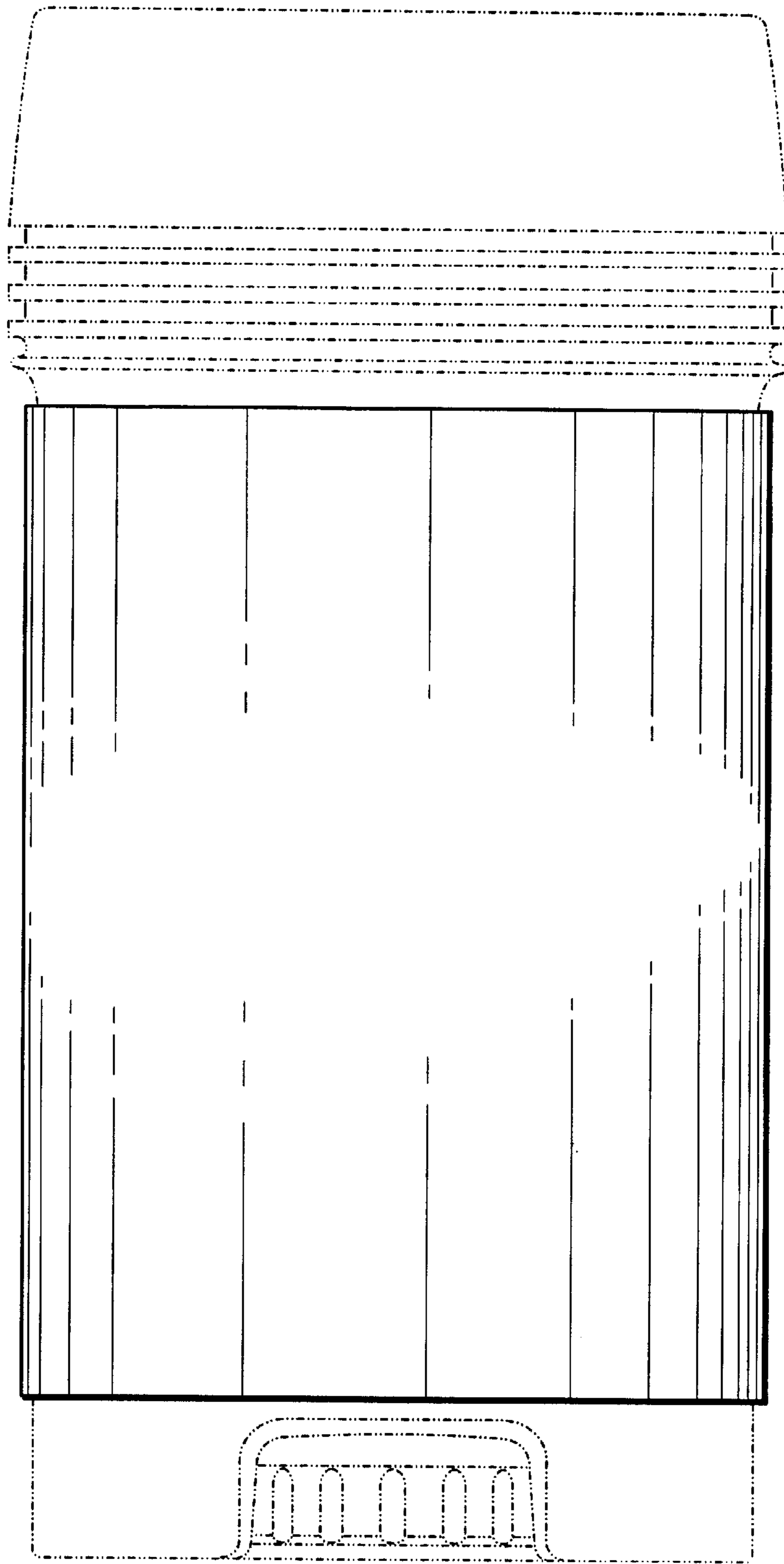

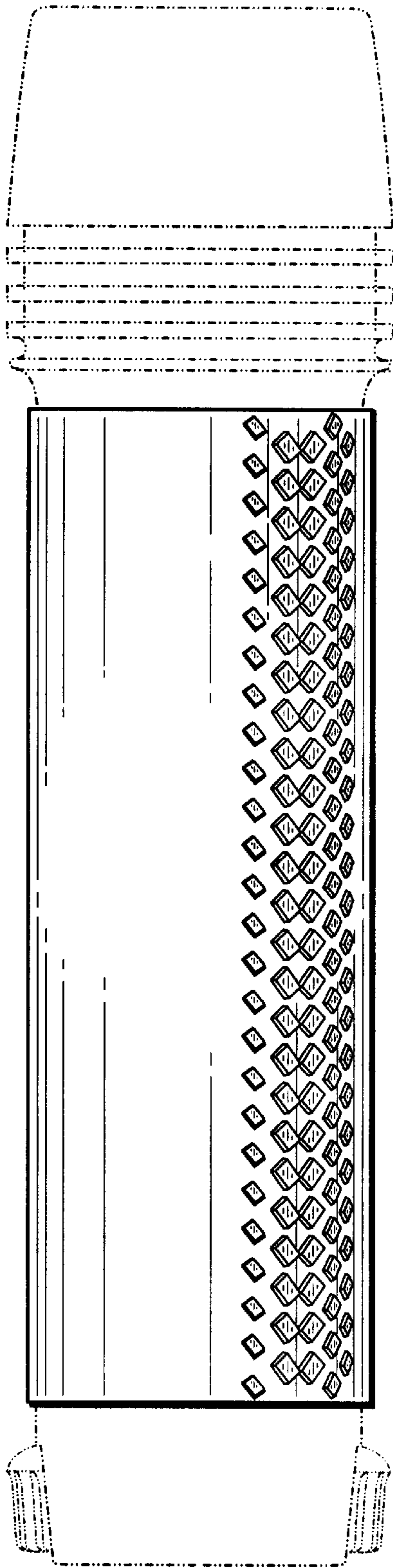

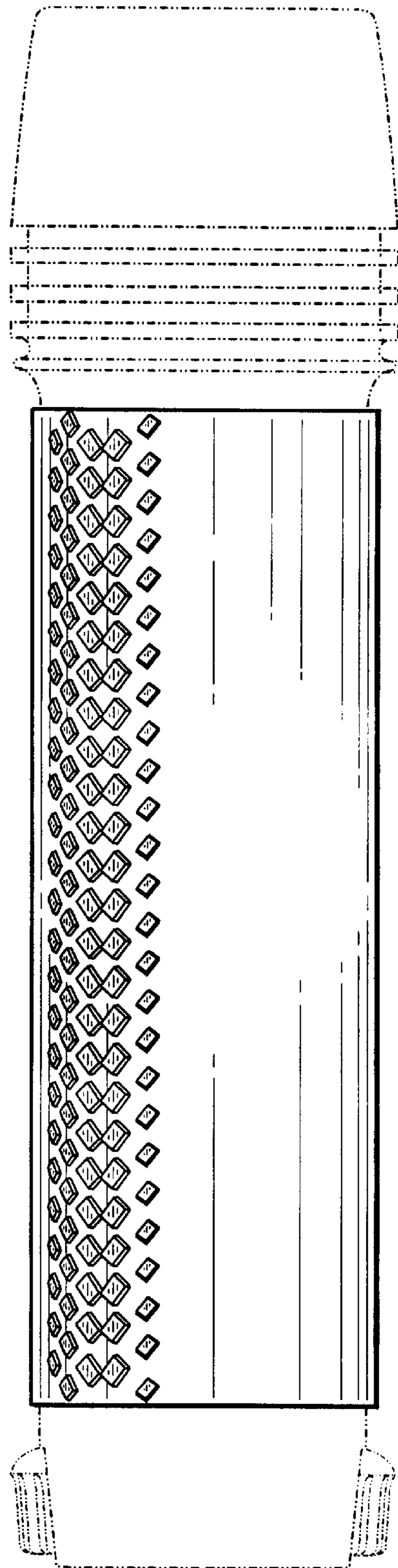

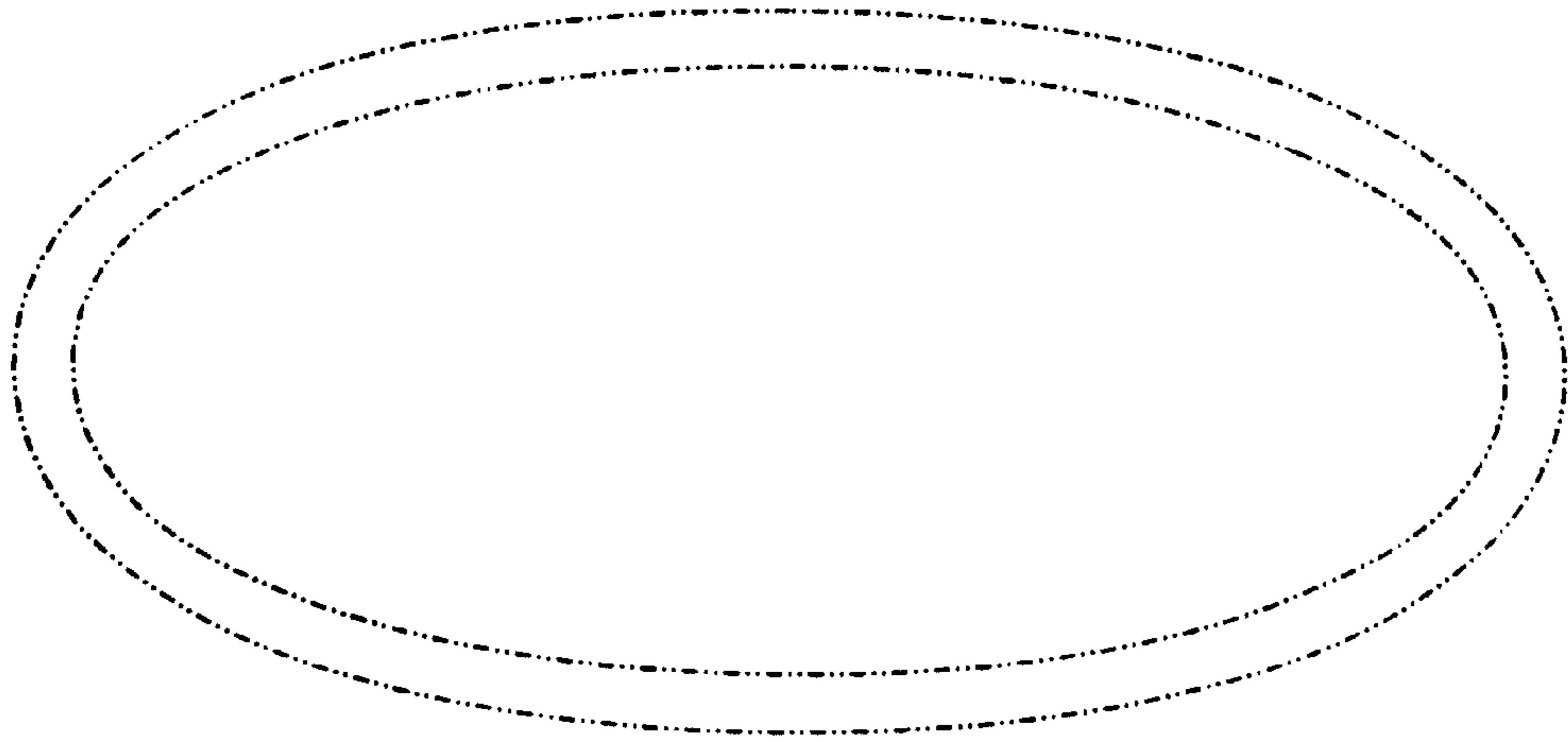

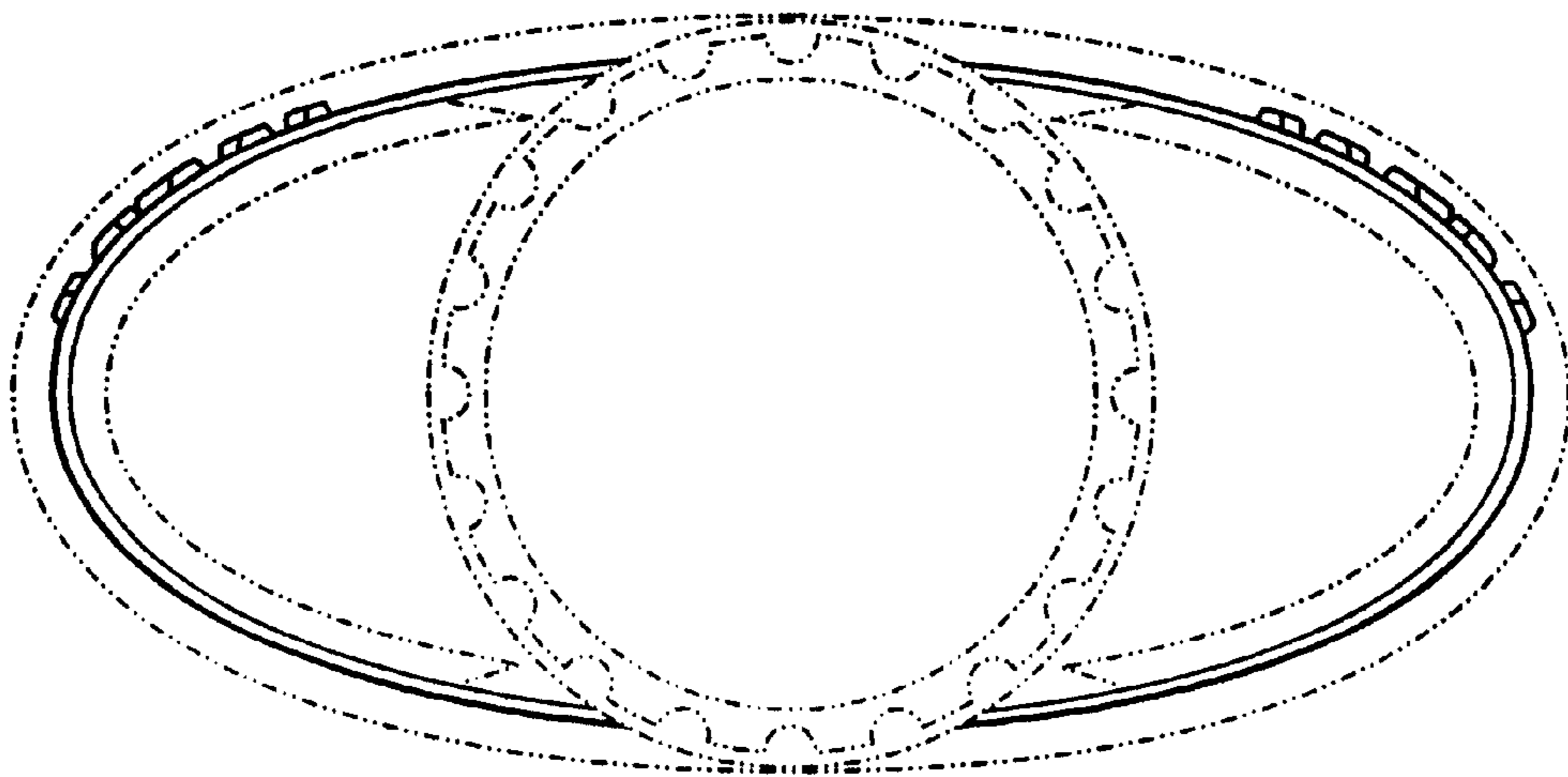
