(57) **CLAIM**

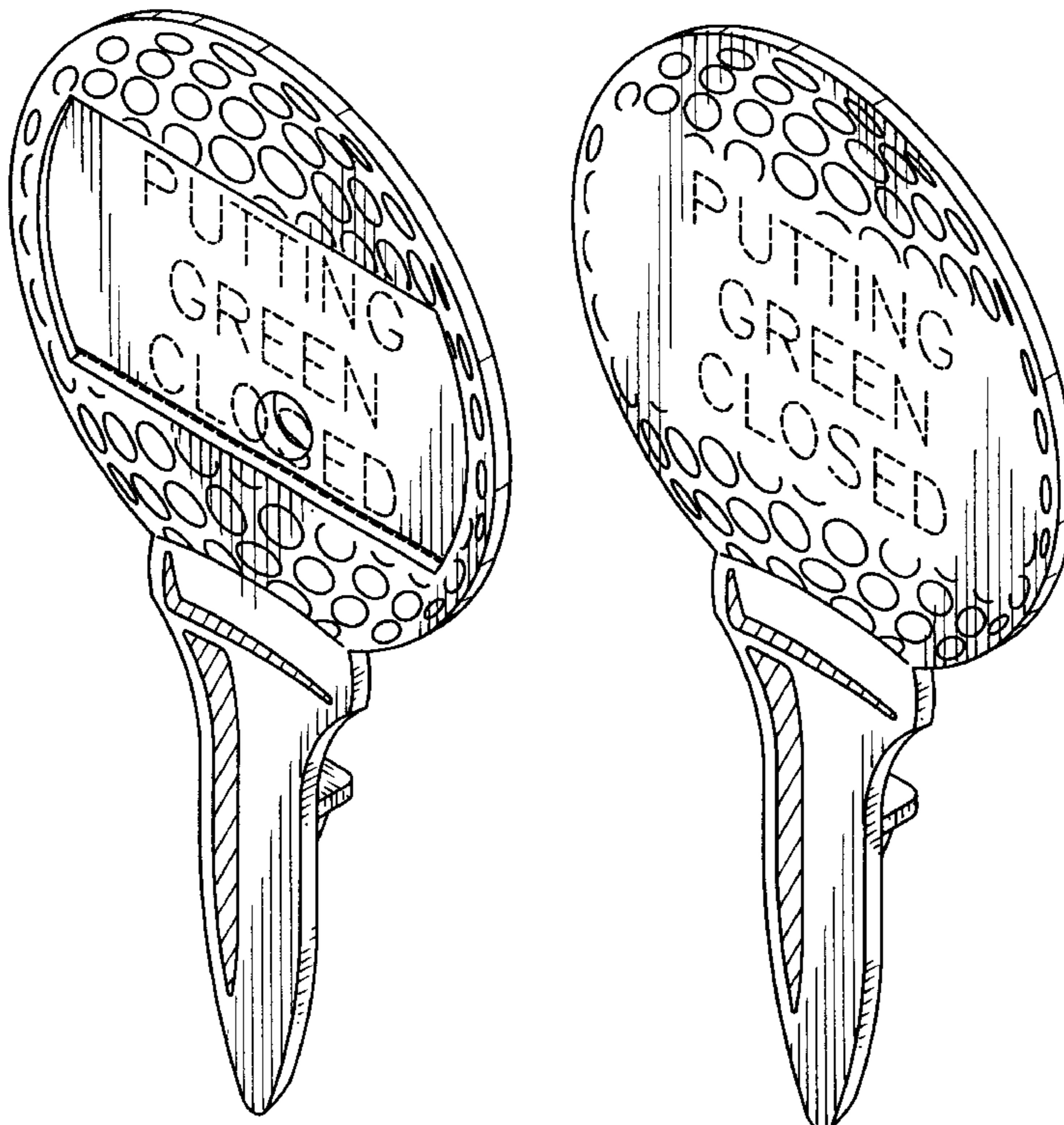
The ornamental design for a golf course sign holder, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a golf course sign holder showing my new design;
 FIG. 2 is a front elevational view thereof;

 FIG. 4 is a top plan view thereof;
 FIG. 5 is a bottom plan view thereof;
 FIG. 6 is a left edge view thereof;
 FIG. 7 is a right edge view thereof;
 FIG. 8 is an enlarged fragmentary view taken on line 8—8 of FIG. 2;
 FIG. 9 is a front perspective view showing the holder with a sign in place;
 FIG. 10 is a rear perspective view thereof;
 FIG. 11 is a front perspective view of an alternate embodiment of a golf course sign holder showing my new design;
 FIG. 12 is a front elevational view thereof;
 FIG. 13 is a rear elevational view thereof;
 FIG. 14 is a top plan view thereof;
 FIG. 15 is a bottom plan view thereof;
 FIG. 16 is a left edge view thereof;

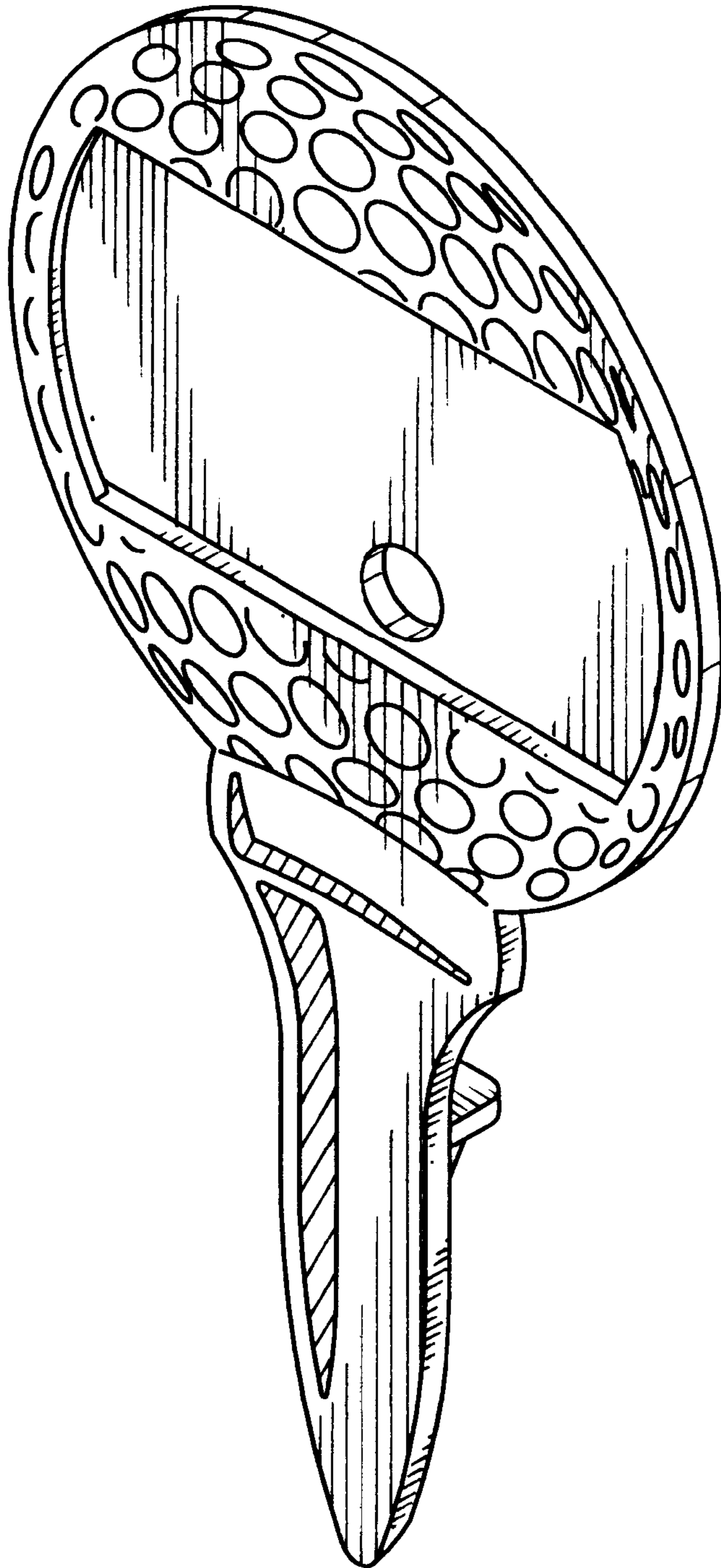

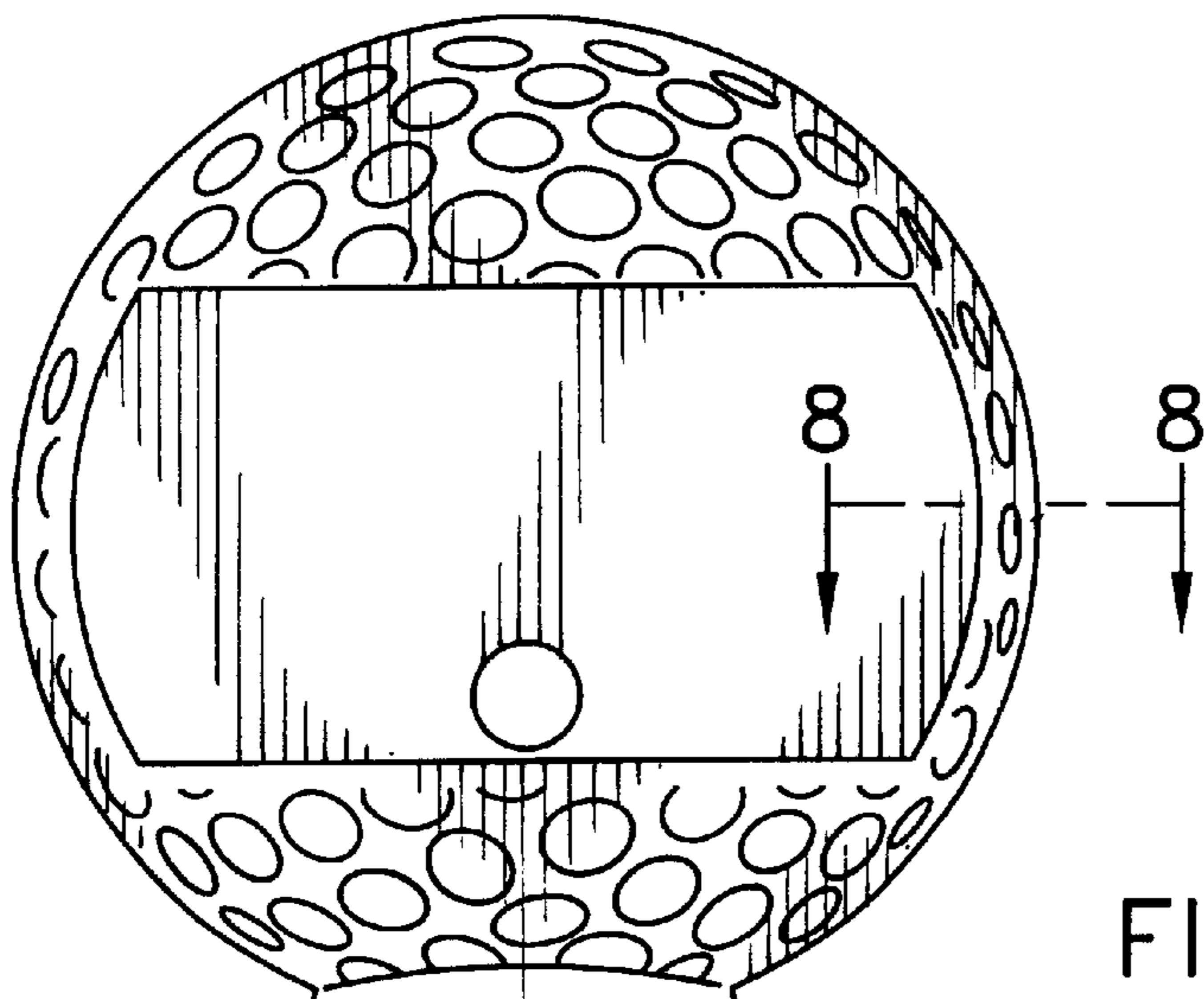

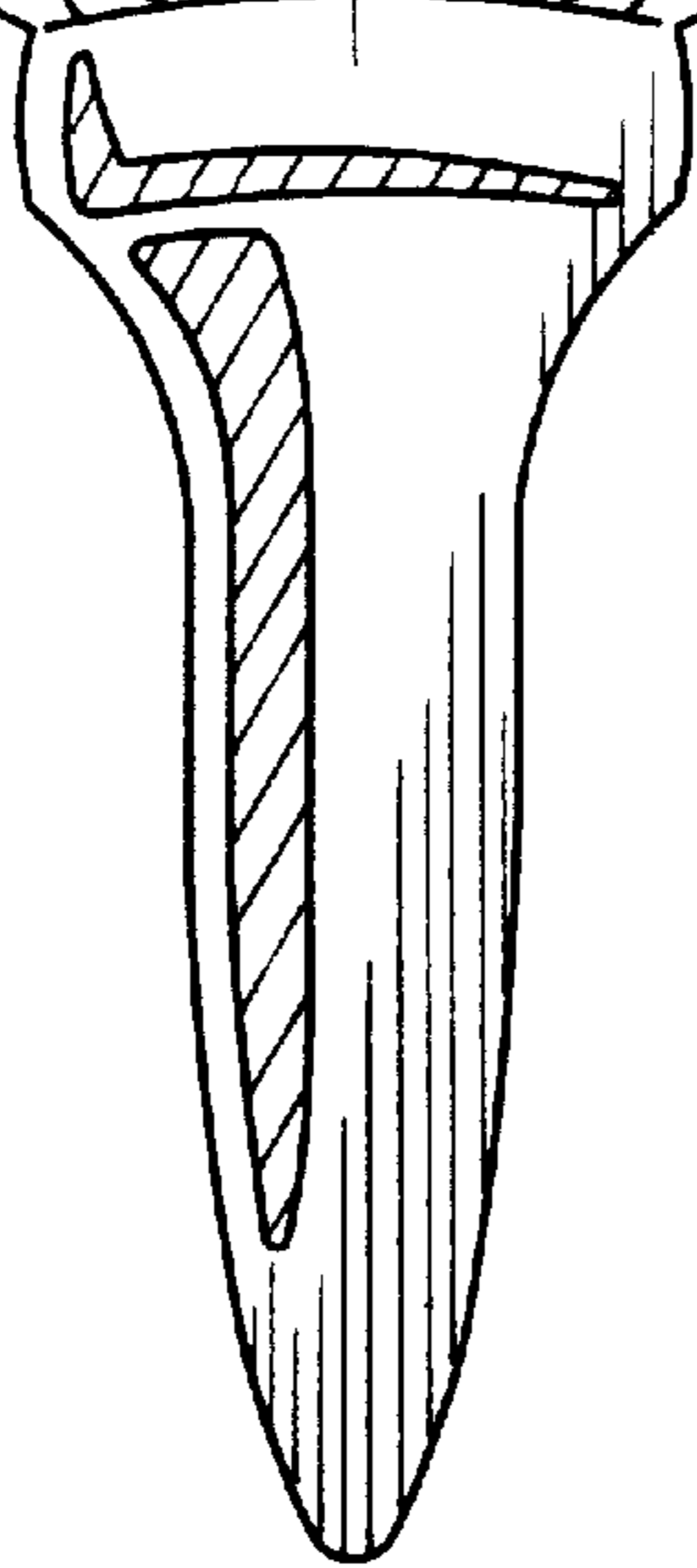

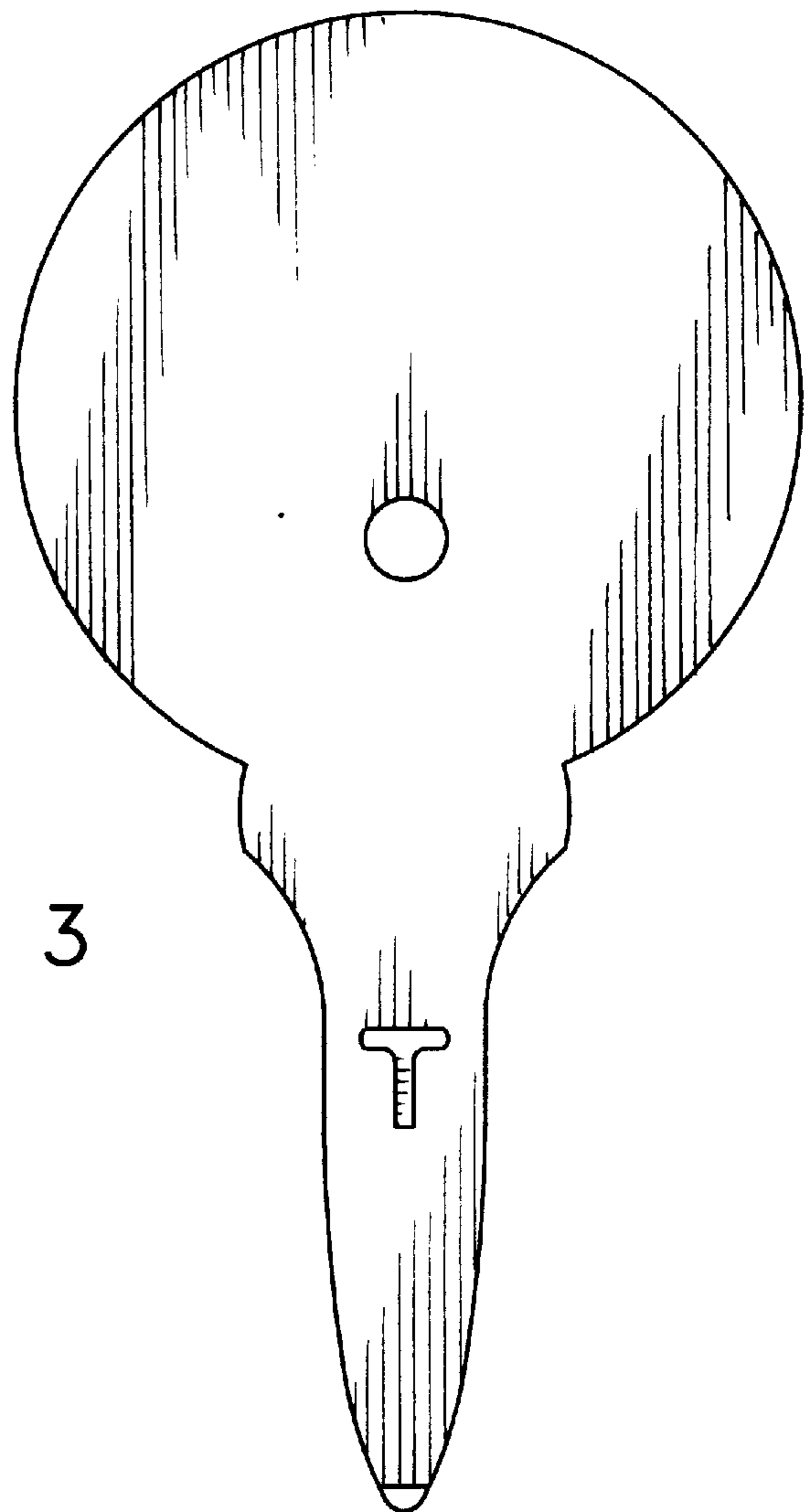

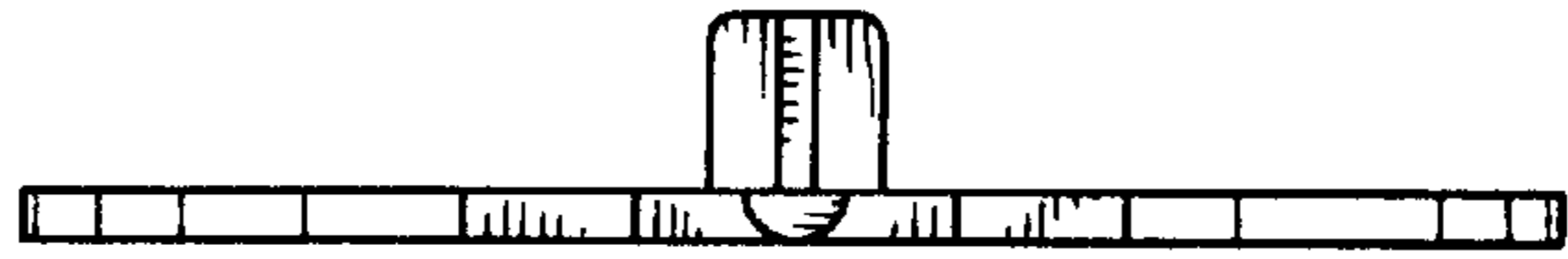

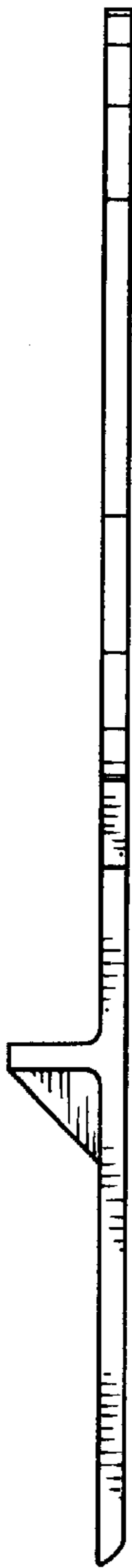

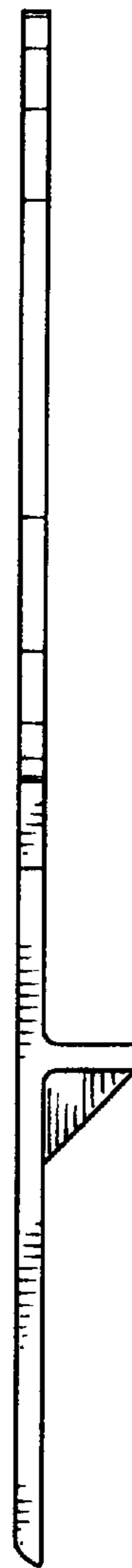

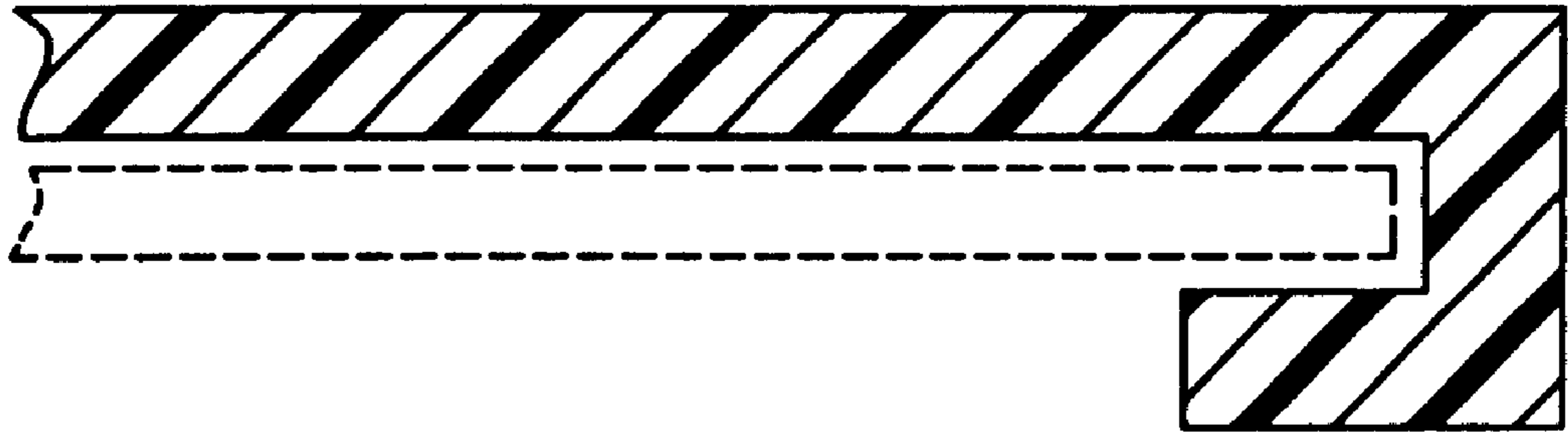

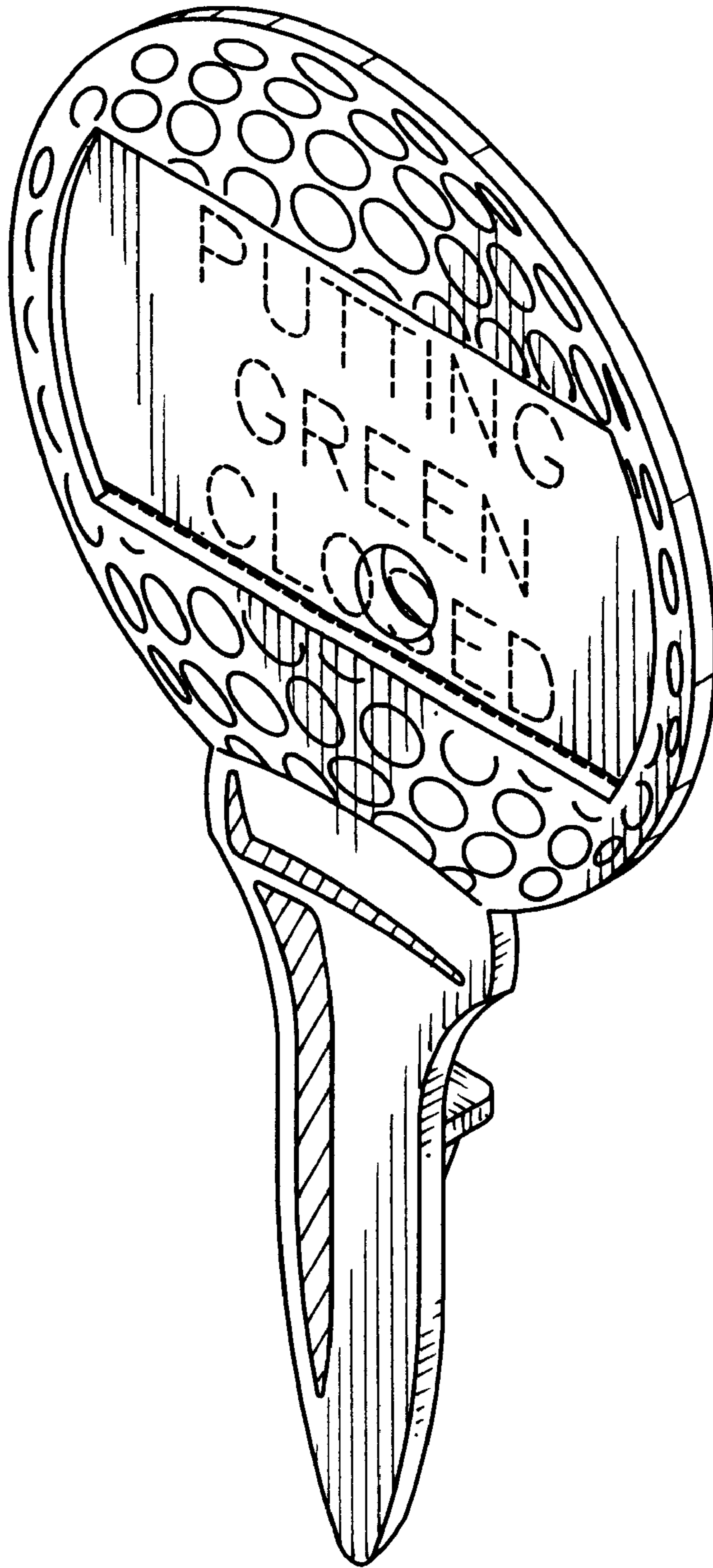

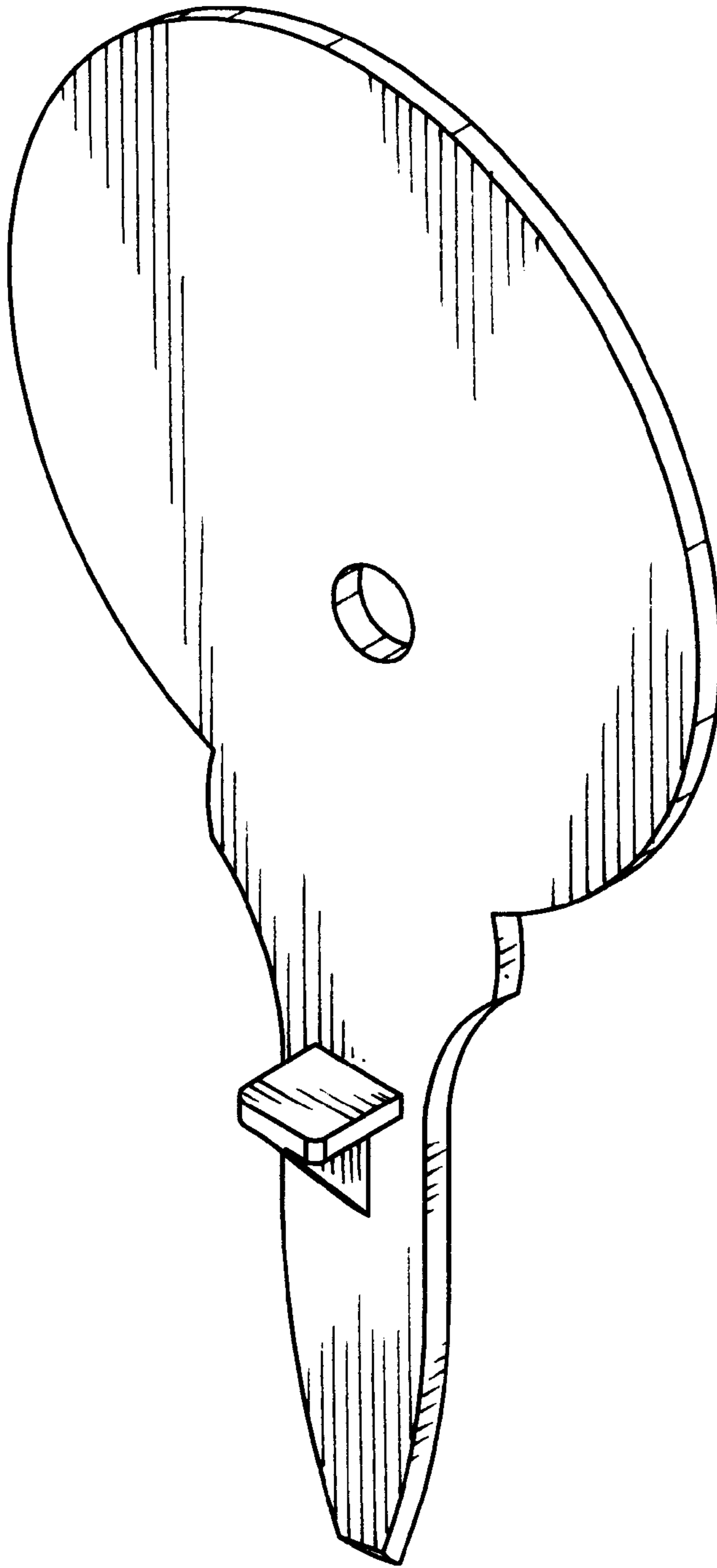

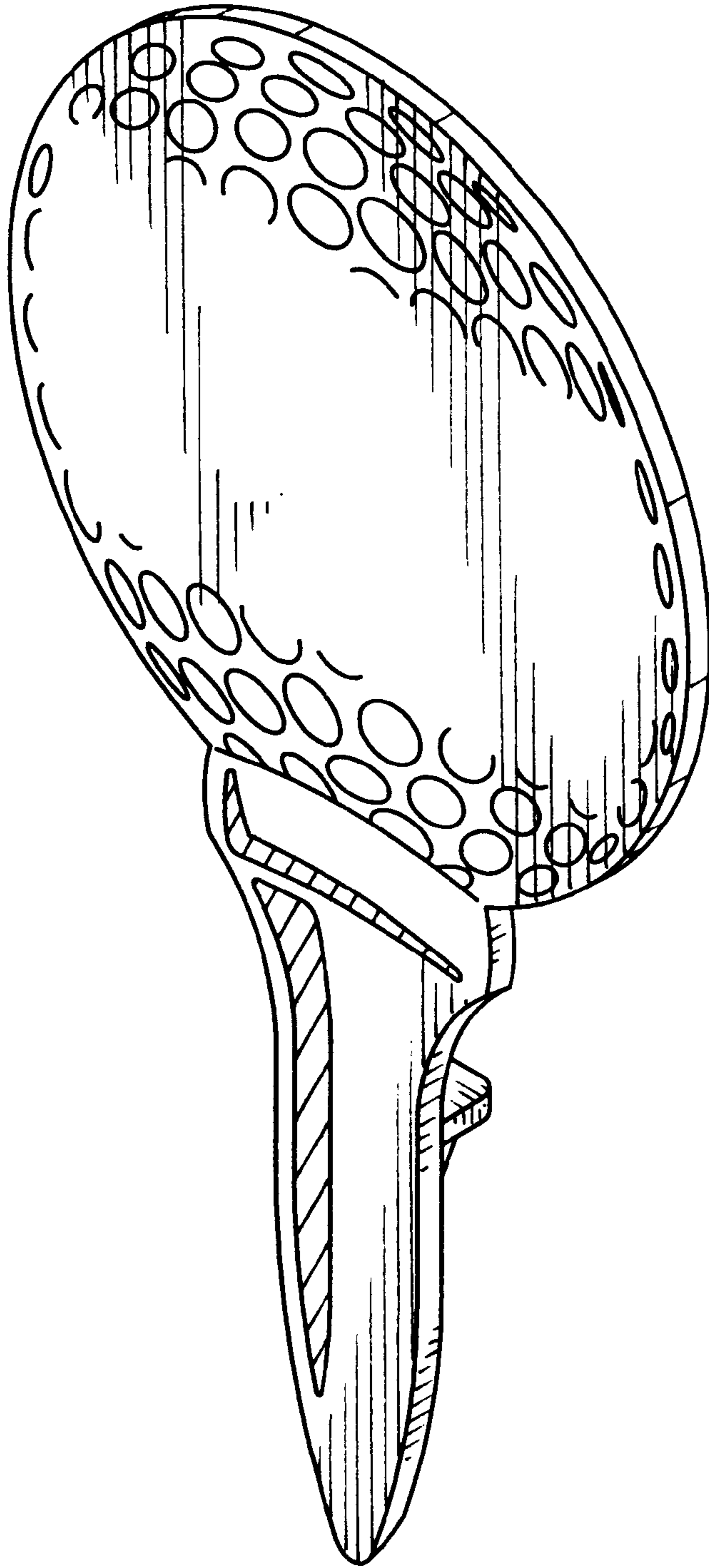

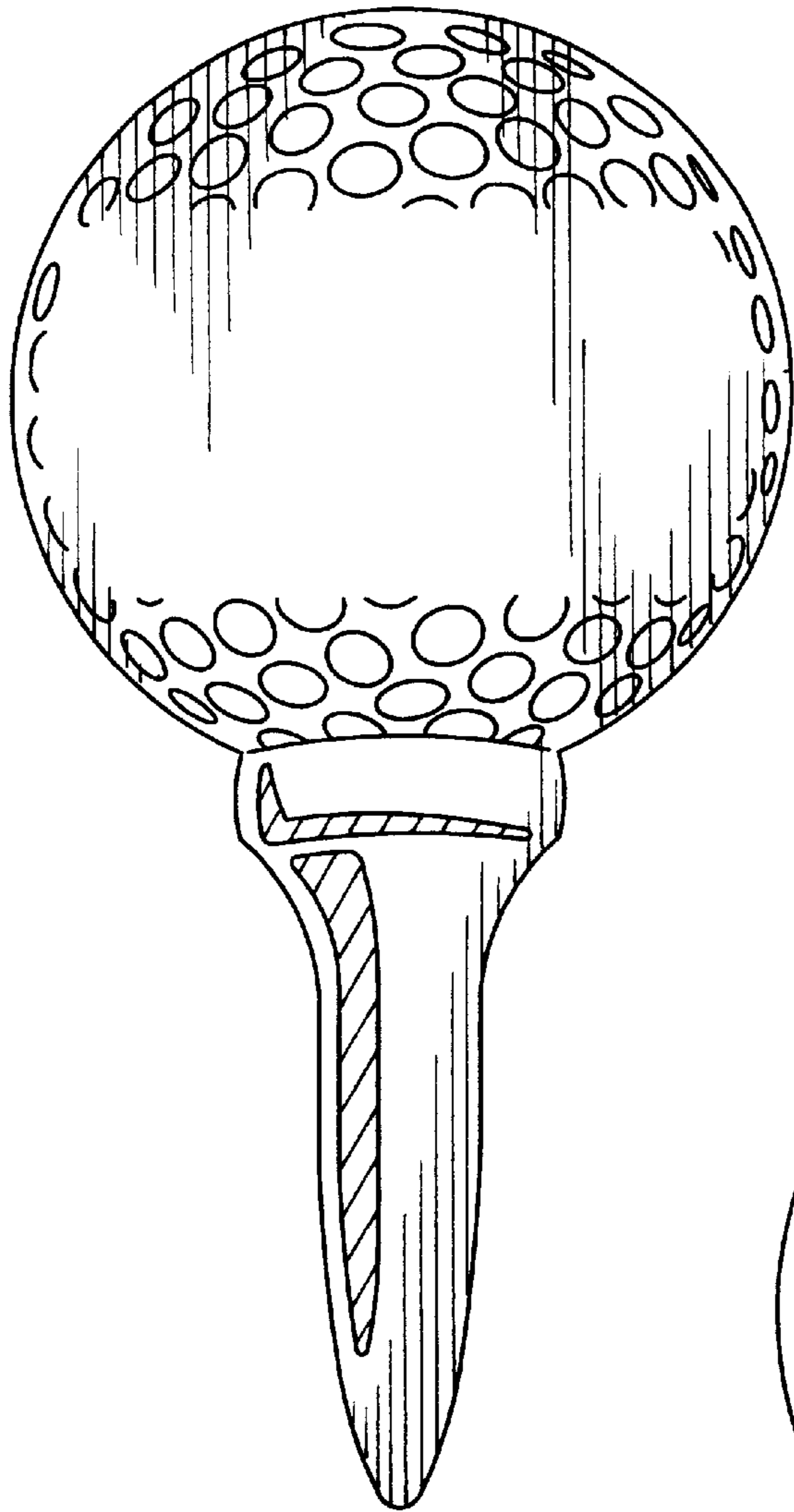

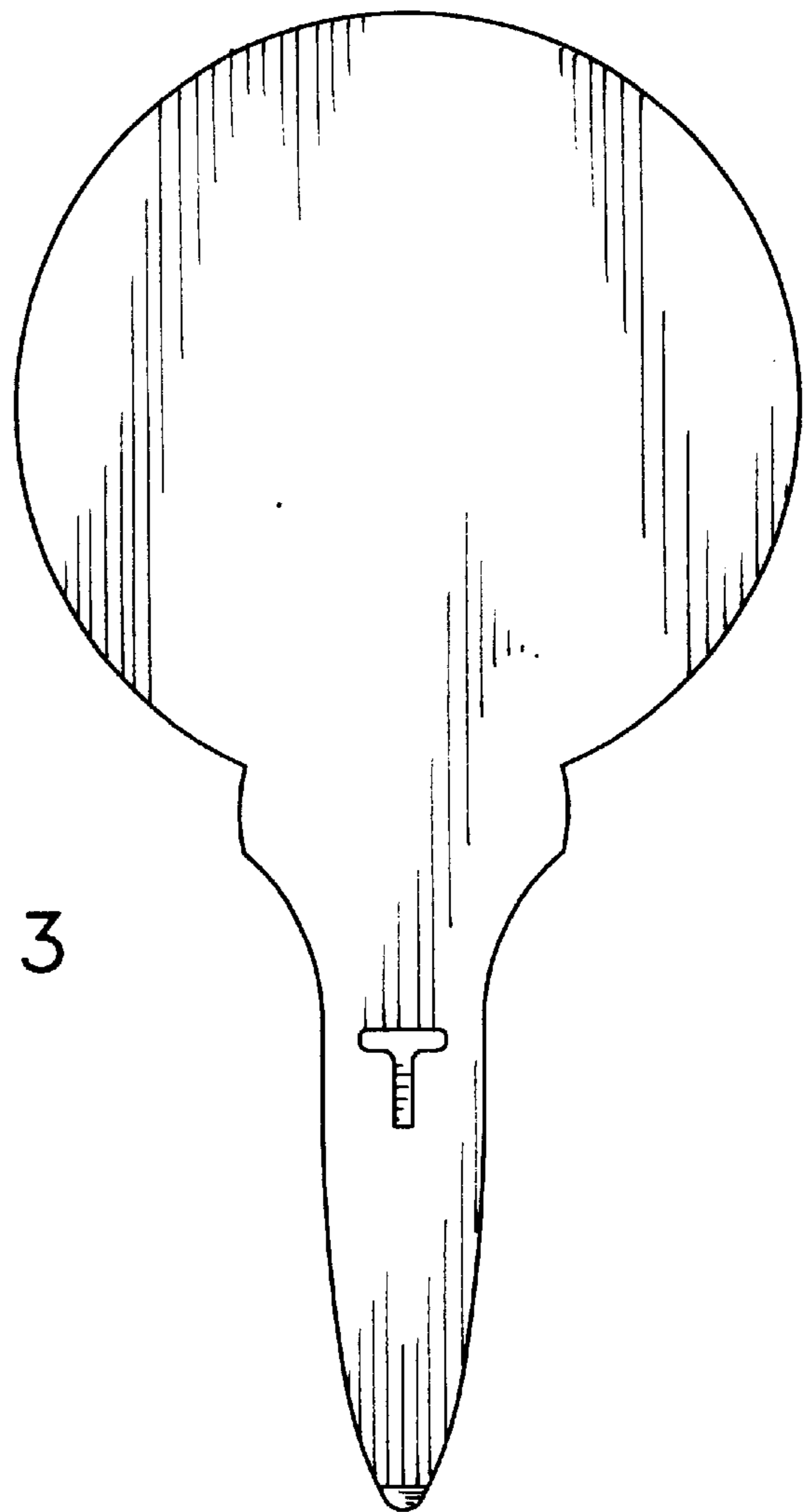

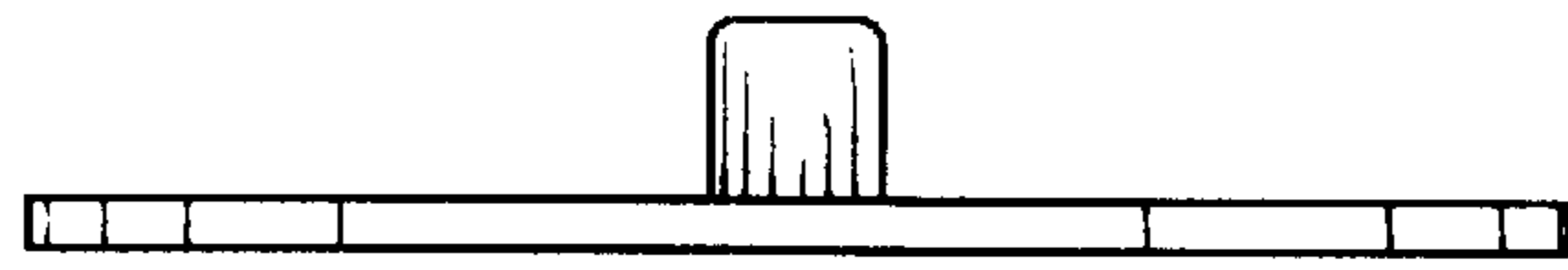

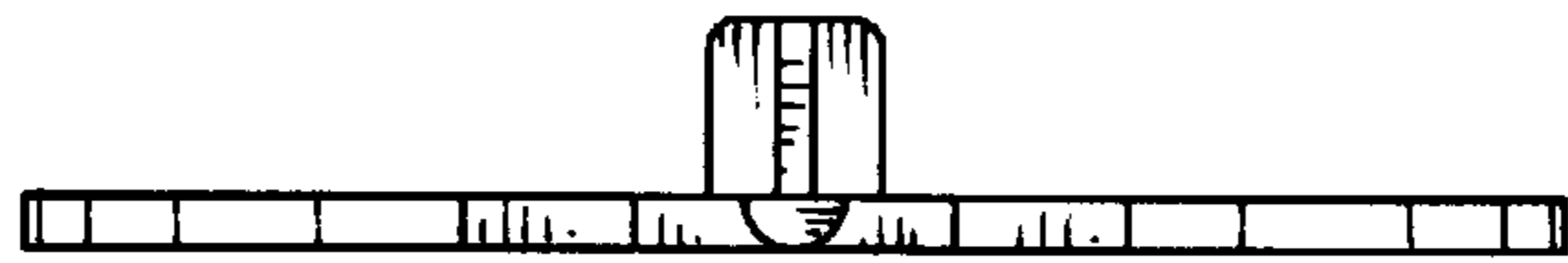

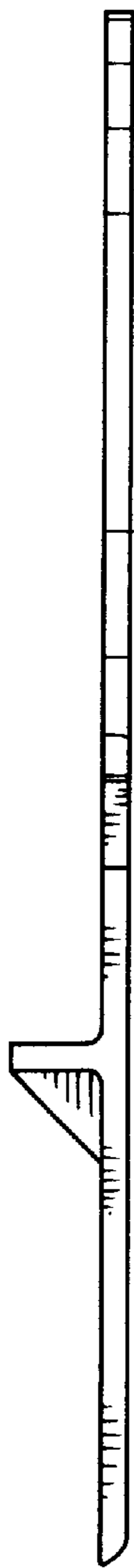

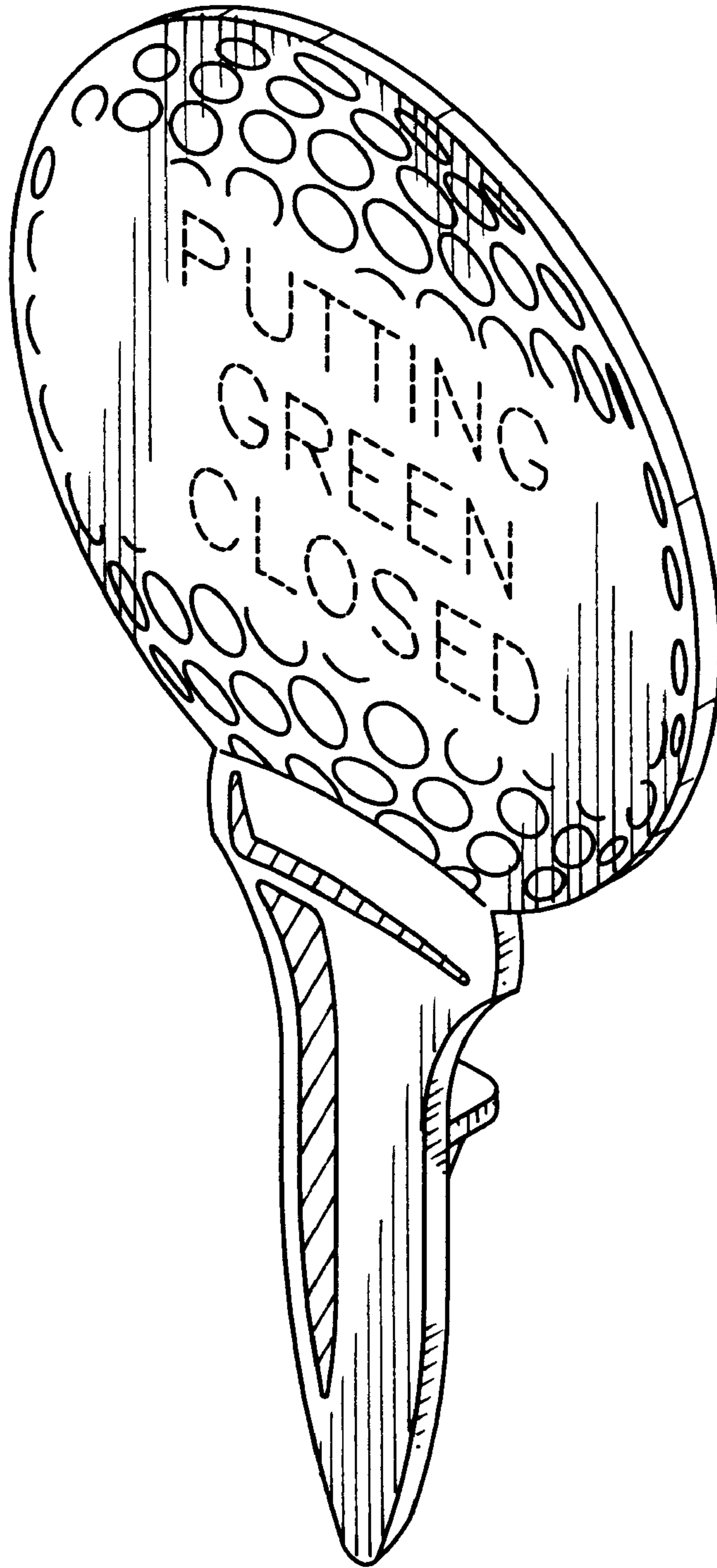

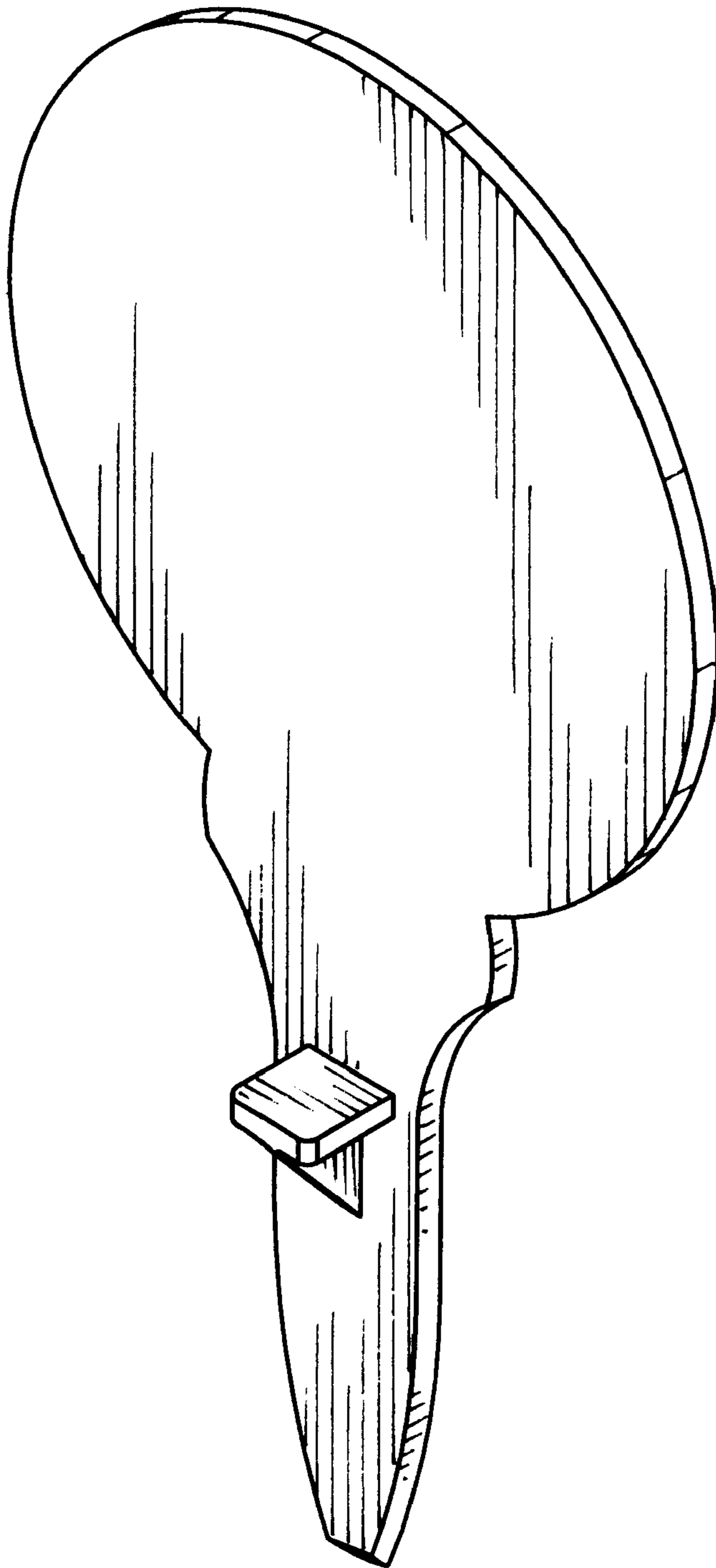
