FIG. 2 is a front elevational view thereof.

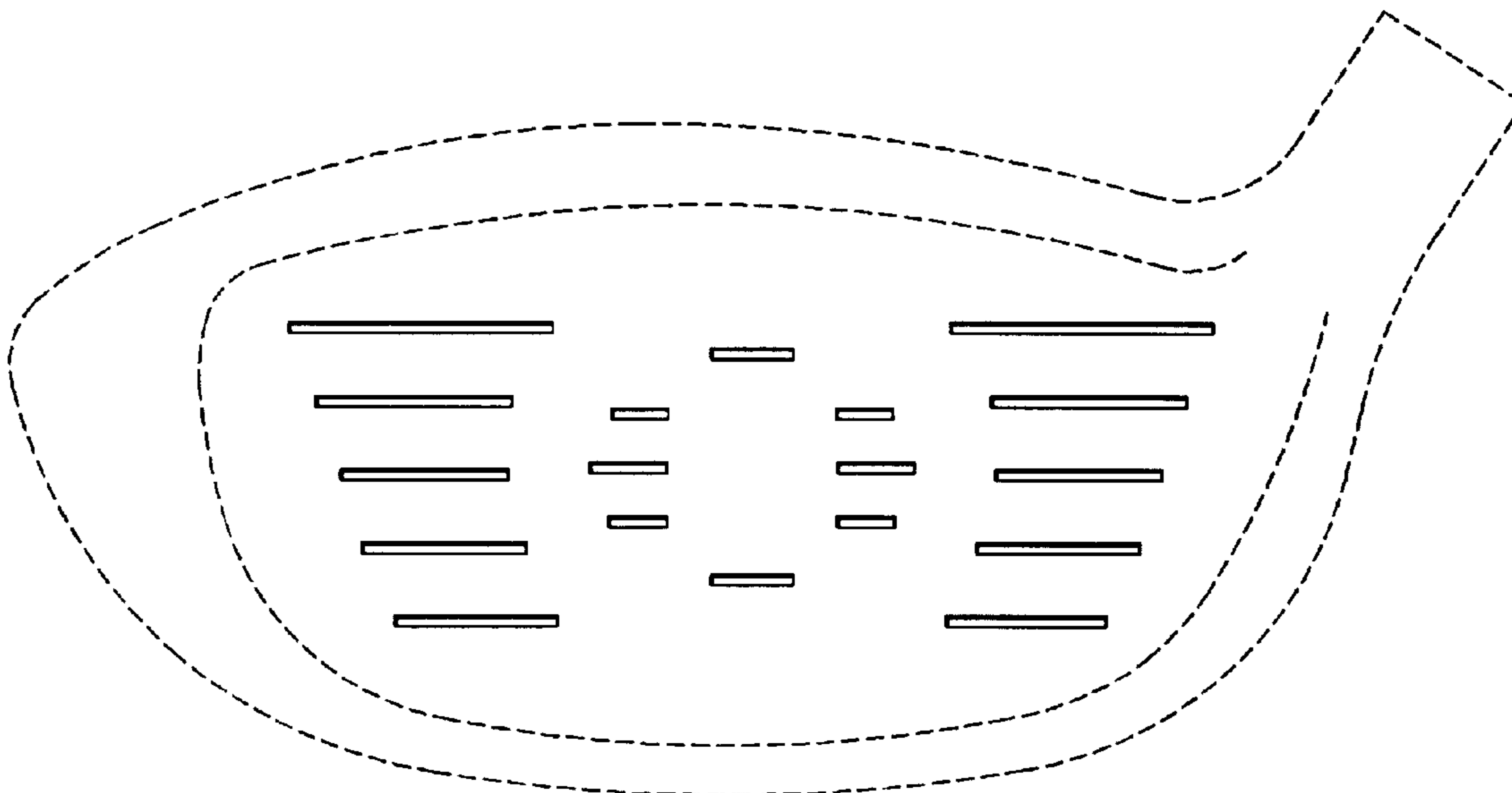
FIG. 3. is a top plan view thereof.

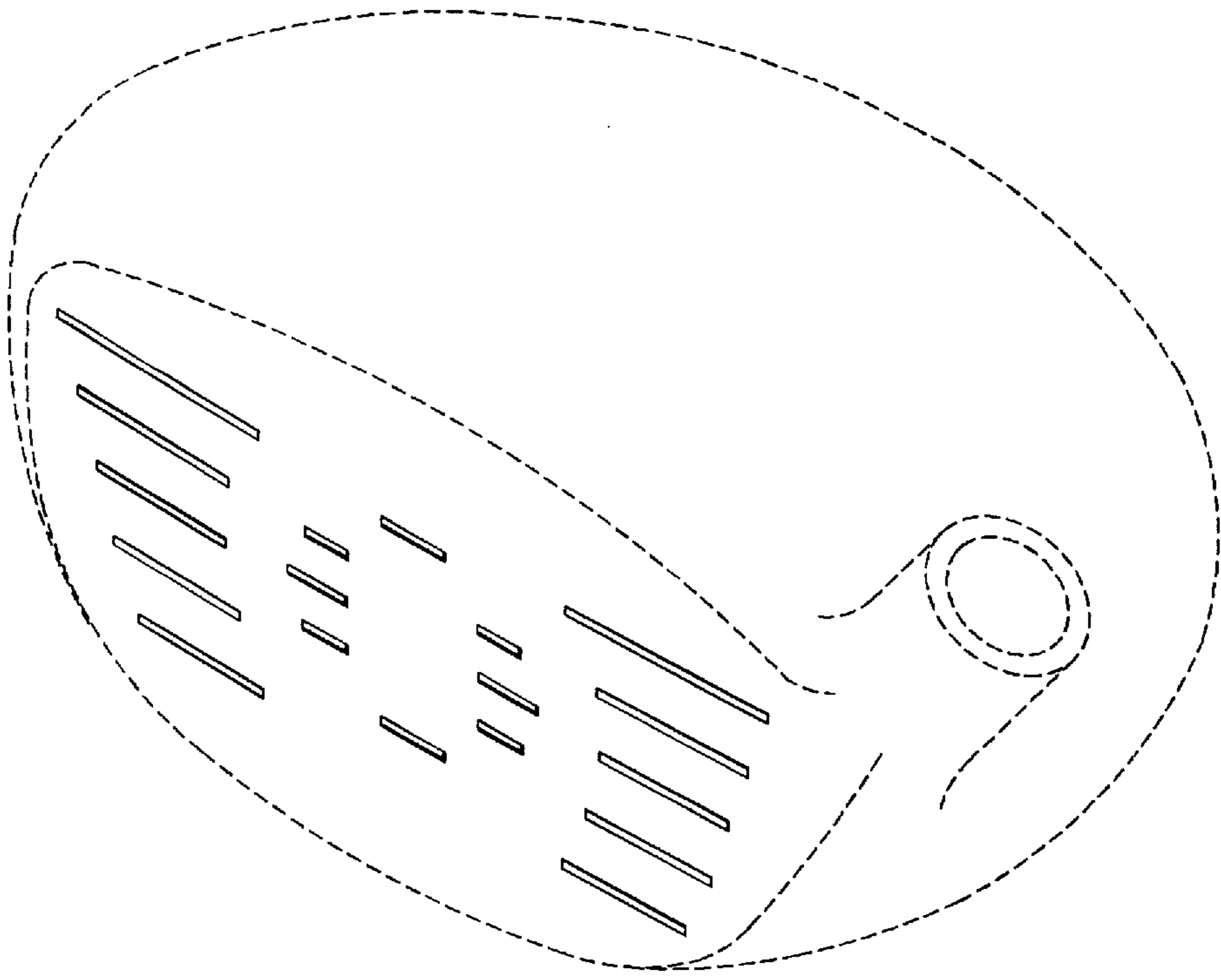

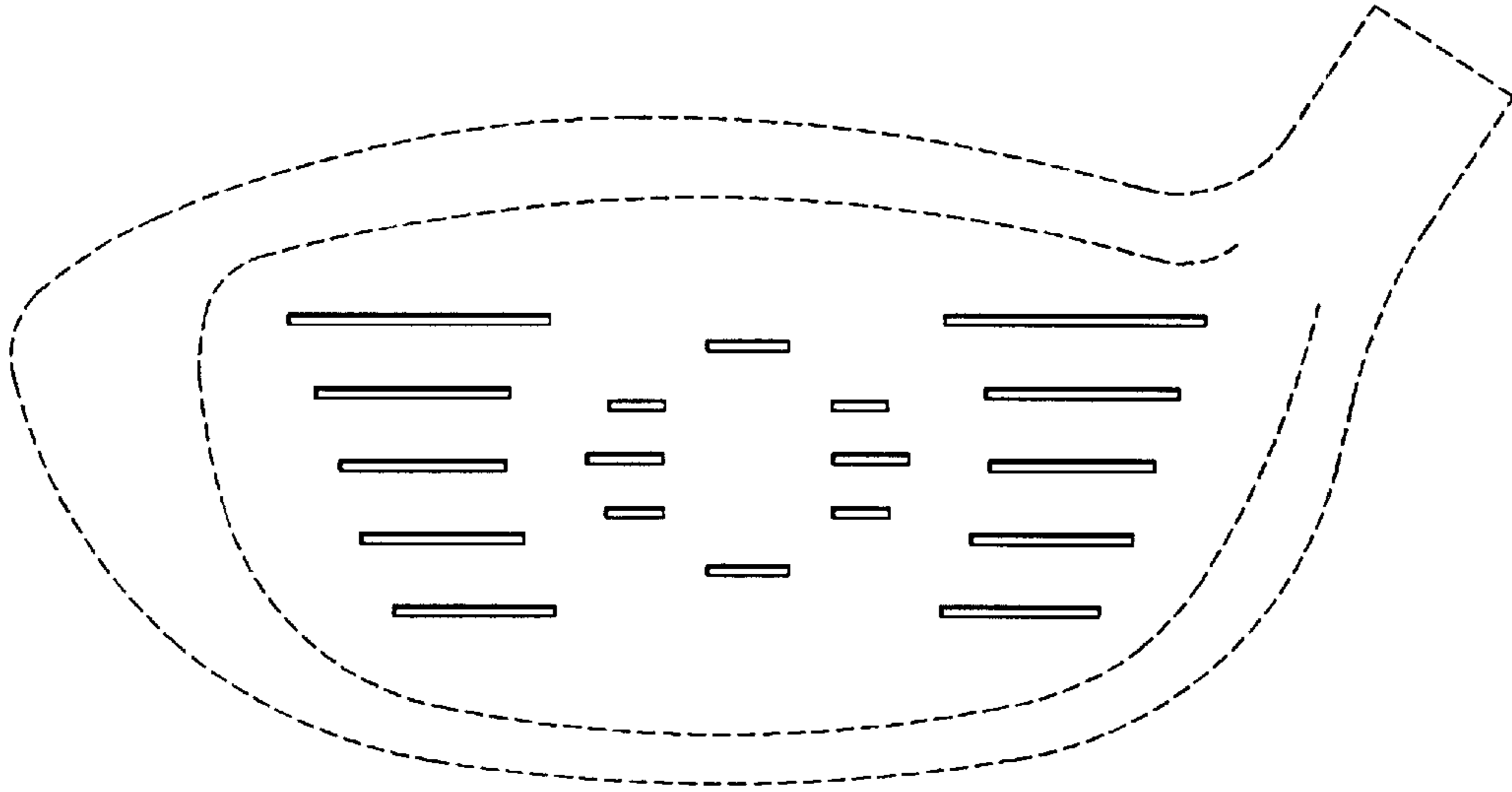

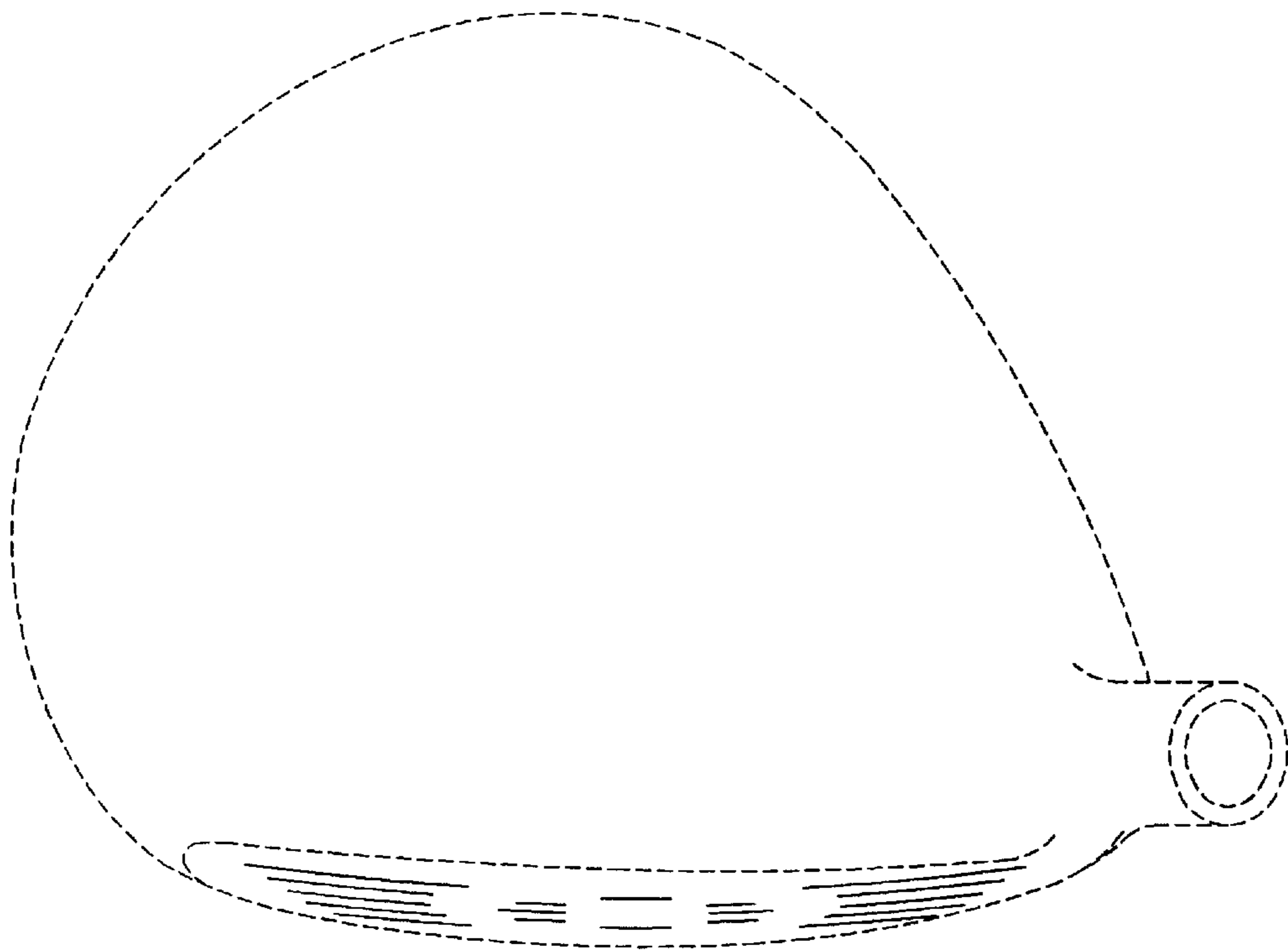

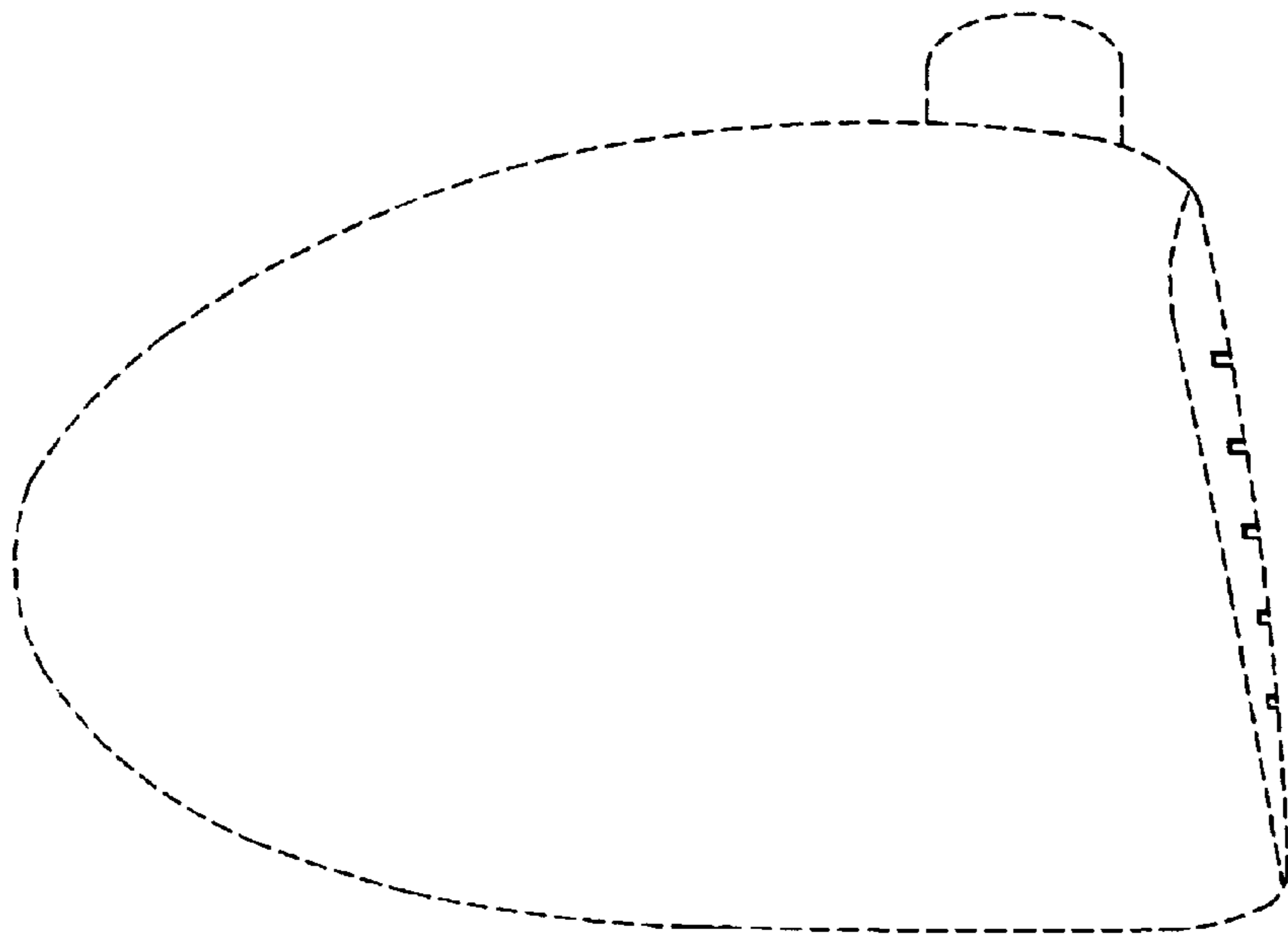

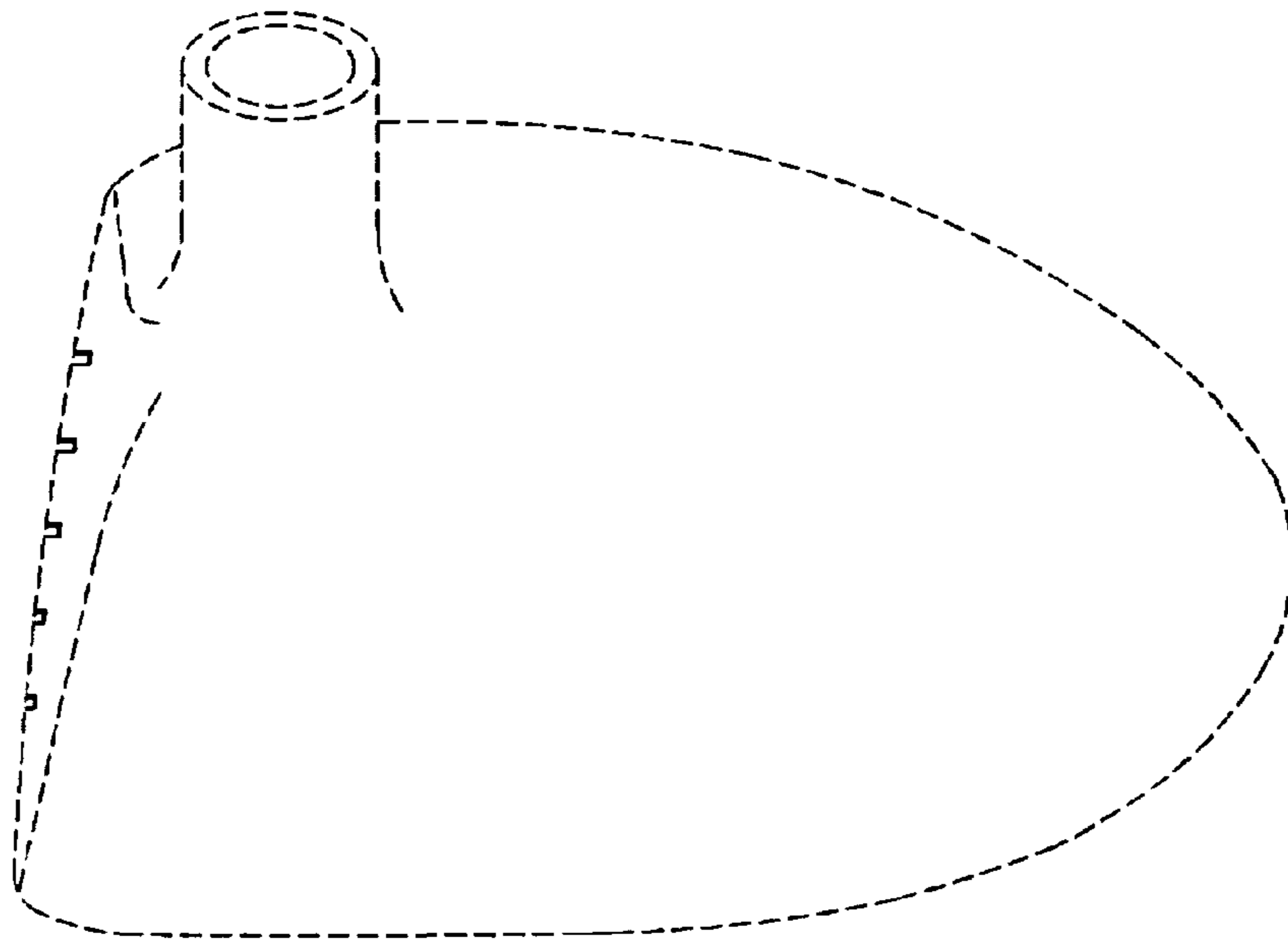
