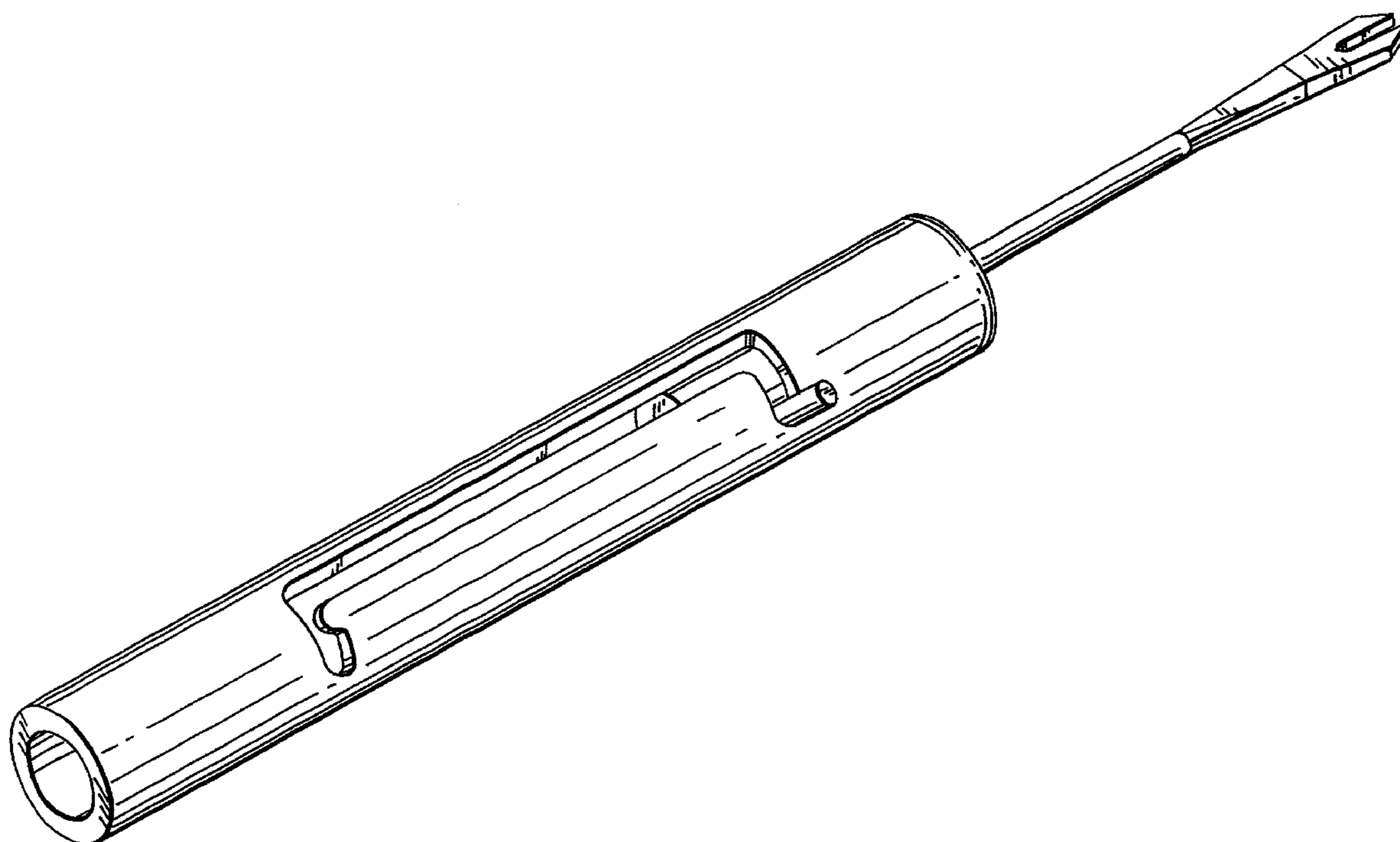
(57) **CLAIM**

The ornamental design for a medical needle assembly, substantially as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a medical needle assembly showing my new design;  
FIG. 2 is a top plan view thereof;

FIG. 4 is a rear elevational view thereof;

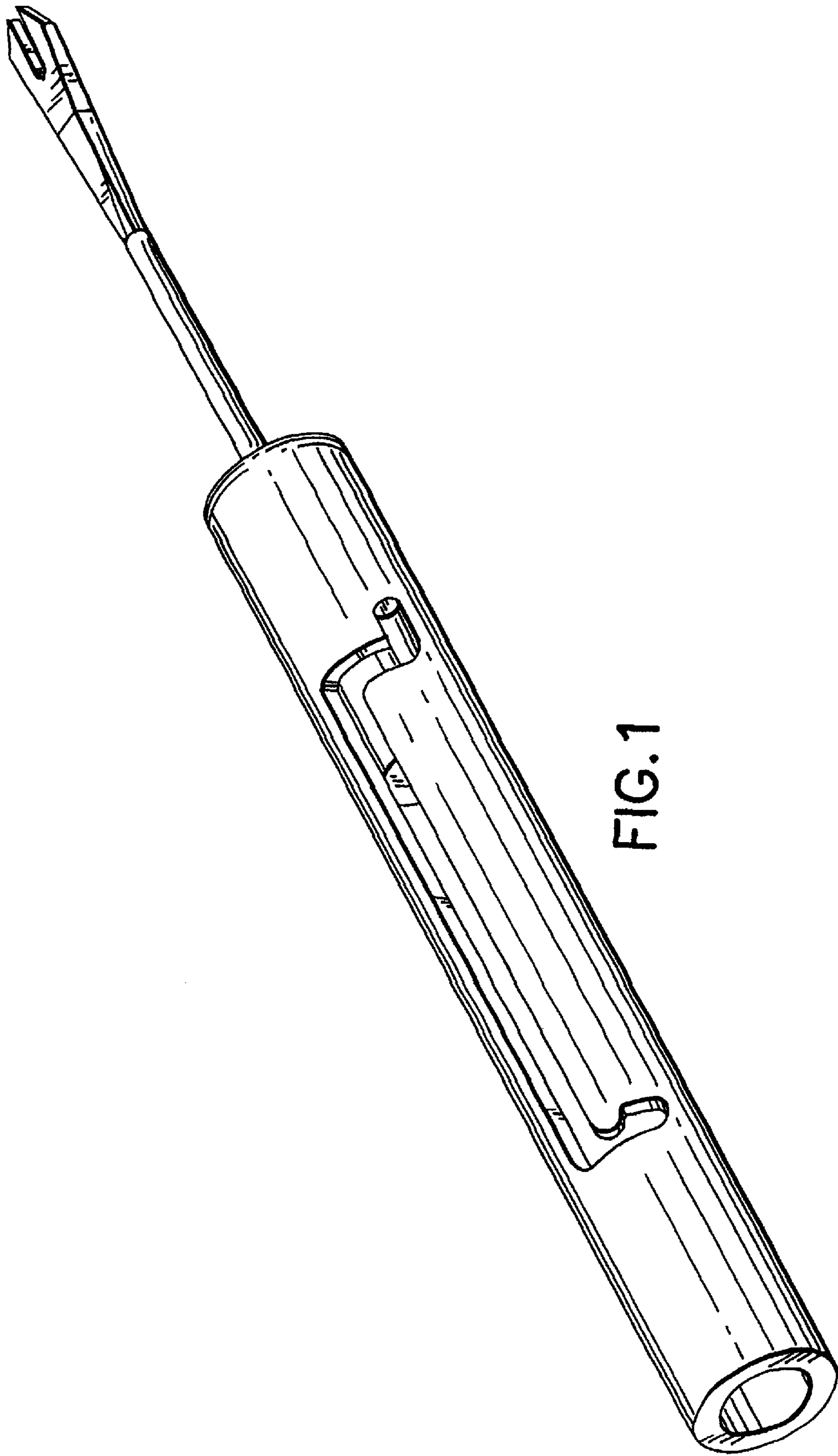

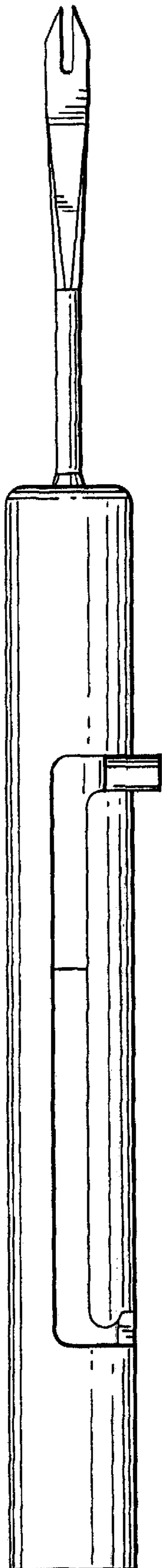

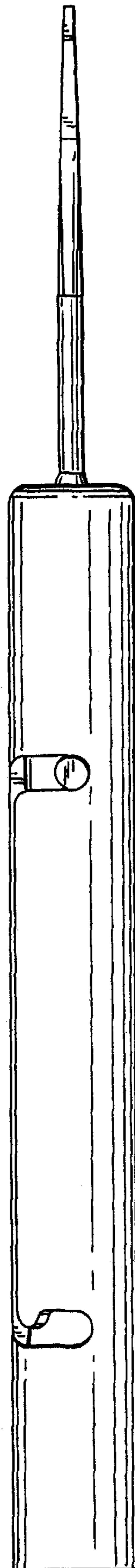

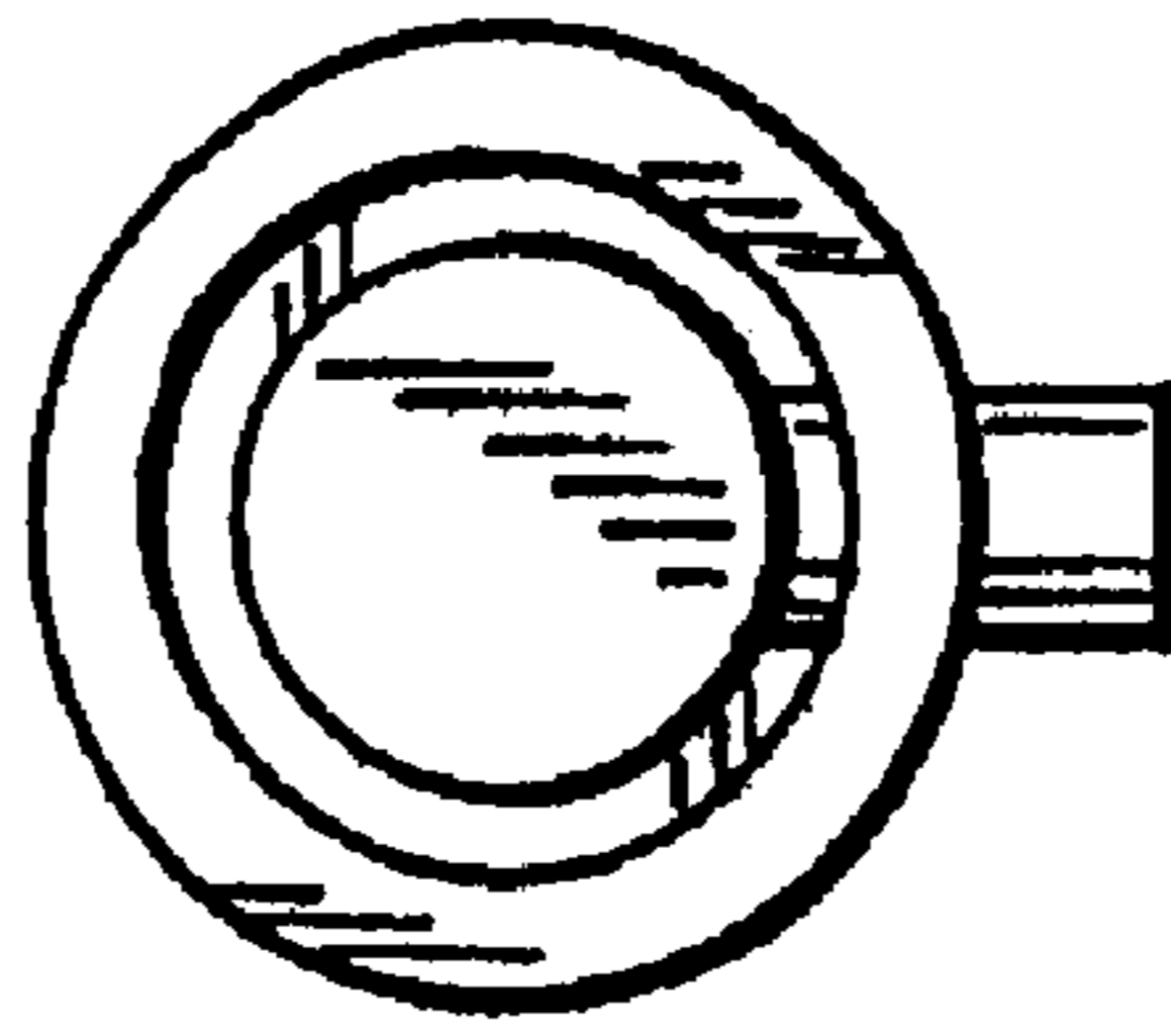

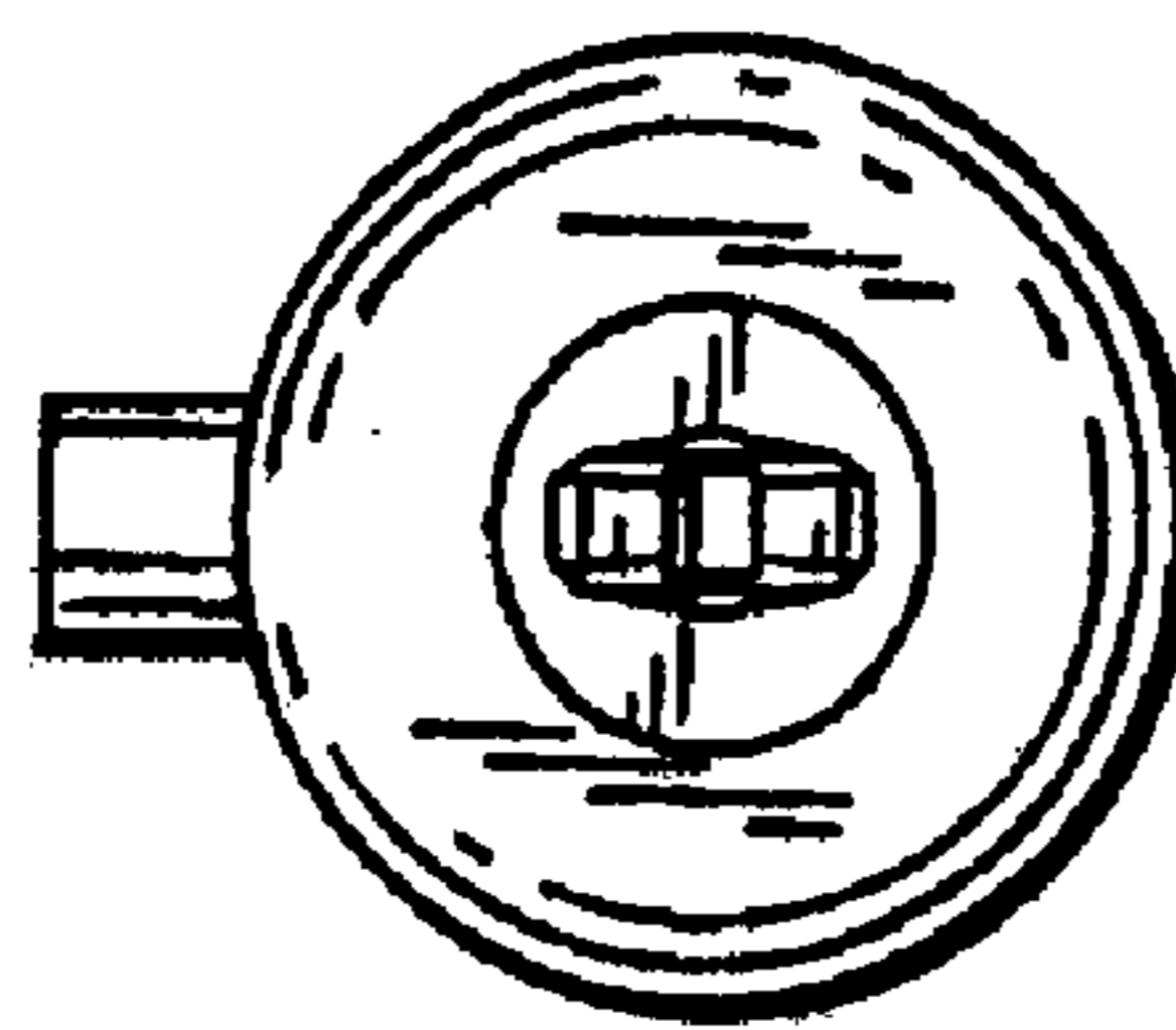

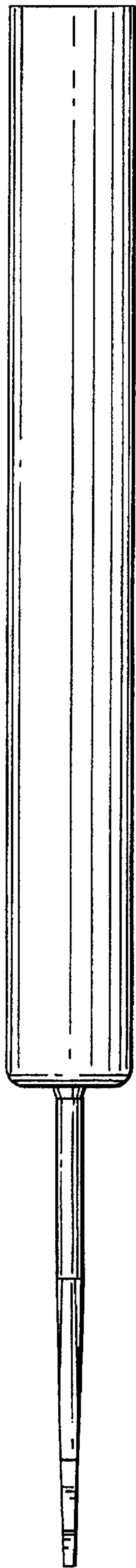

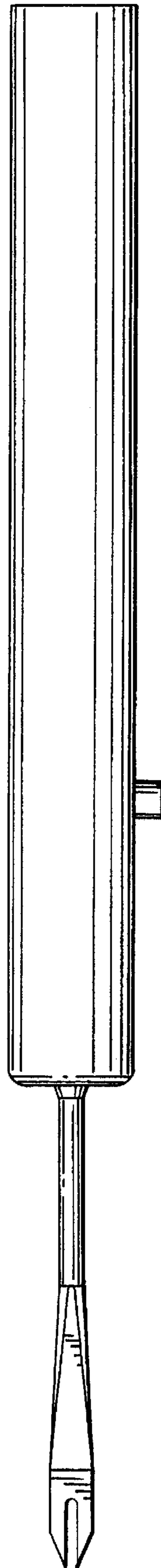
