(57) **CLAIM**

The ornamental design for a two seat spa alcove system with spa alcove, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a two seat spa alcove system with spa alcove showing the new design.

FIG. 2 is a cross-sectional view of the two seat spa alcove system with spa alcove taken along lines 2—2 of FIG. 1.

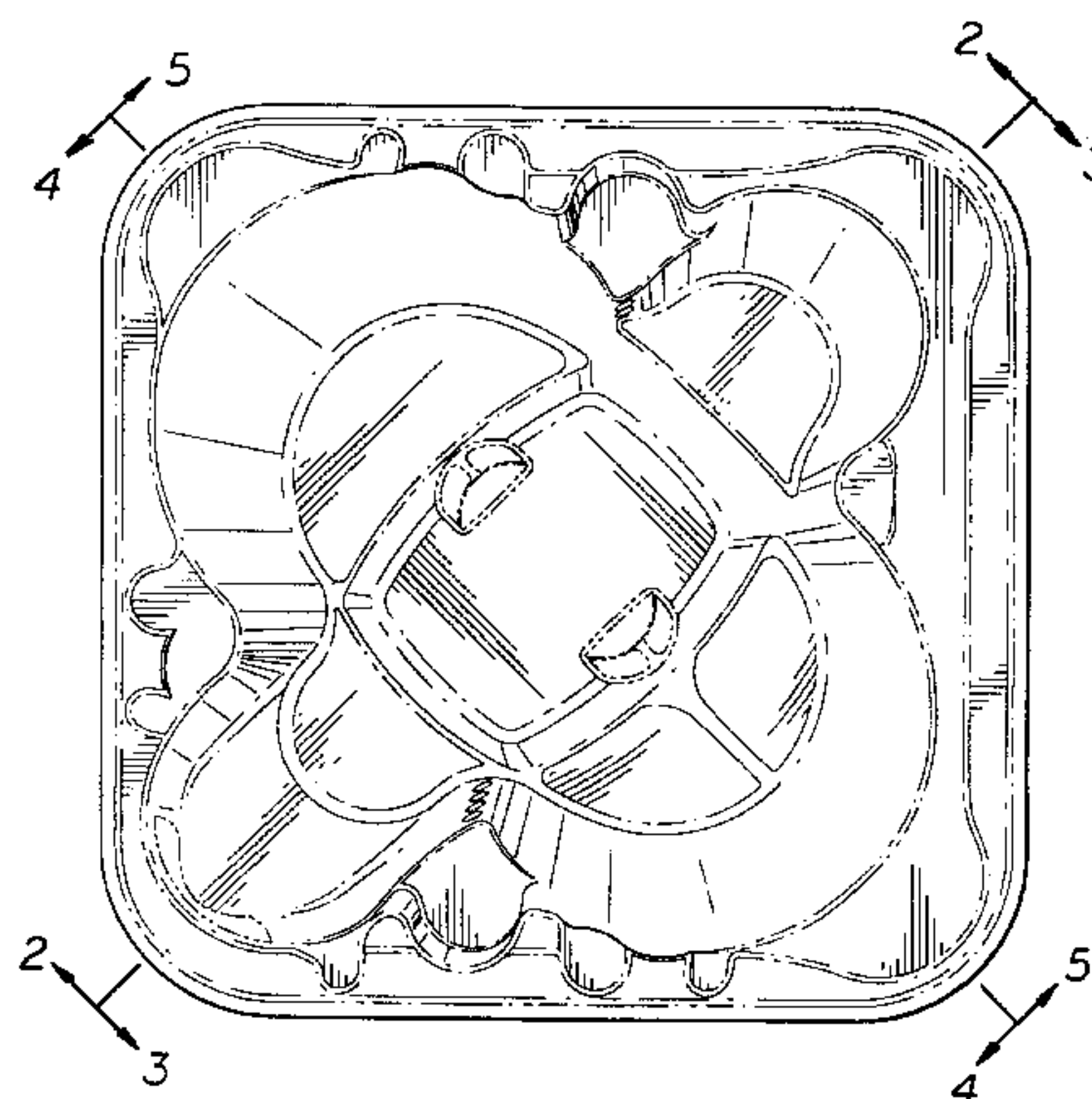
FIG. 3 is a cross-sectional view of the two seat spa alcove system with spa alcove taken along lines 3—3 of FIG. 1.

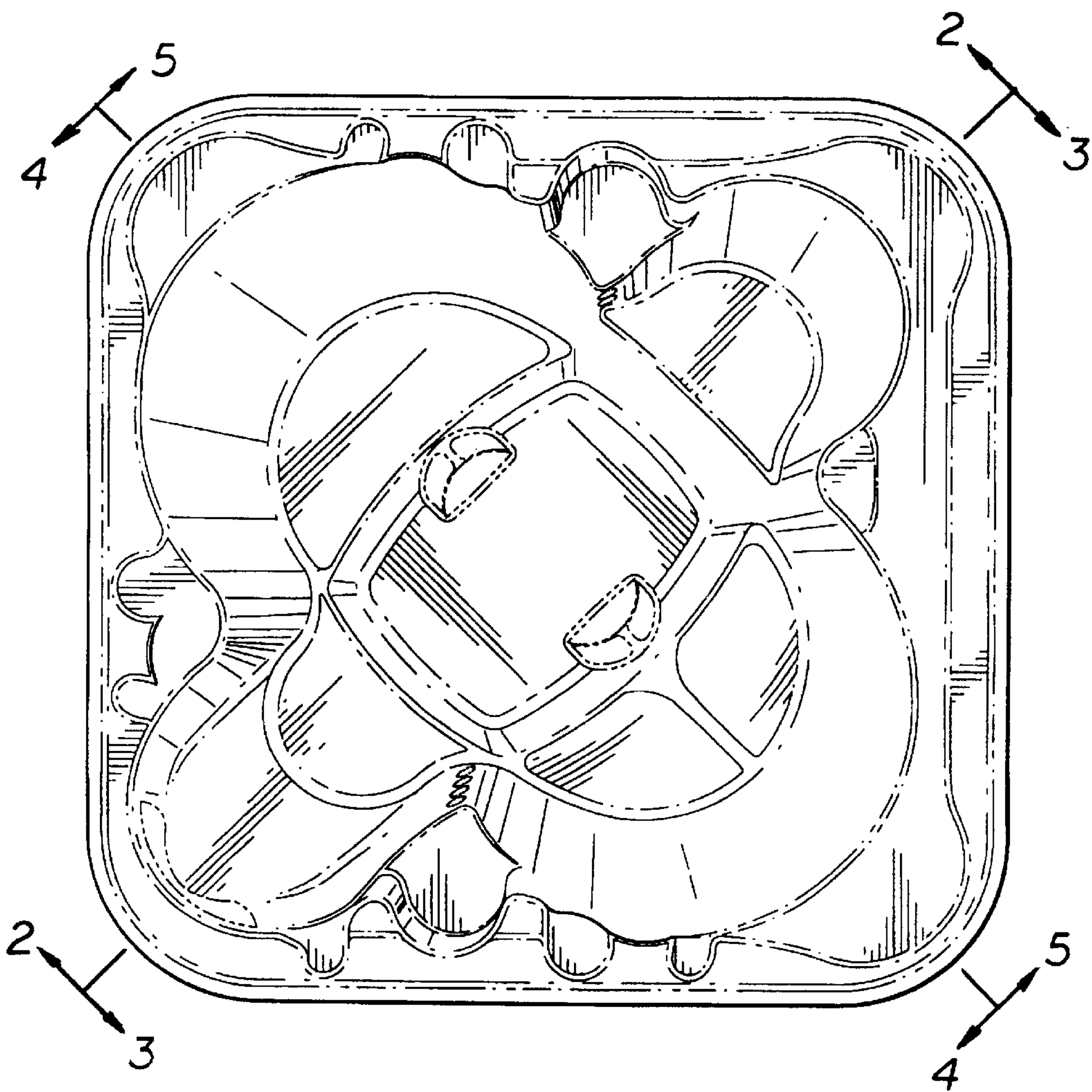

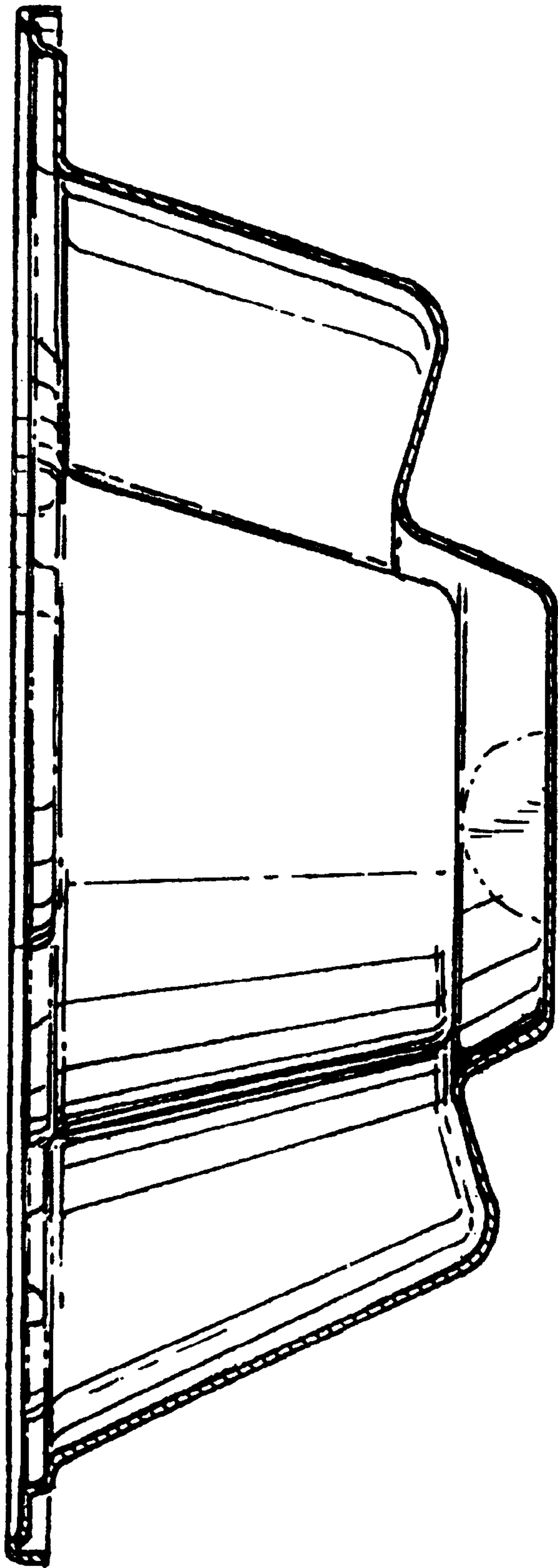

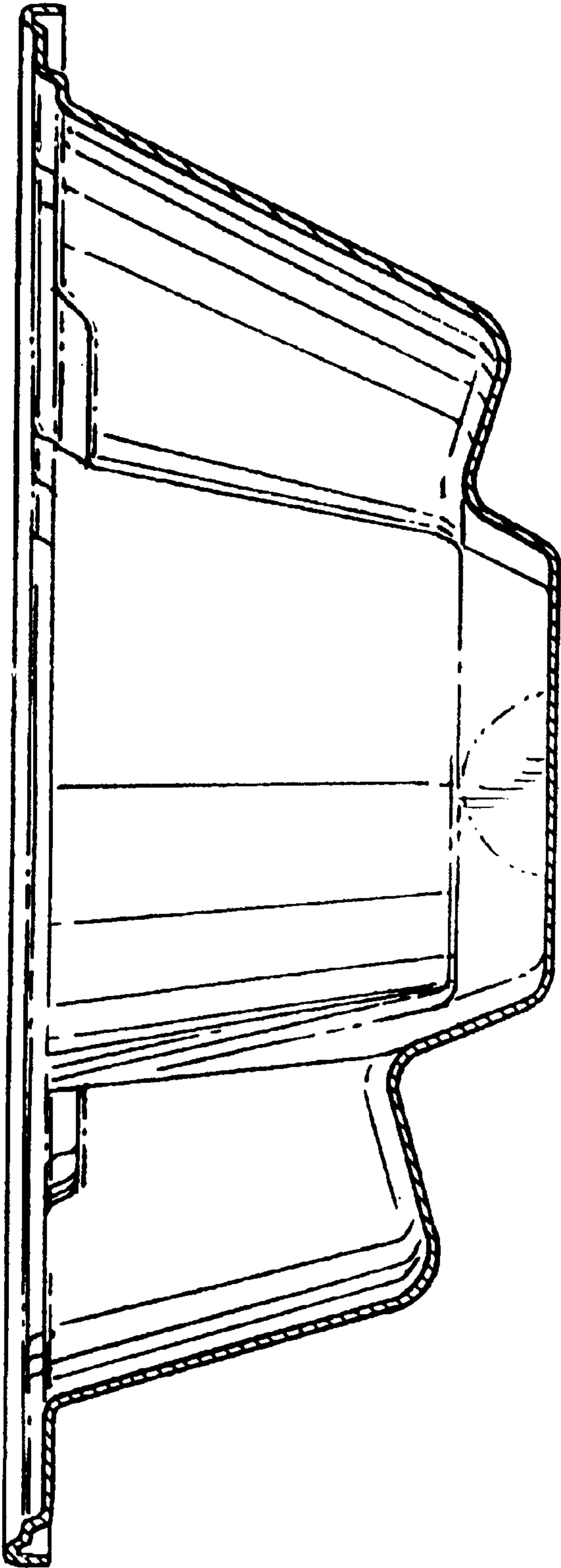

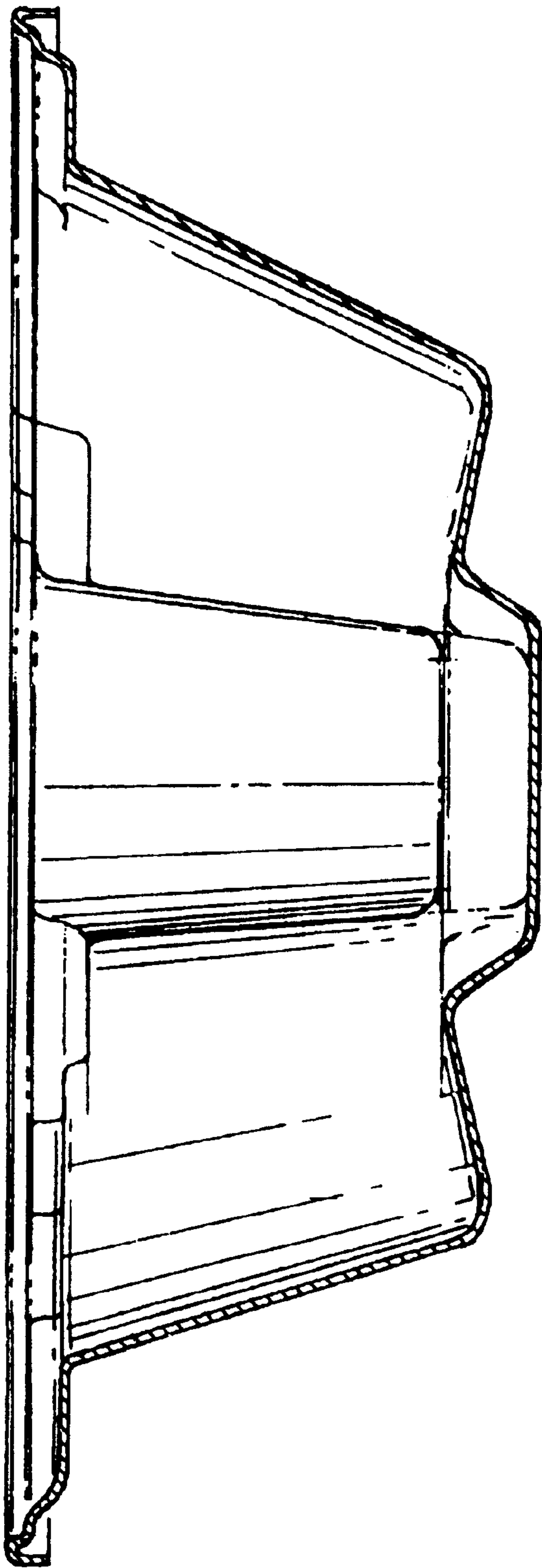

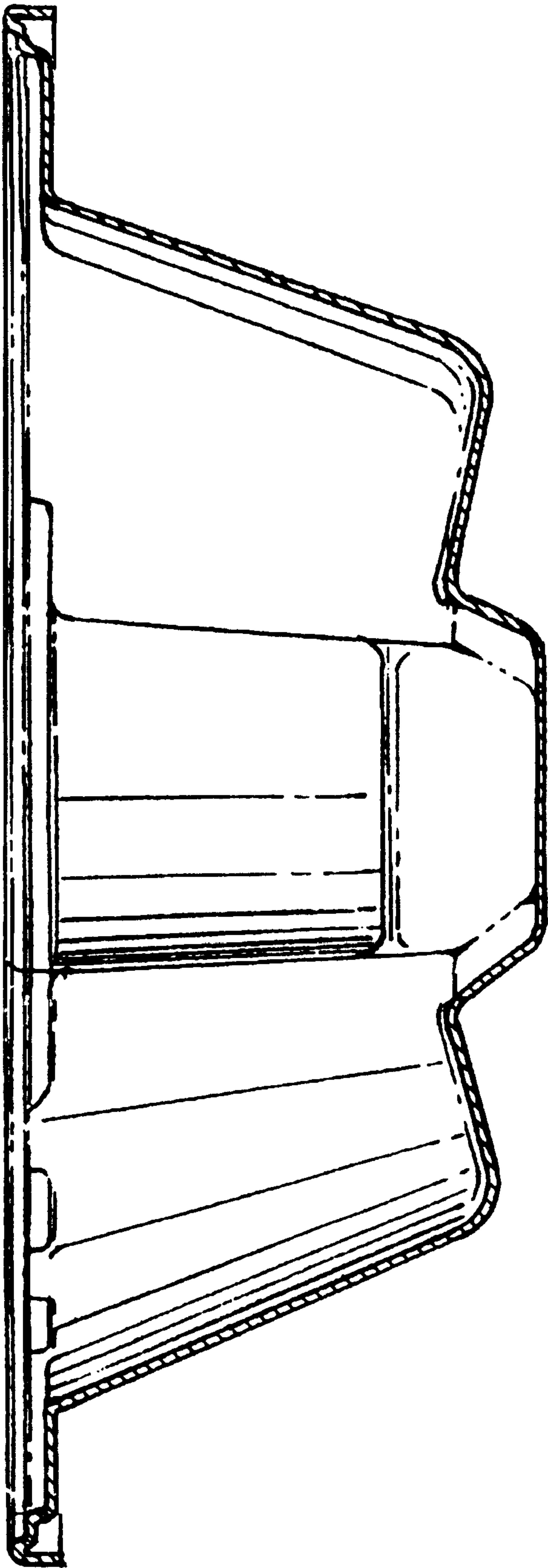
