(57) **CLAIM**

The ornamental design for a cabinet panel, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of the cabinet panel.

FIG. 2 is a sectional view taken through the lines 2—2 of FIG. 1.

FIG. 3 is a front elevational view of an alternate design for the cabinet panel.

FIG. 4 is a view taken through the lines 4—4 of FIG. 3.

FIG. 5 is a sectional view taken through the lines 5—5 of FIG. 3.

FIG. 6 is a front elevational view of another alternative design of the cabinet panel.

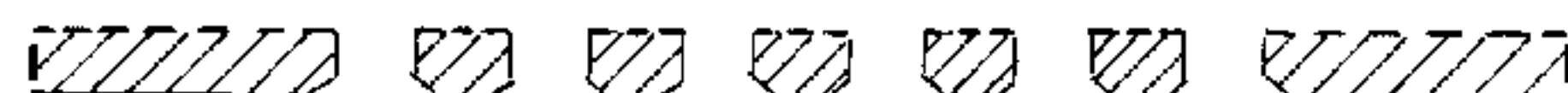
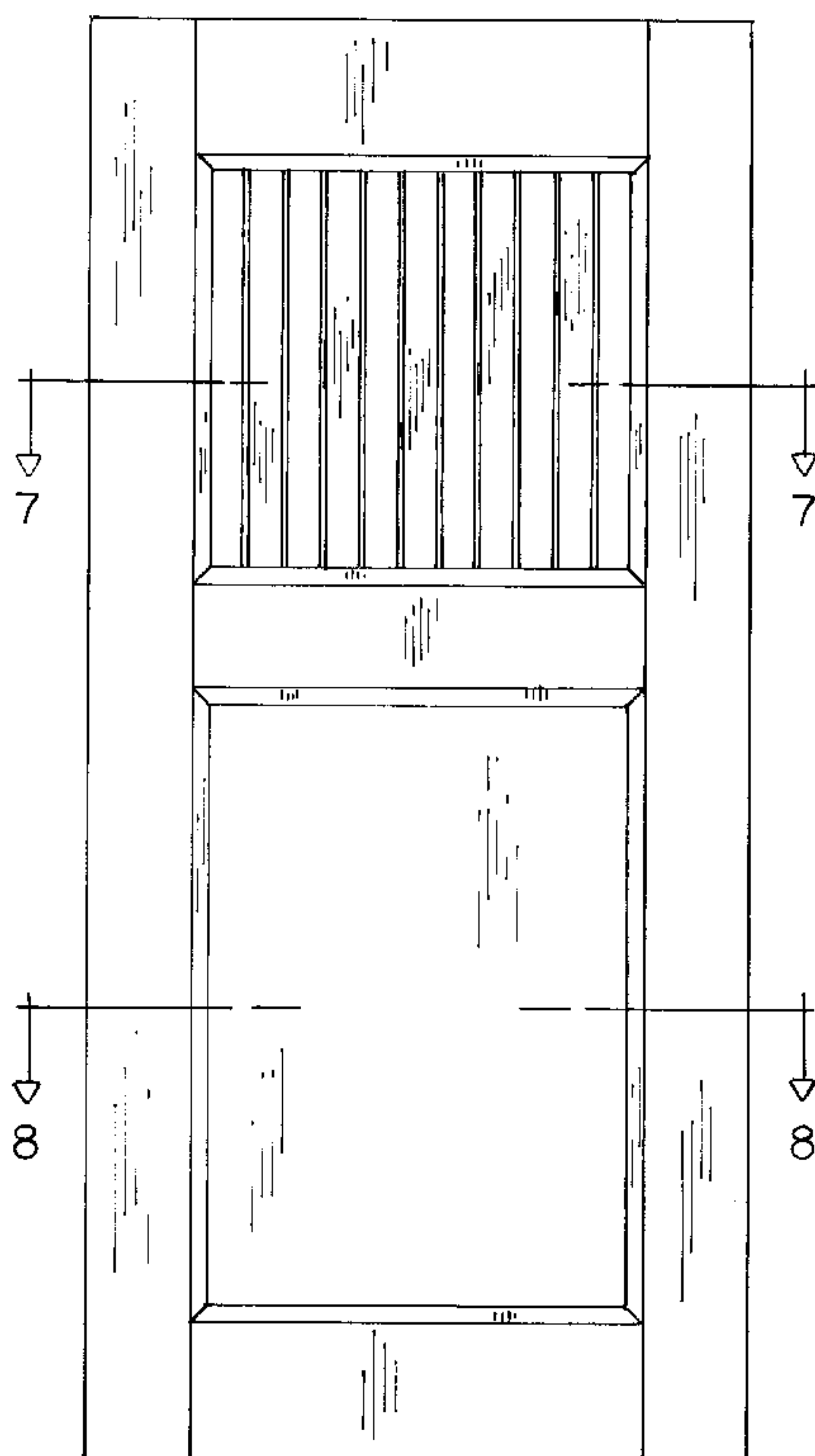
FIG. 7 is a sectional view taken through the lines 7—7 of FIG. 6; and,

FIG. 8 is a sectional view taken through the lines 8—8 of FIG. 6.

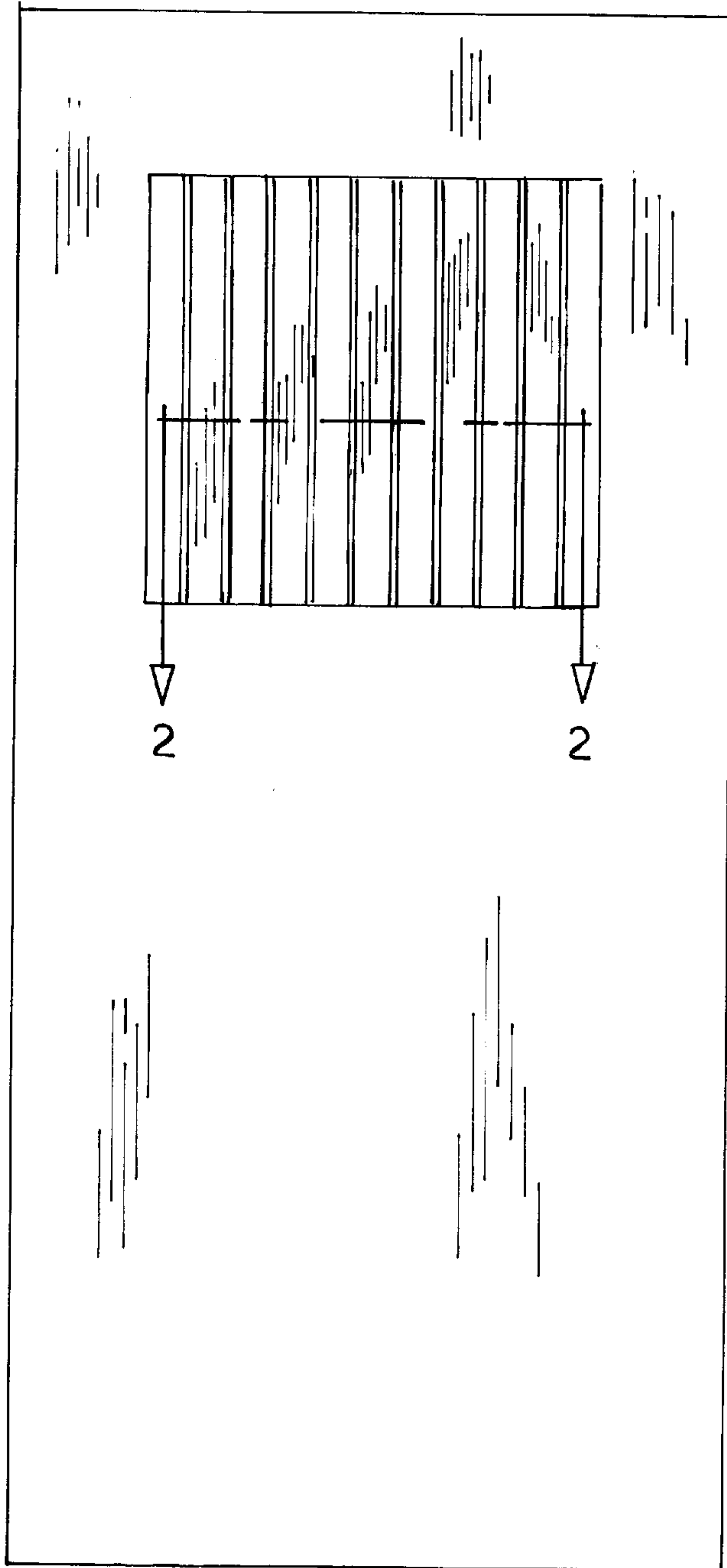

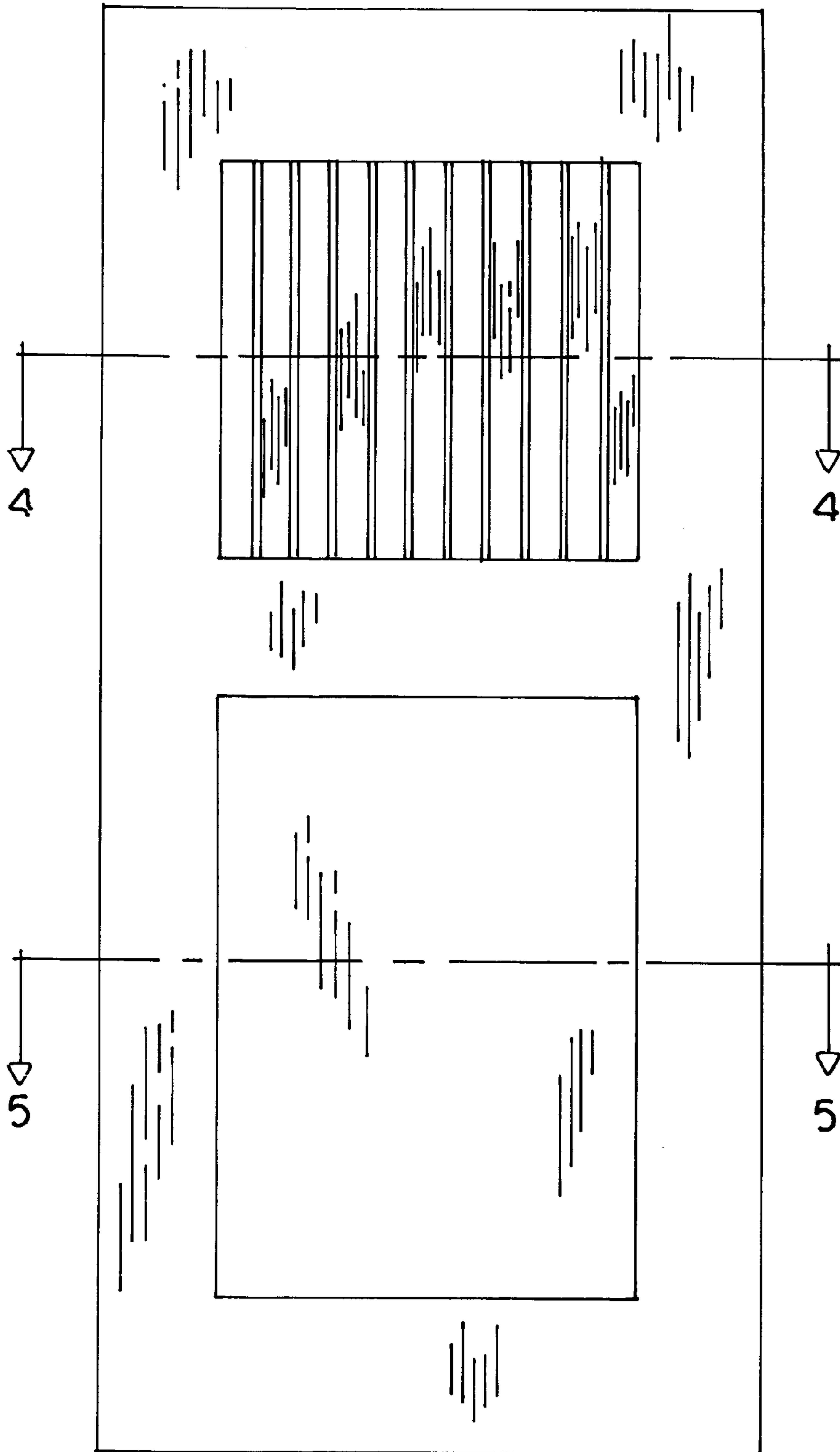

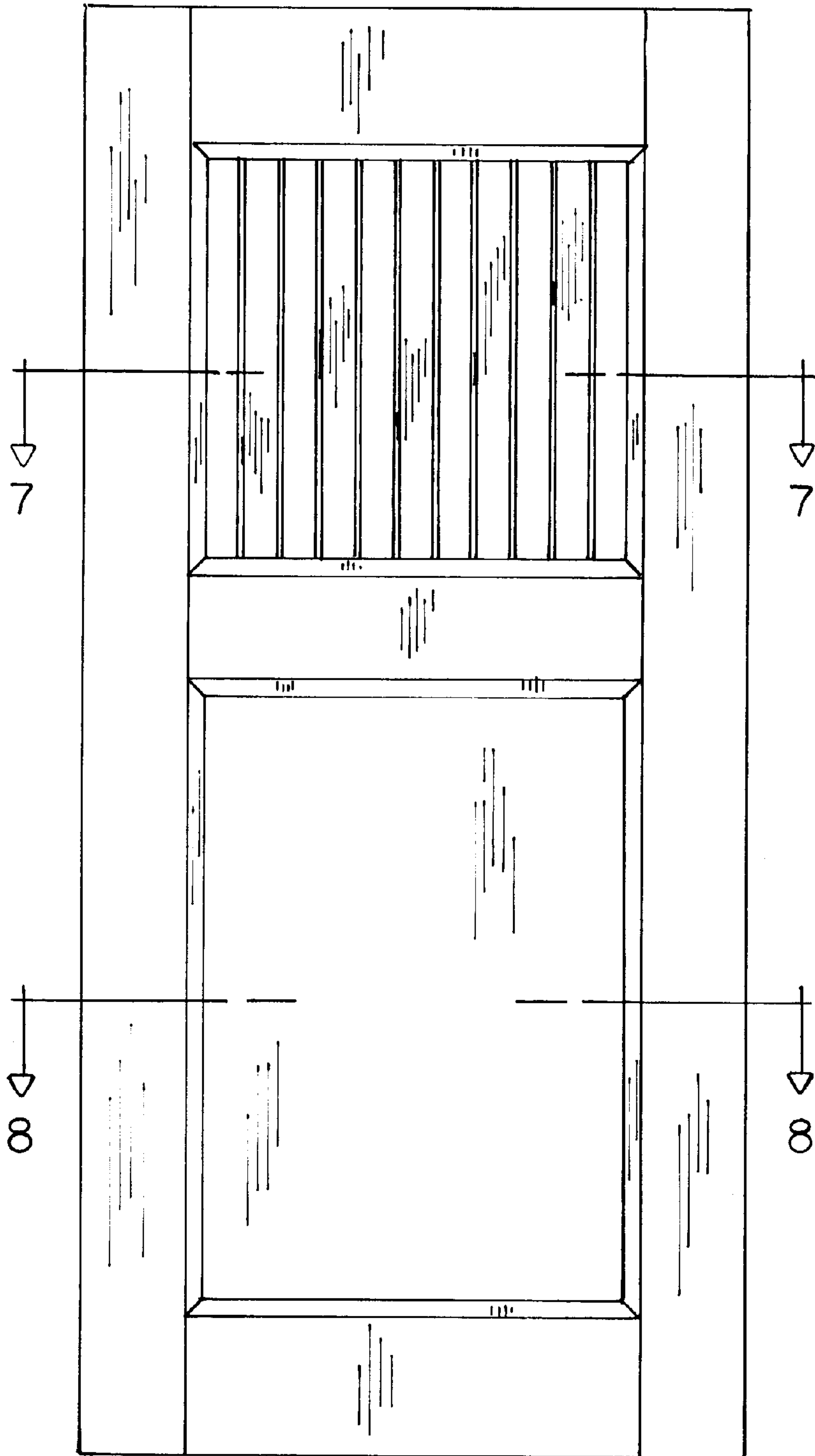
