(57) **CLAIM**

The ornamental design for a beverage stand/holder, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of the beverage stand/holder of the present invention, the rear view being a mirror image thereof;

FIG. 2 is a left side elevational view of the beverage stand/holder of FIG. 1, the right view being a mirror image thereof;

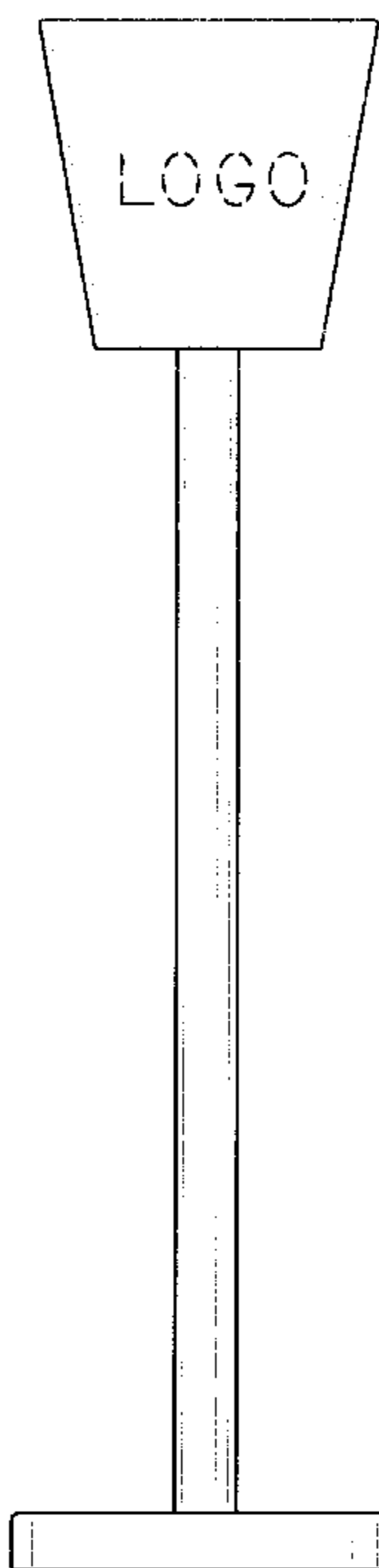
FIG. 3 is a top plan view of the beverage stand/holder of FIG. 1;

FIG. 4 is a bottom plan view of the beverage stand/holder of FIG. 1; and,

FIG. 5 is a top, front perspective view in an alternate position (exploded view).

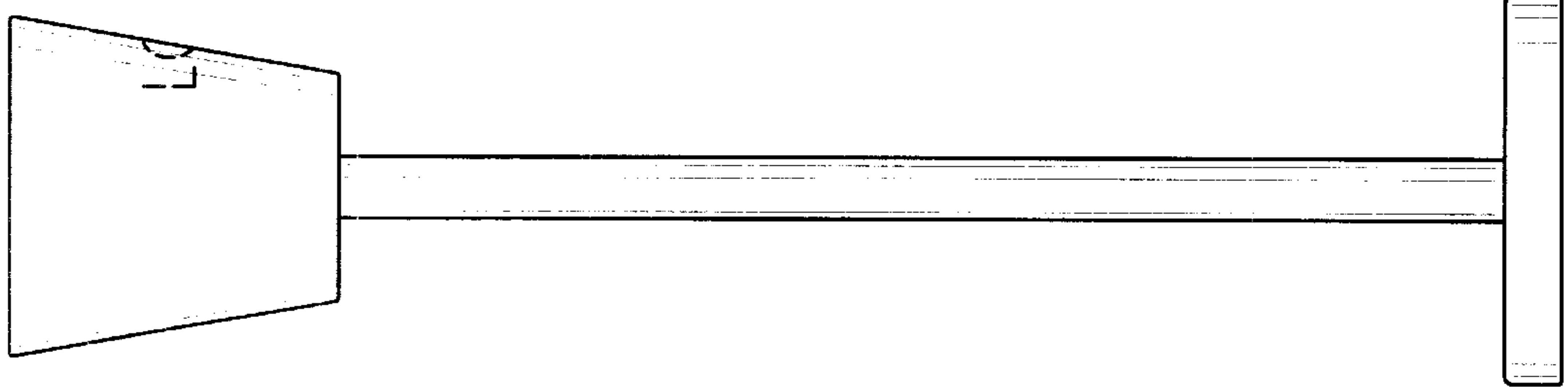

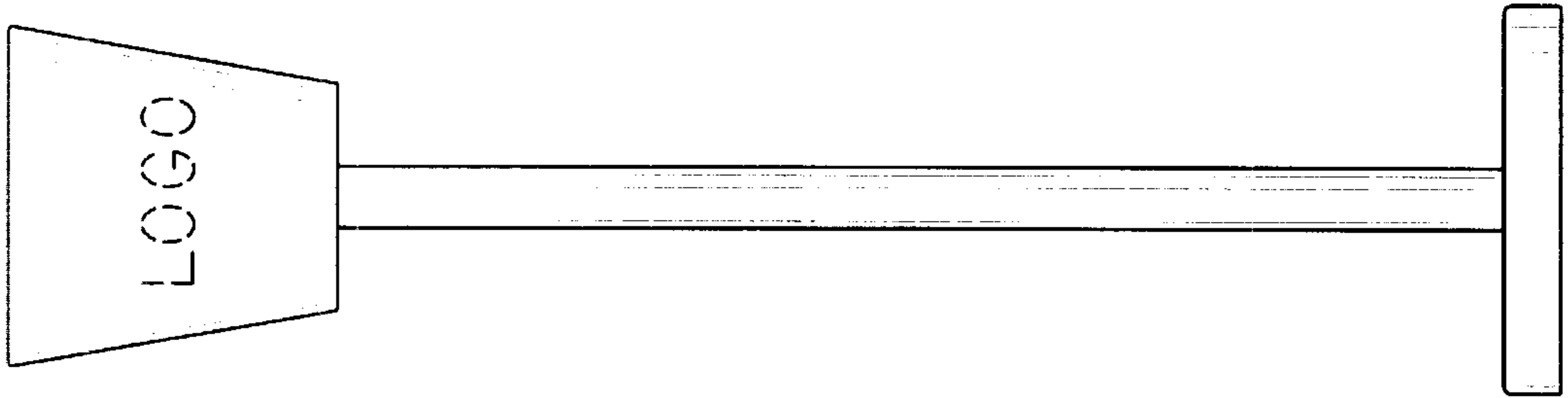

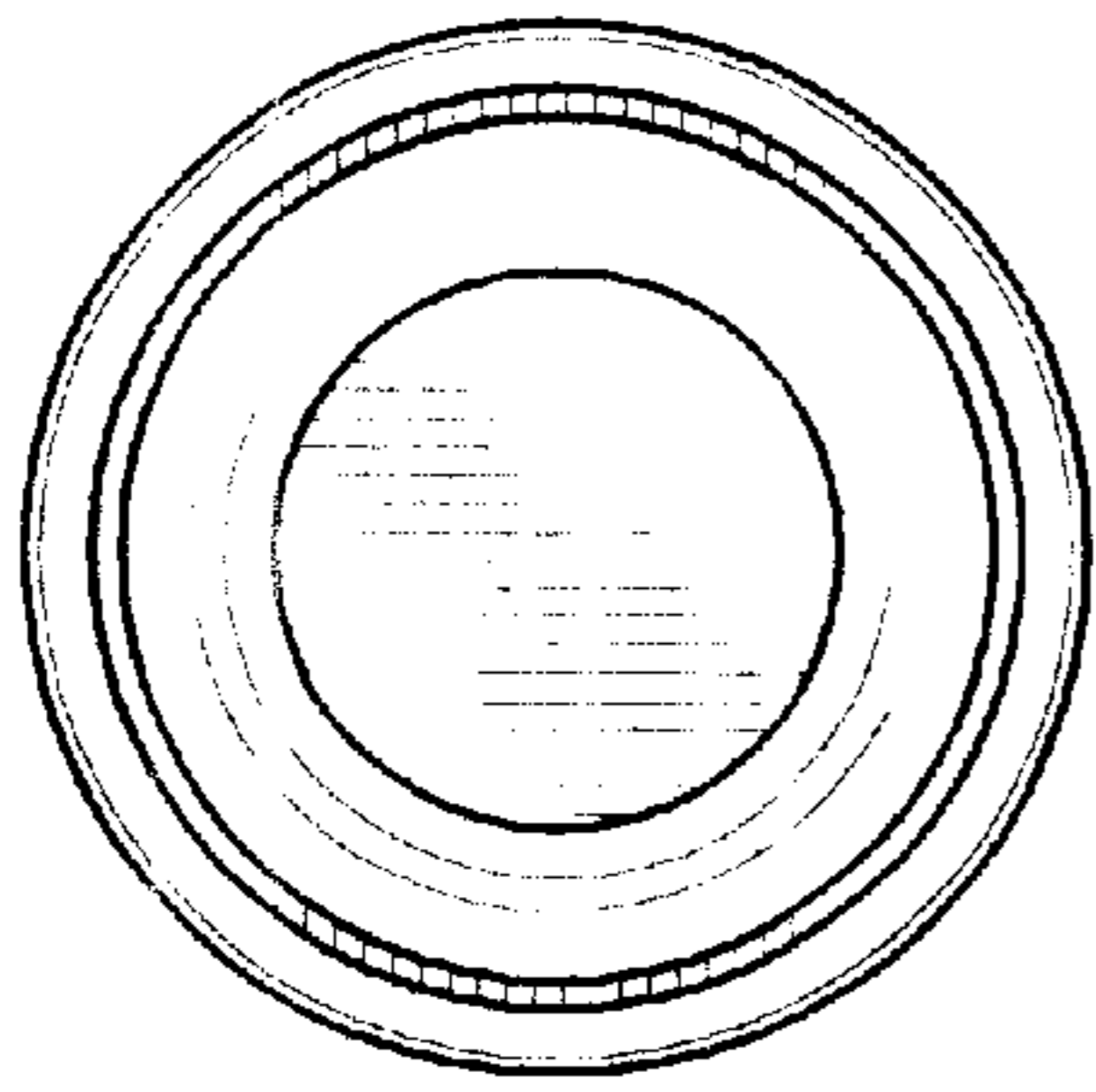

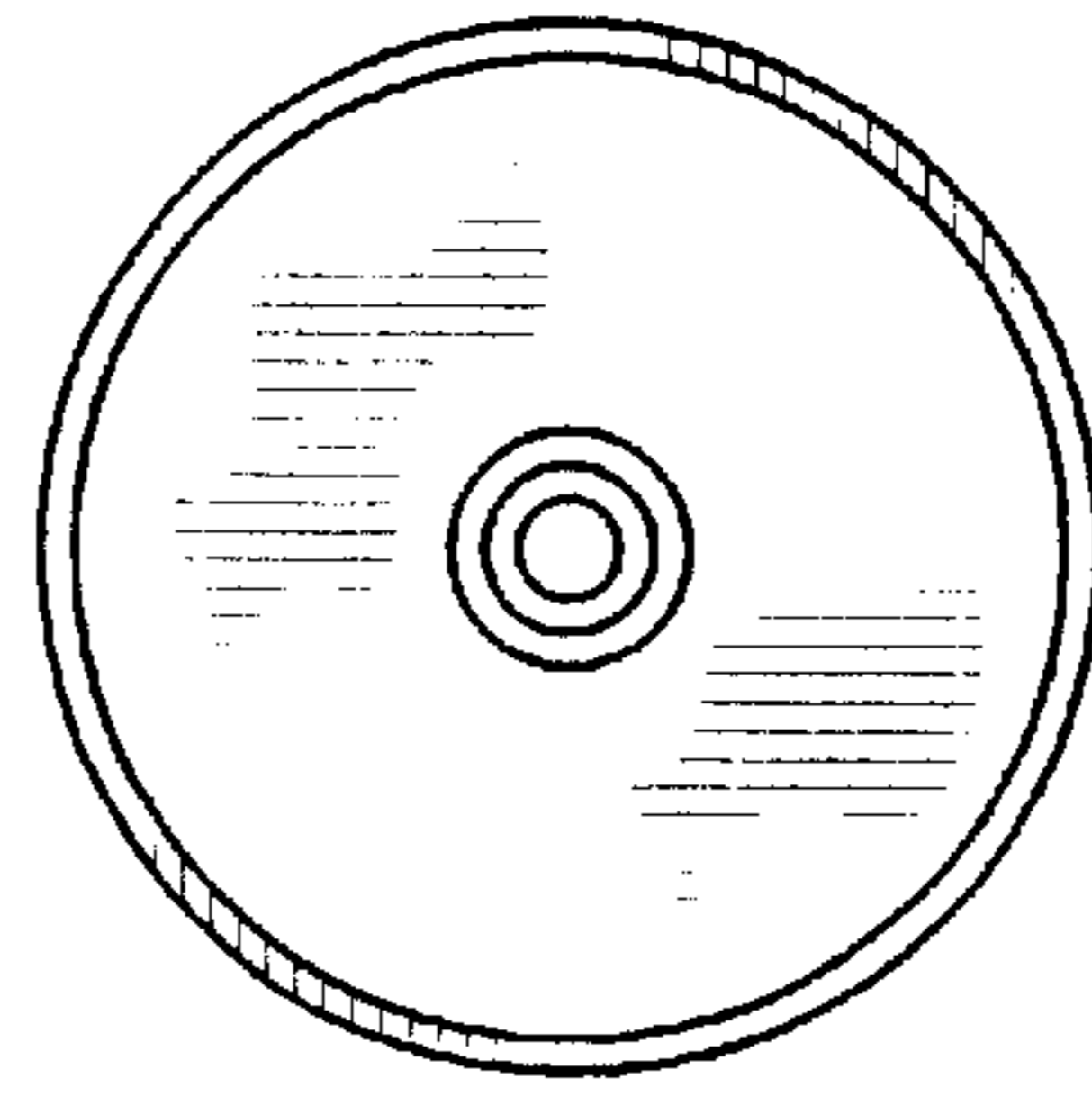
