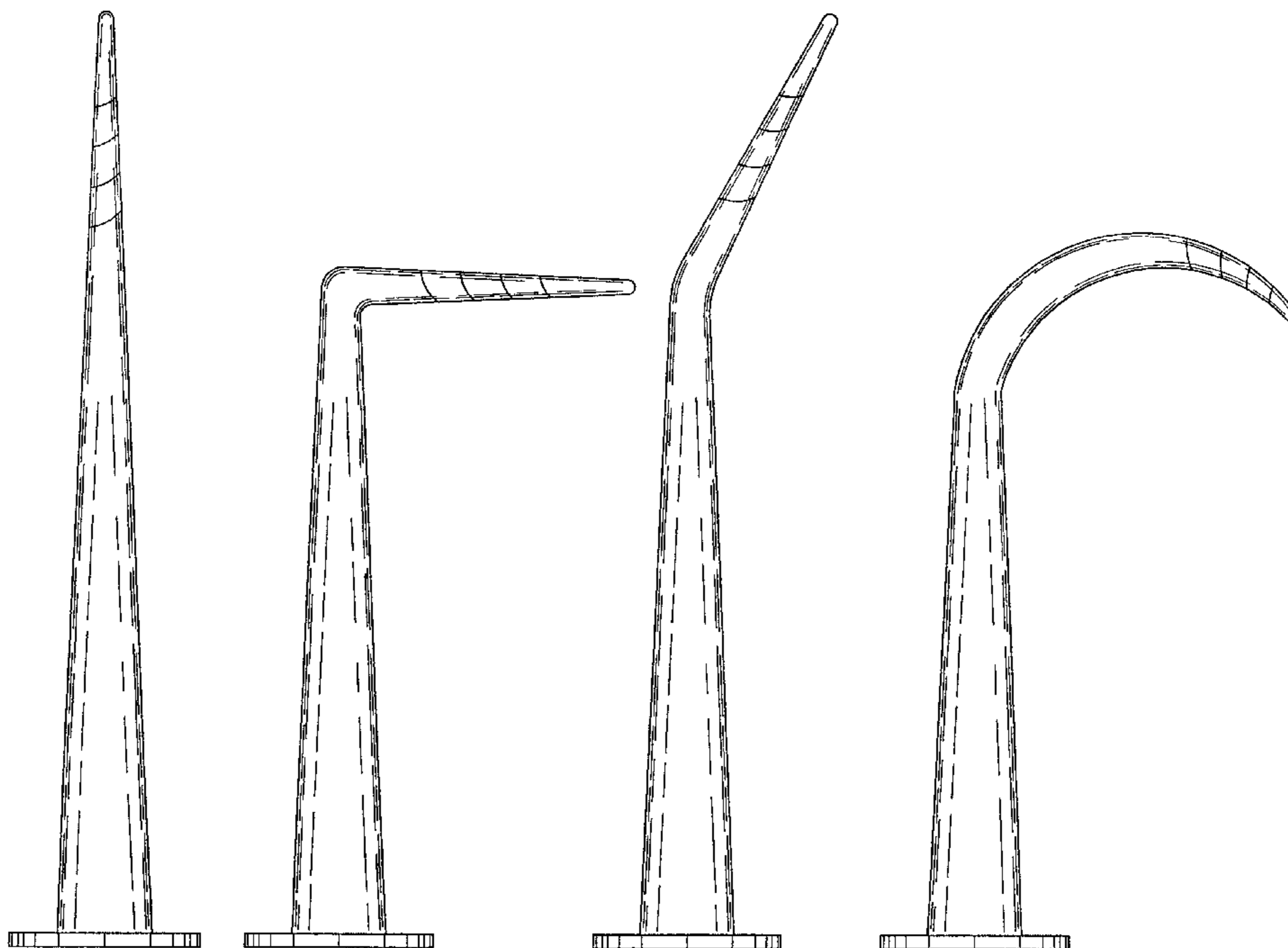

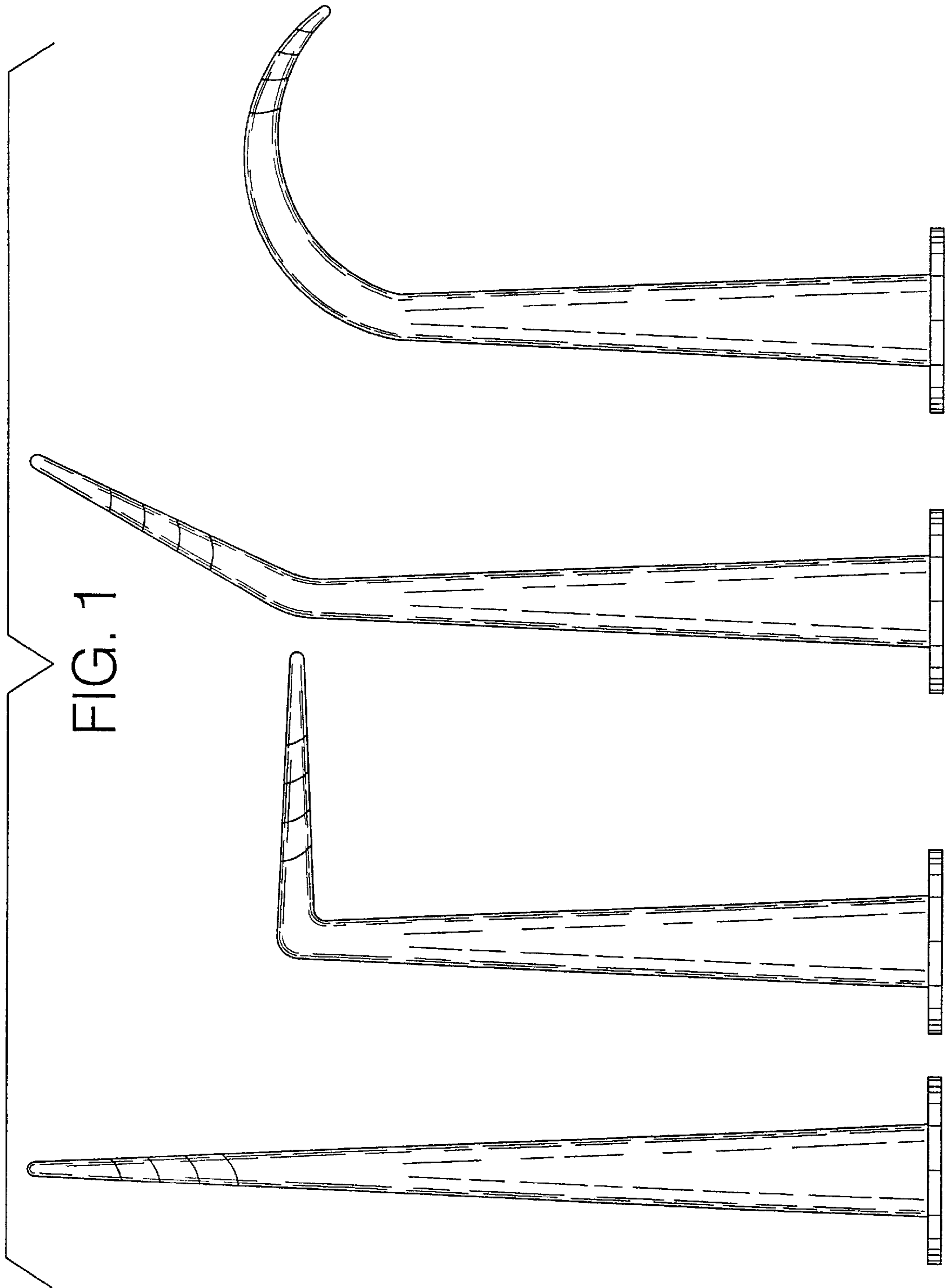
The ornamental design for a set of caulking applicator tips, as shown and described.

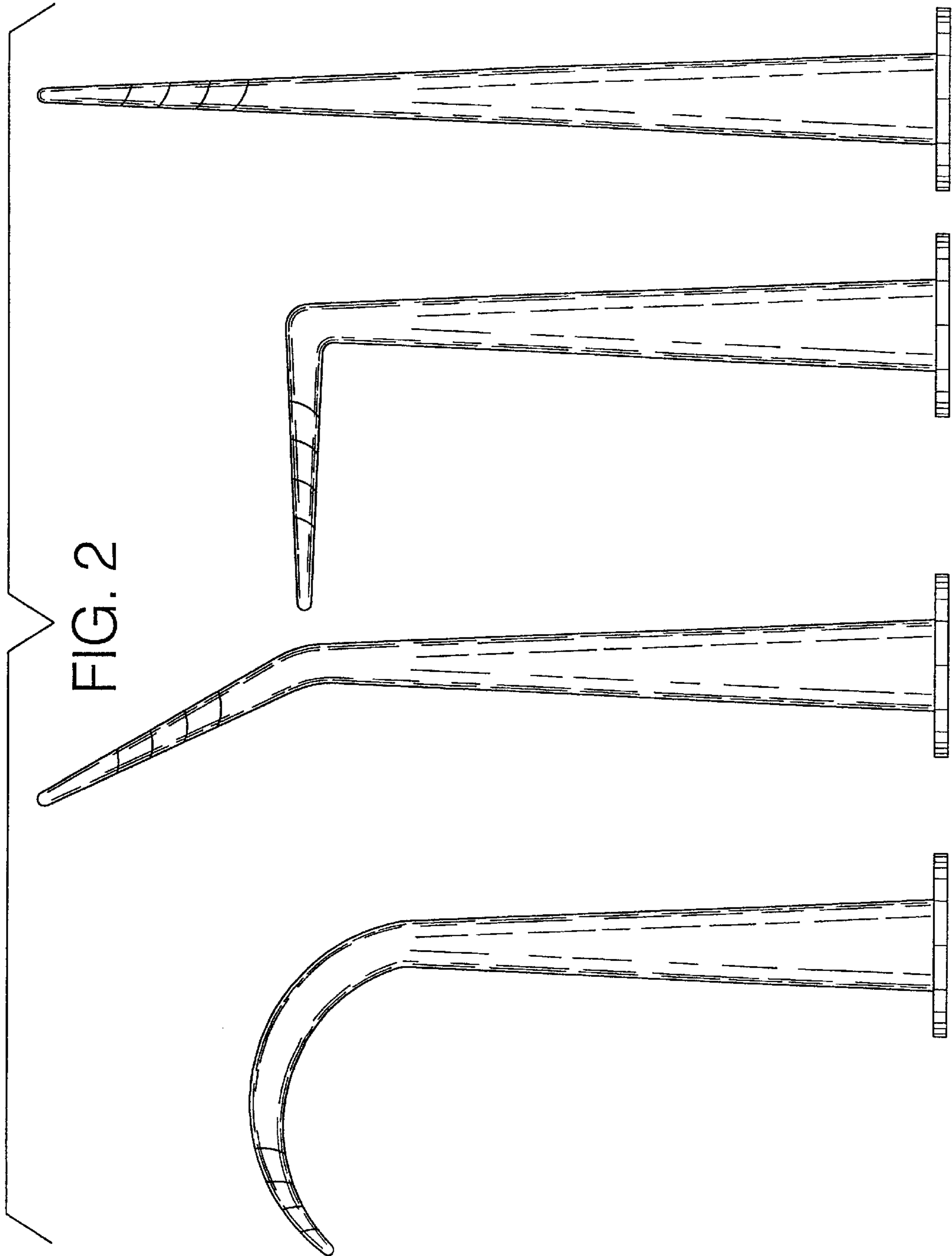
DESCRIPTION

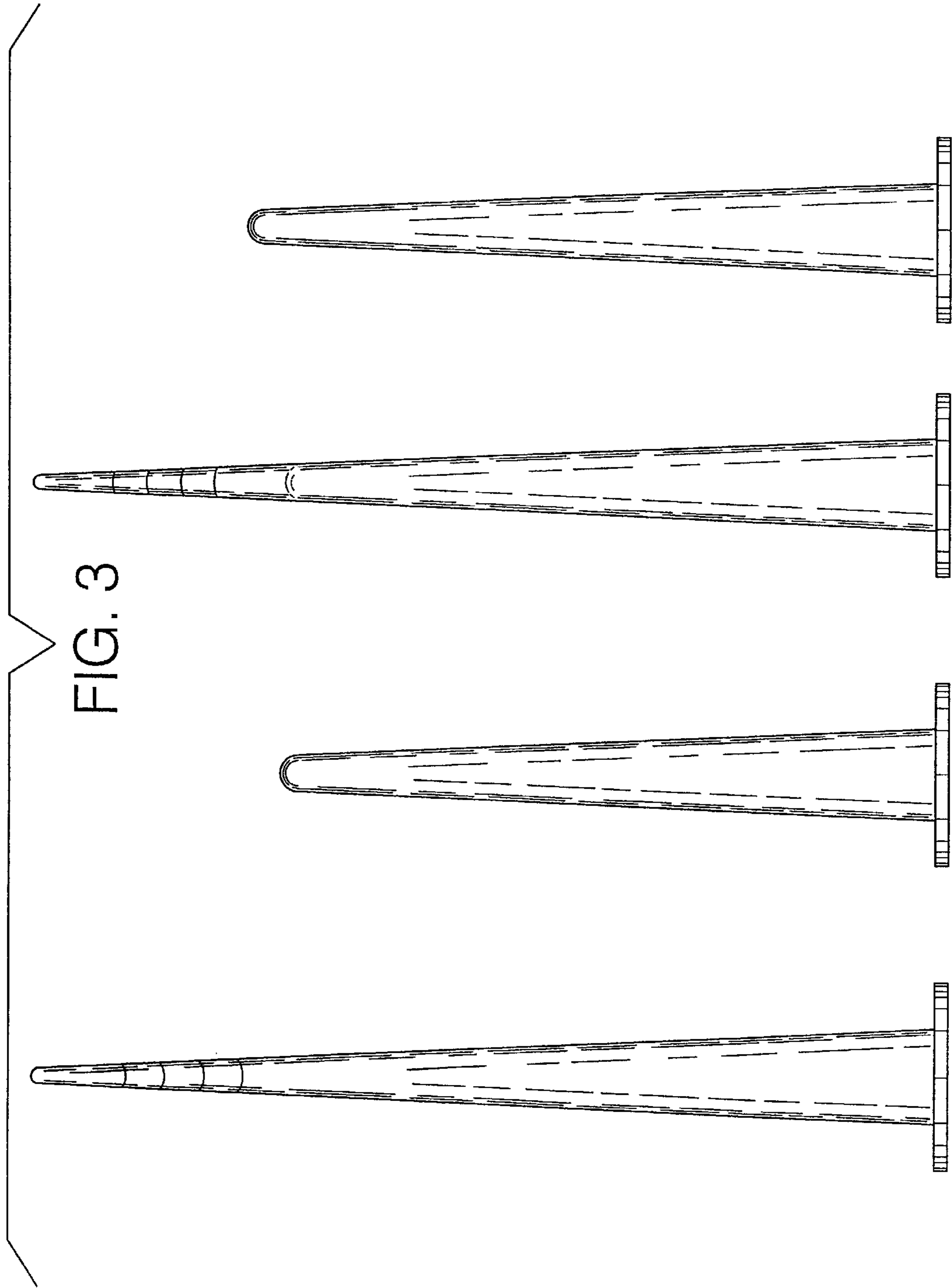
FIG. 1 is a front elevational view of the set of caulking applicator tips of the present invention;

 FIG. 7 is a cross-sectional view of FIG. 5 taken along lines 7—7.

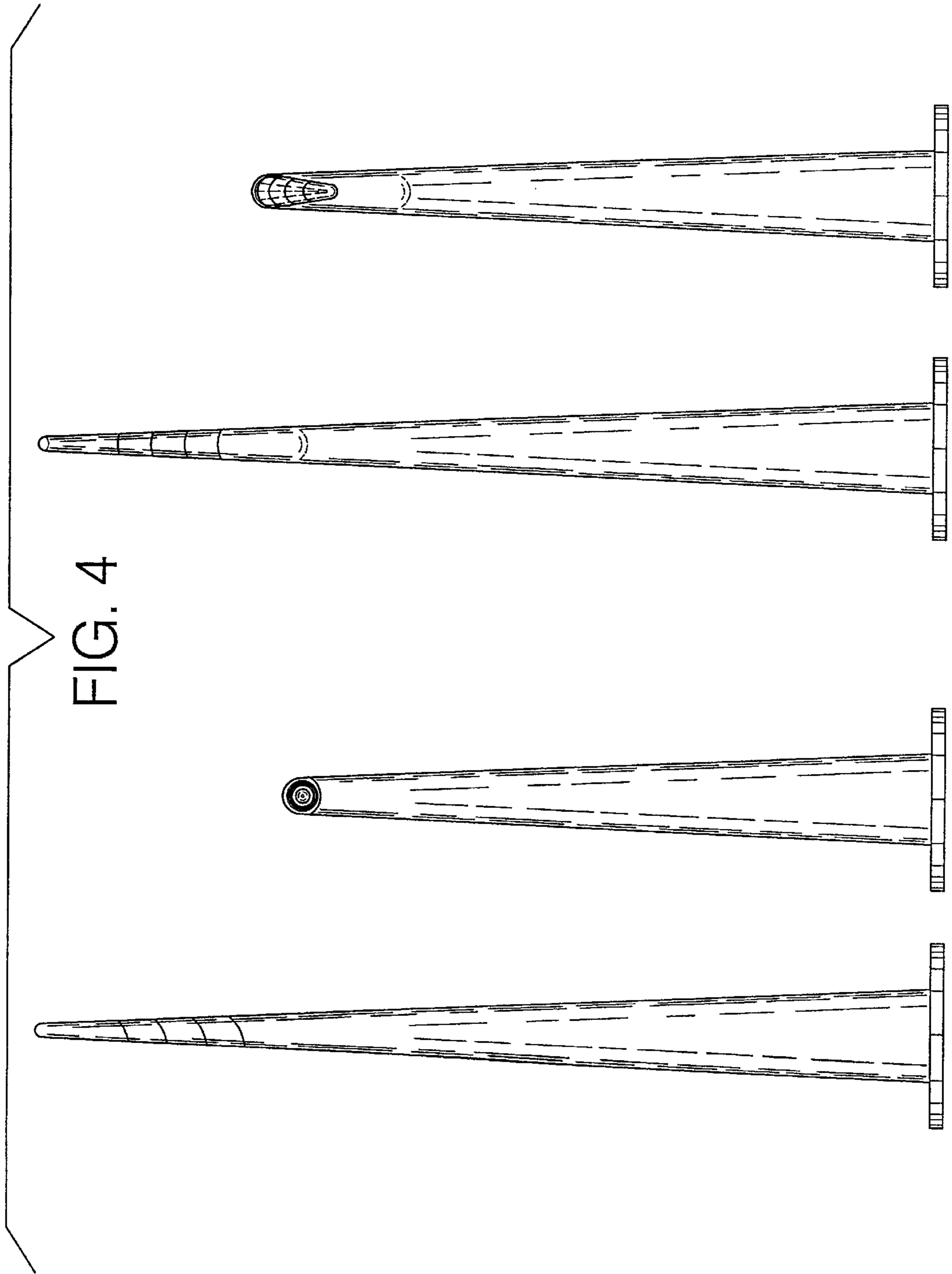

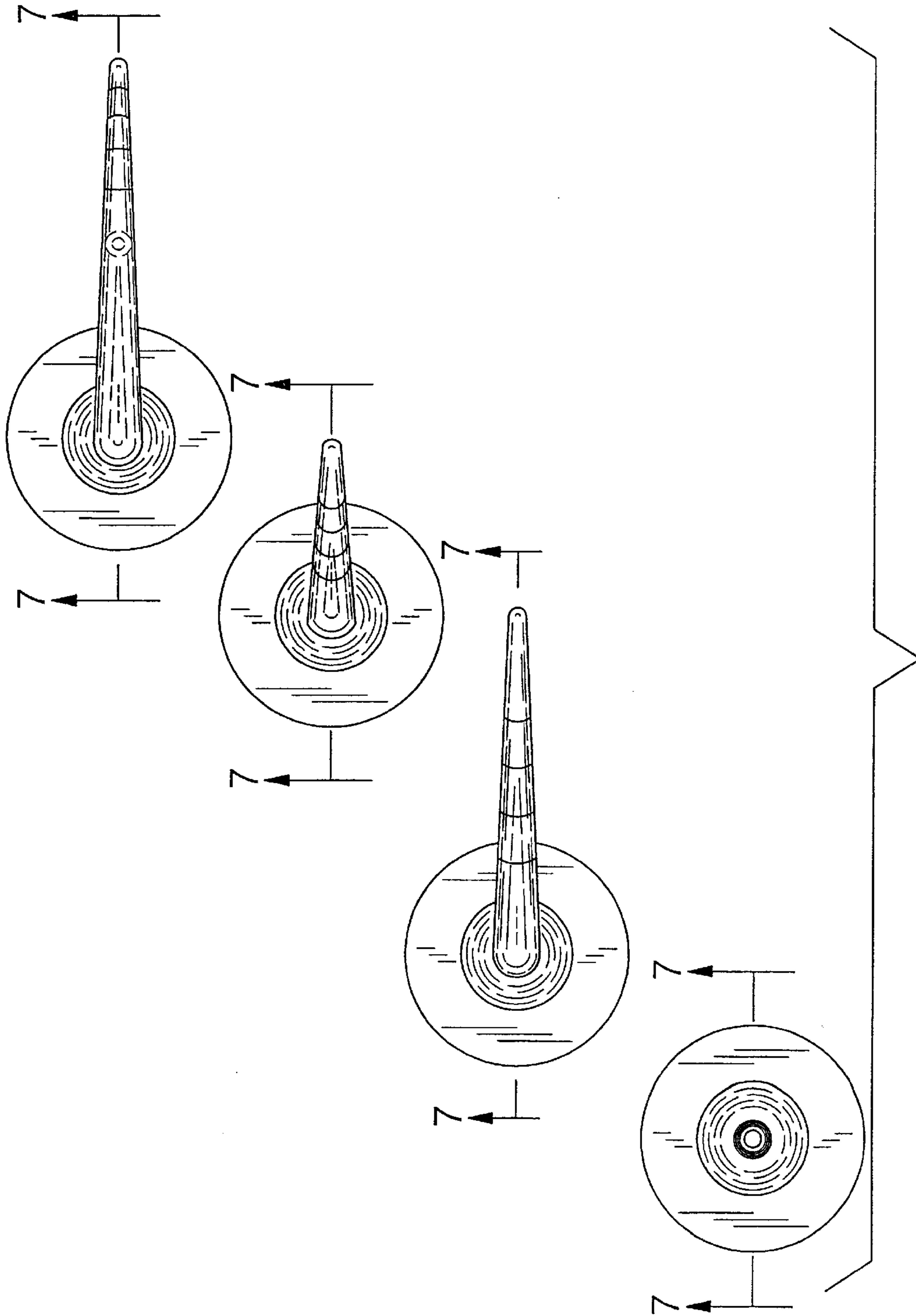

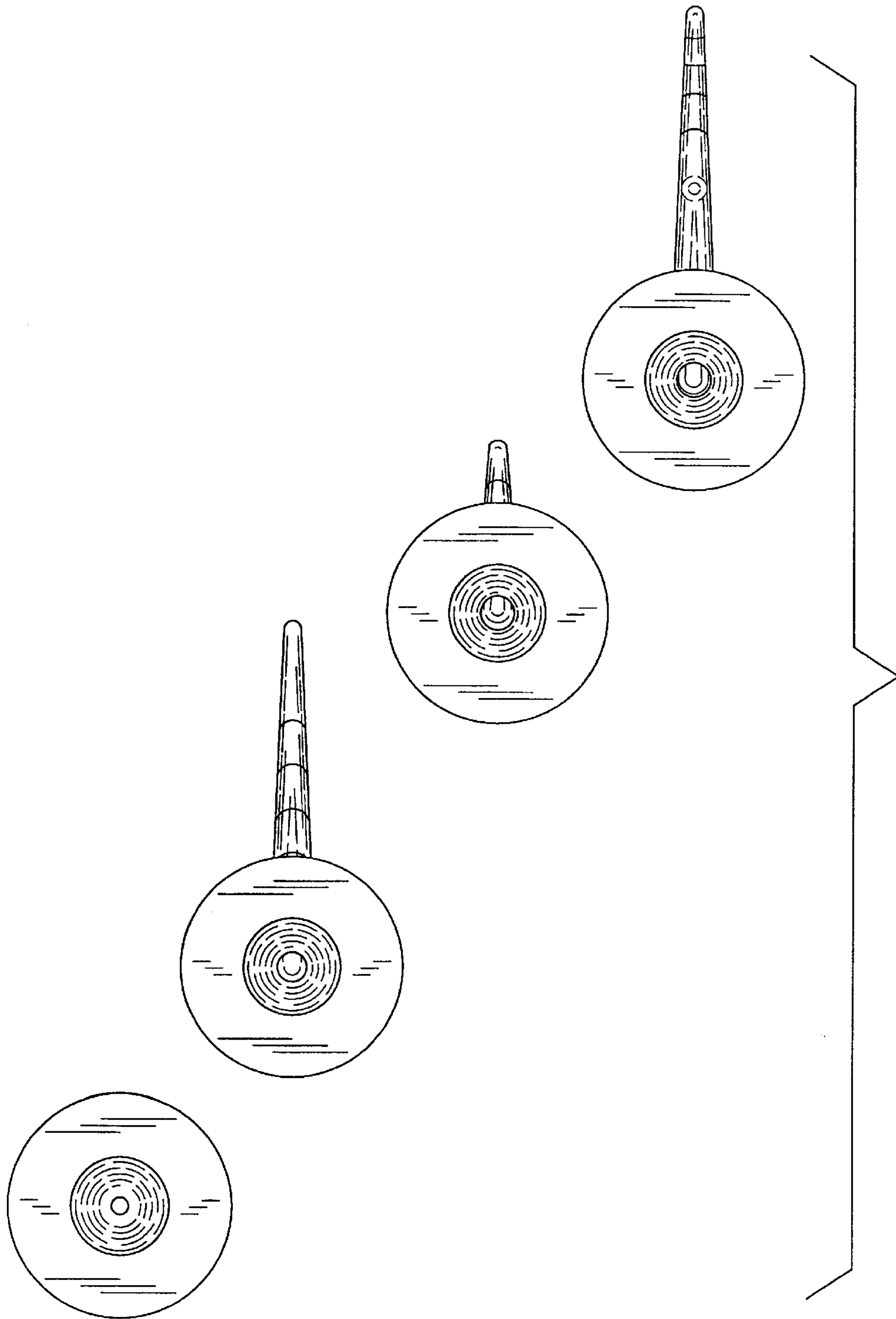
