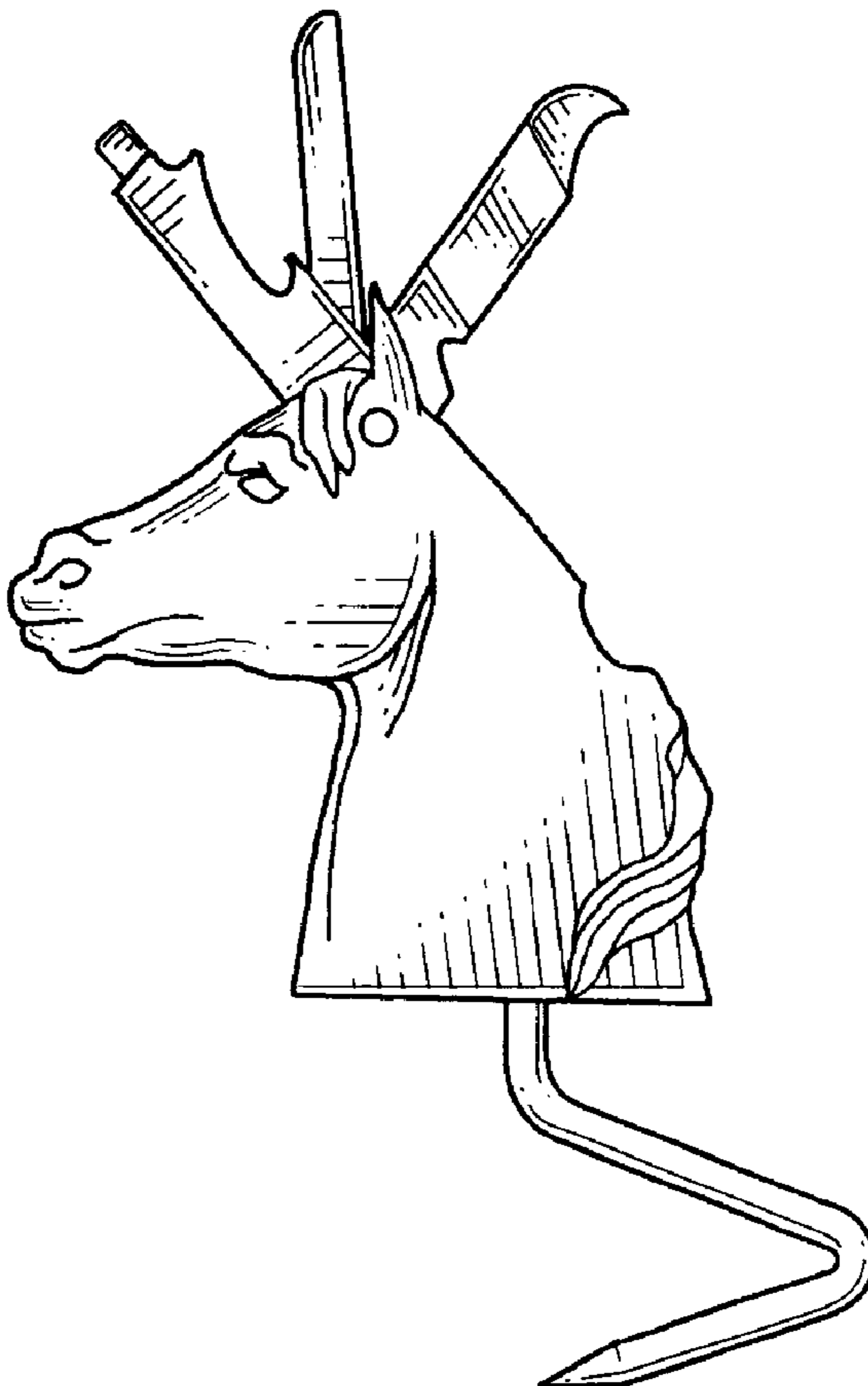
(57) **CLAIM**

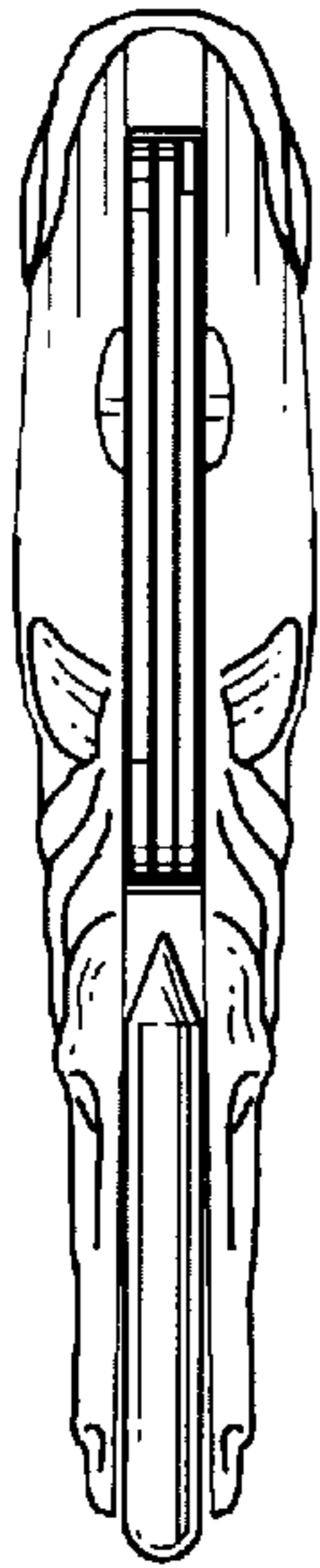
I claim the ornamental design for an equestrian tool, as shown and described.

**DESCRIPTION**

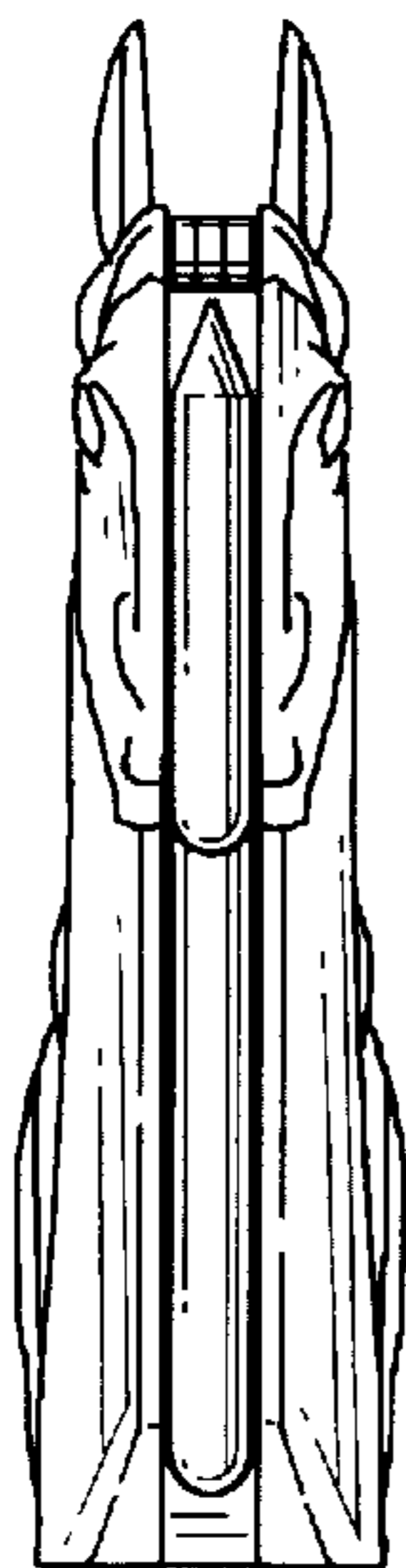
FIG. 1 is a side view of my design for an equestrian tool shown in an open position;

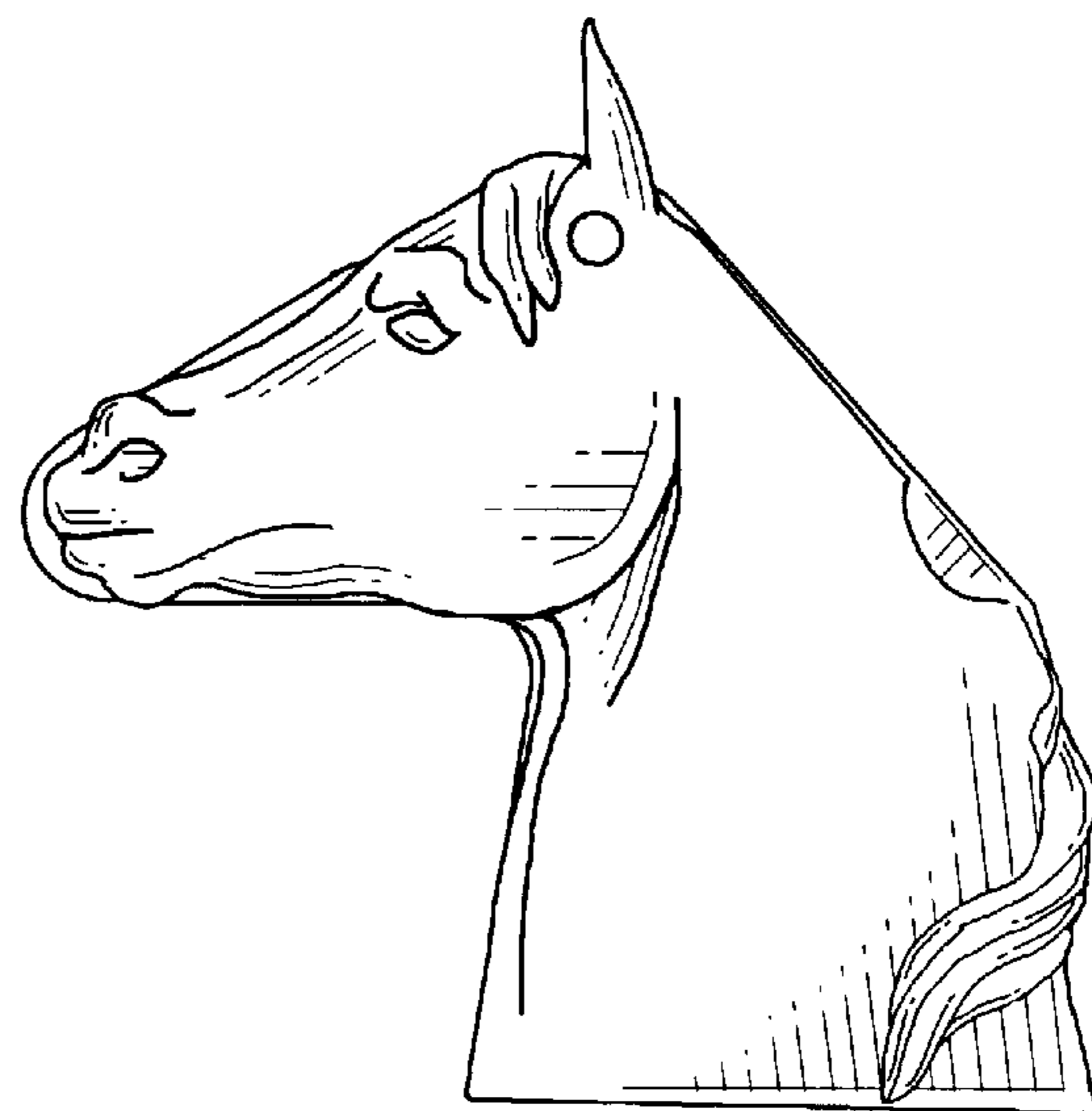
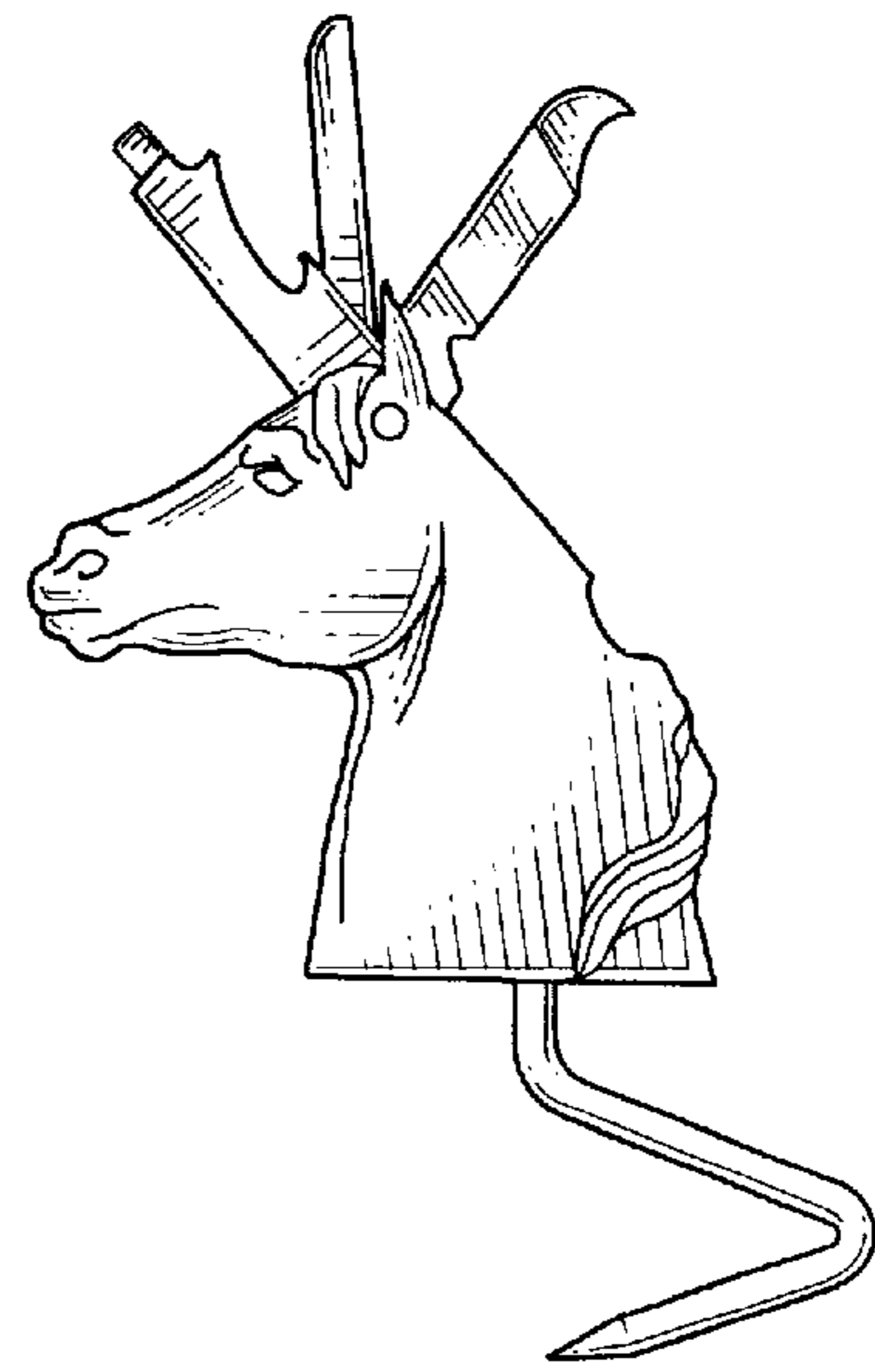

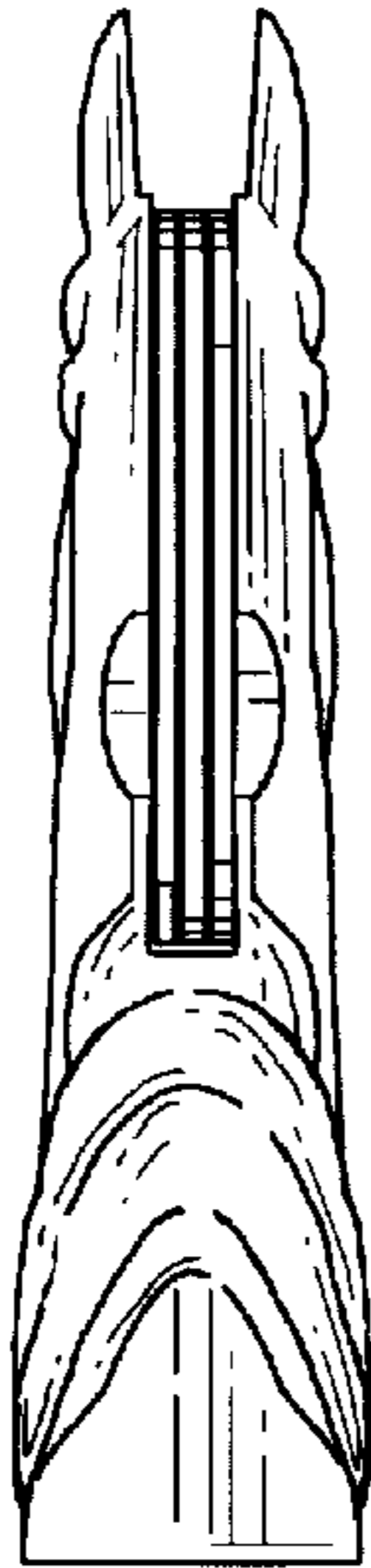

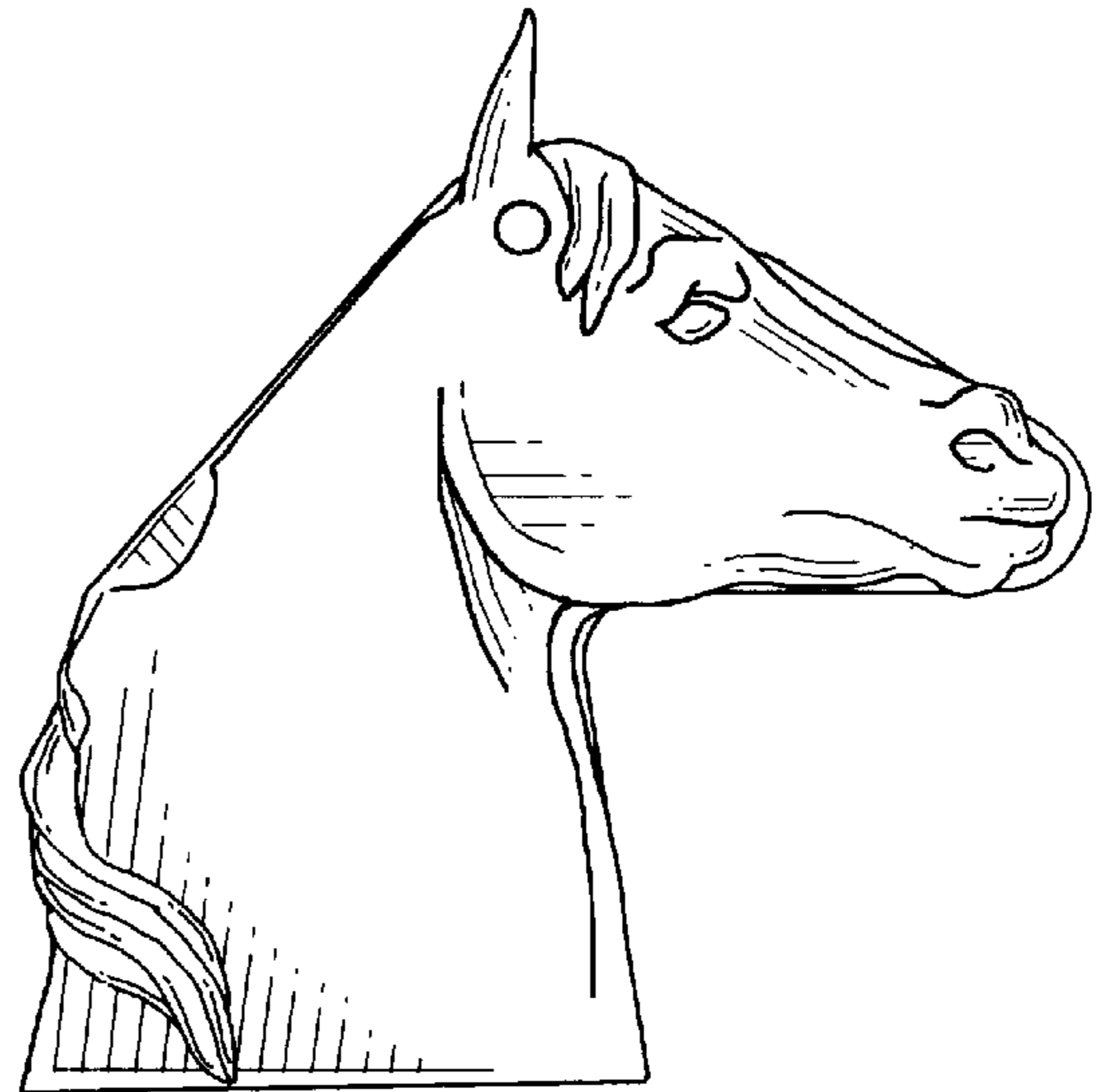

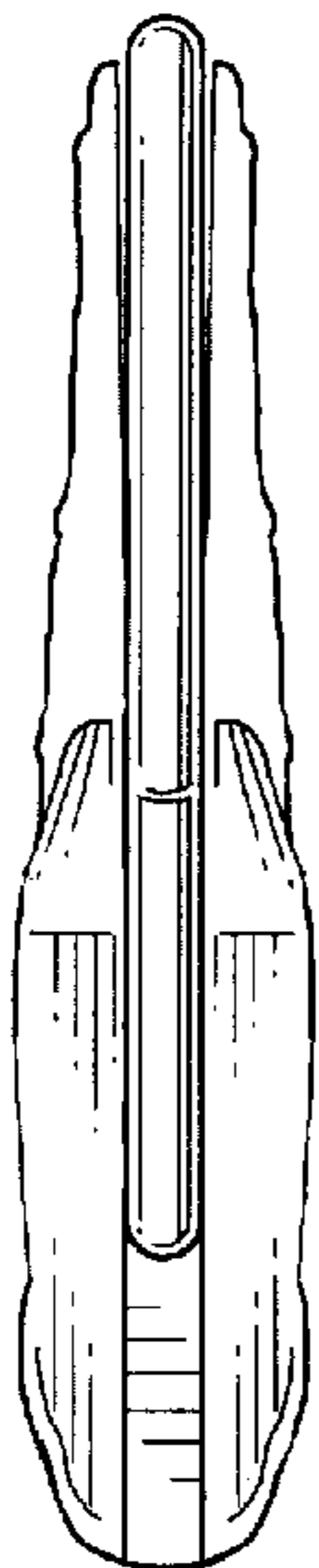
