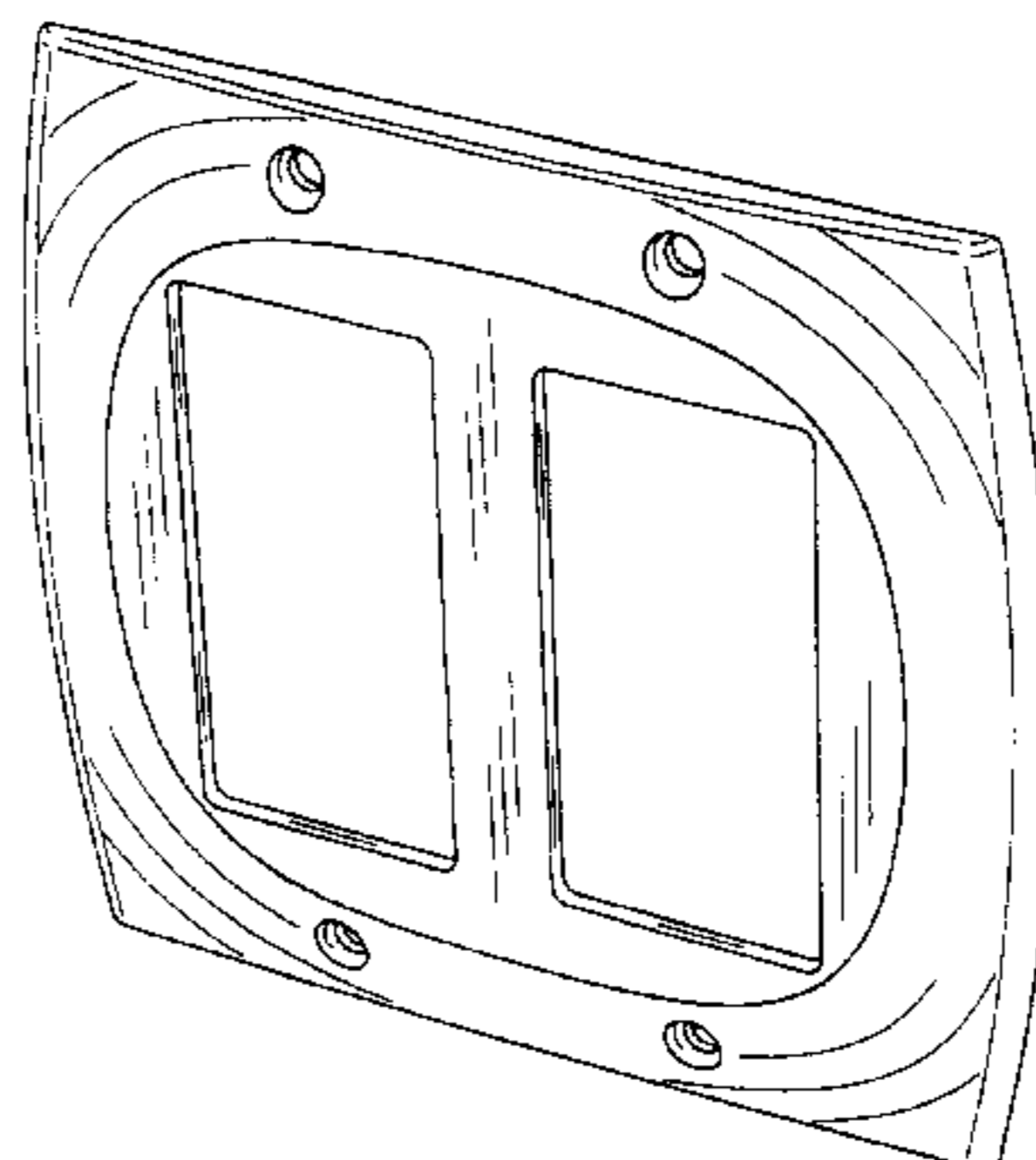
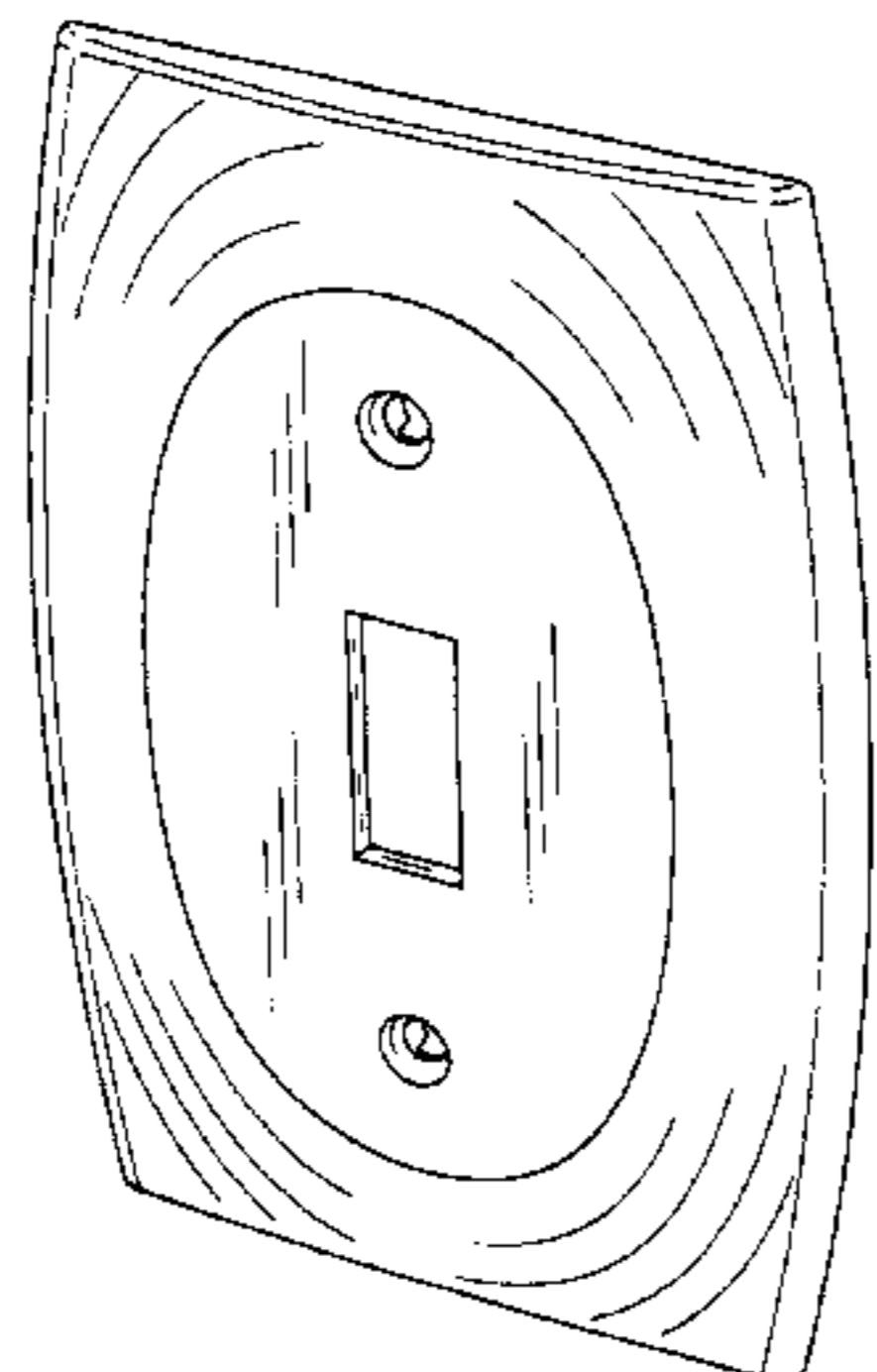
FIG. 1 is a front perspective view of a switch trim plate showing a first embodiment of my new design.

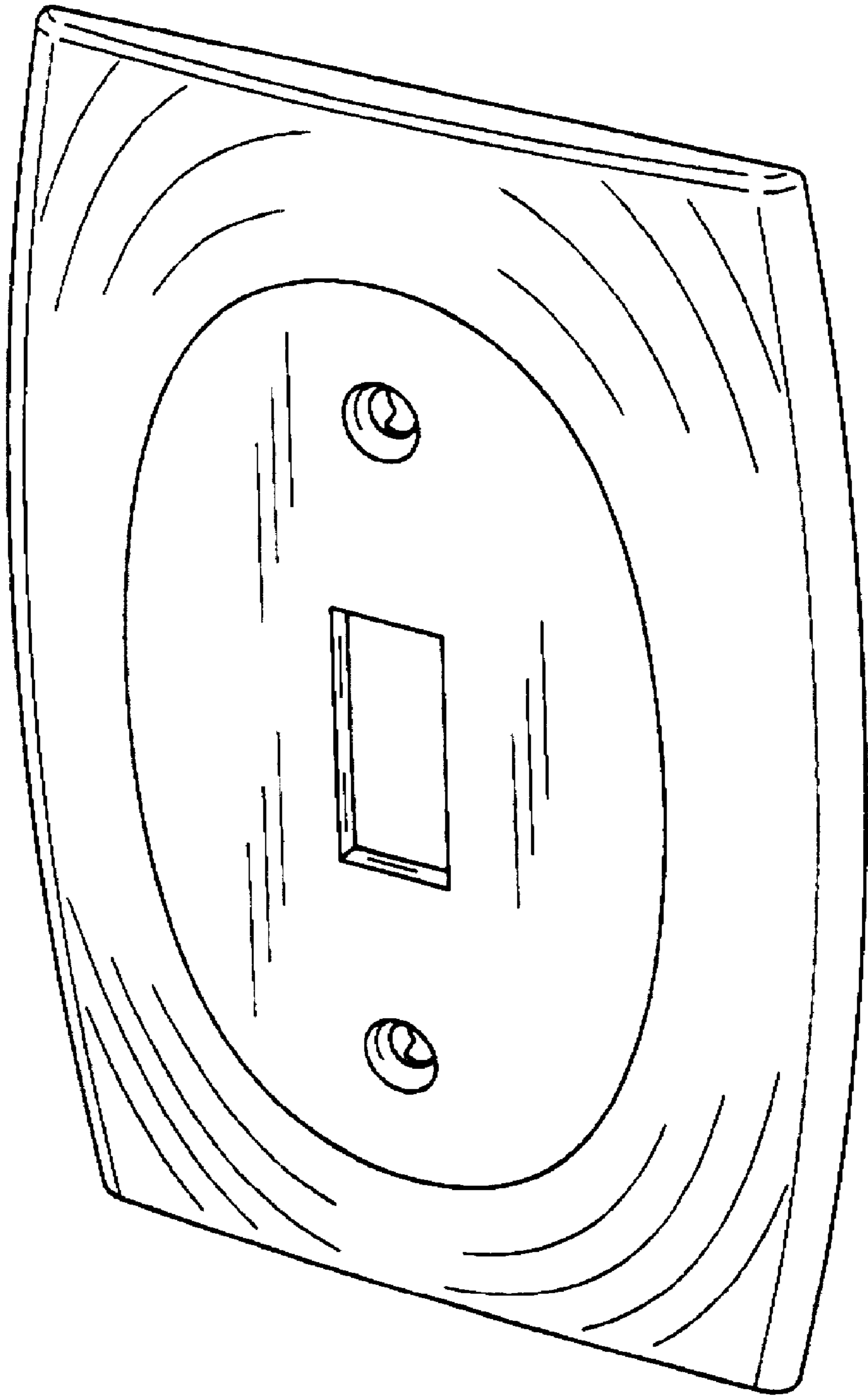

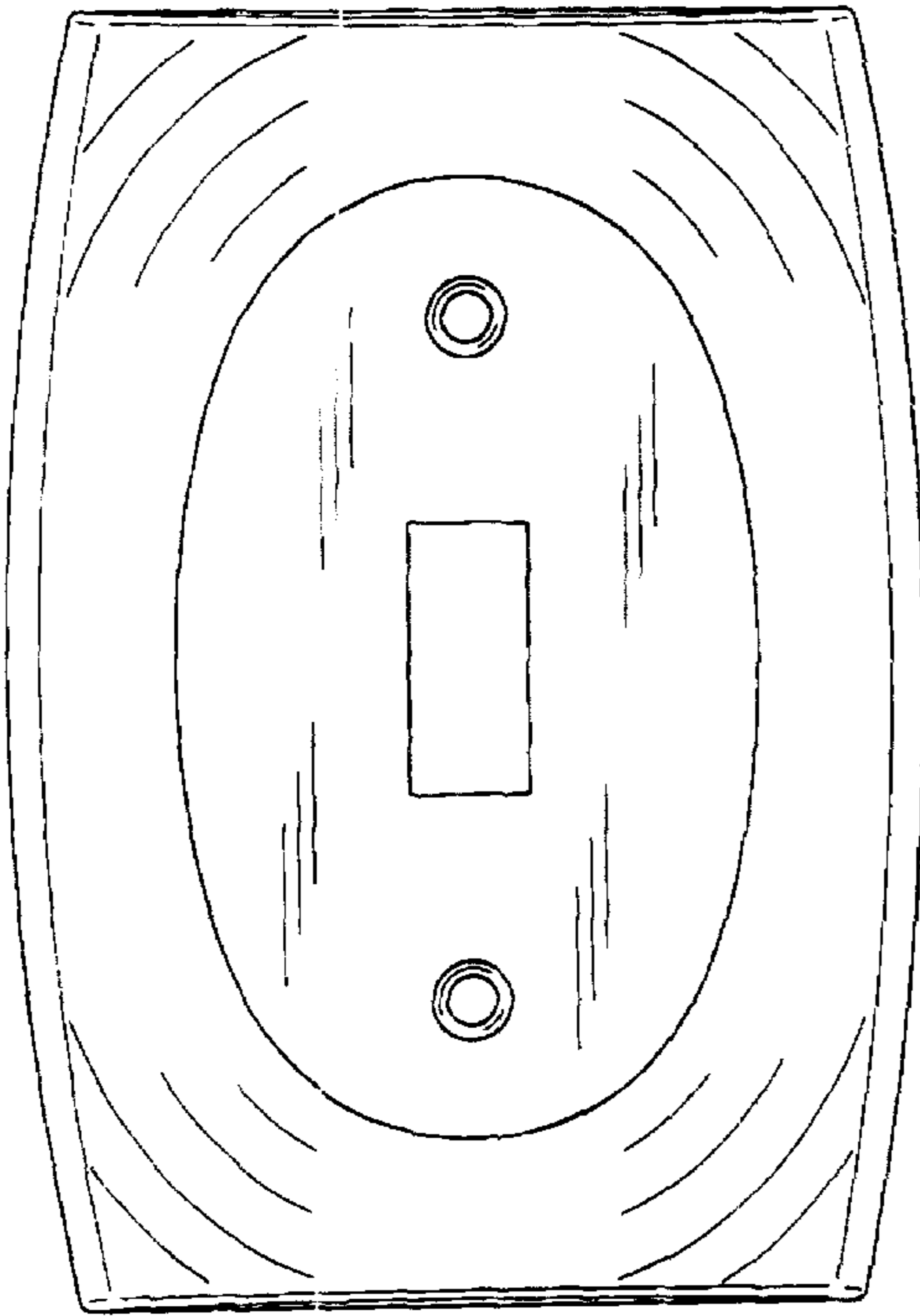

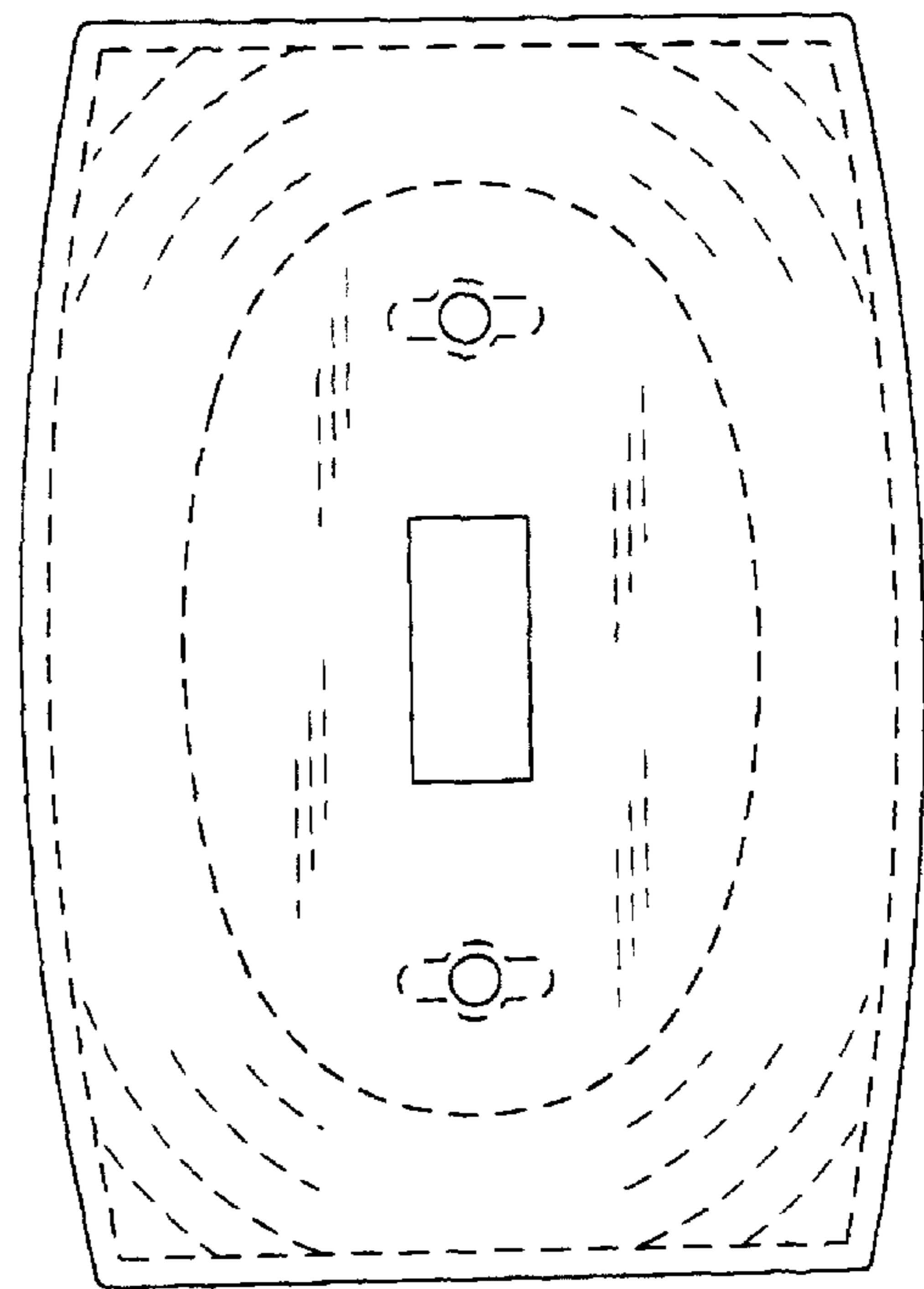

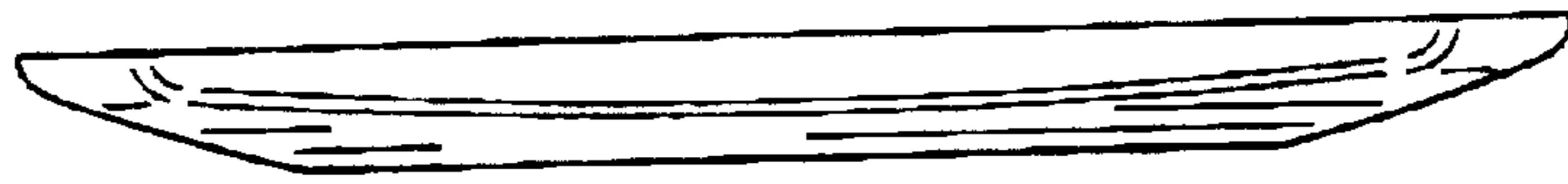

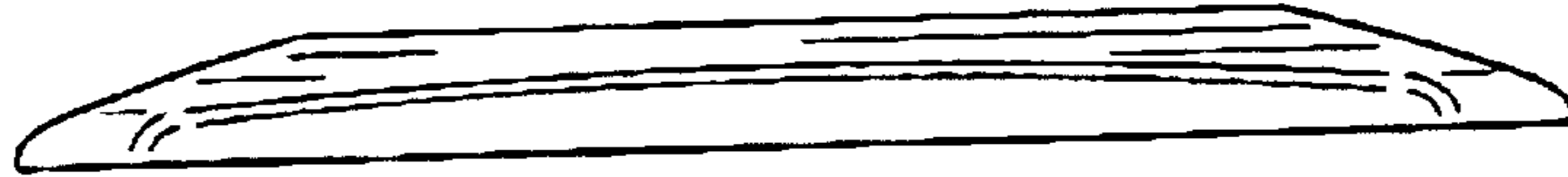

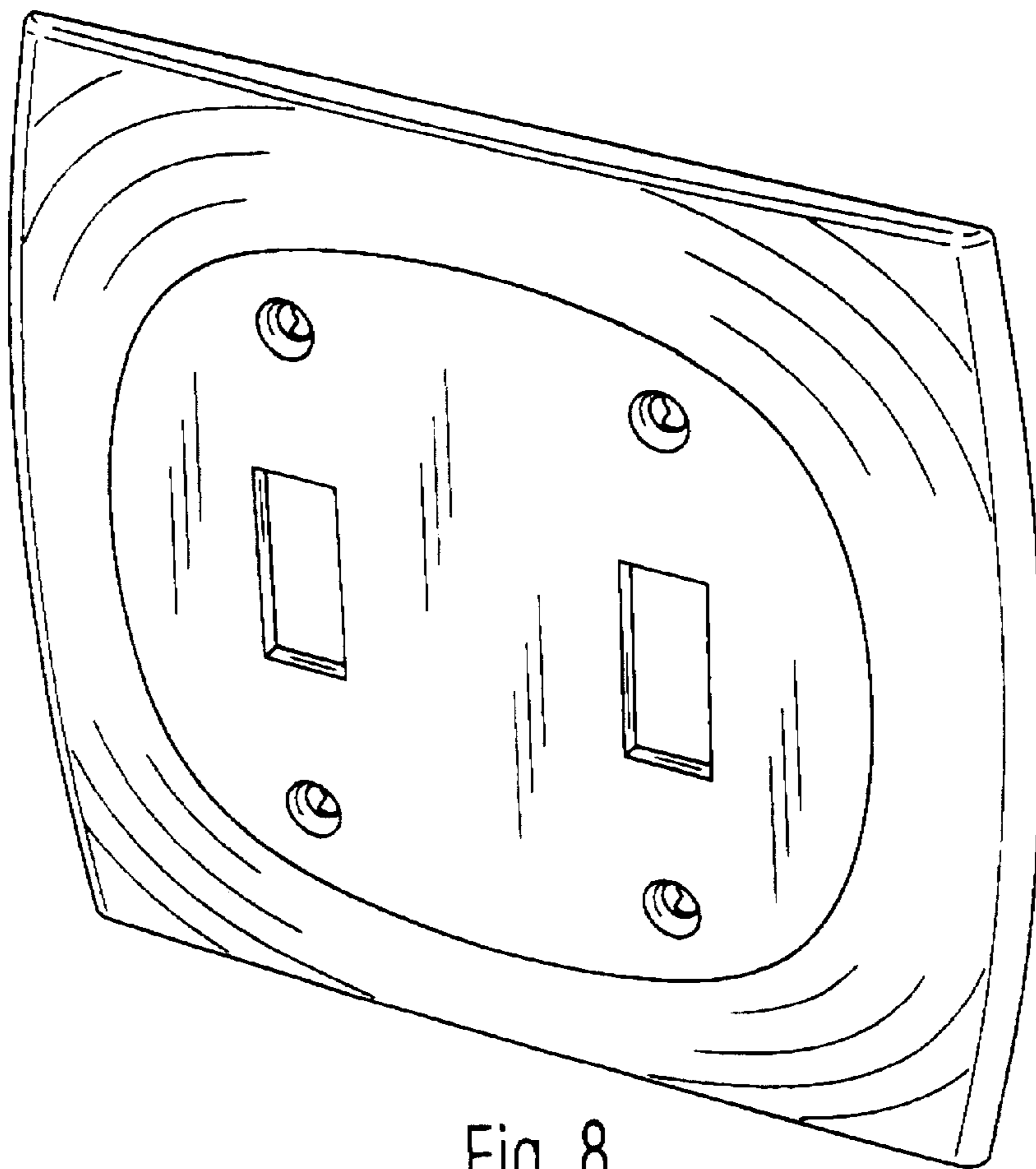

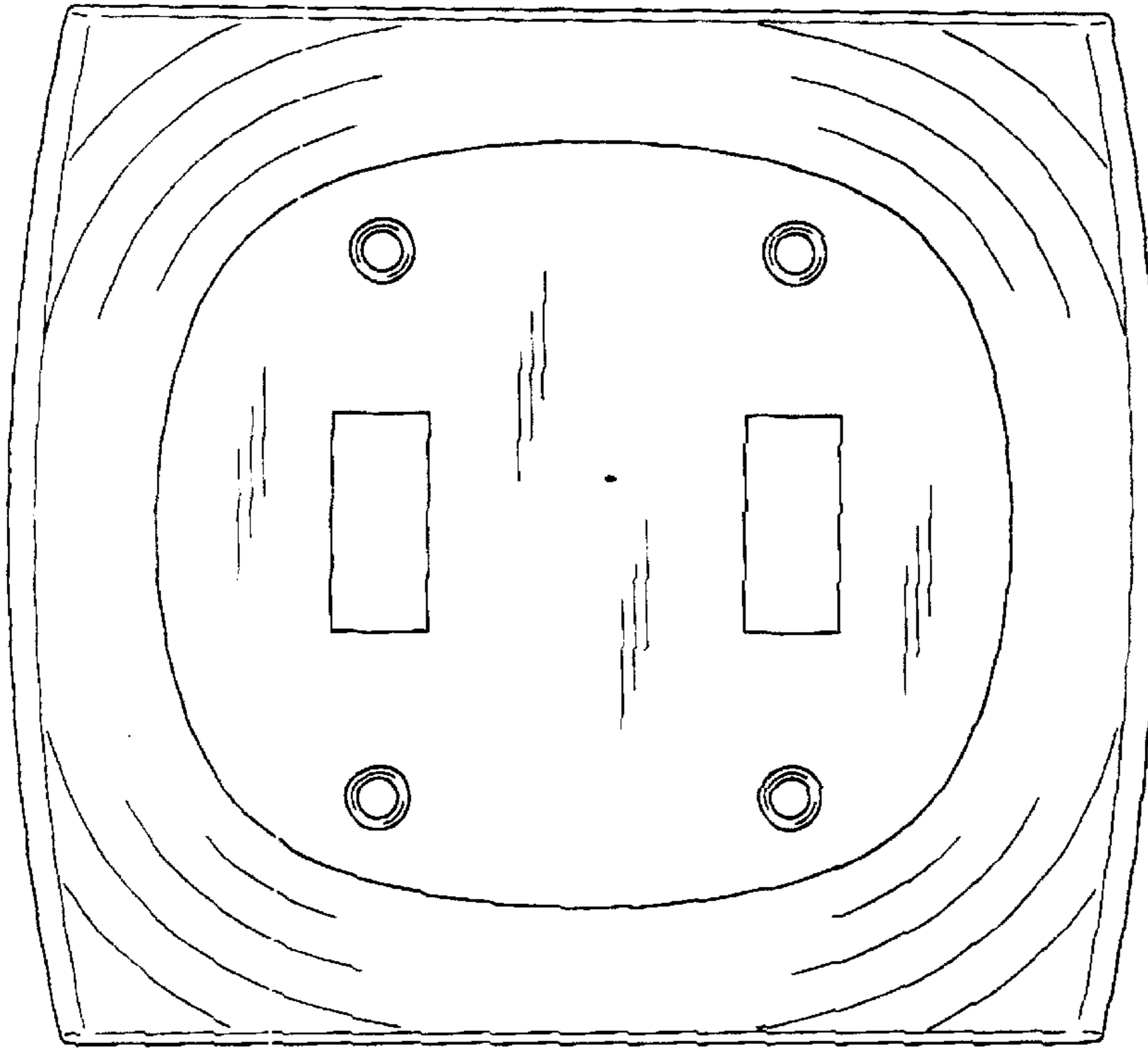

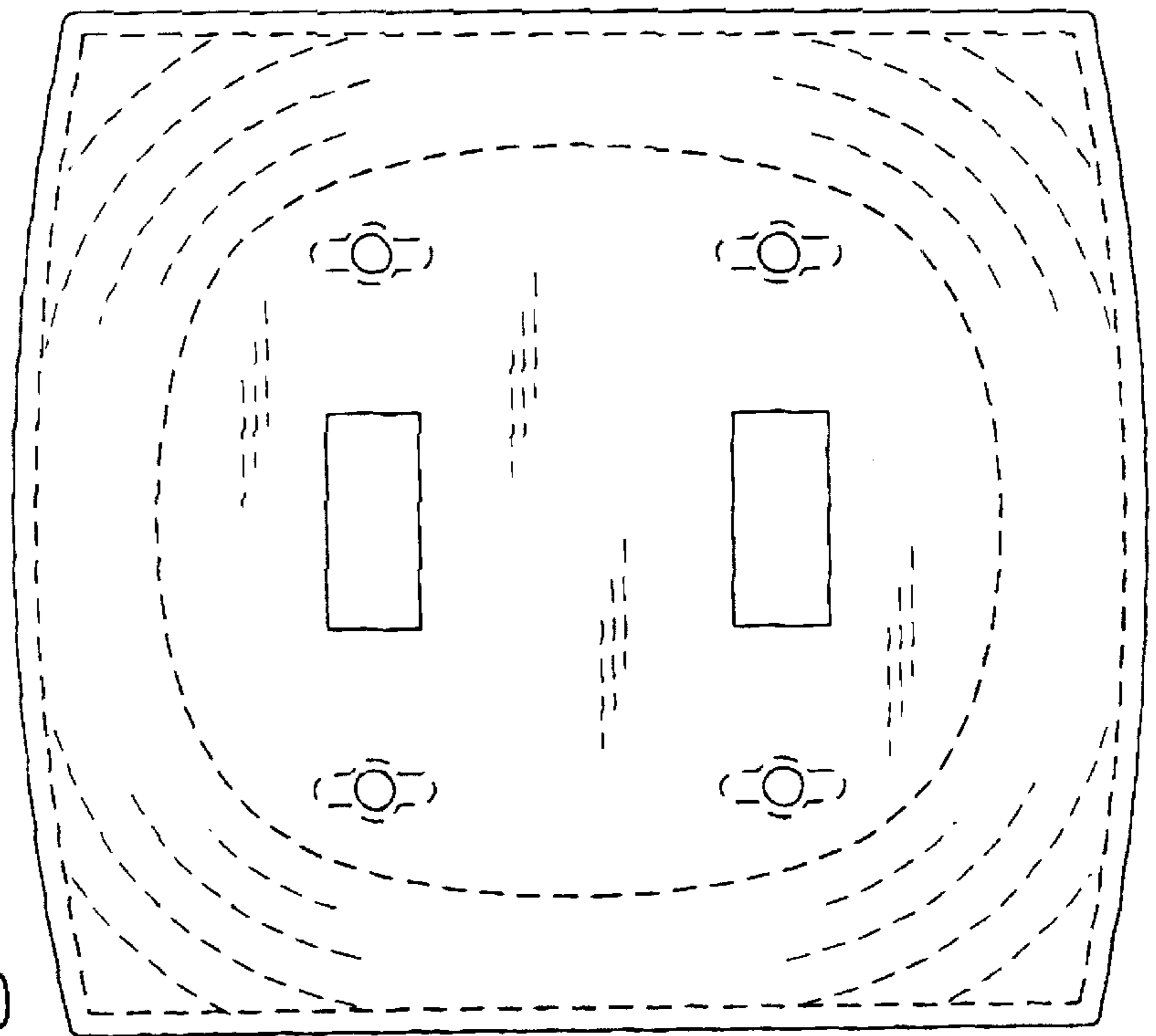

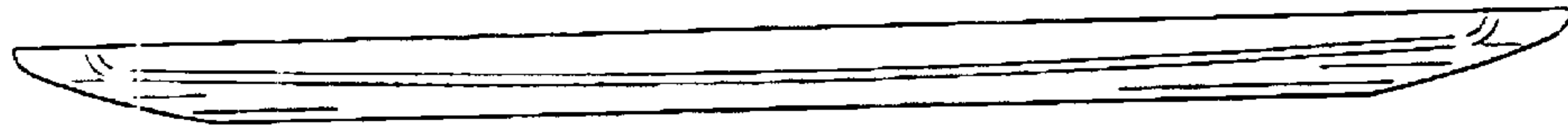

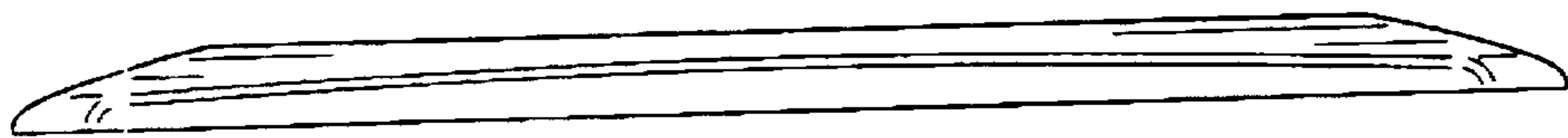

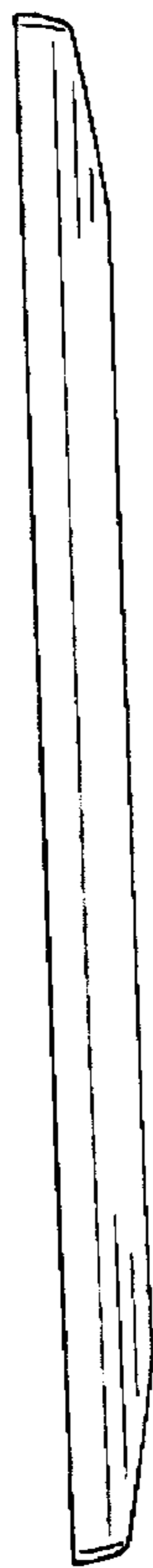

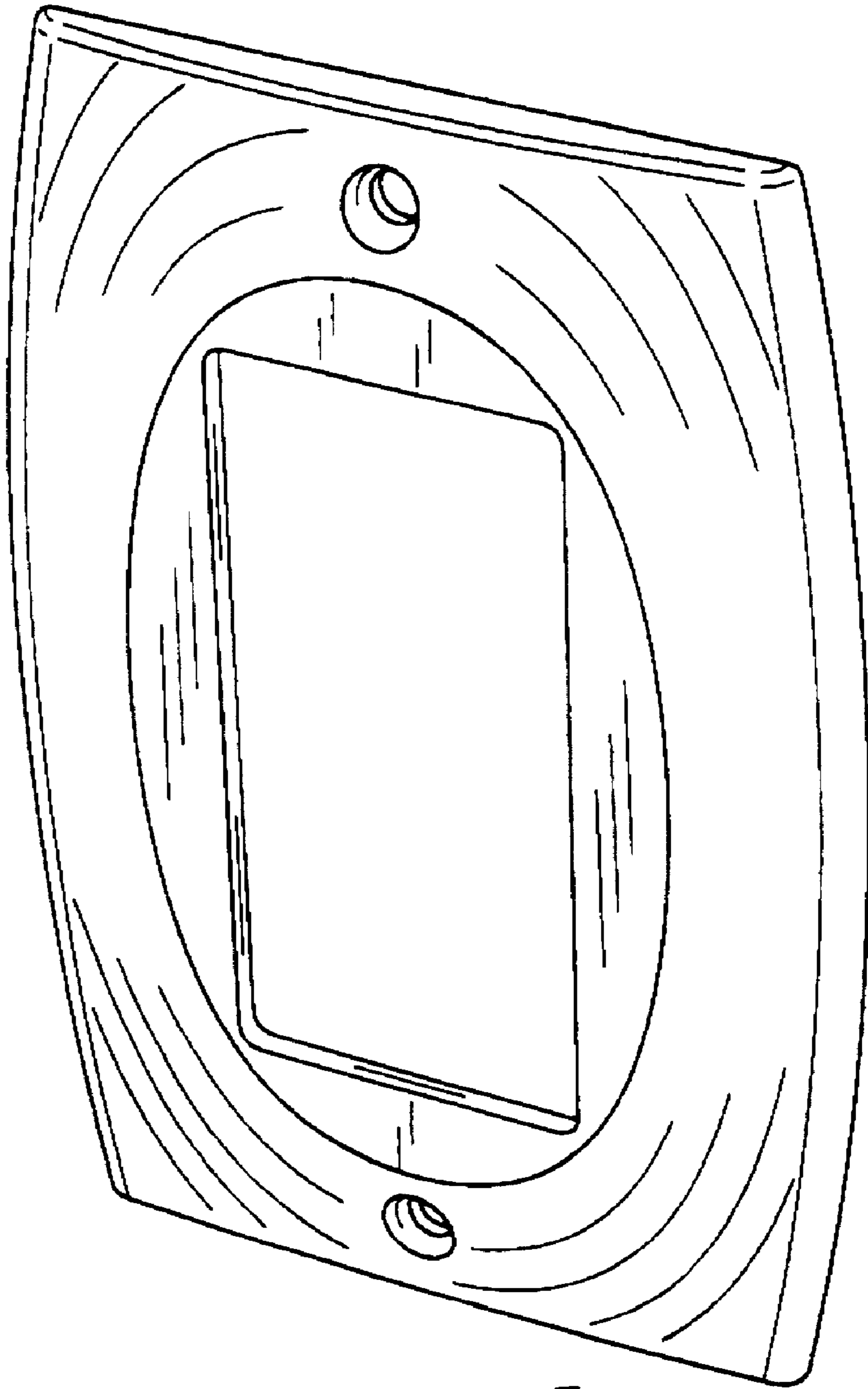

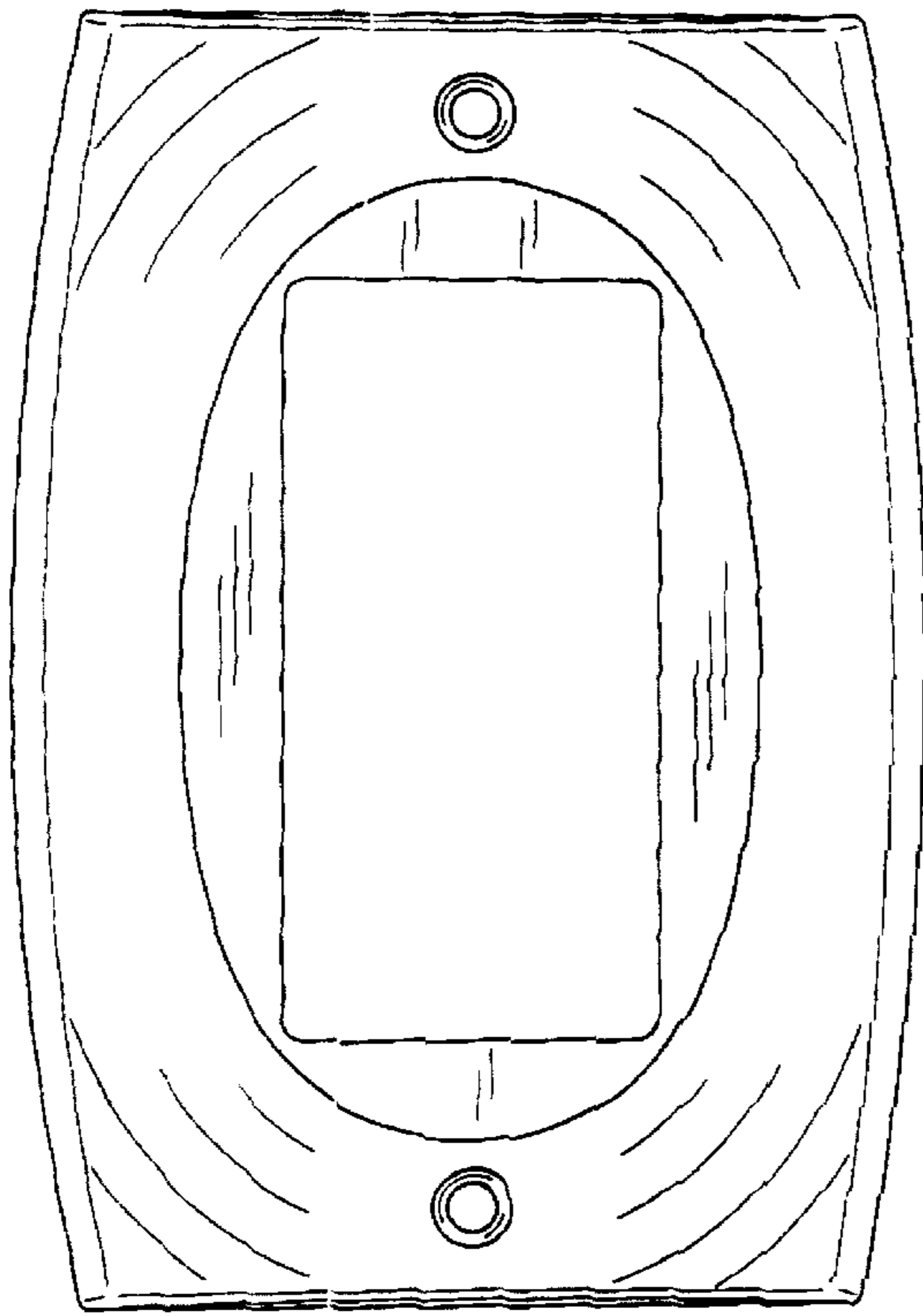

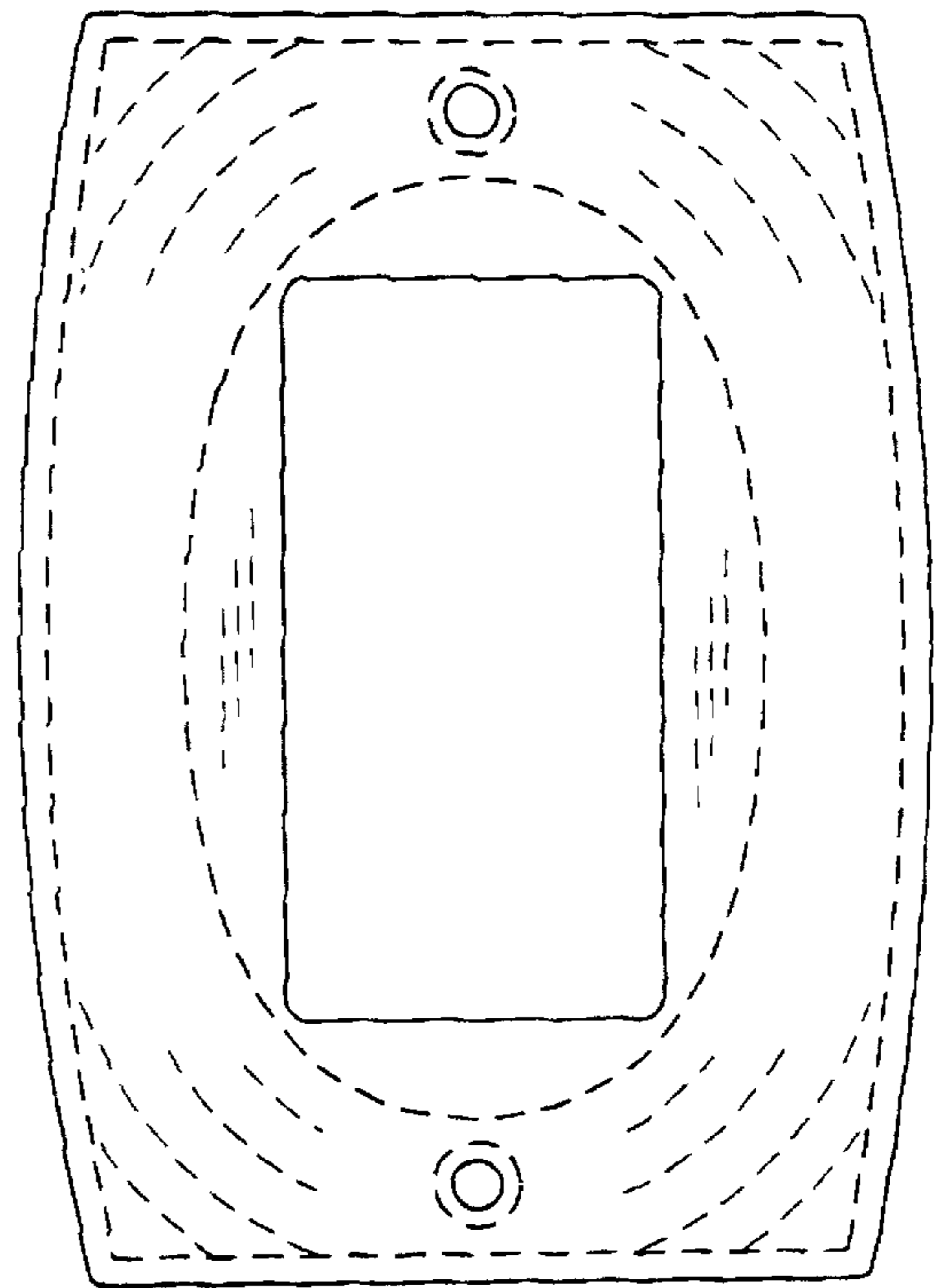

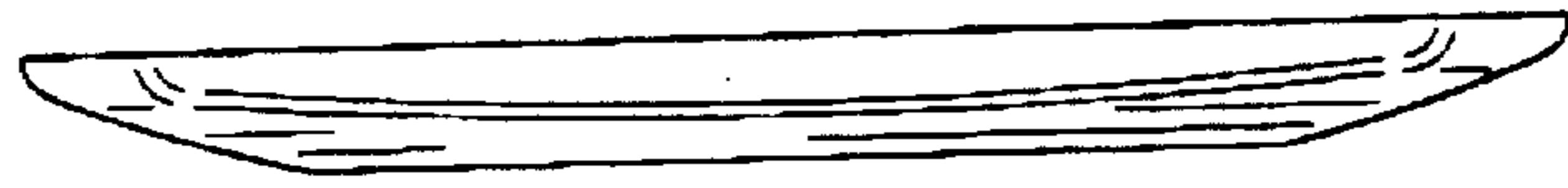

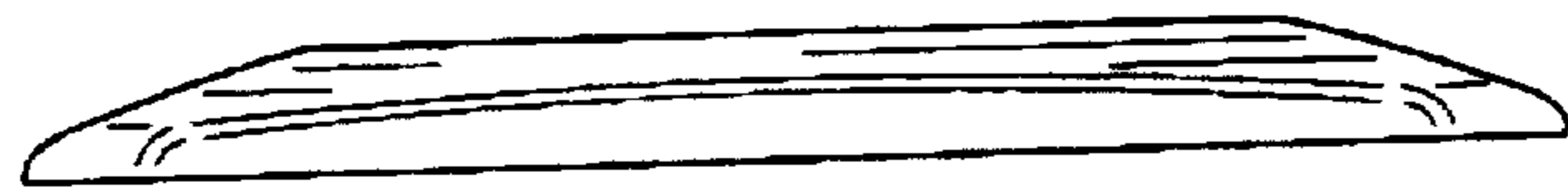

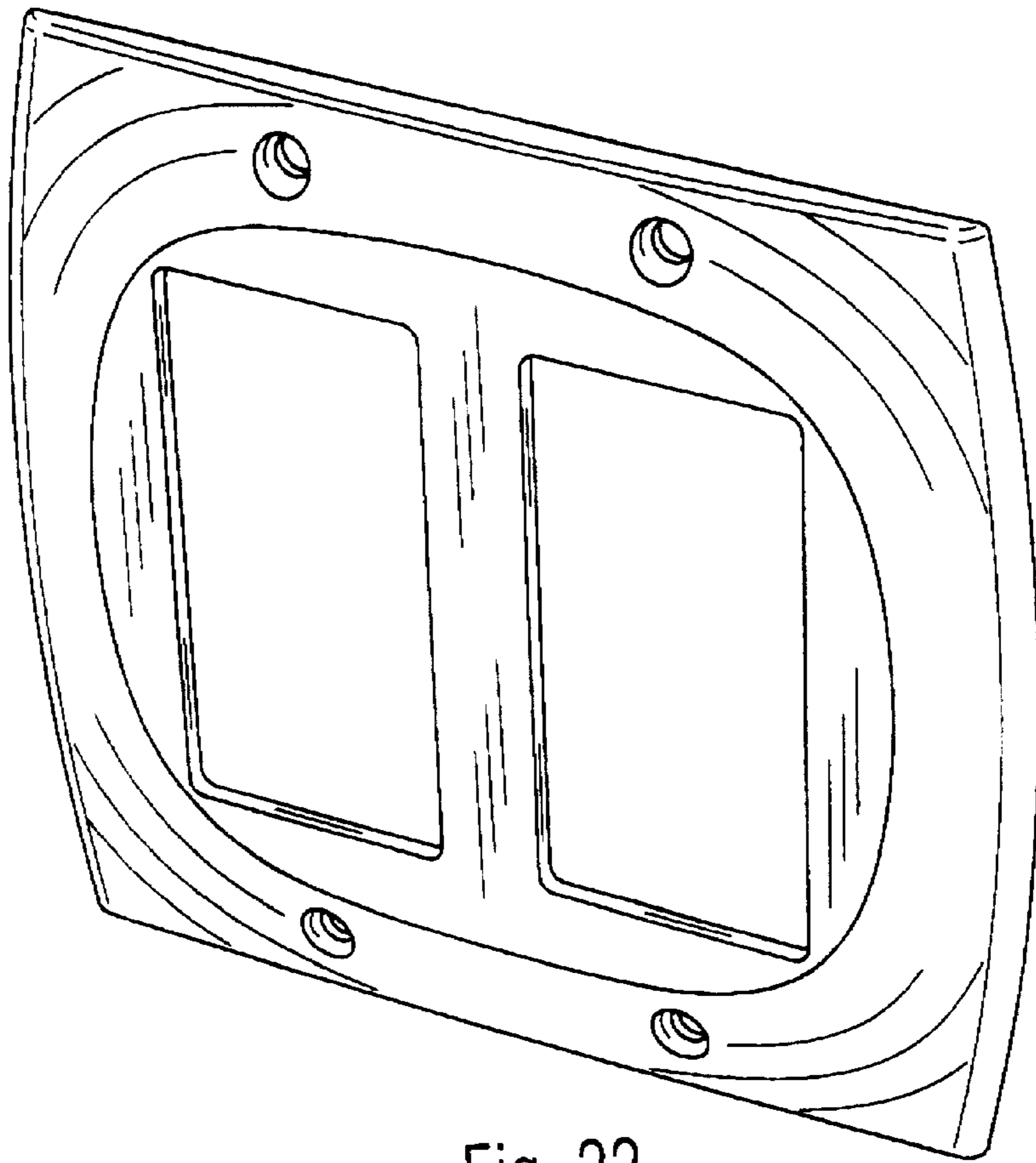

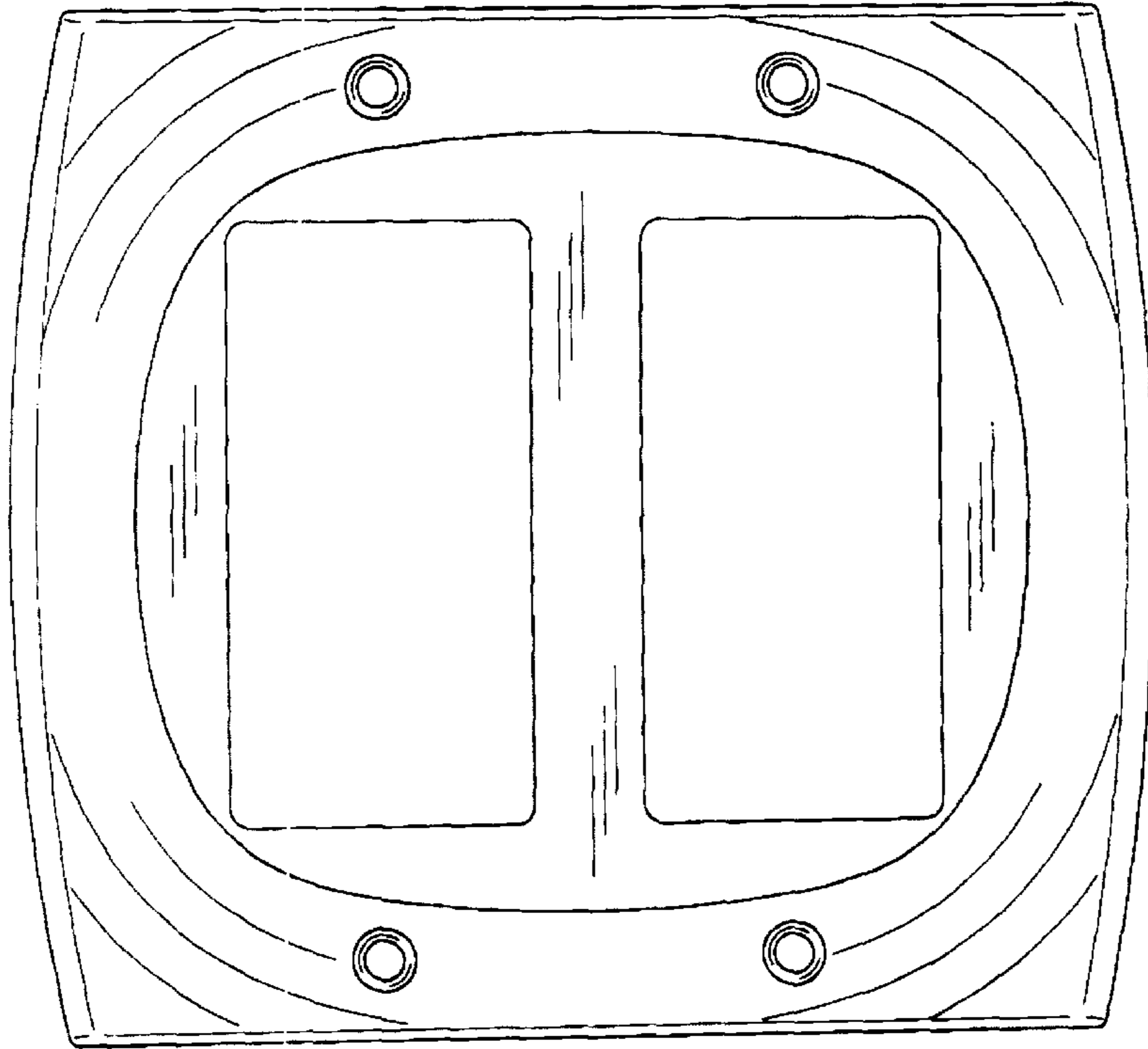

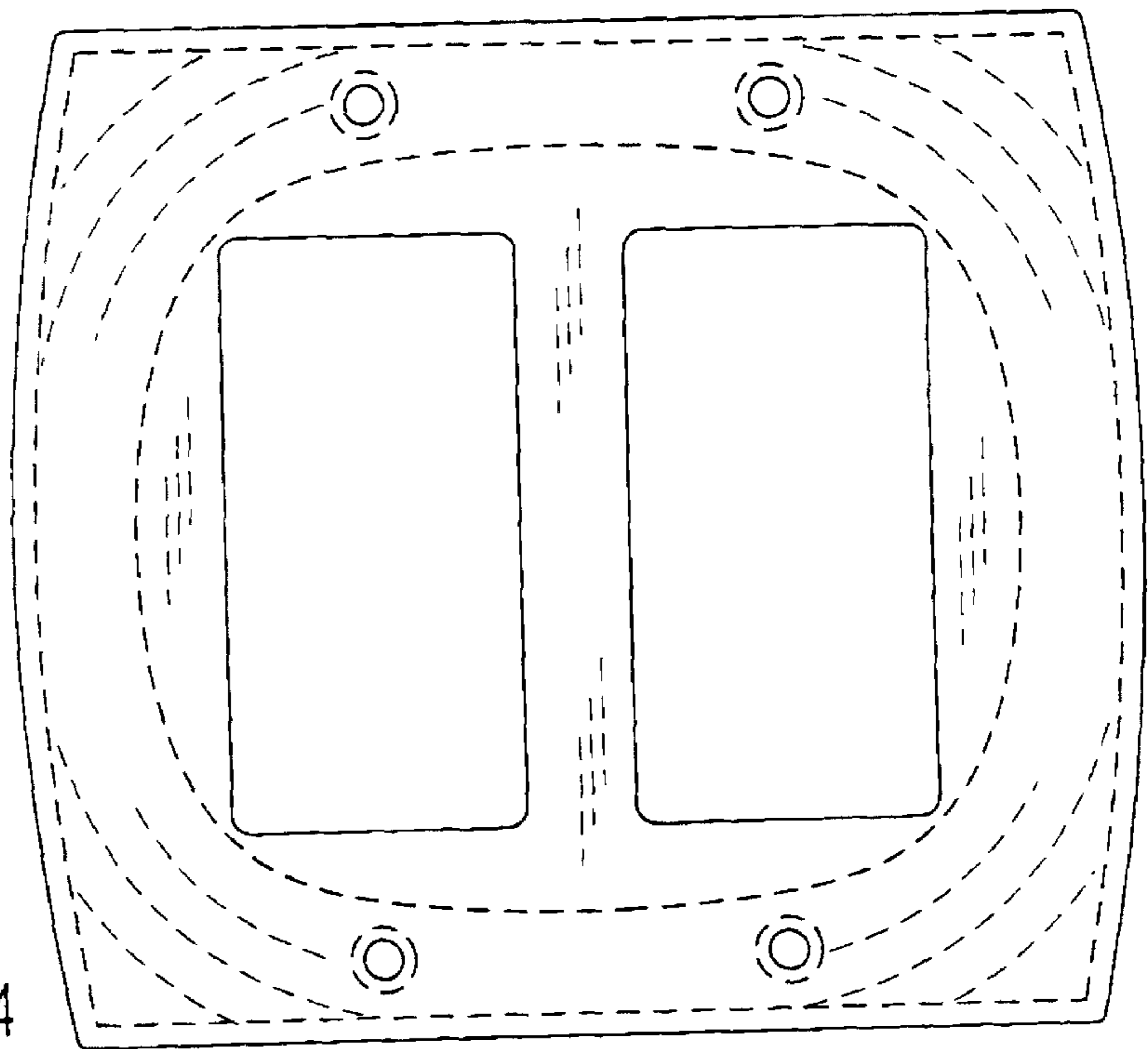

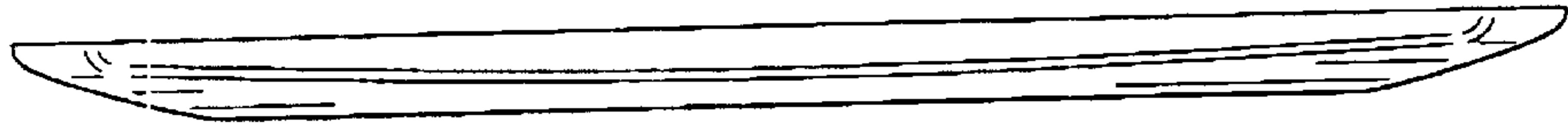

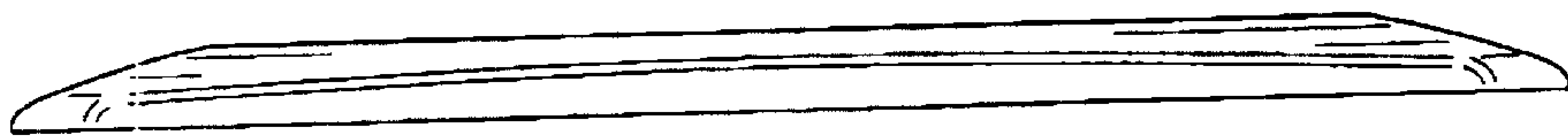

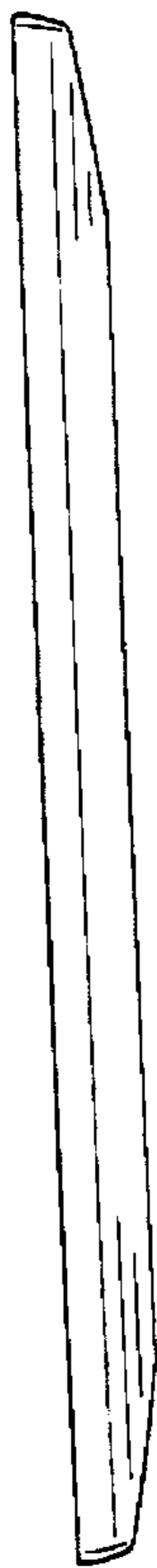

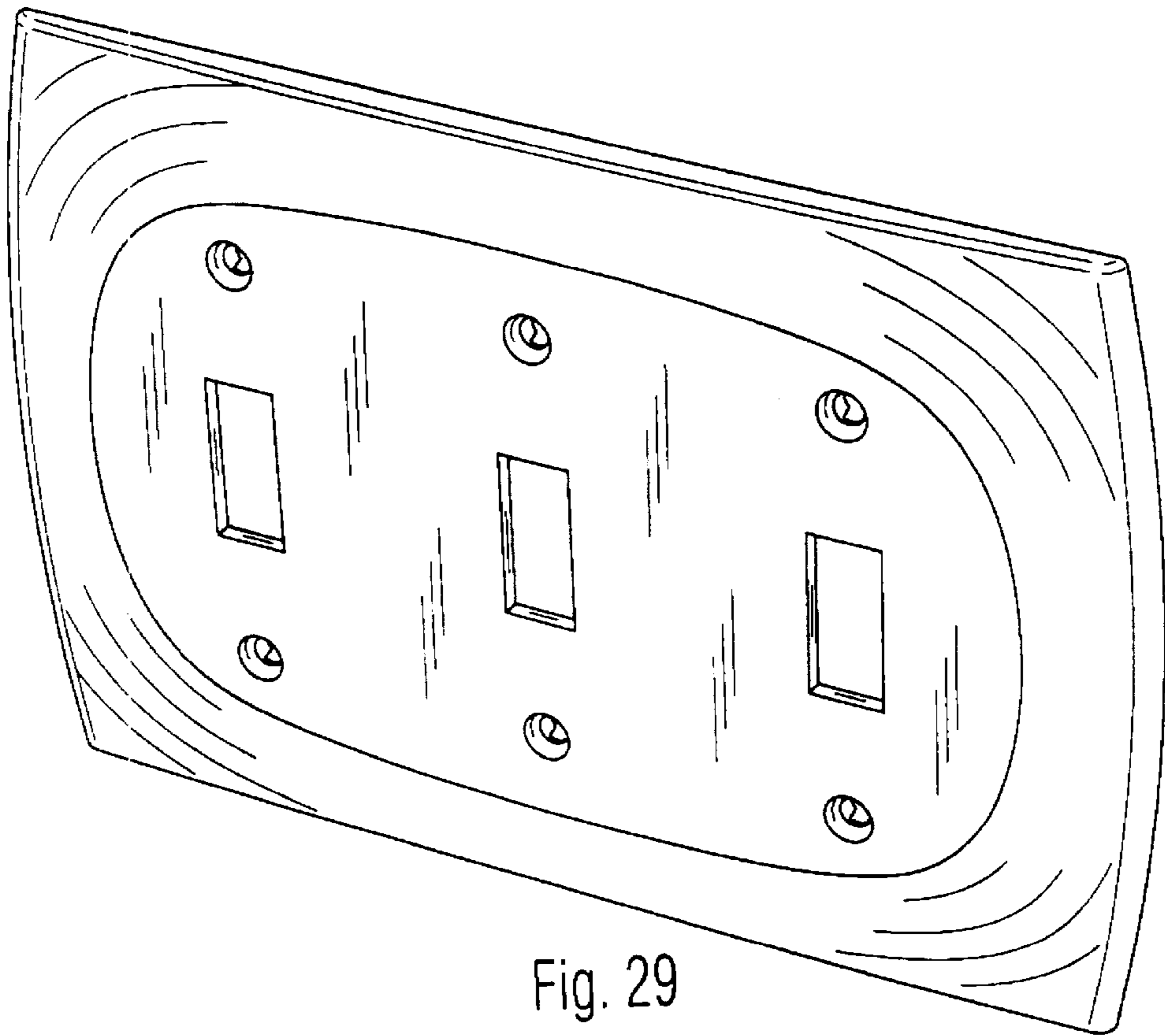

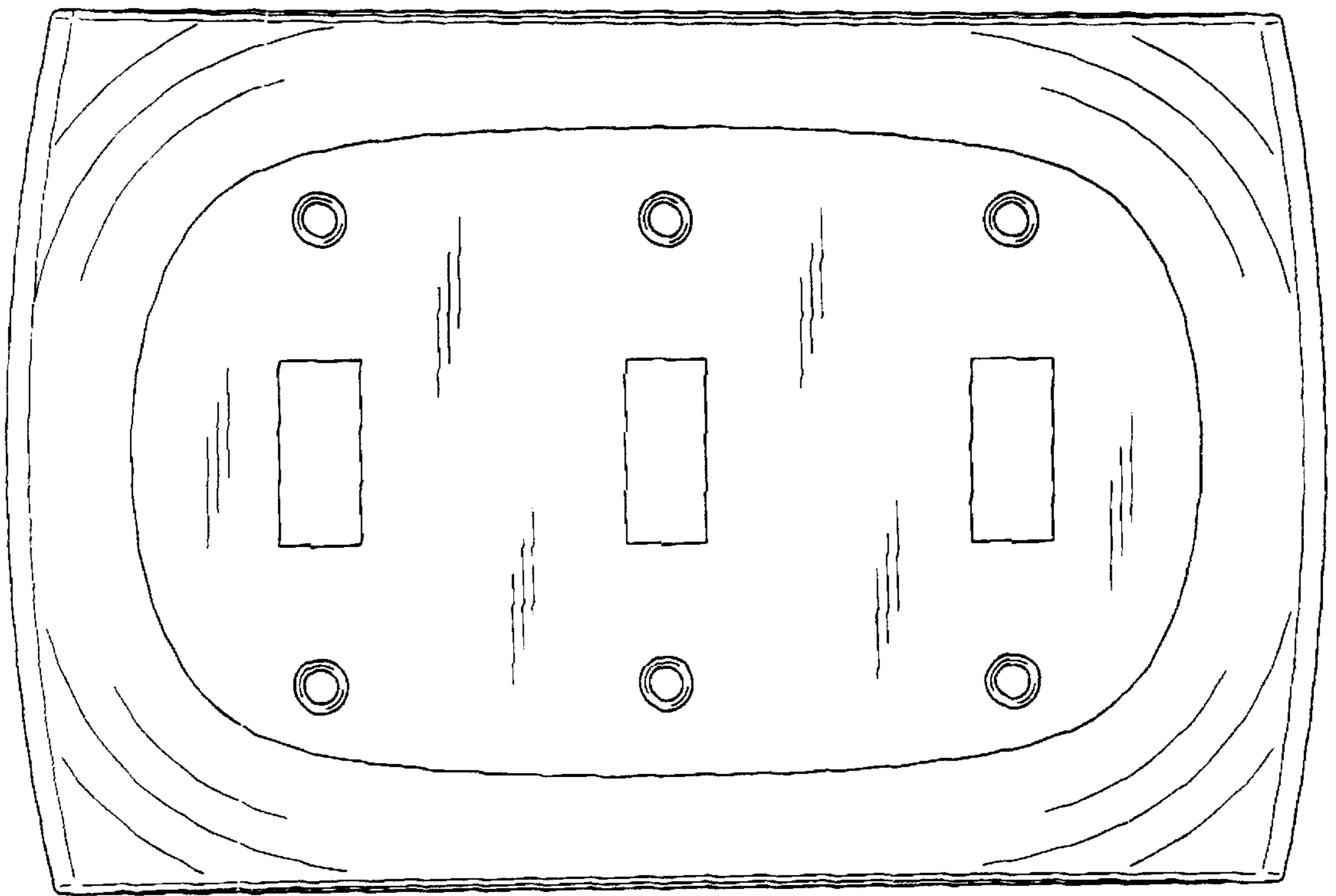

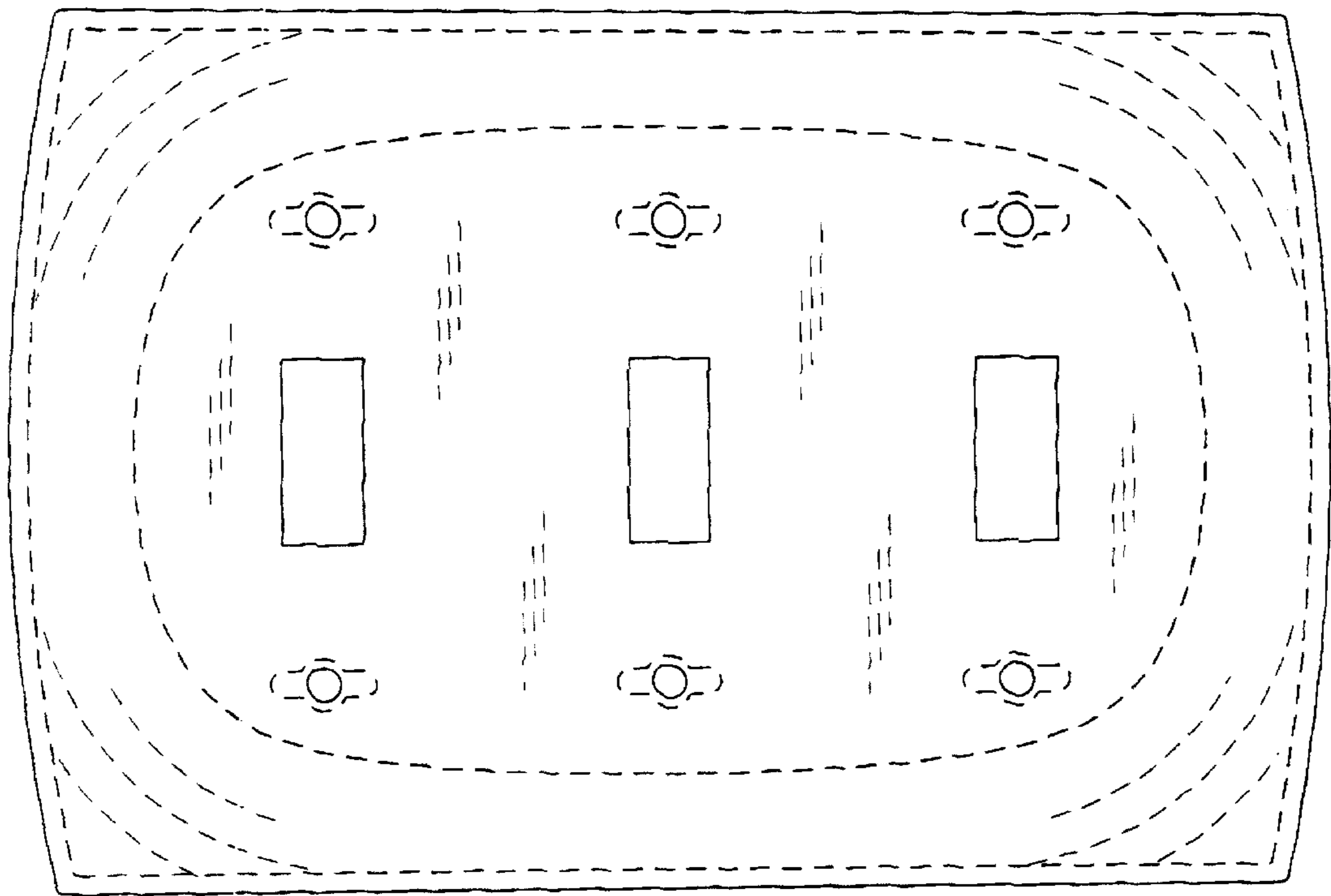

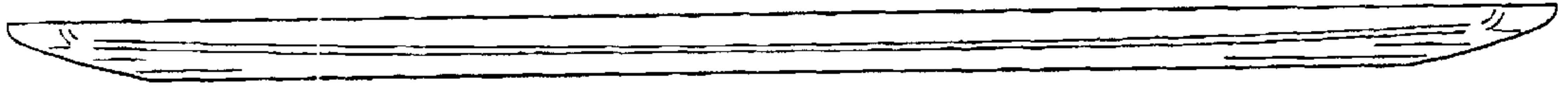

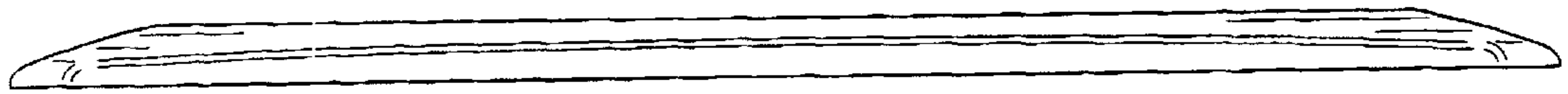

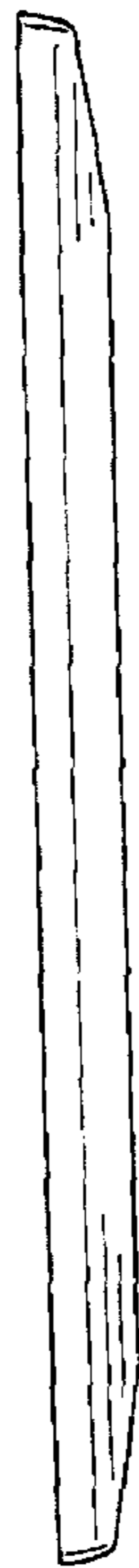

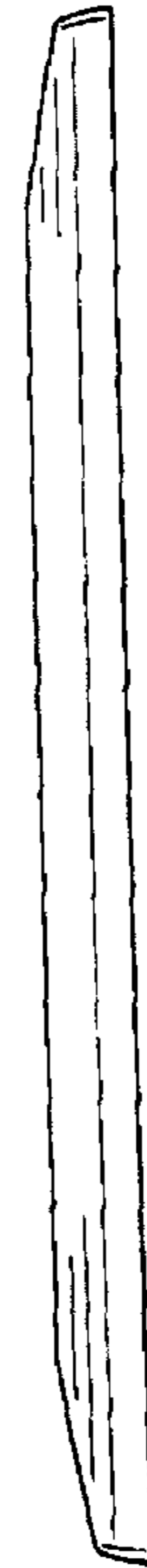

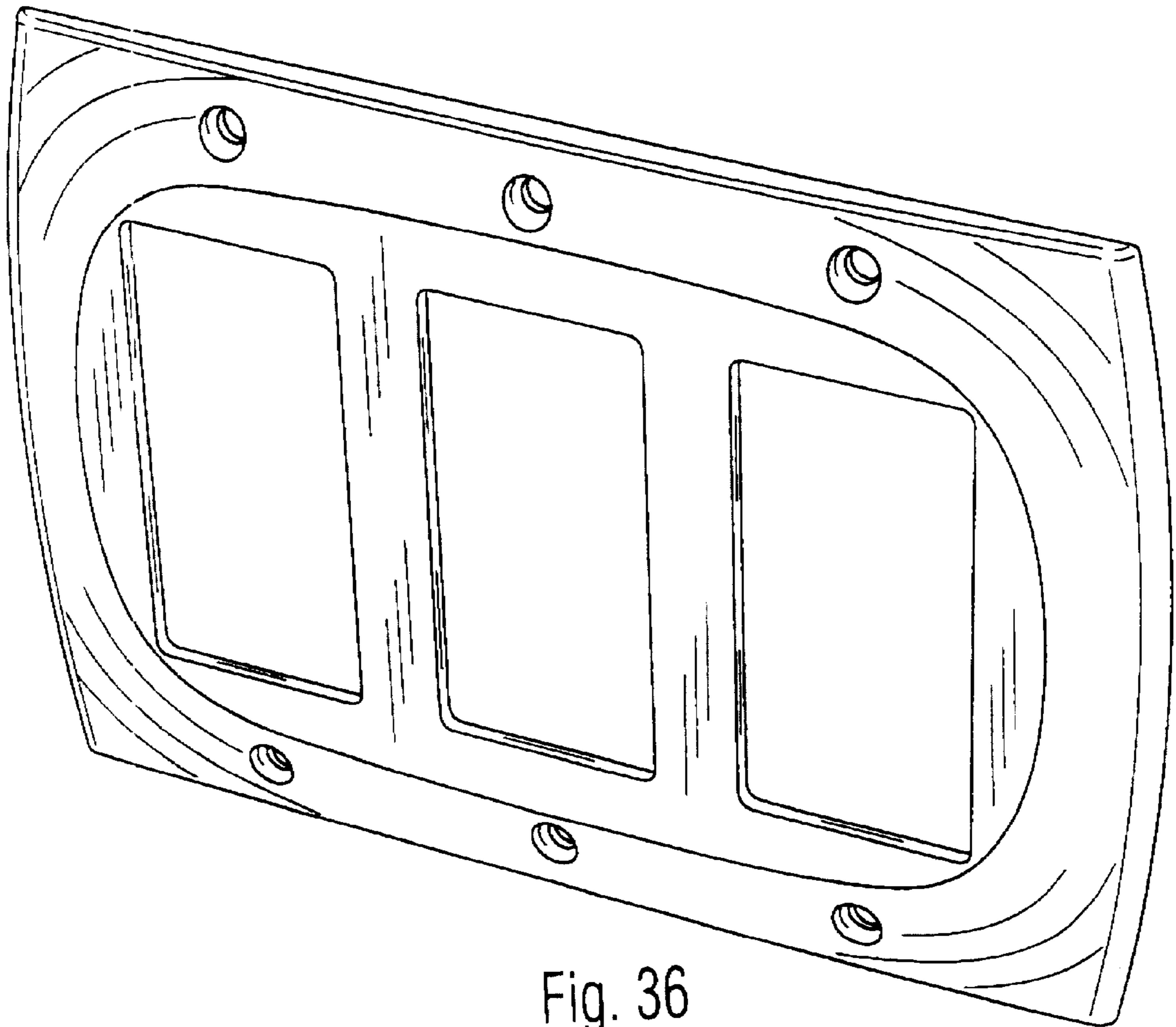

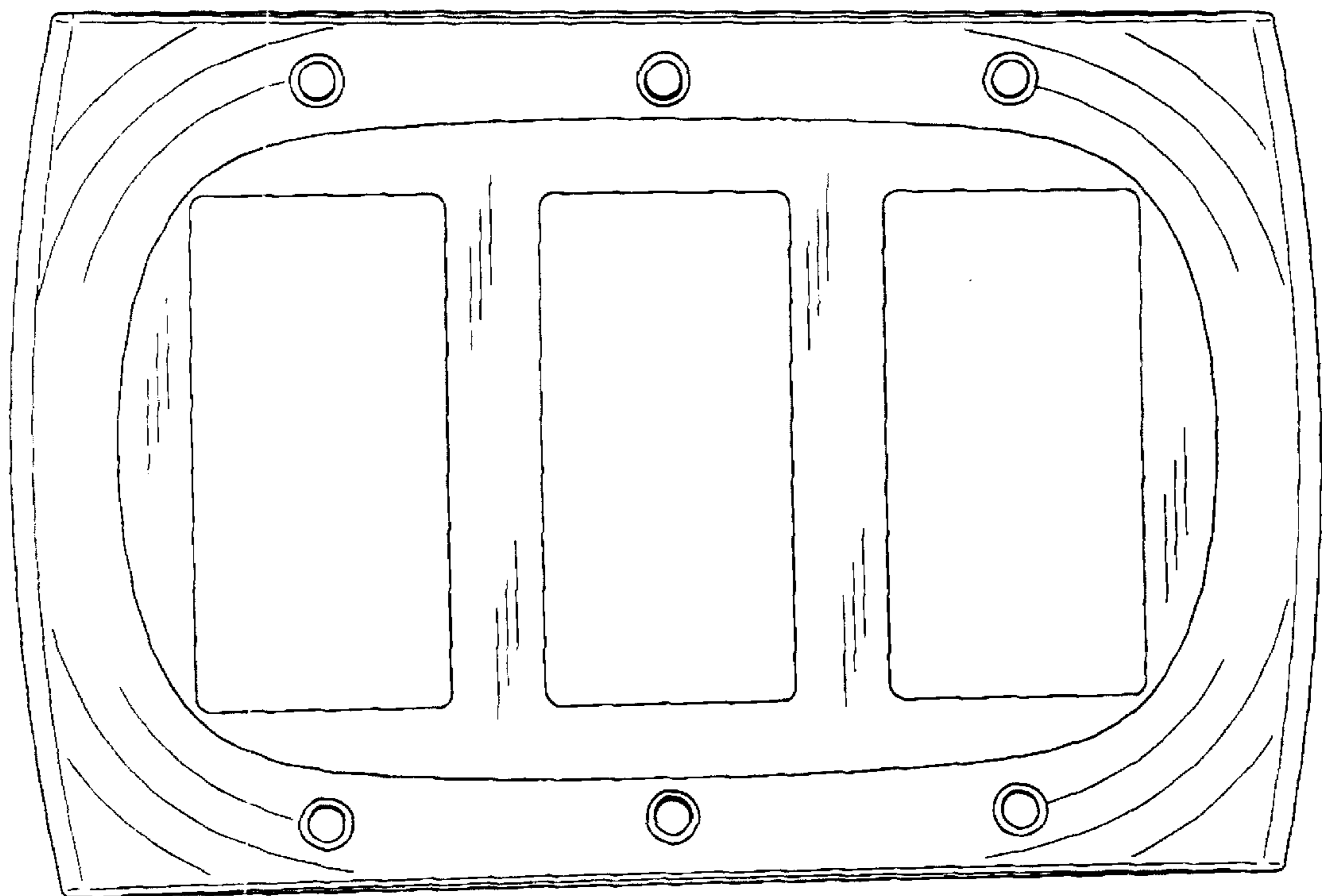

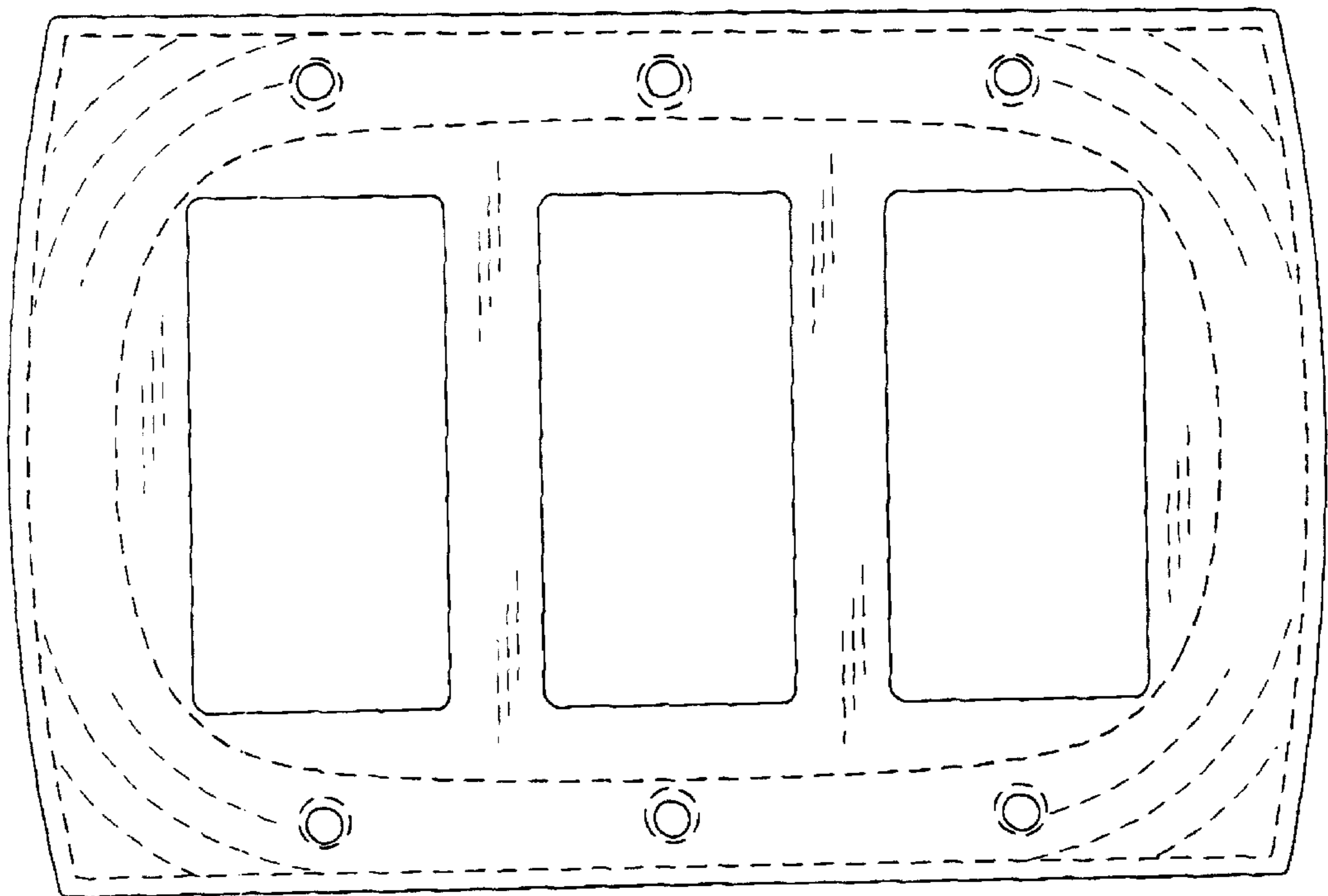

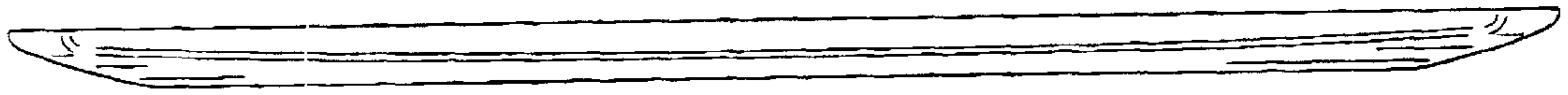

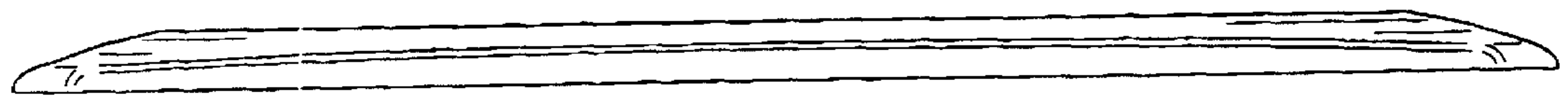

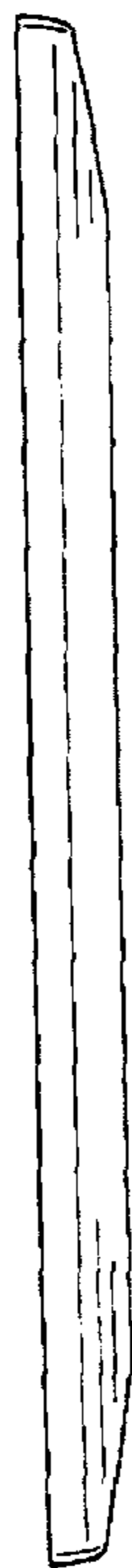

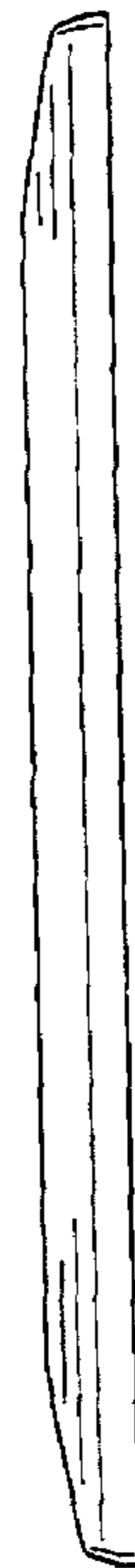
