I claim the ornamental design for a transfer switch, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a transfer switch of the present invention;

FIG. 2 is a front view of the transfer switch of FIG. 1;

FIG. 3 is a rear view of the transfer switch of FIG. 1;

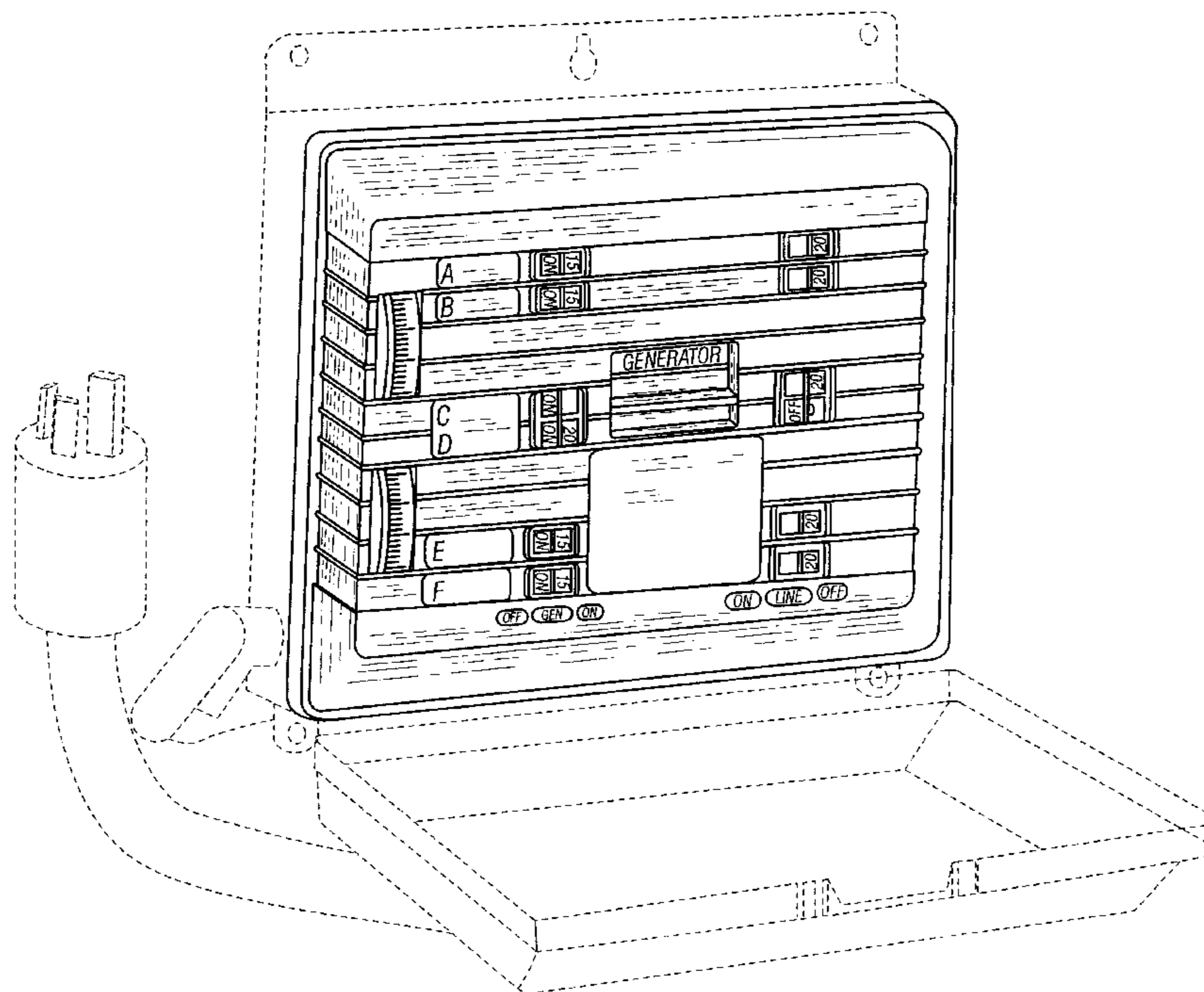
FIG. 4 is a top view of the transfer switch of FIG. 1, the bottom view being a substantial mirror image thereof;

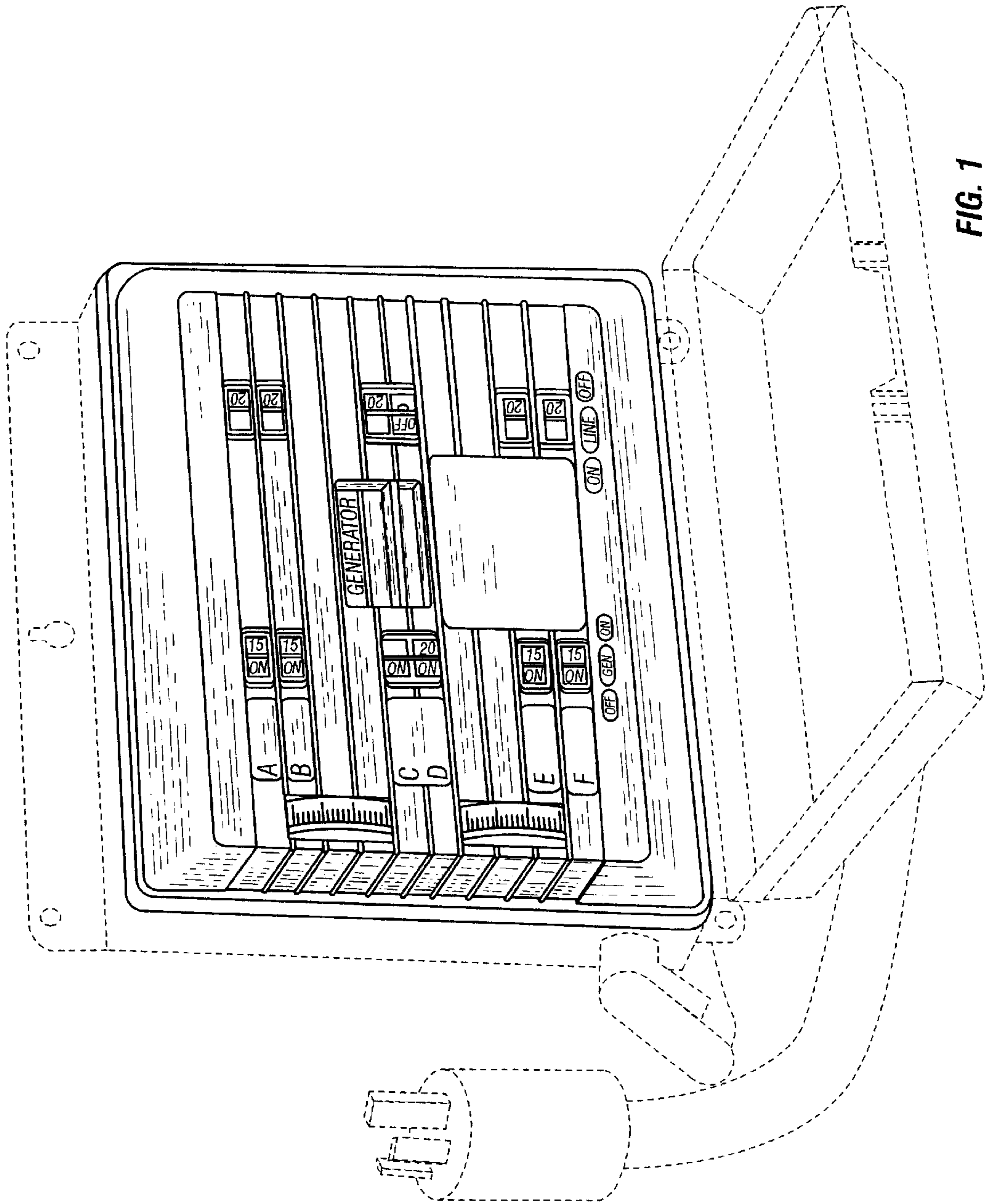
FIG. 5 is a right side view of the transfer switch of FIG. 1; and,

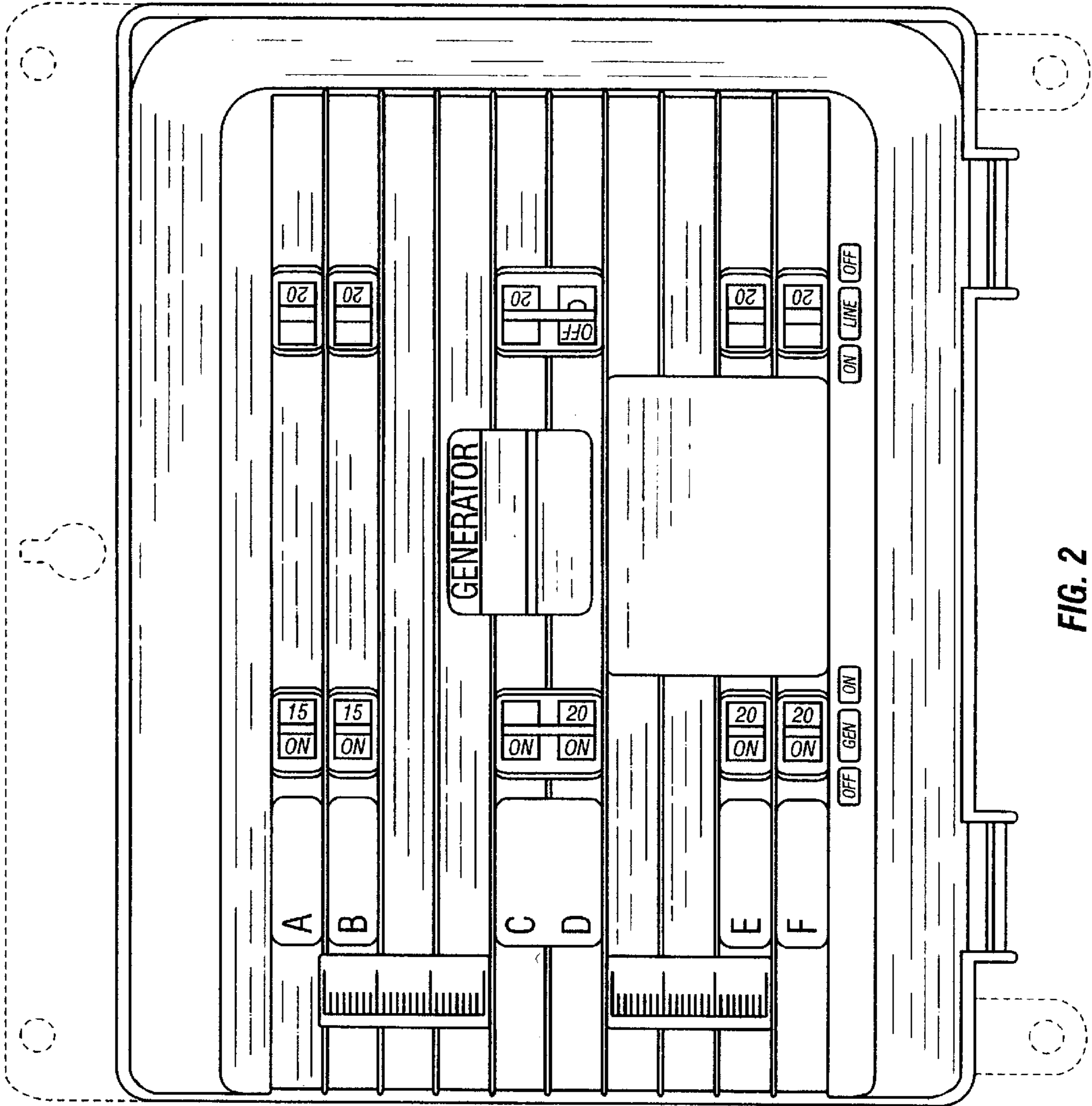

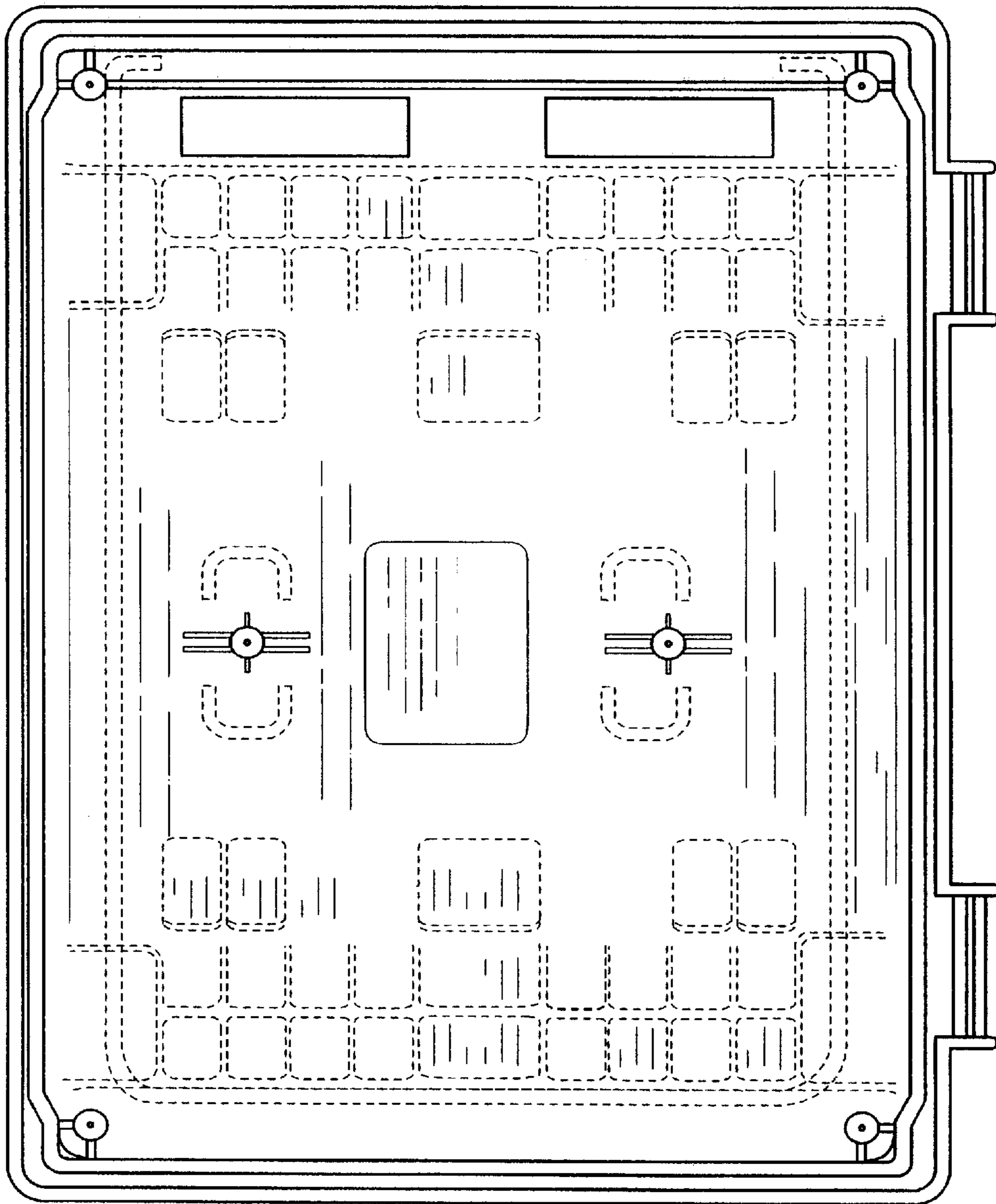

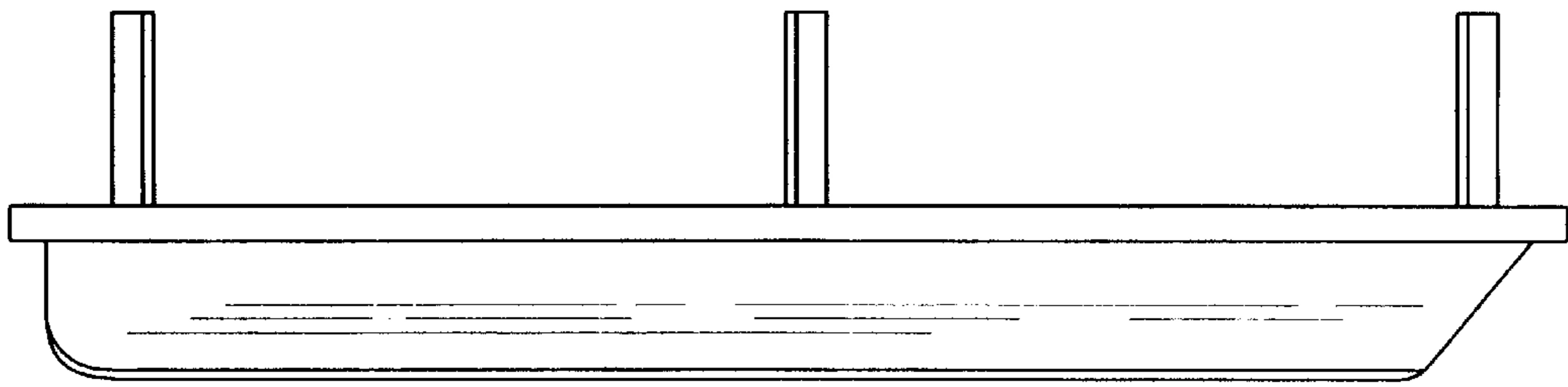

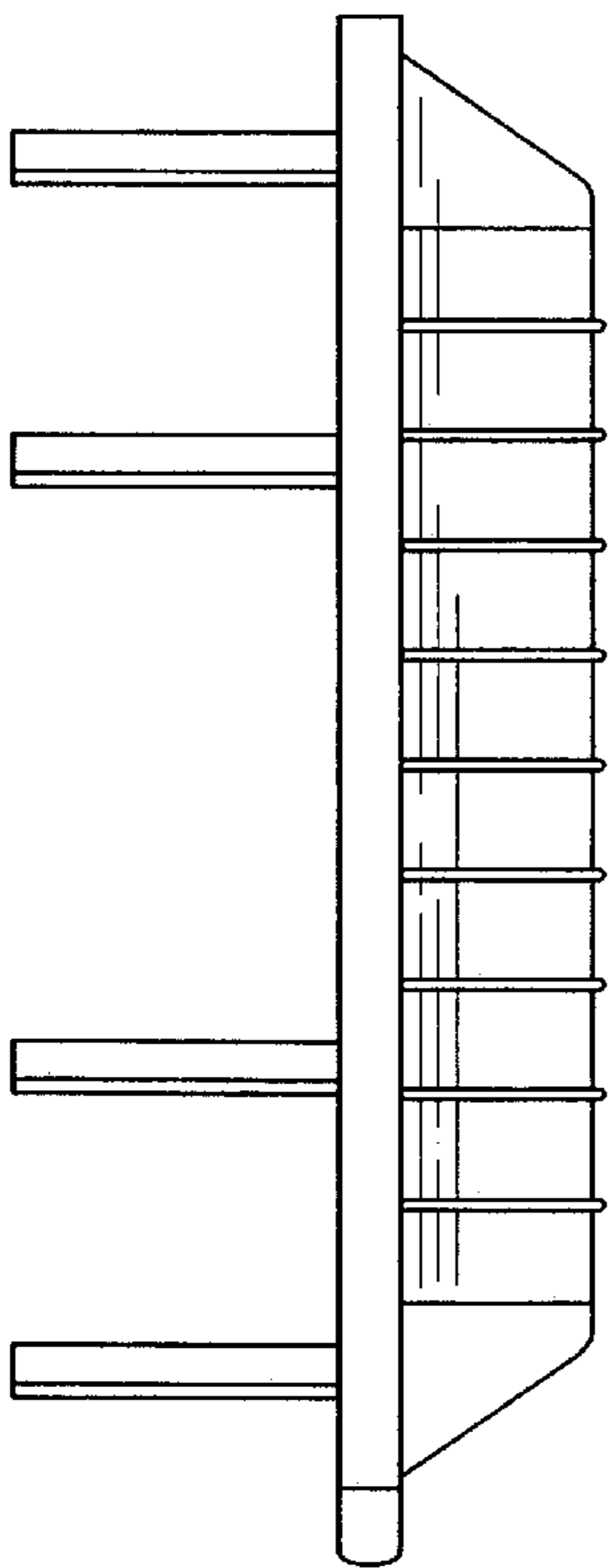

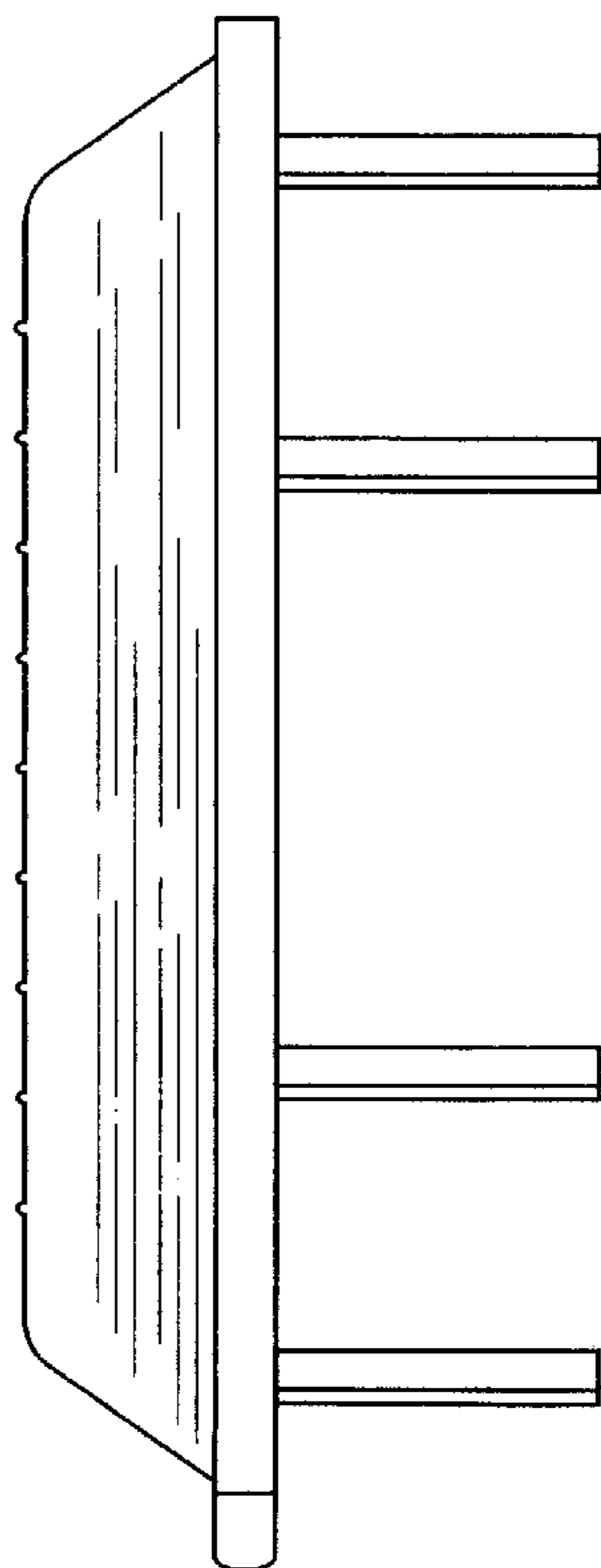
