FIG. 3 is a perspective view according to the second aspect of the invention;

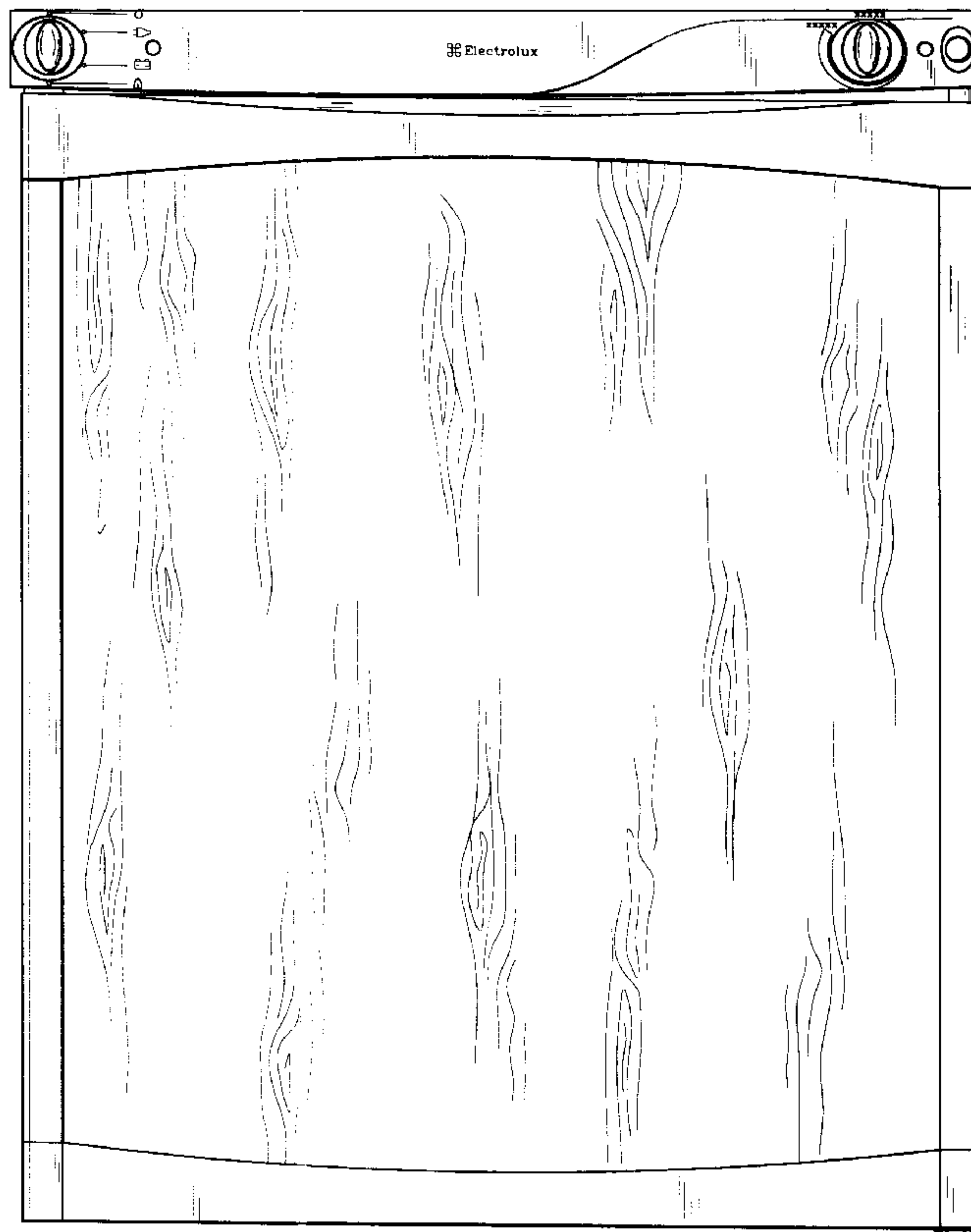
FIG. 4 is a perspective view according to a third aspect of the invention;

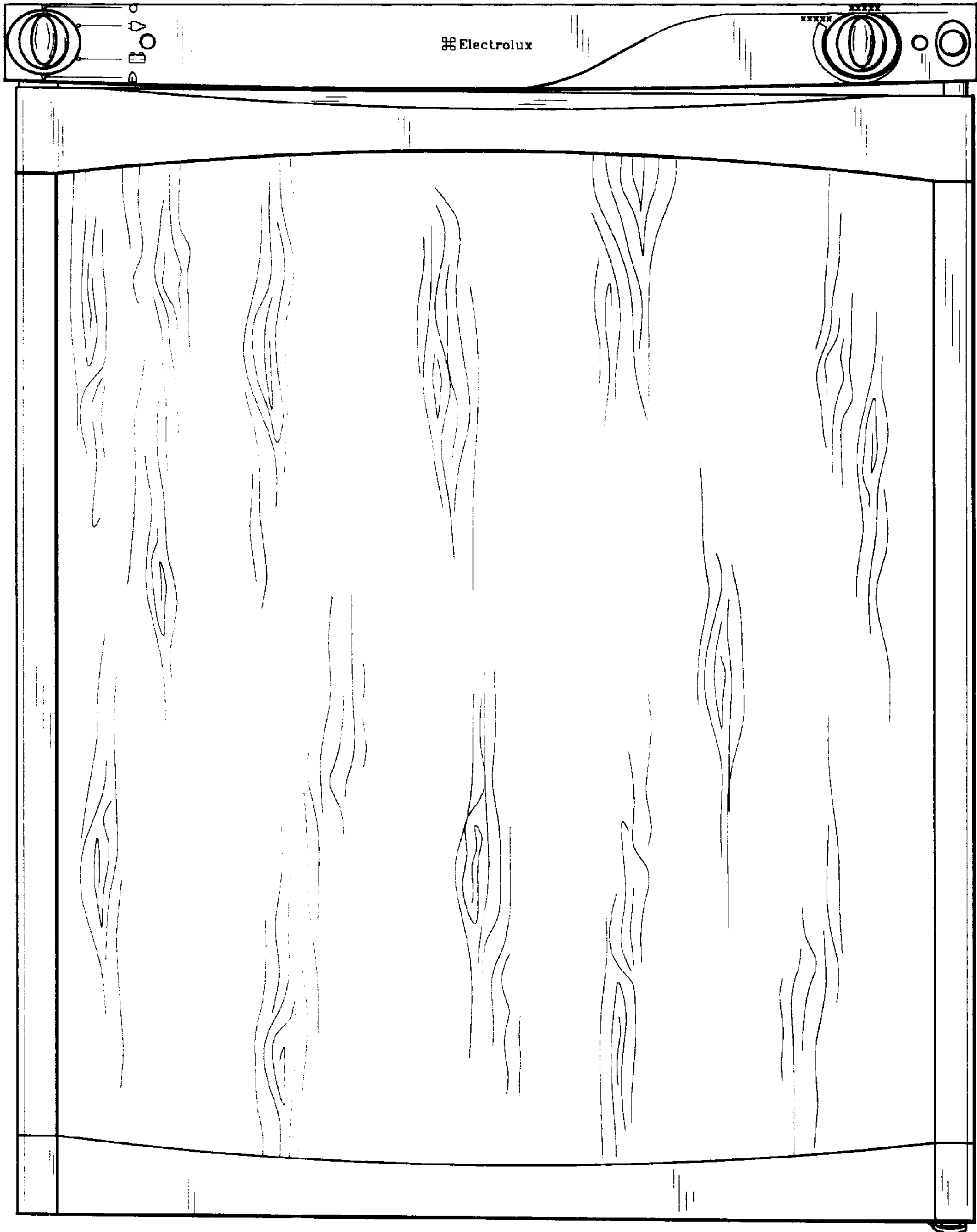

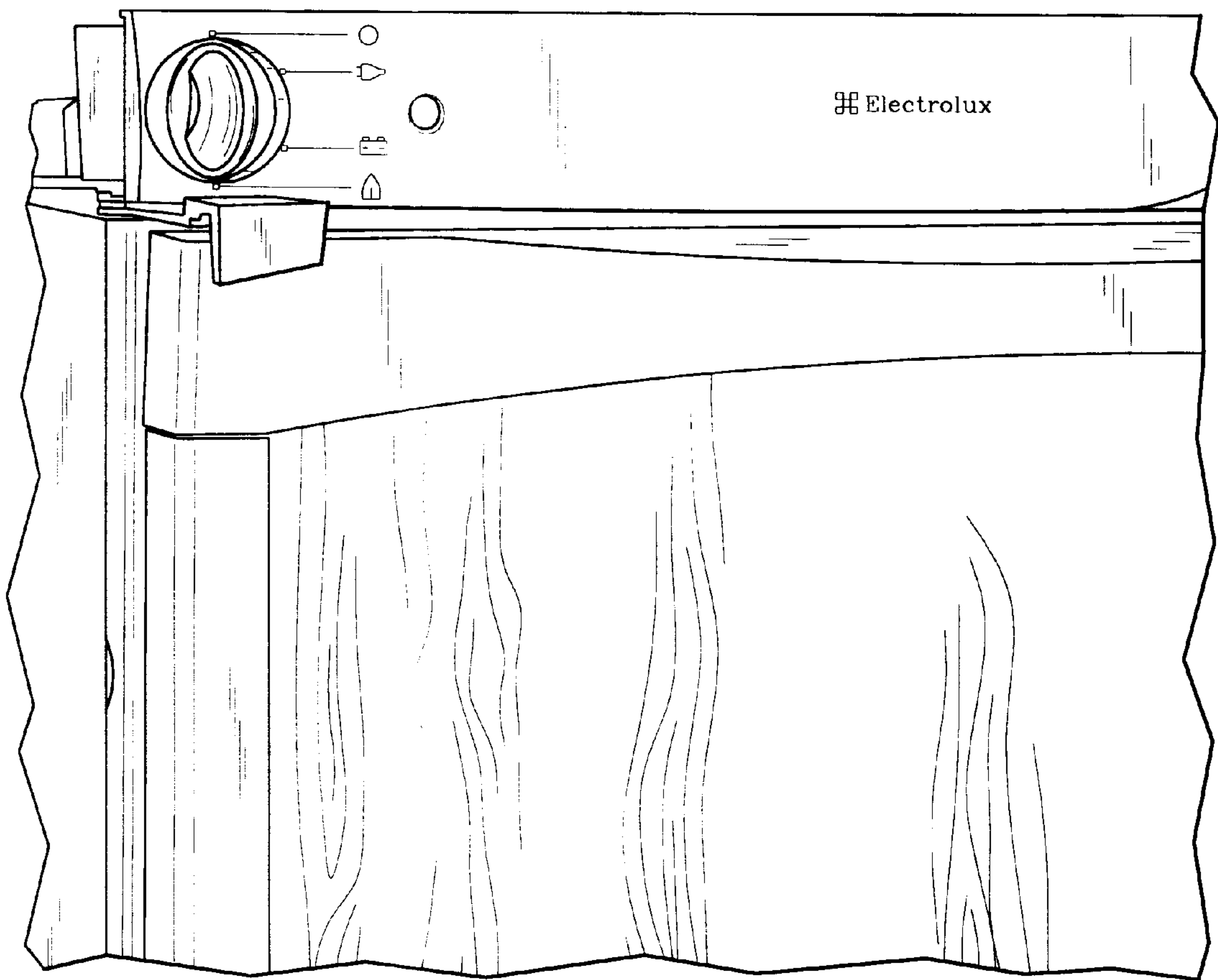

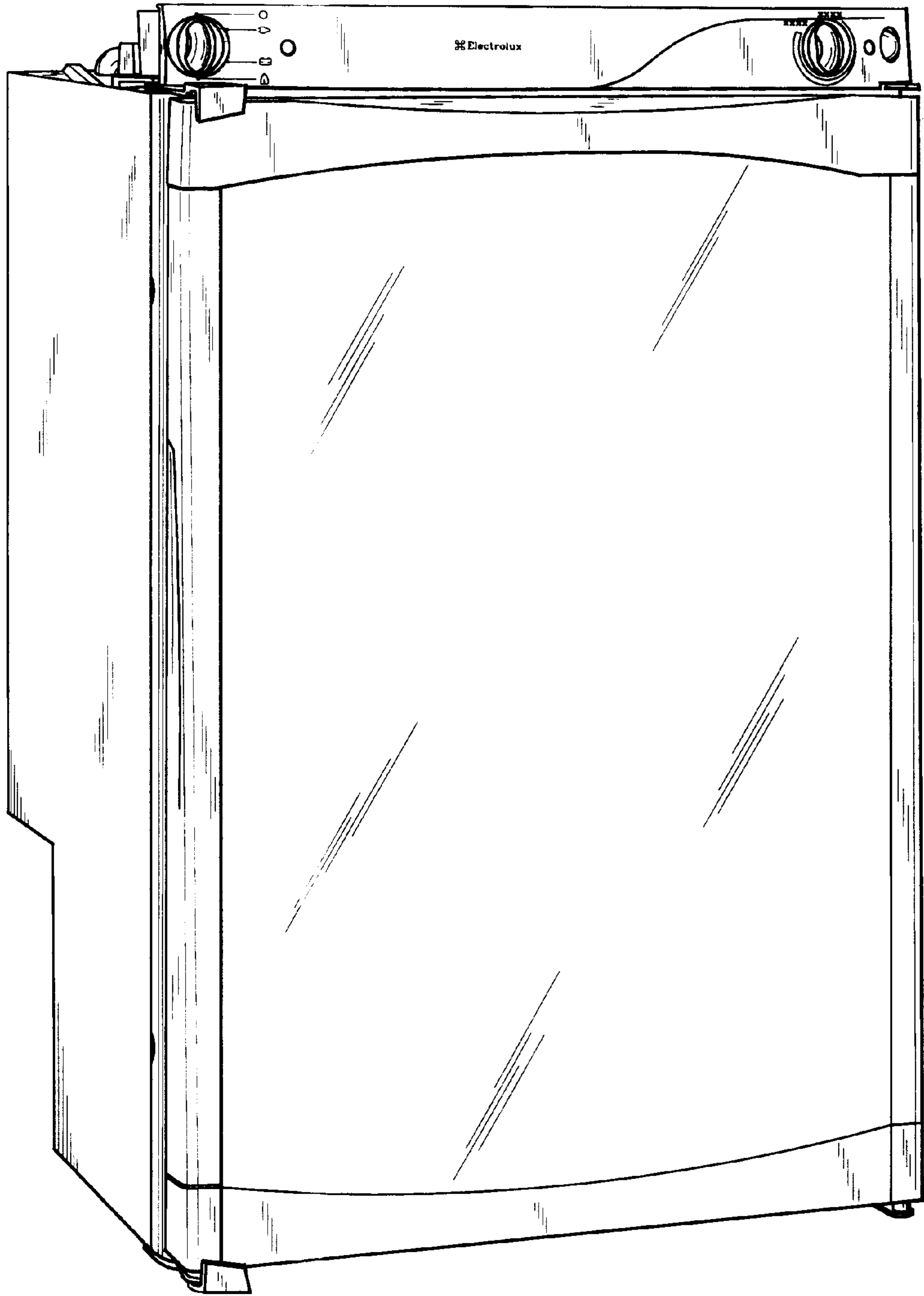
