(57) **CLAIM**

The ornamental design for a horizontal ornamental hand sign with “_____’s on T.V.”, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of one embodiment of a horizontal ornamental hand sign with “_____’s on T.V.” demonstrating its basic form.

FIG. 2 is a frontal view of the embodiment depicted in FIG. 1.

FIG. 3 is a bottom view of the embodiment depicted in FIG. 1.

FIG. 4 is a rear view of the embodiment depicted in FIG. 1.

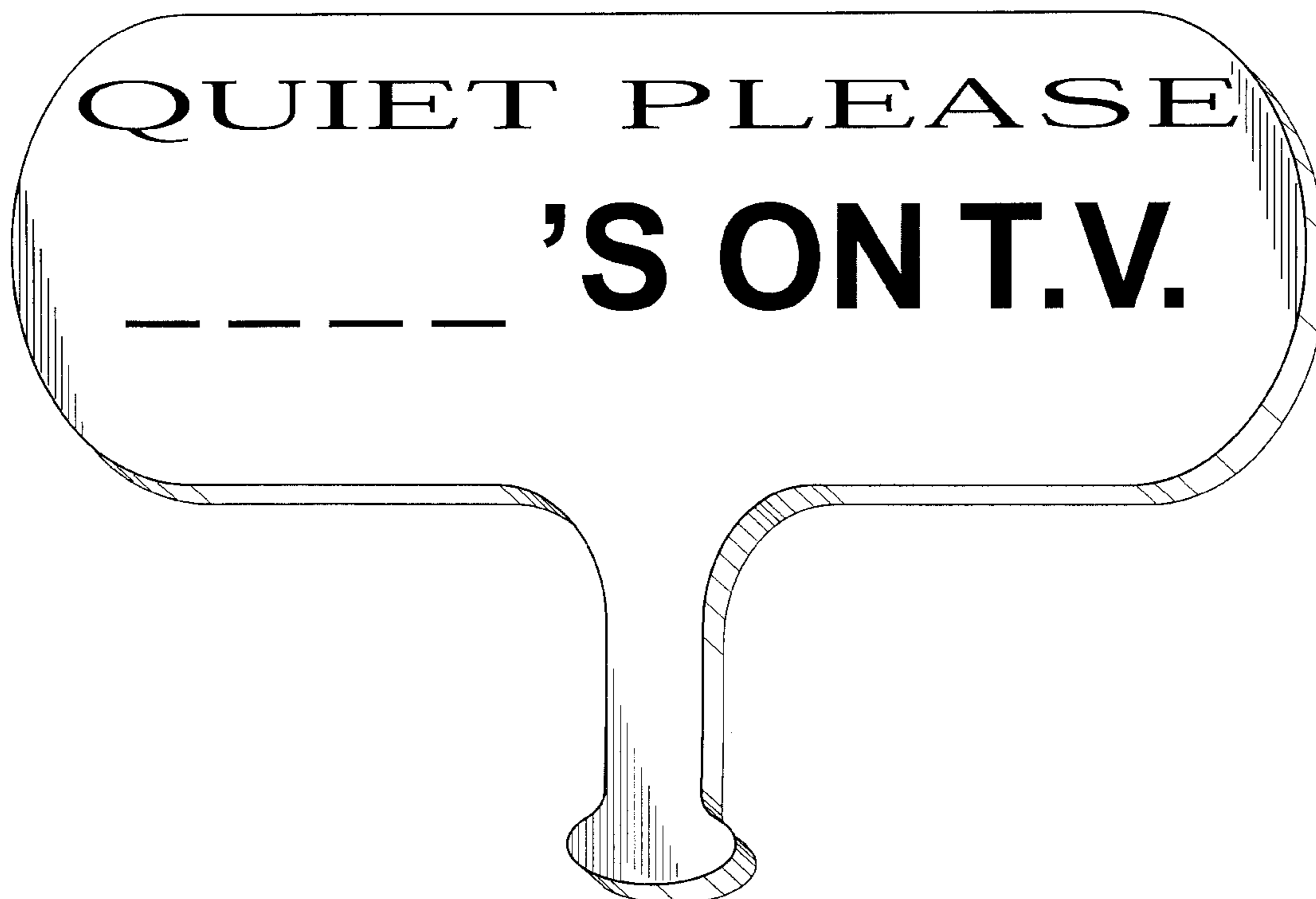
FIG. 5 is a top view of the embodiment depicted in FIG. 1.

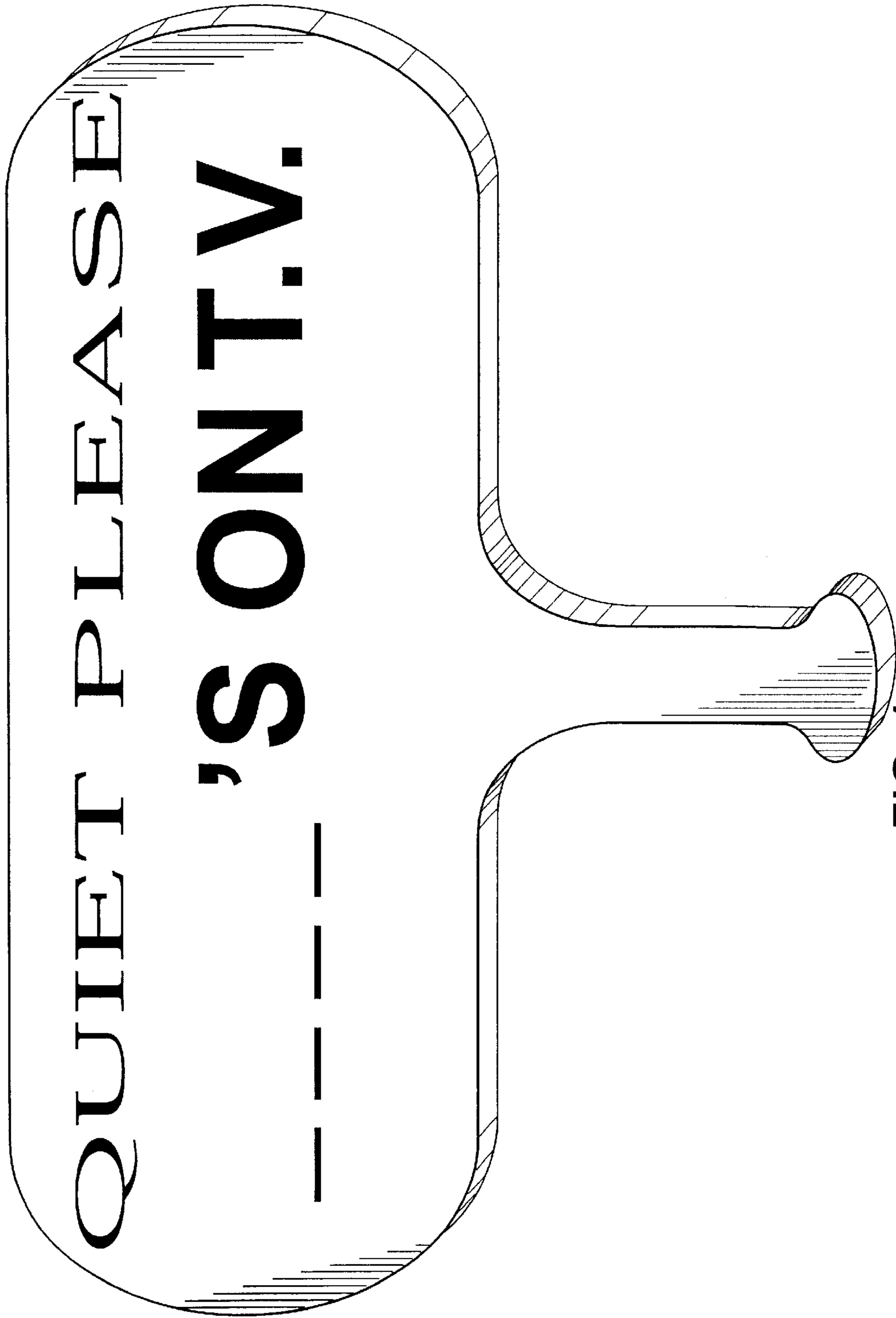

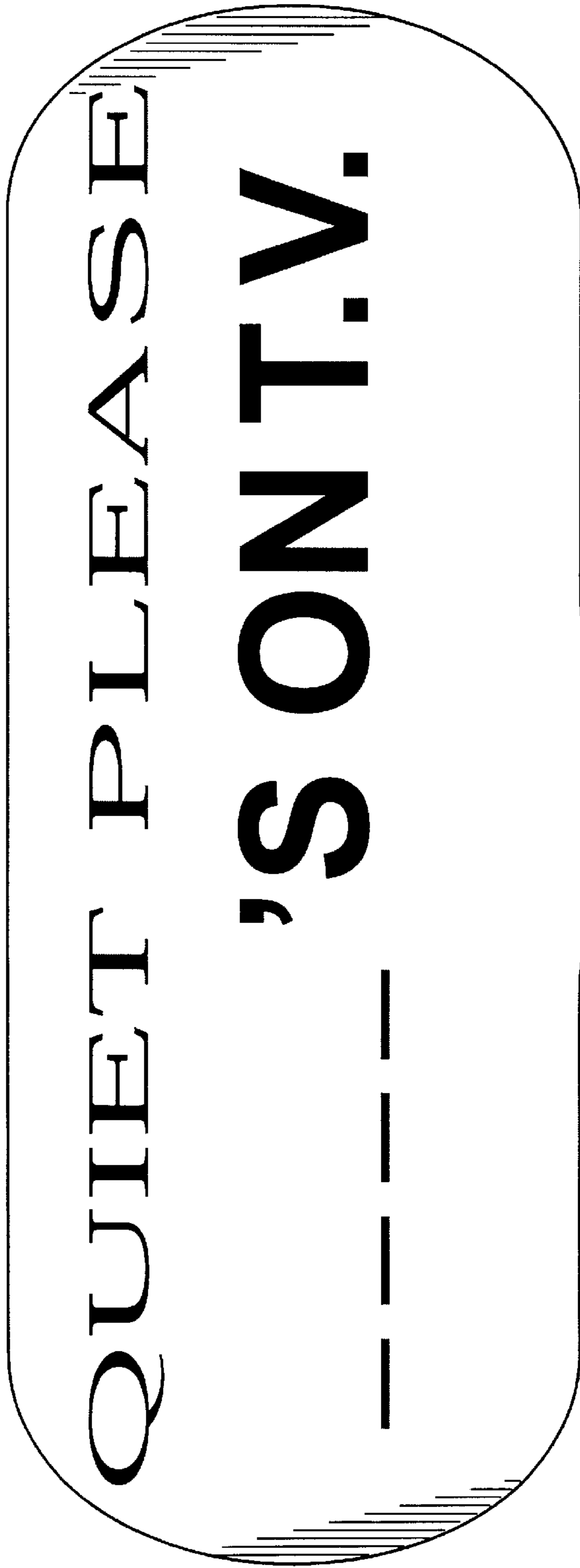

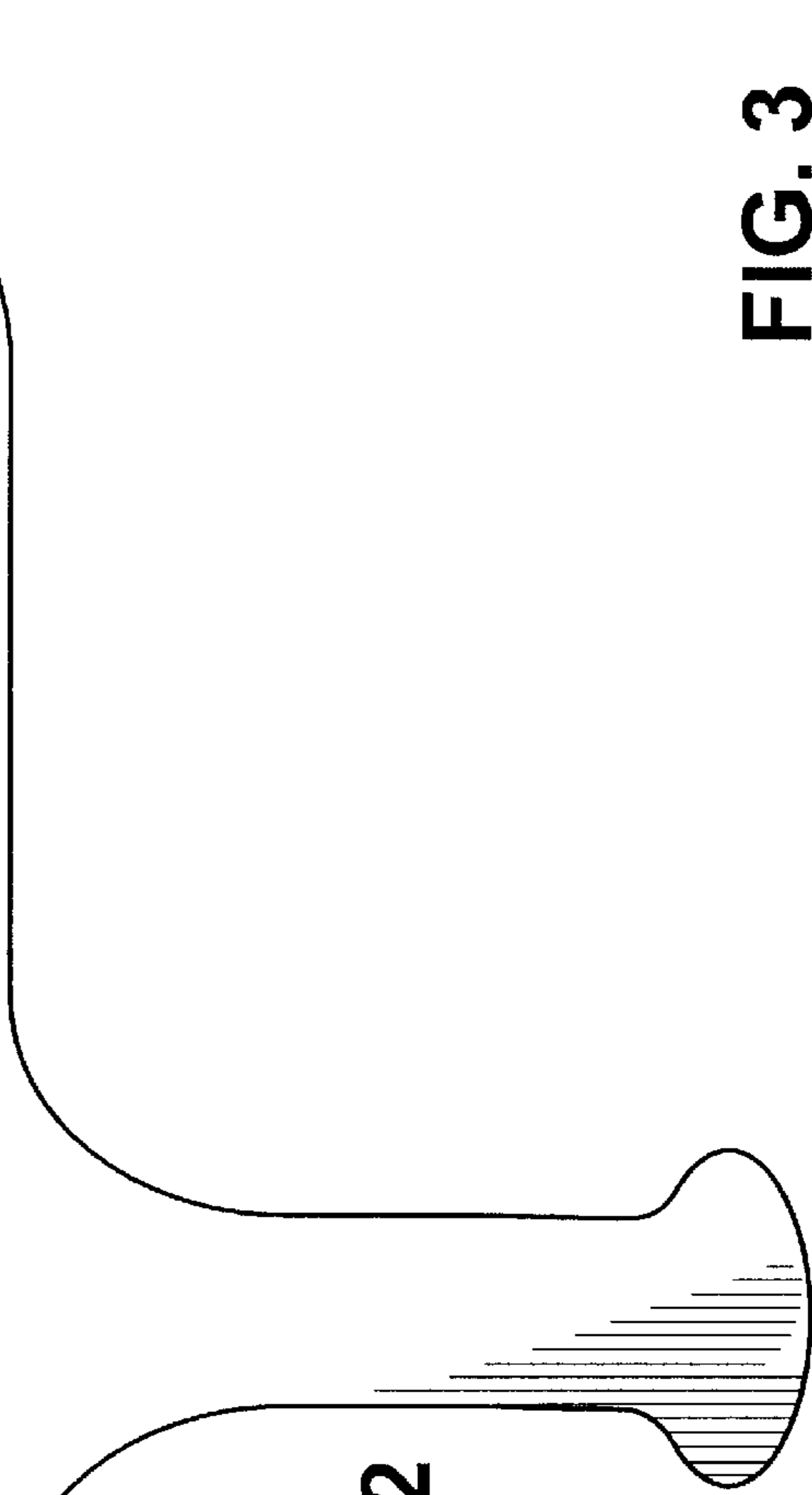

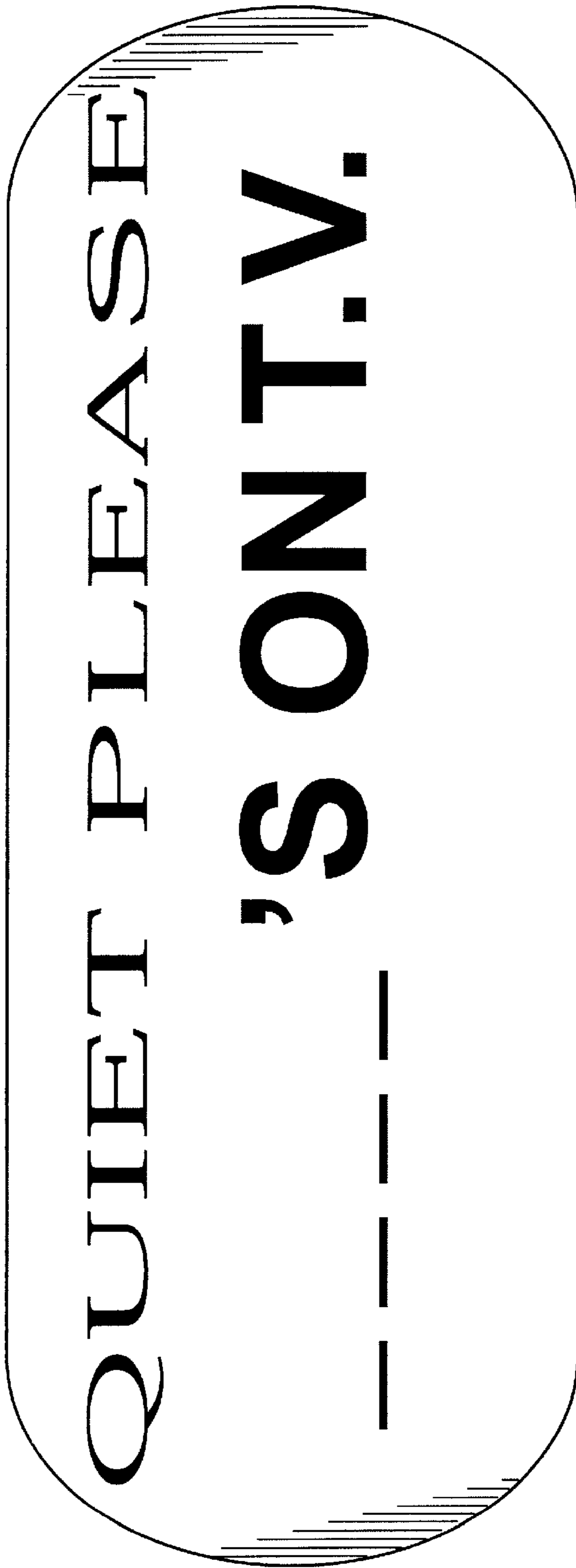

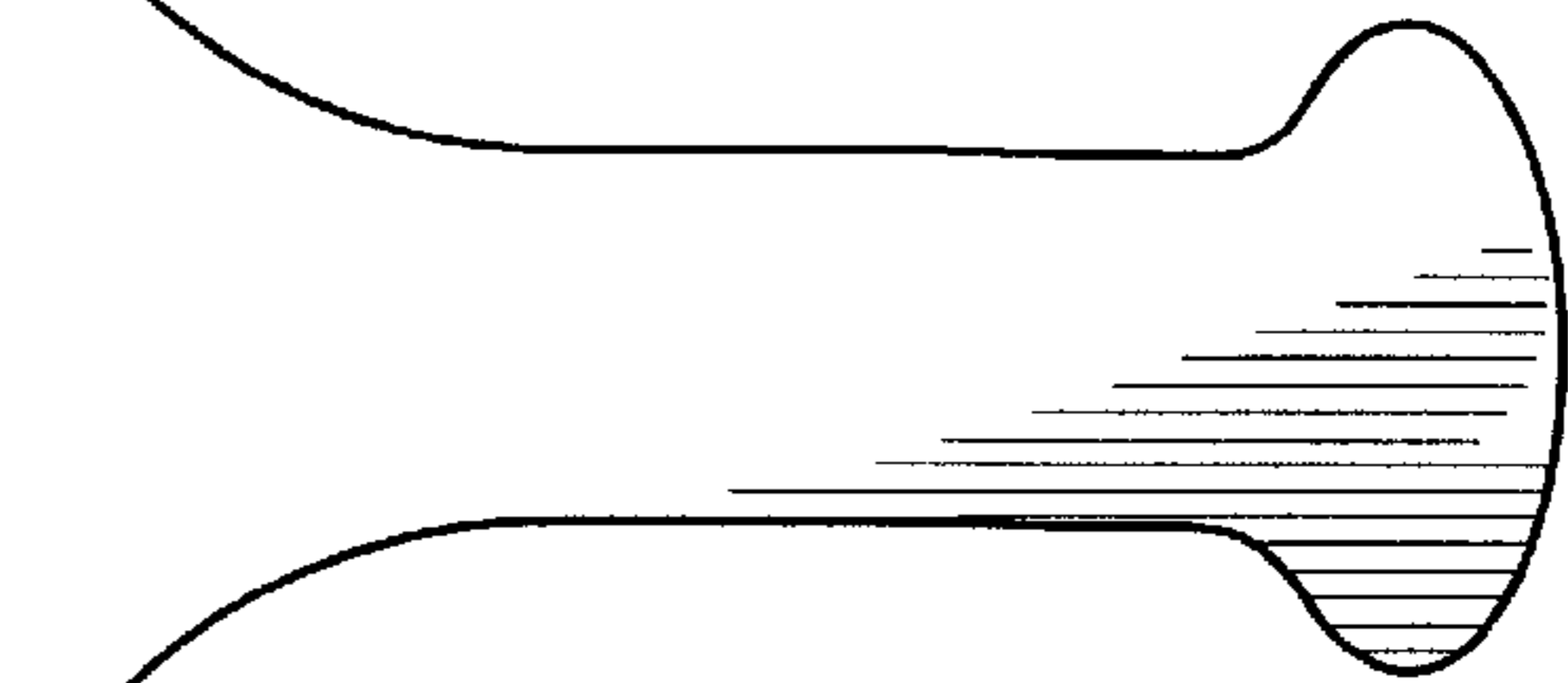

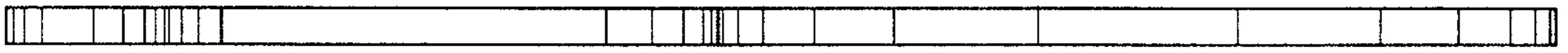
