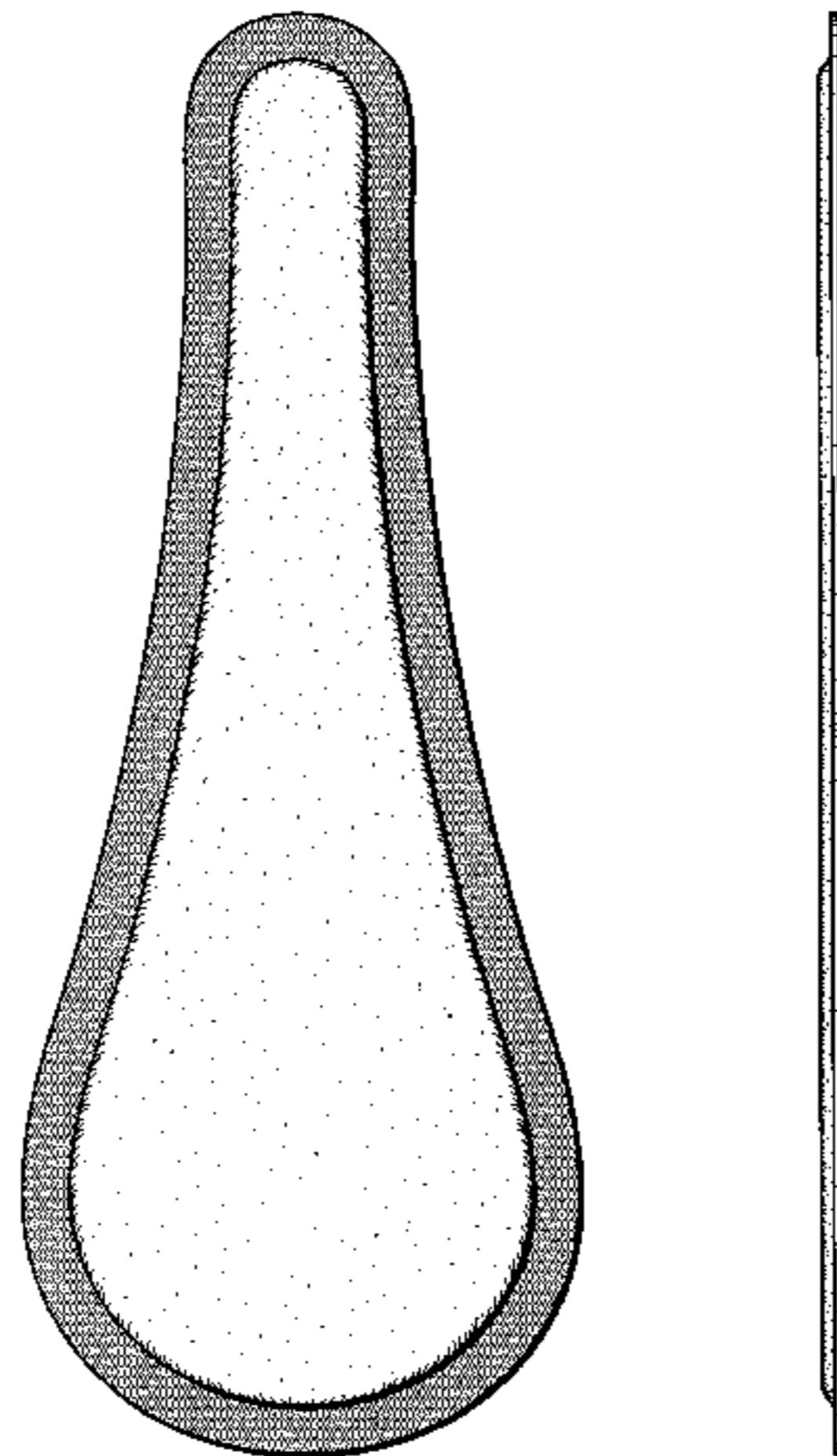
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top plan view of a sanitary napkin, showing our new design;
FIG. 2 is a right side elevational view thereof, the left side elevational view being a mirror image;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a rear elevational view thereof; and,

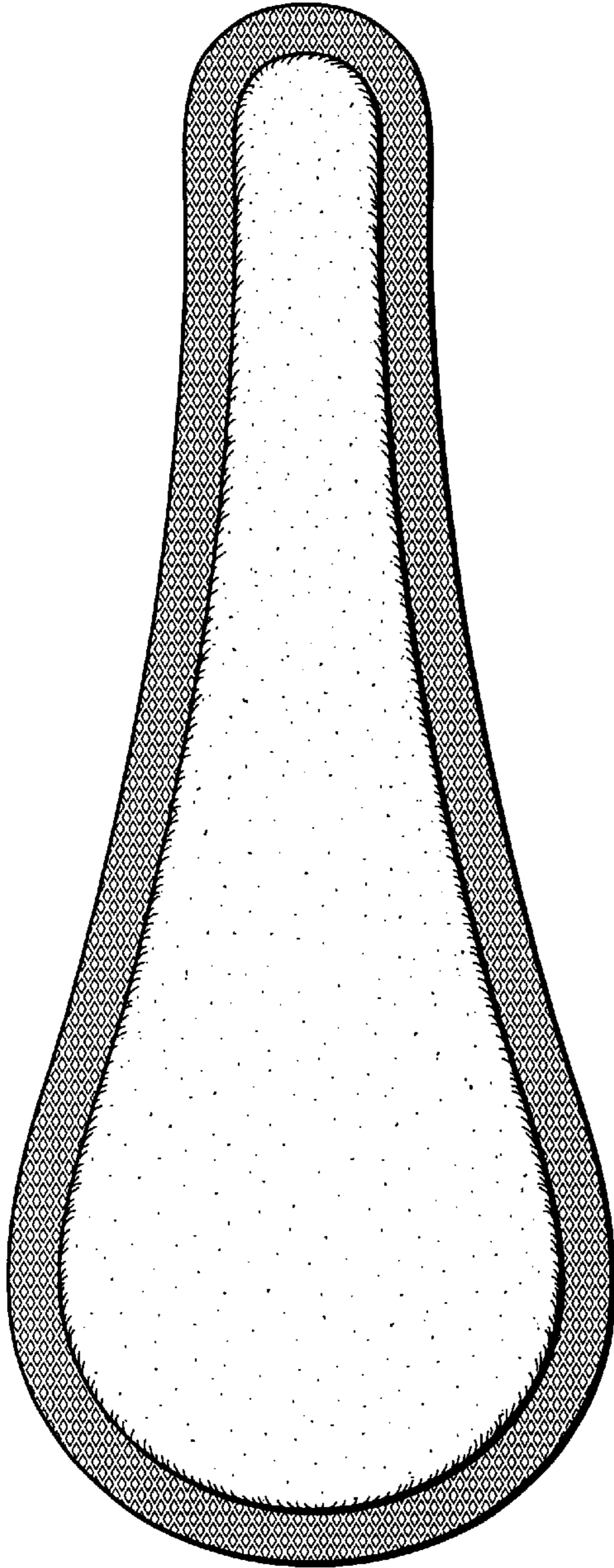

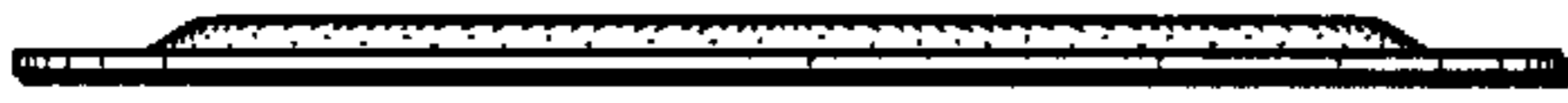
