(57) **CLAIM**

The ornamental design for an taillight assembly, as shown and described.

DESCRIPTION

FIG. 1 is a front-right side three-quarter view of the taillight assembly according to the present design;

FIG. 2 is a front elevational view of the taillight assembly of FIG. 1;

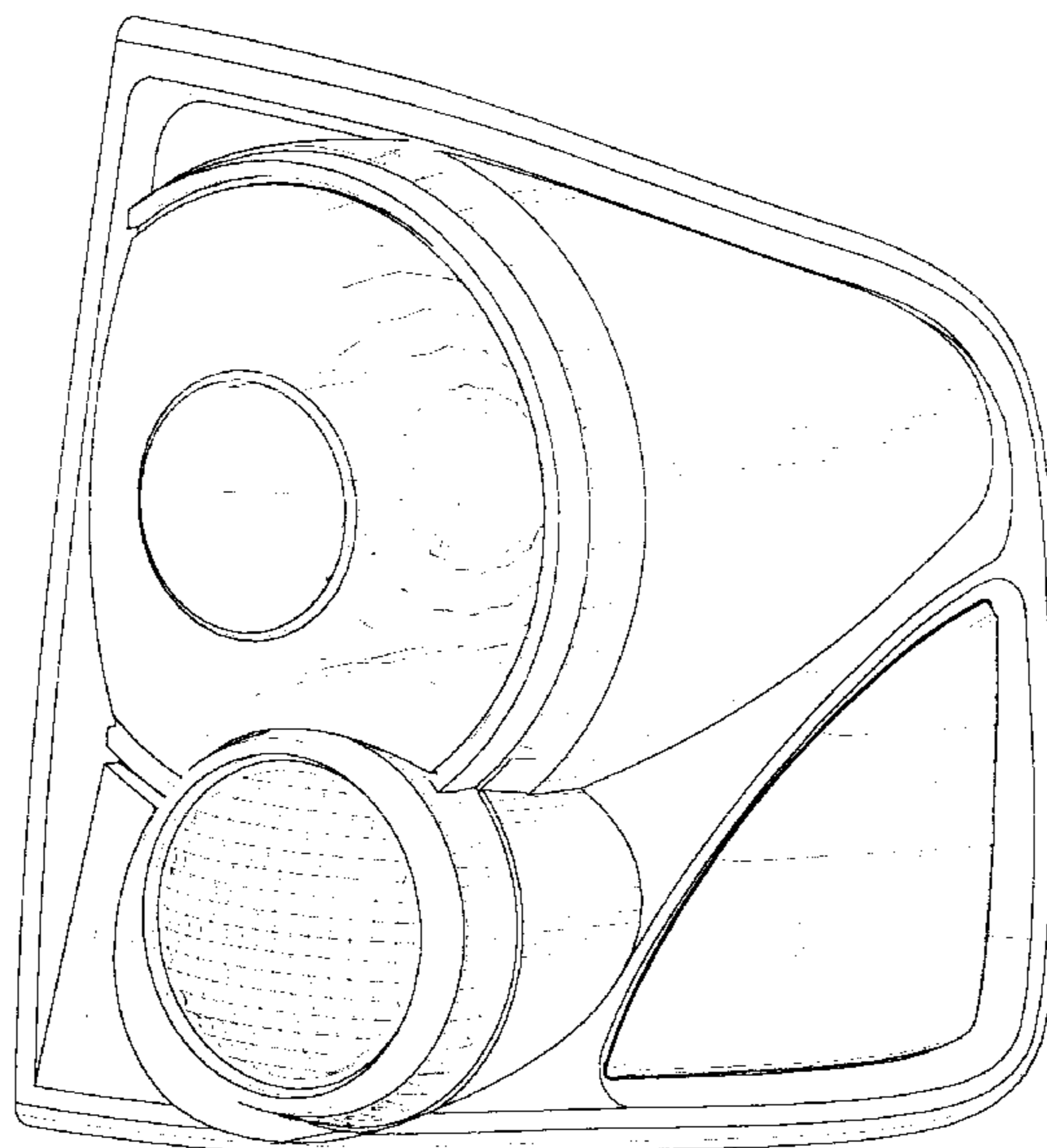
FIG. 3 is a right side elevational view of the taillight assembly of FIG. 1;

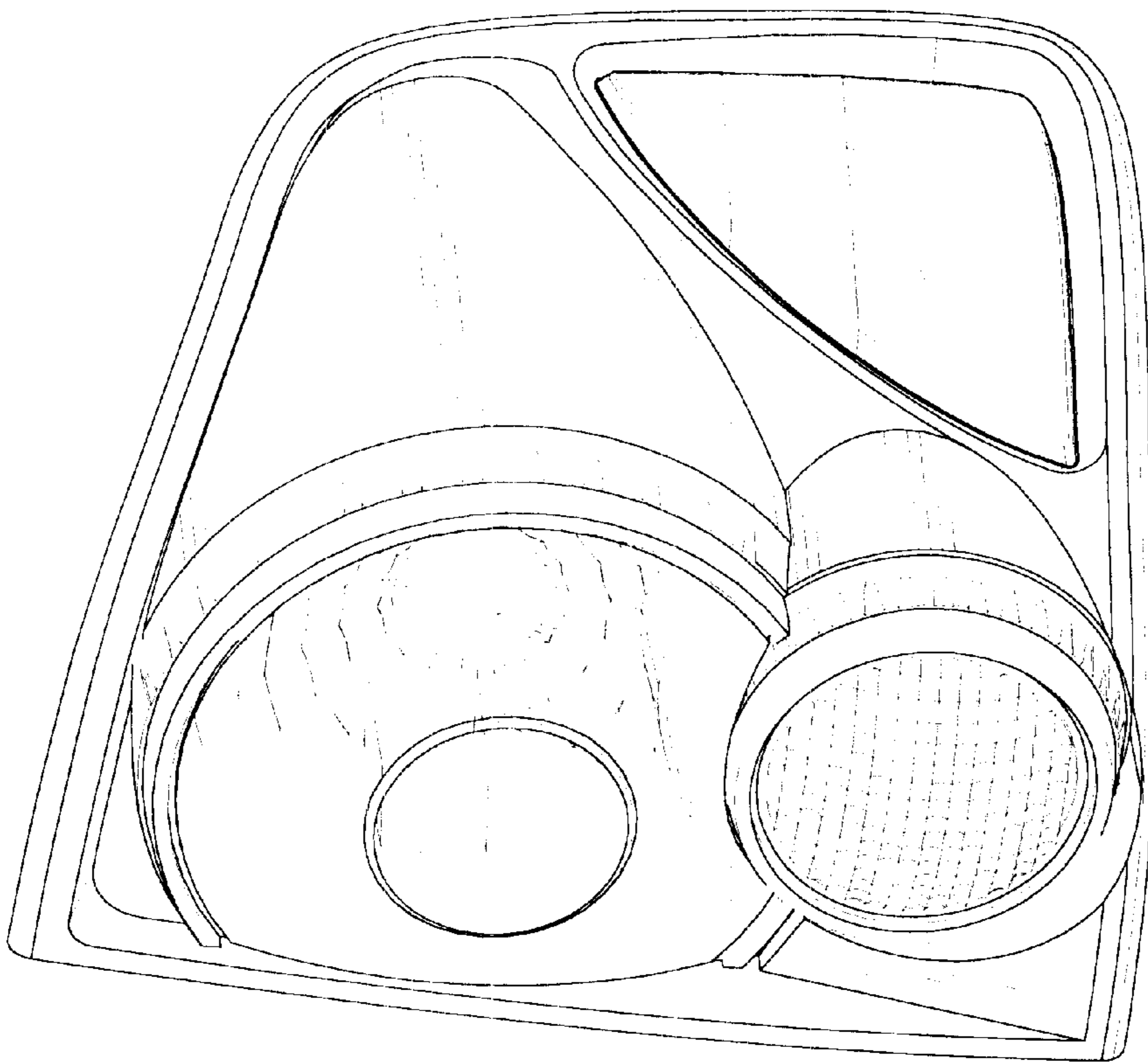

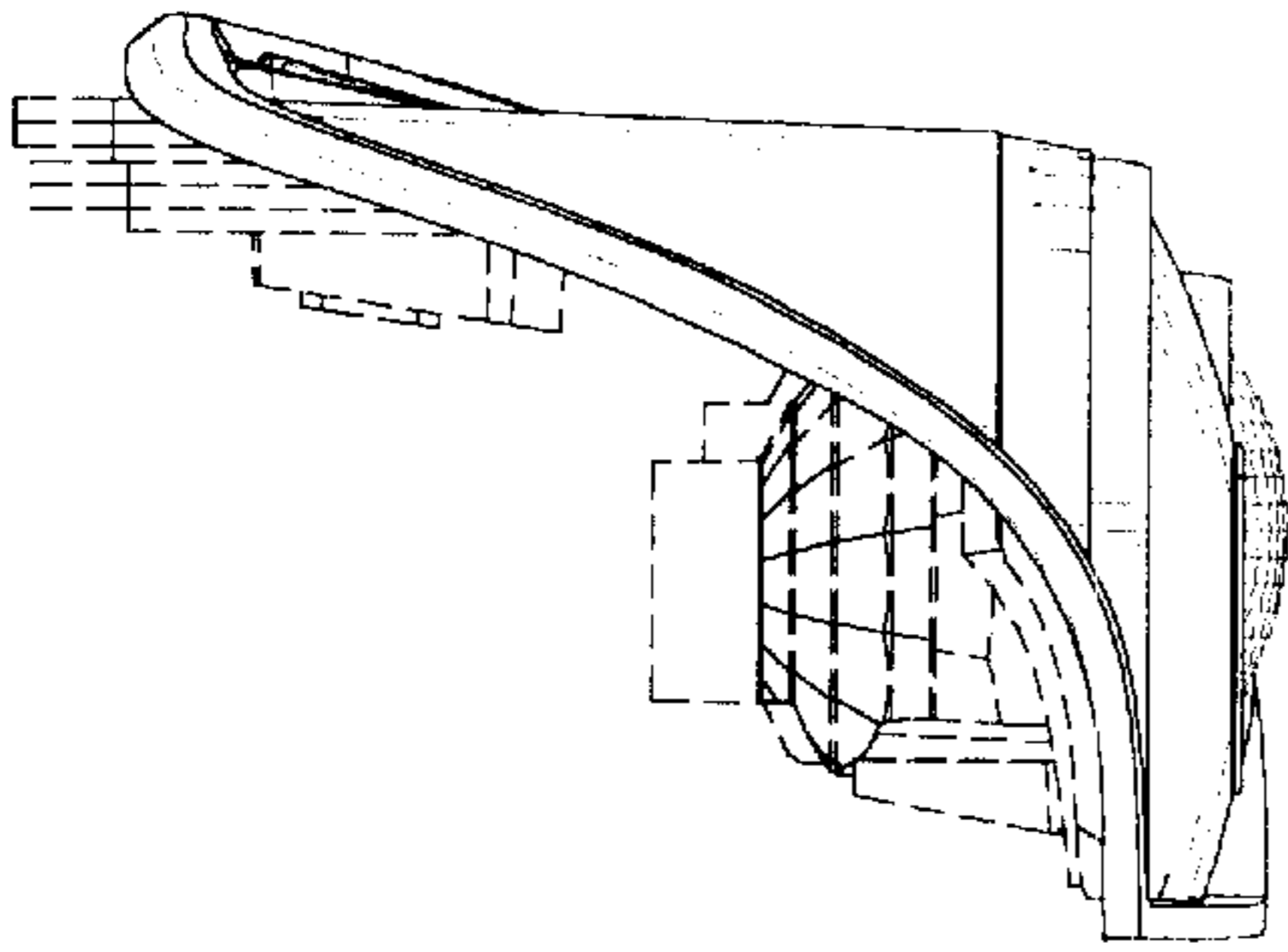

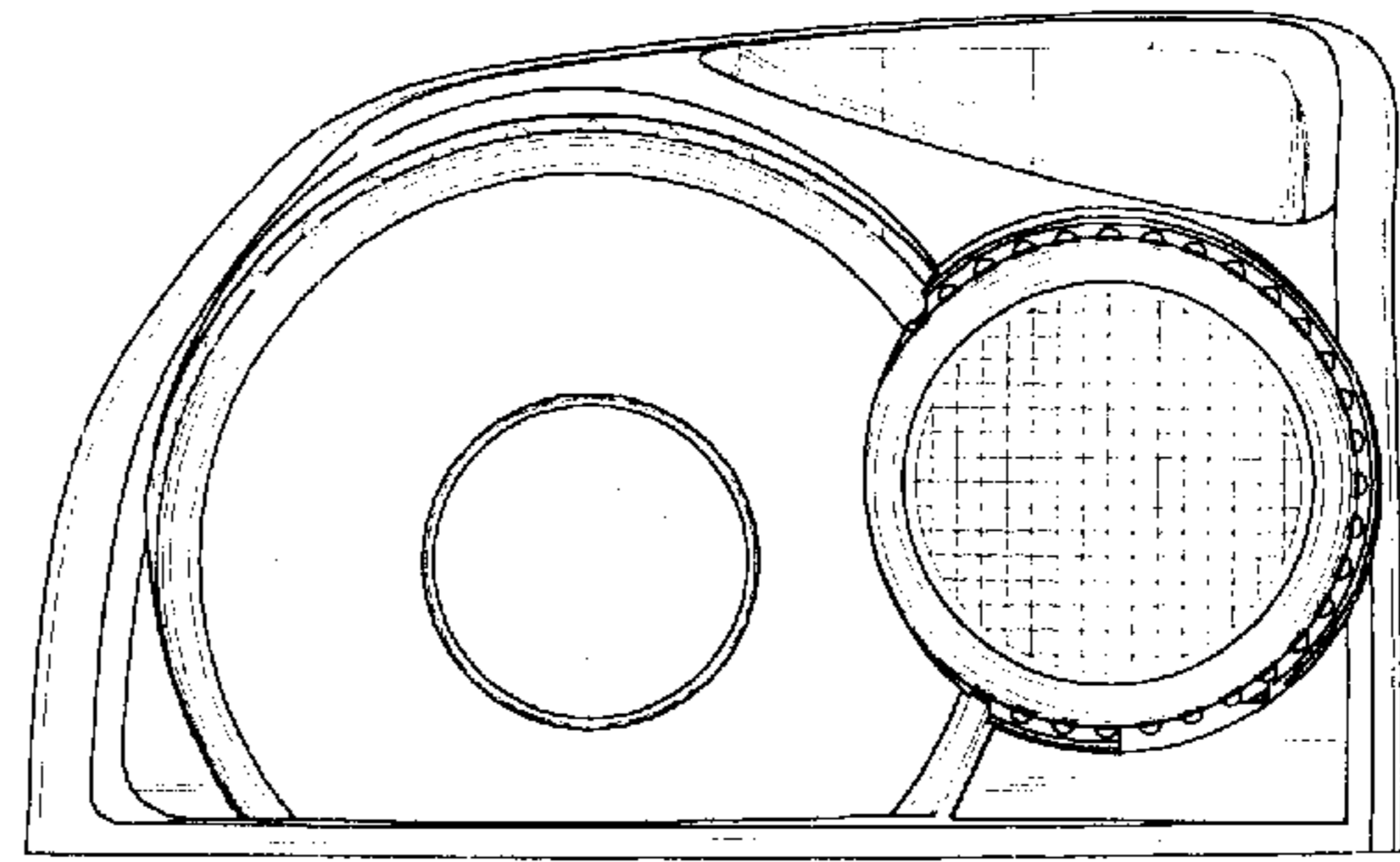

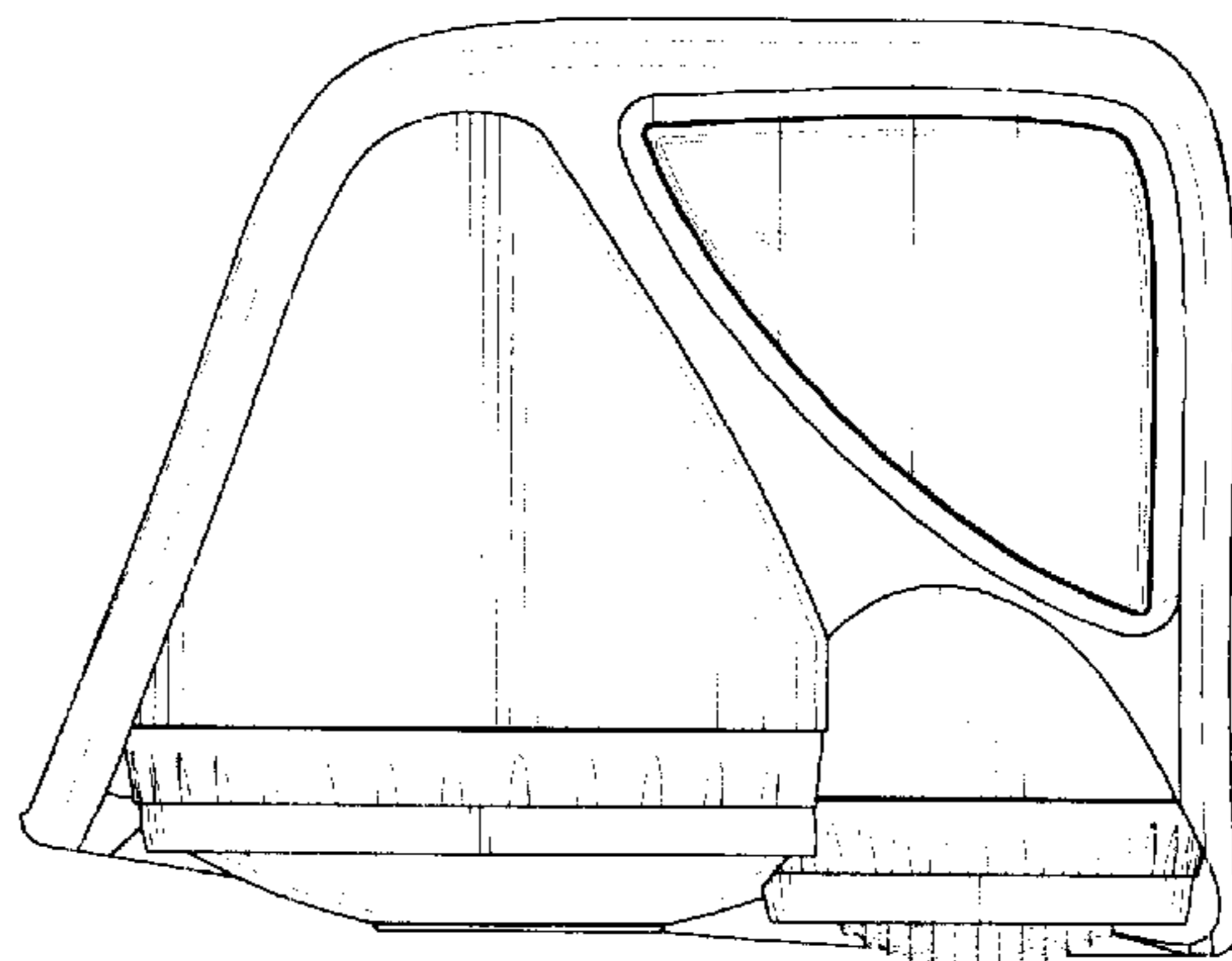

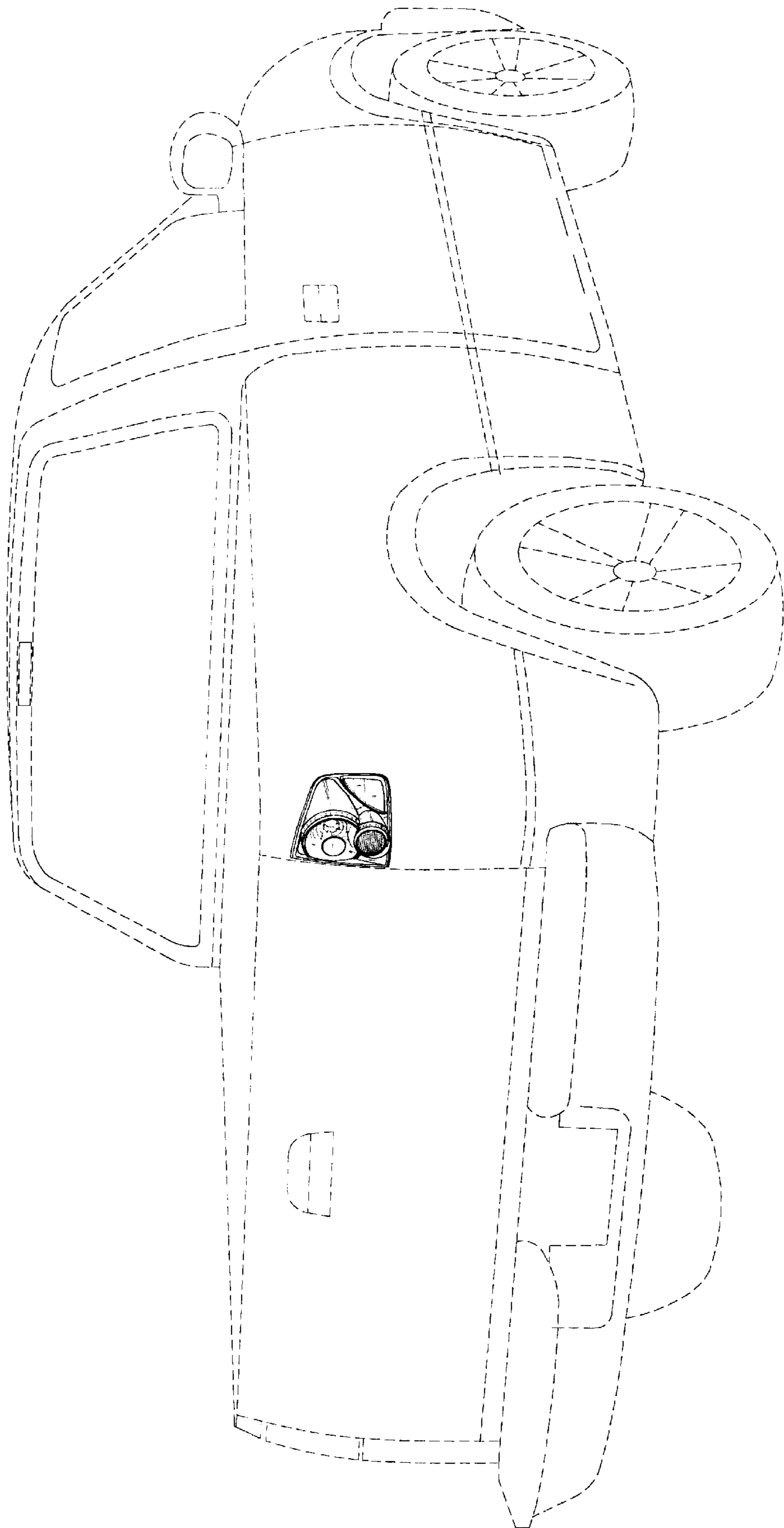
