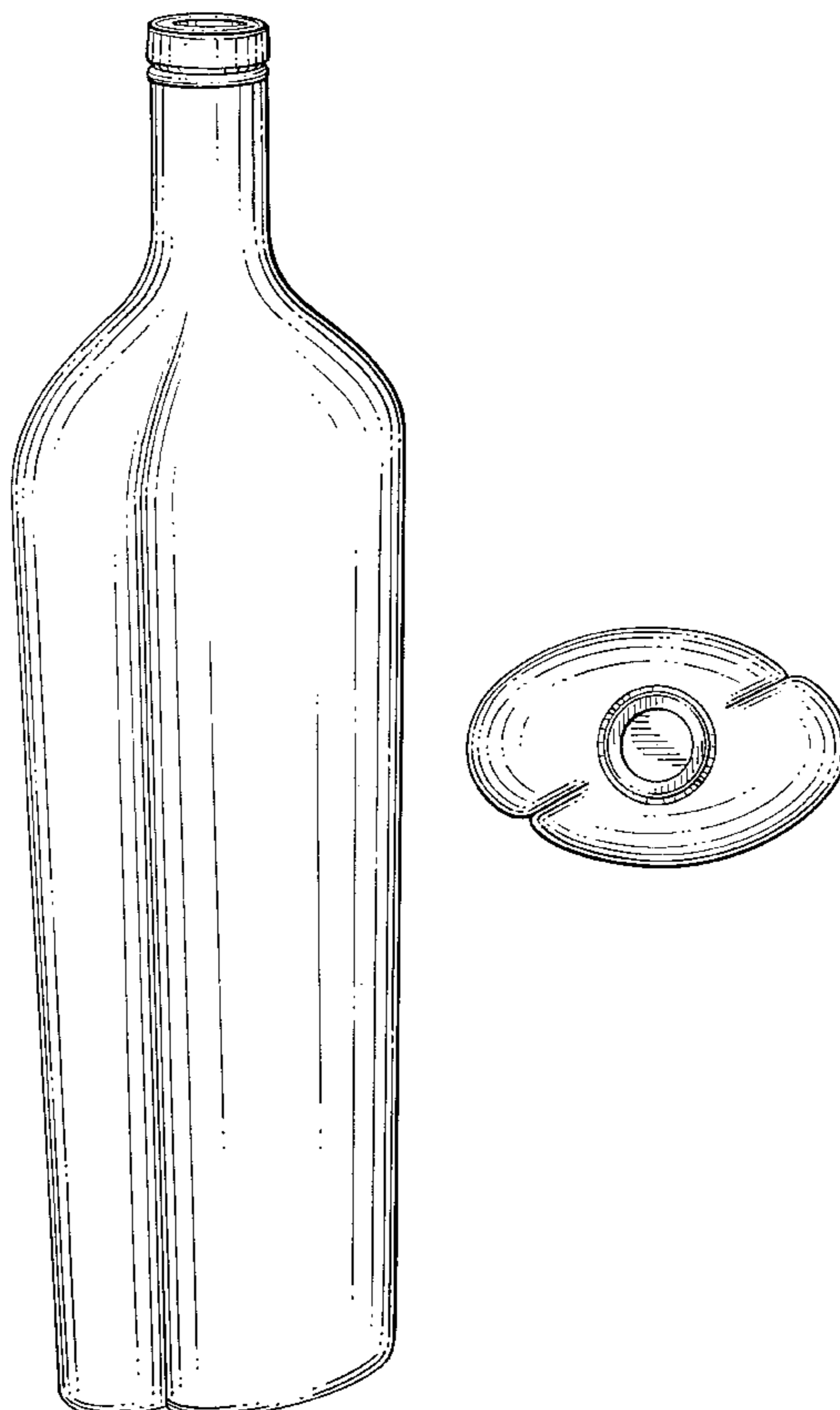
(57) **CLAIM**

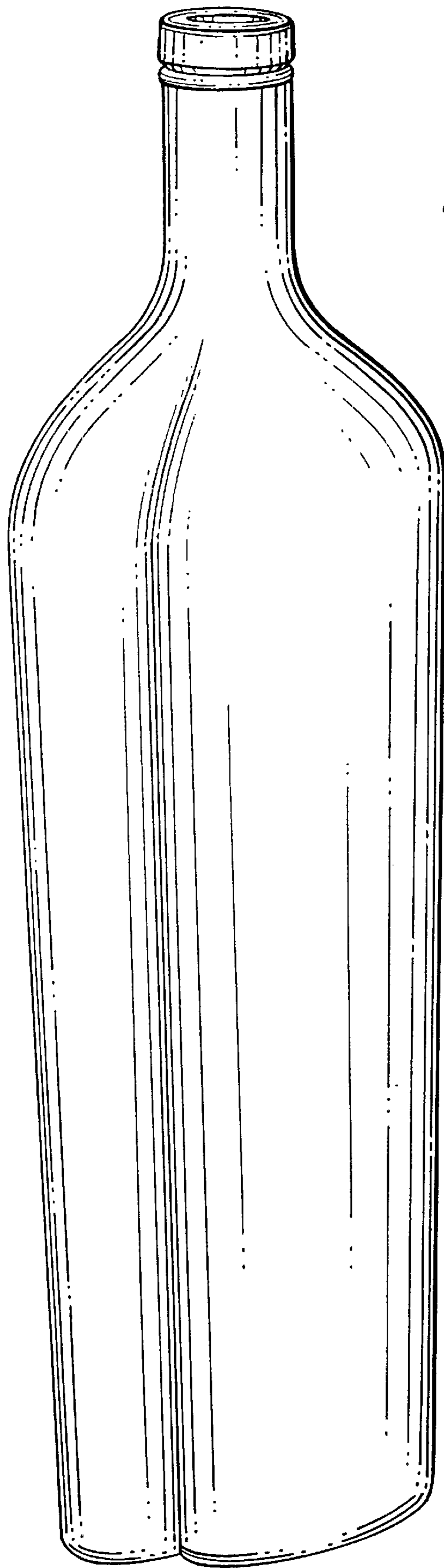
We claim the ornamental design for a bottle, as shown and described.

The broken line shown in FIG. 5 is for environmental purposes only and forms no part of the claimed design.

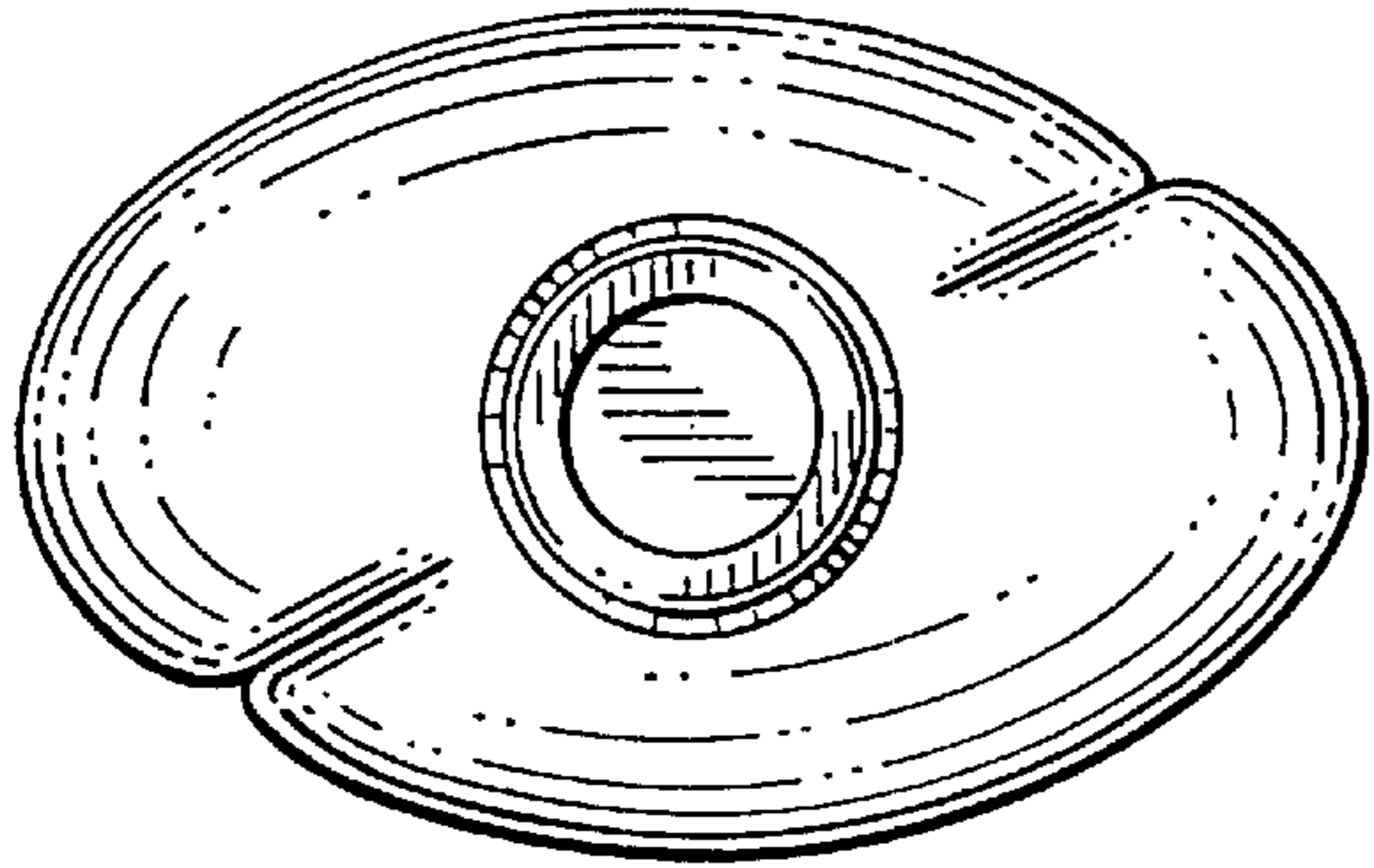

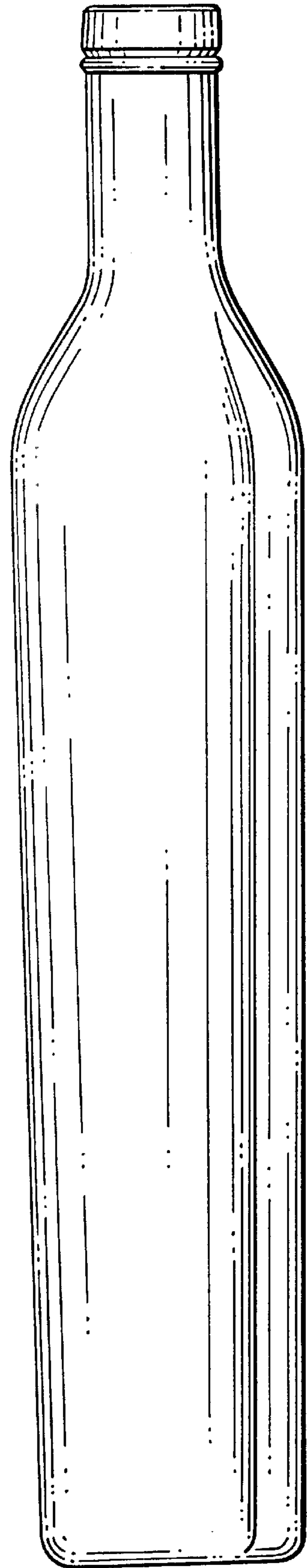


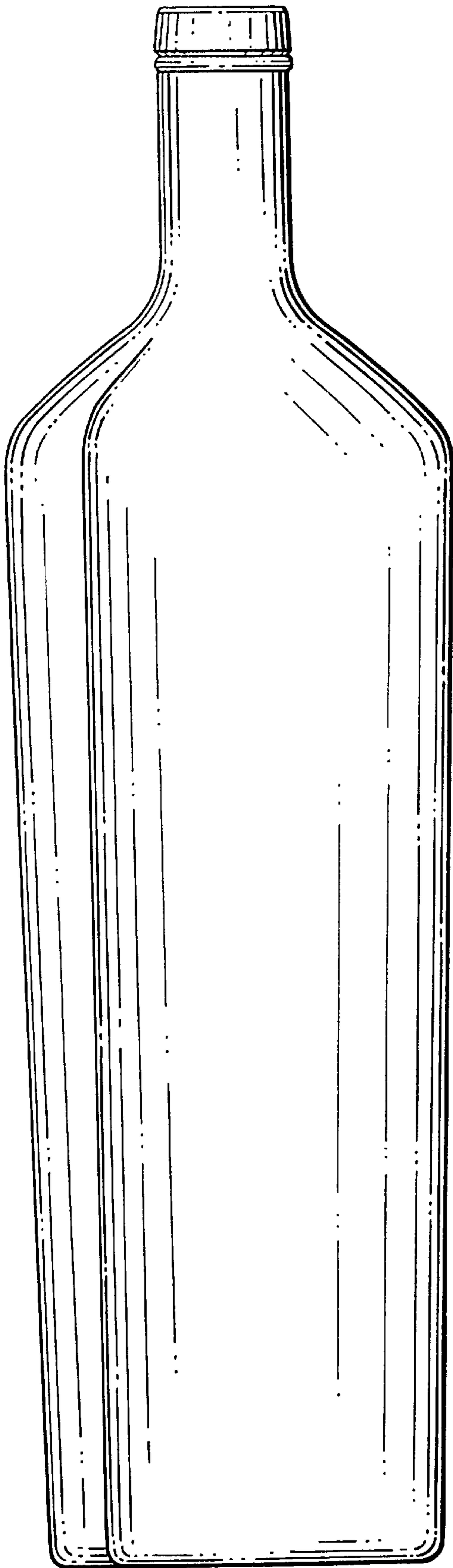

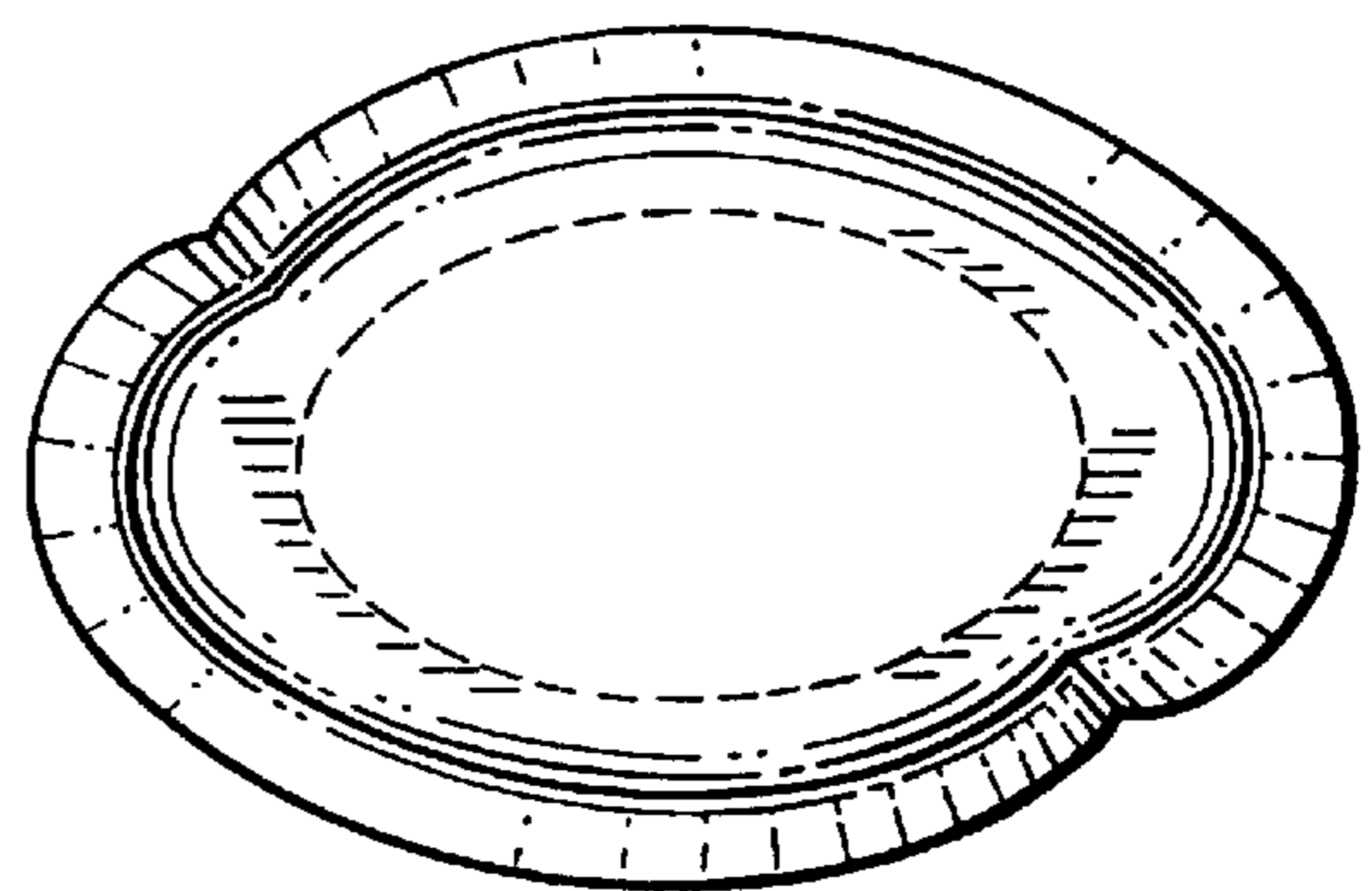
