FIG. 5 is a rear view thereof;

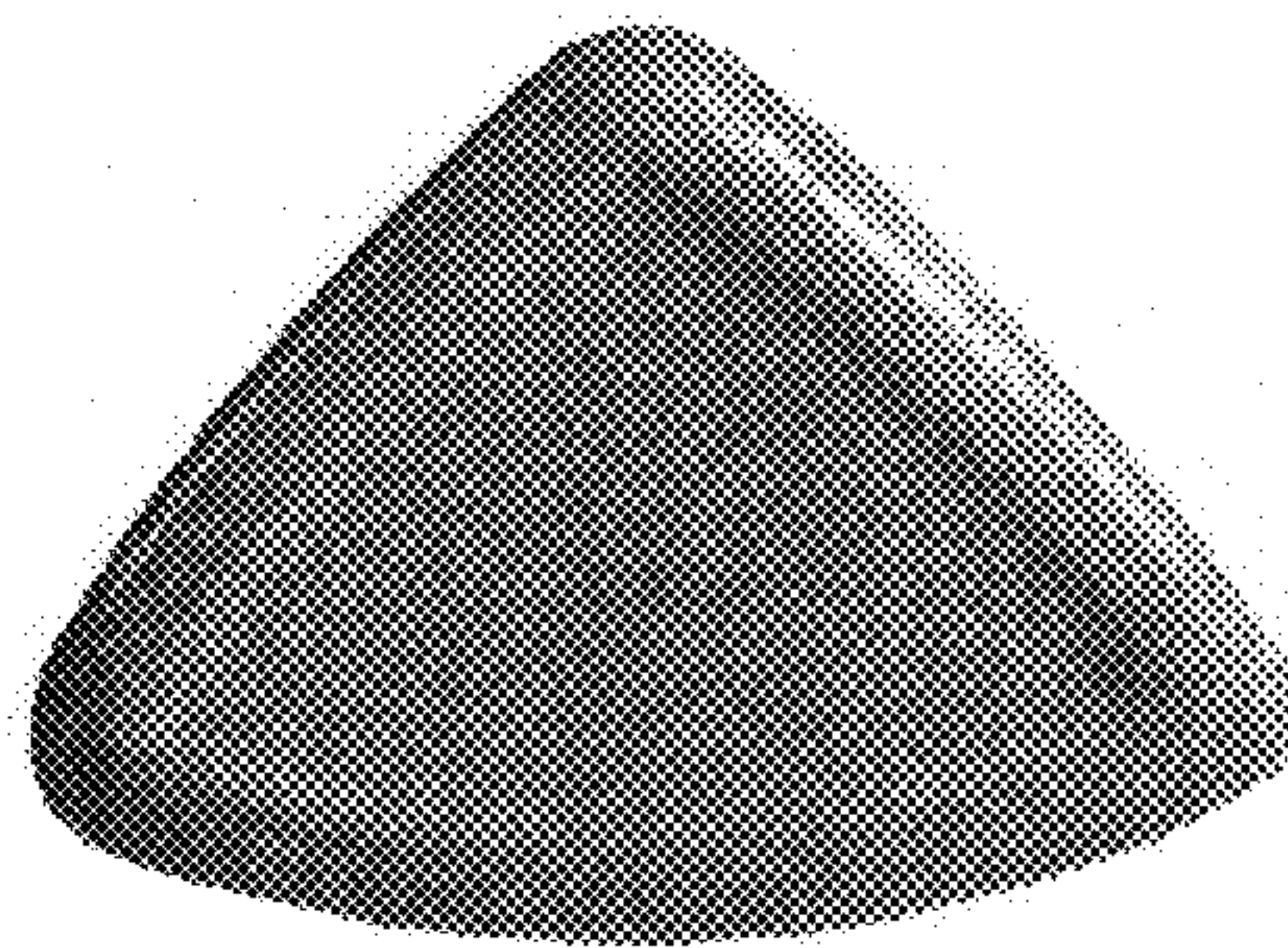
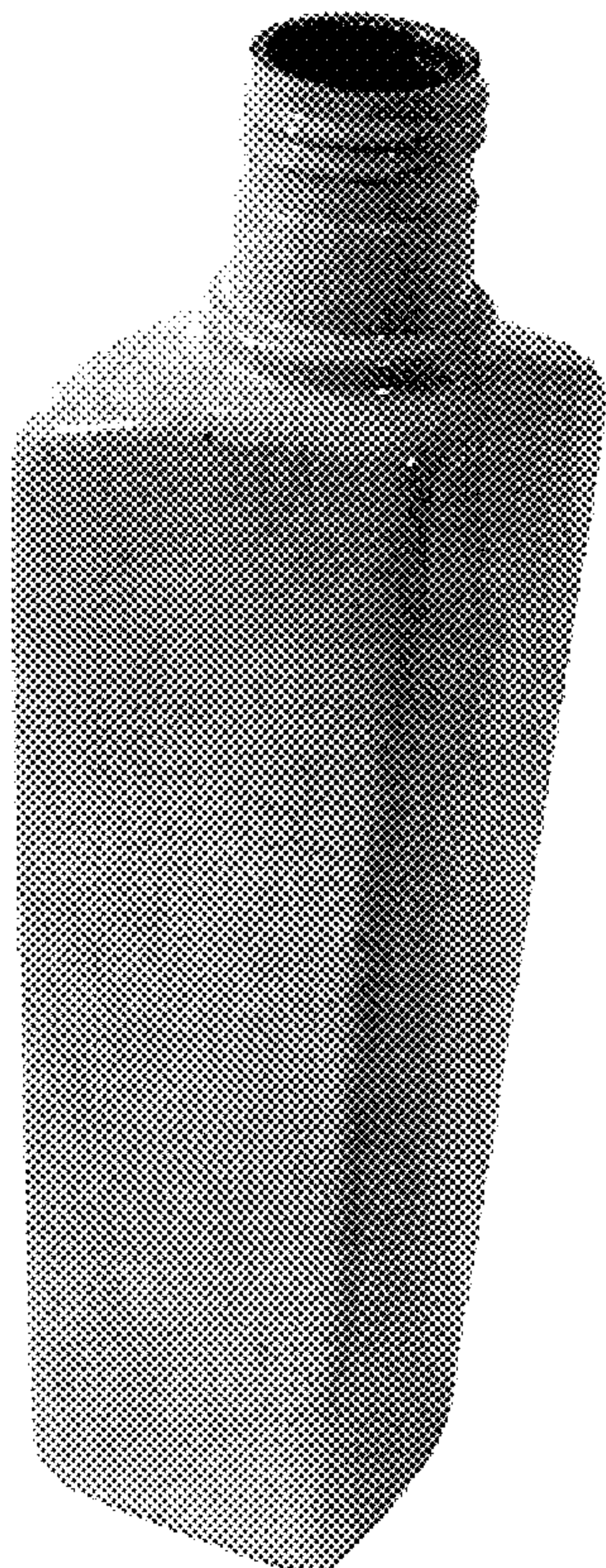
FIG. 6 is a top plan view thereof;

FIG. 7 is a bottom plan view thereof;

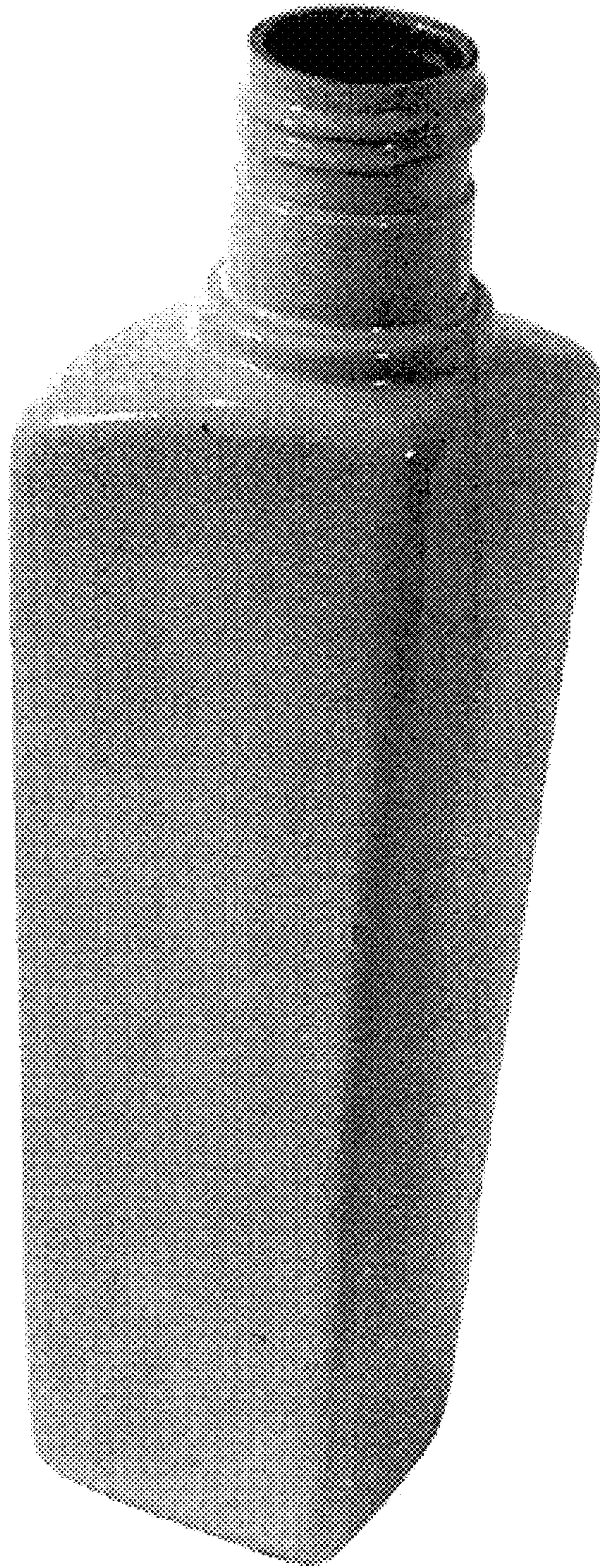
FIG. 8 is a perspective view thereof as seen from the right side; and,

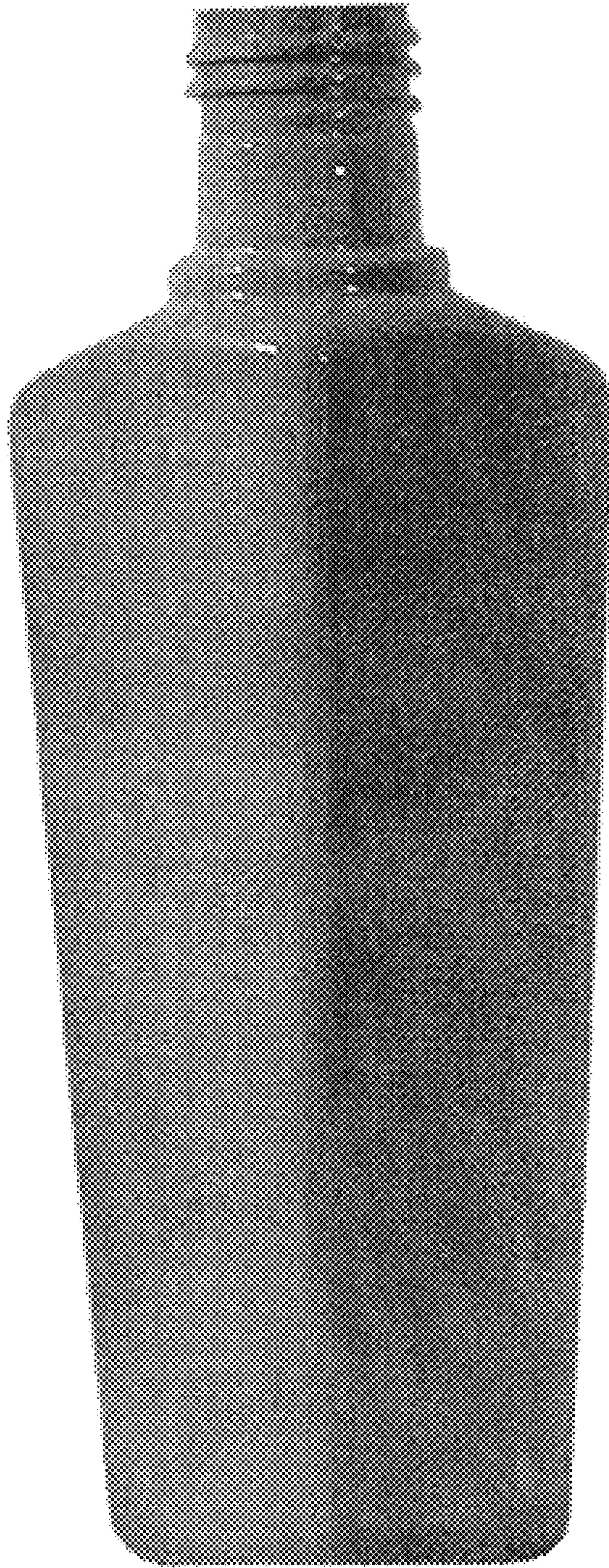






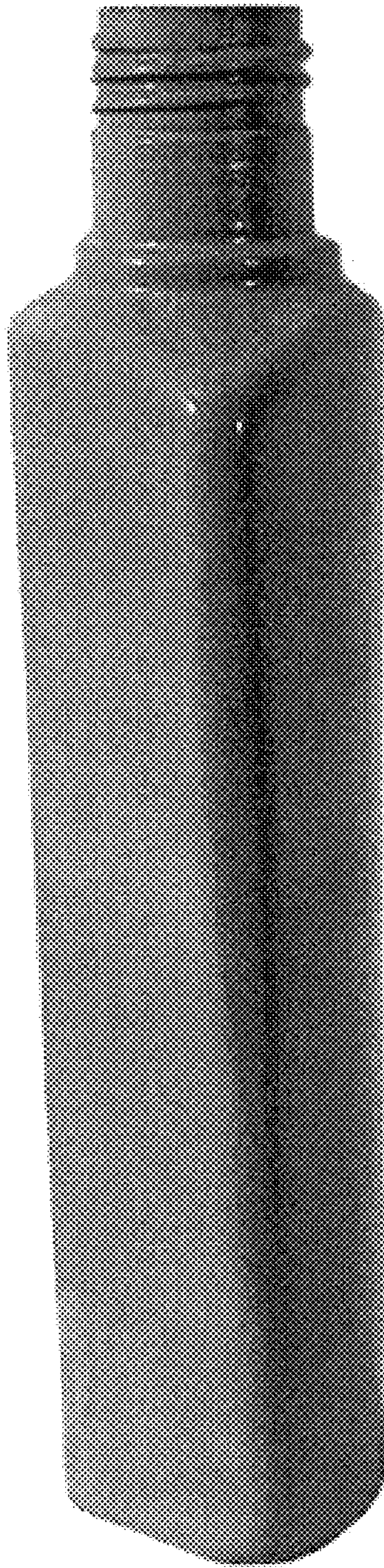

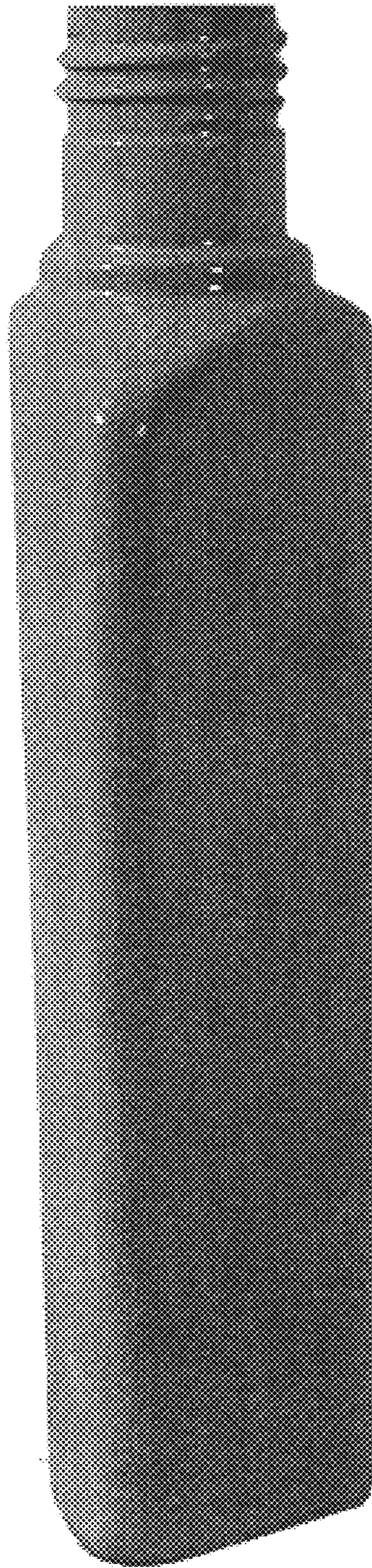

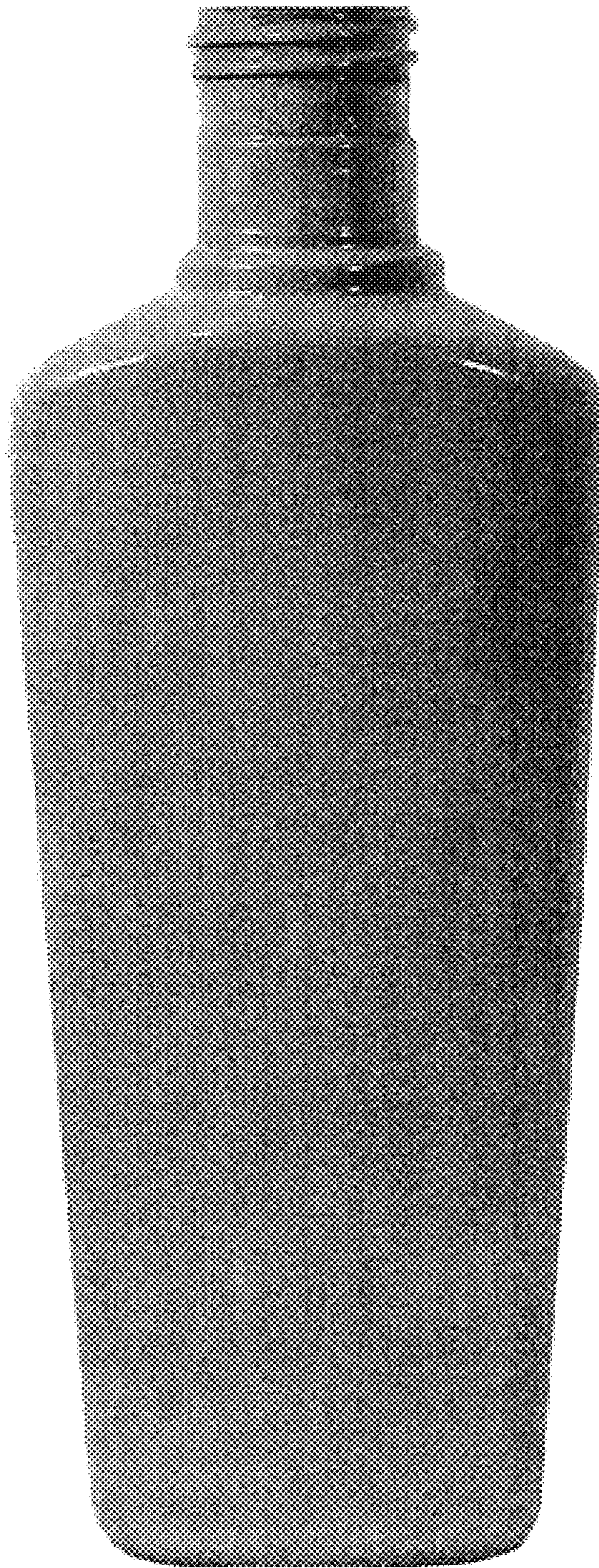

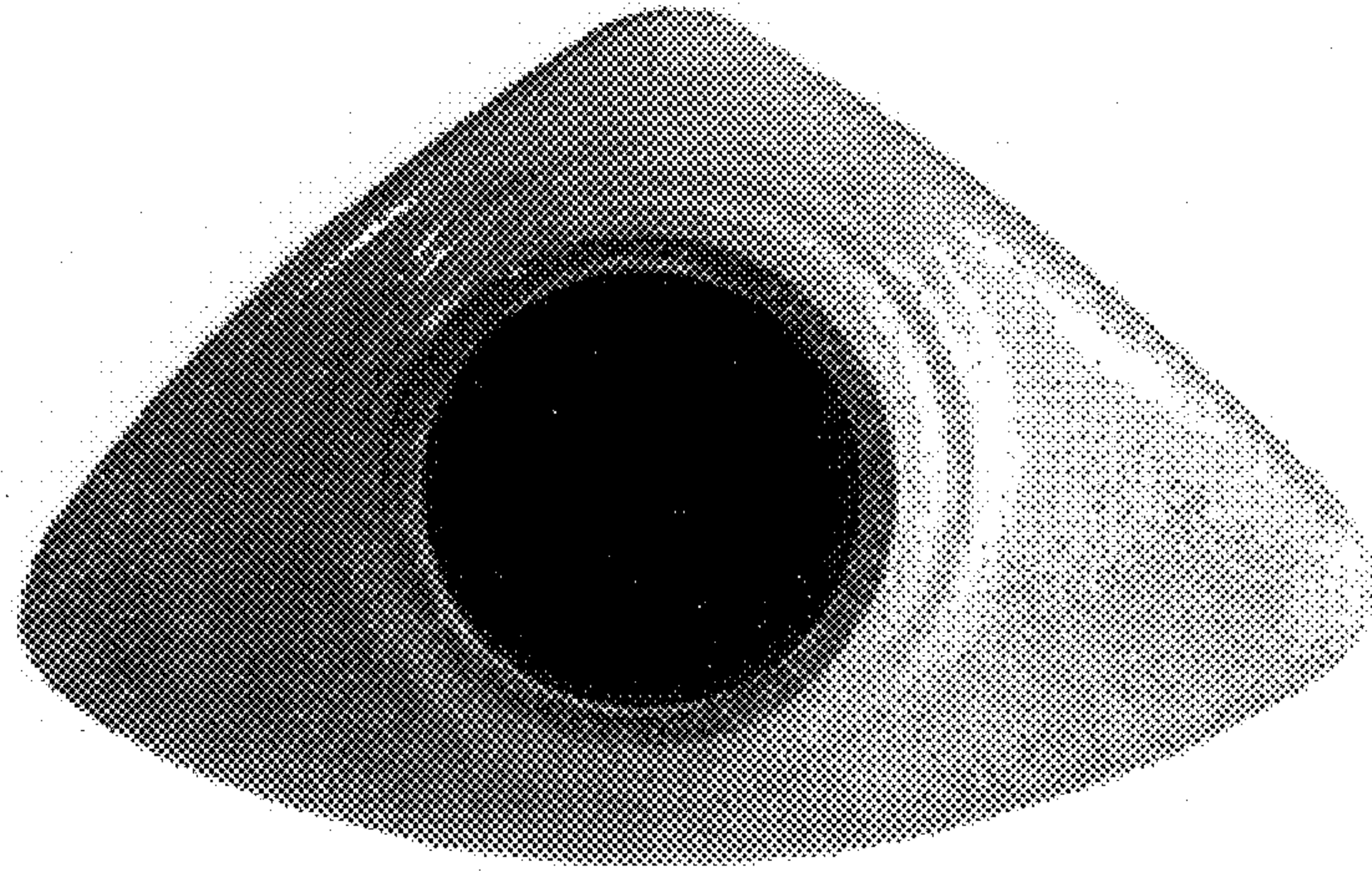

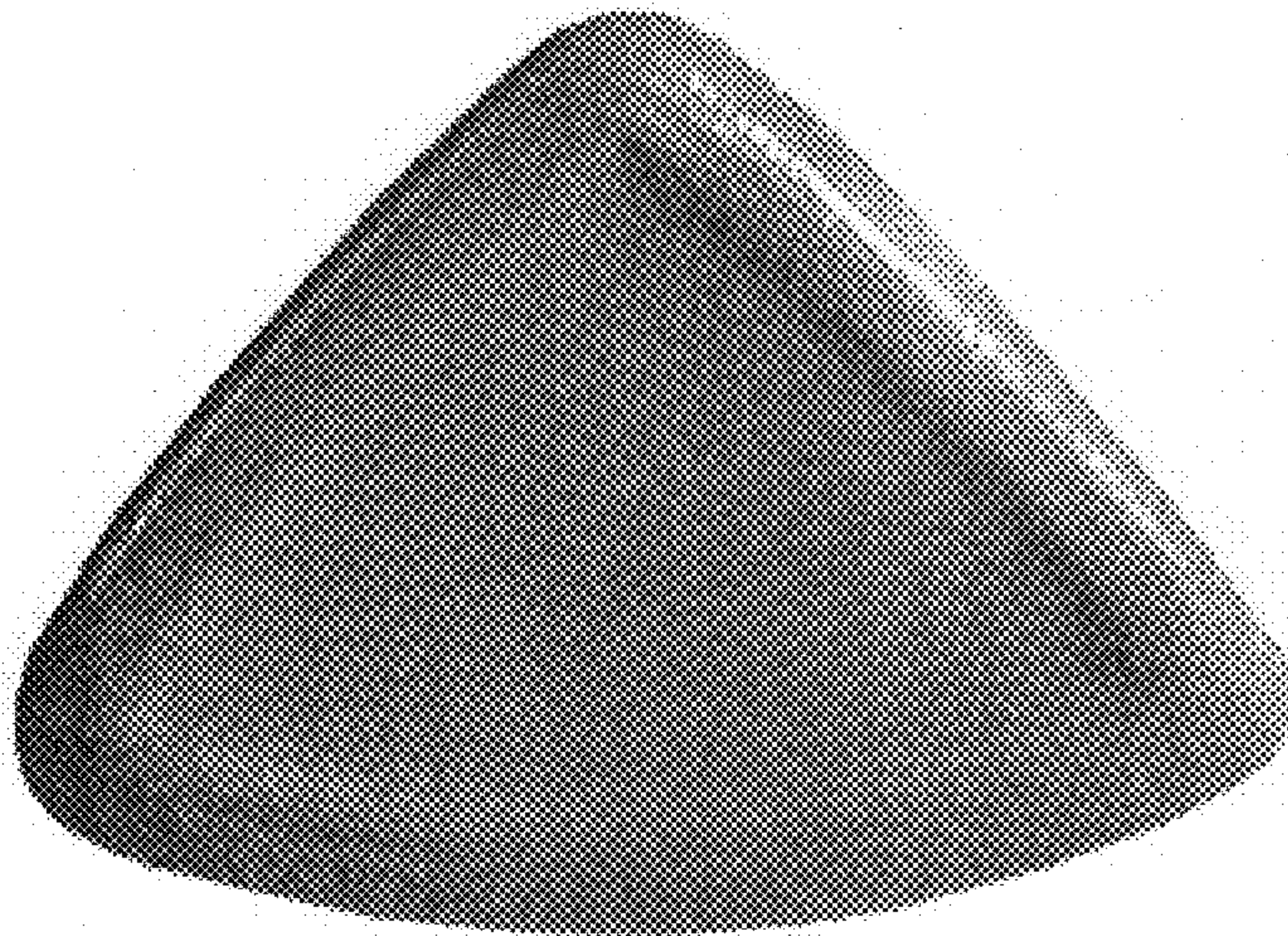
