The ornamental design for a microphone, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a microphone embodying my new design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a bottom view thereof;
FIG. 5 is a right side view thereof;
FIG. 6 is a perspective view as viewed from a portion above the microphone; and,
FIG. 7 is a perspective view as viewed from a portion below the microphone.

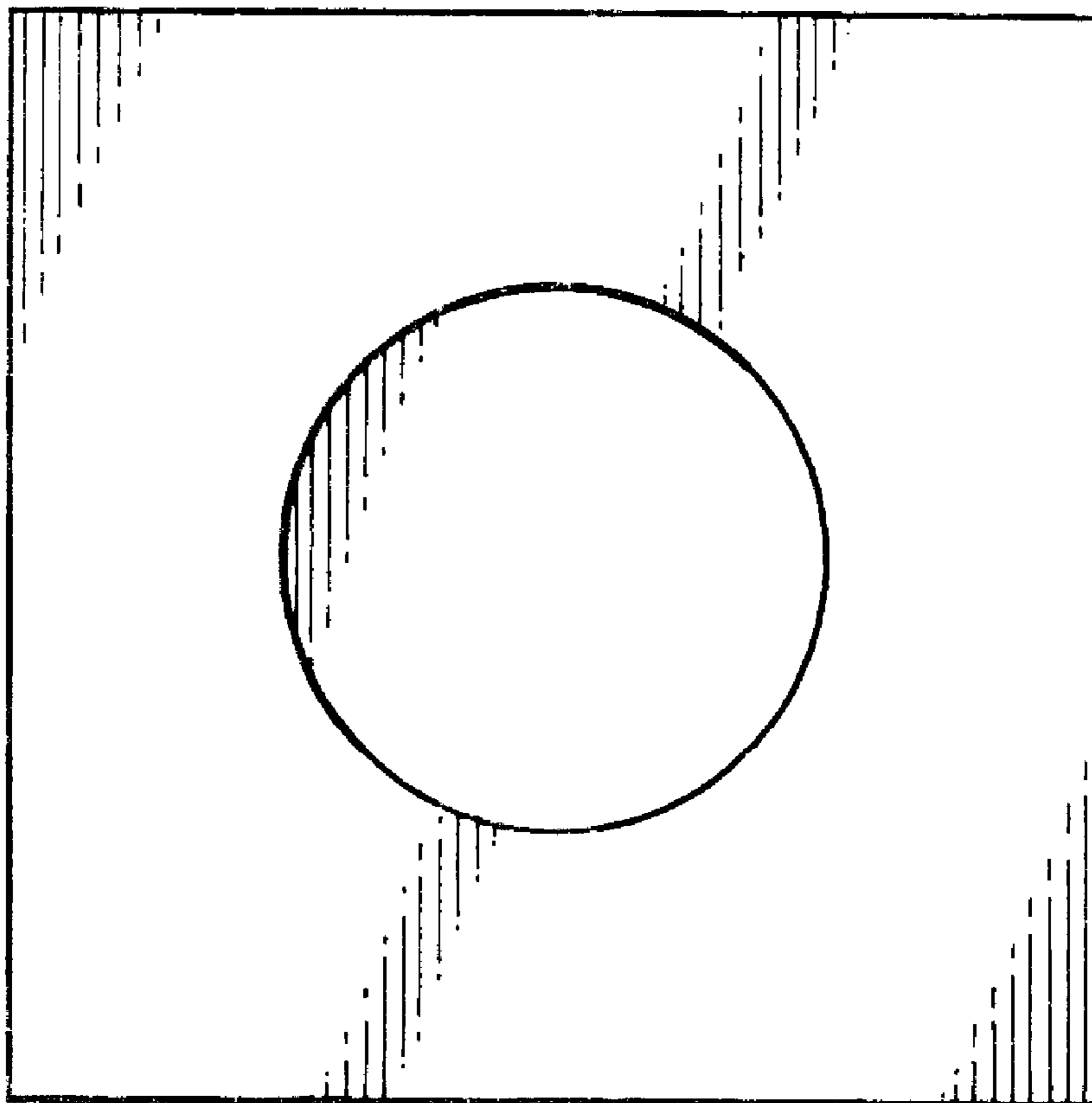

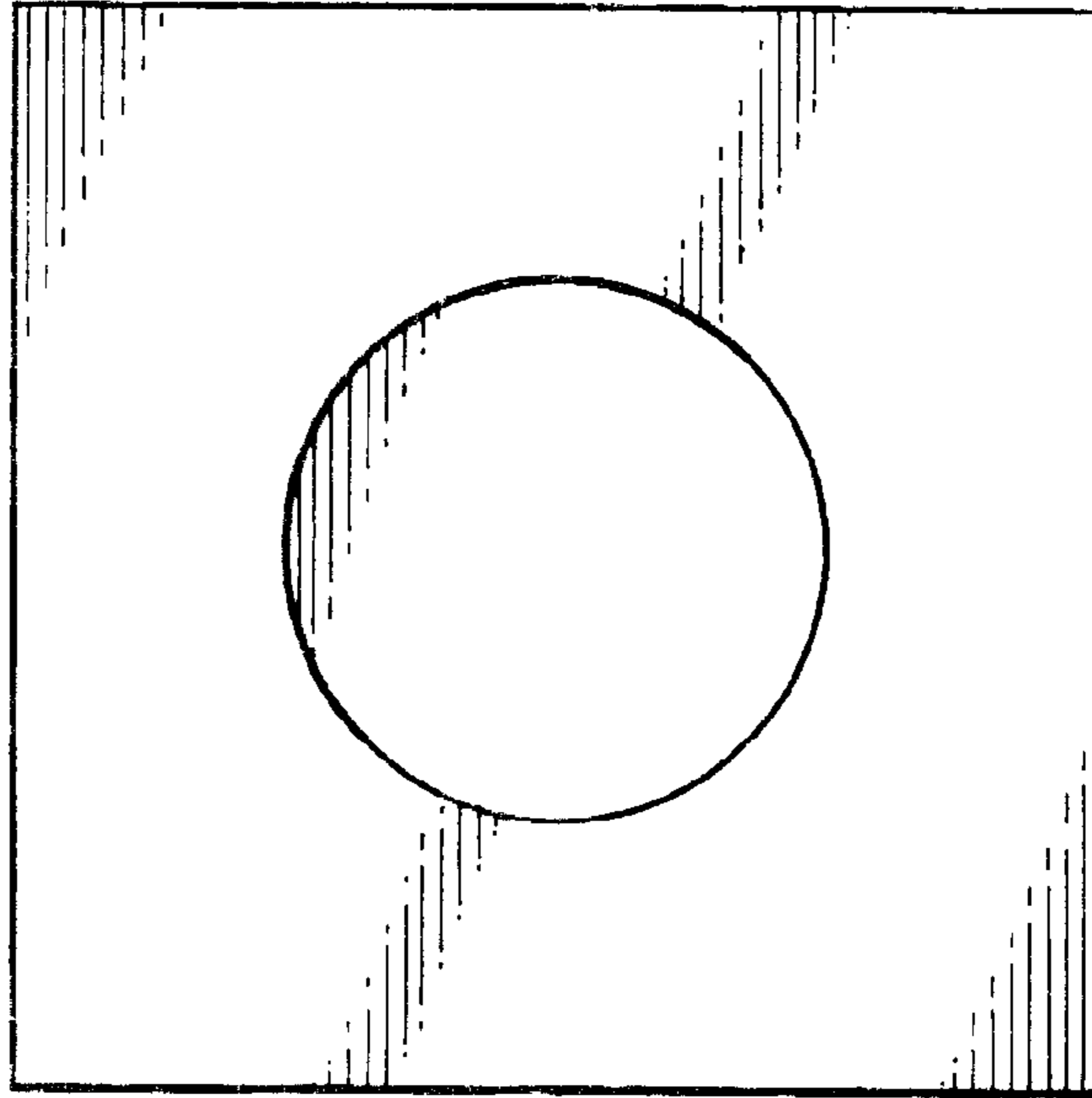

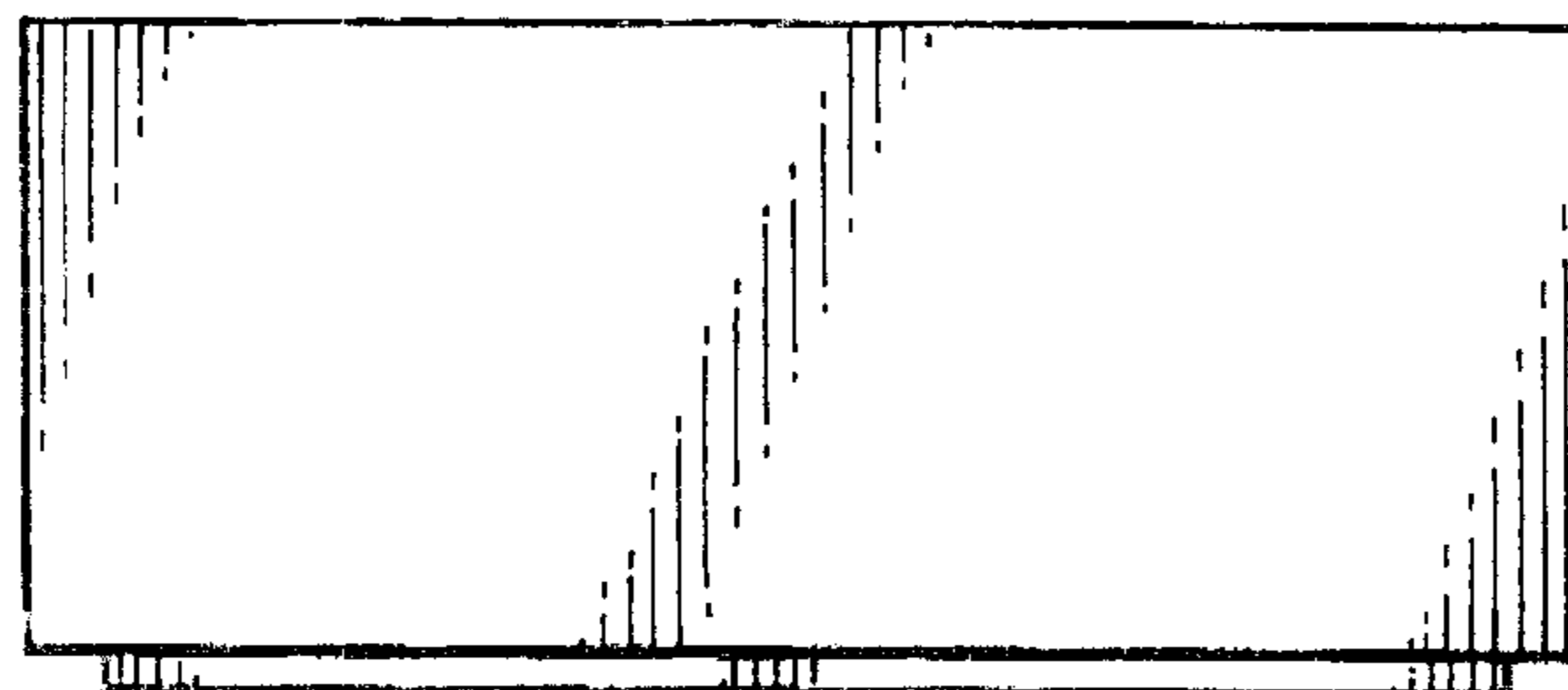

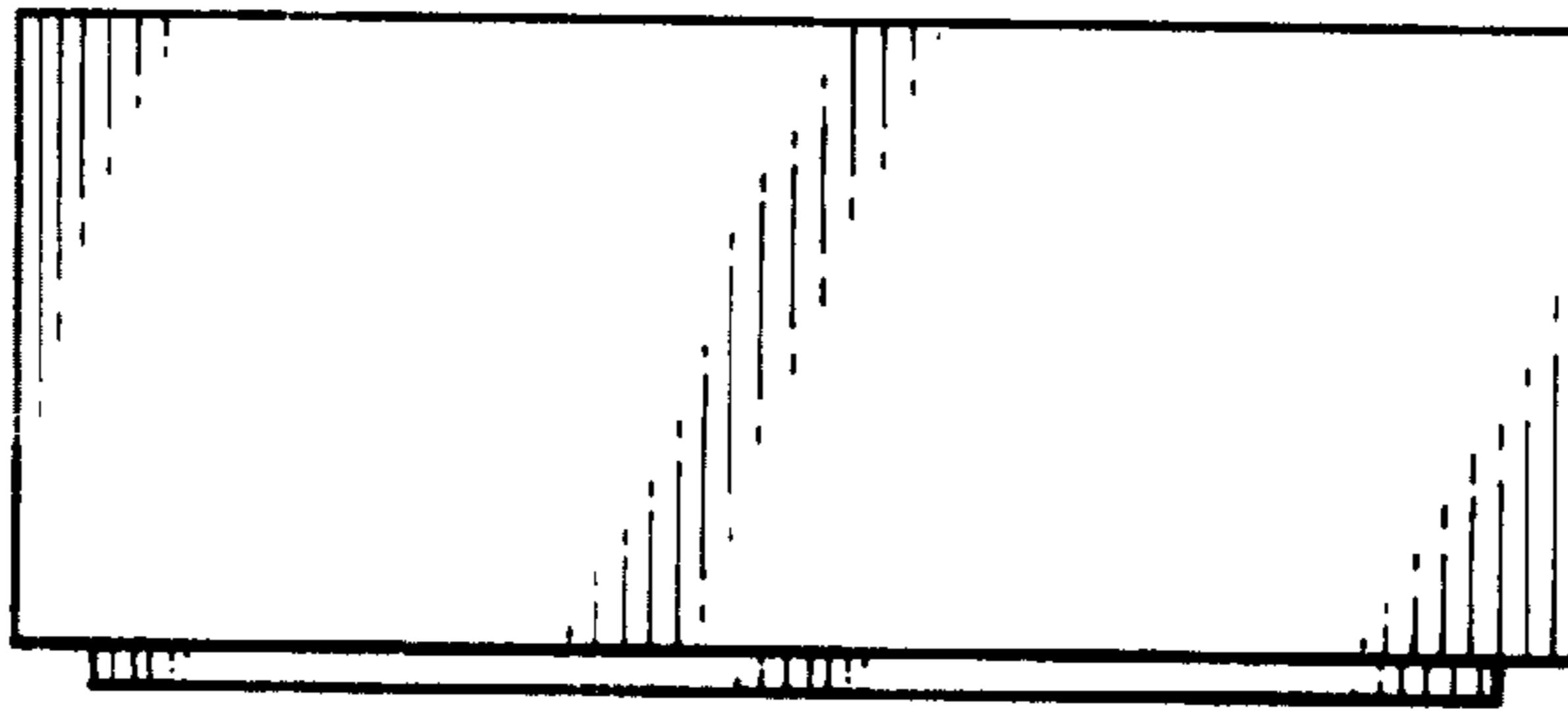

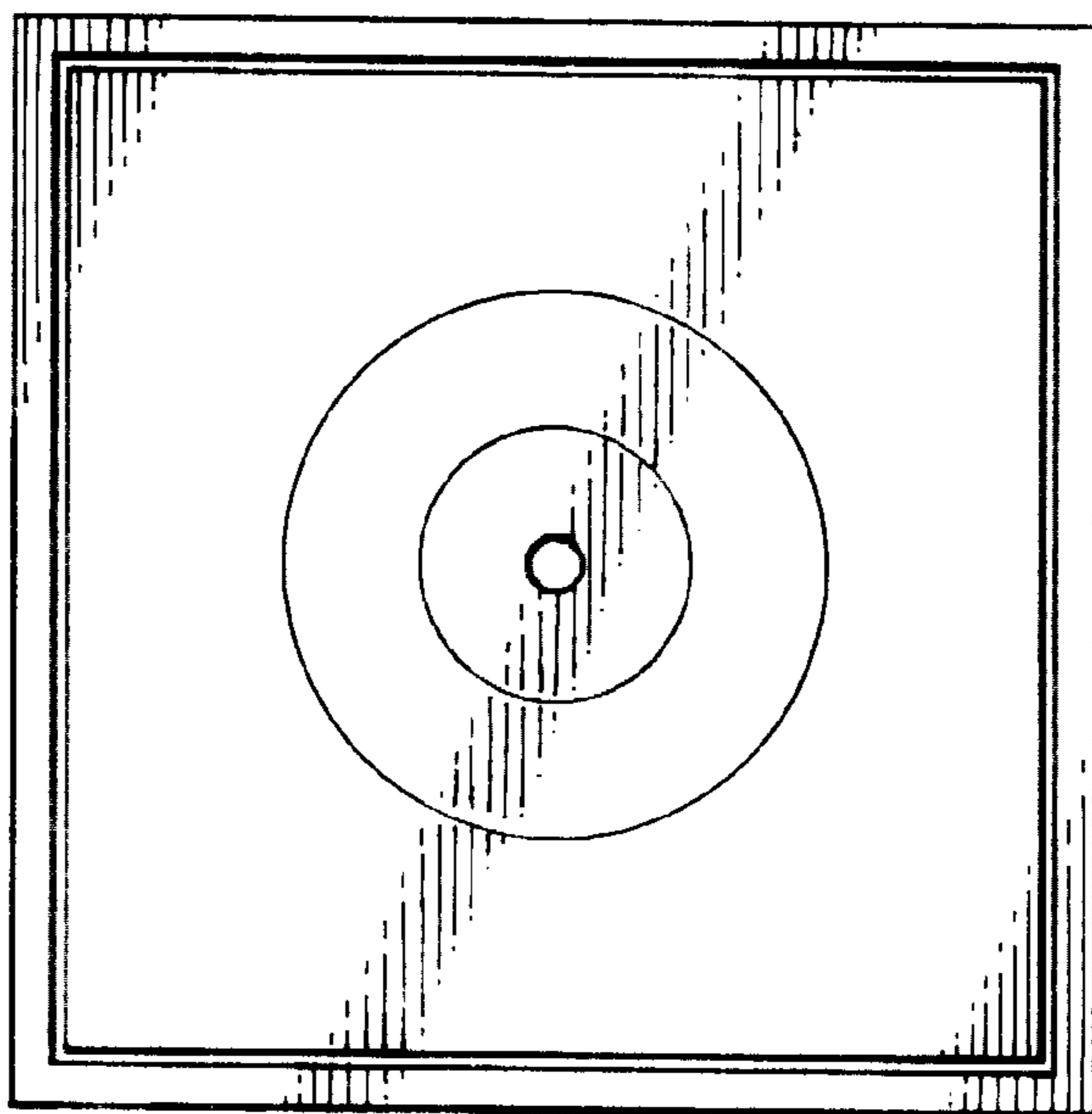

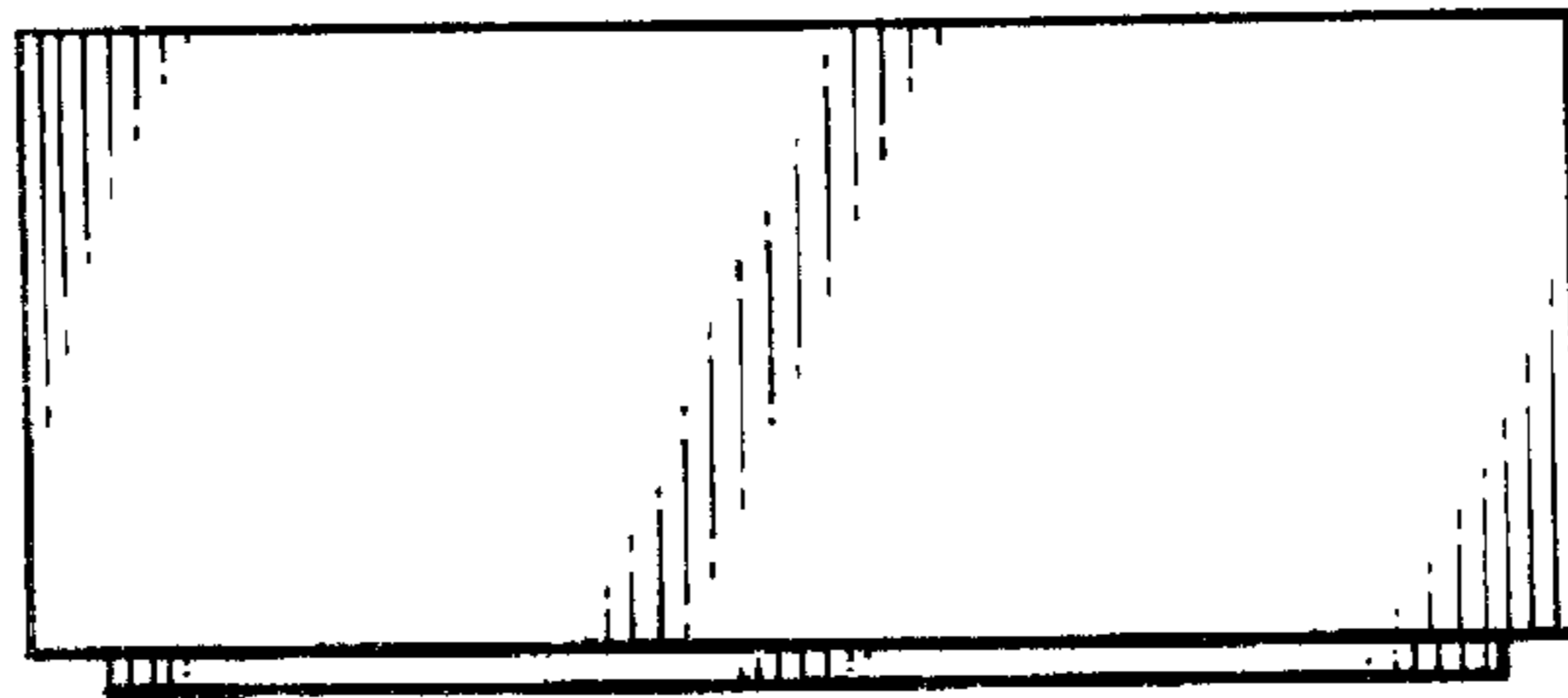

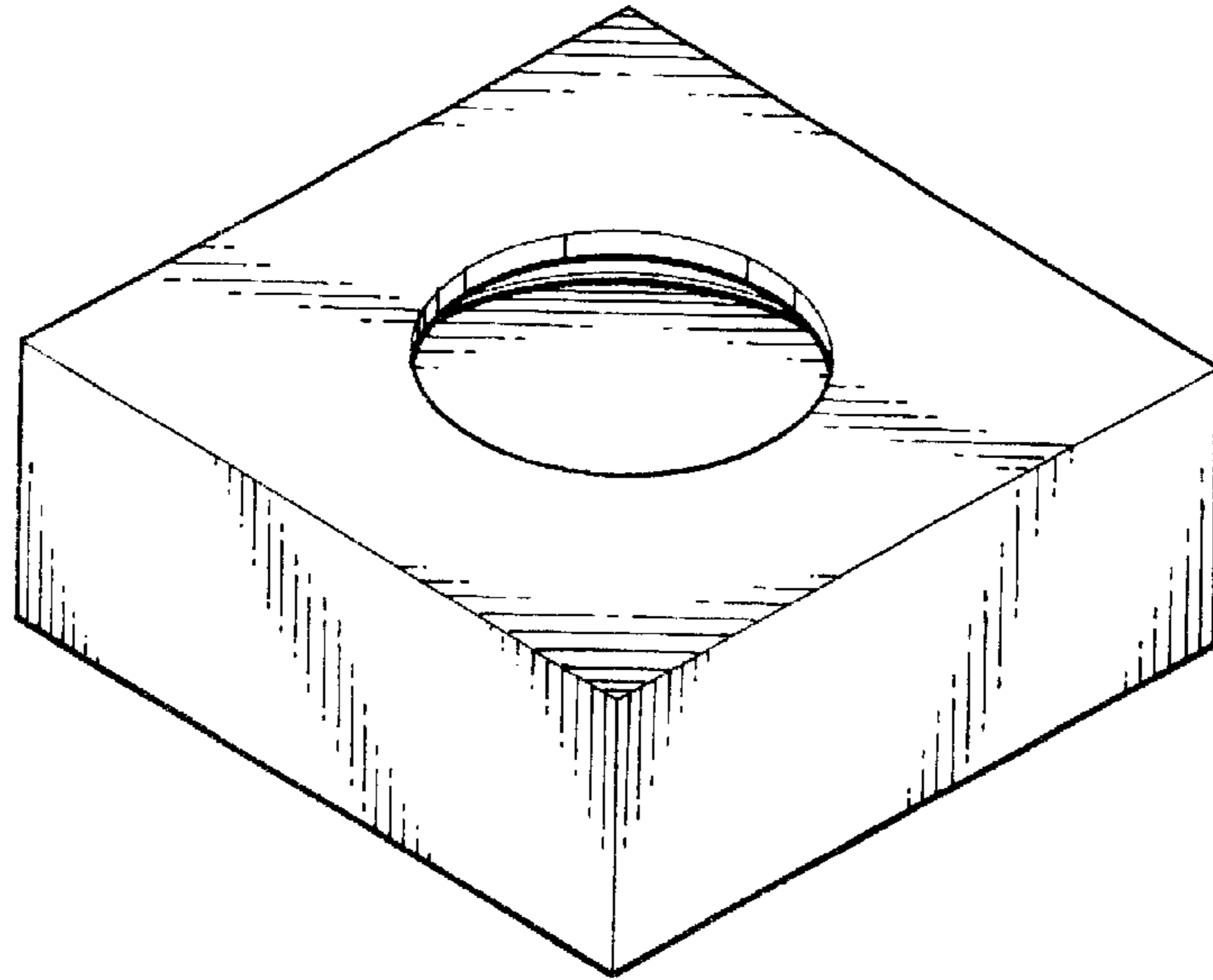
