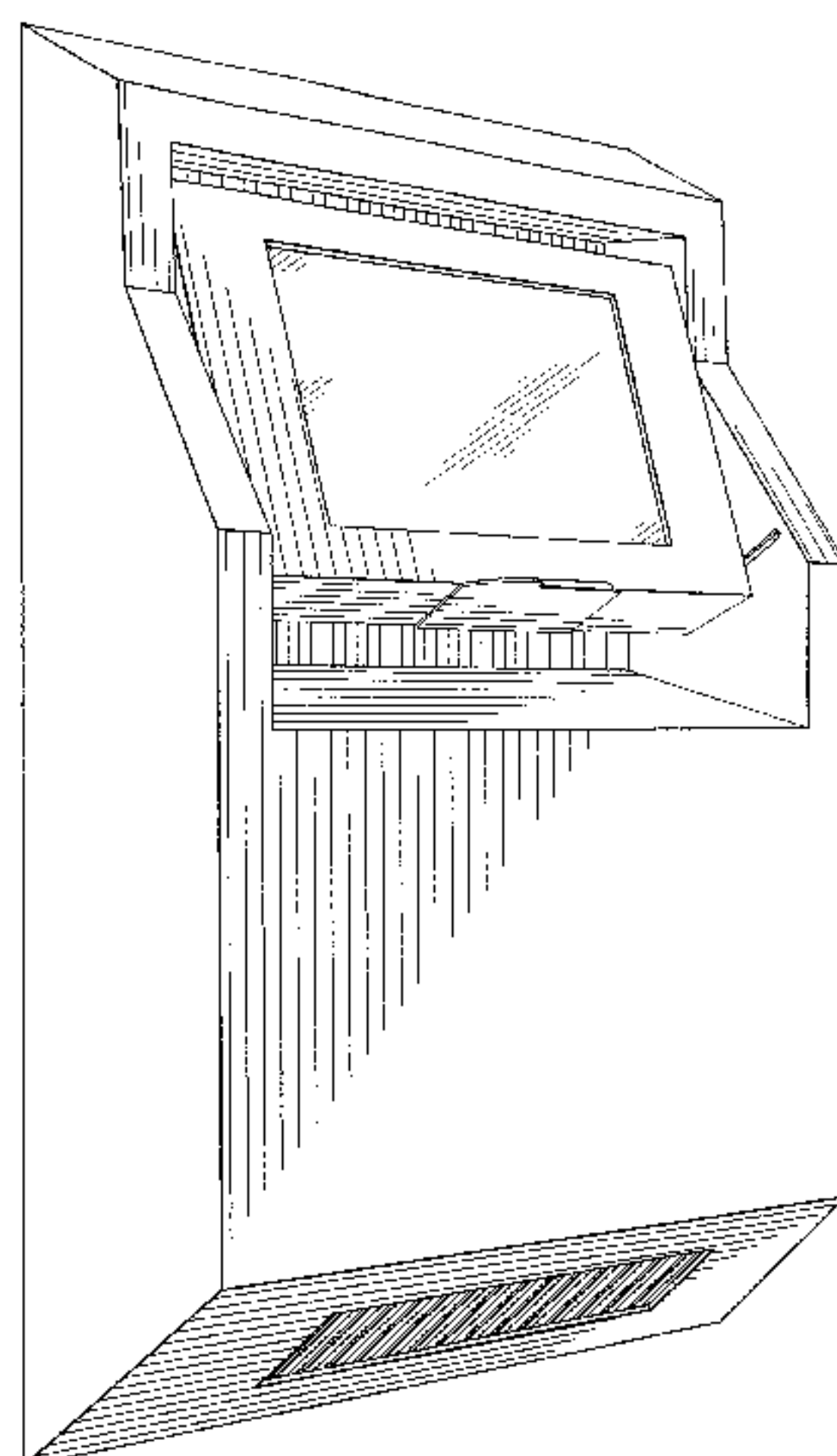
(57) **CLAIM**

I claim the ornamental design for an advertising apparatus, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an advertising apparatus according to the present design;
 FIG. 2 is a front elevational view of the advertising apparatus of FIG. 1;
 FIG. 3 is a left side elevational view of the advertising apparatus of FIG. 1;
 FIG. 4 is a right side elevational view of the advertising apparatus of FIG. 1;
 FIG. 5 is a top plan view of the advertising apparatus of FIG. 1;
 FIG. 6 is a bottom plan view of the advertising apparatus of FIG. 1;
 FIG. 7 is a perspective view of a second variant of the advertising apparatus according to the present design;
 FIG. 8 is a front elevational view of the advertising apparatus of FIG. 7;
 FIG. 9 is a left side elevational view of the advertising apparatus of FIG. 7;
 FIG. 10 is a right side elevational view of the advertising apparatus of FIG. 7;

 FIG. 12 is a bottom plan view of the advertising apparatus of FIG. 7;
 FIG. 13 is a perspective view of a third variant of the advertising apparatus according to the present design;

 FIG. 16 is a right side elevational view of the advertising apparatus of FIG. 13;

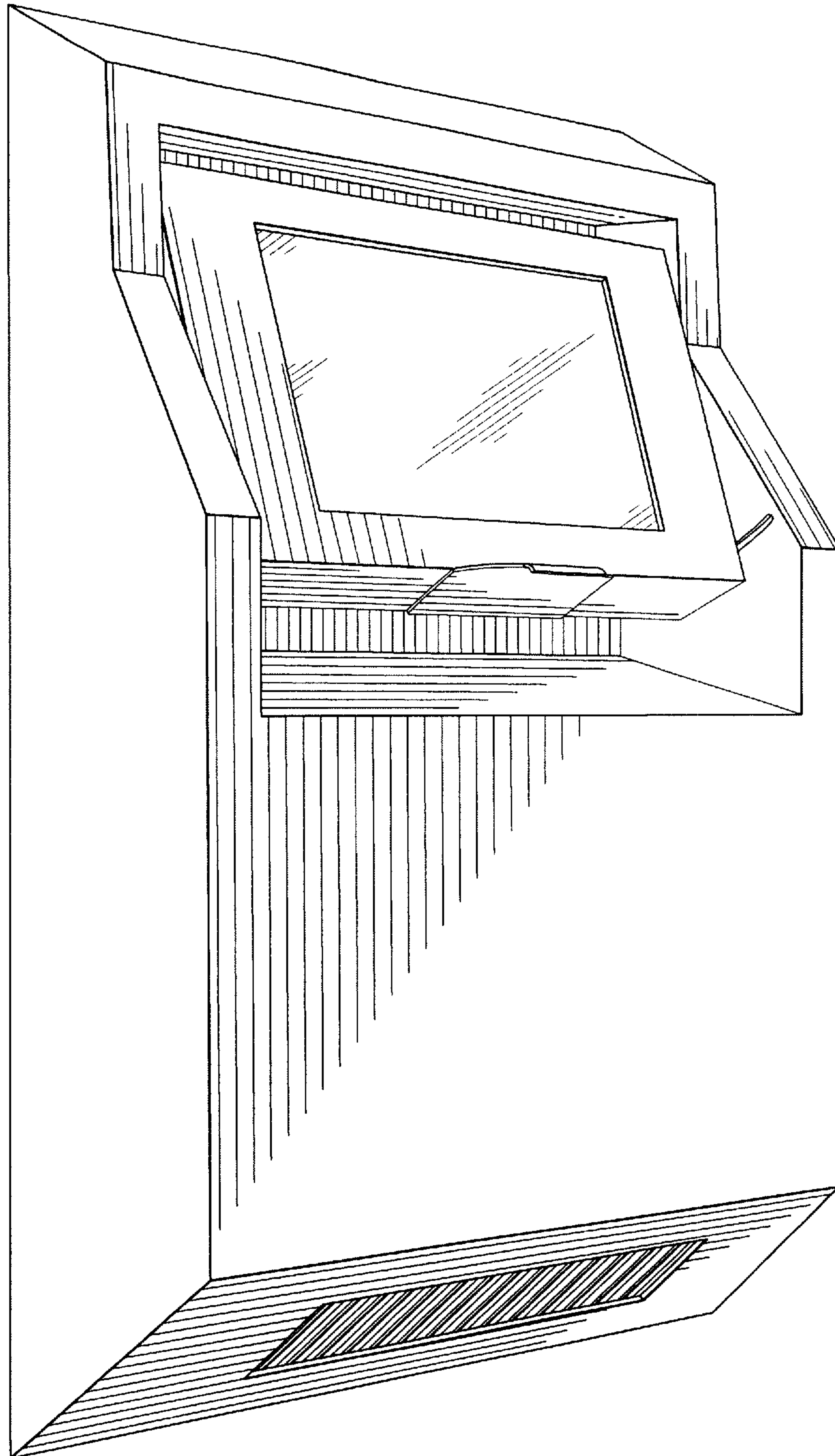

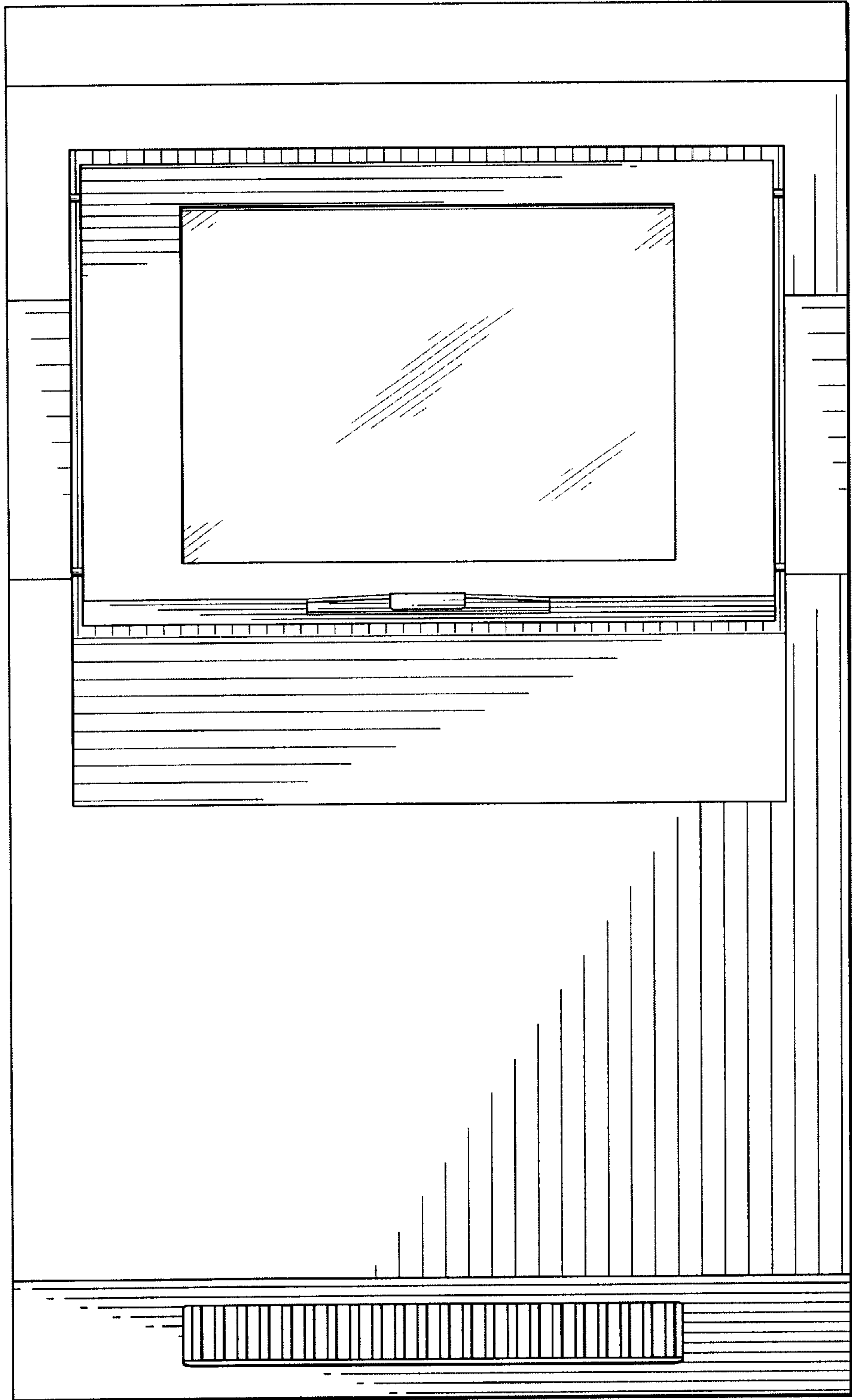

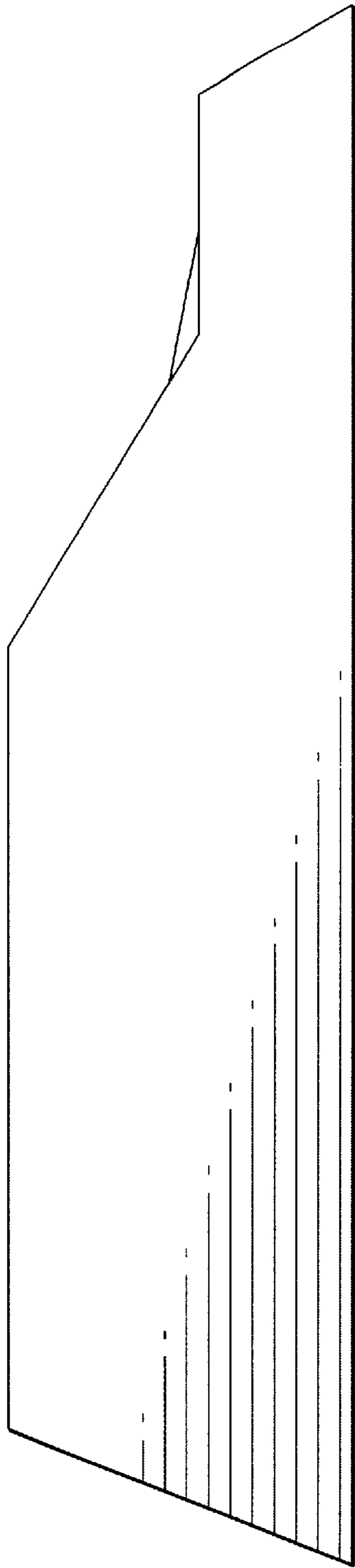

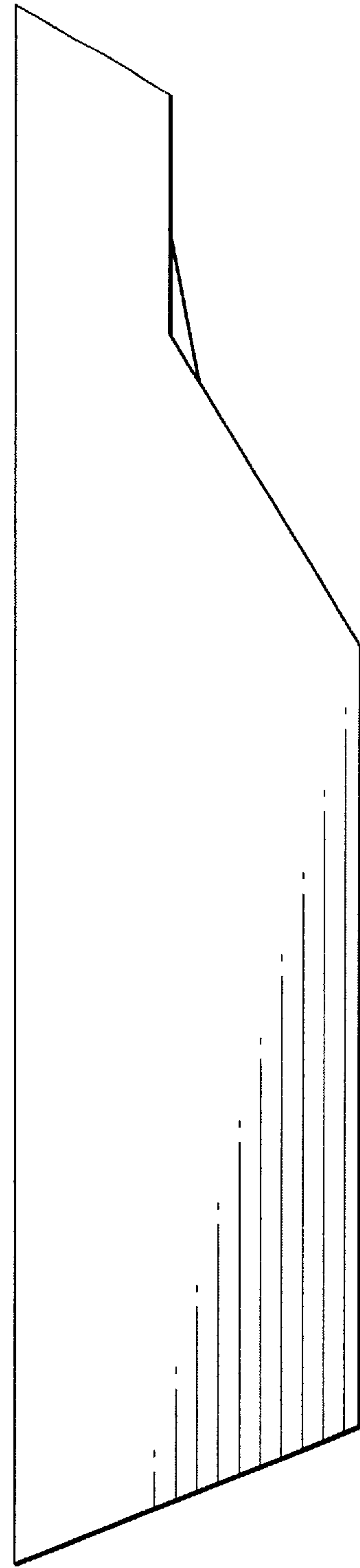

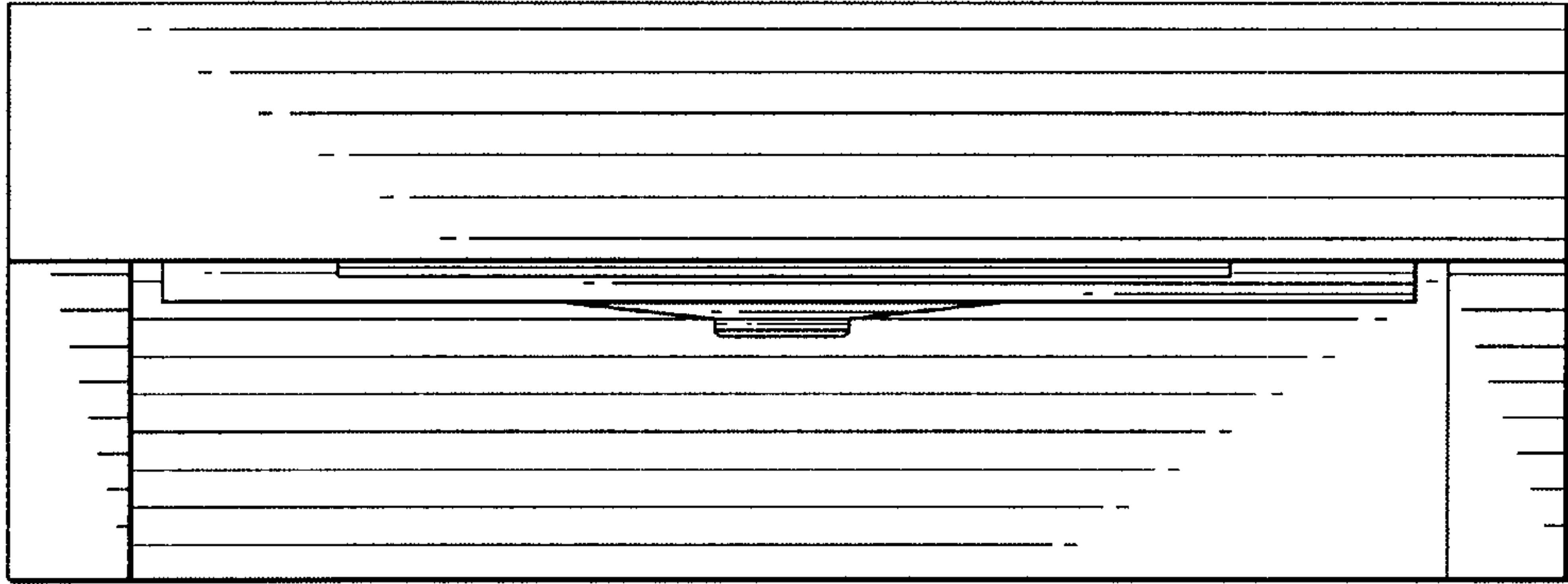

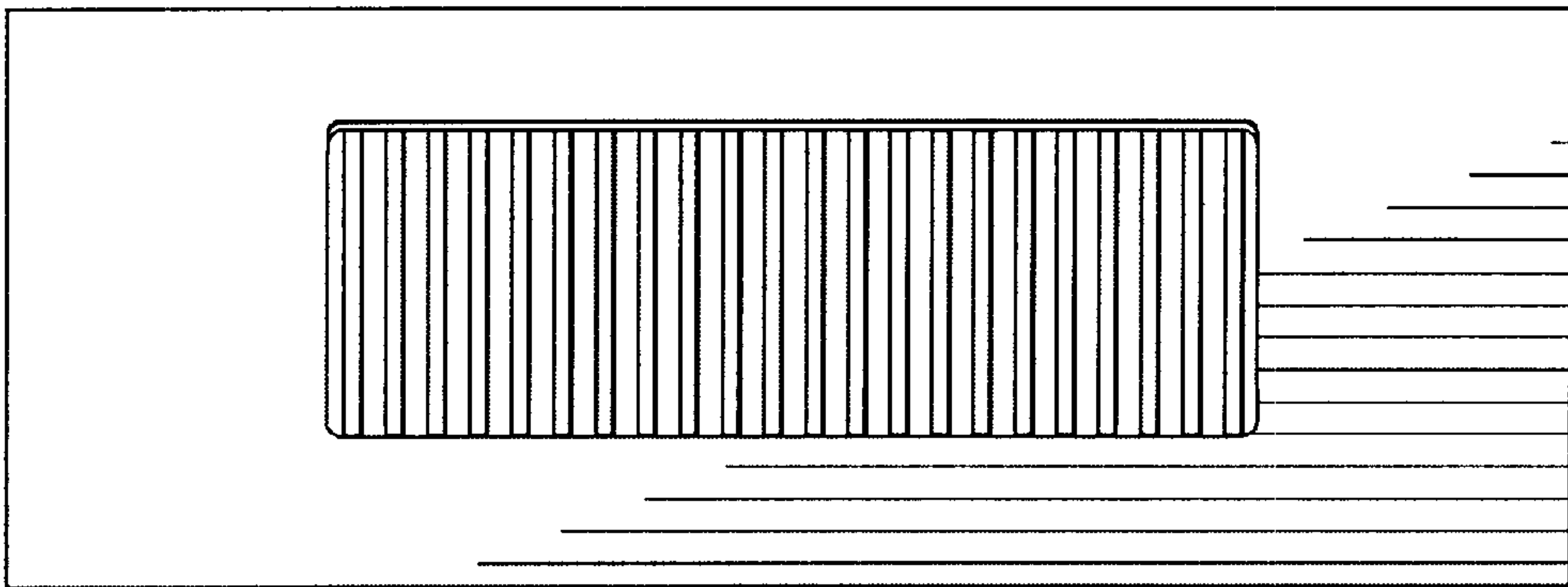

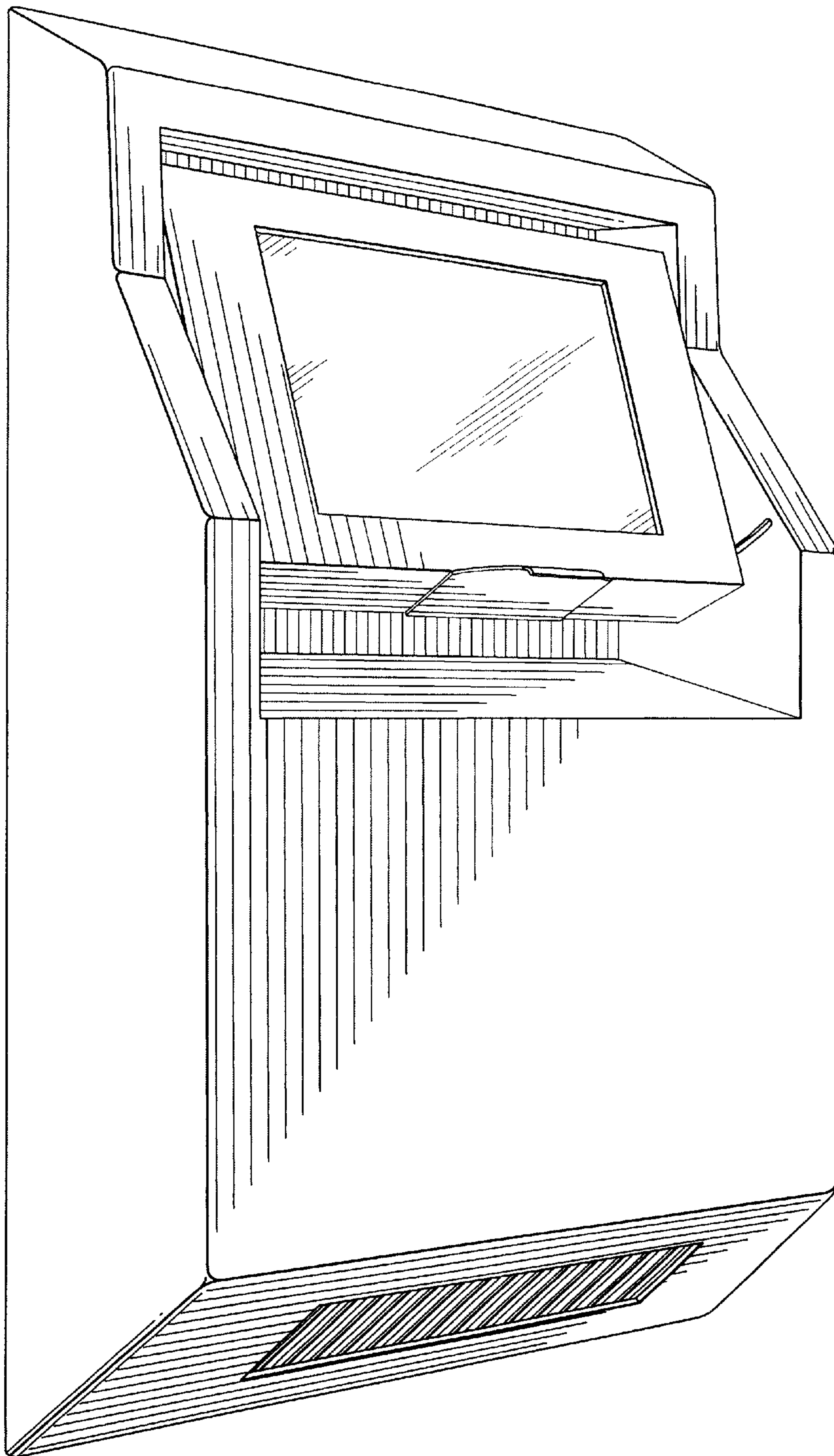

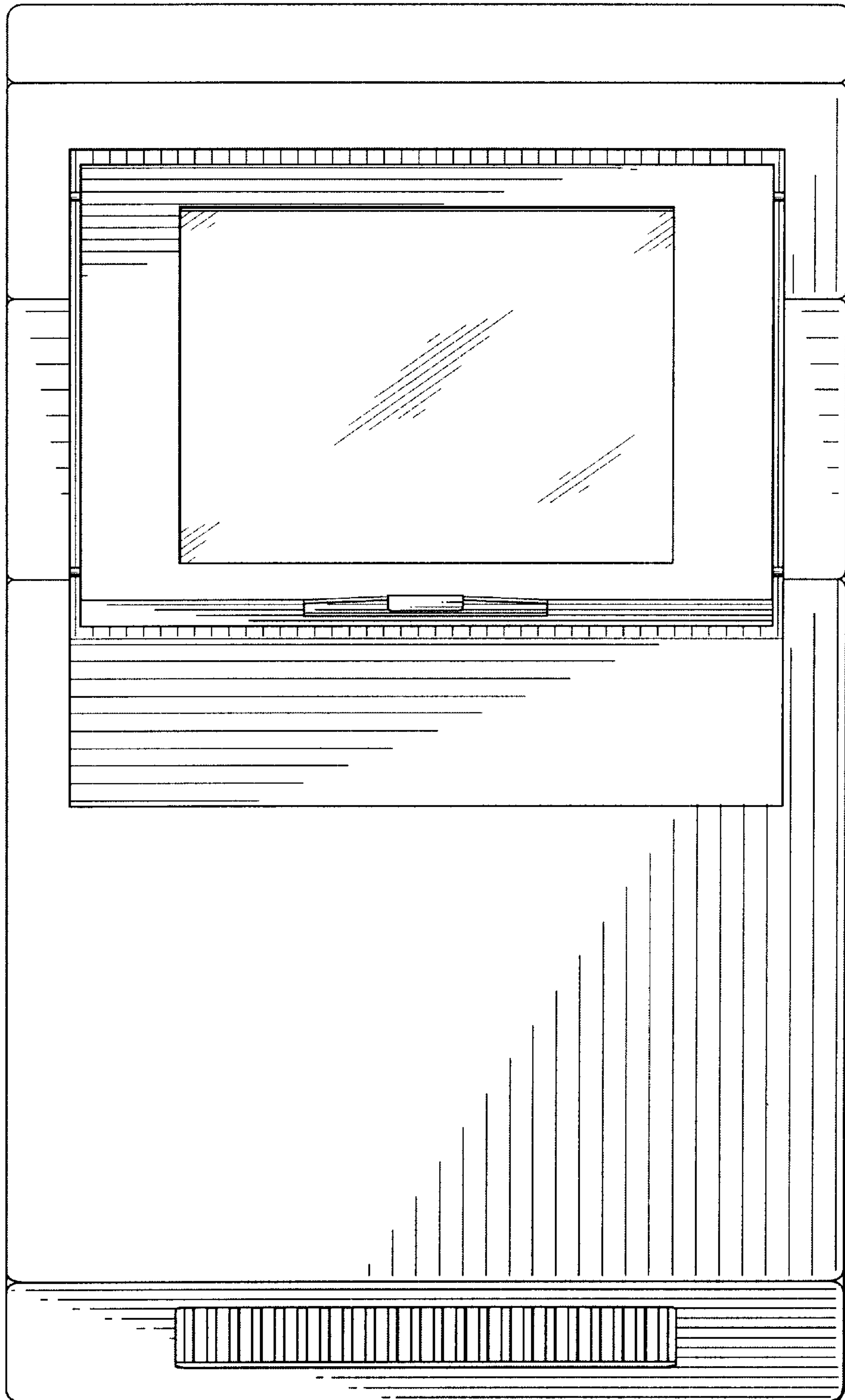

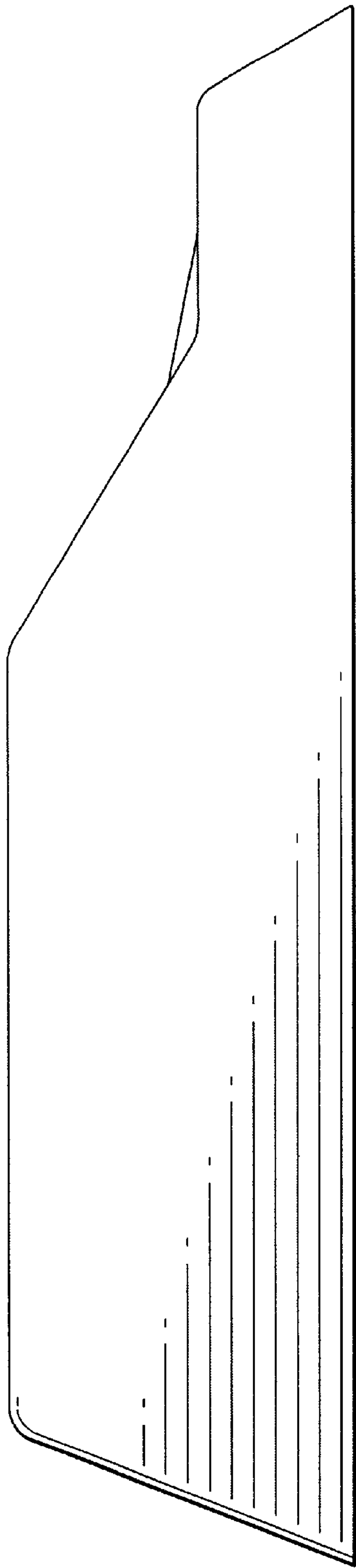

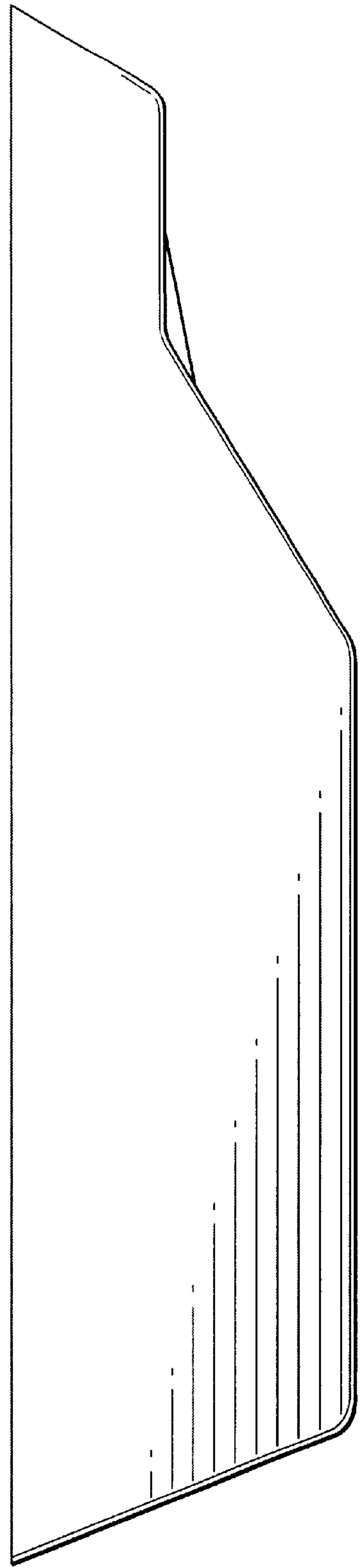

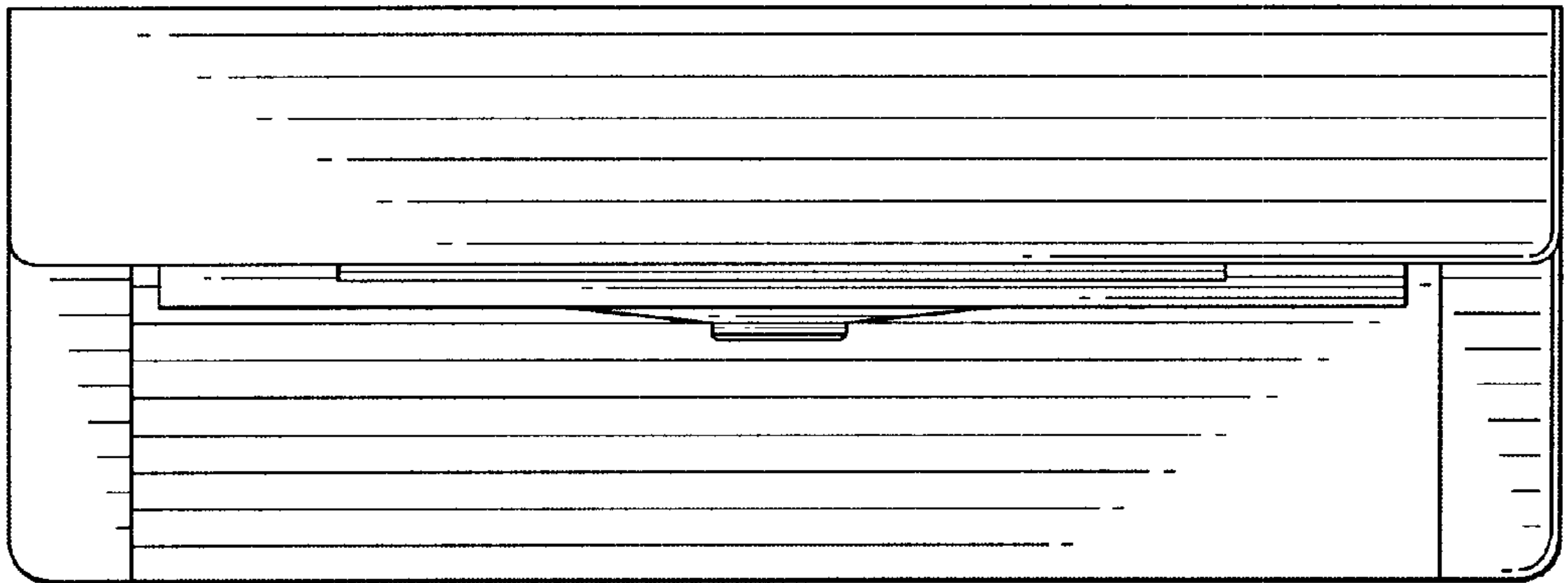

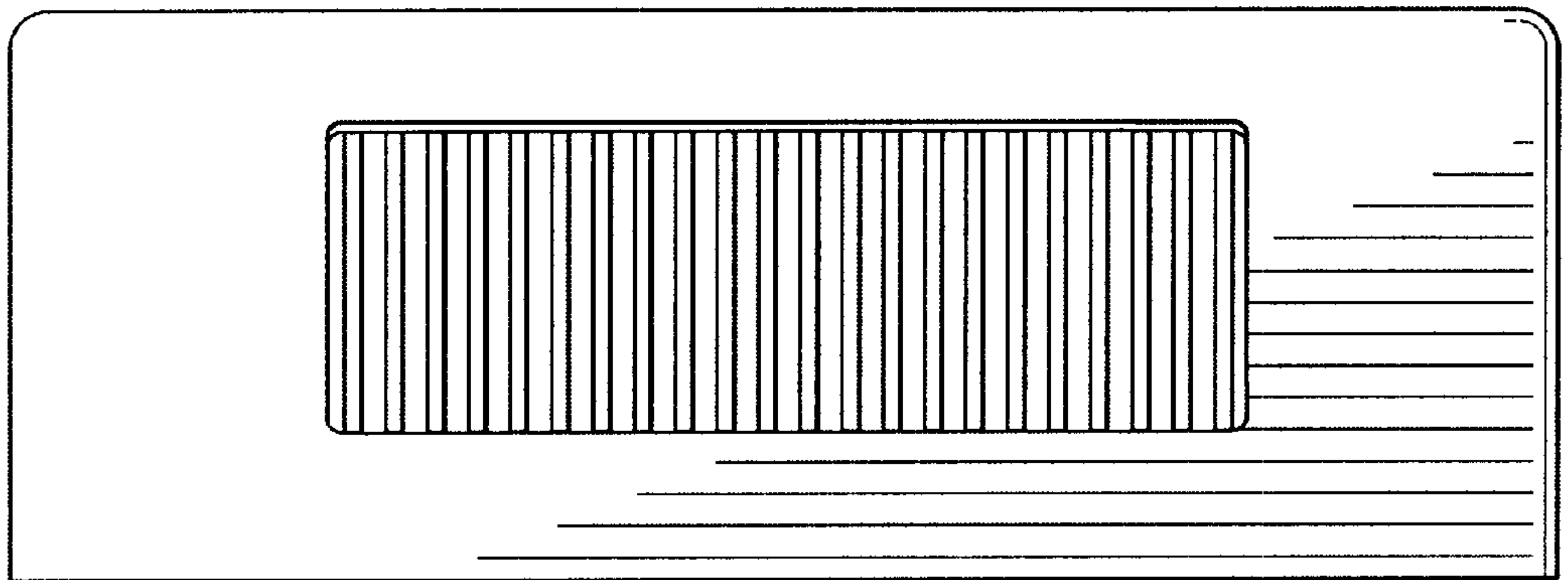

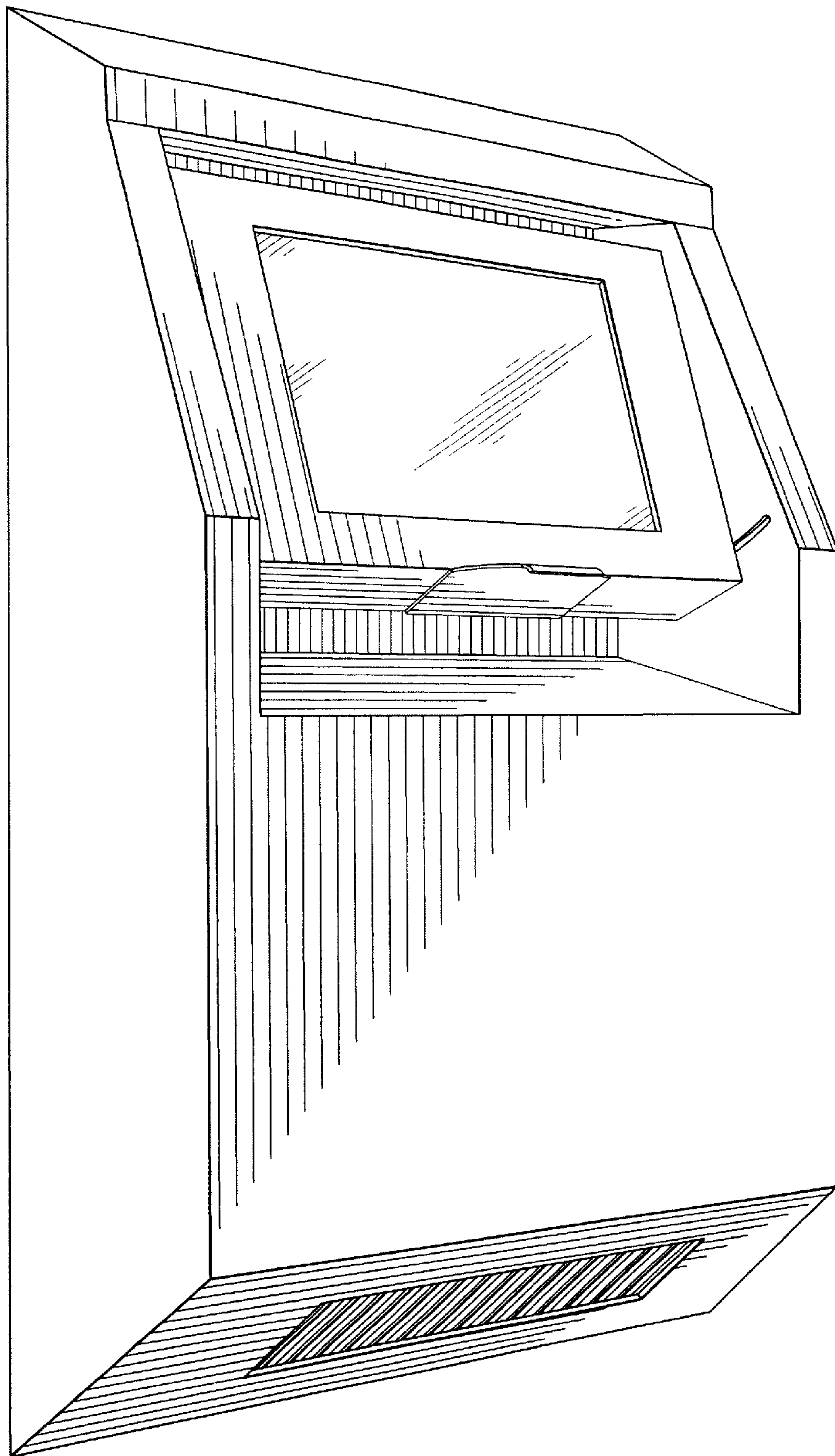

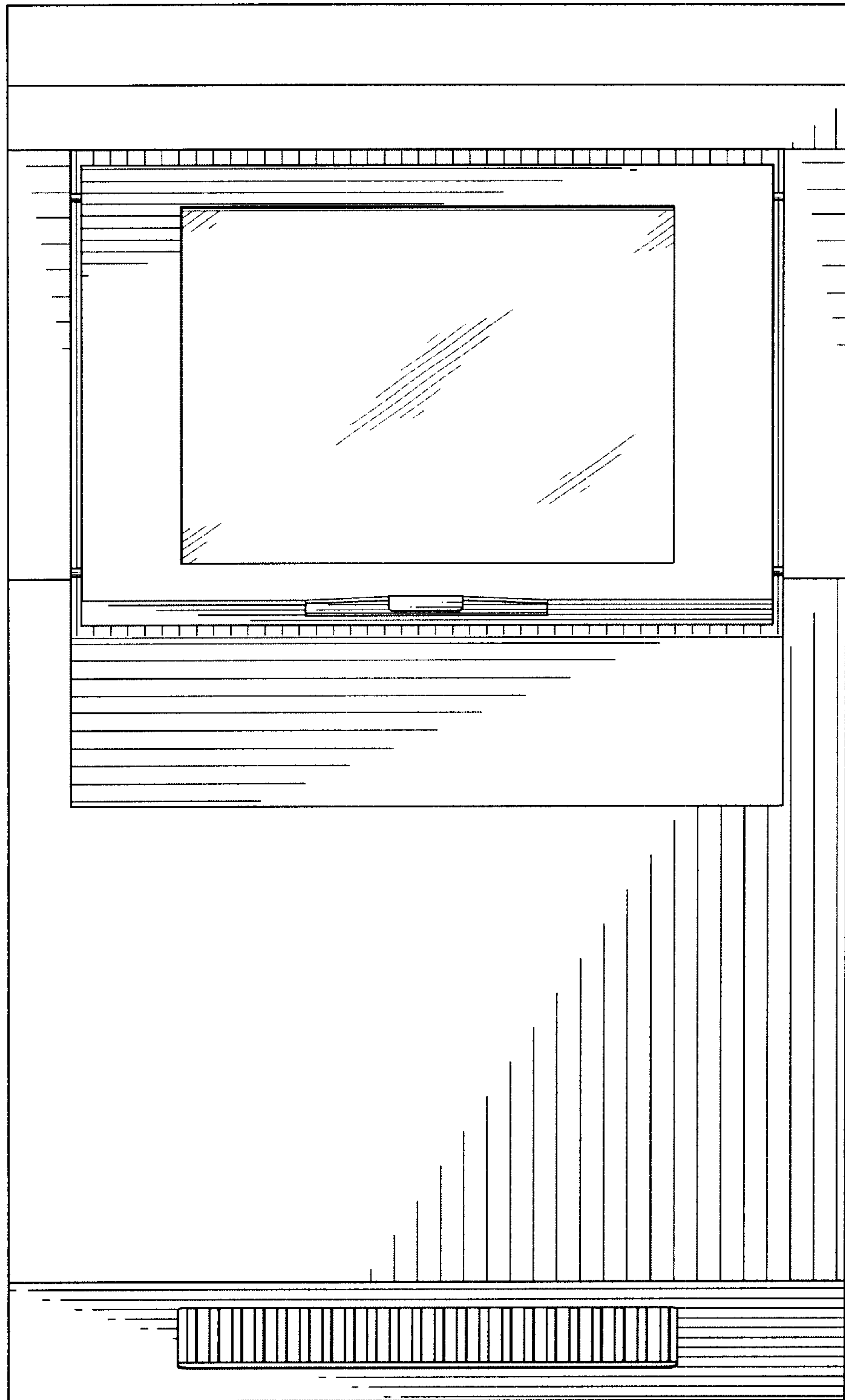

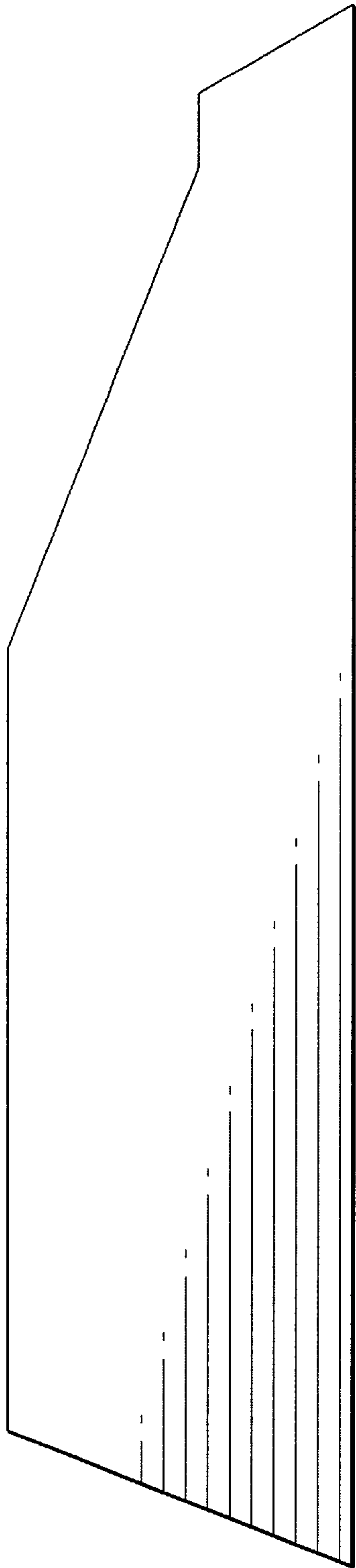

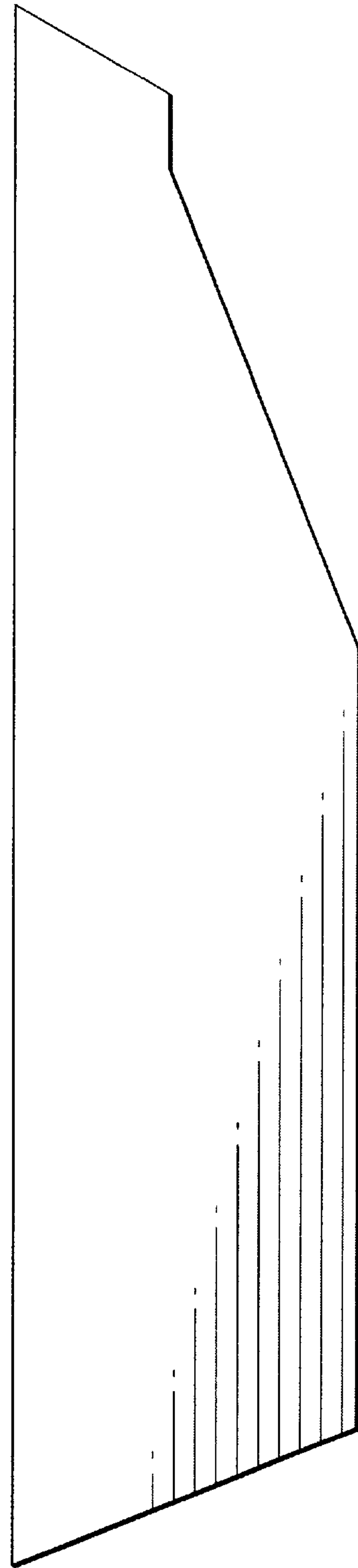

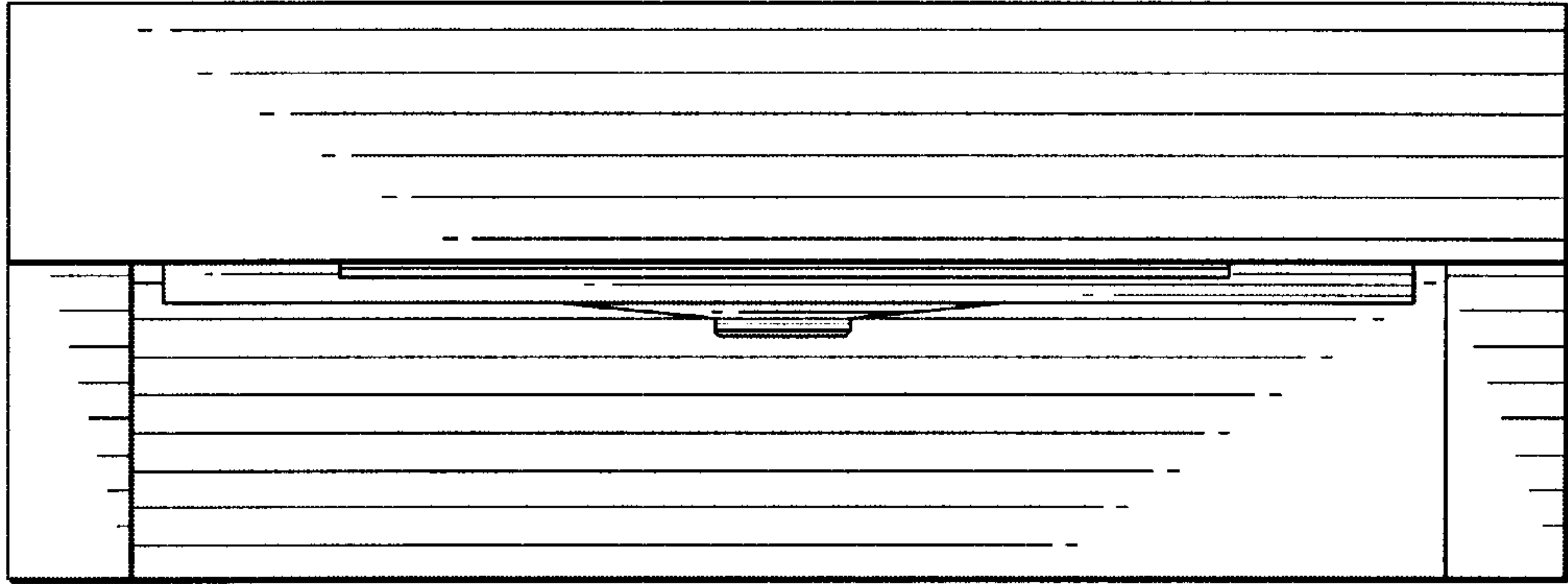

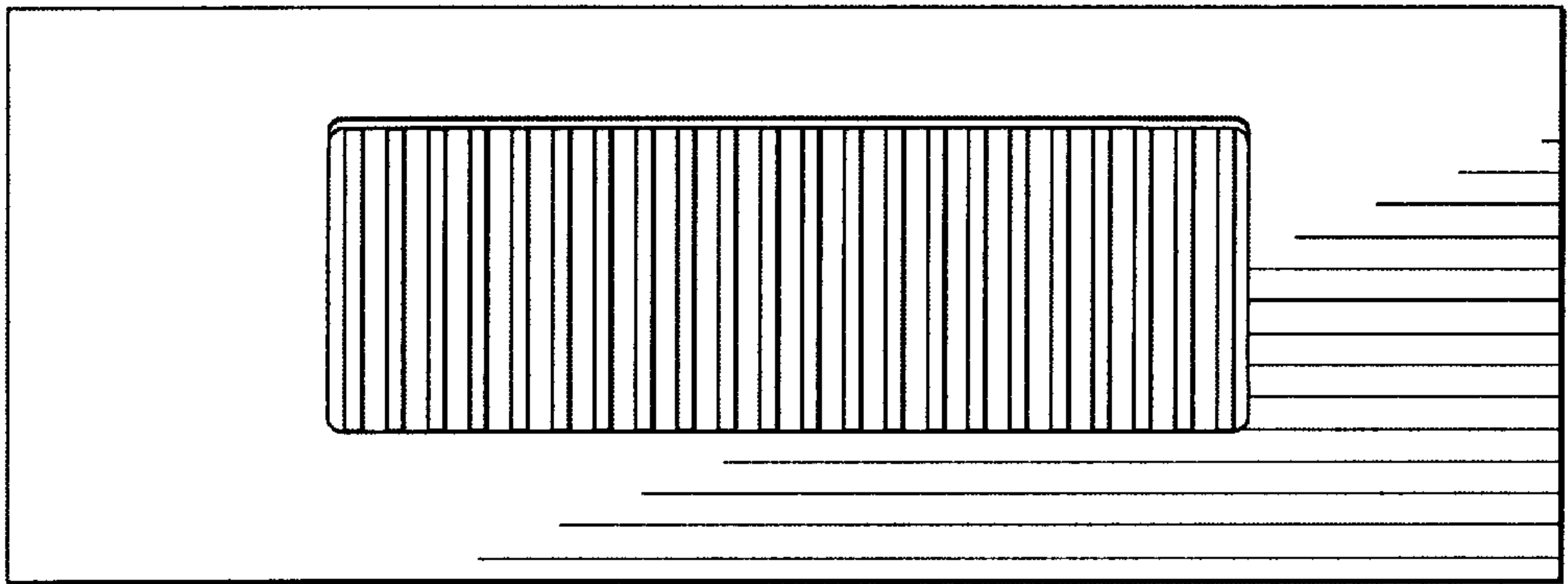
