FIG. 6 is a bottom plan view thereof;

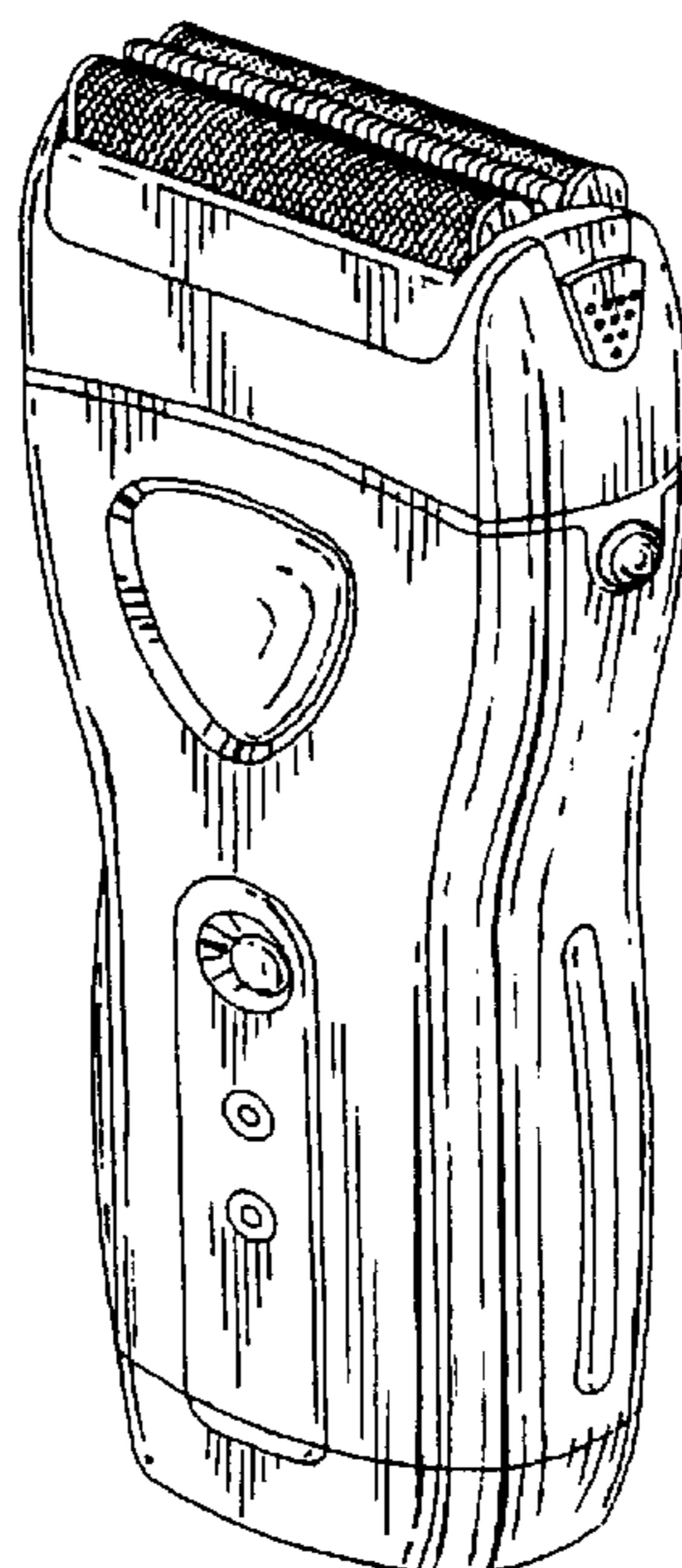
FIG. 7 is a cross-section view thereof taken along the line 7-7 in FIG. 2; and,

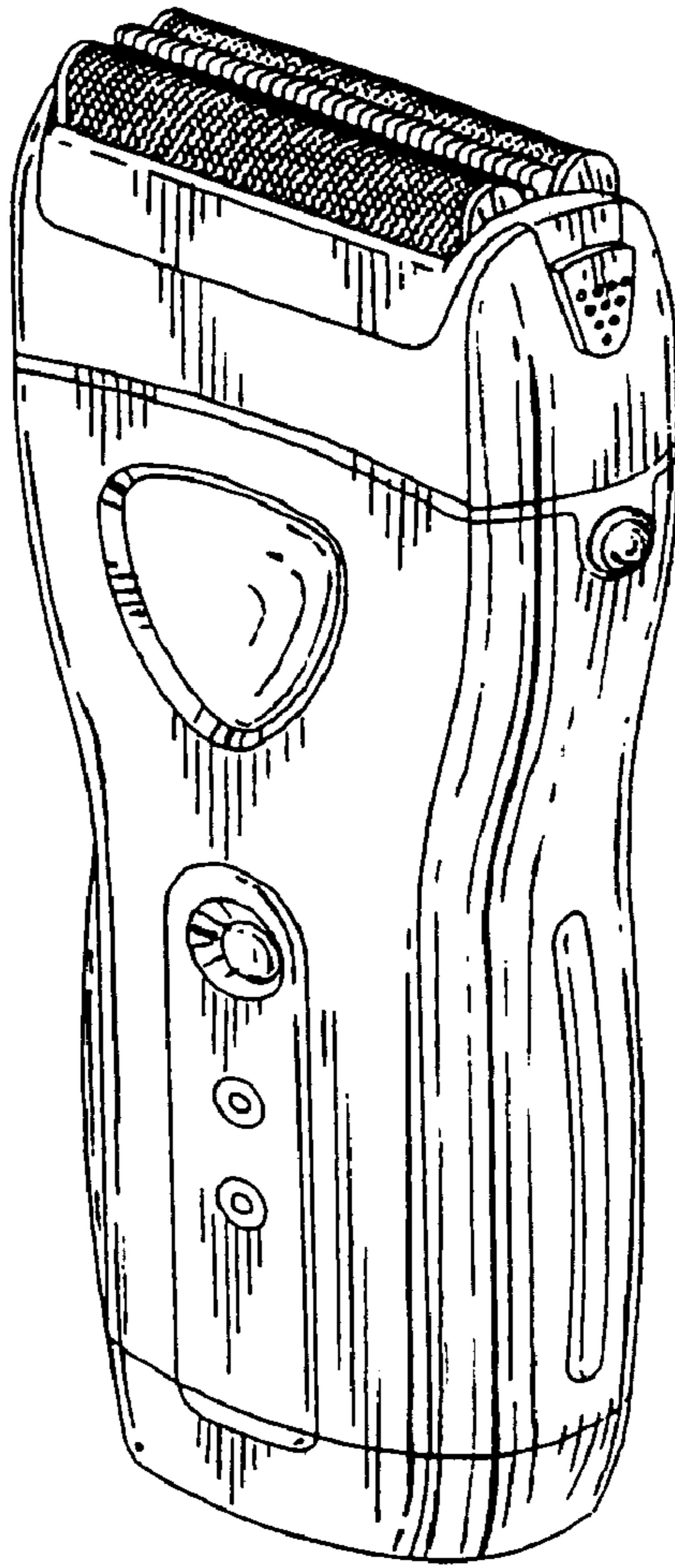
FIG. 8 is a cross-sectional view thereof taken along the line 8-8 in FIG. 2.

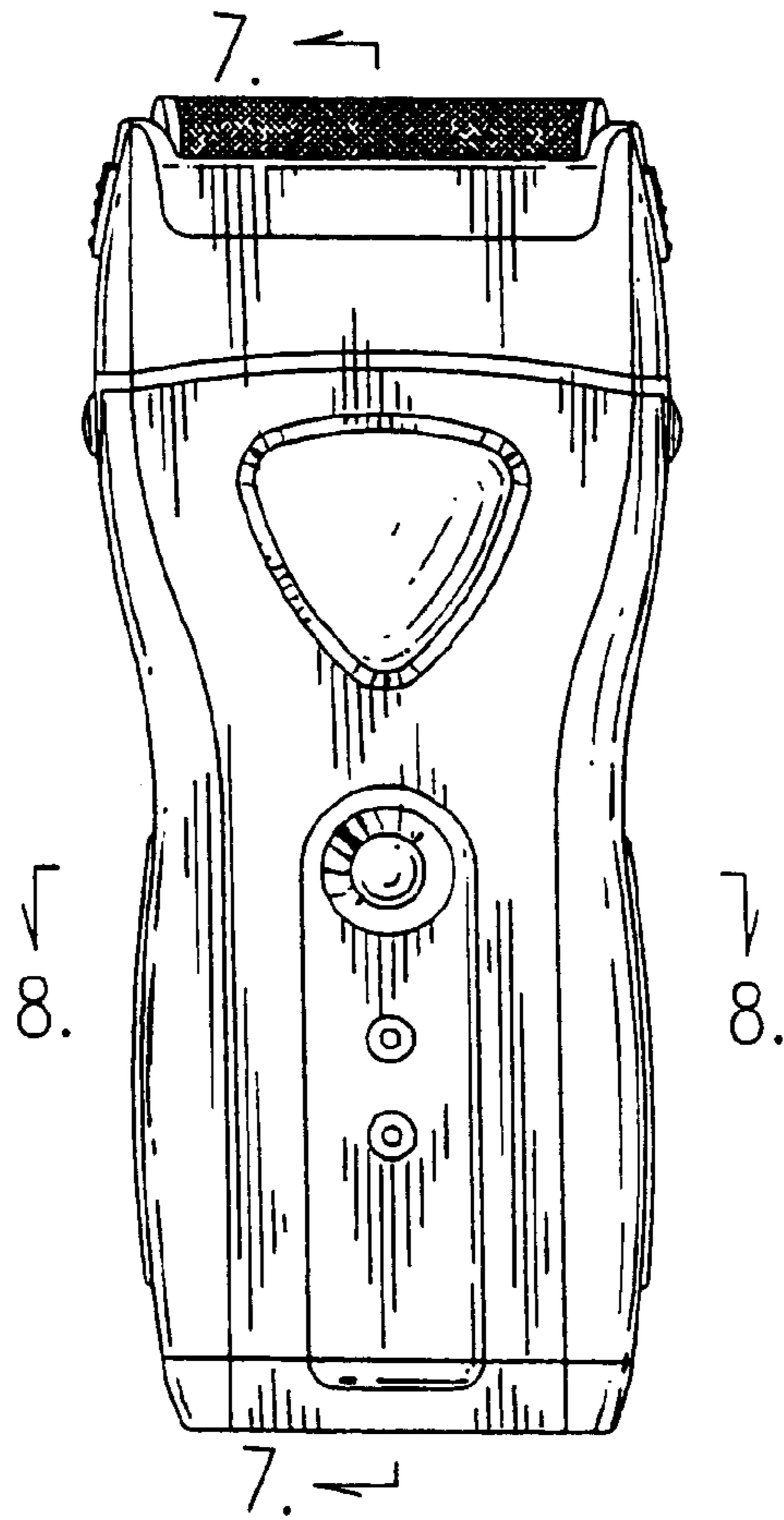

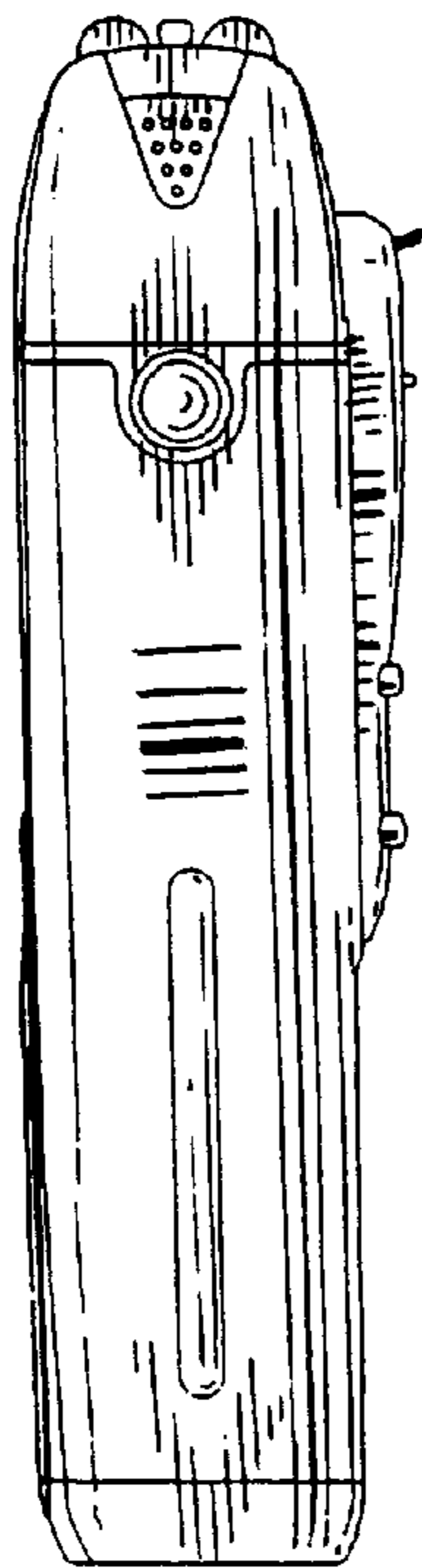




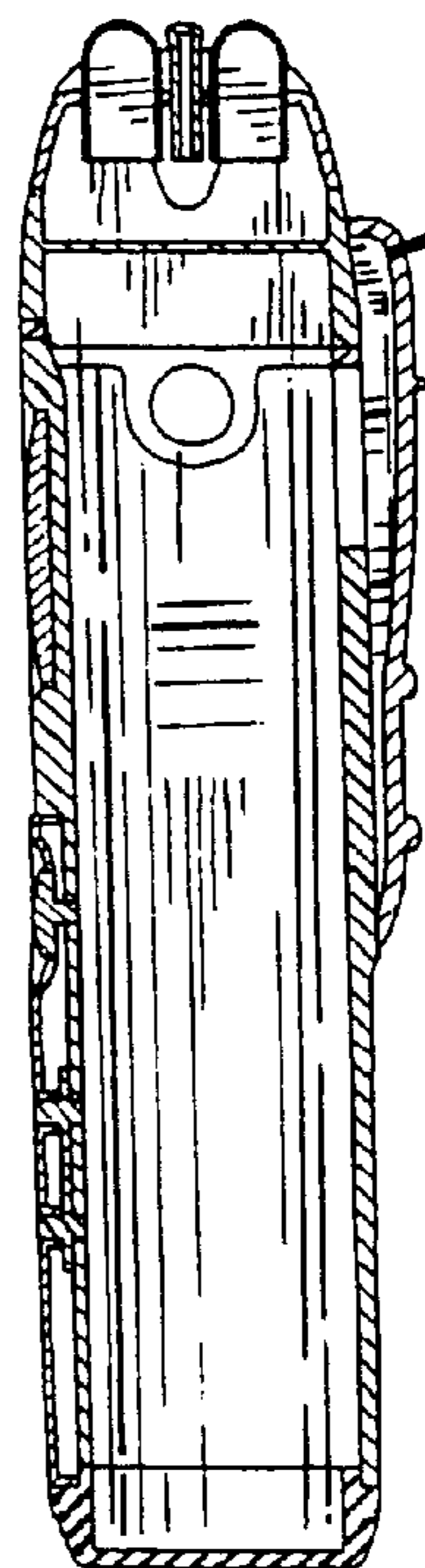

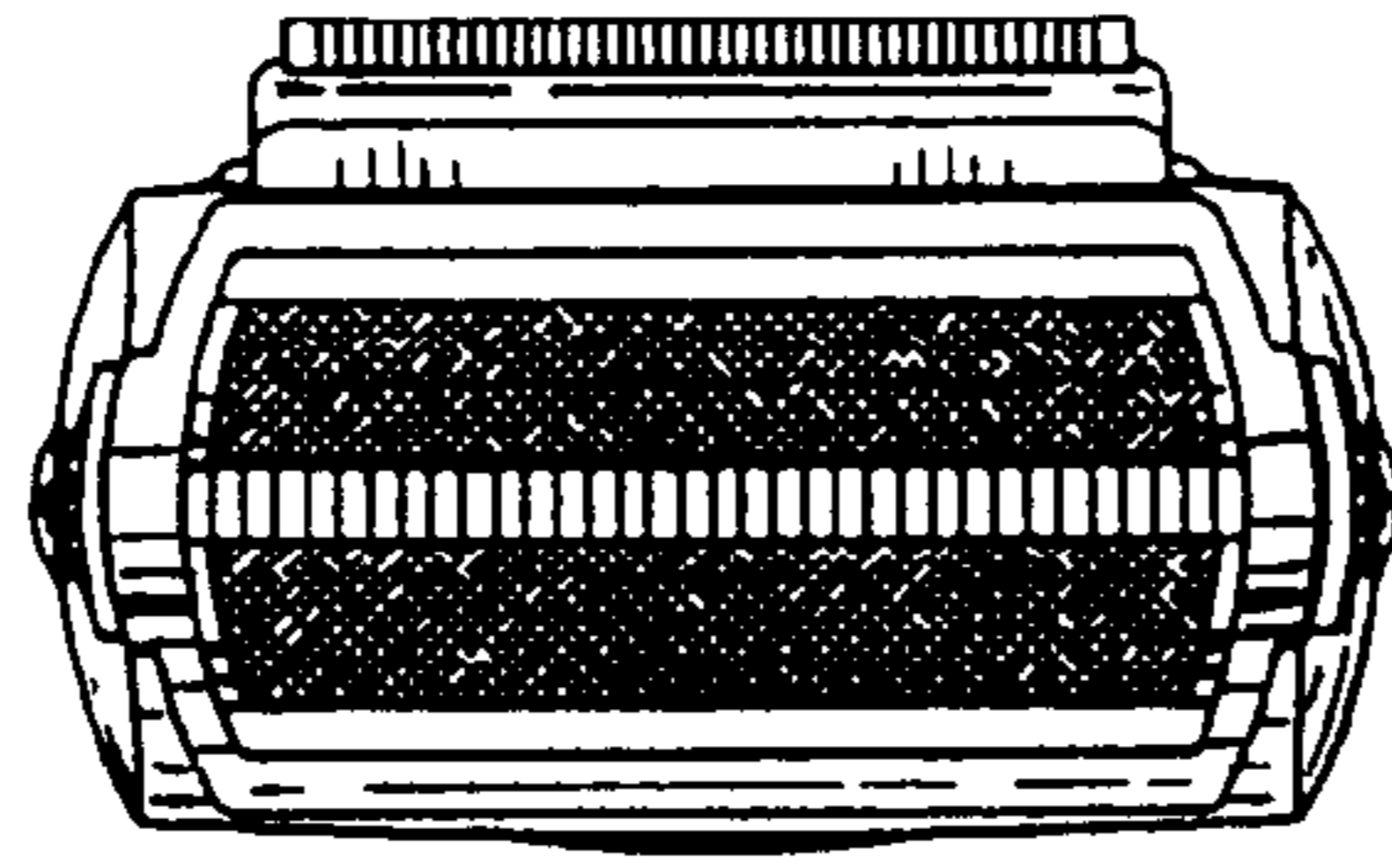

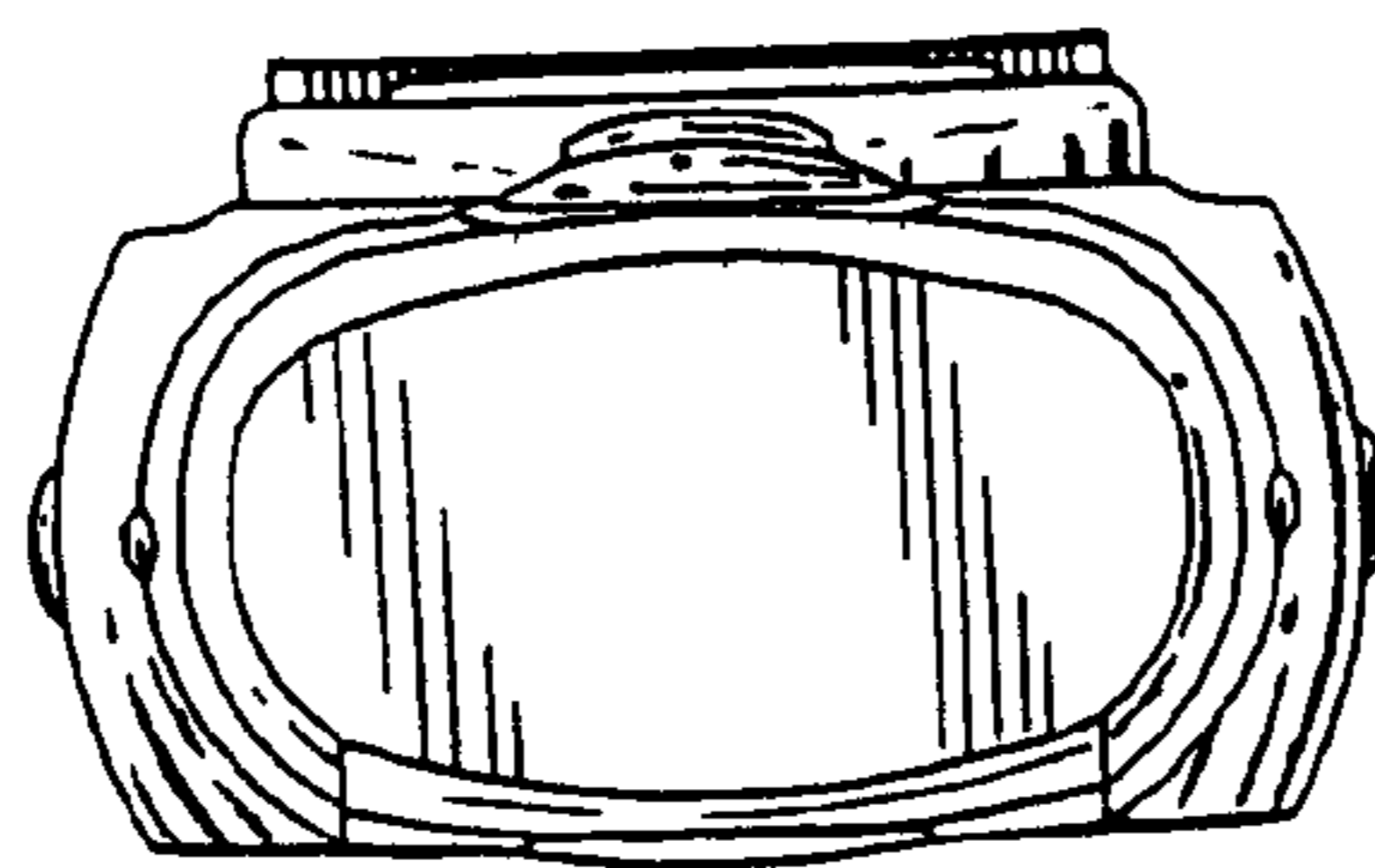

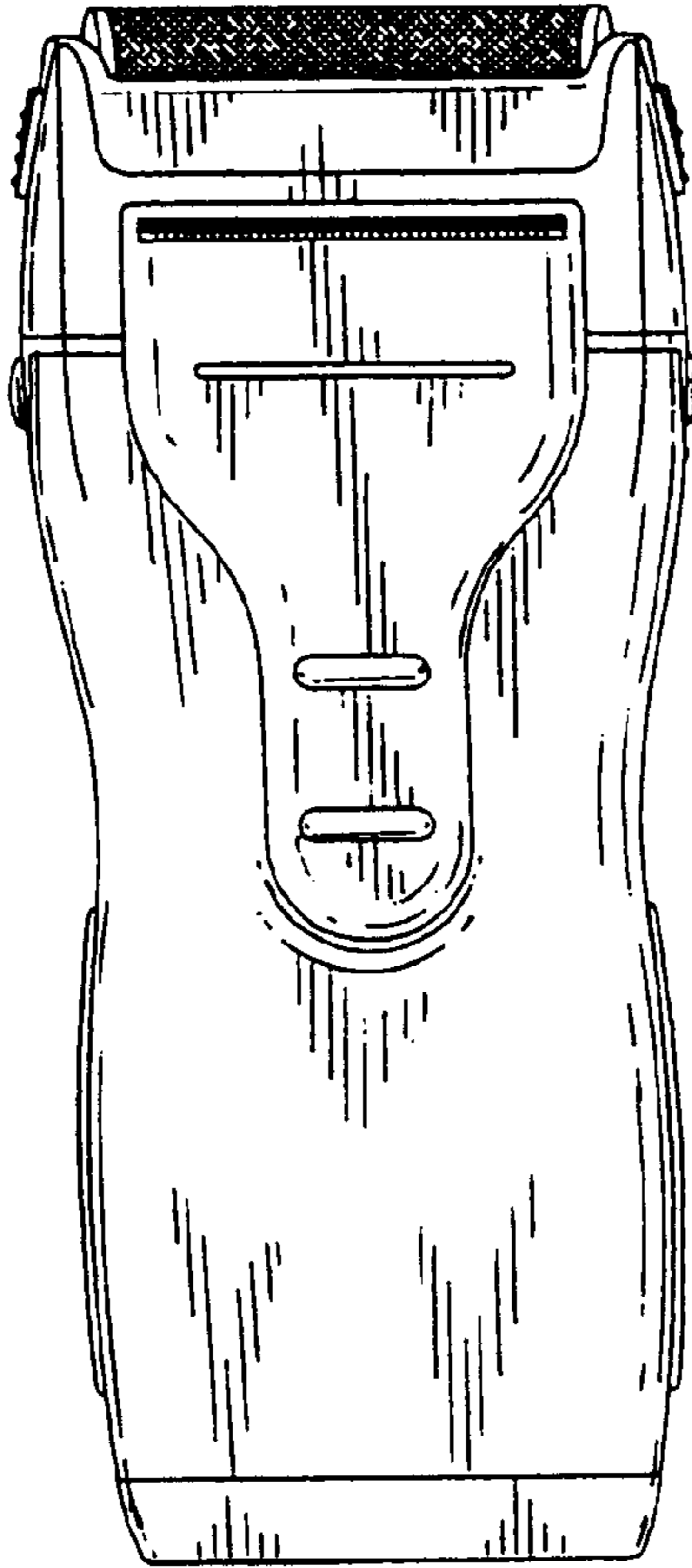

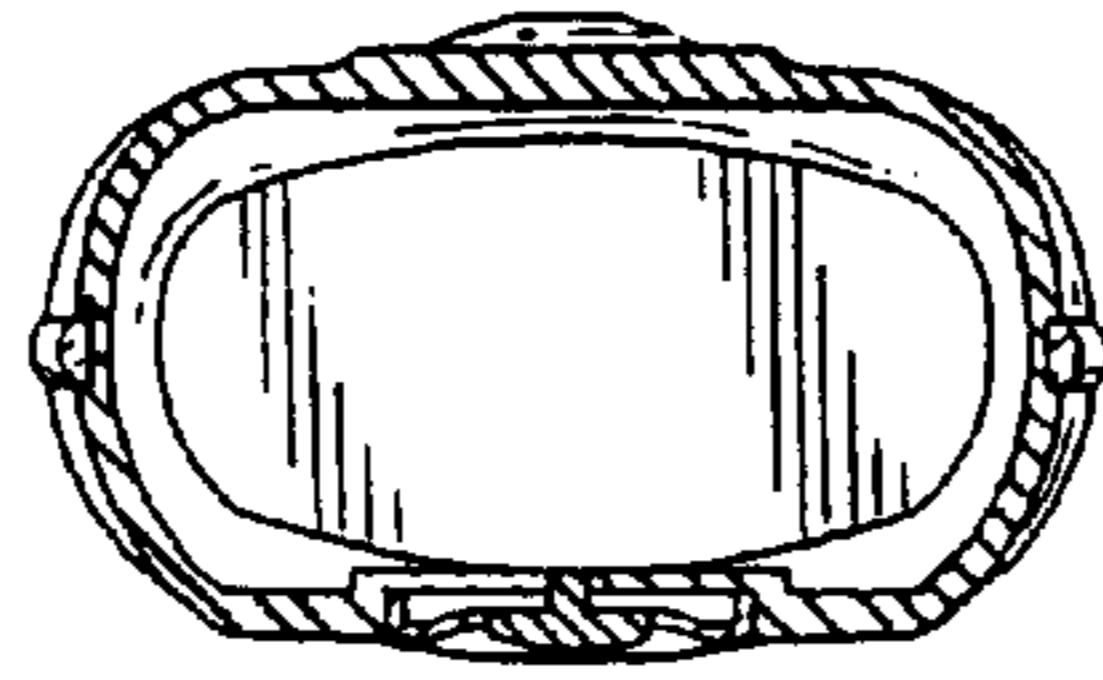
