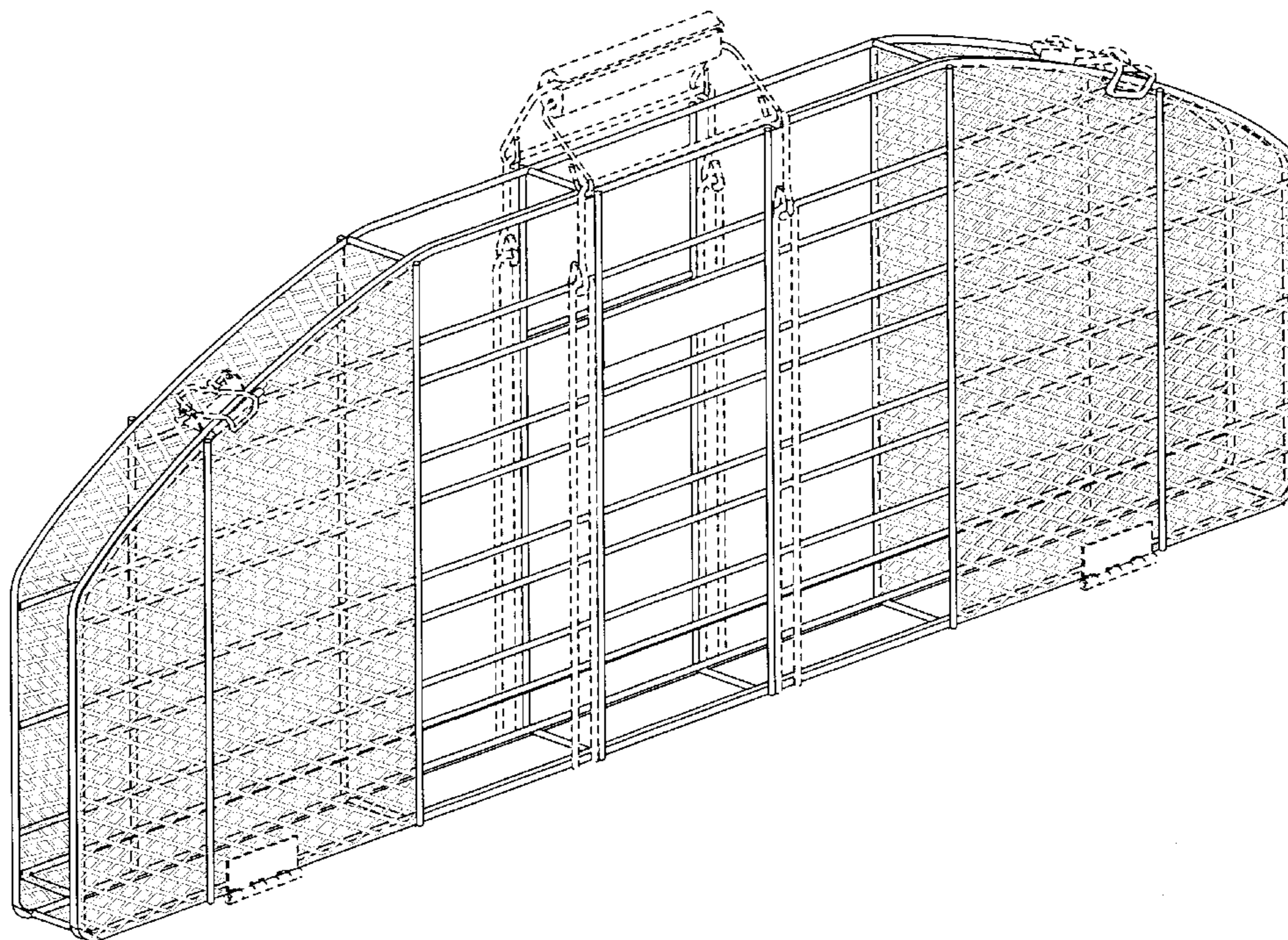
The ornamental design for a wire basket for packaging sporting equipment, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view illustrating a product packaging crate for sporting equipment;

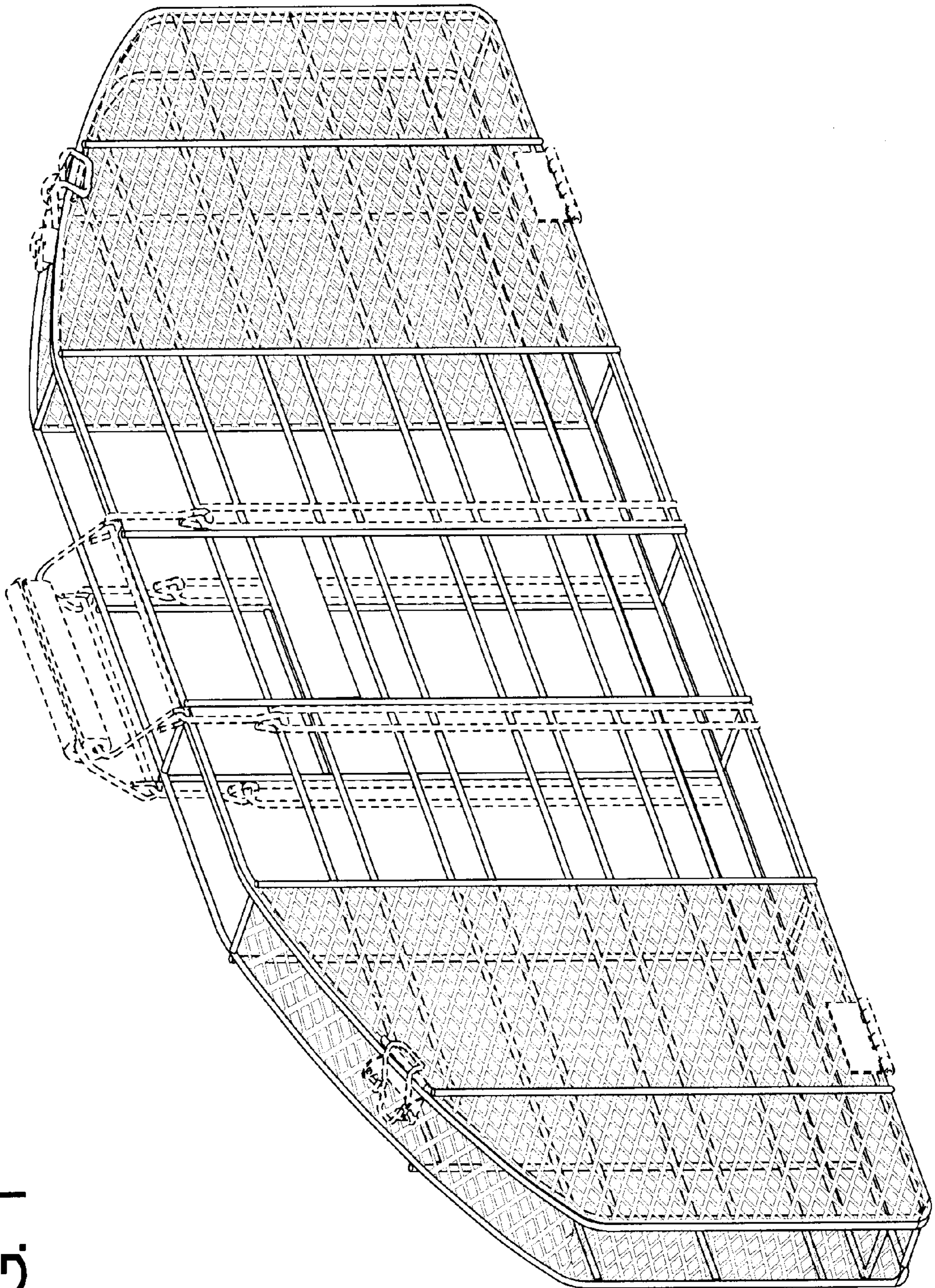

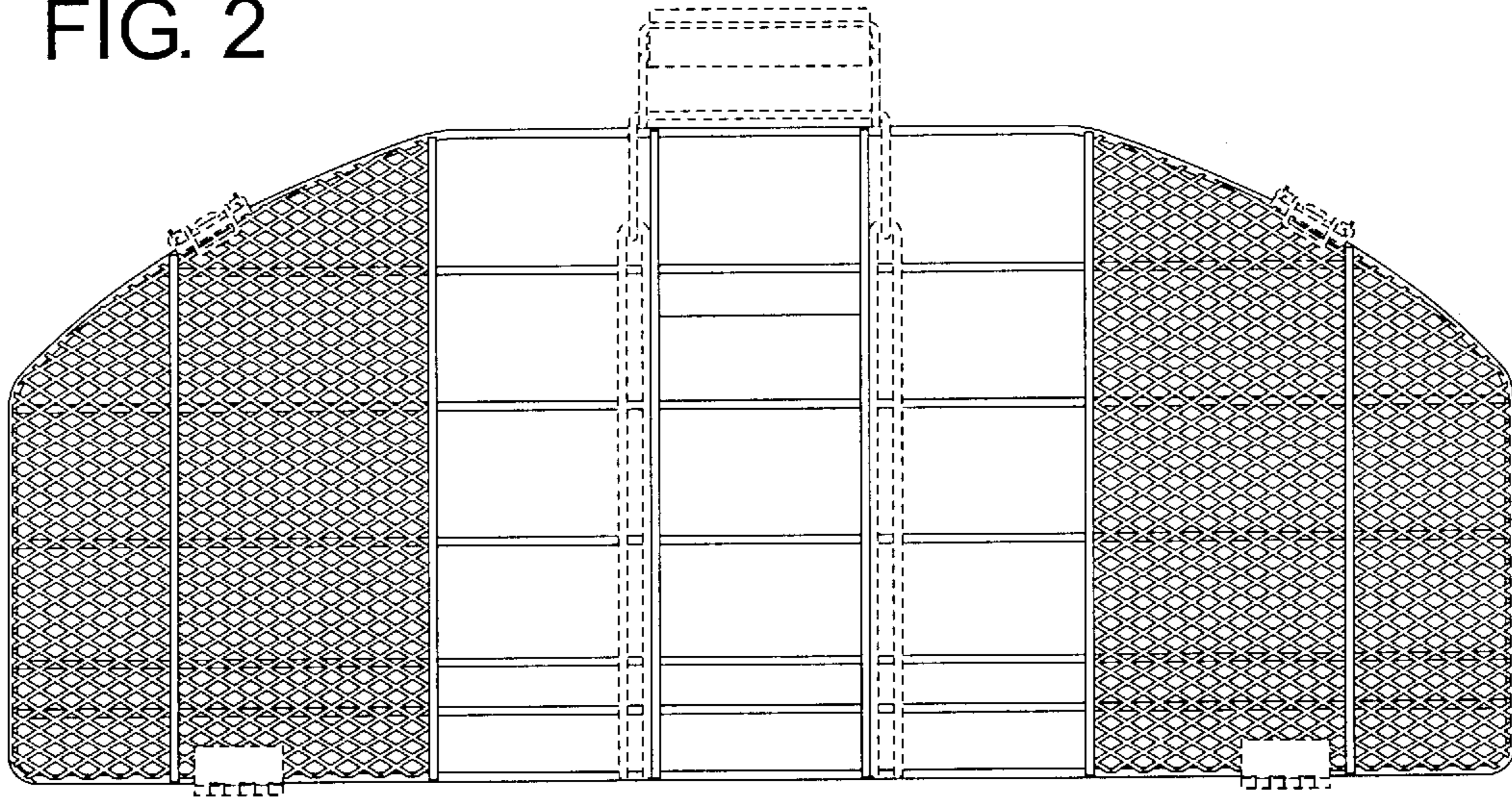

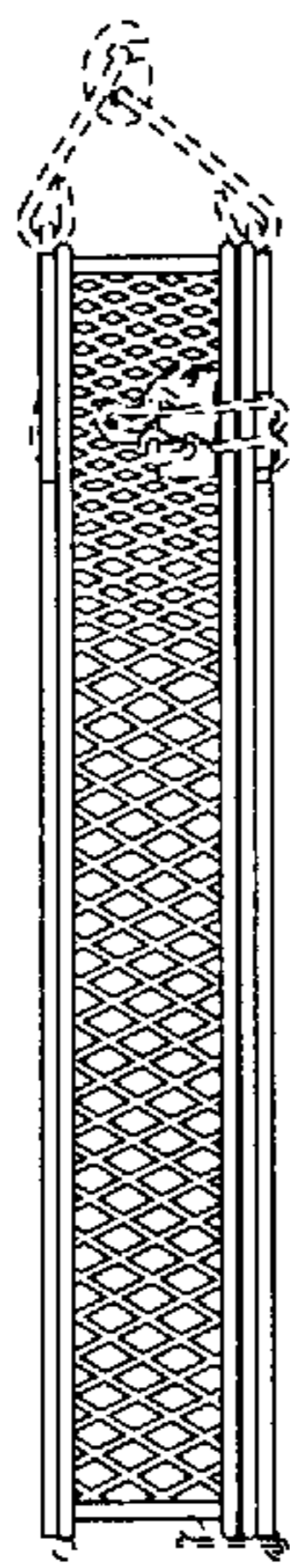

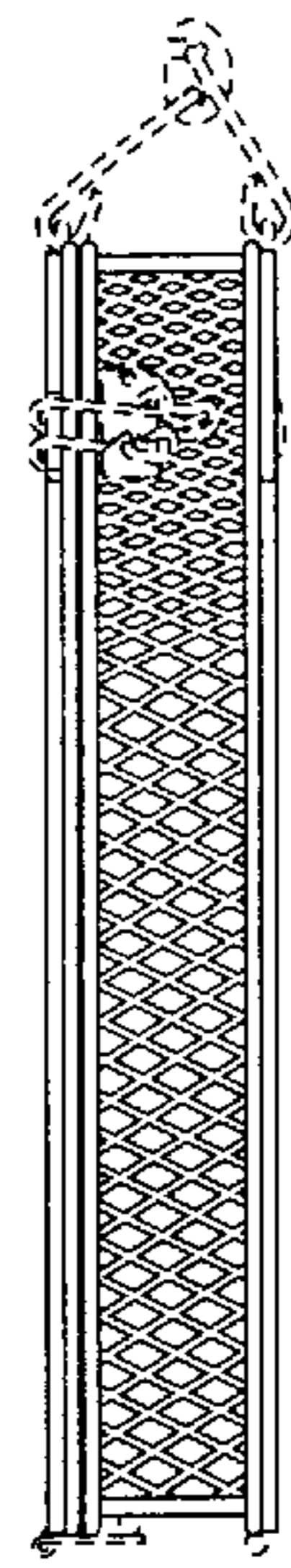

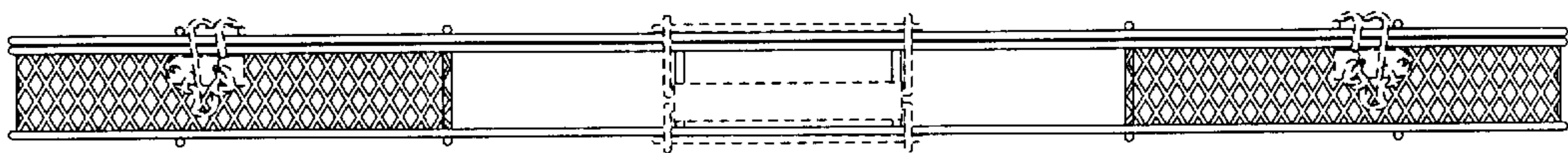

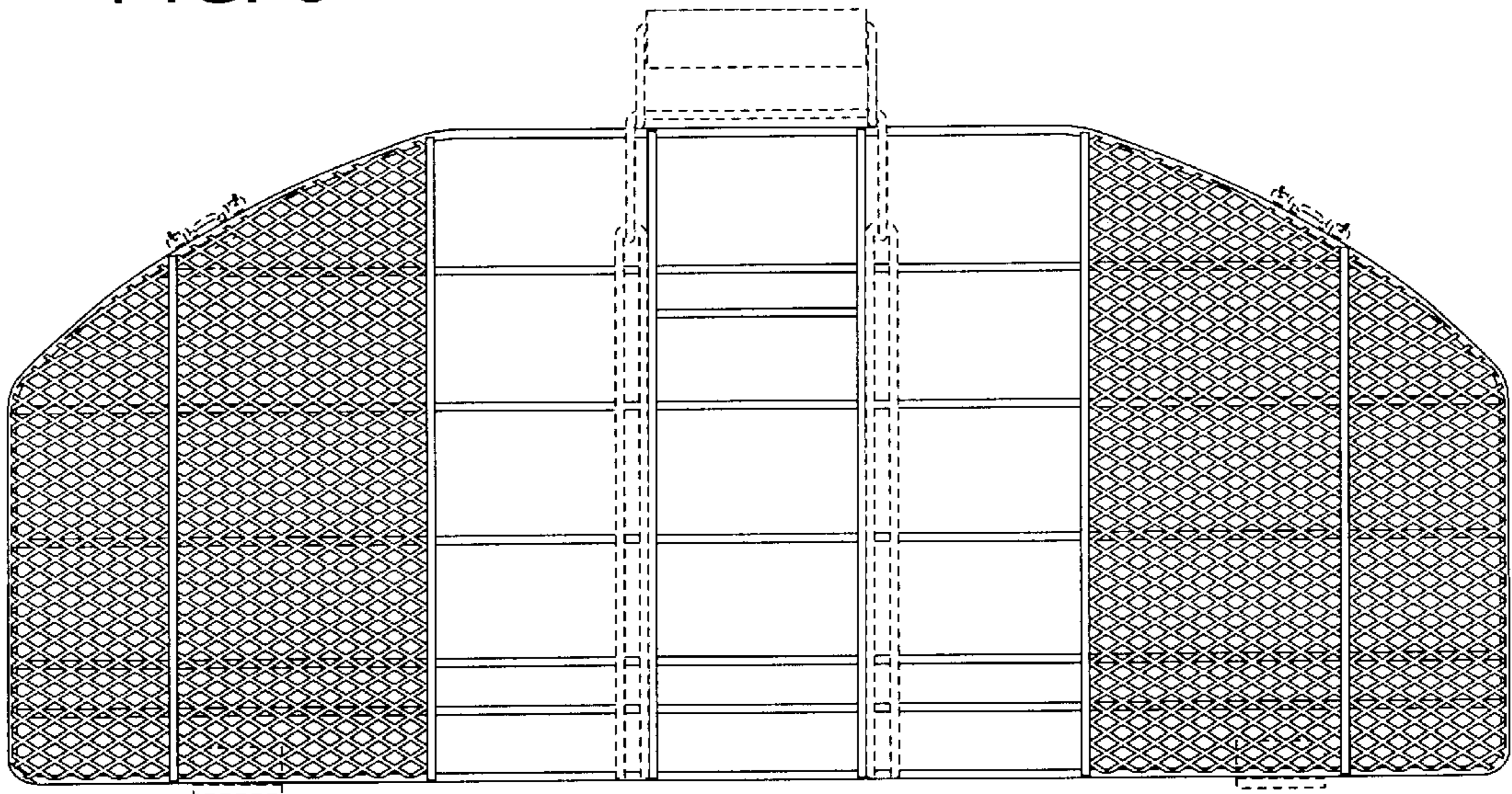
