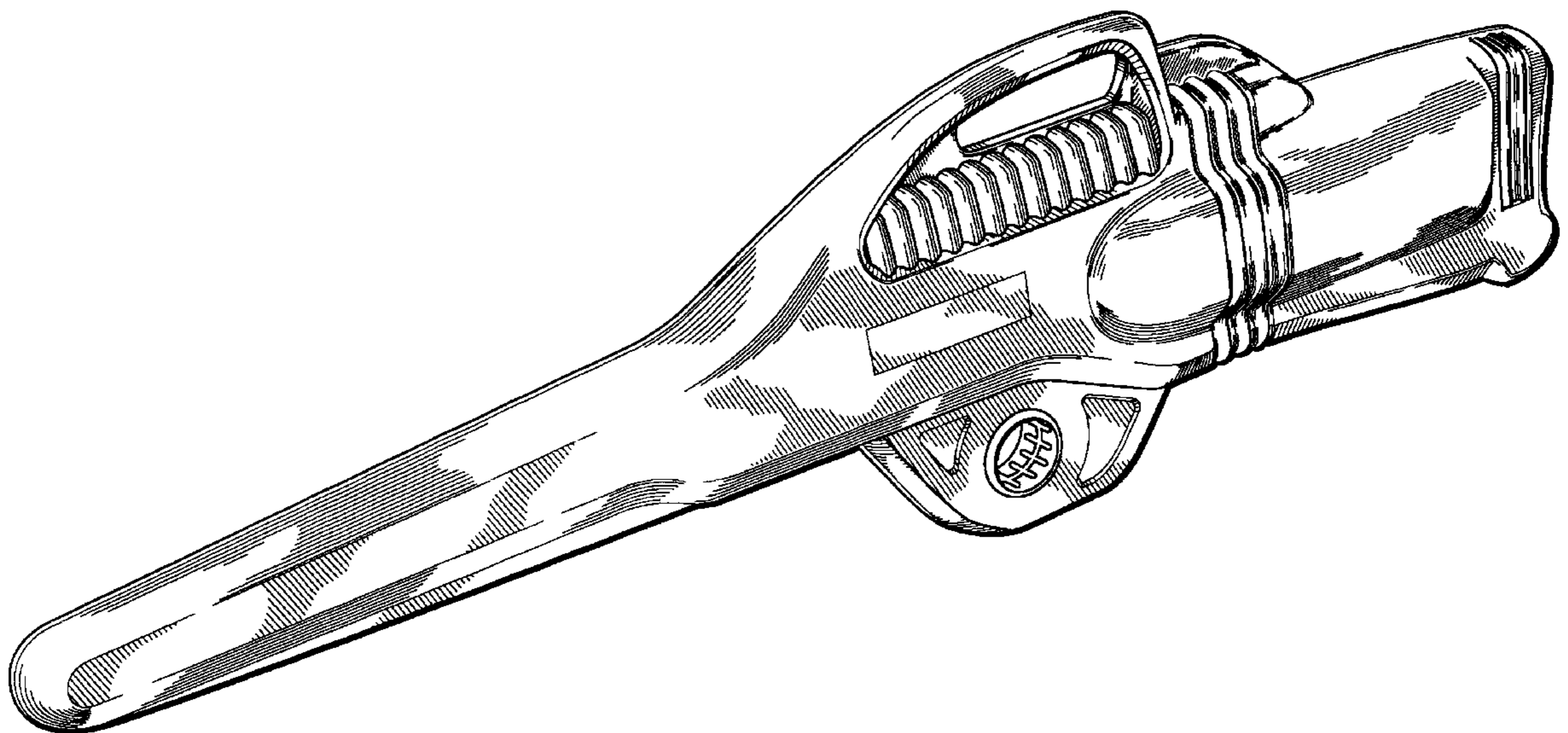
(57) **CLAIM**

The ornamental design for a hard-sided gun case with bracket, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the hard-sided gun case with bracket showing the new design;
FIG. 2 is a left side view of the hard-sided gun case with bracket showing the new design with the right side being a mirror image thereof;
FIG. 3 is a top plan view of the hard-sided gun case with bracket showing the new design;
FIG. 4 is a bottom plan view of the hard-sided gun case with bracket showing the new design;
FIG. 5 is a front plan view of the hard-sided gun case with bracket showing the new design; and,
FIG. 6 is a rear plan view of the hard-sided gun case with bracket showing the new design.

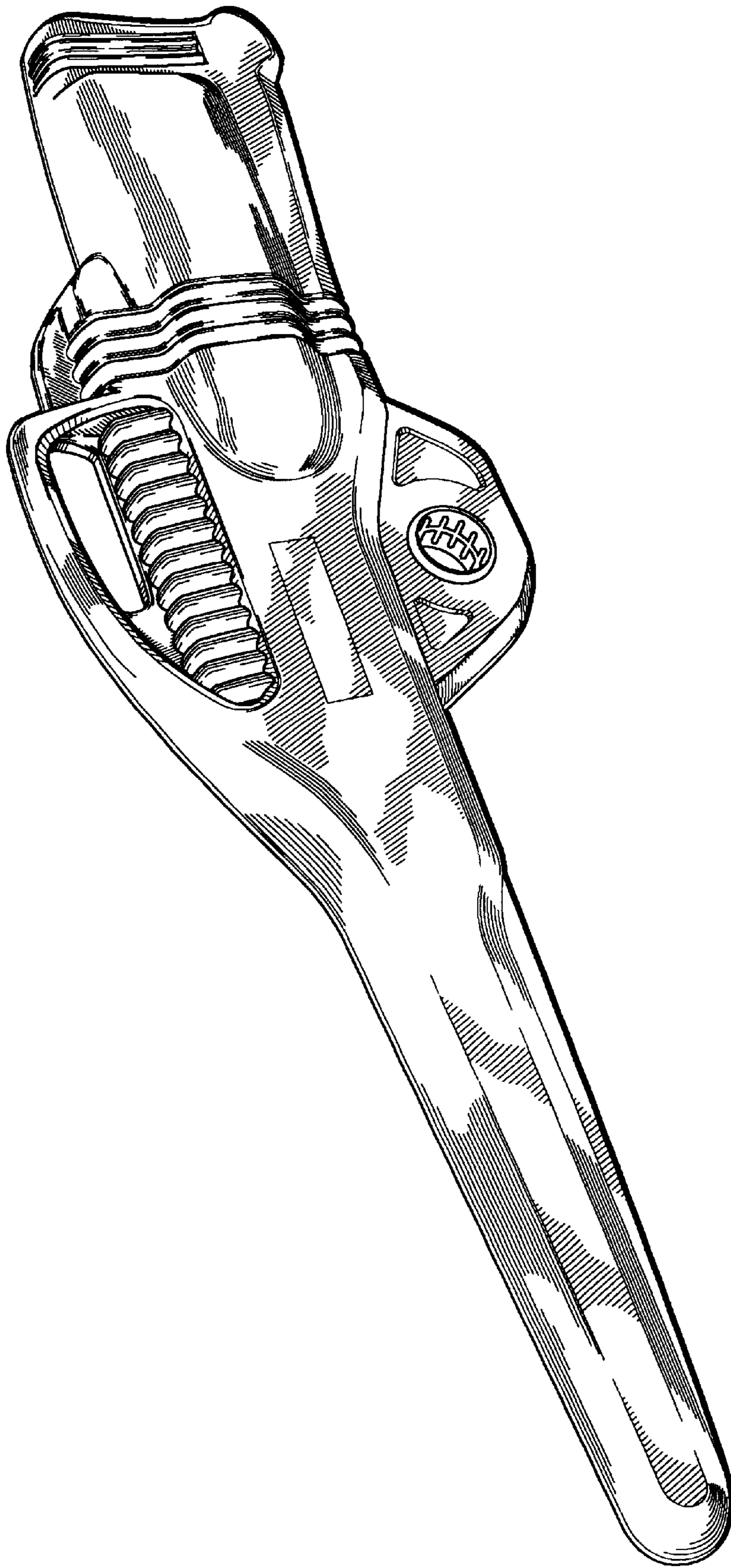

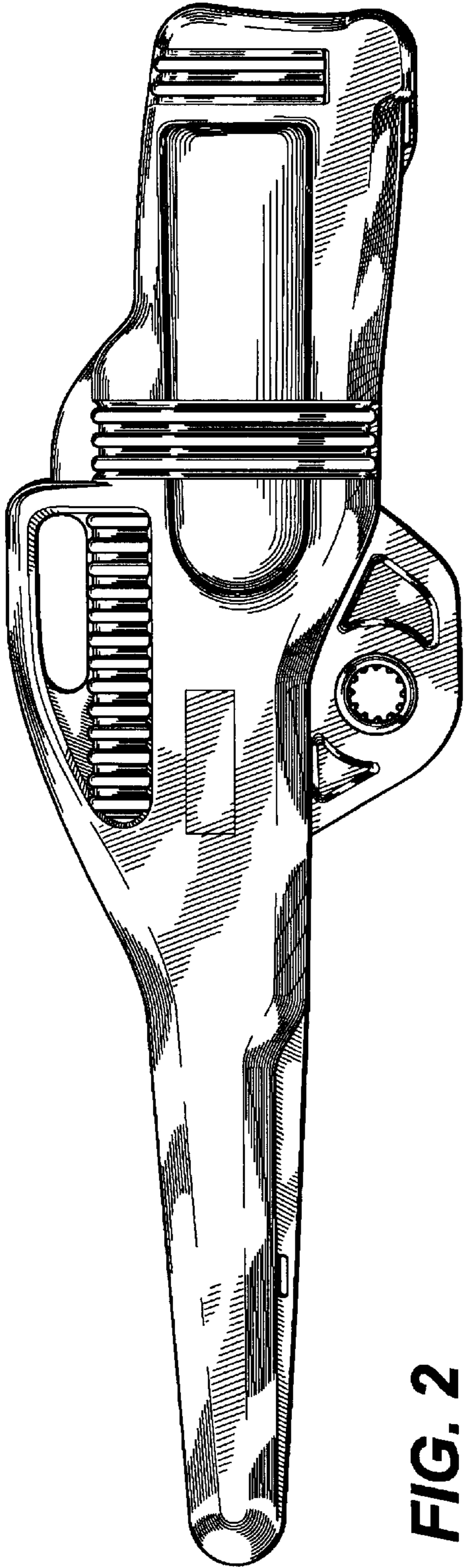

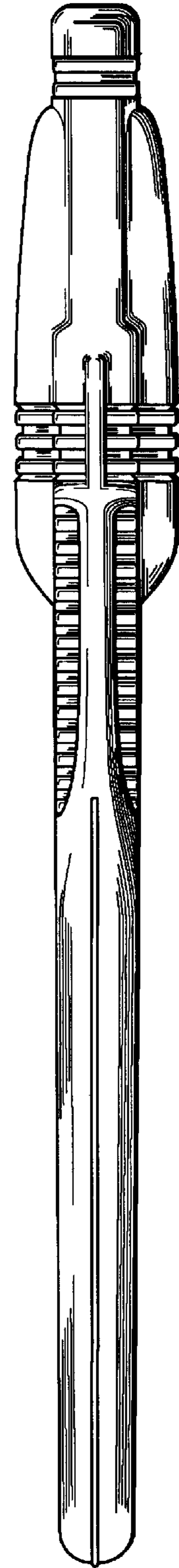

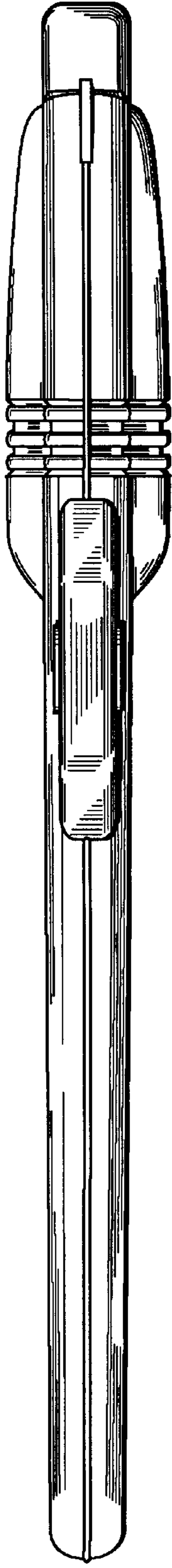

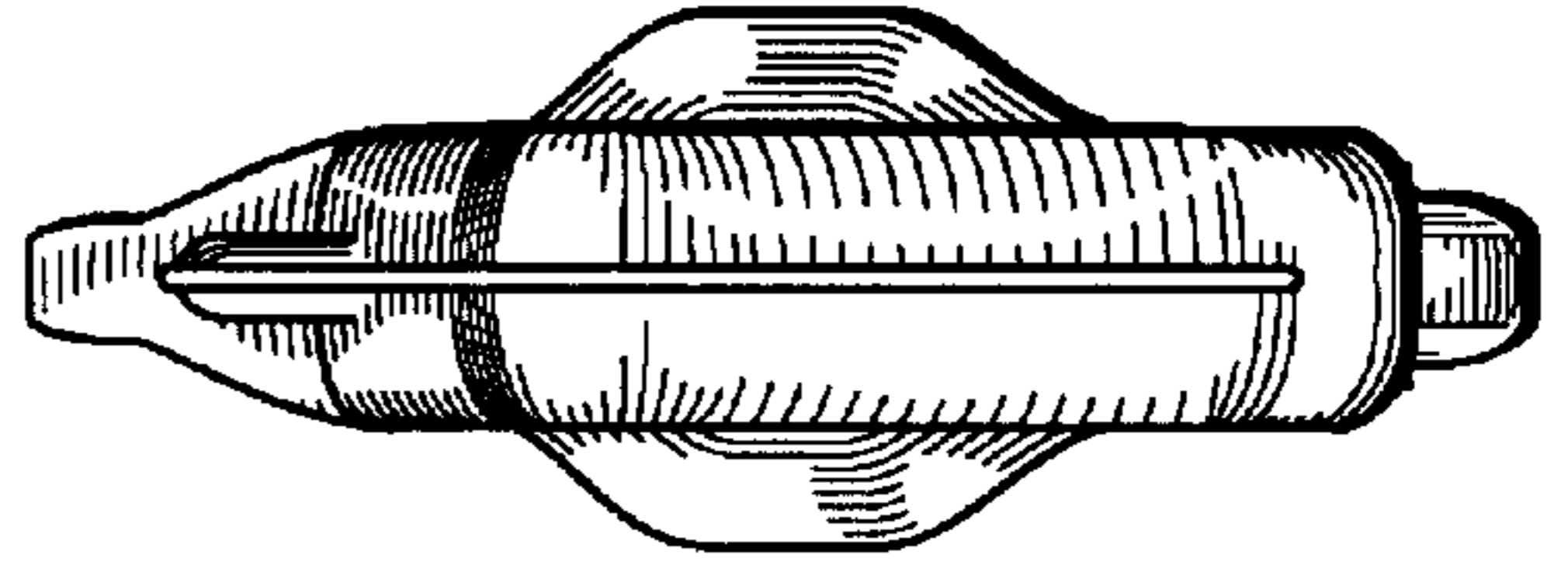

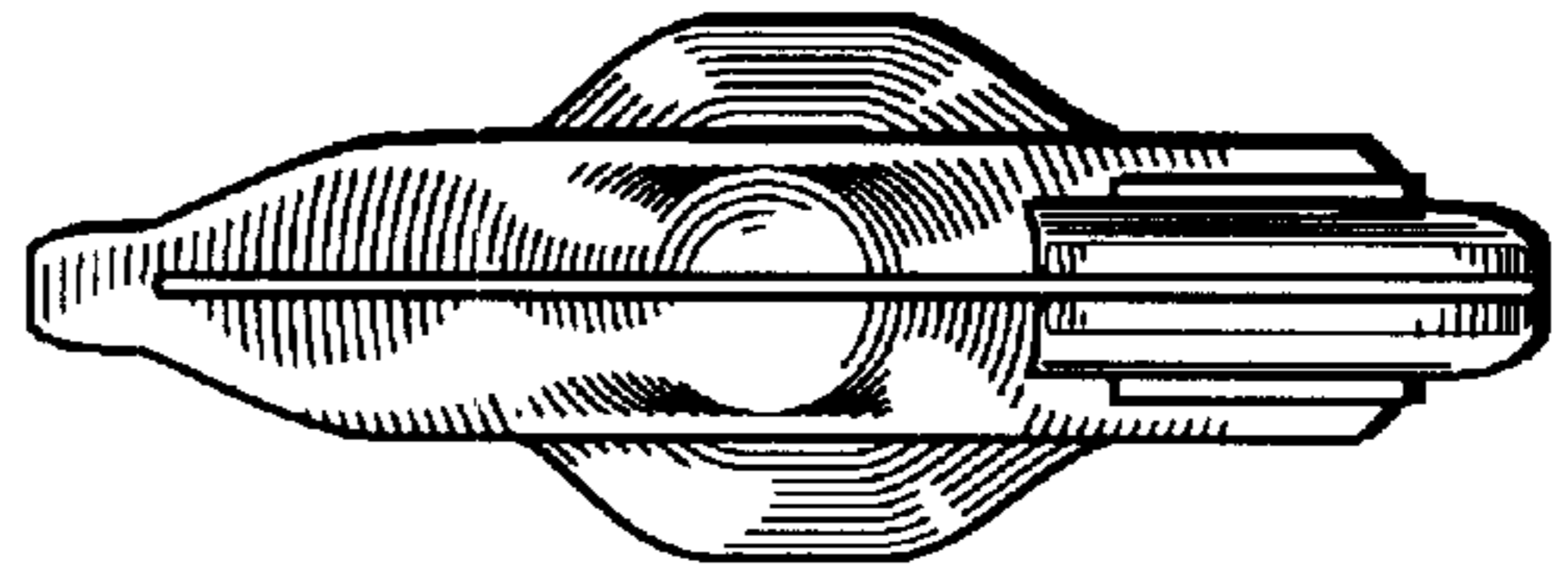
