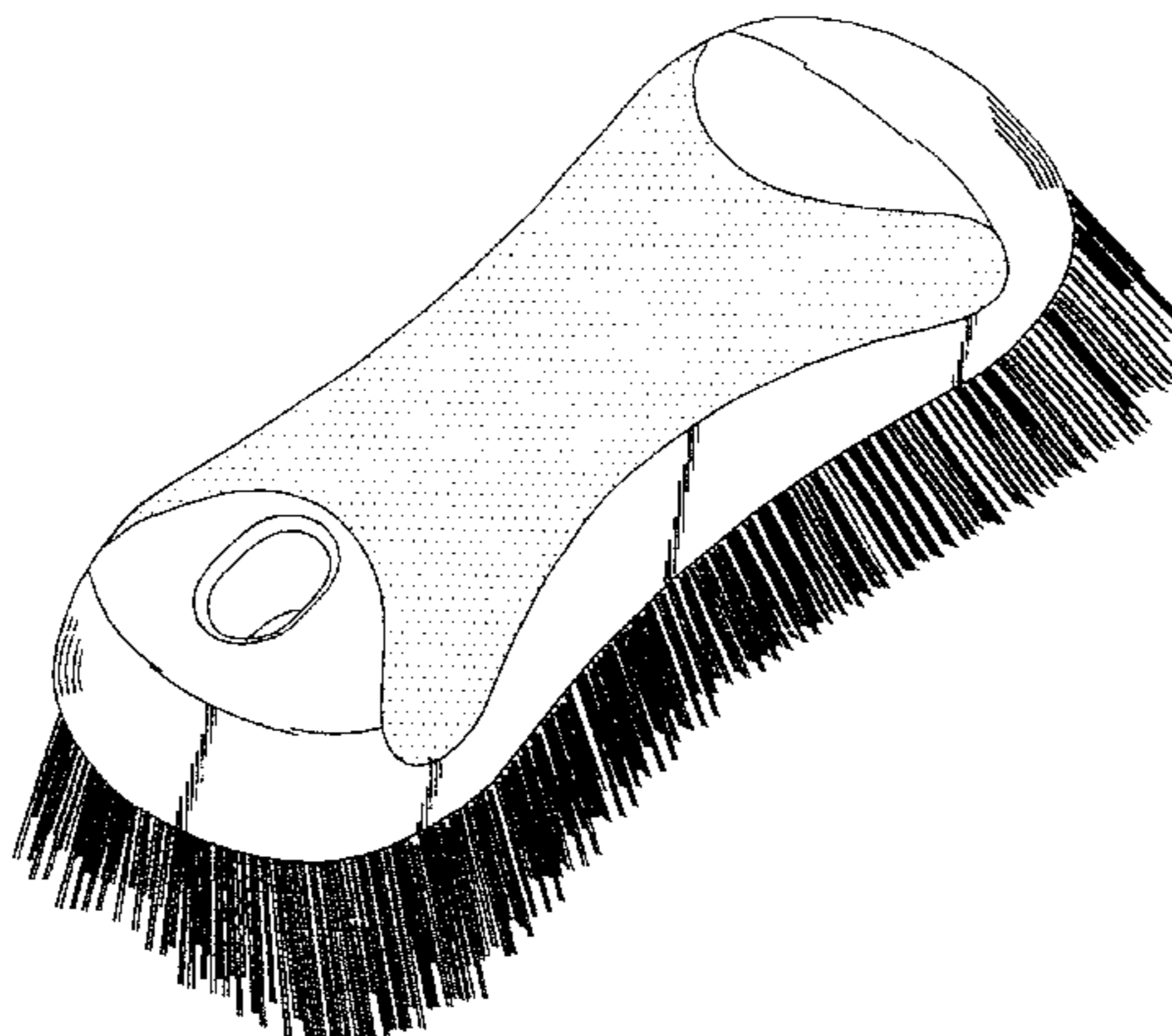
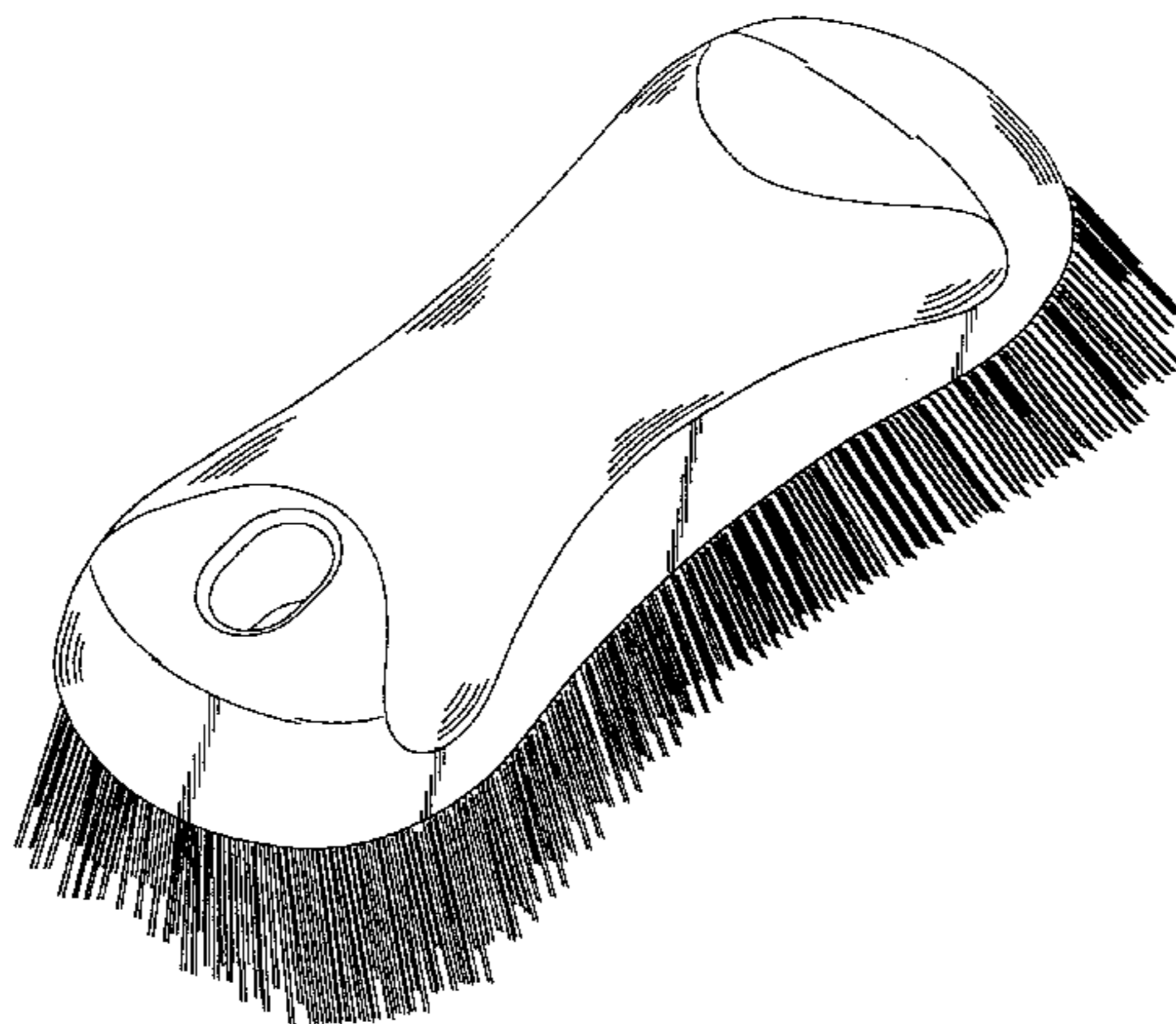
(57) **CLAIM**

The ornamental design for “brush”, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view showing one embodiment of a “brush” incorporating the design of my invention; FIG. 2 is a top view thereof; FIG. 3 is a bottom view thereof; FIG. 4 is a side view thereof; FIG. 5 is another side view thereof; FIG. 6 is a front view thereof; FIG. 7 is a rear view thereof; FIG. 8 is a front perspective view showing another embodiment of a “brush” incorporating the design of my invention; FIG. 9 is a top view of the brush shown in FIG. 8; FIG. 10 is a bottom view of the brush shown in FIG. 8; FIG. 11 is a side view of the brush shown in FIG. 8; FIG. 12 is another side view of the brush shown in FIG. 8; FIG. 13 is a front view of the brush shown in FIG. 8; and, FIG. 14 is a rear view of the brush shown in FIG. 8. The dotted area shown in FIGS. 8 to 9 and 11 to 14 illustrate different pattern or ornament used in that part of the design of the invention.

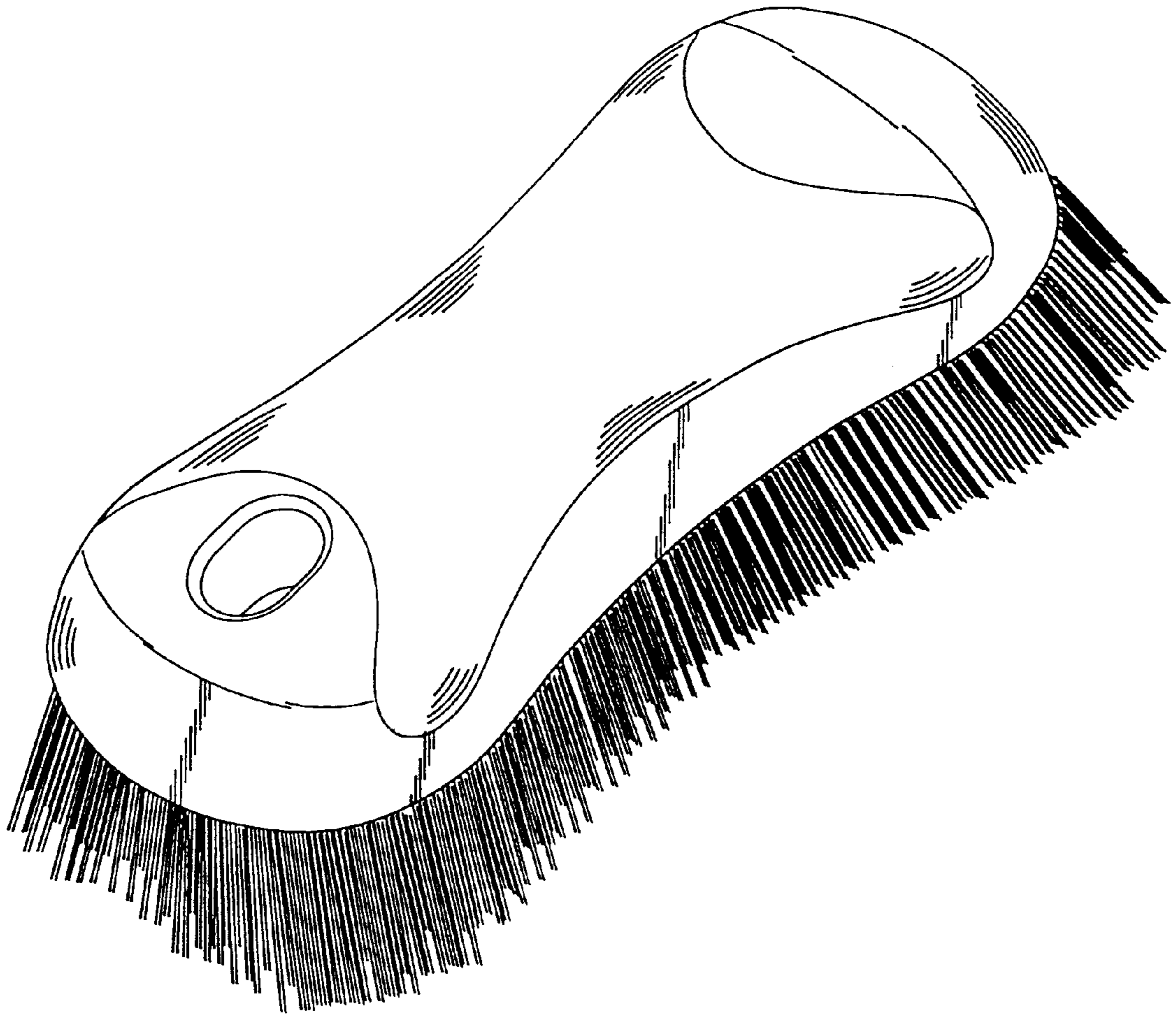

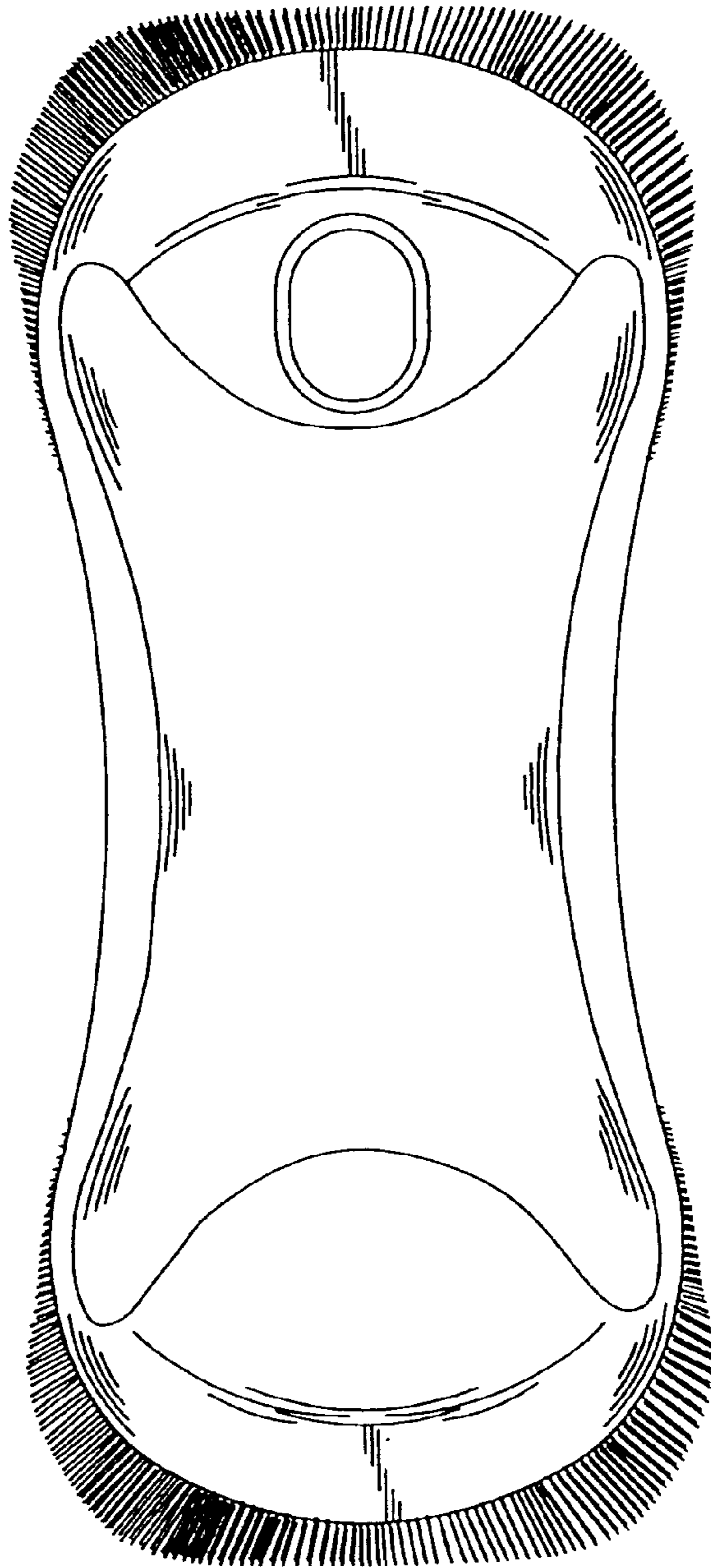

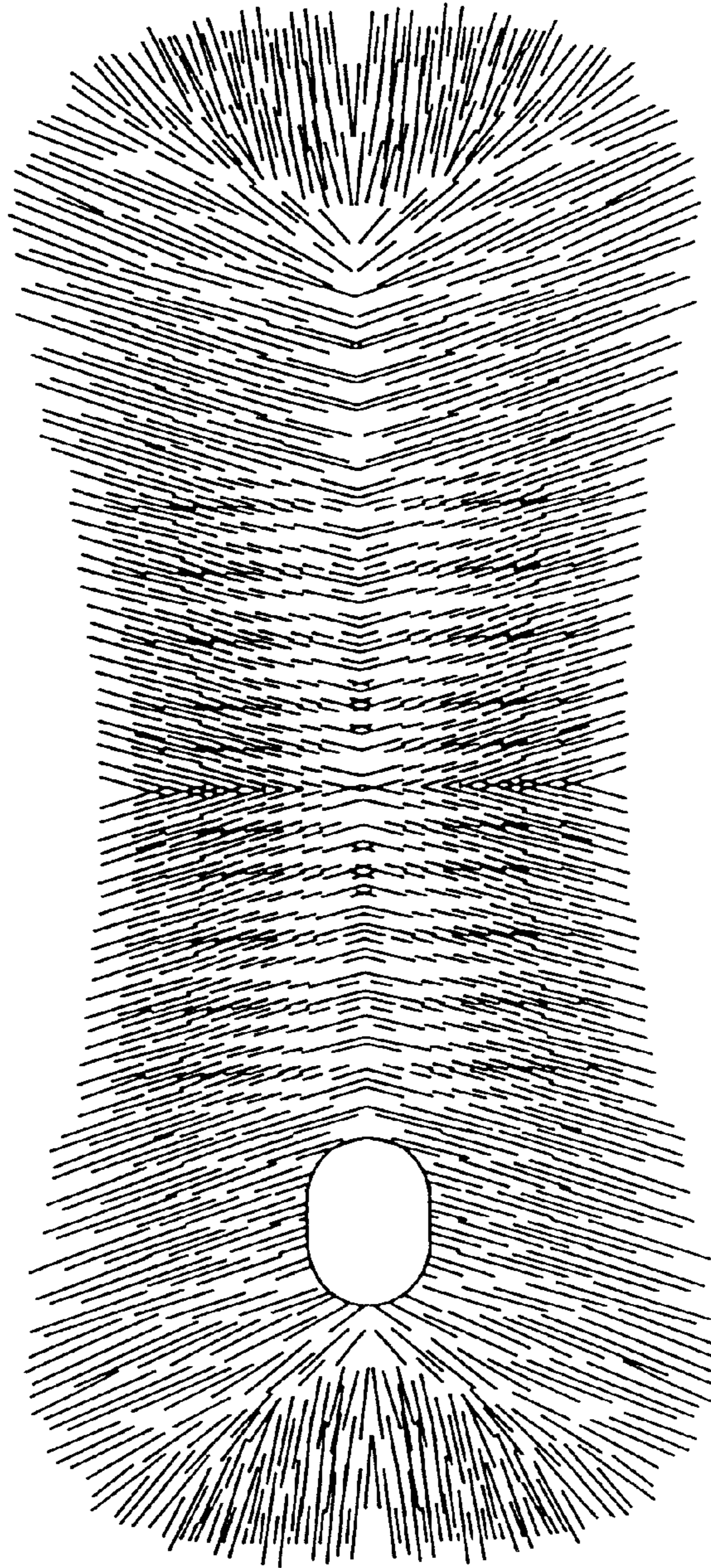

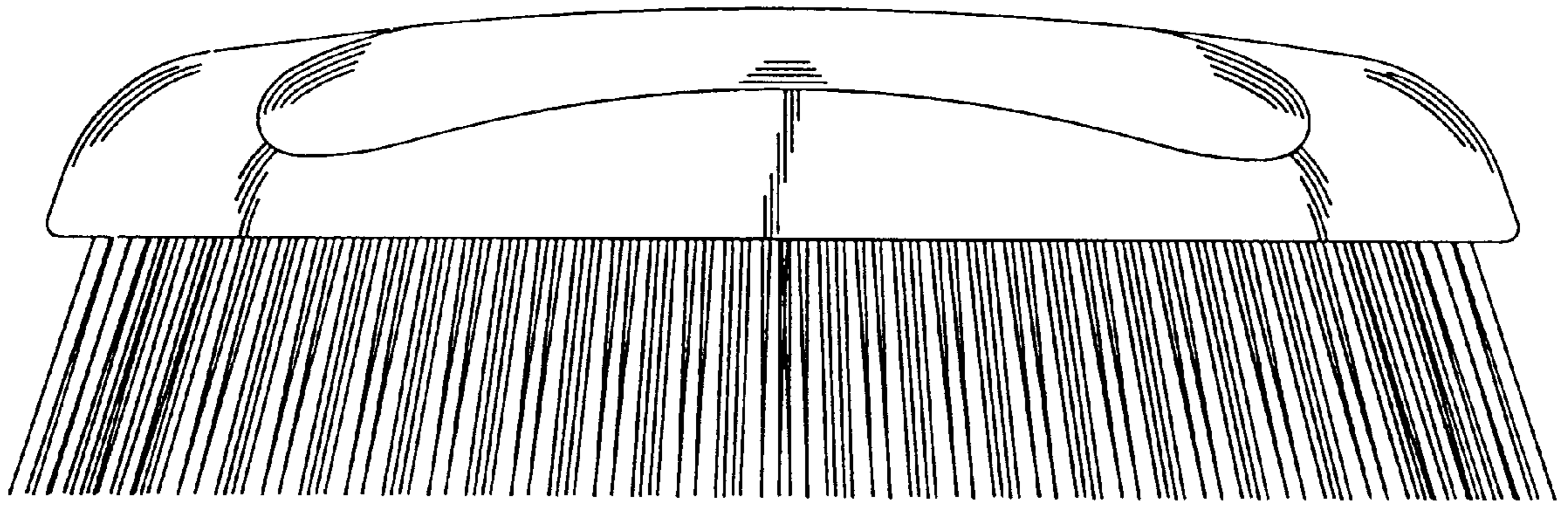

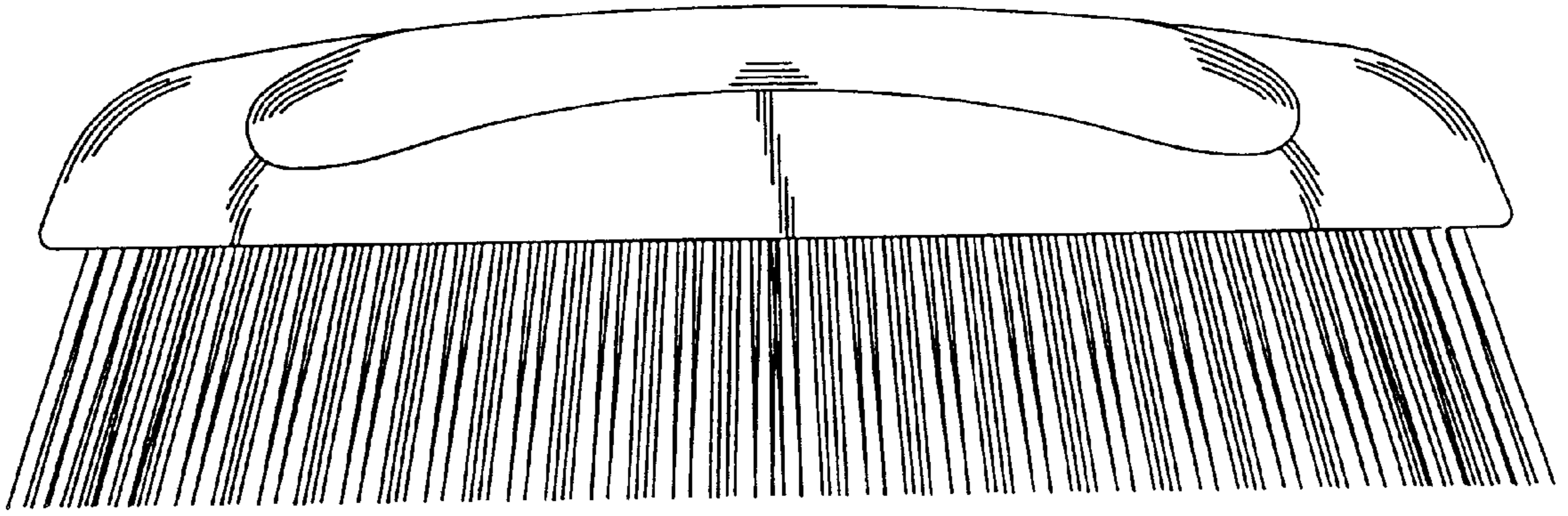

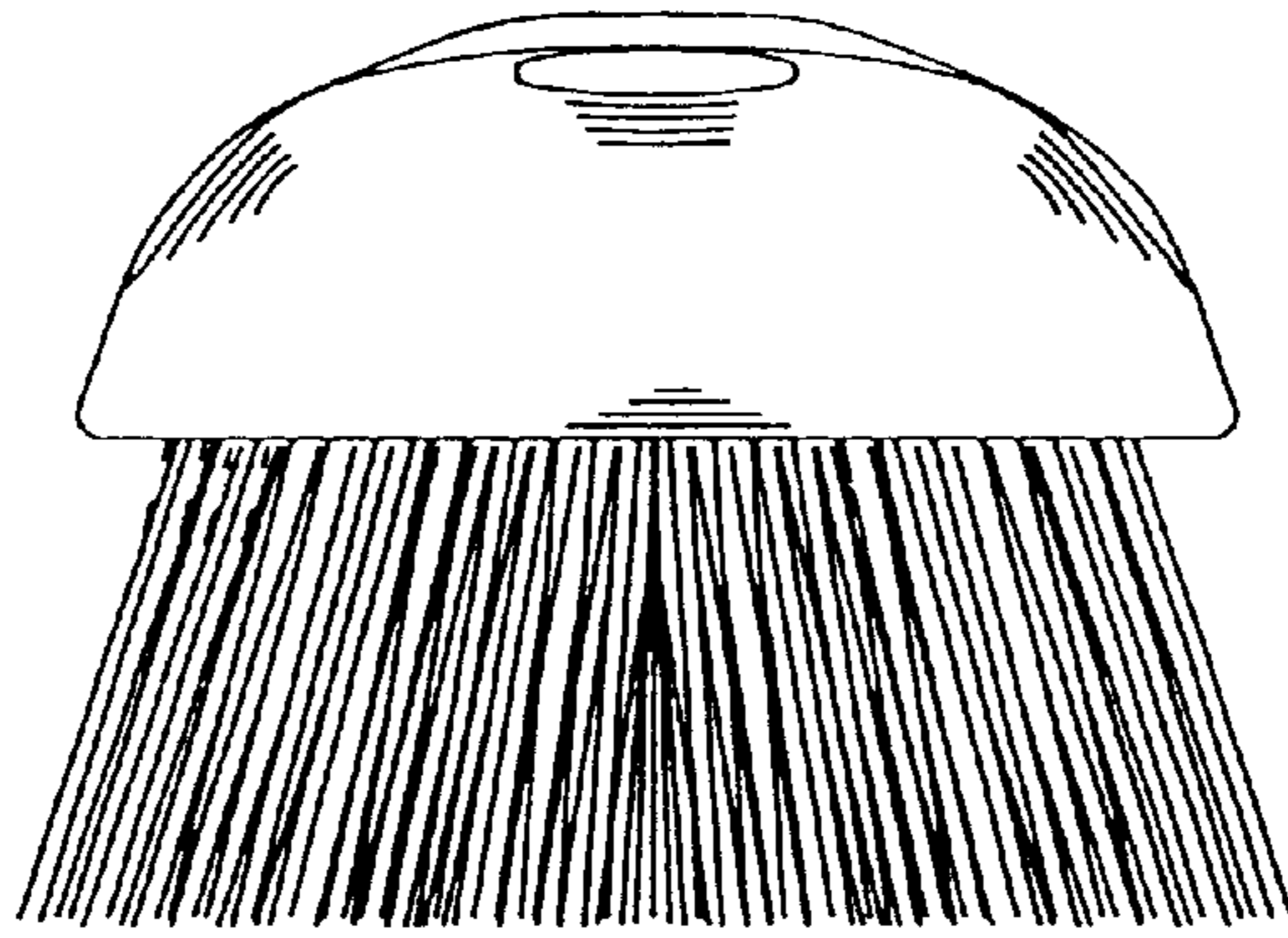

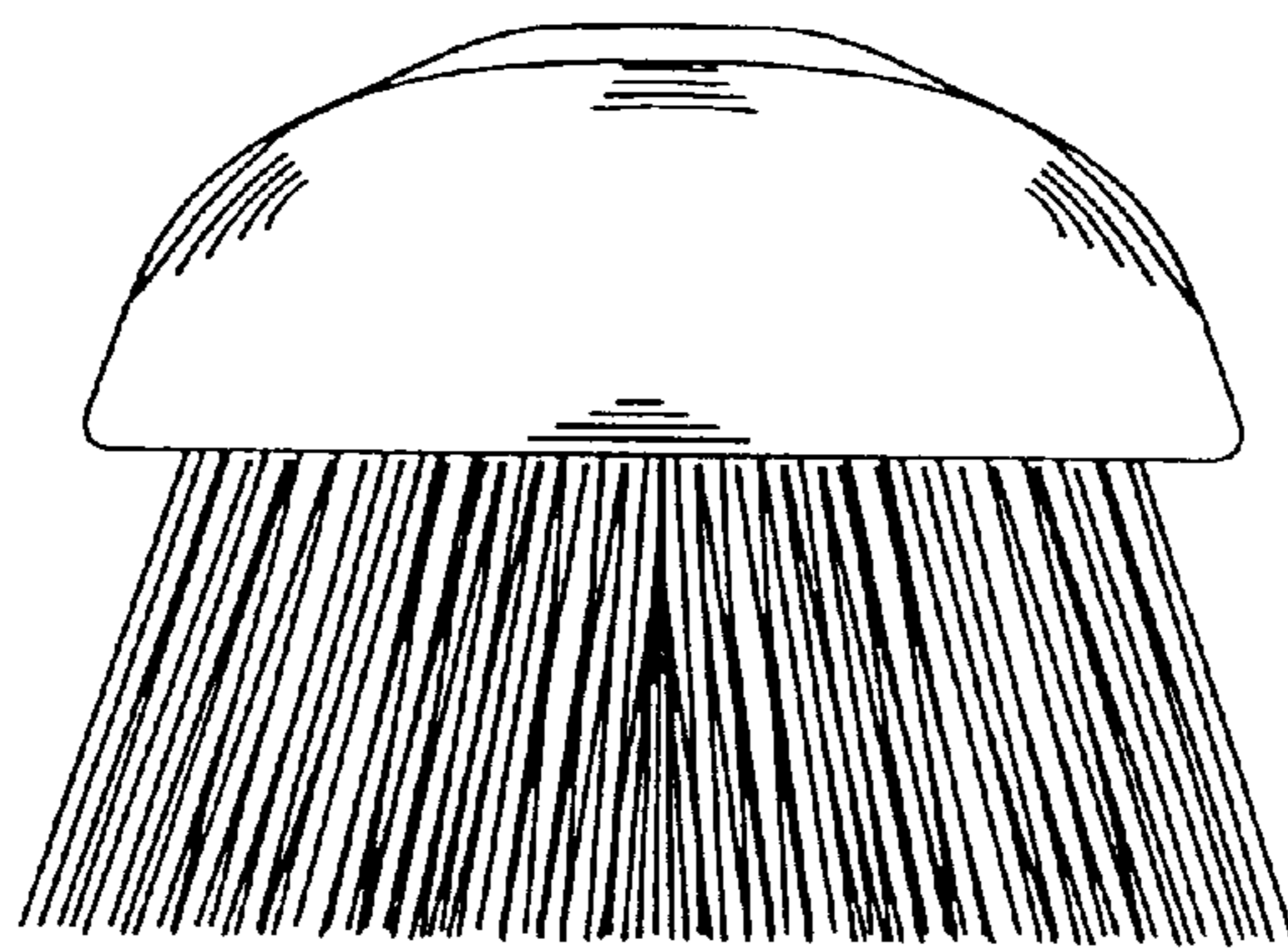

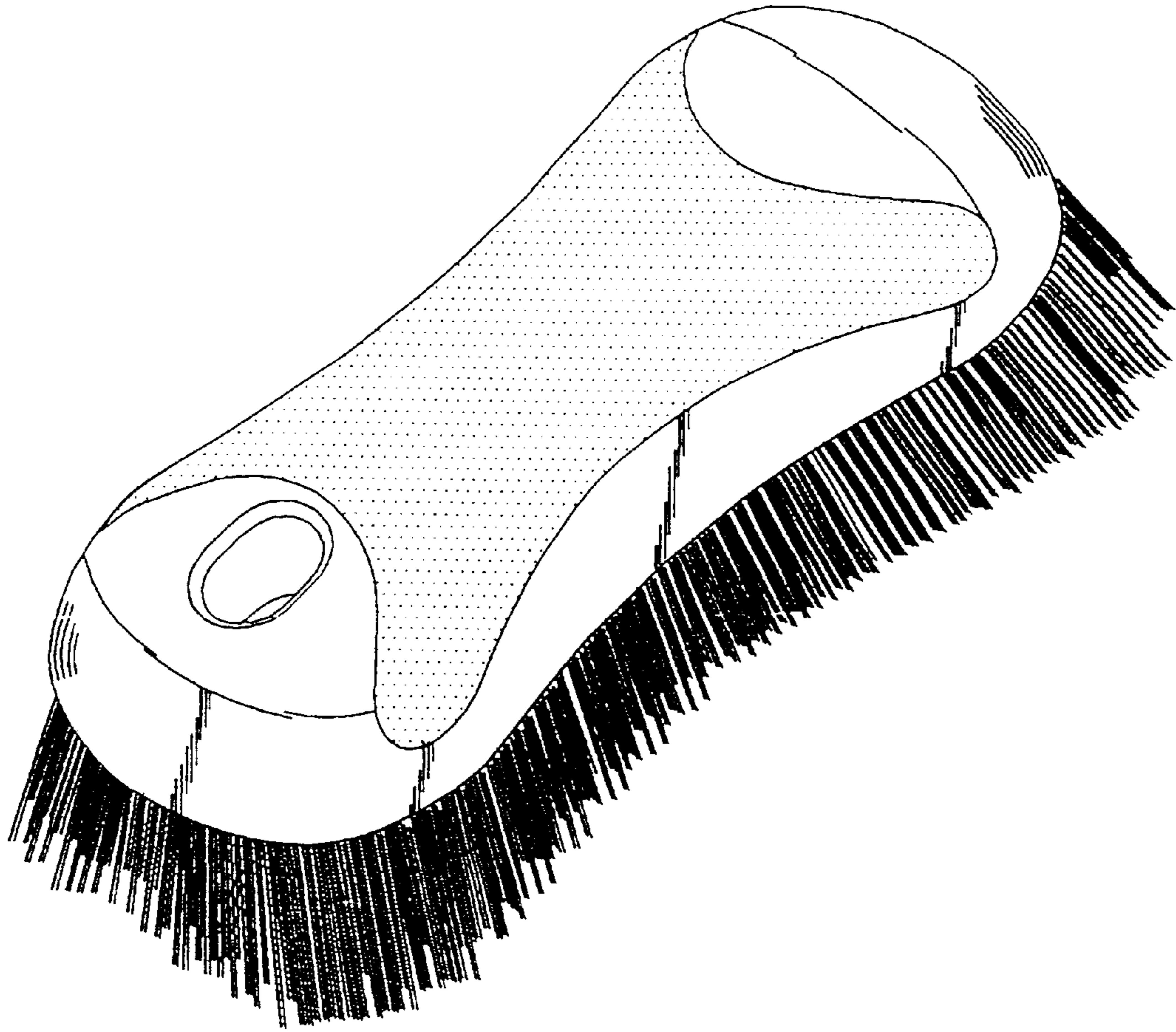

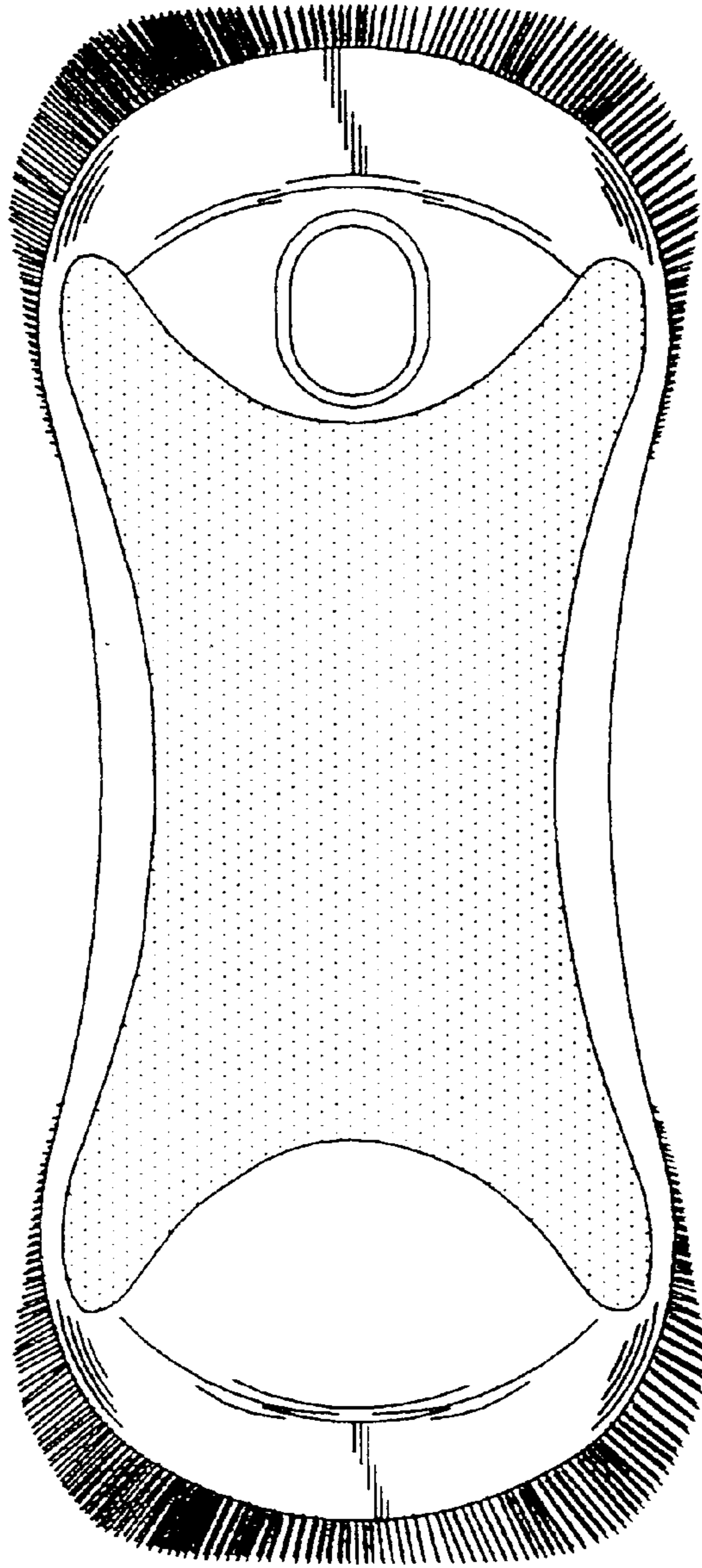

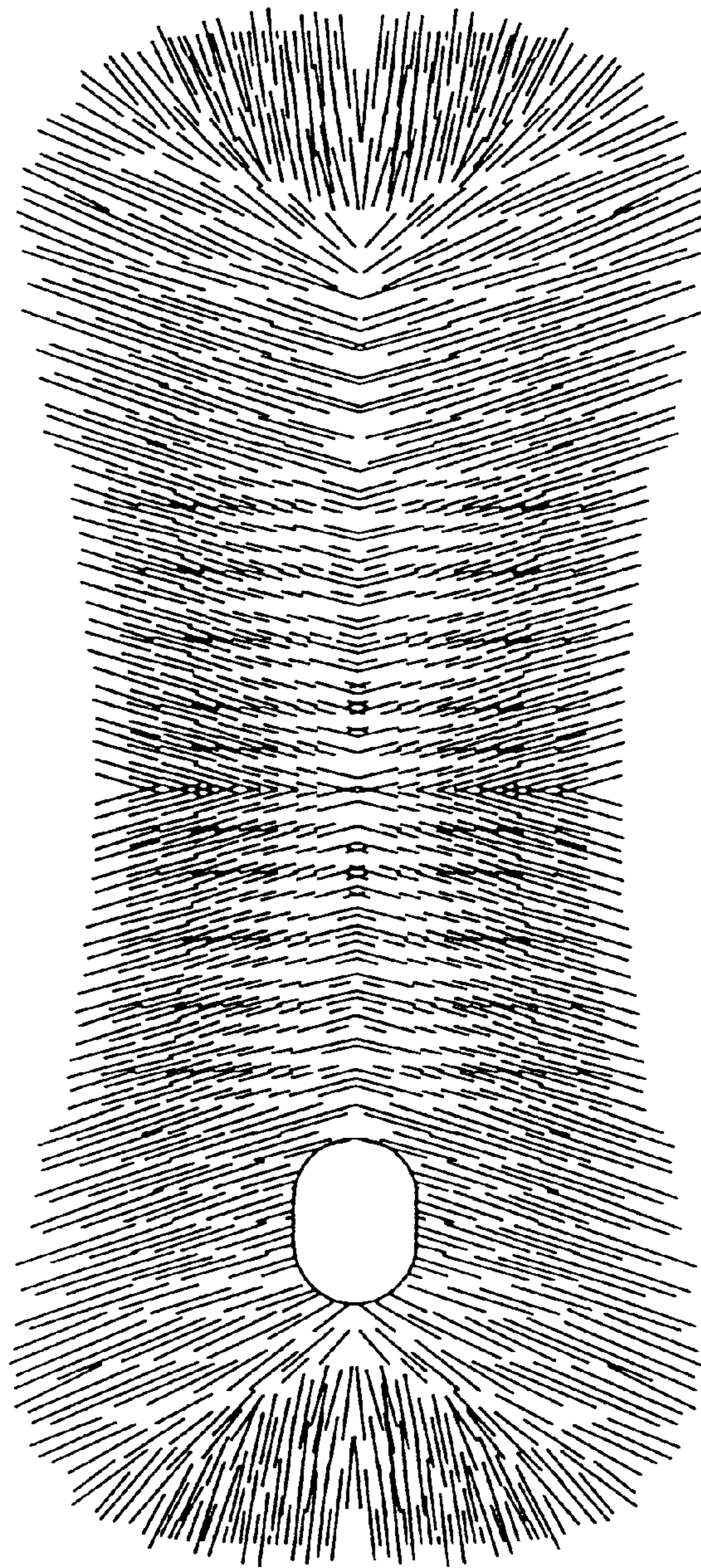

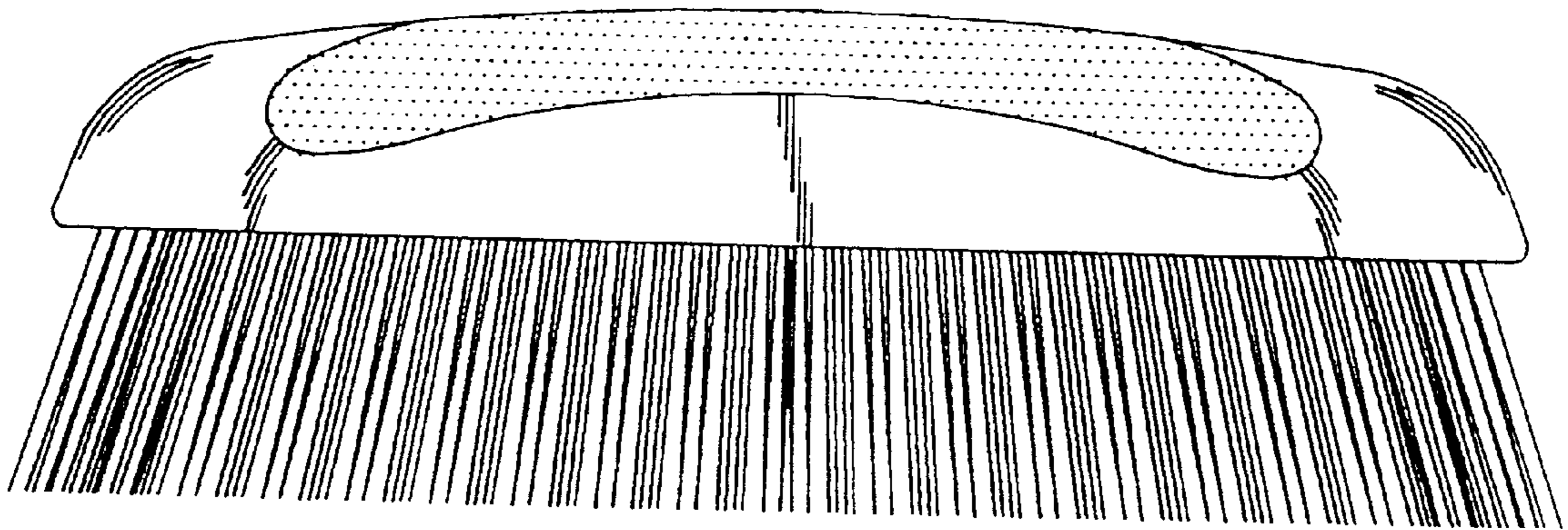

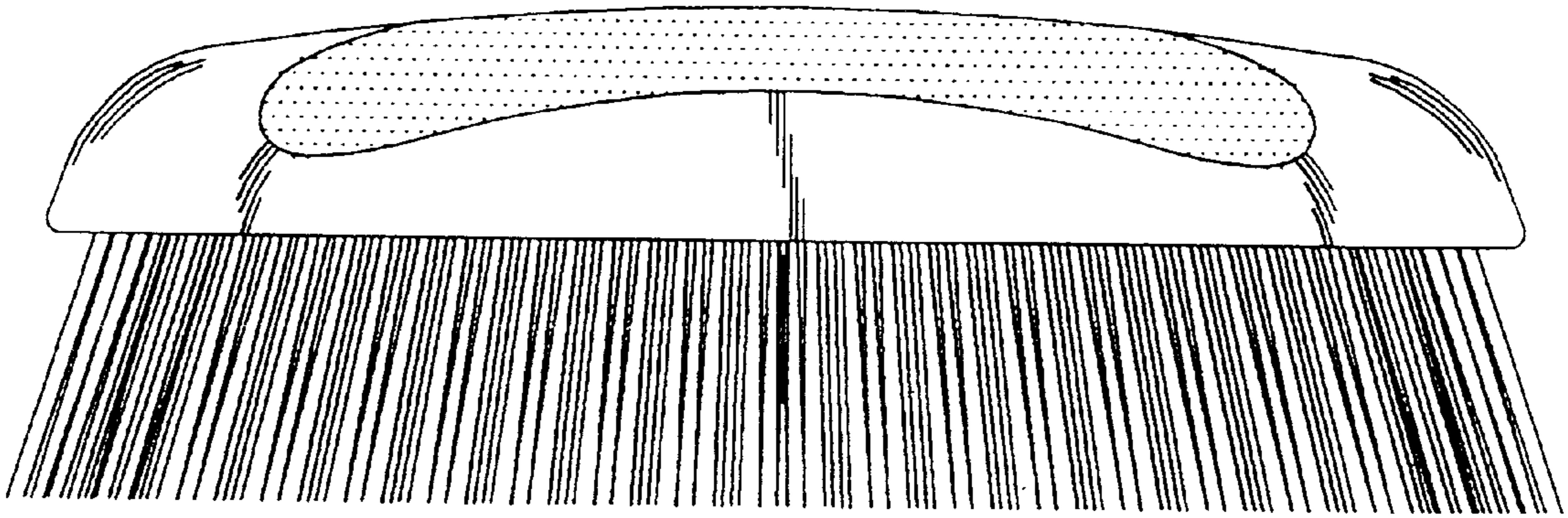

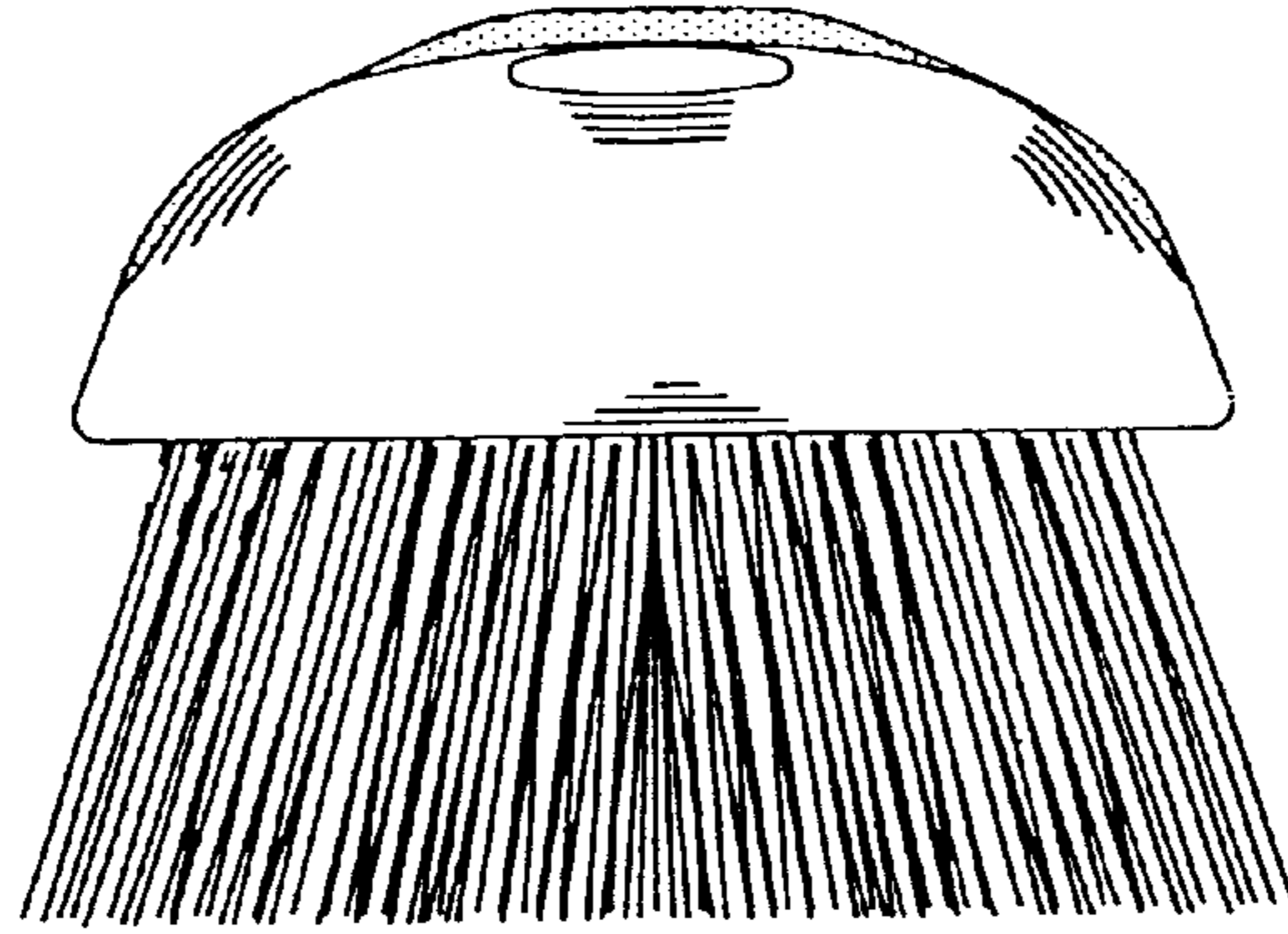

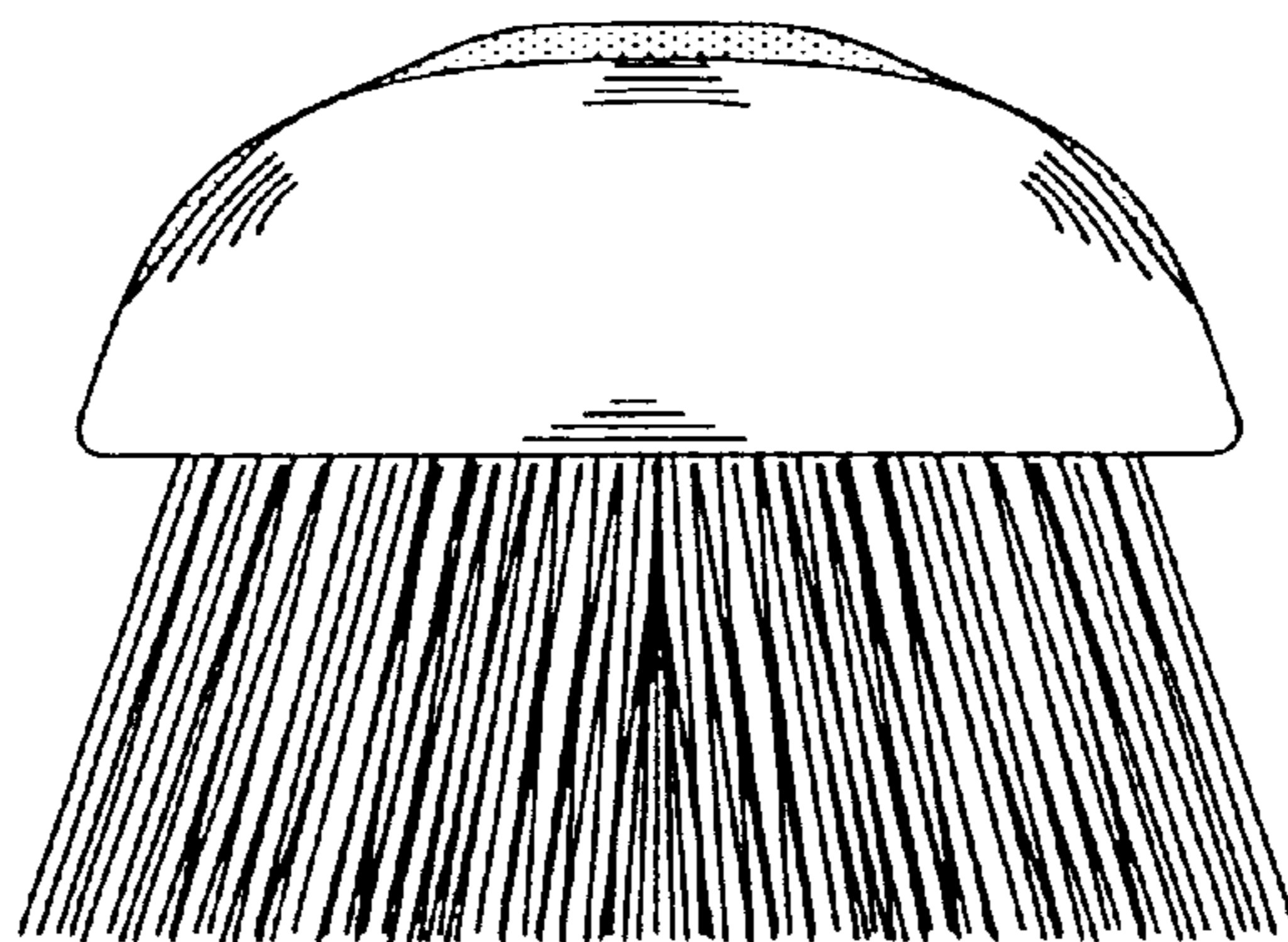
