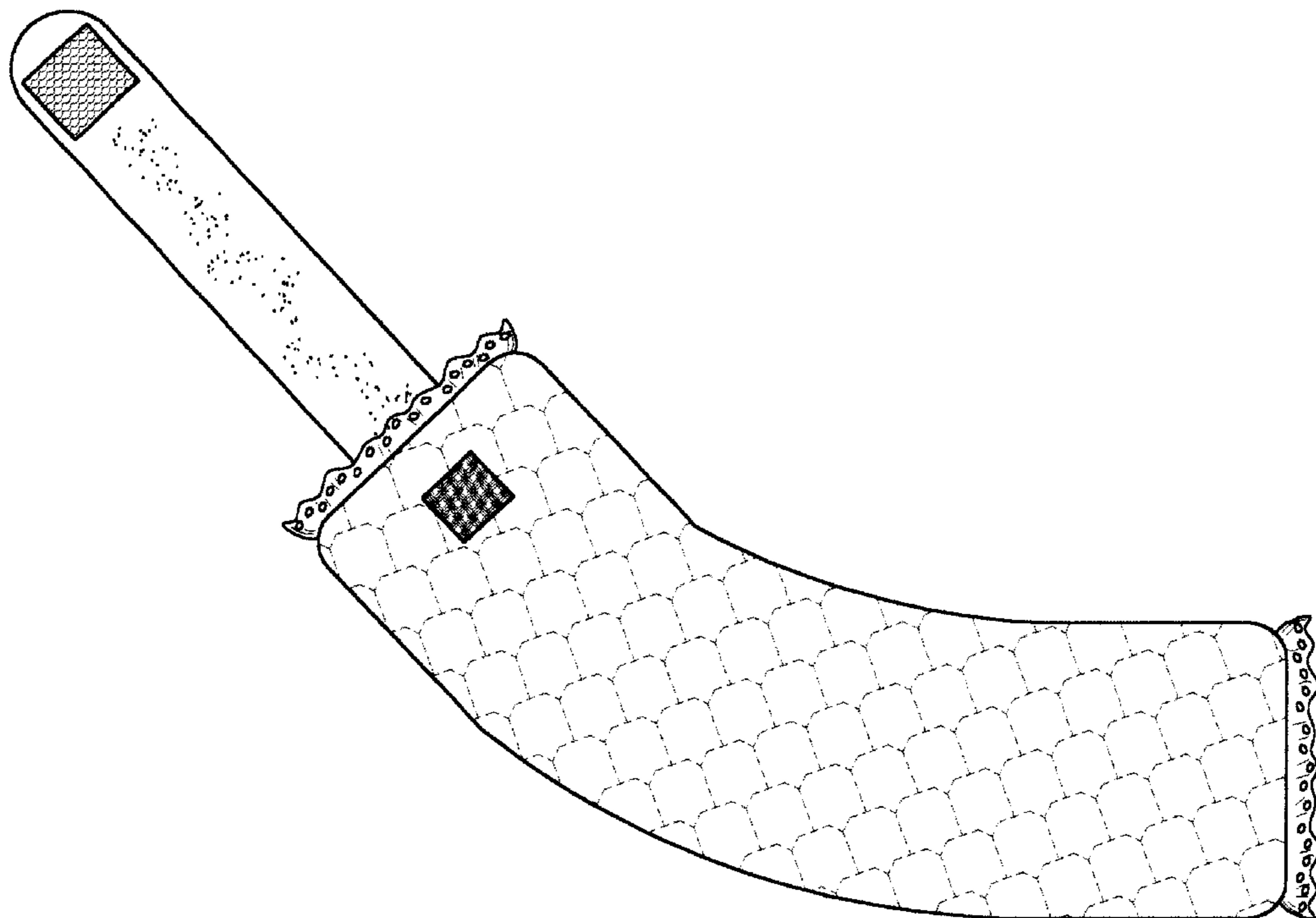
(57) **CLAIM**

The ornamental design for an arm-mountable pad for use when holding a baby, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of an arm-mountable pad for use when holding a baby showing my new design; FIG. 2 is a rear elevational view thereof; FIG. 3 is a side view, taken from the left side of FIG. 1; FIG. 4 is a side view, taken from the right side of FIG. 1; FIG. 5 is a top plan view thereof; and, FIG. 6 is a bottom plan view thereof. The broken line showing of environmental structure is for illustrative purposes only and forms no part of the claimed design.

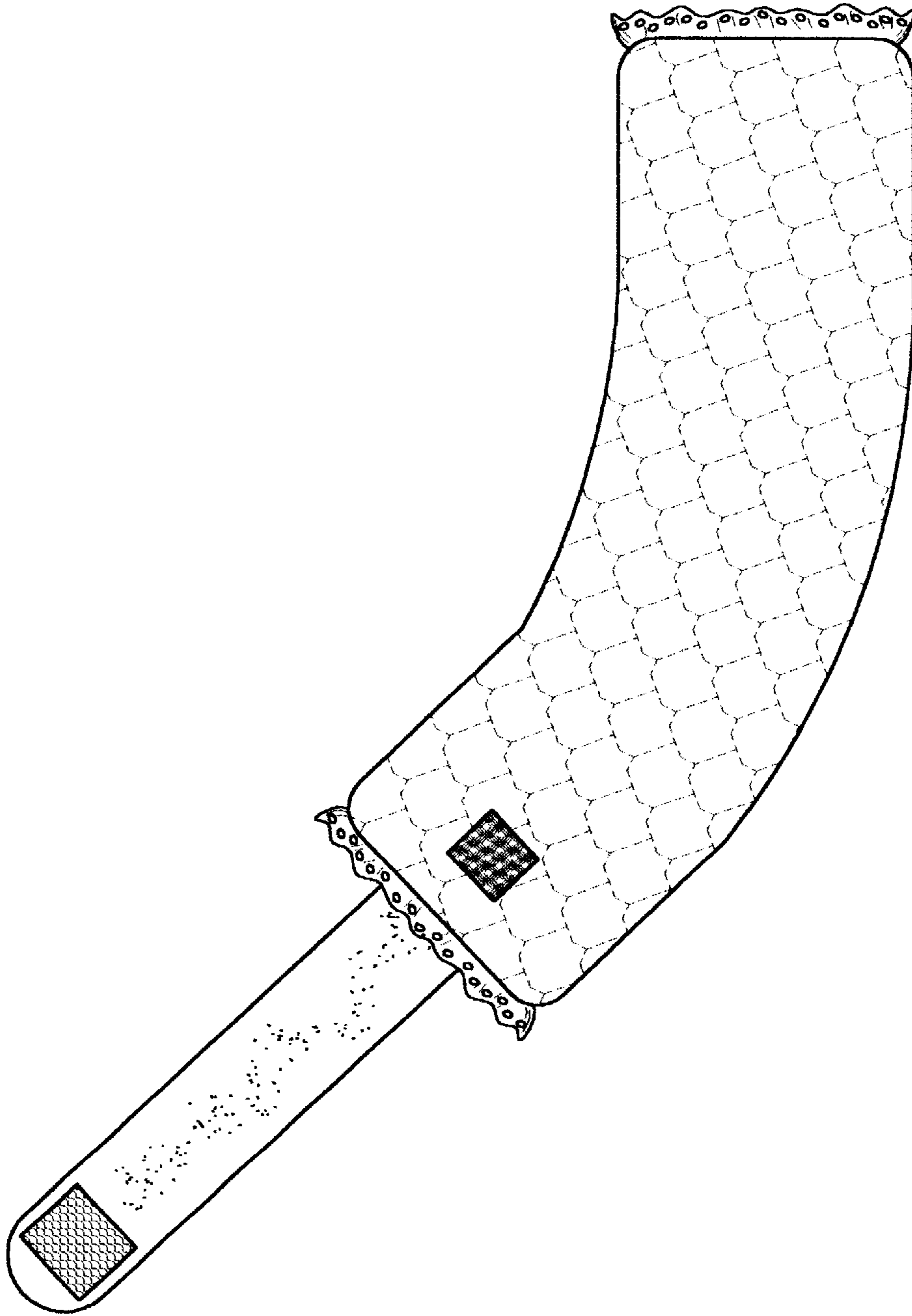

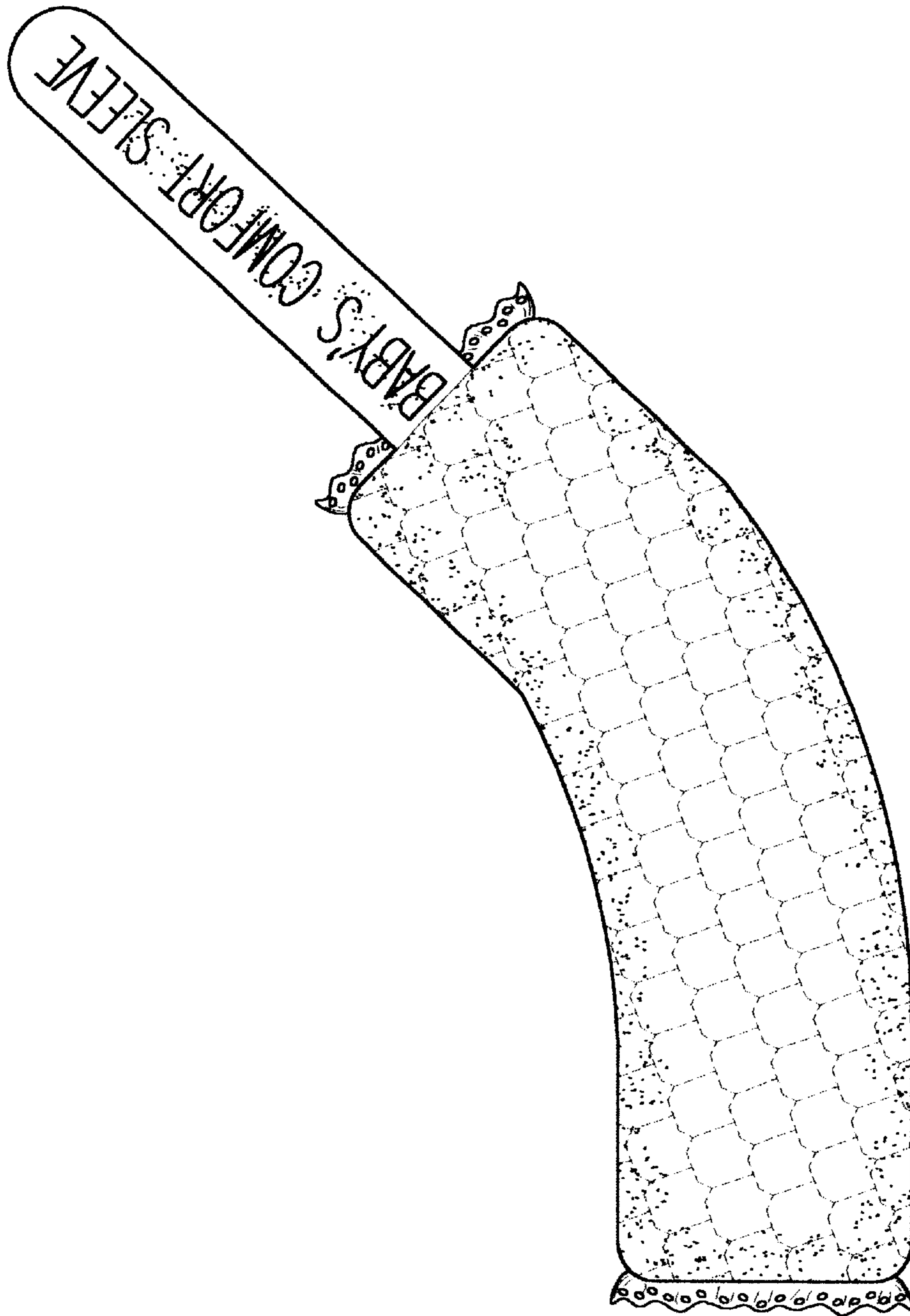

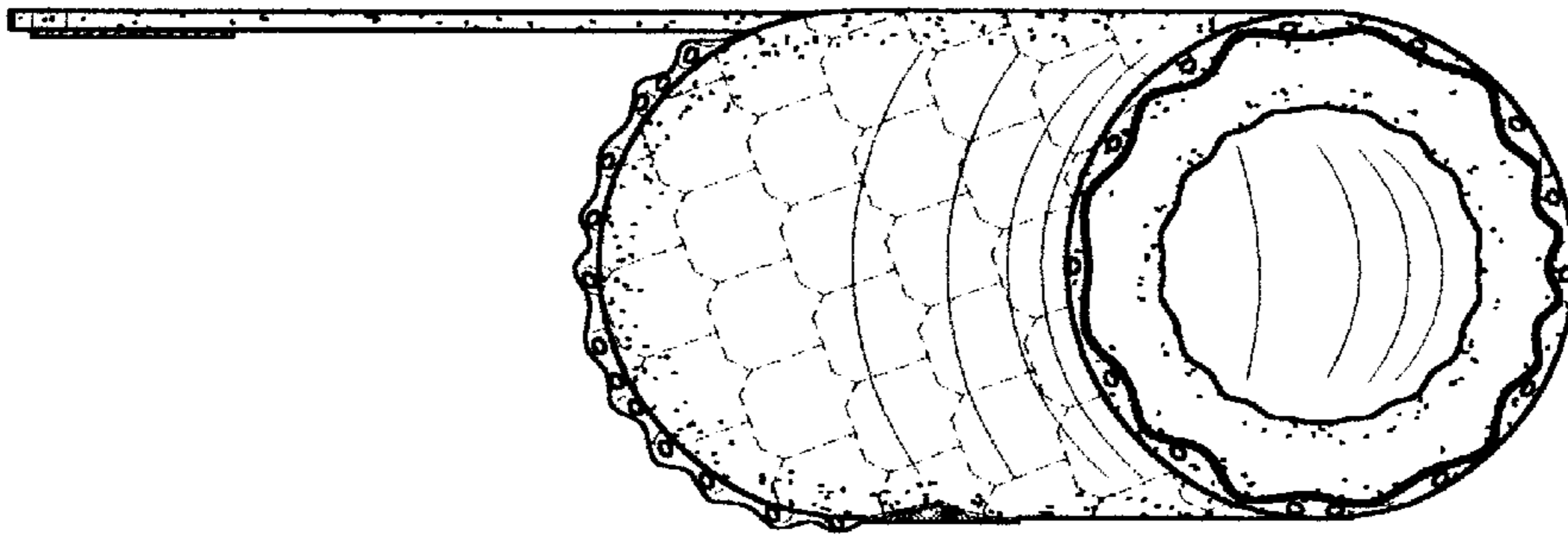

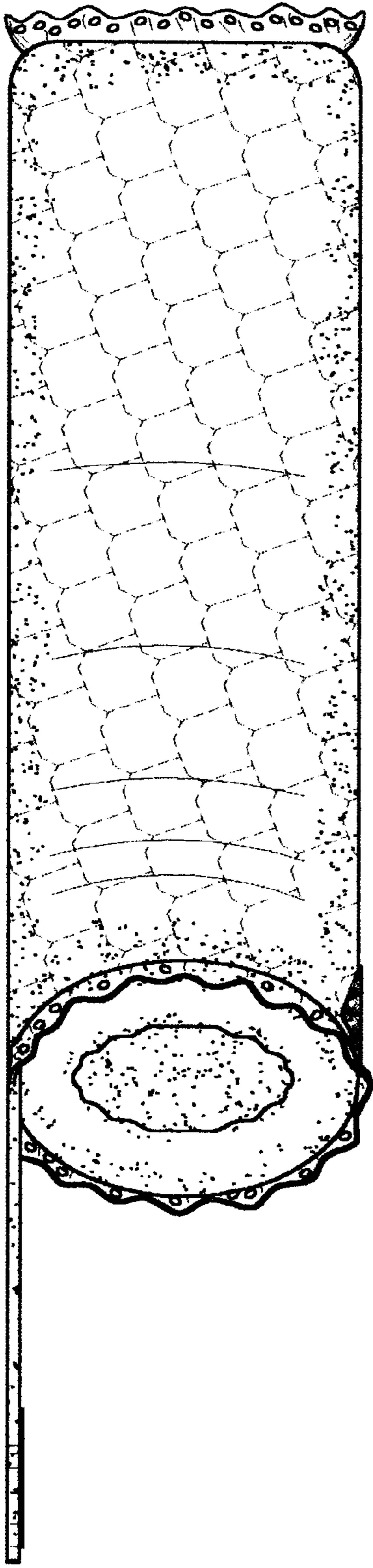

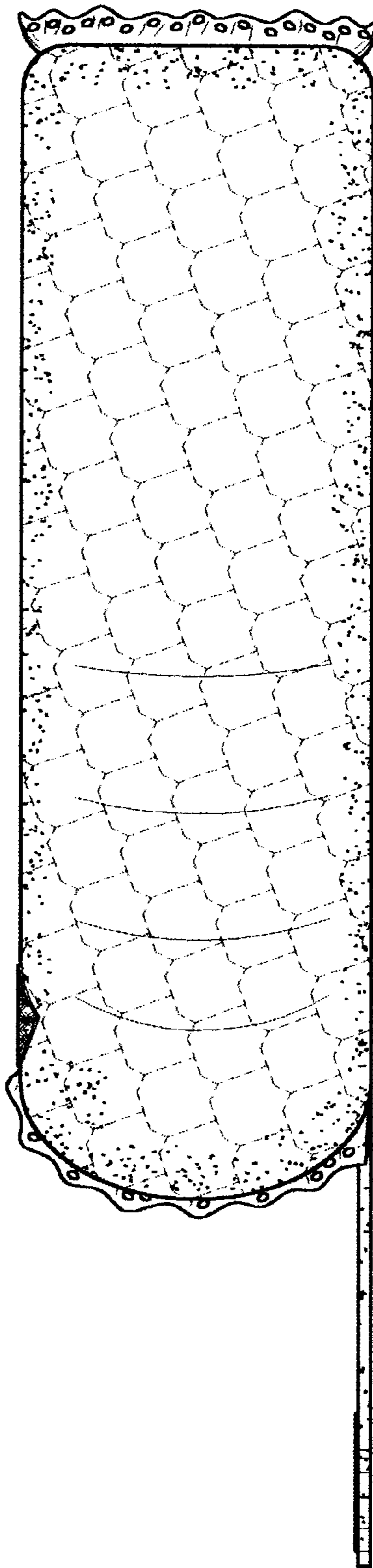
