(57) **CLAIM**

The ornamental design for a high chair liner, as shown and described.

**DESCRIPTION**

FIG. 1 is a front plan view of a high chair liner showing my new design;

FIG. 2 is a rear plan view thereof;

FIG. 3 is a left side elevation view thereof;

FIG. 4 is a right side elevation view thereof;

FIG. 5 is a top plan view thereof;

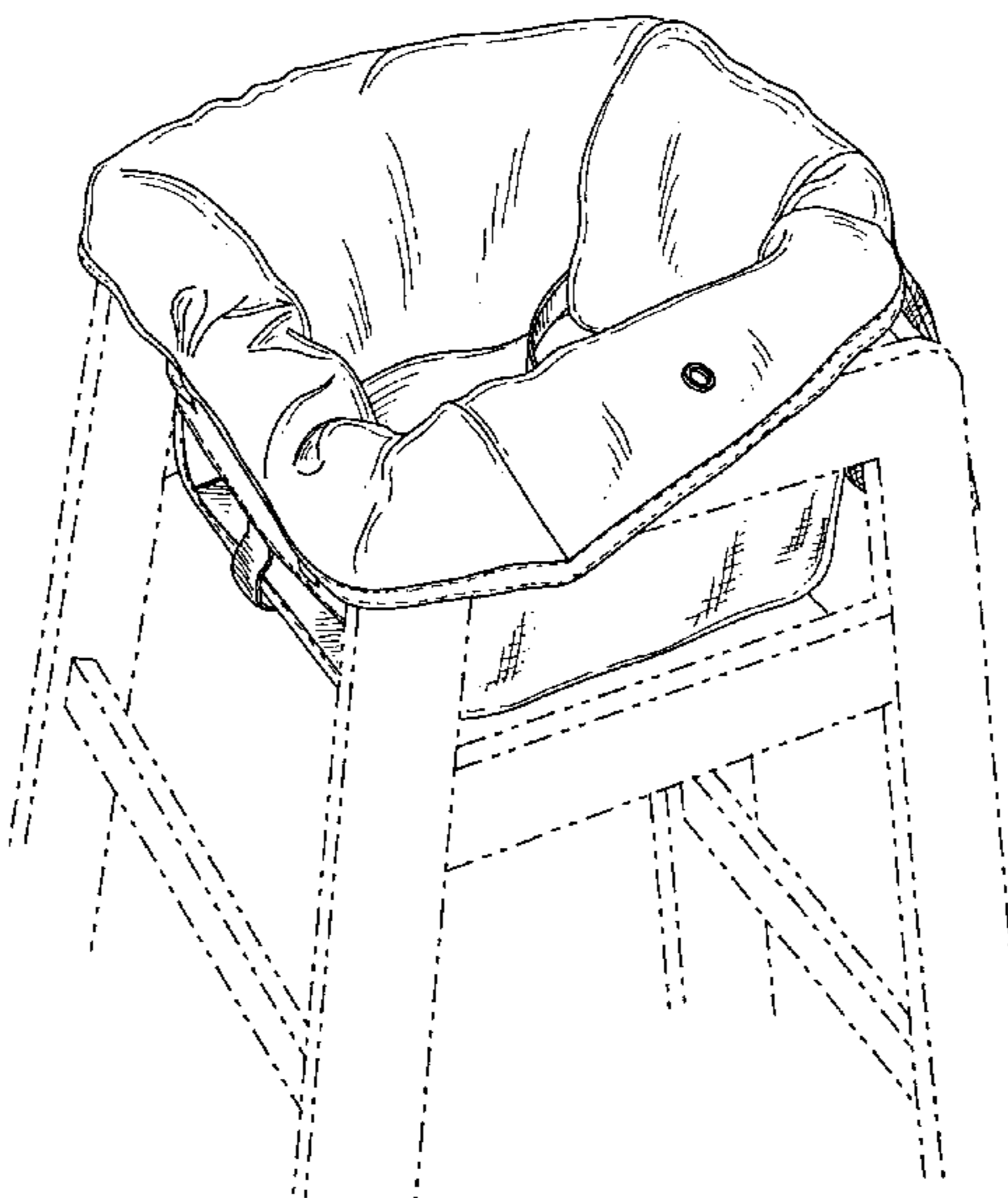
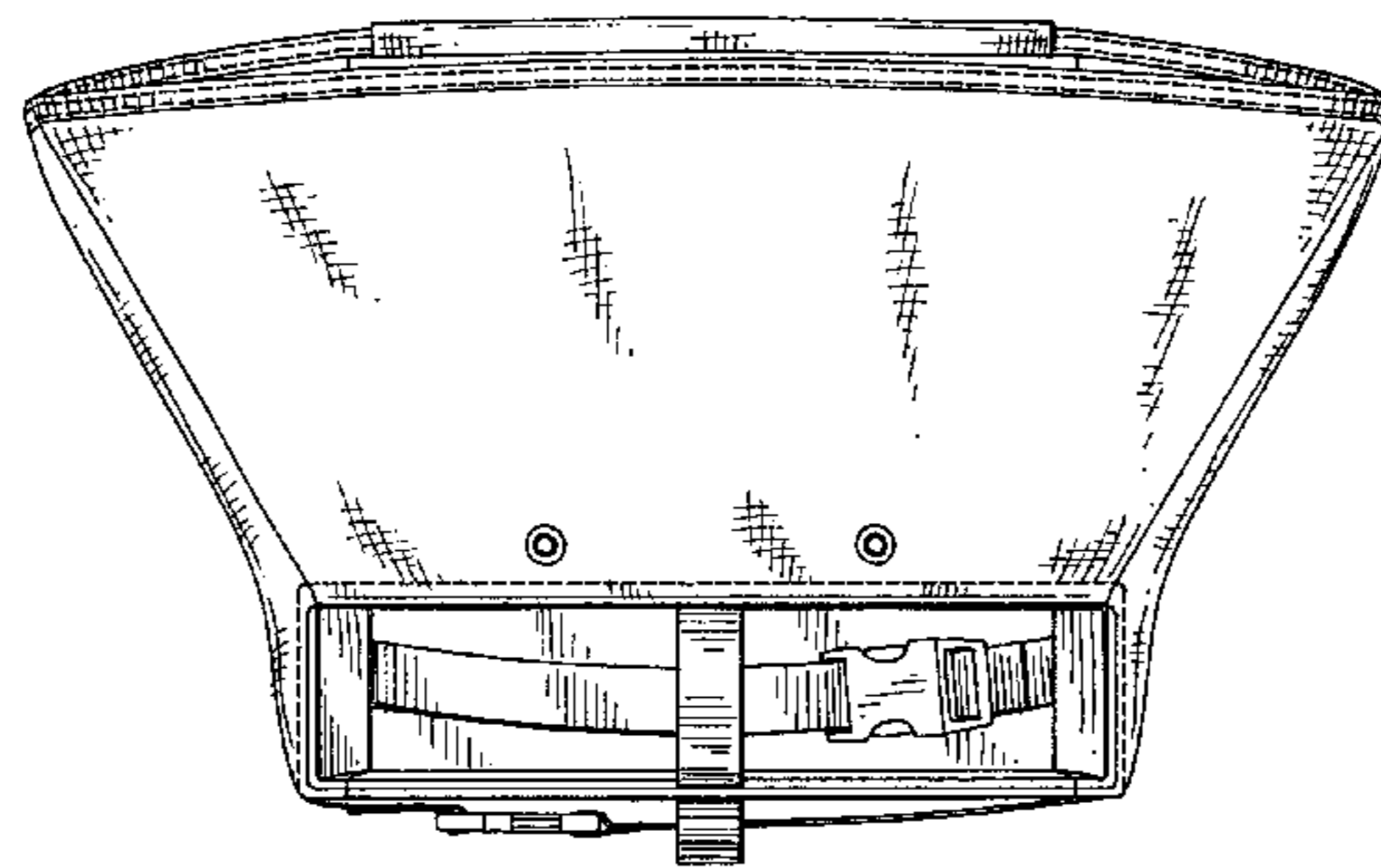
FIG. 6 is a bottom plan view thereof;

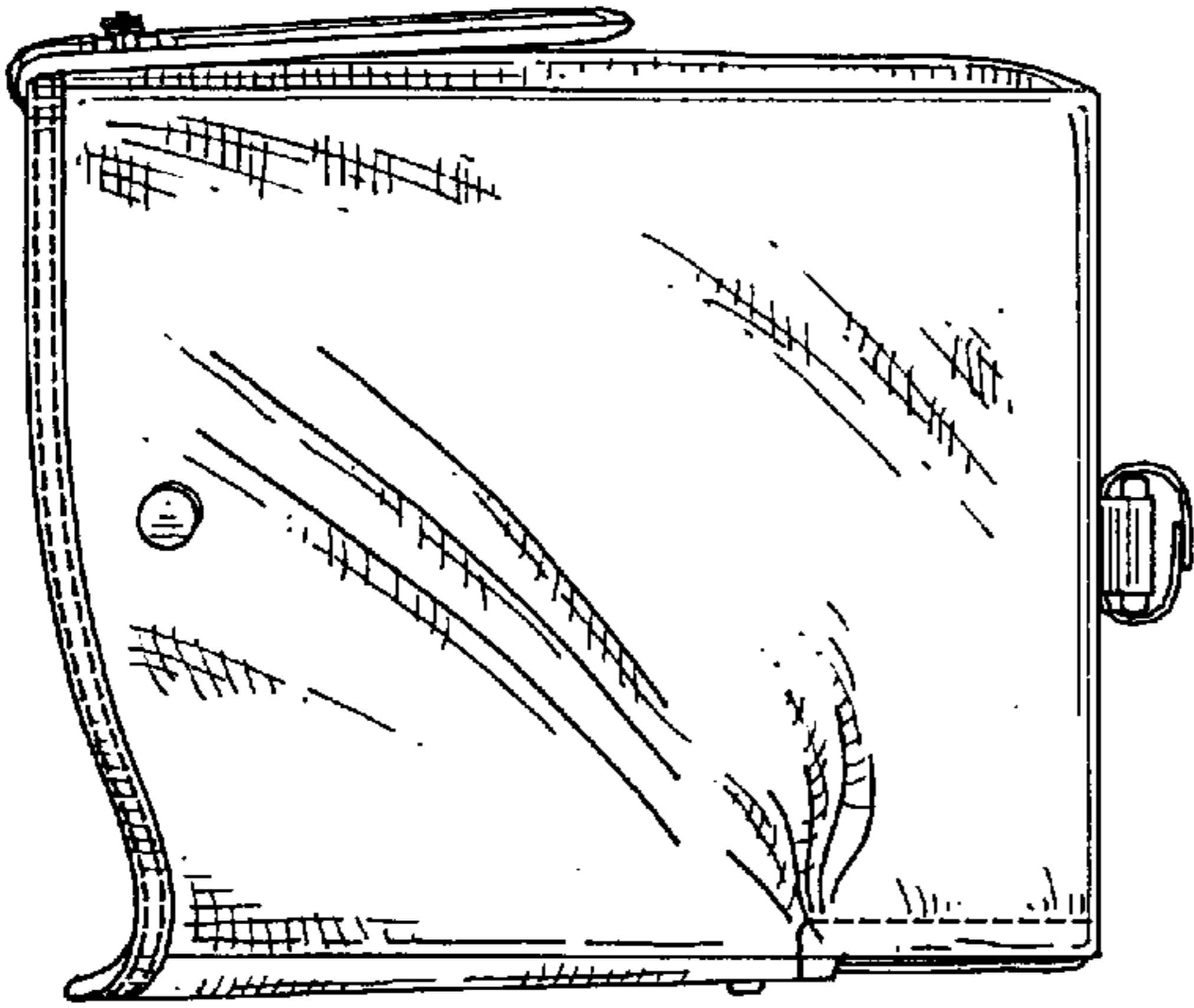

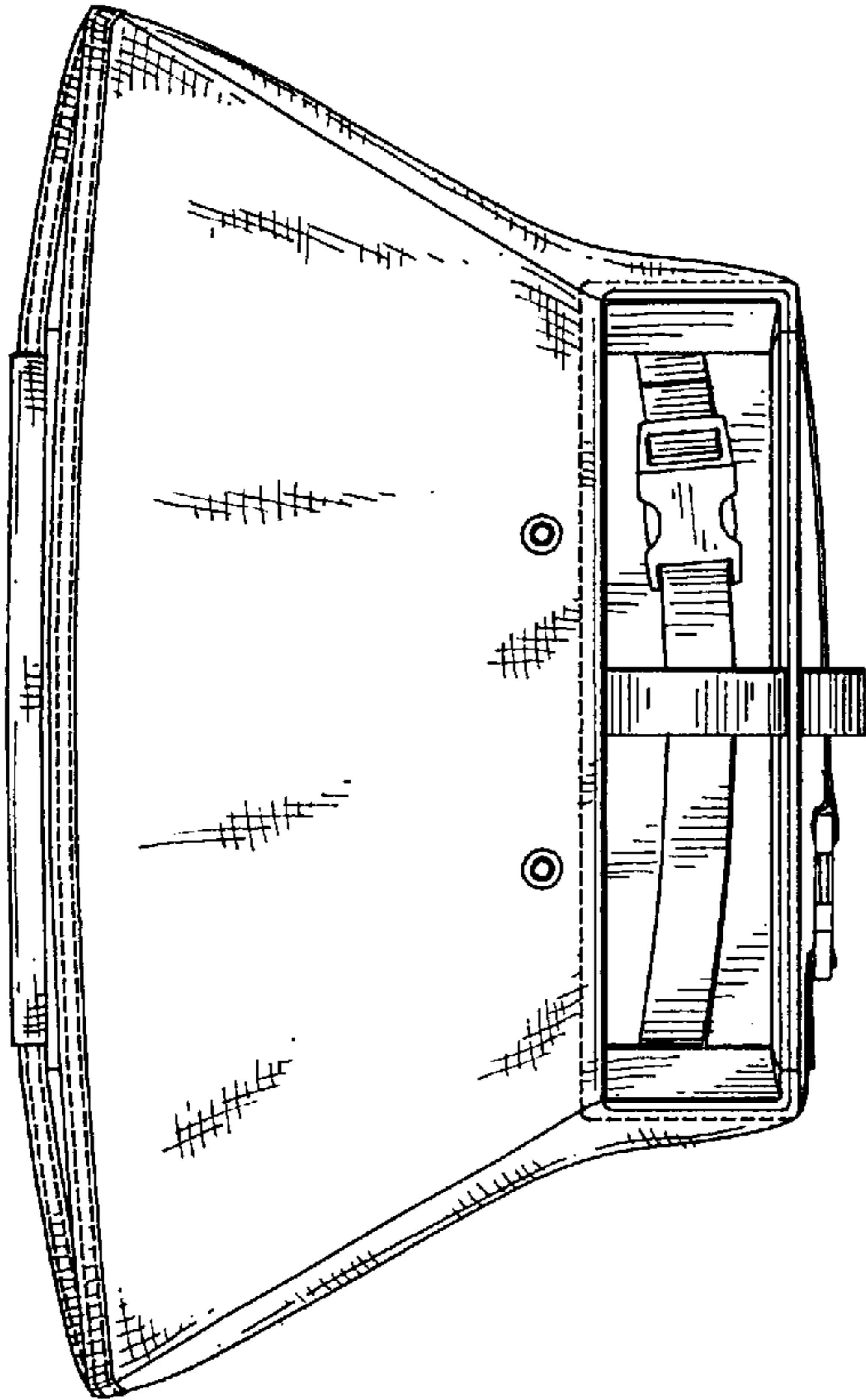

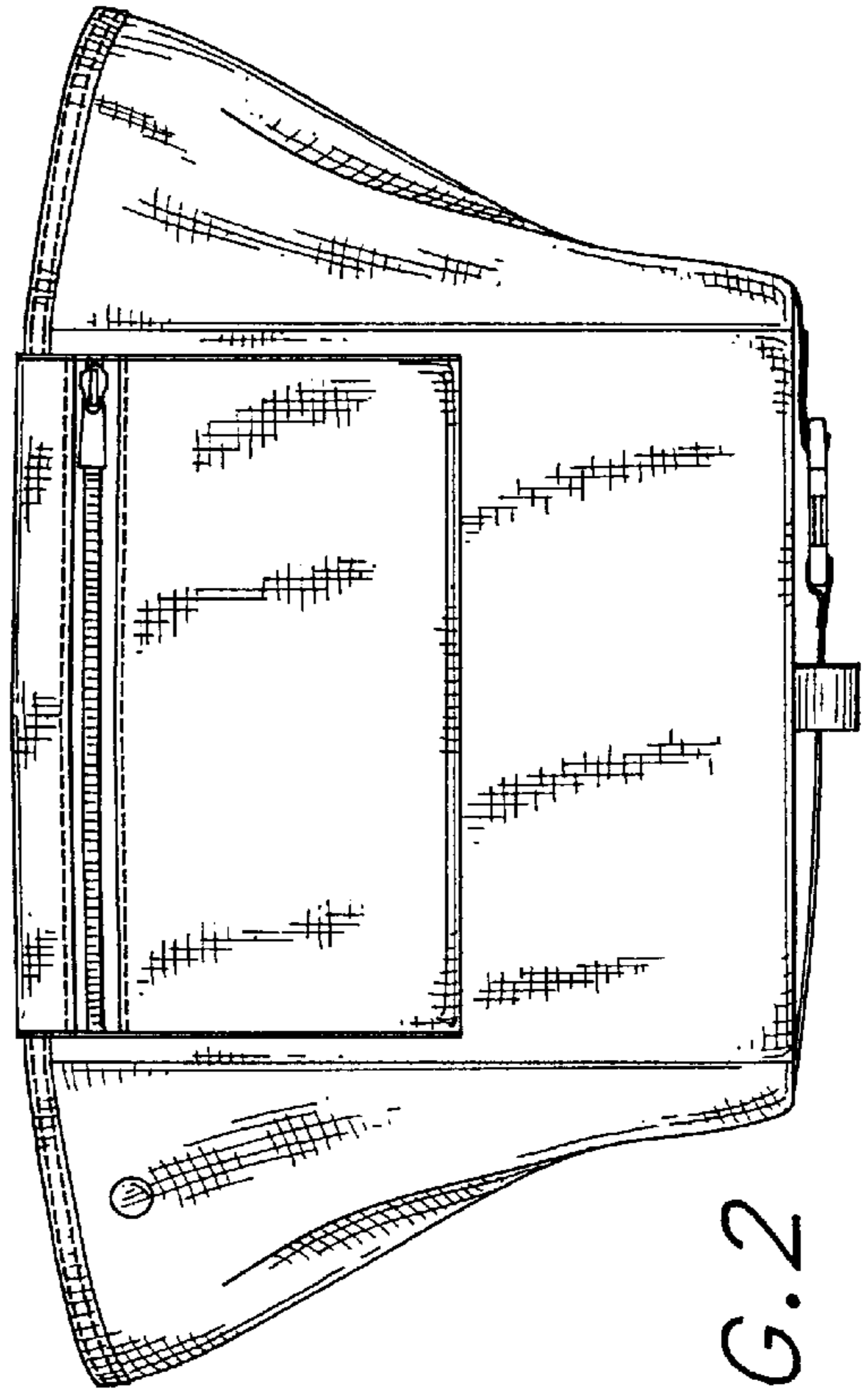

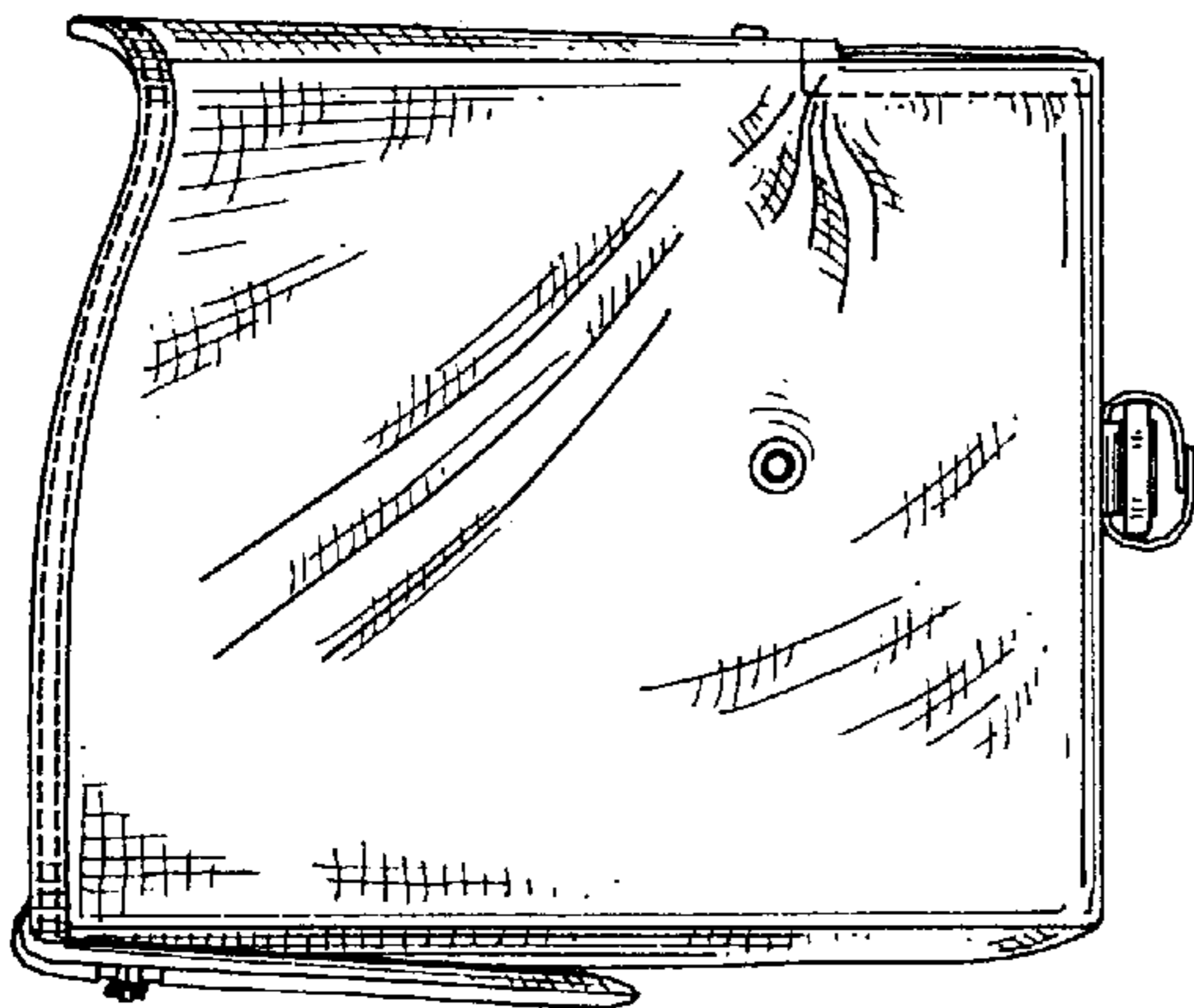

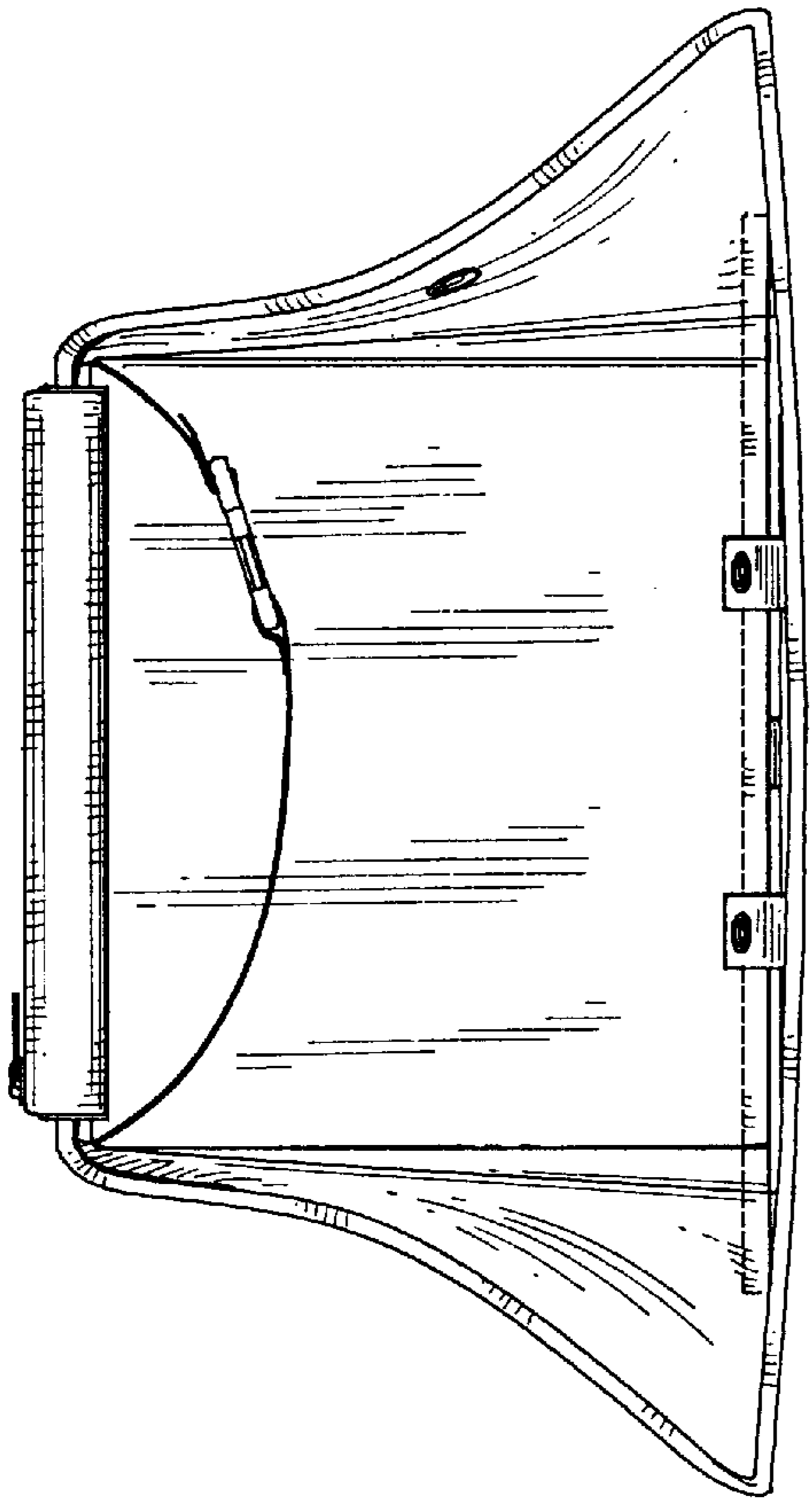
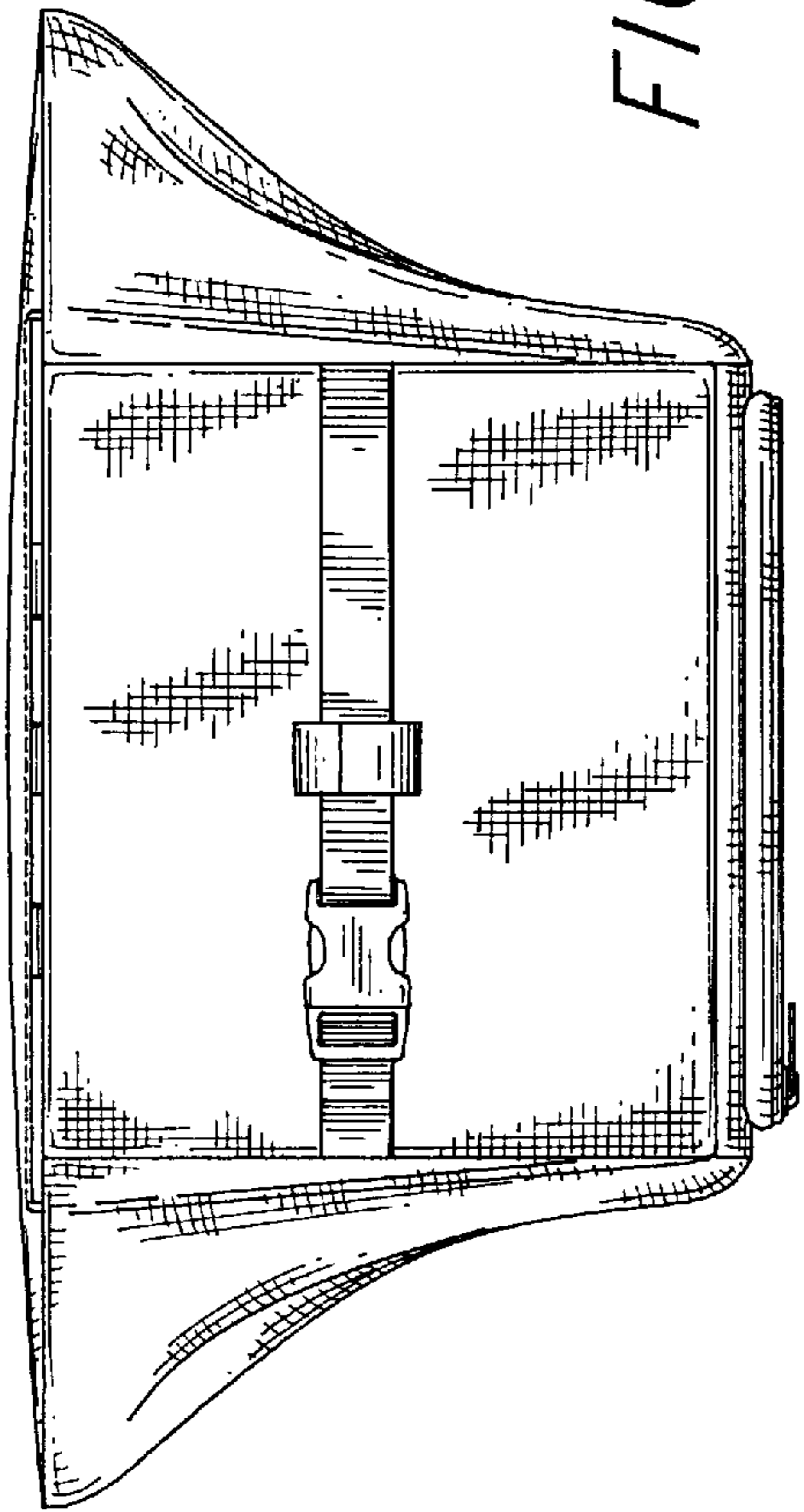

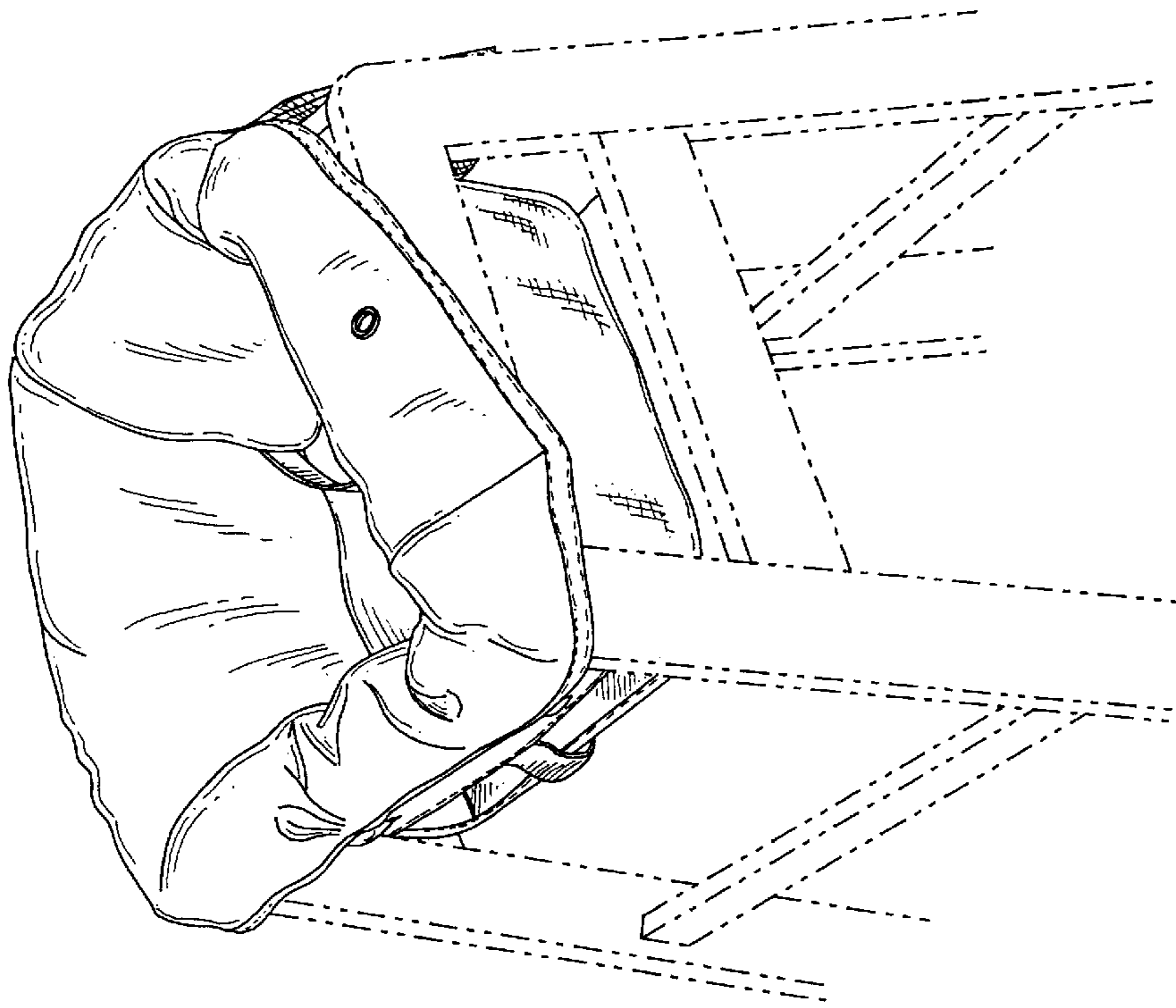

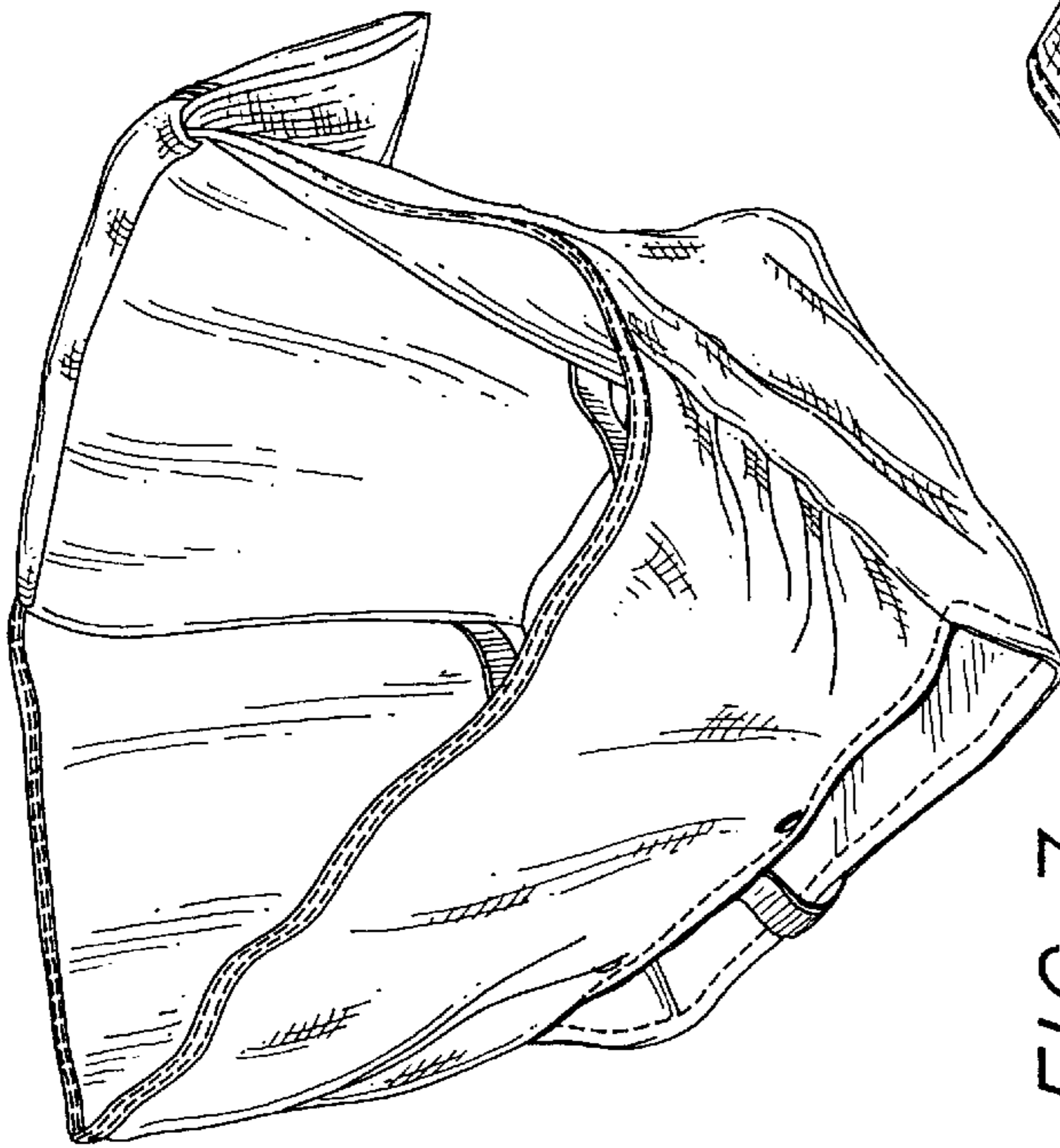

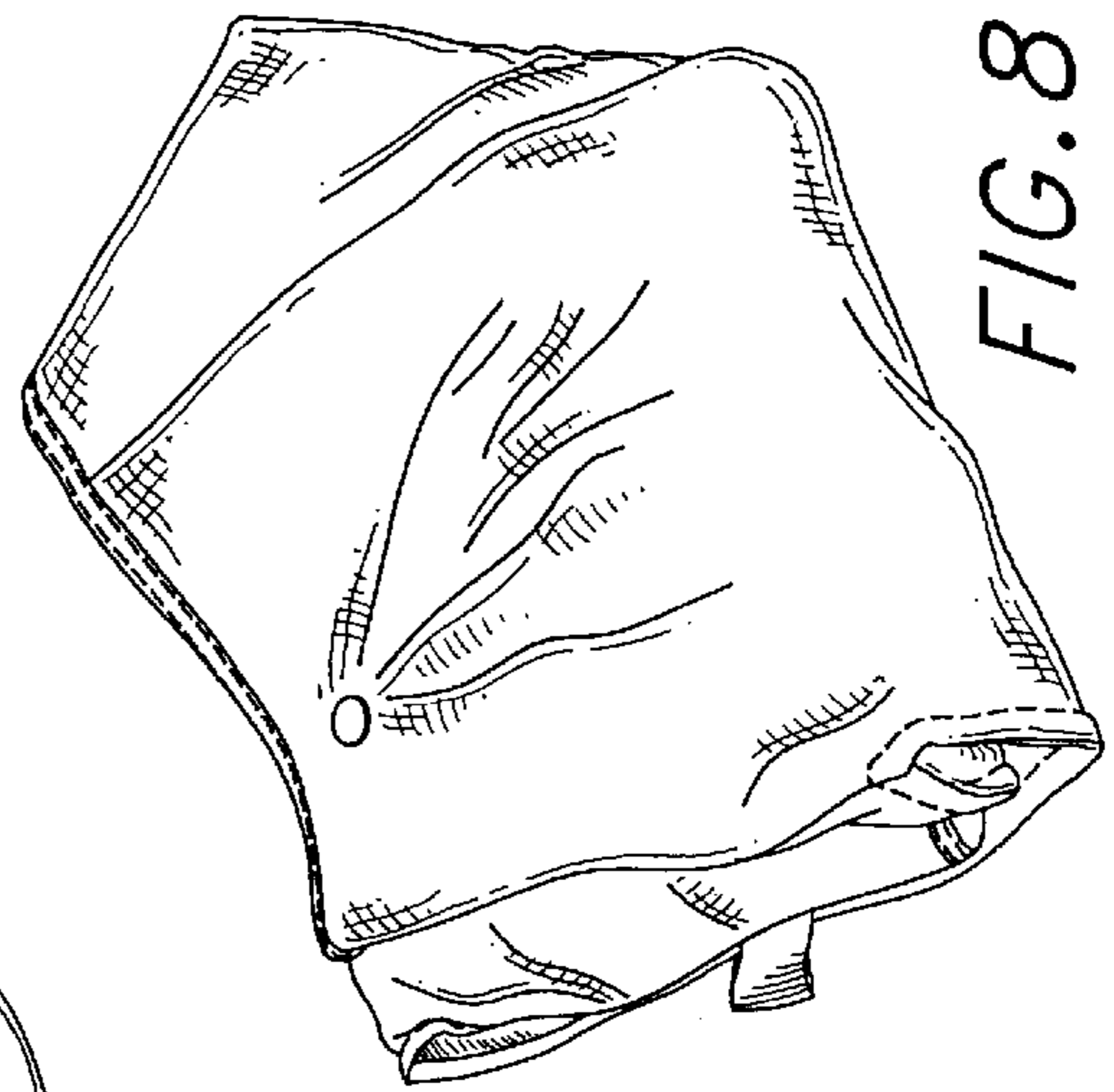
