(57) **CLAIM**

The ornamental design for a combined cosmetic container and cap, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view showing my new design with its cap in a closed position;

FIG. 2 is a front end elevational view showing the cap in its closed position; the back end elevational view being identical thereto;

FIG. 3 is a right side elevational view showing the cap in its closed position; the left side elevational view being identical thereto;

FIG. 4 is a top plan view showing the cap in its closed position;

FIG. 5 is a bottom plan view;

FIG. 6 is an exploded top perspective view showing the cap in its open position;

FIG. 7 is a top plan view without the cap for clarity of illustration; and,

FIG. 8 is a right side elevational view without the cap for clarity of illustration.

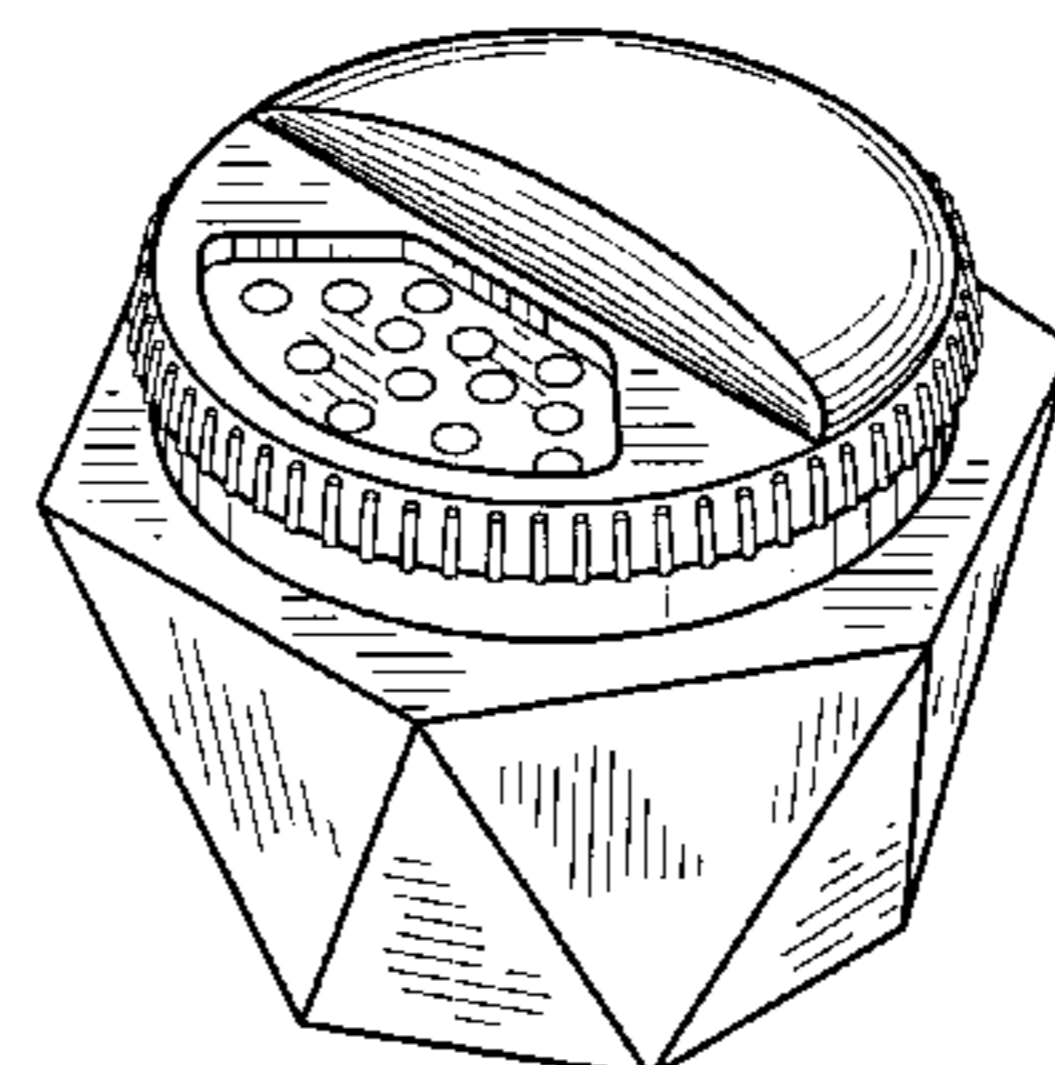
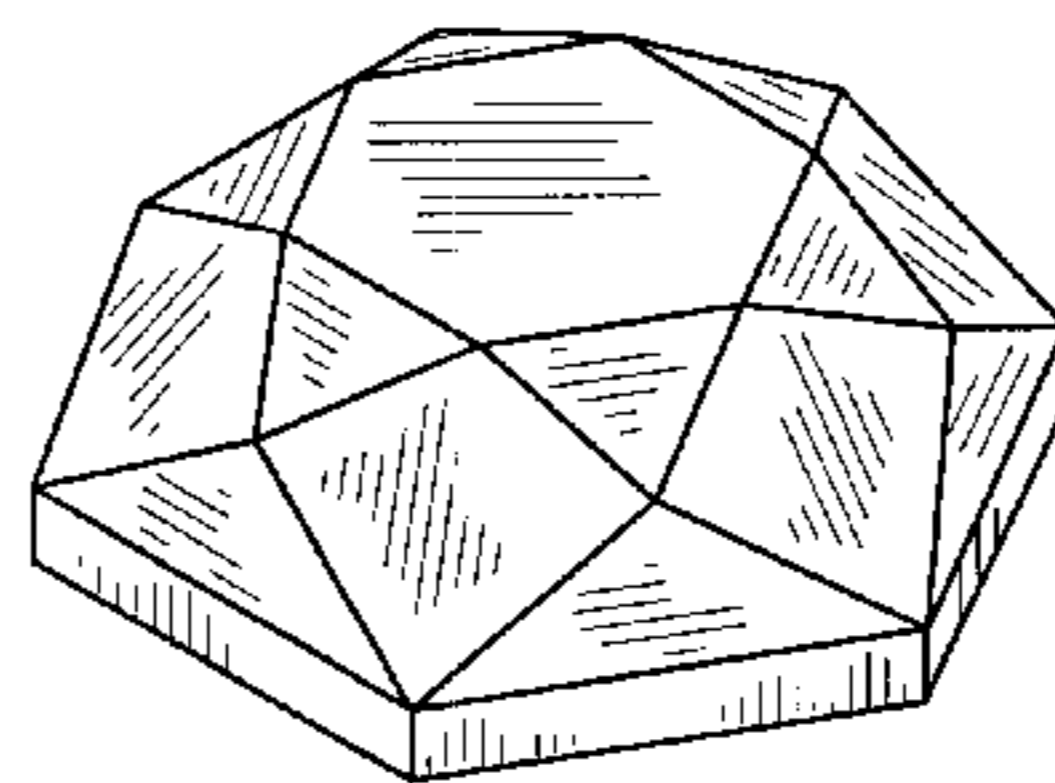
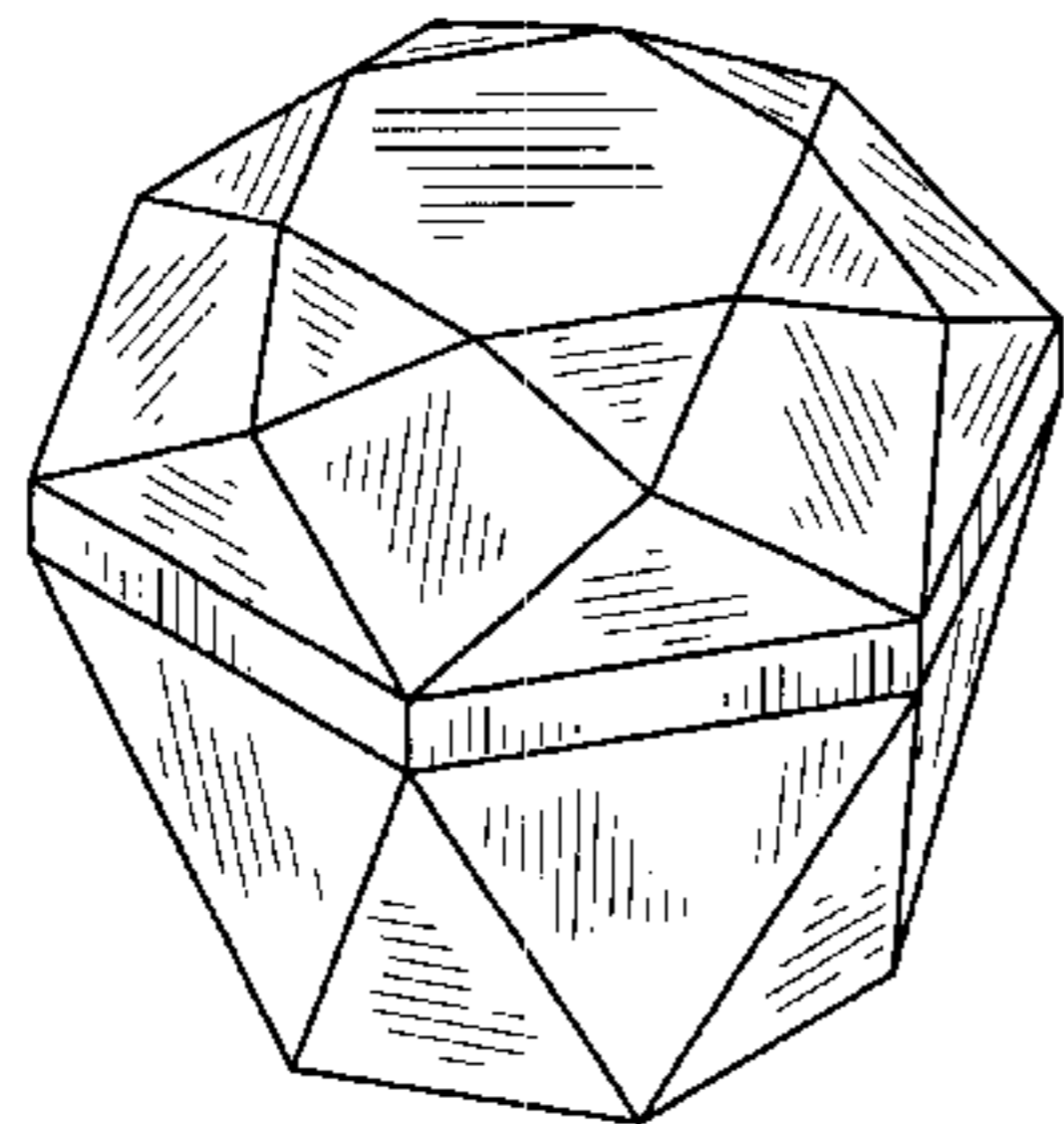

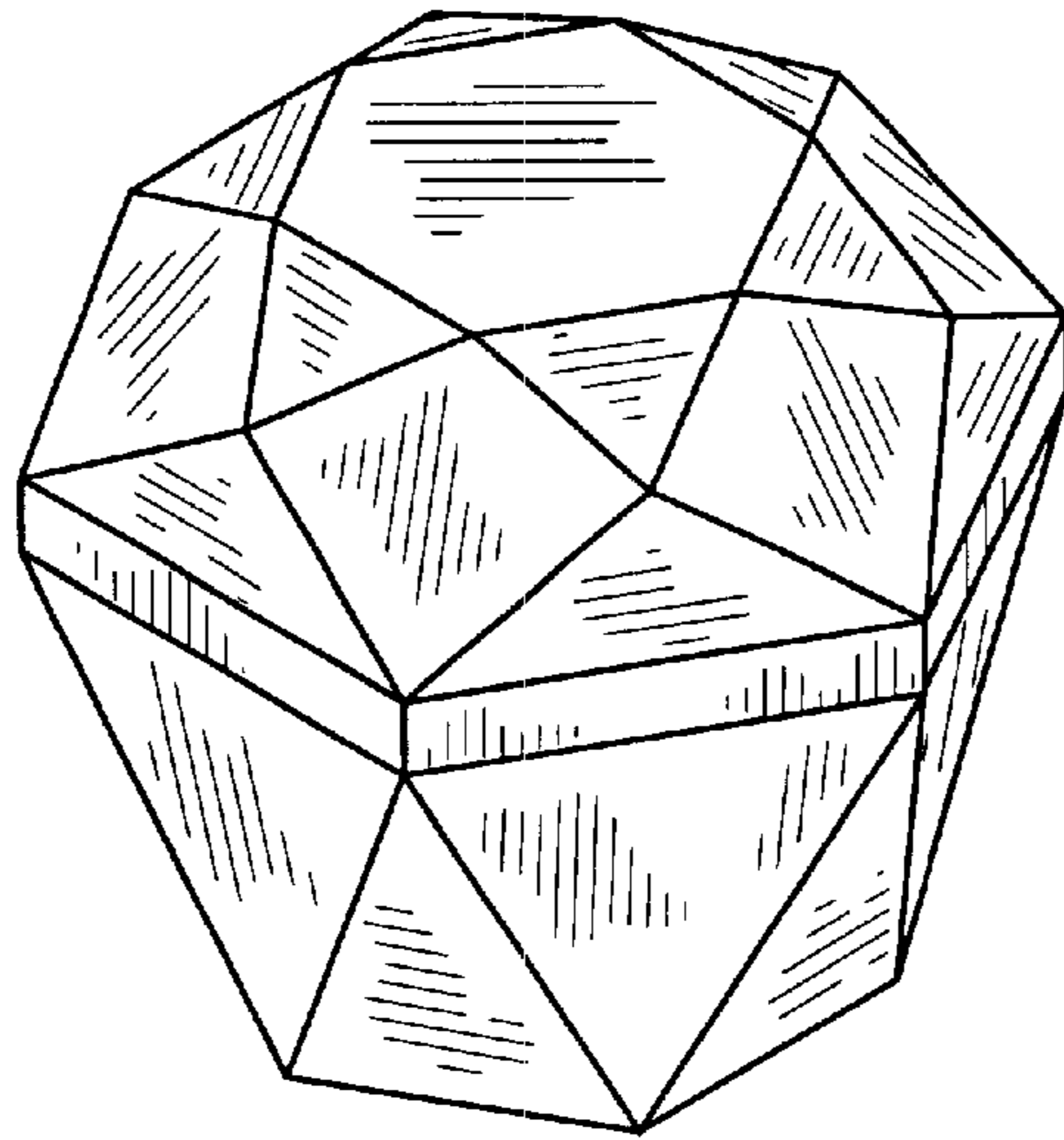

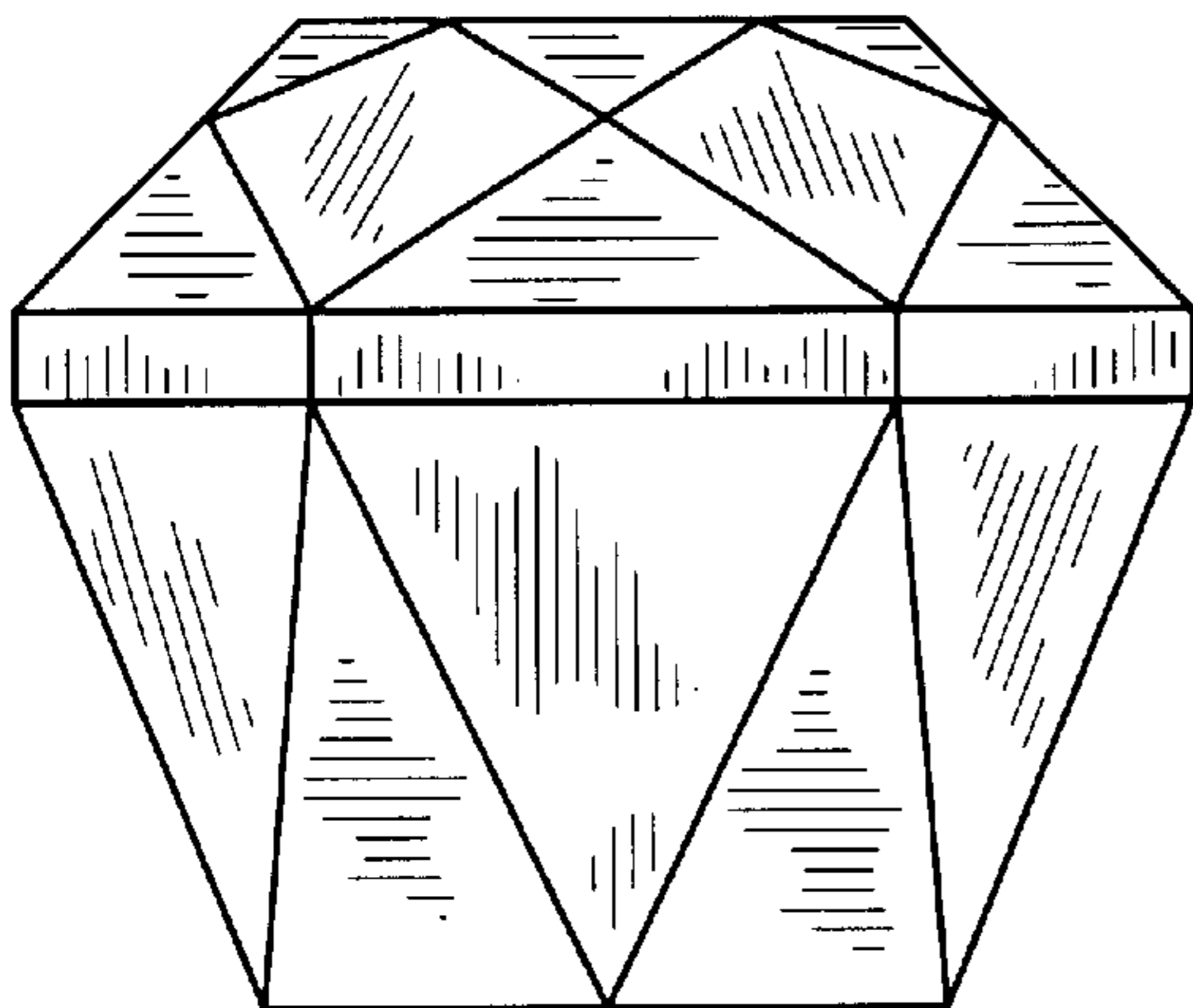

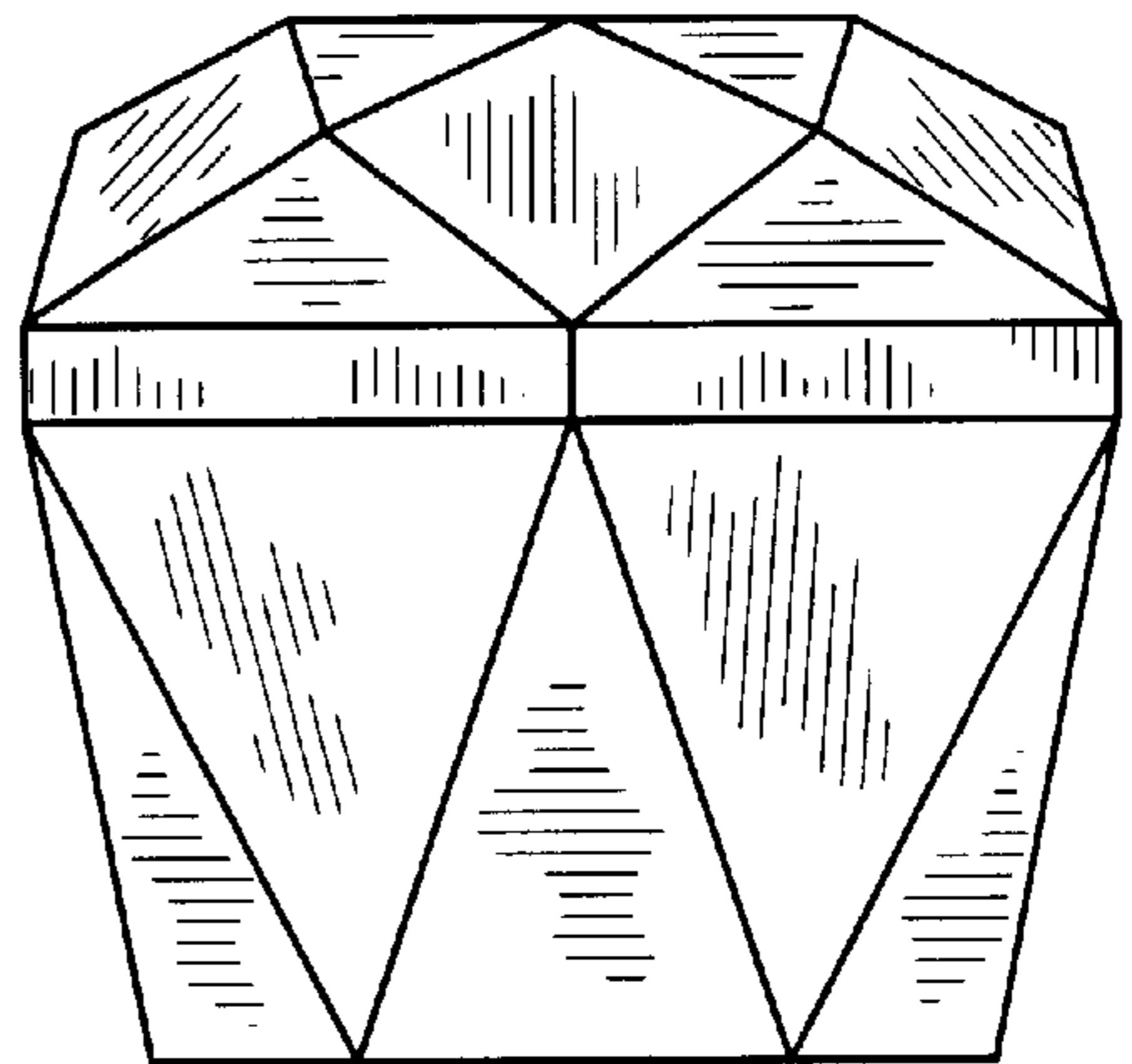

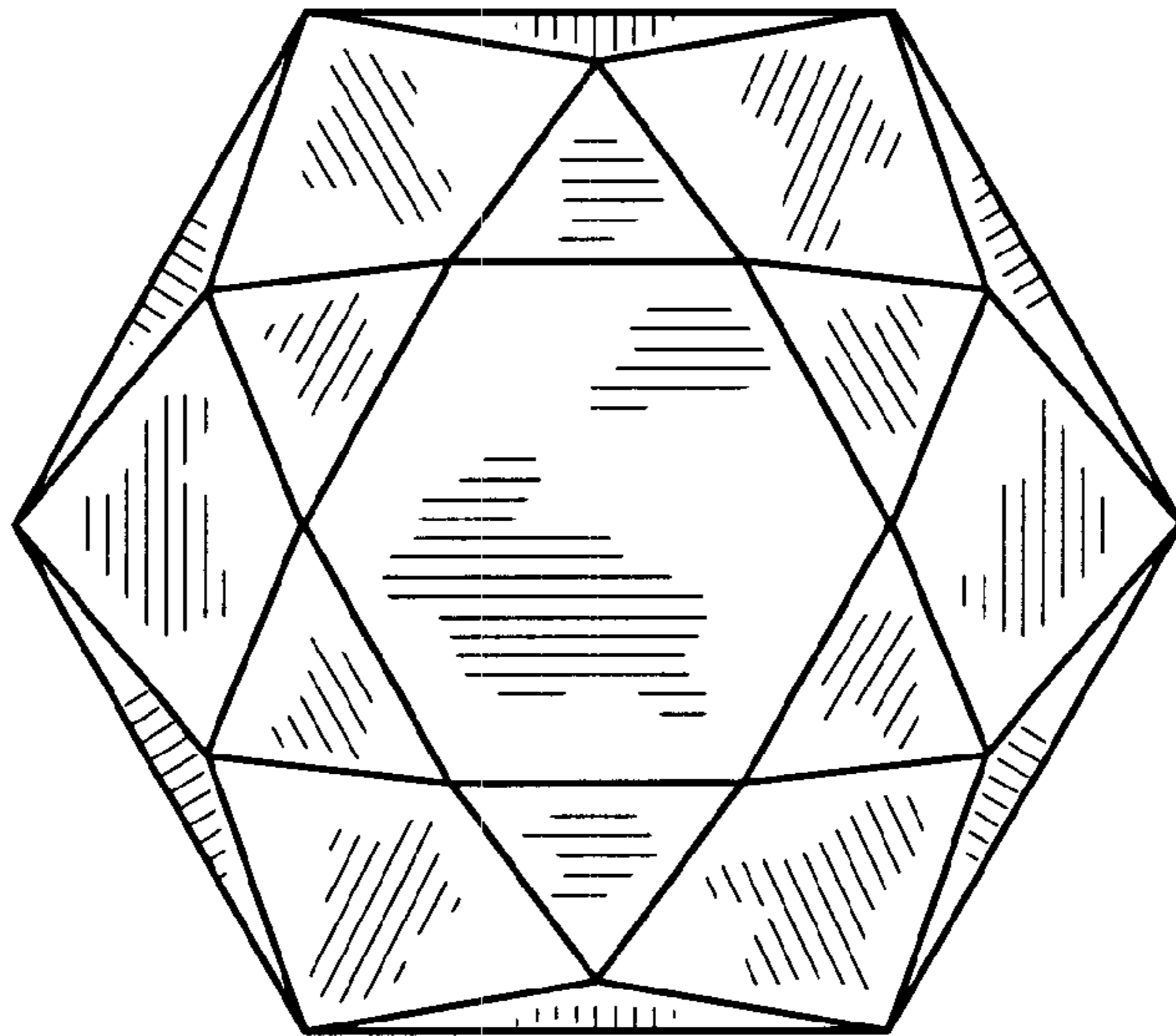

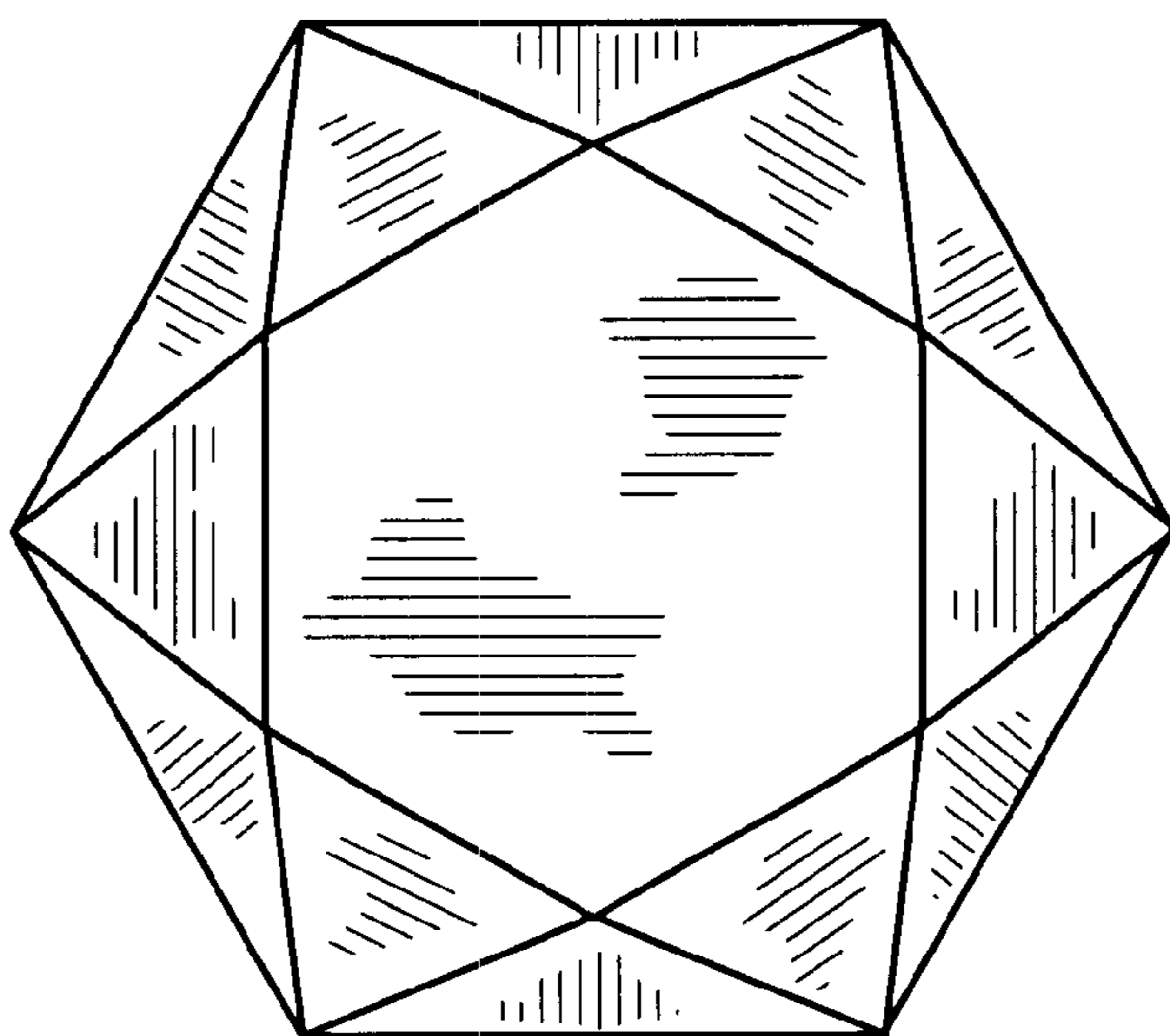

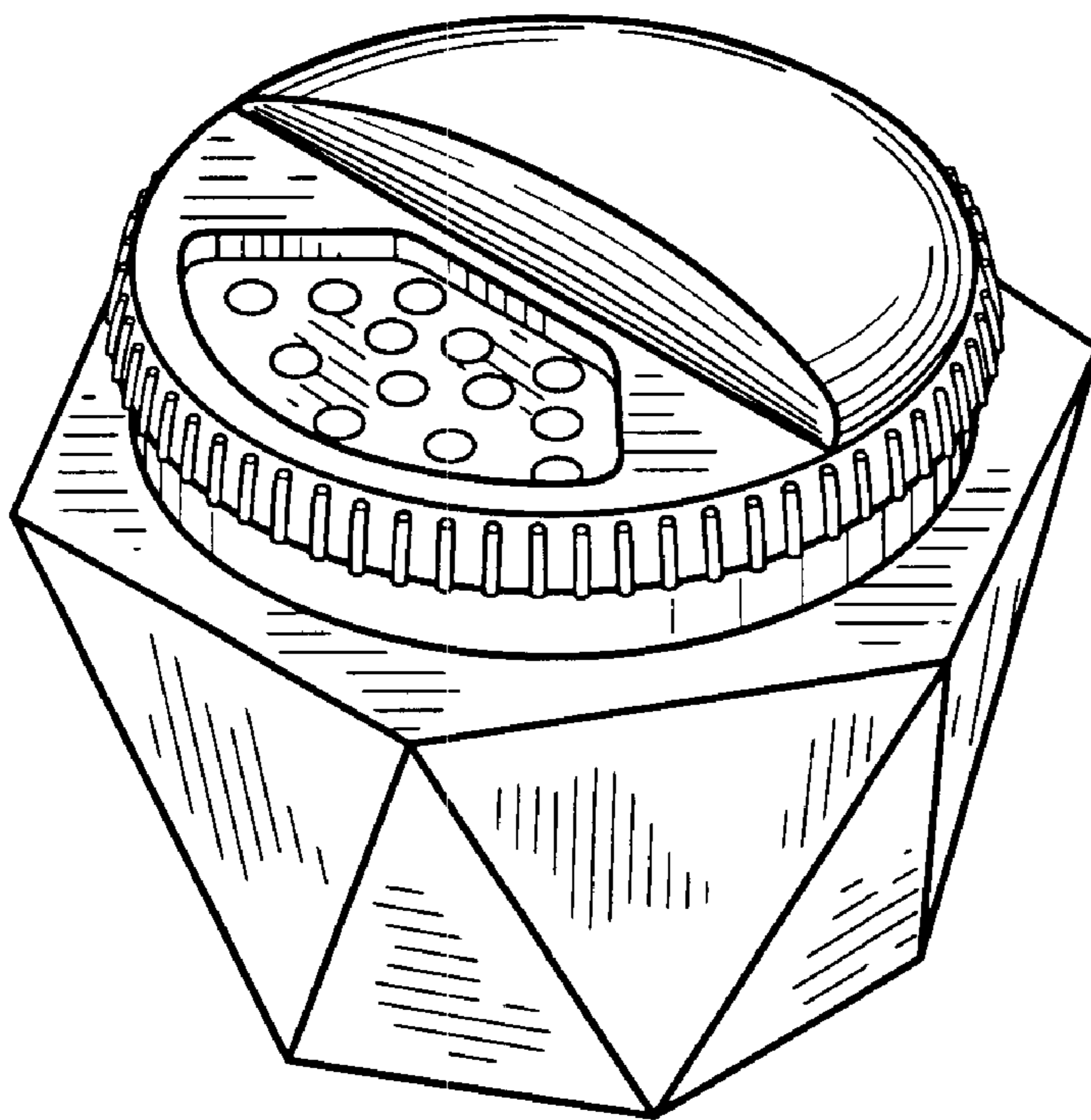
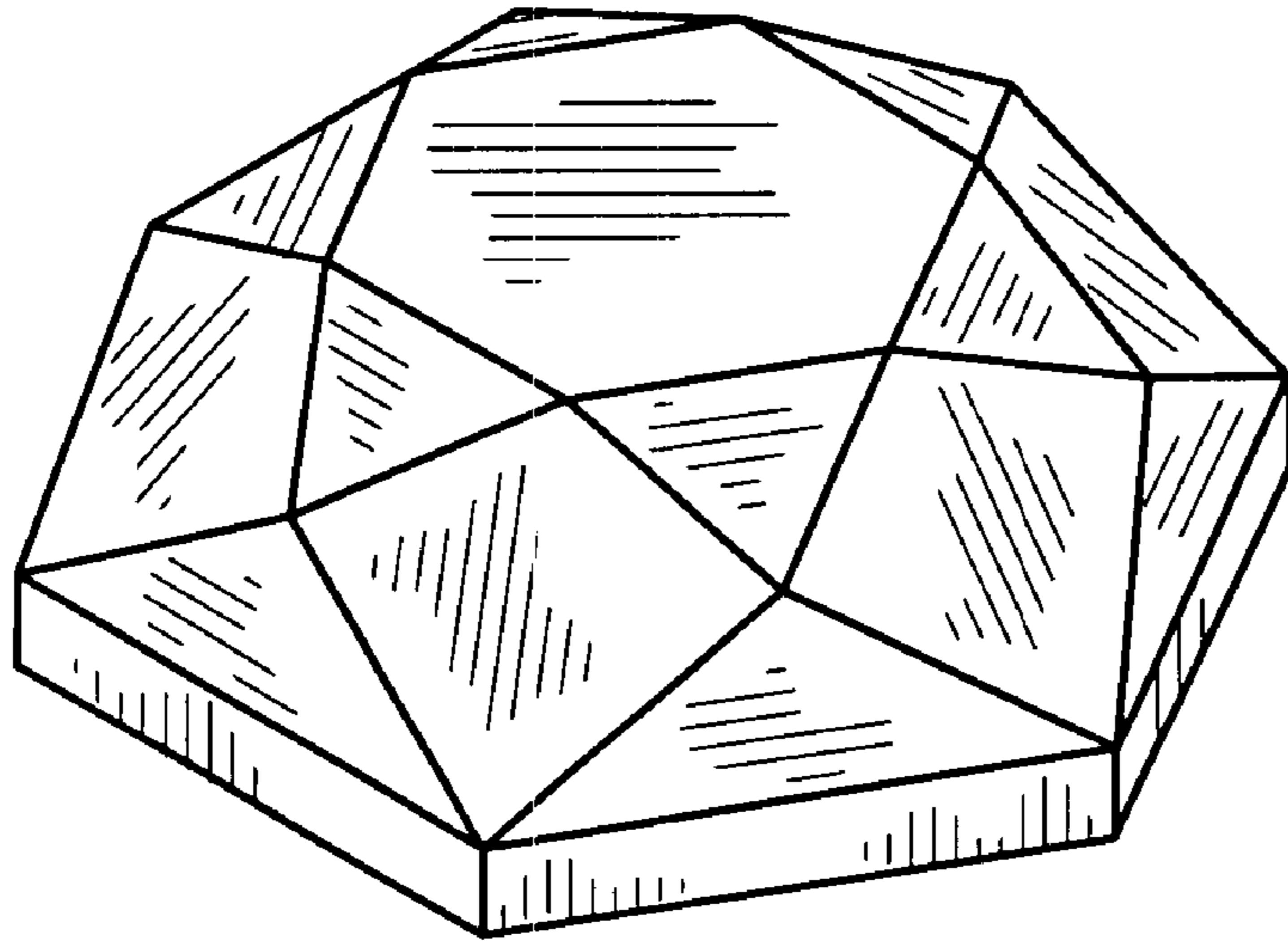

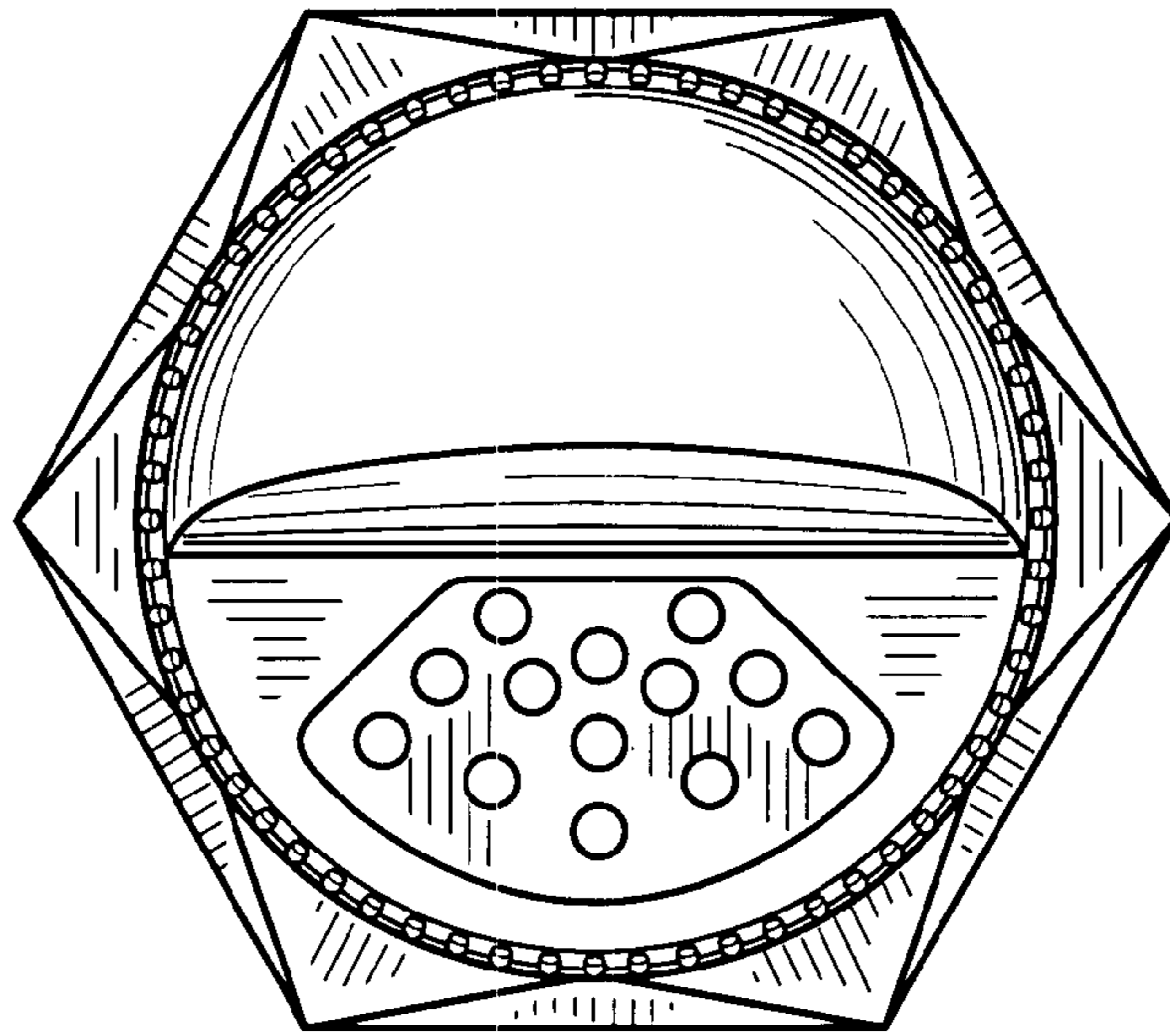
