(57) **CLAIM**

The ornamental design for a bottle, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a first embodiment of a bottle showing my new design;

FIG. 2 is a plan view thereof;

FIG. 3 is a bottom view thereof;

FIG. 4 is a left side view thereof;

FIG. 5 is a front elevation view thereof;

FIG. 6 is a right side view thereof;

FIG. 7 is a rear elevation view thereof;

FIG. 8 is a sectional view thereof along the line 8—8 of the front elevation view;

FIG. 9 is a perspective view of a second embodiment of a bottle;

FIG. 10 is a plan view of the second embodiment;

FIG. 11 is a bottom view of the second embodiment;

FIG. 12 is a left side view of the second embodiment;

FIG. 13 is a front elevation view of the second embodiment;

FIG. 14 is a right side view of the second embodiment;

FIG. 15 is a rear elevation view of the second embodiment; and,

FIG. 16 is a sectional view along the line 16—16 of the front elevation view of the embodiment.

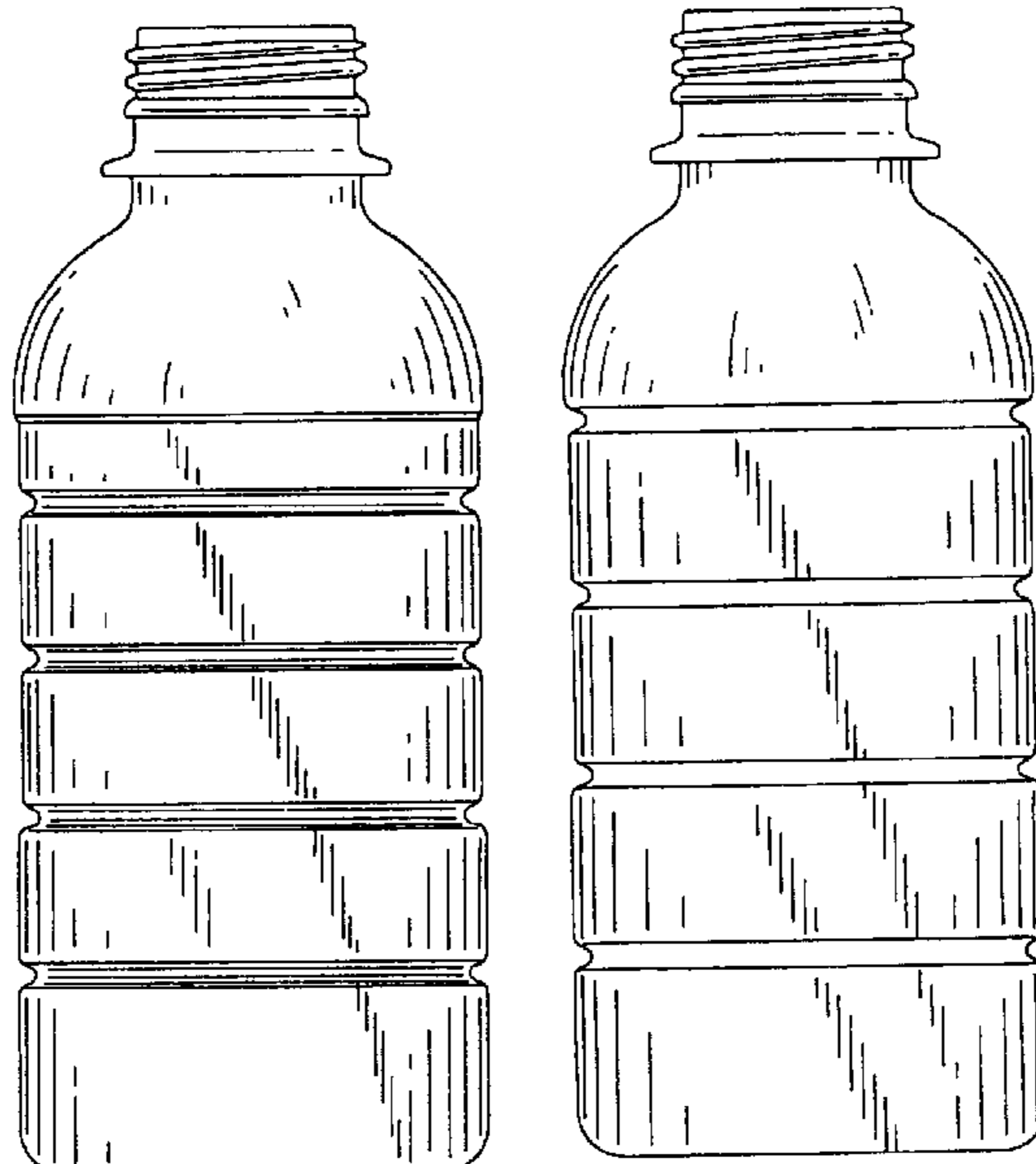

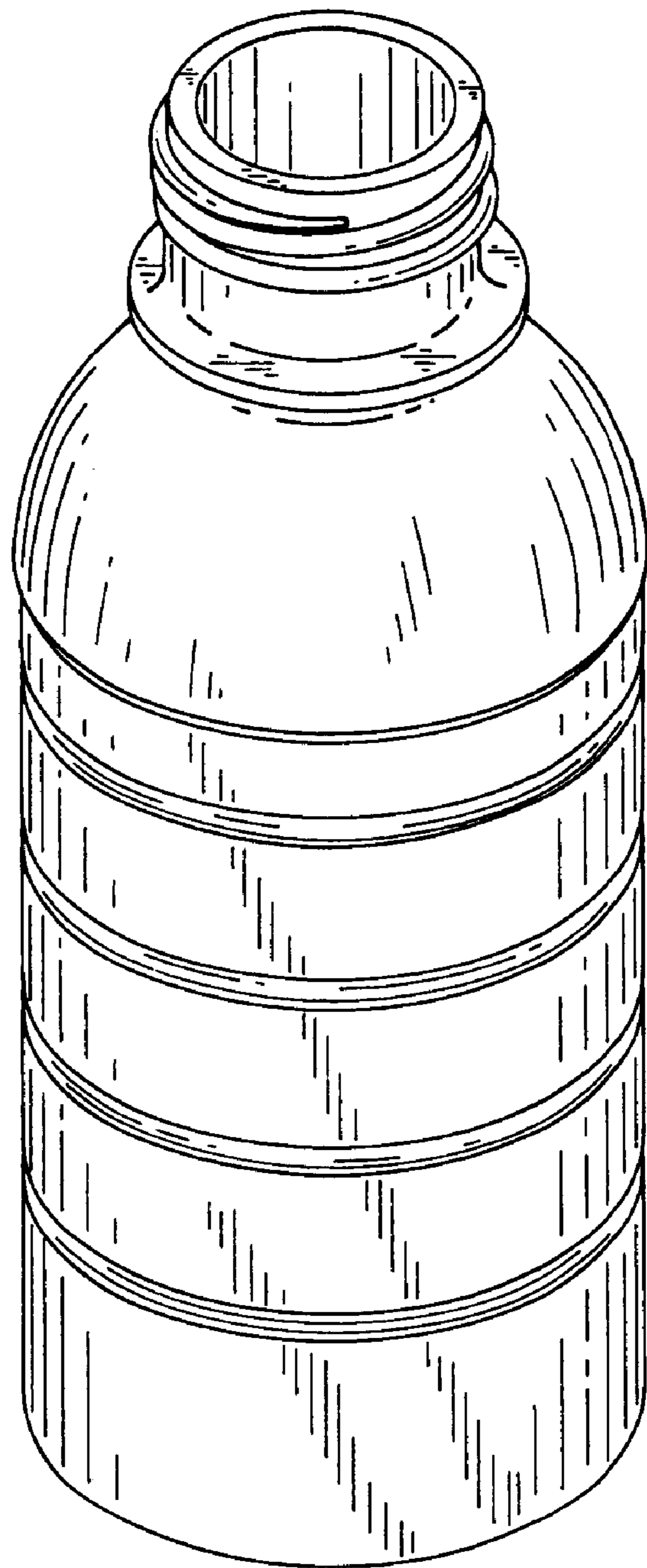

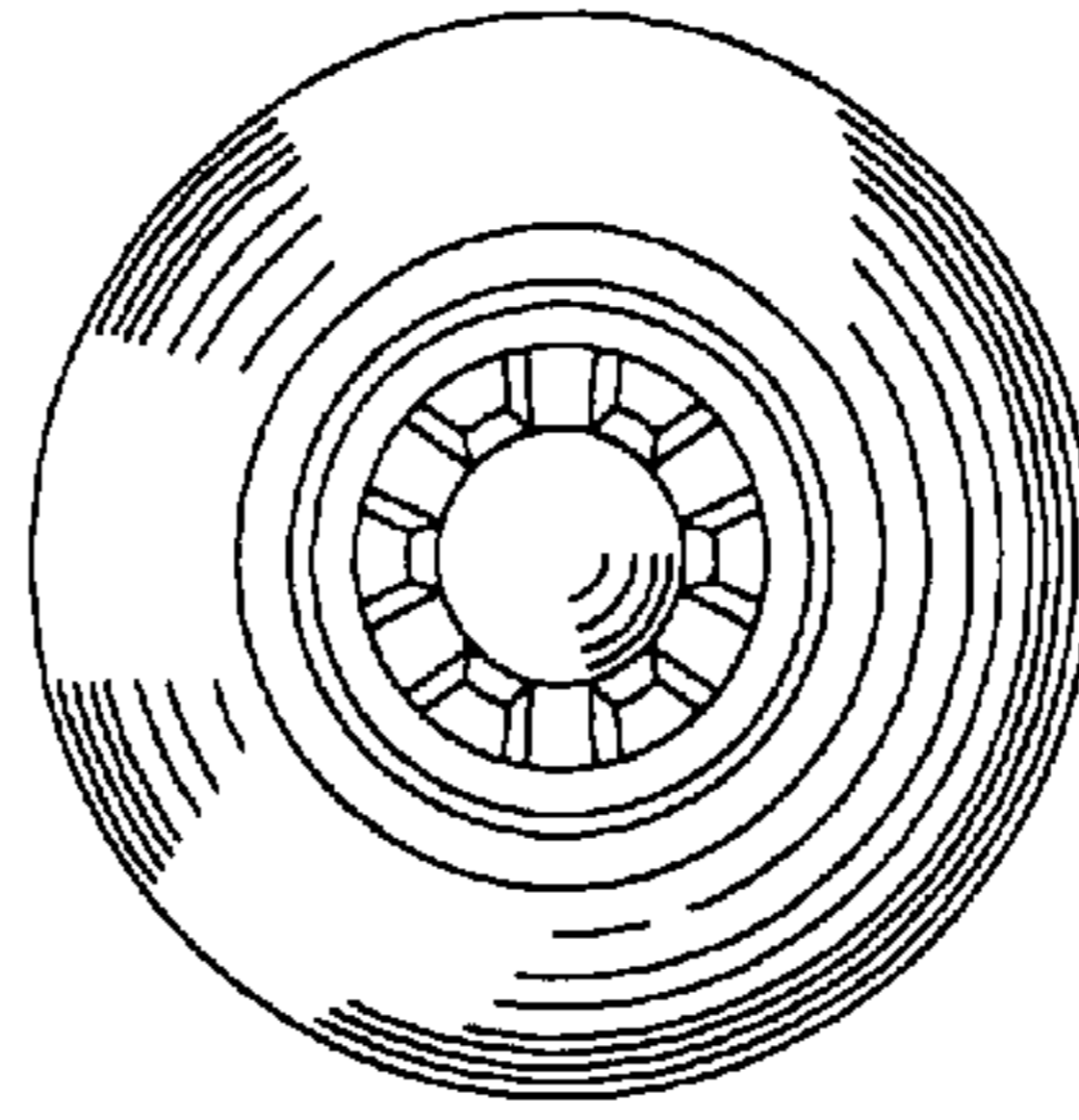

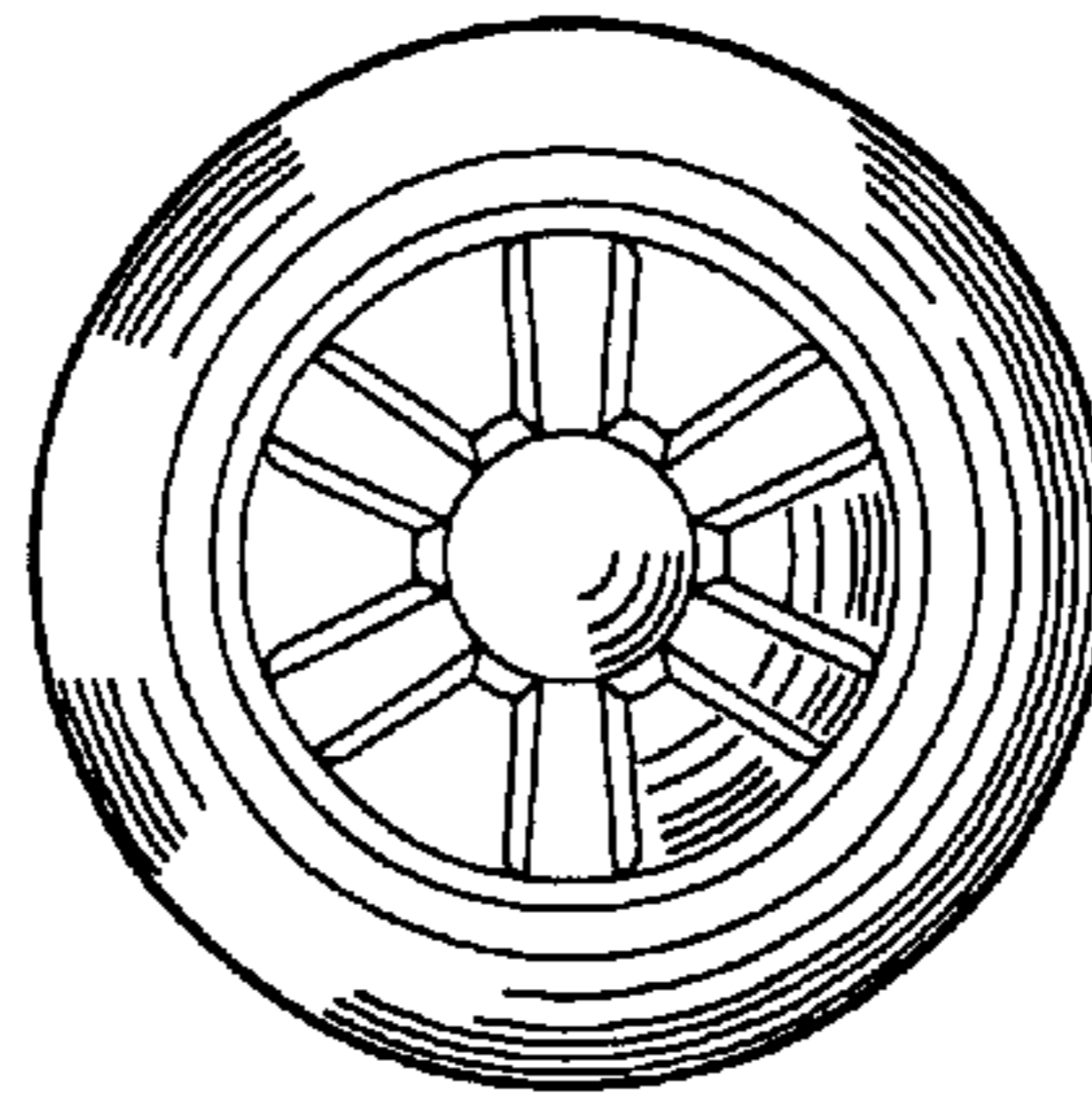

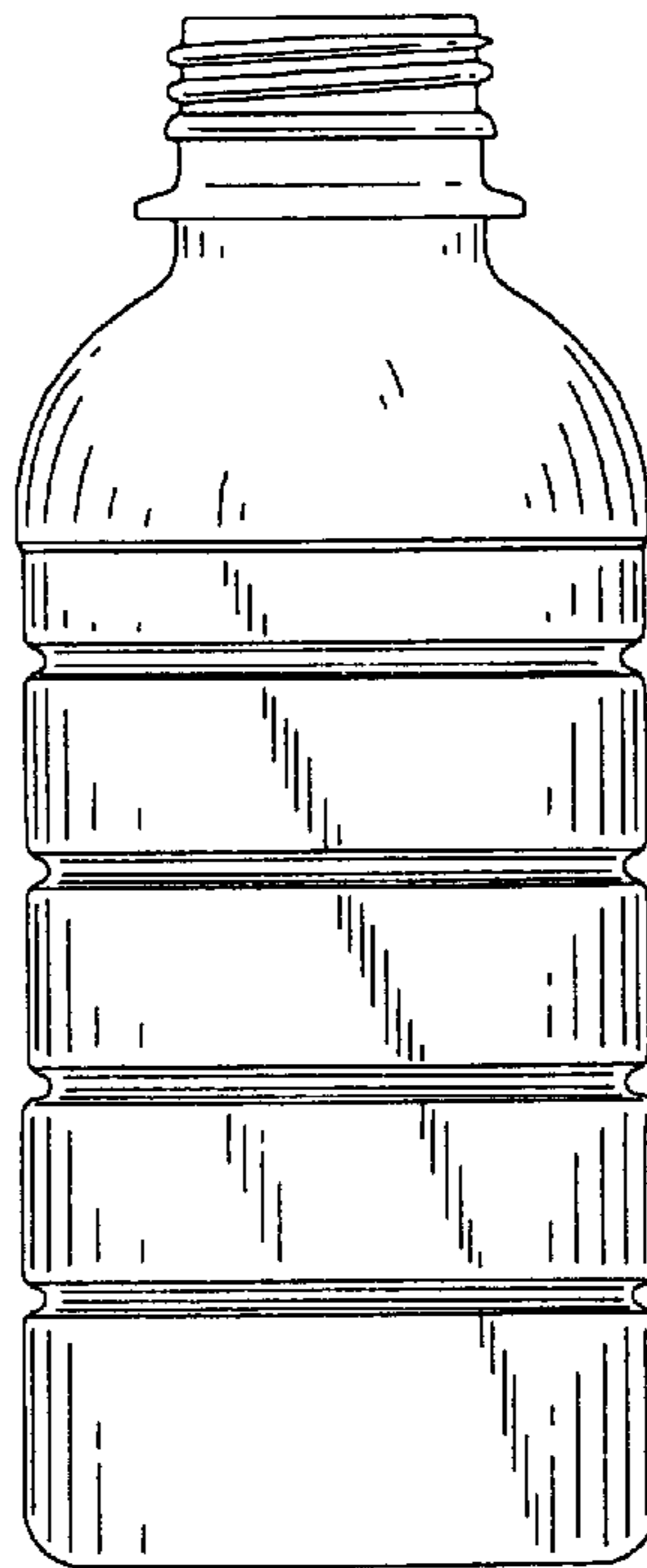

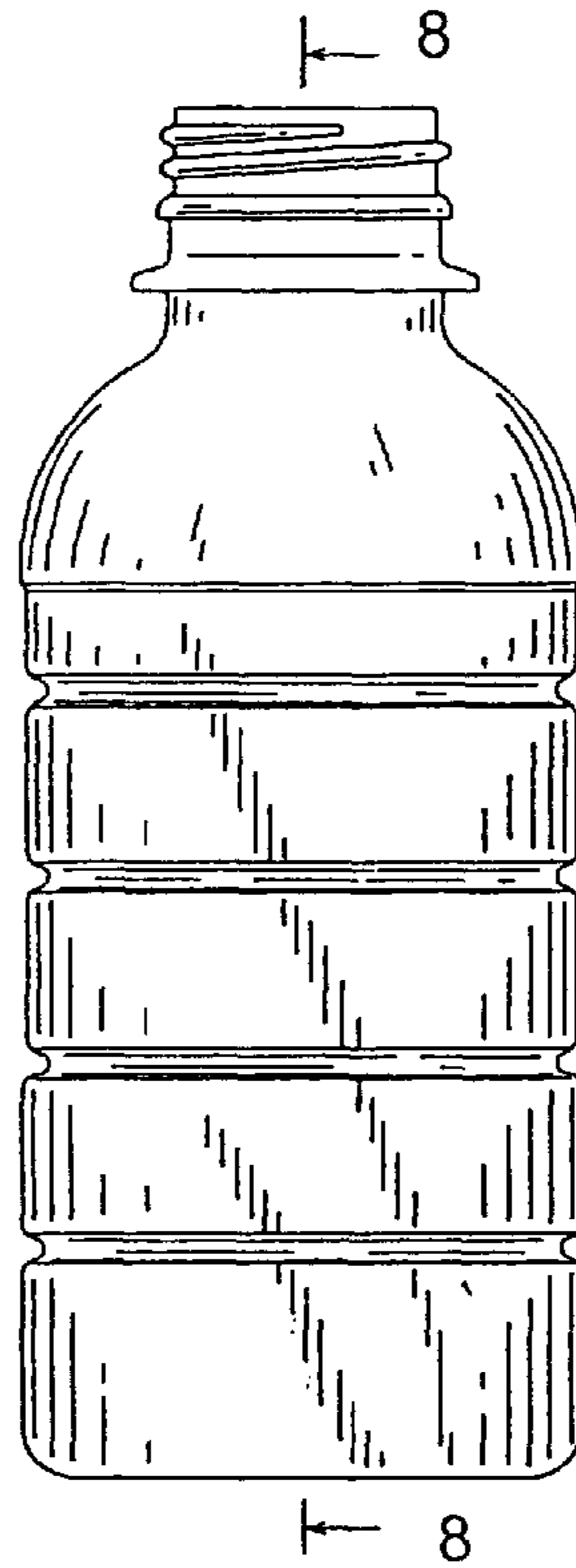

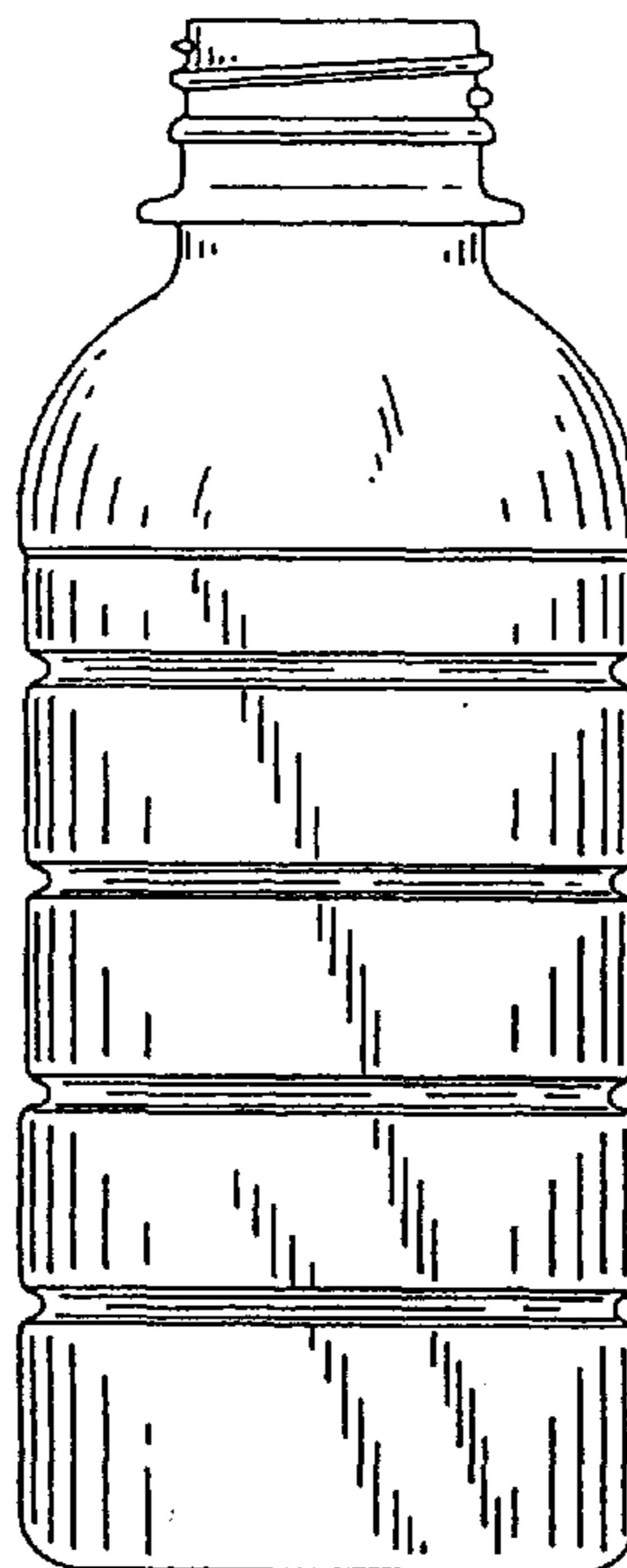

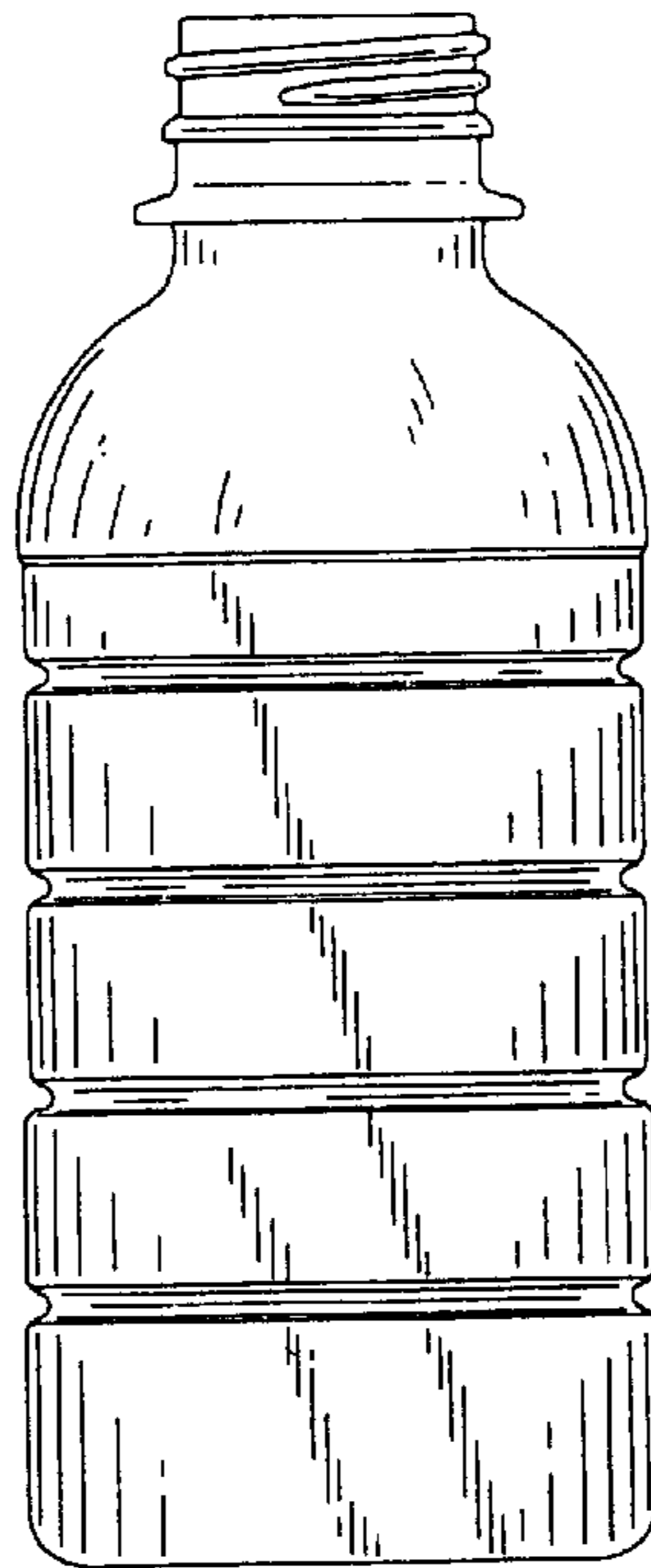

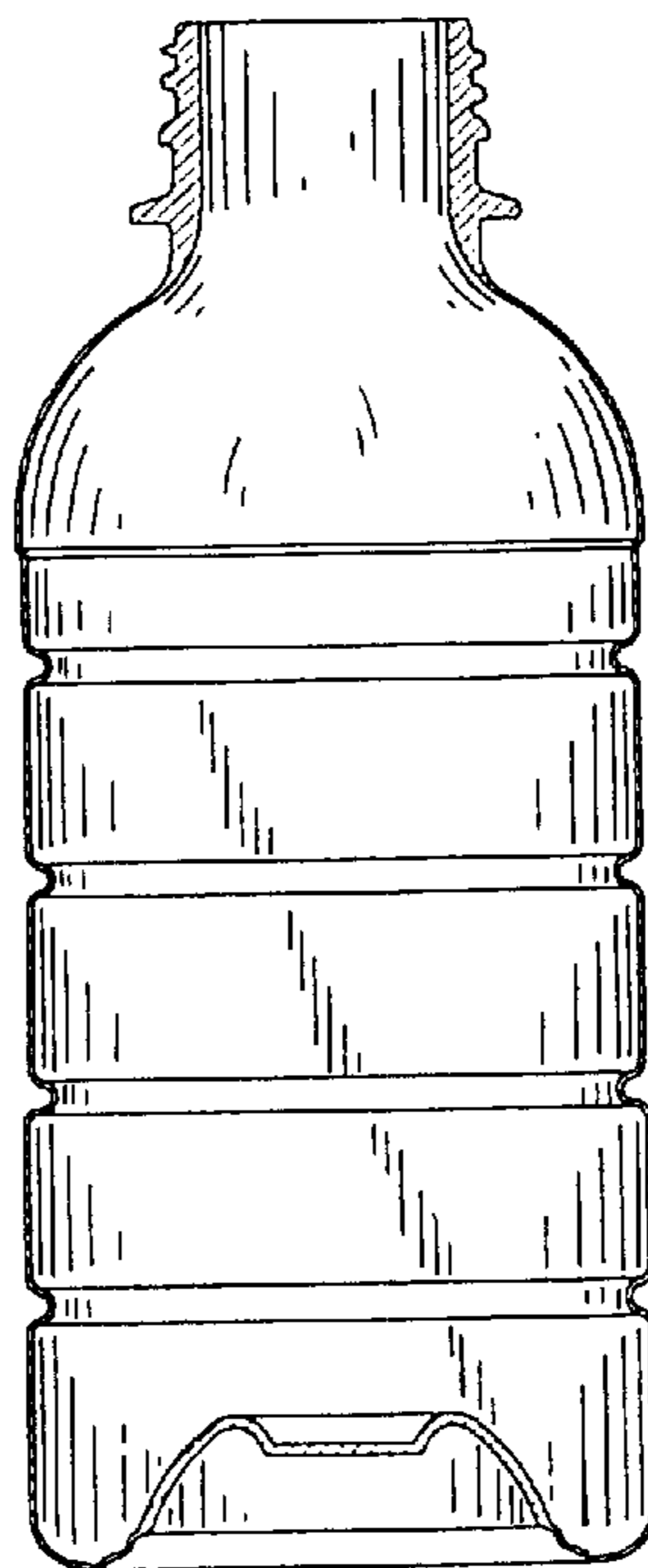

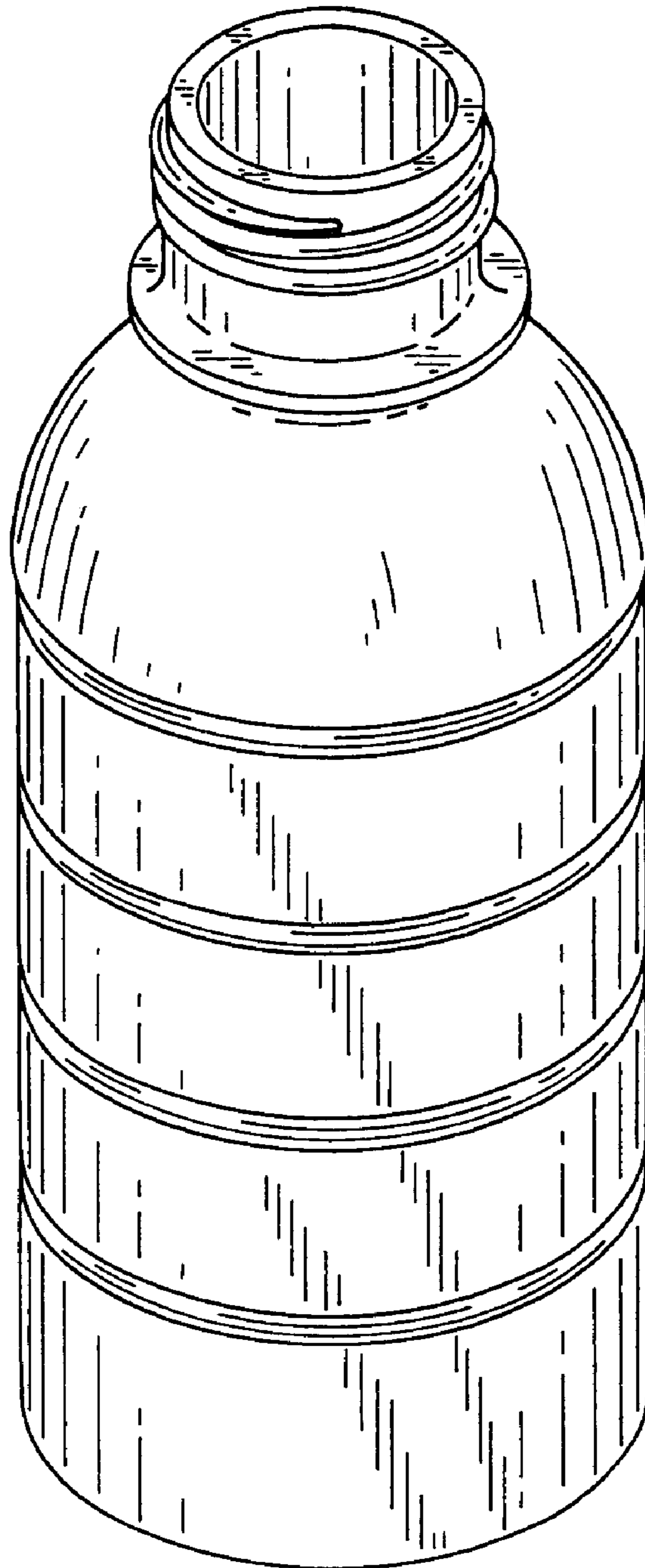

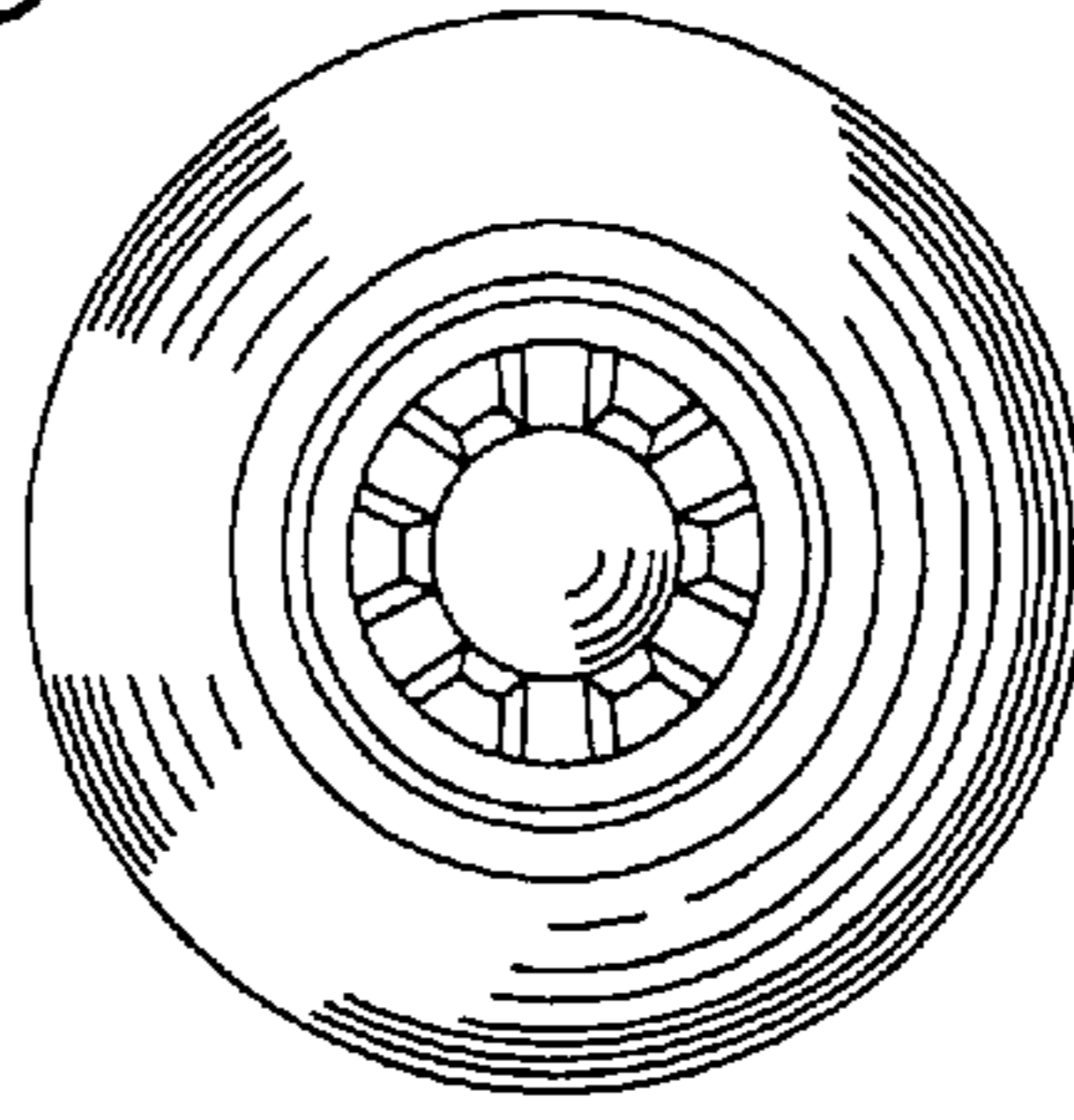

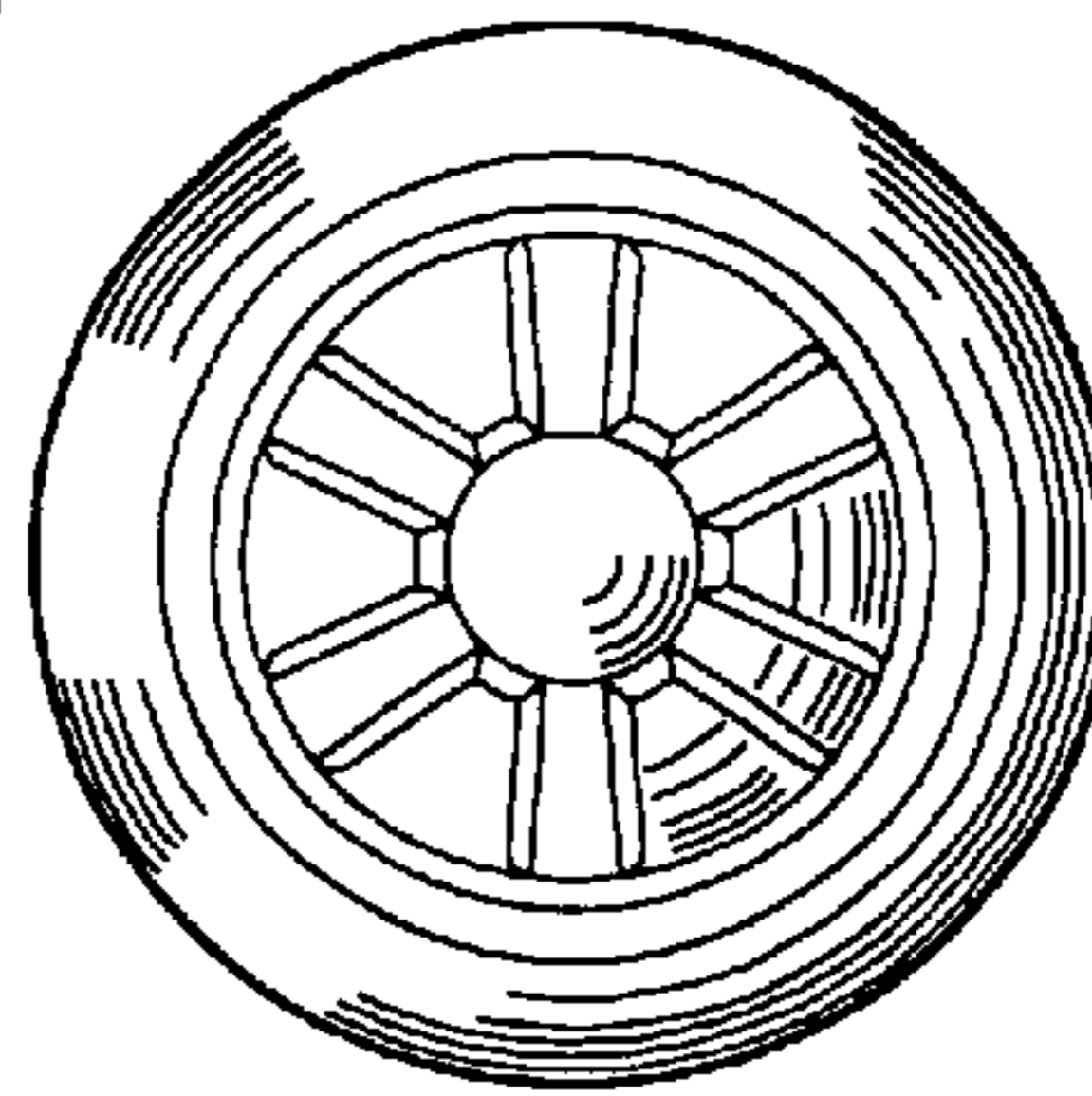

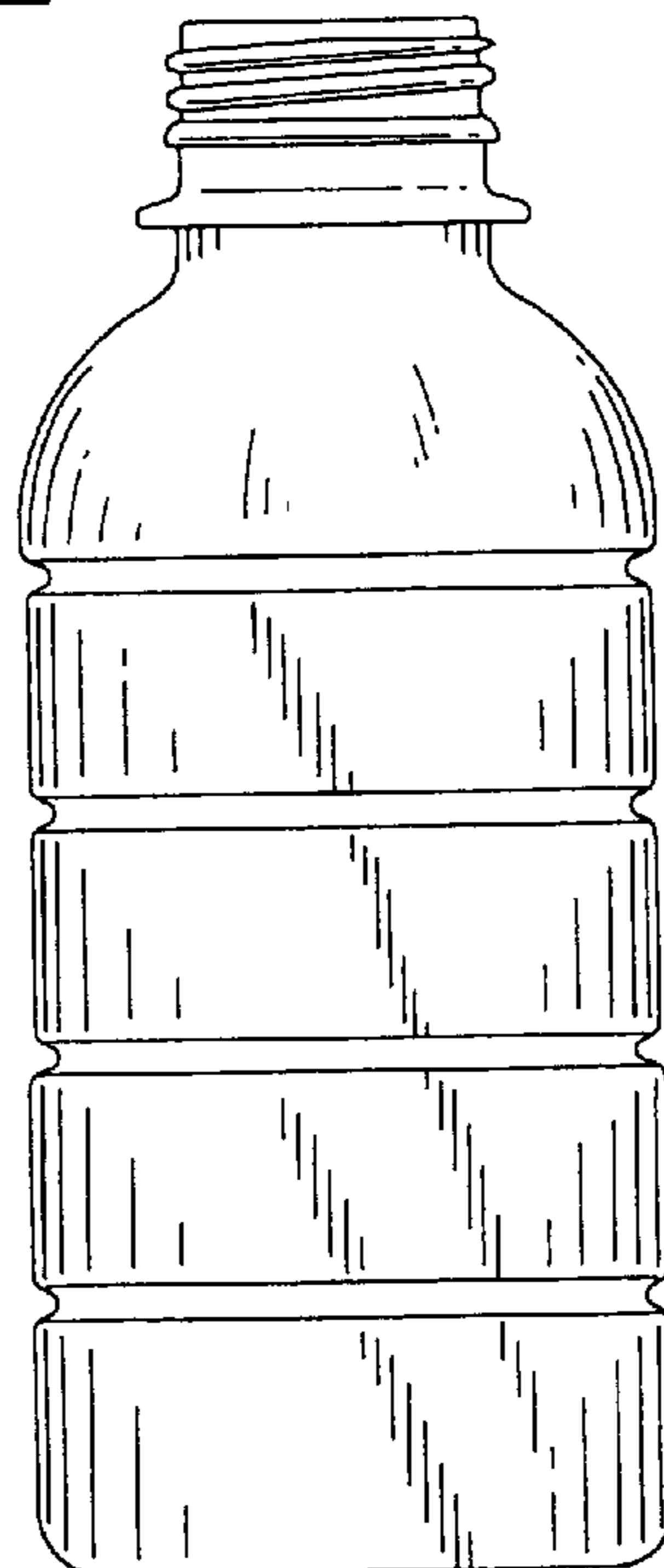

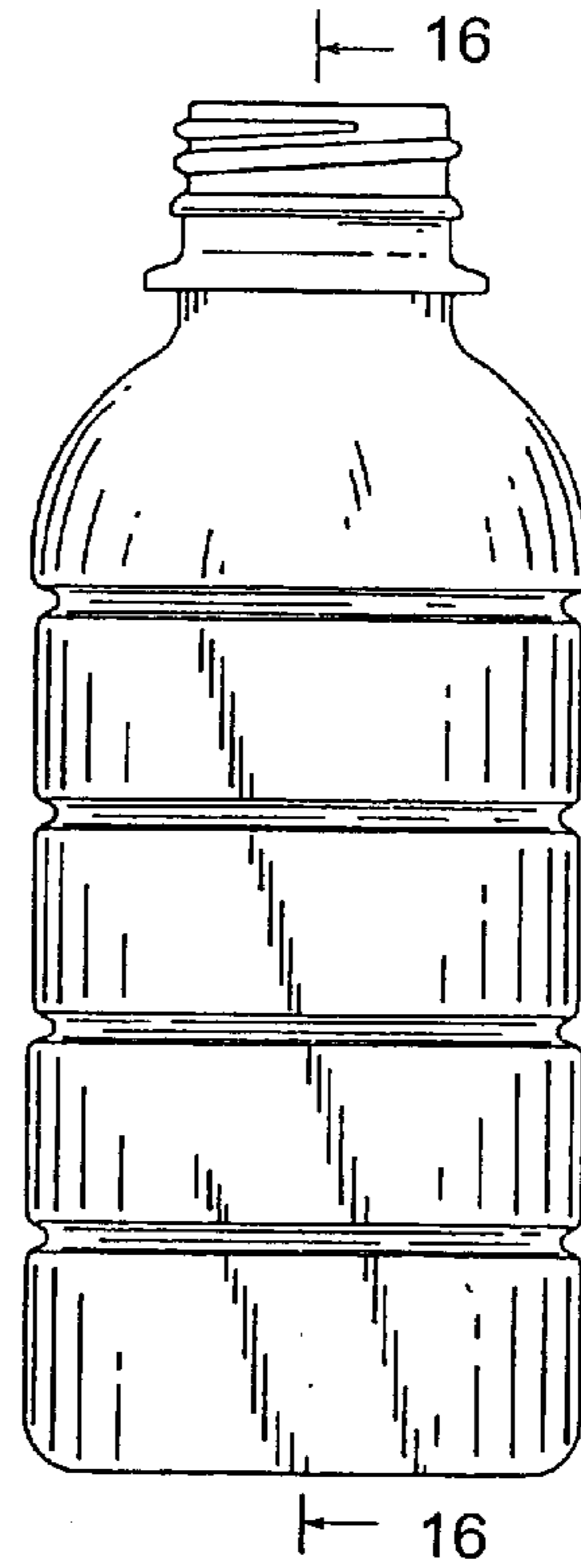

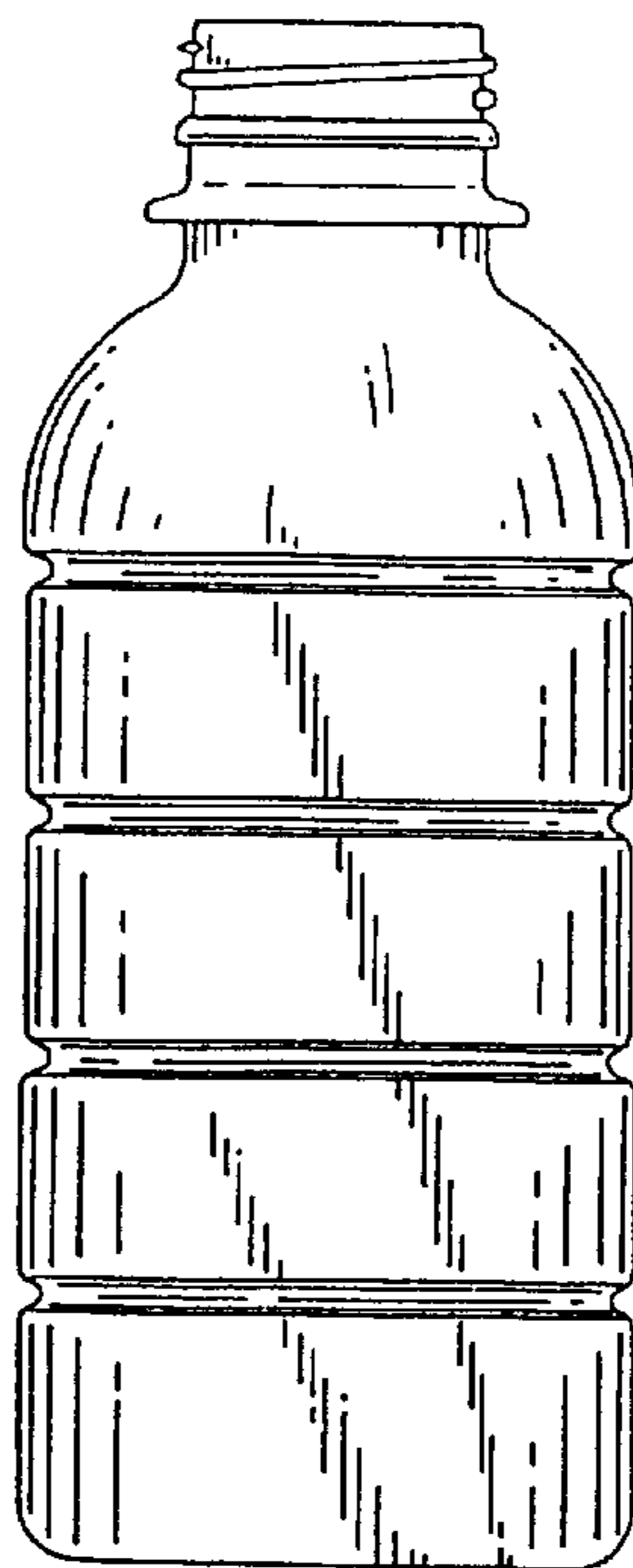

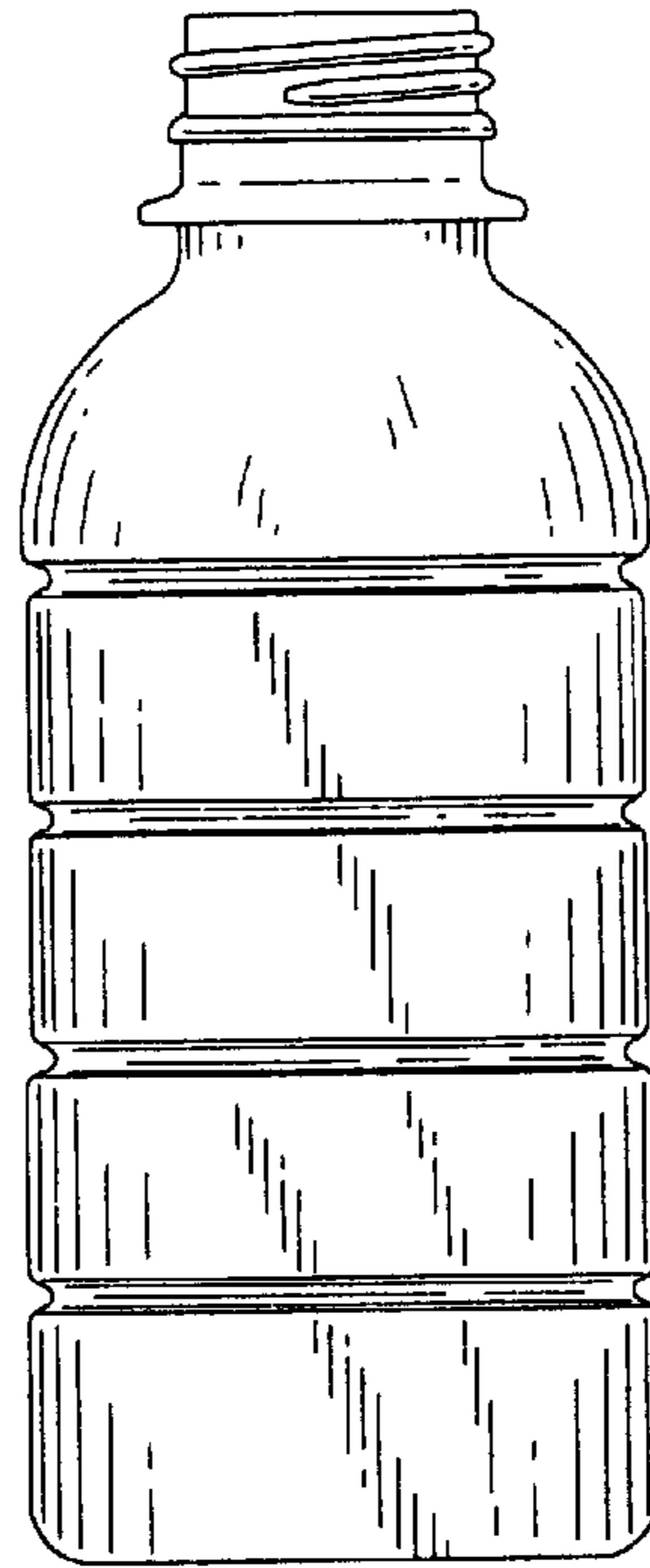
