**DESCRIPTION**

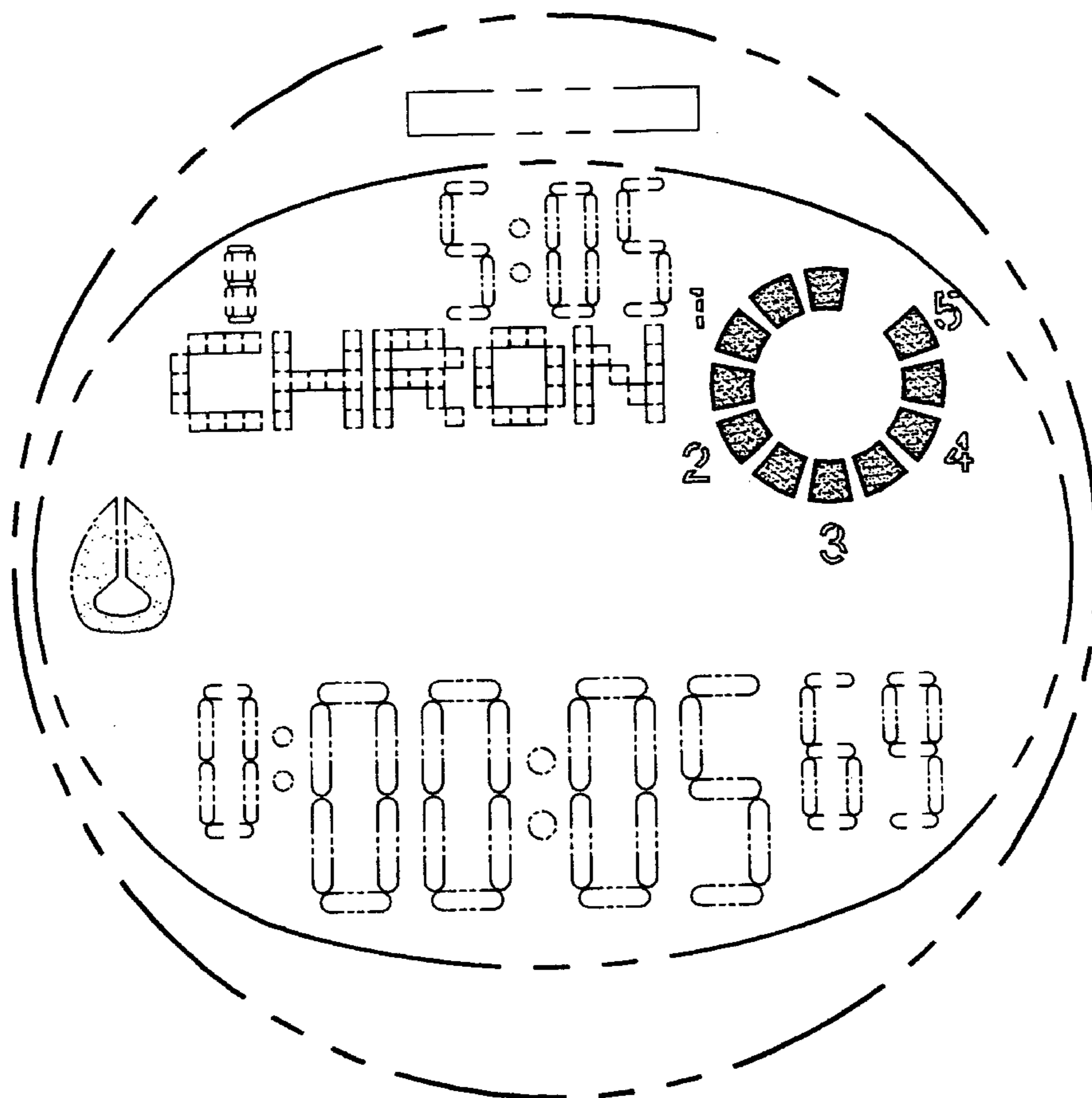
FIG. 1 is a top plan view of a tide watch dial showing my new design;

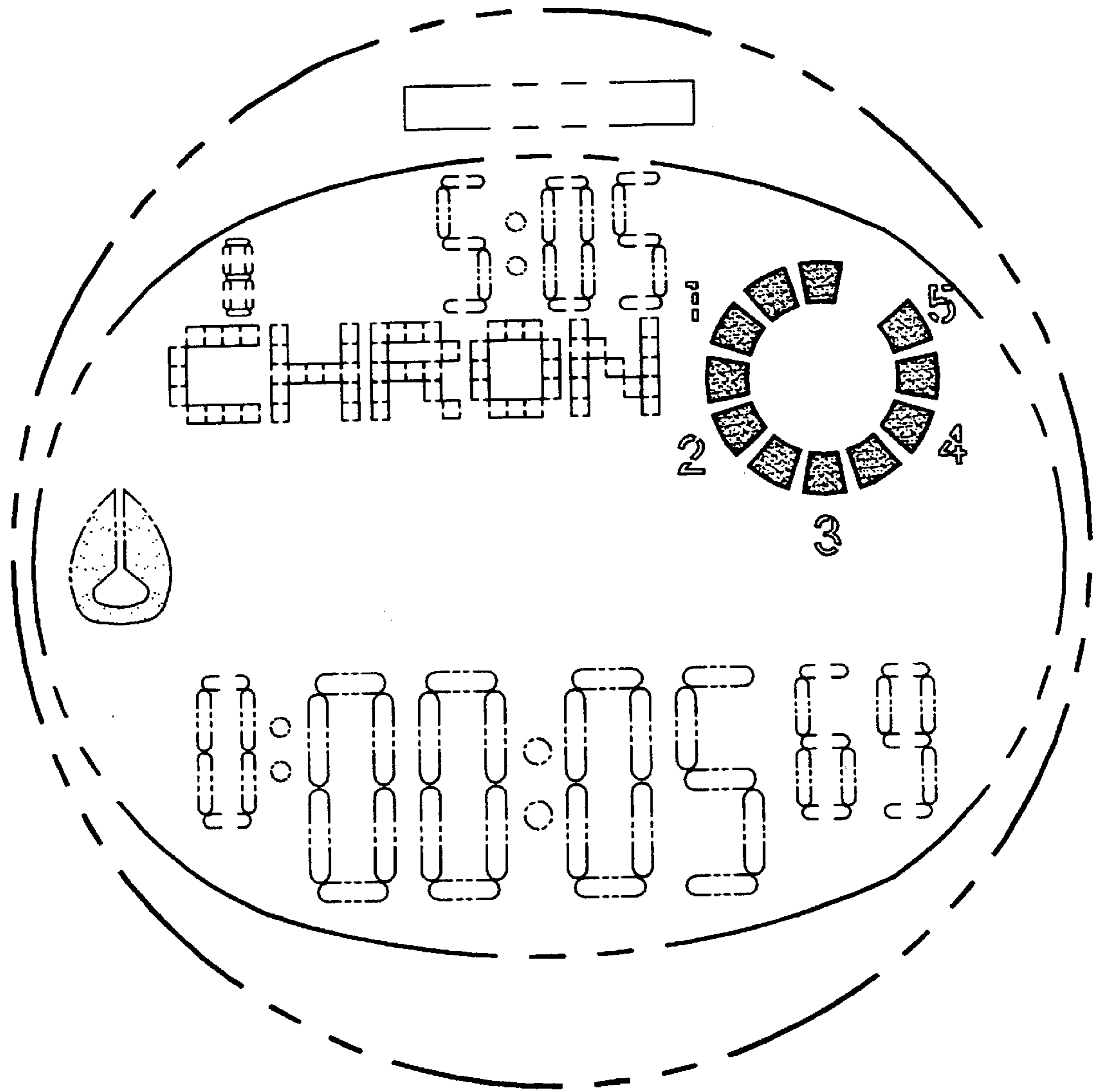

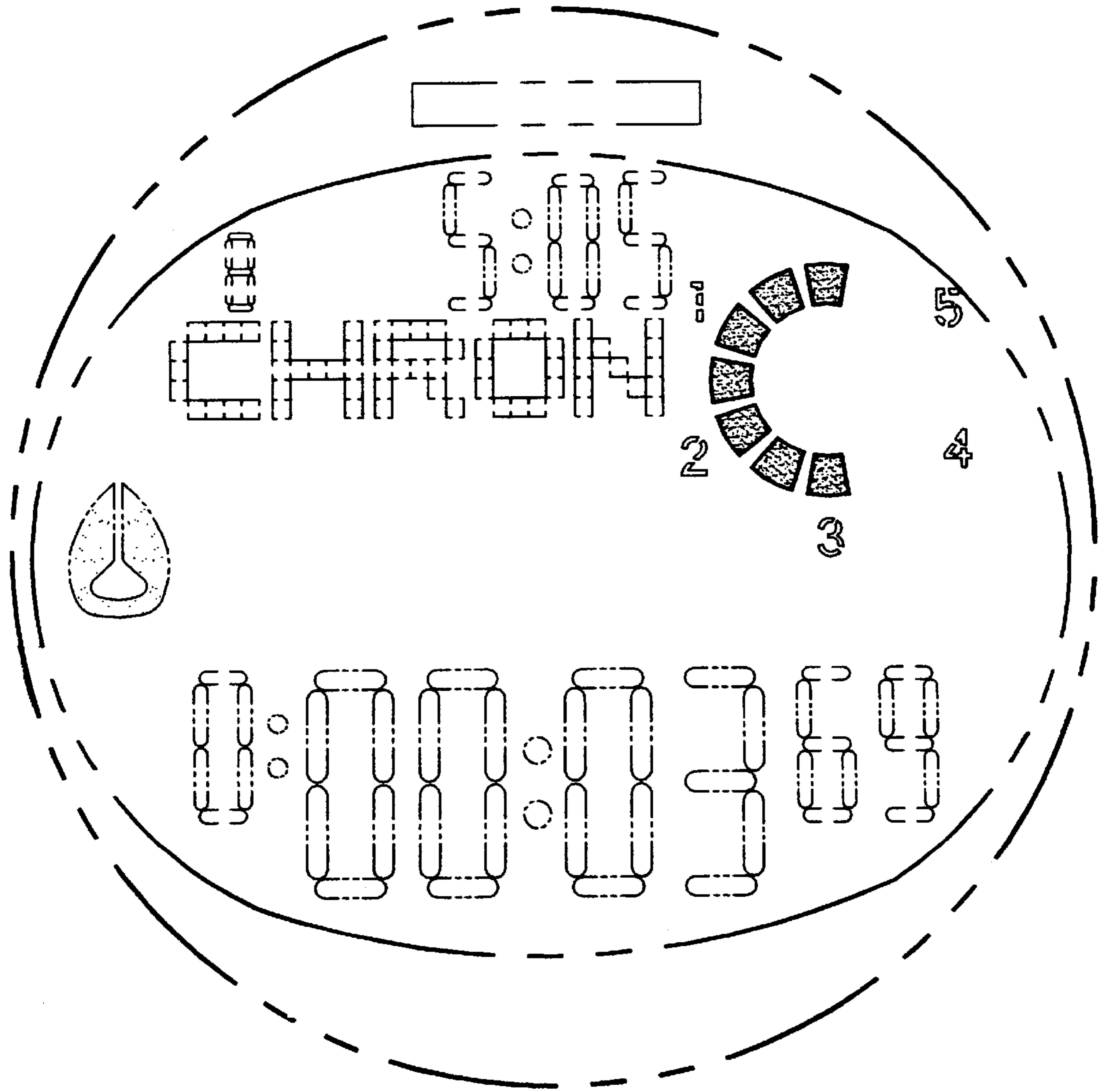

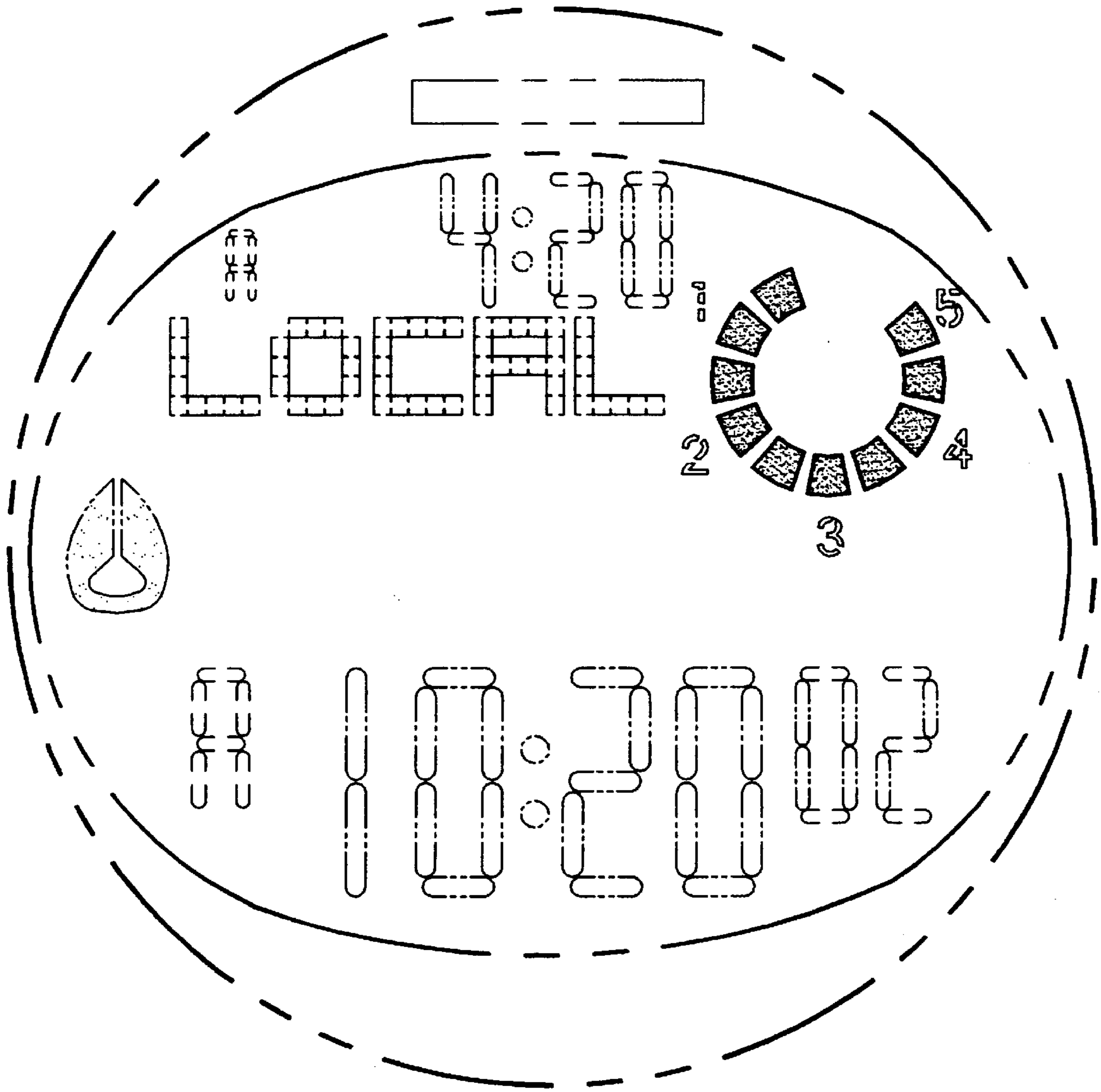
