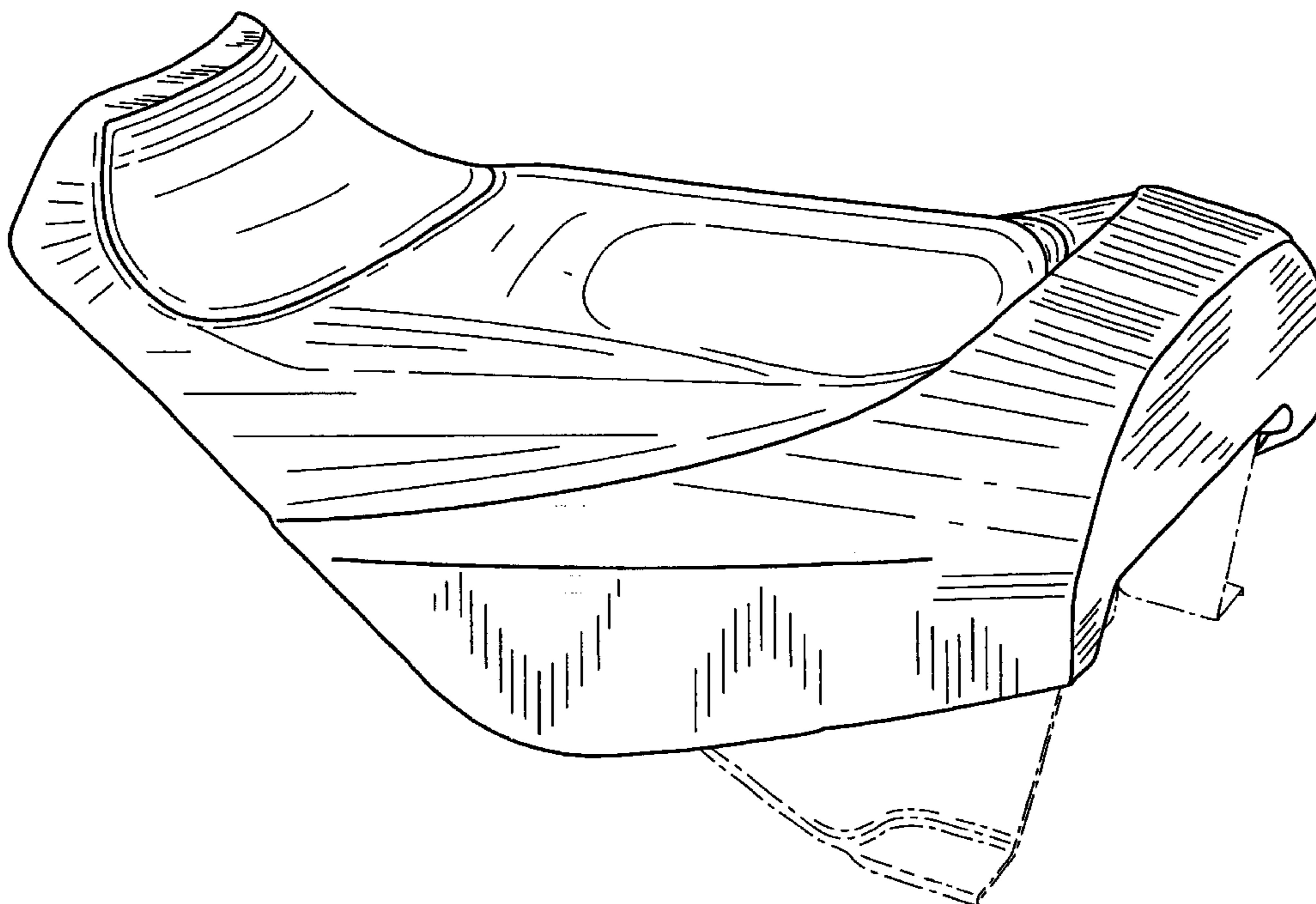
(57) **CLAIM**

The ornamental design for a seat for a snowmobile, as shown and described.

DESCRIPTION

FIG. 1 is a right-rear perspective view of a seat for a snowmobile showing our new design; FIG. 2 is a rear elevational view thereof; FIG. 3 is a left side elevational view thereof, the right side being a mirror image; FIG. 4 is a top plan view thereof; and, FIG. 5 is a front elevational view thereof. The broken line showing of the interior of the seat is for illustrative purposes only and forms no part of the claimed design.

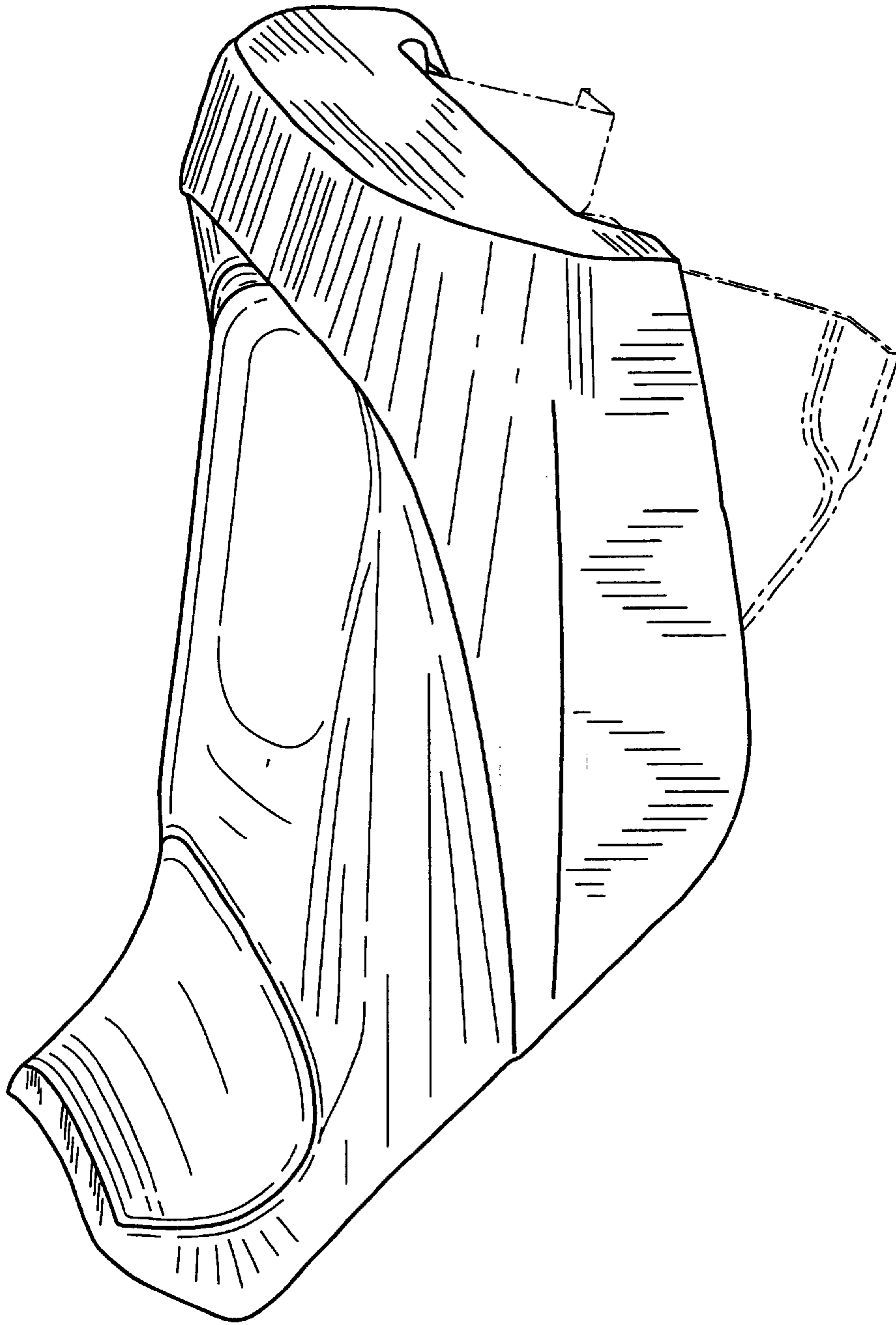

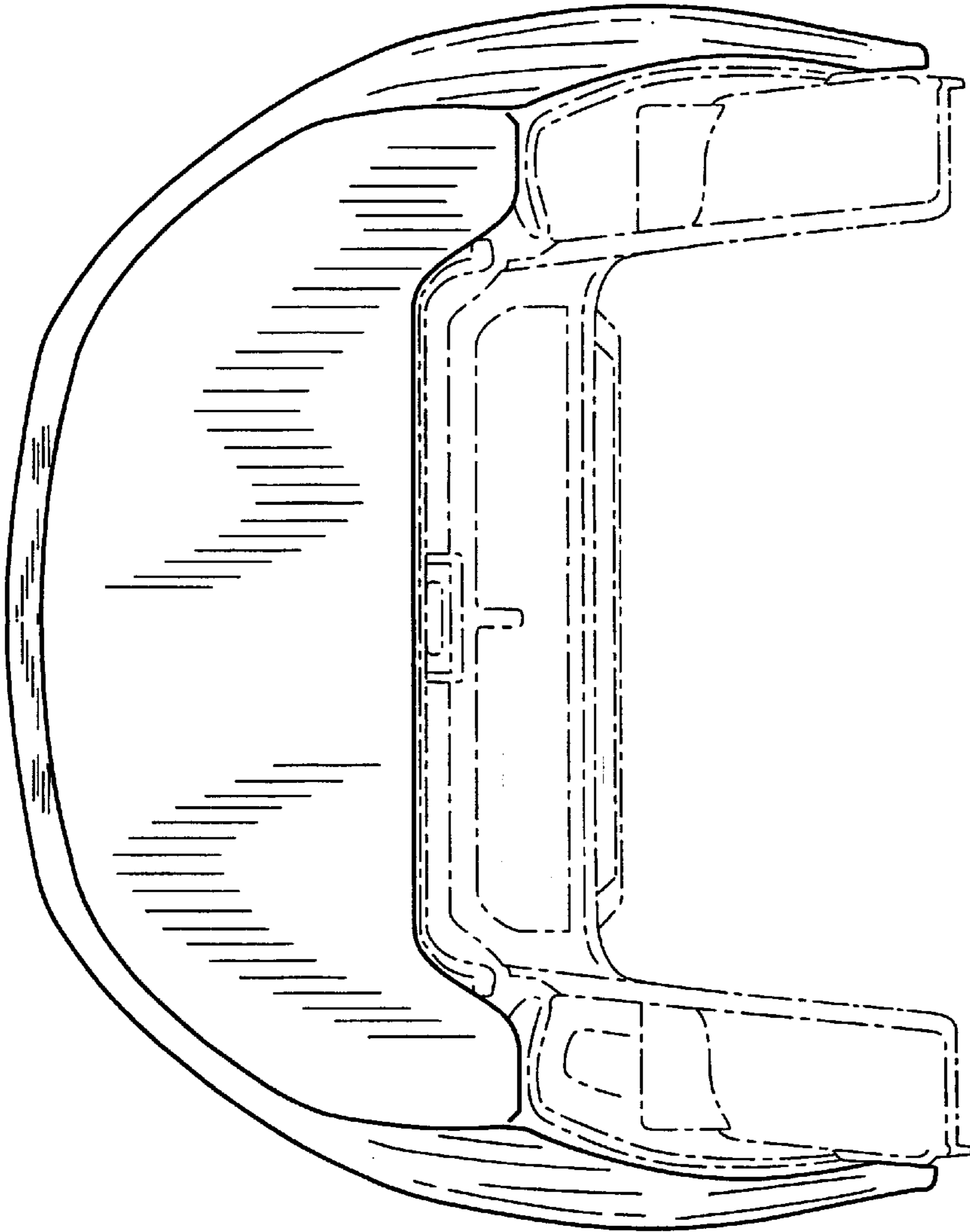

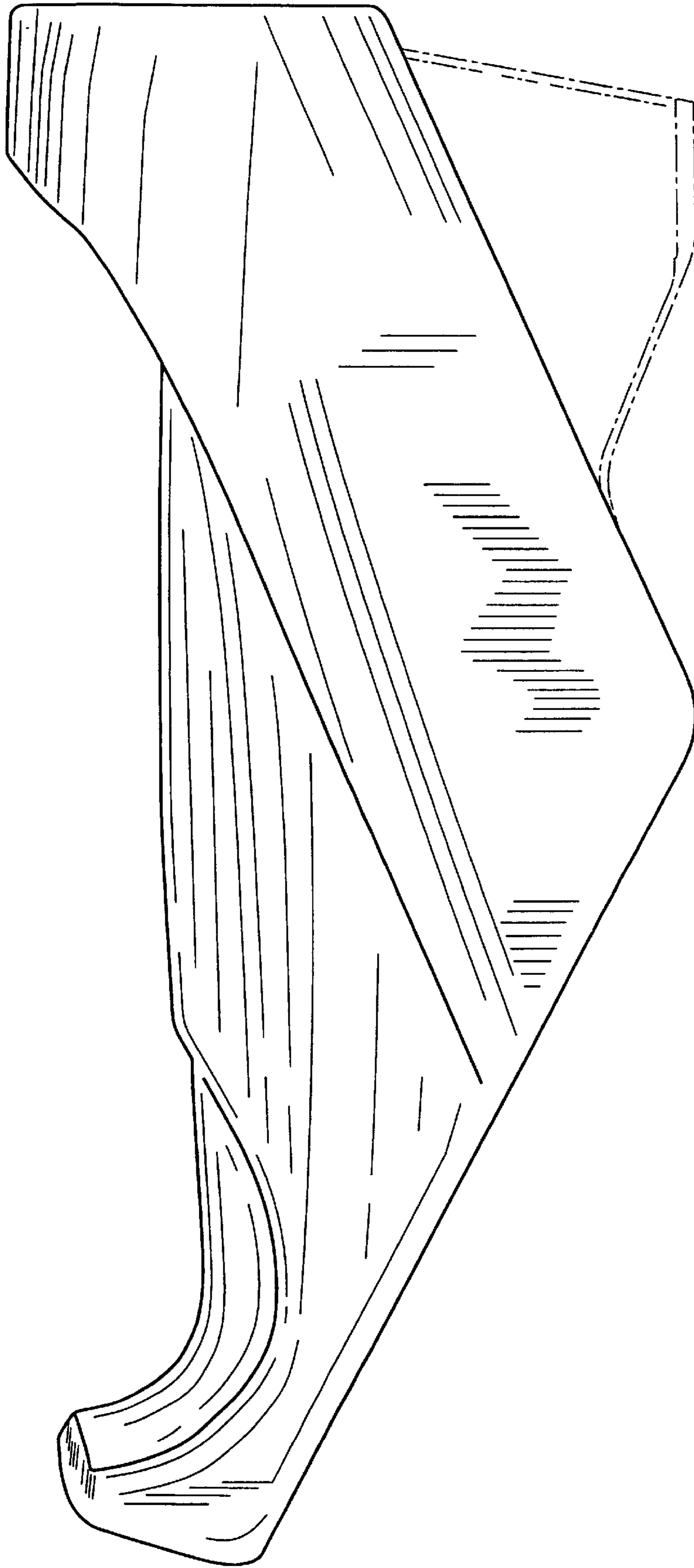

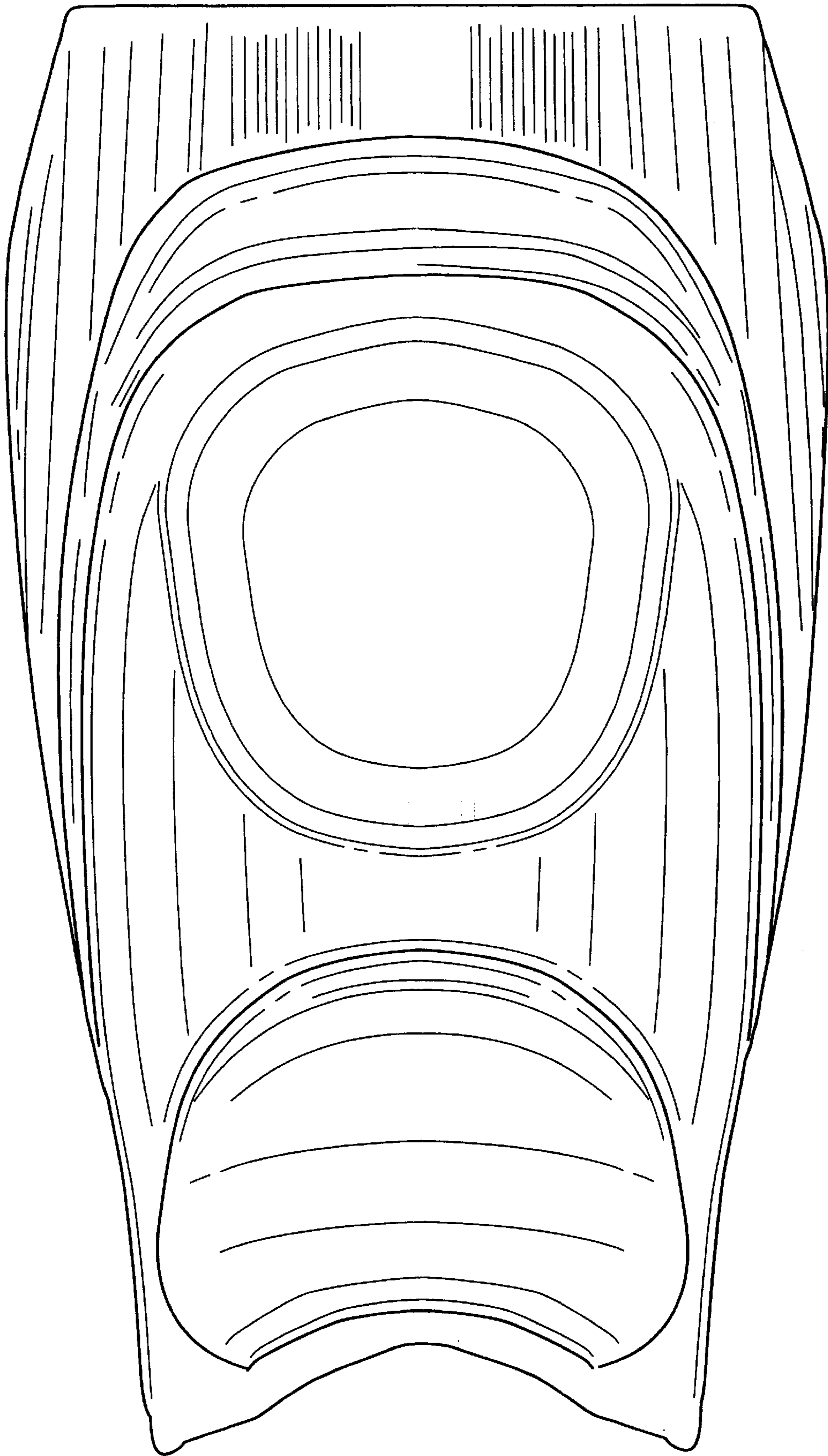

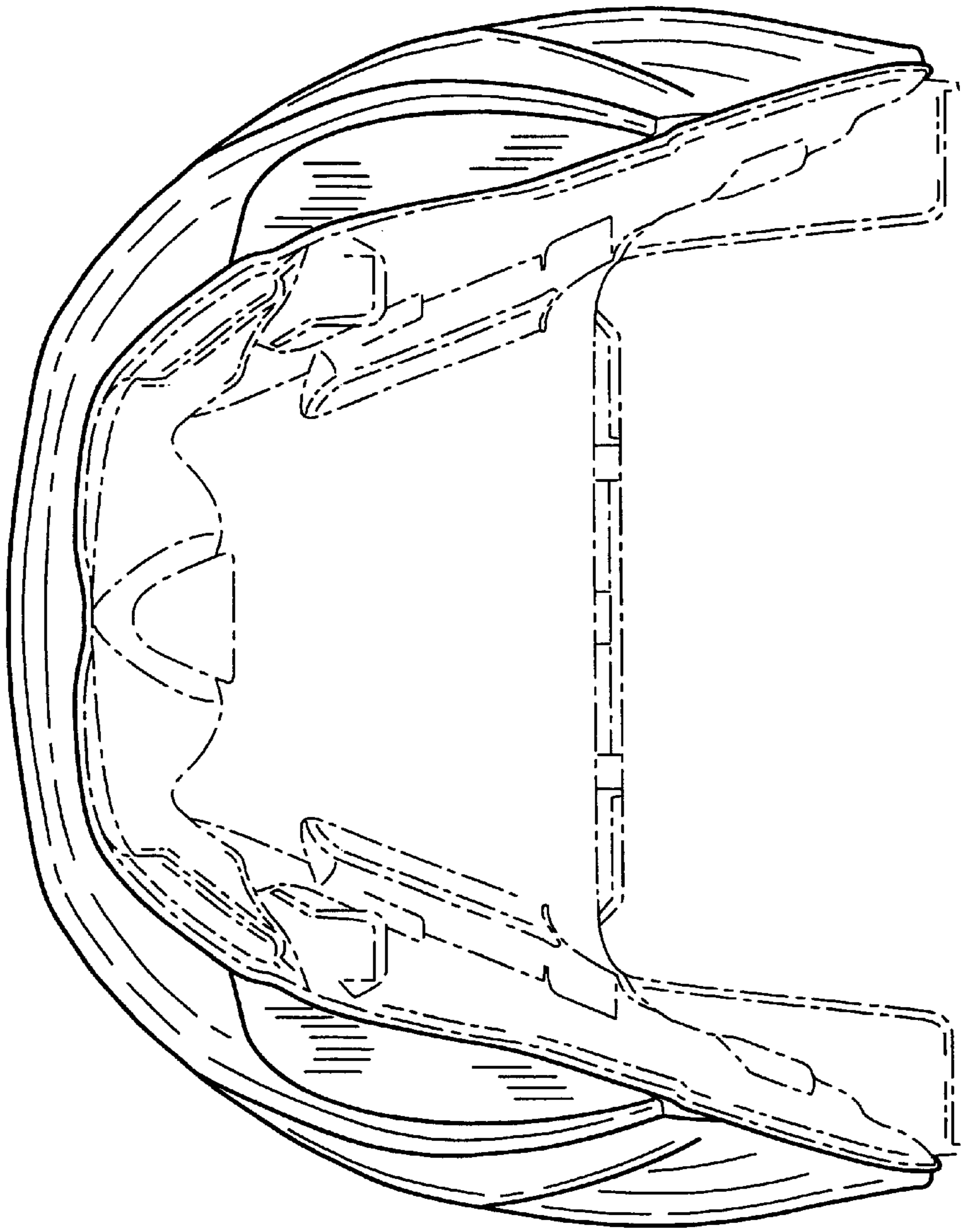
