(57) **CLAIM**

The ornamental design for an ambulatory bag, as shown and described.

DESCRIPTION

FIG. 14 is a front view of an ambulatory bag.

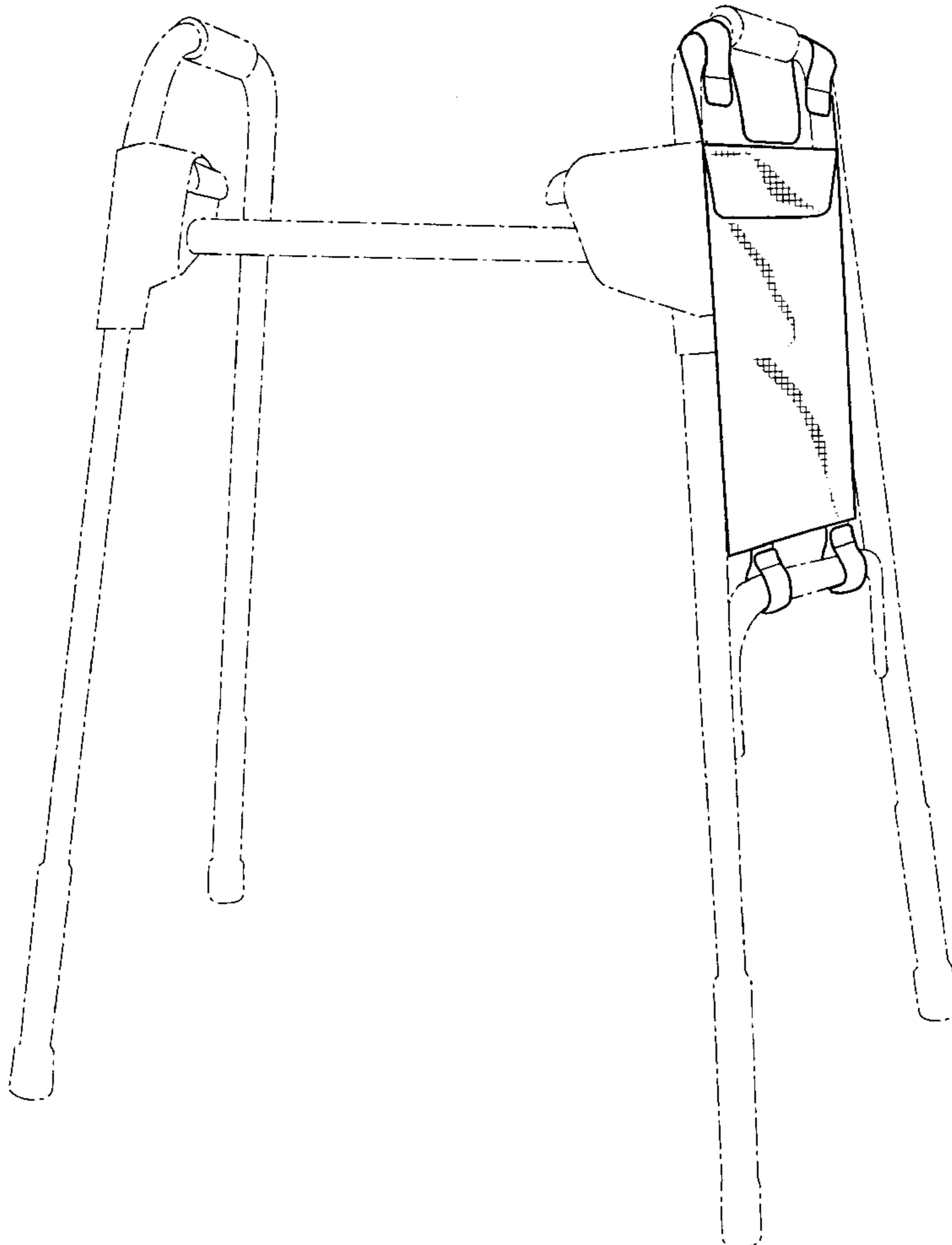
FIG. 15 is a side view of an ambulatory bag. The side views of the ambulatory bag are mirror images.

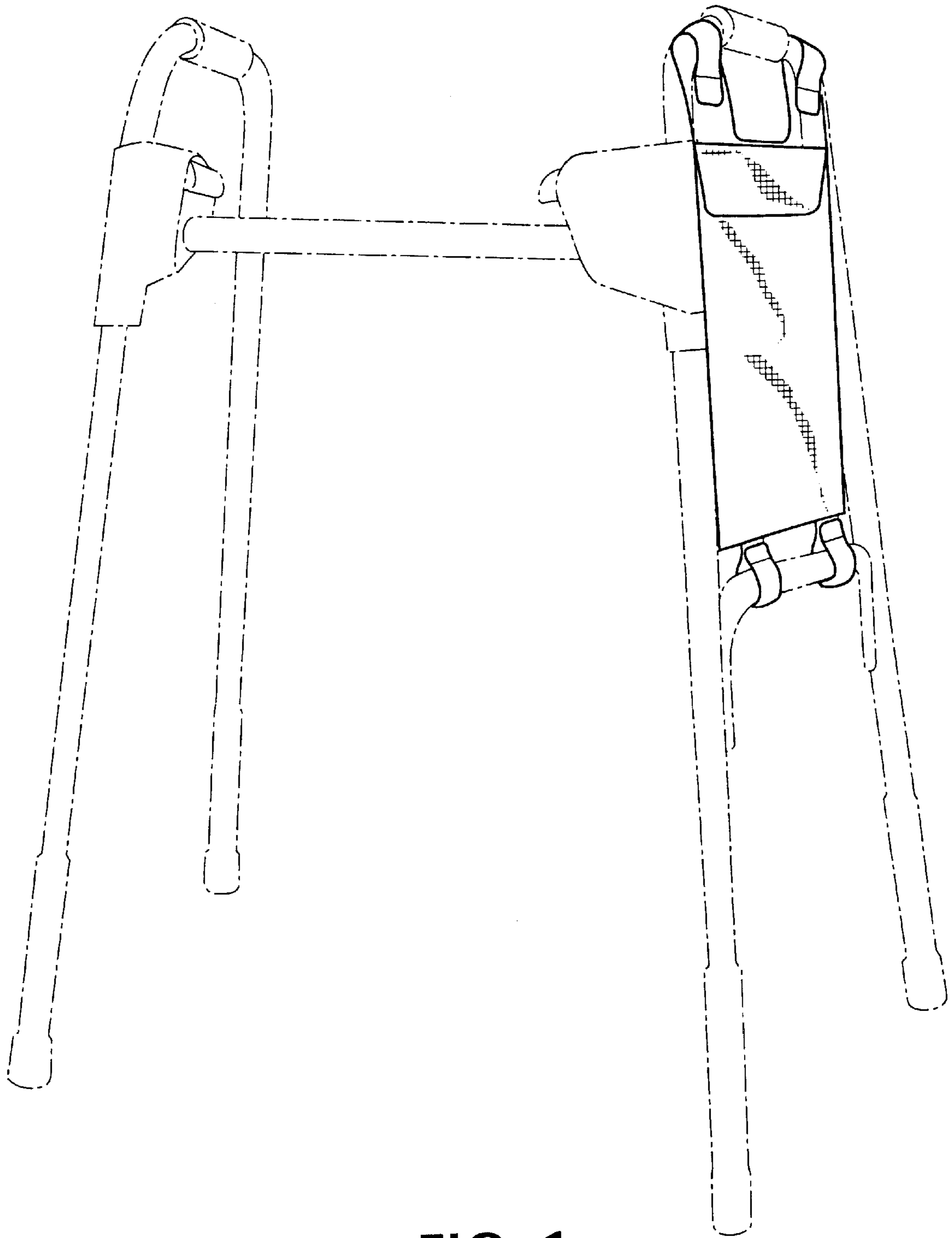

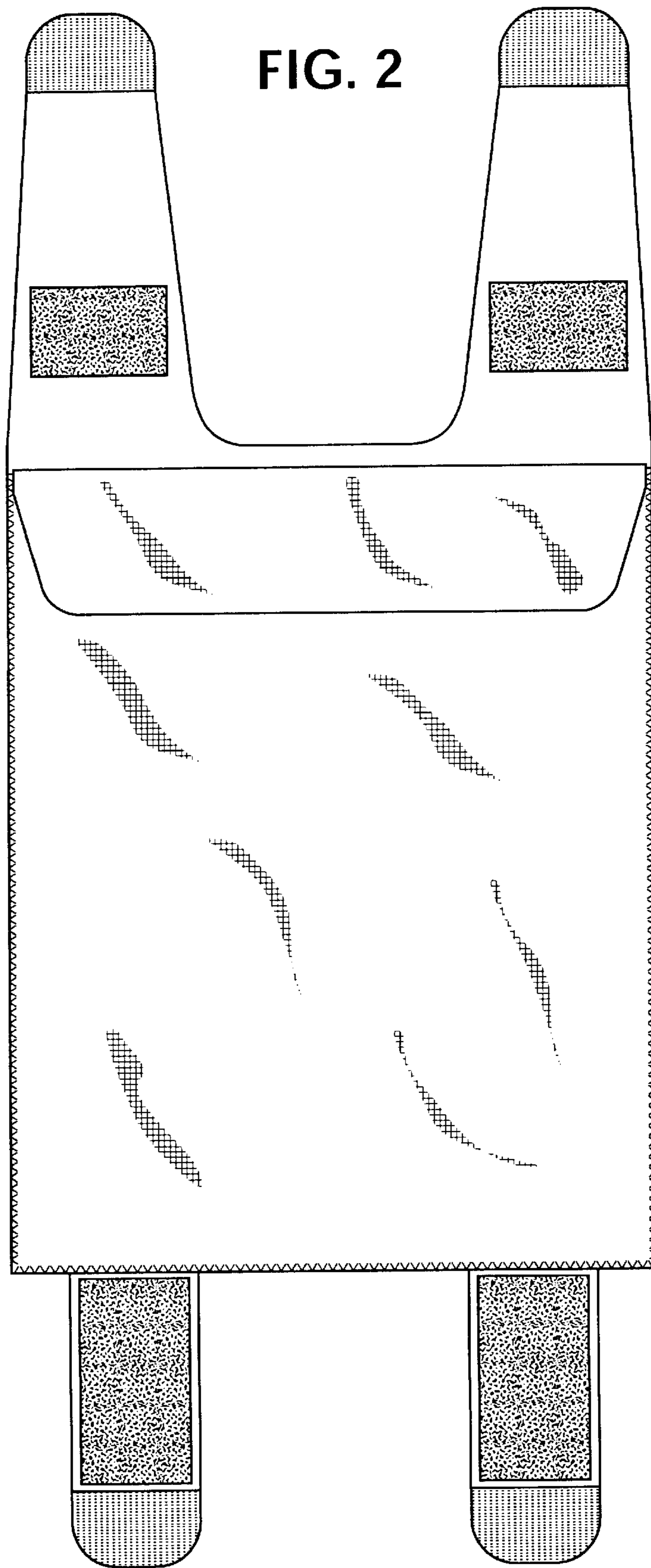

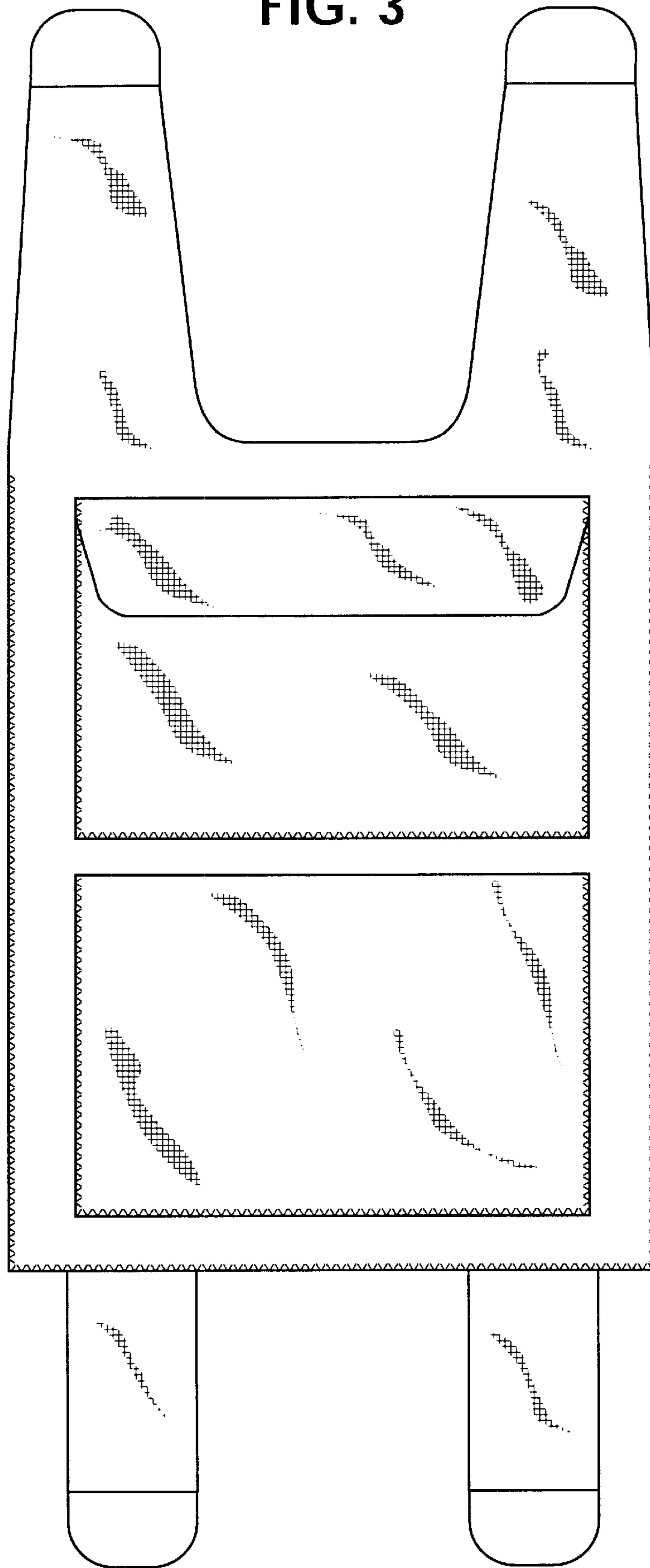

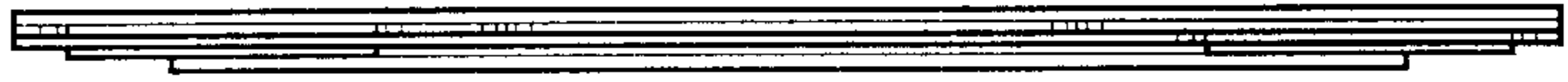

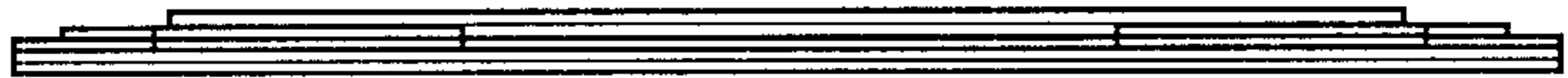

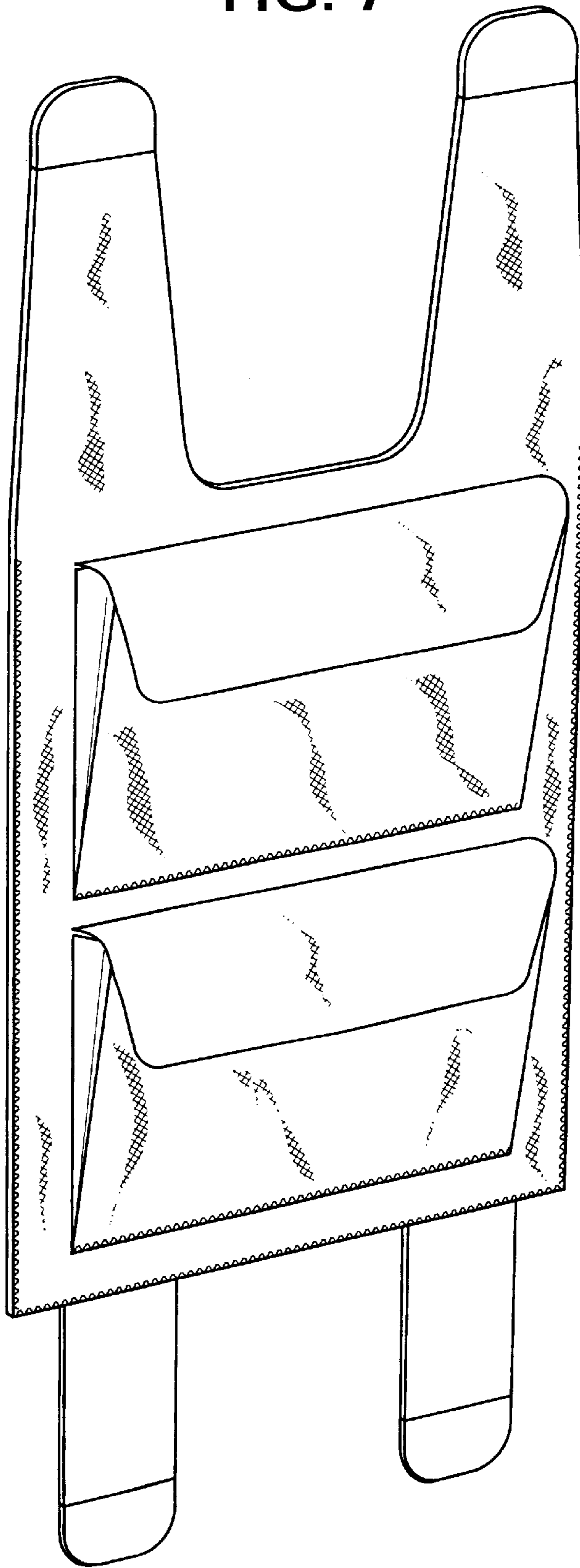

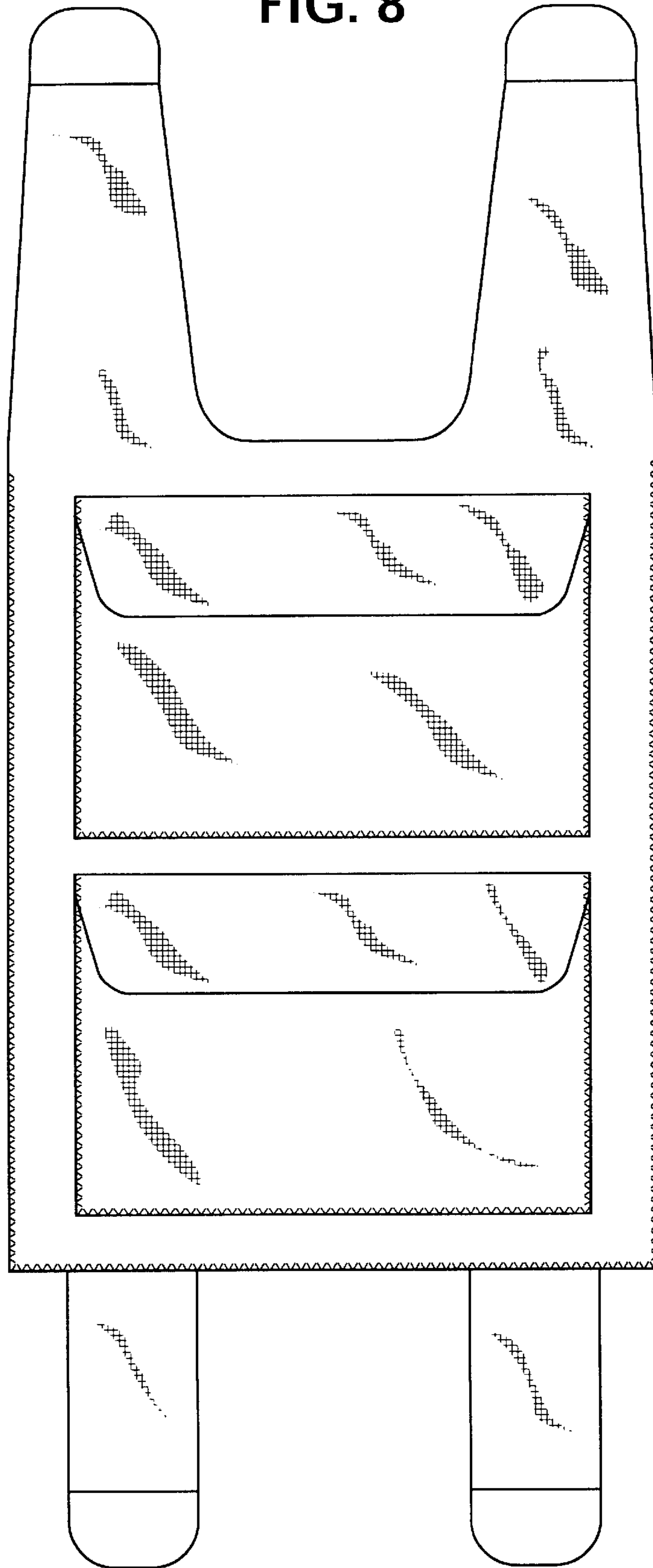

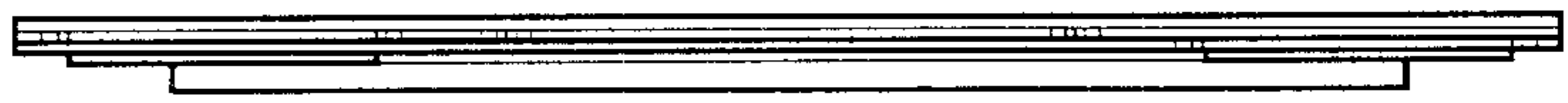
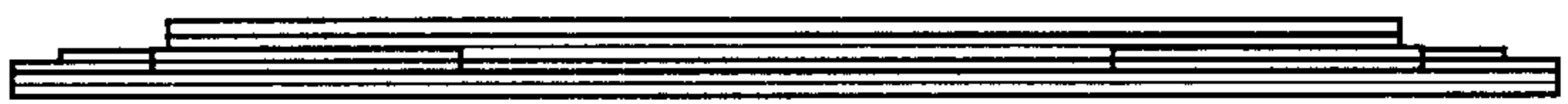

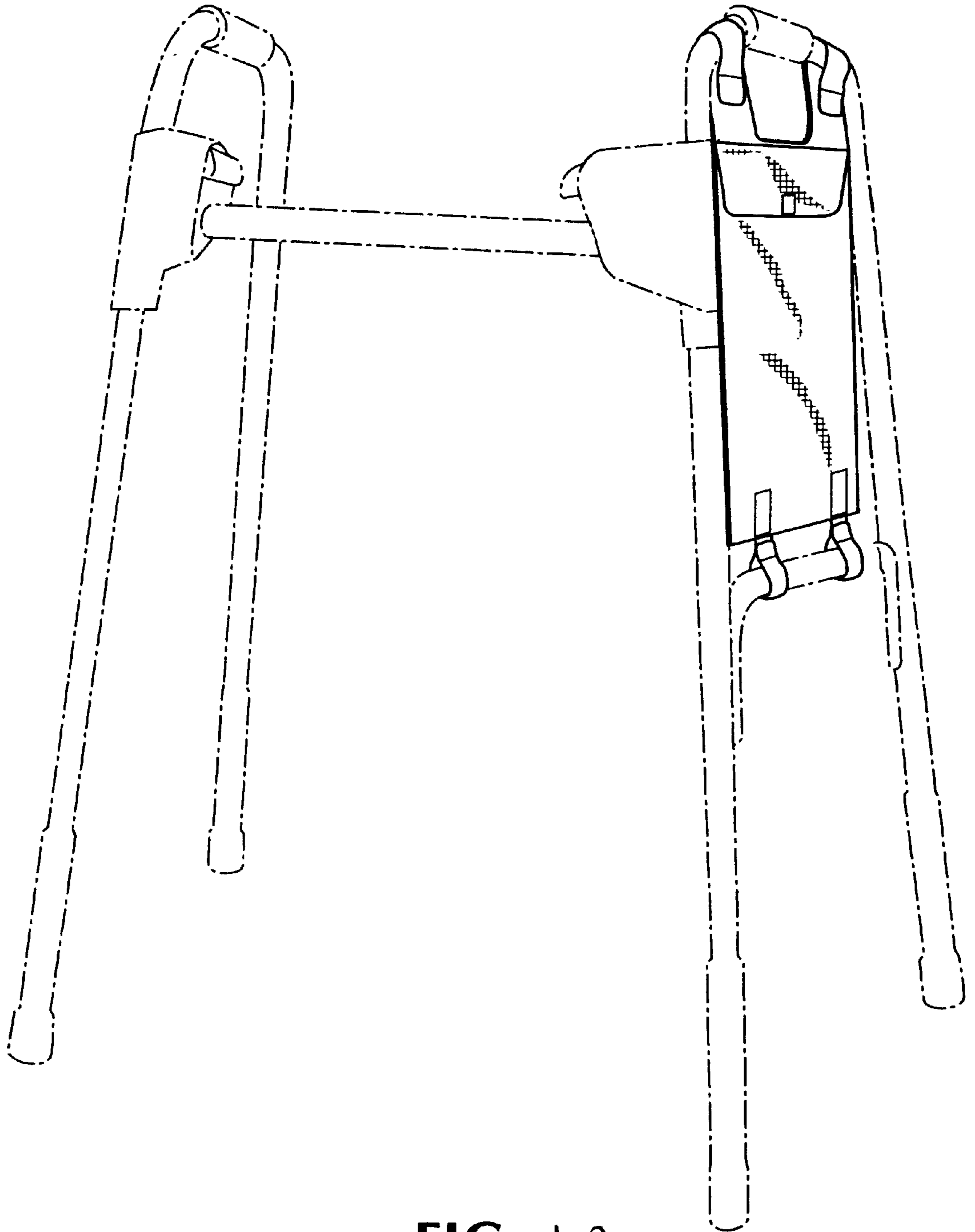
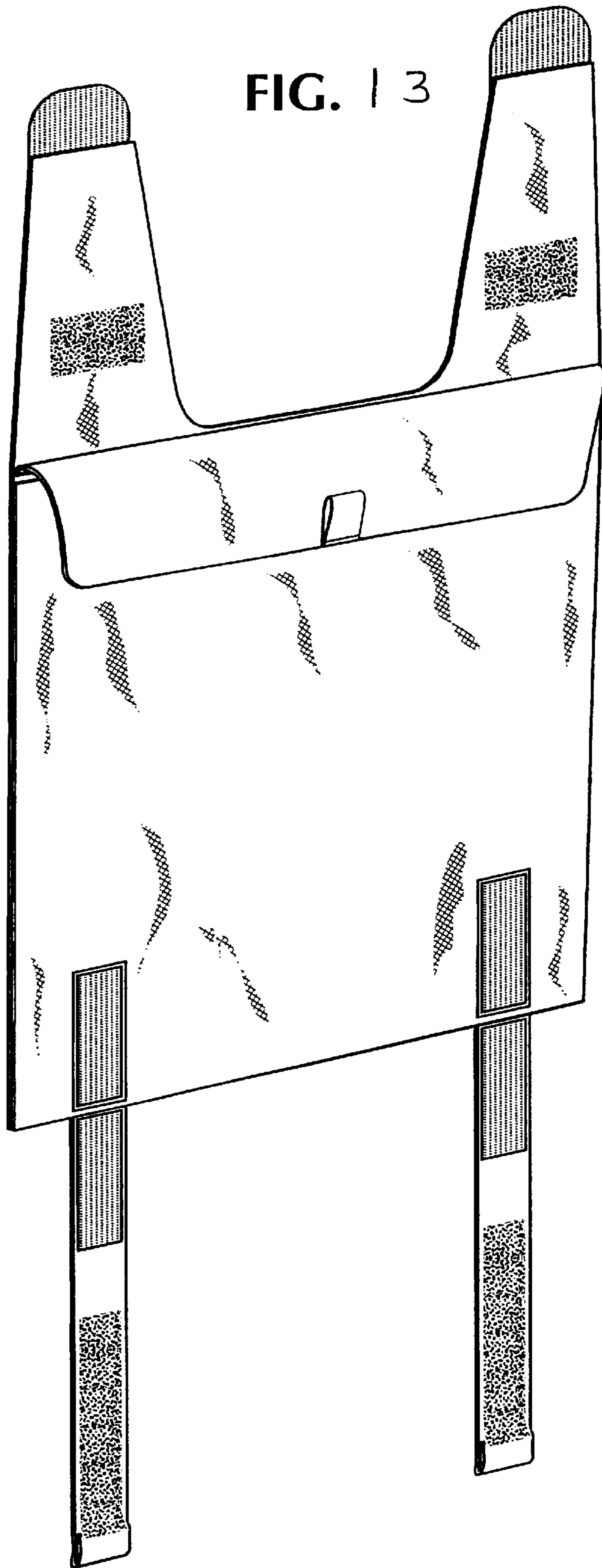

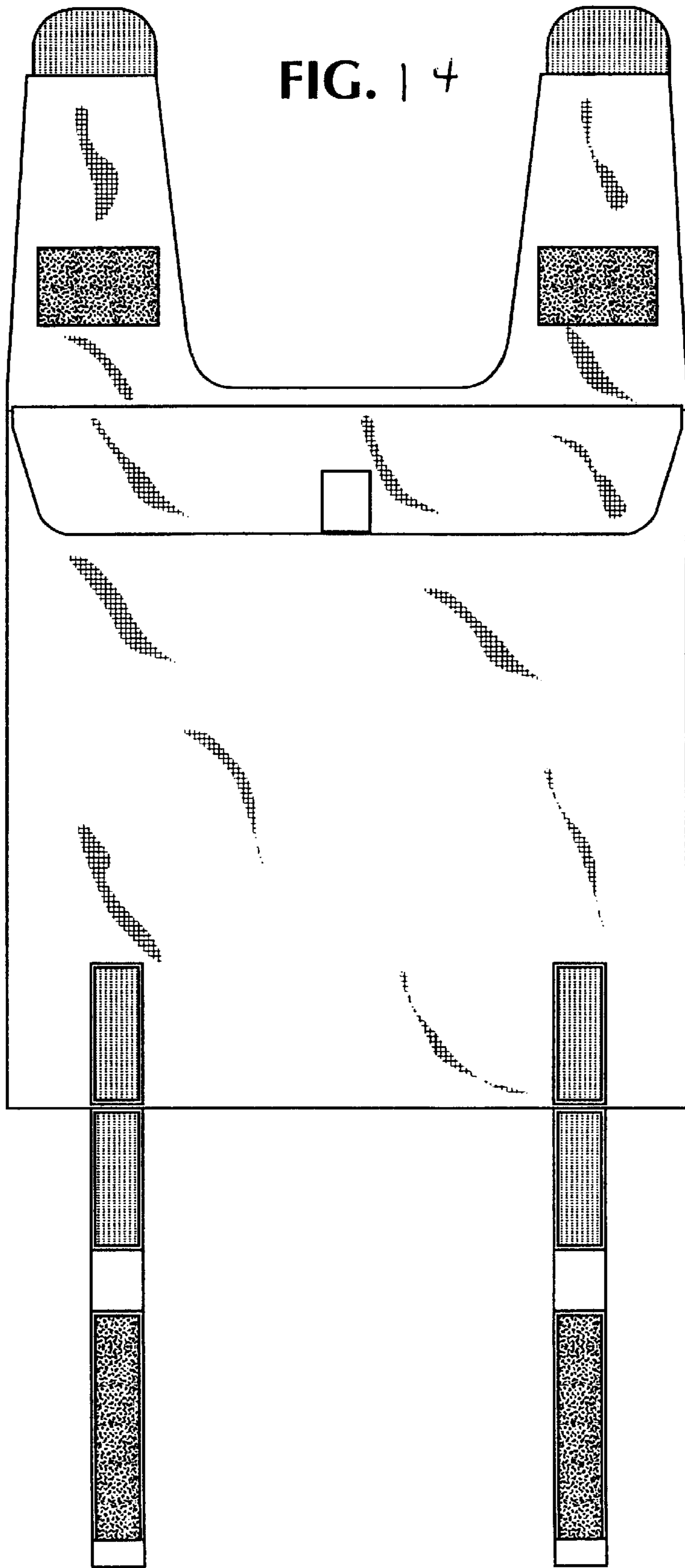




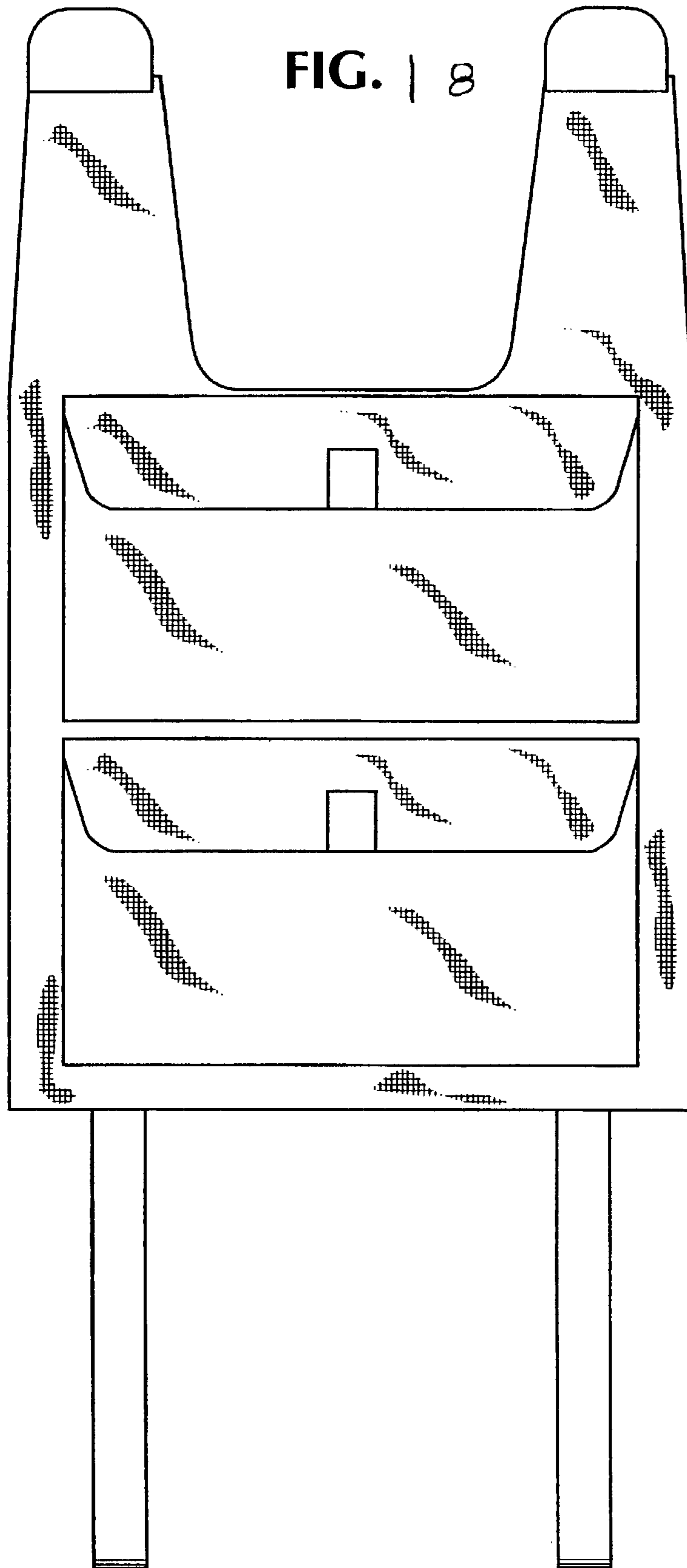
