DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of the skirt guard.

FIG. 4 is a top plan view of the embodiment of FIG. 1.

FIG. 7 is a right side elevational view of the embodiment of FIG. 1.

FIG. 8 is a perspective view of a second embodiment of the skirt guard.

FIG. 9 is a front elevational view of the embodiment of FIG. 8.

FIG. 10 is a rear elevational view of the embodiment of FIG. 8.

FIG. 11 is a top plan view of the embodiment of FIG. 8.

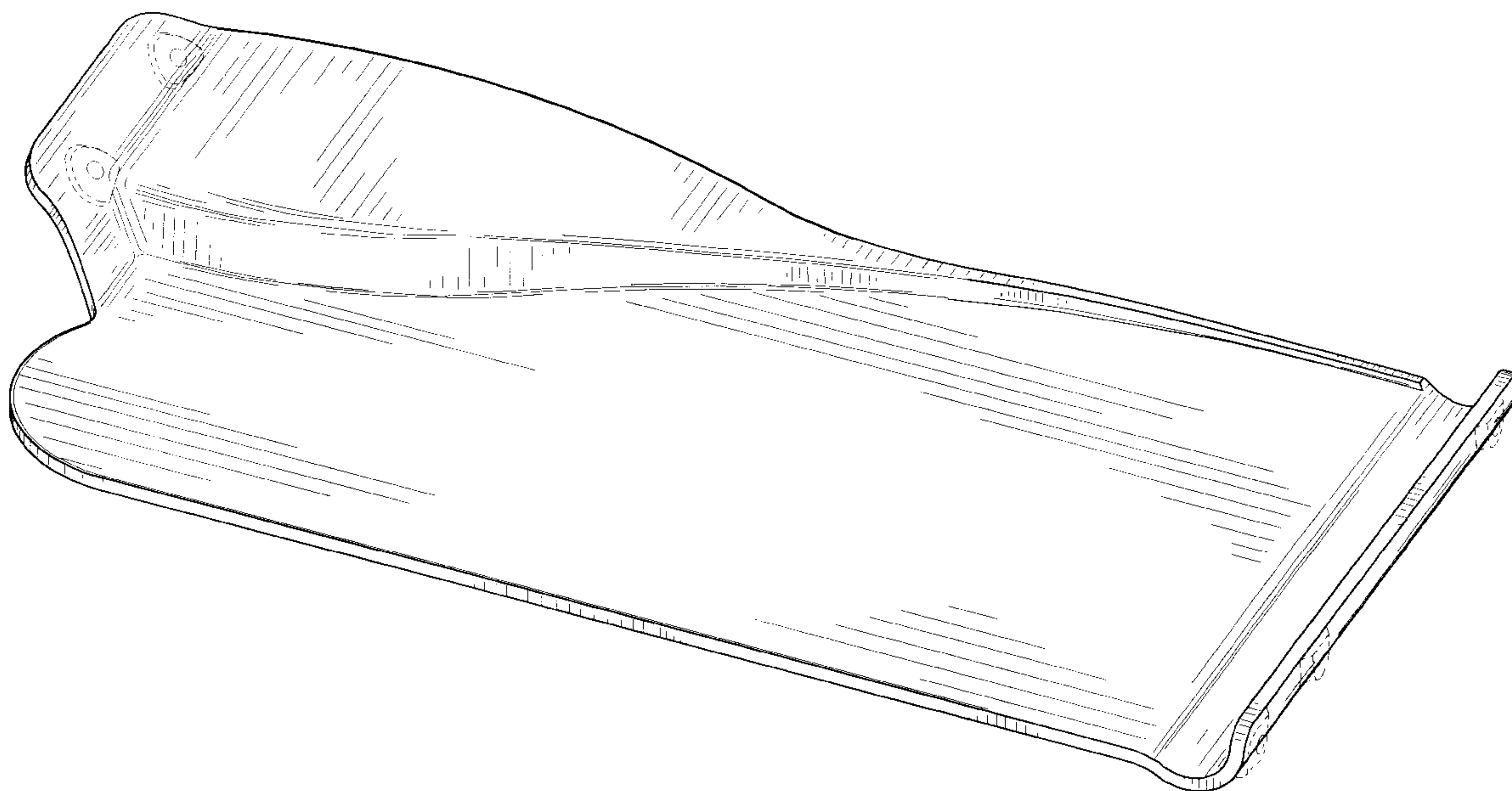
FIG. 12 is a bottom plan view of the embodiment of FIG. 8.

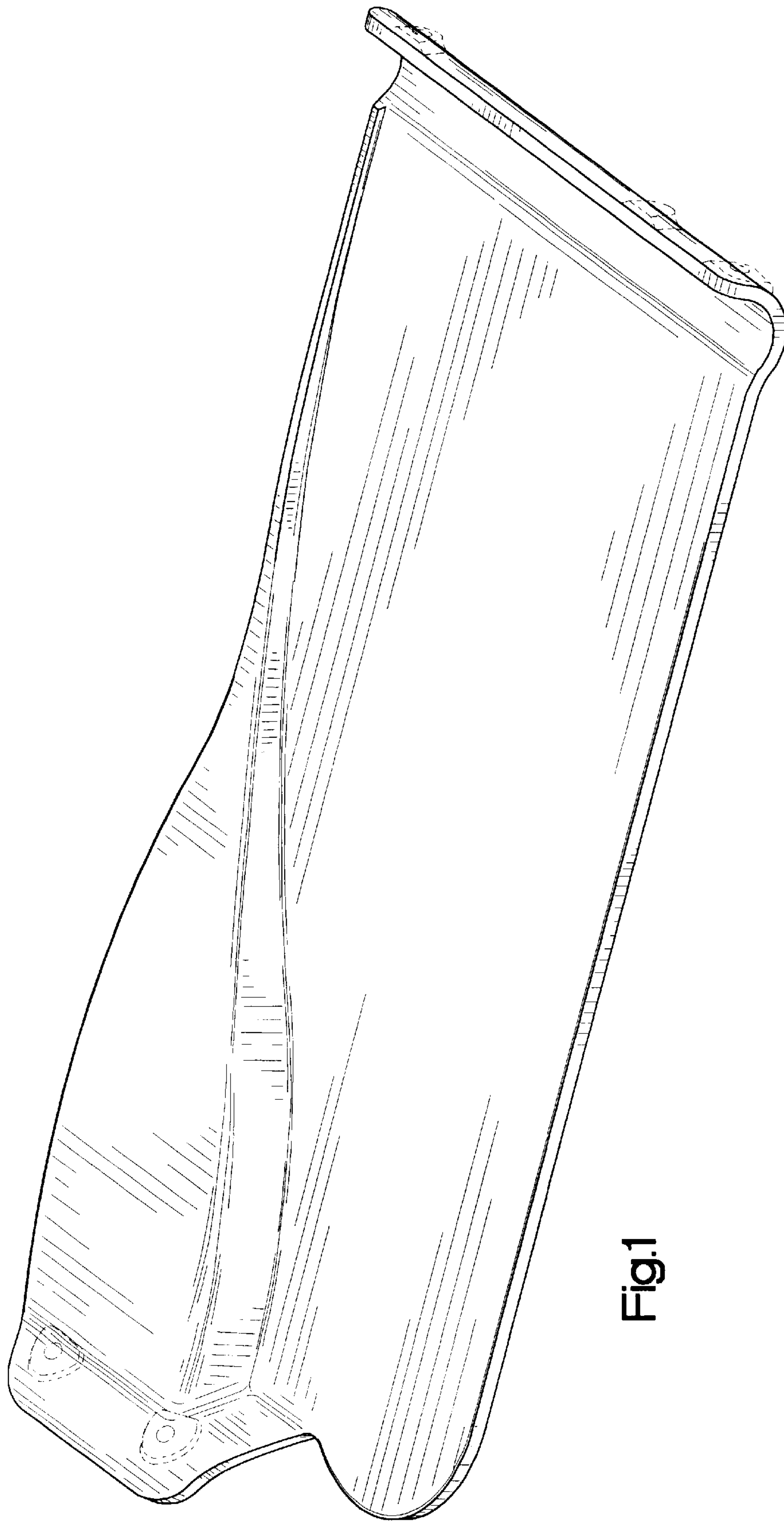

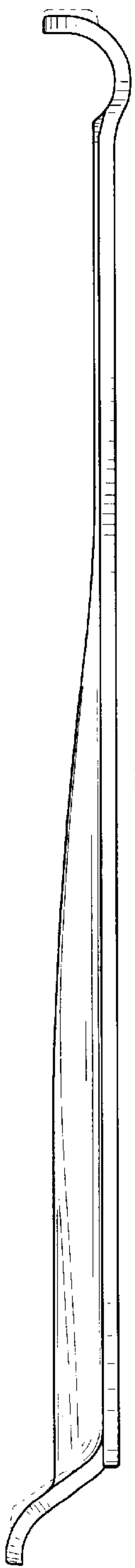

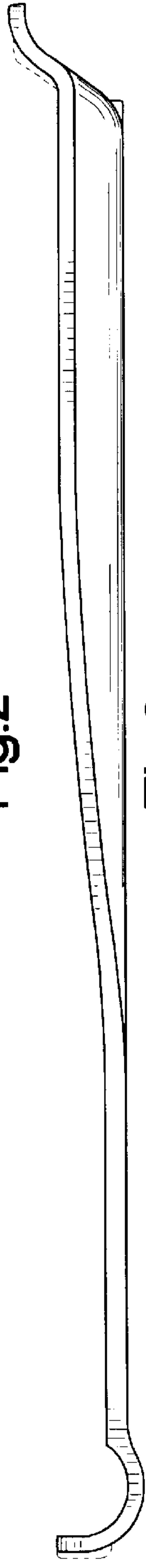

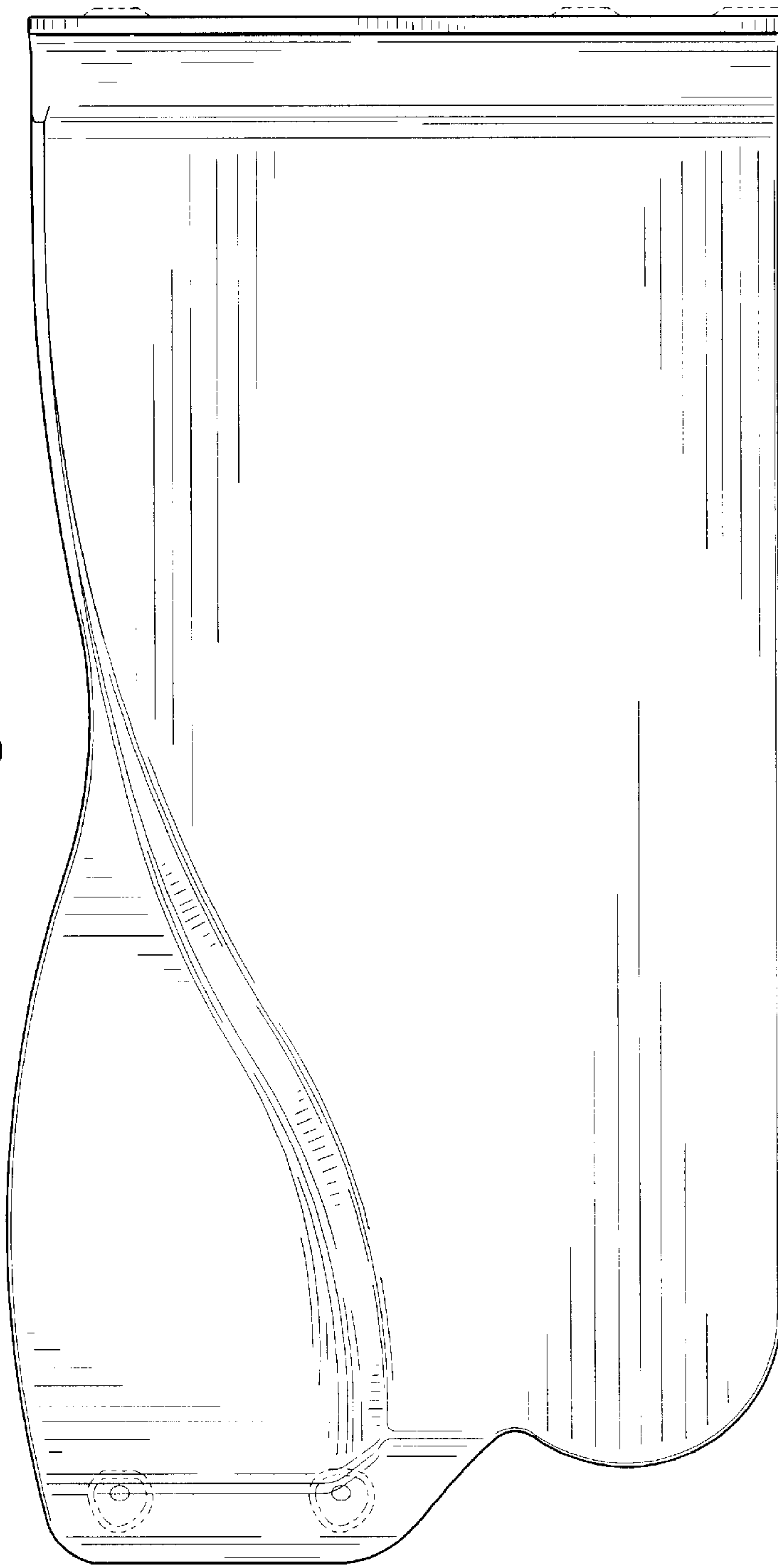

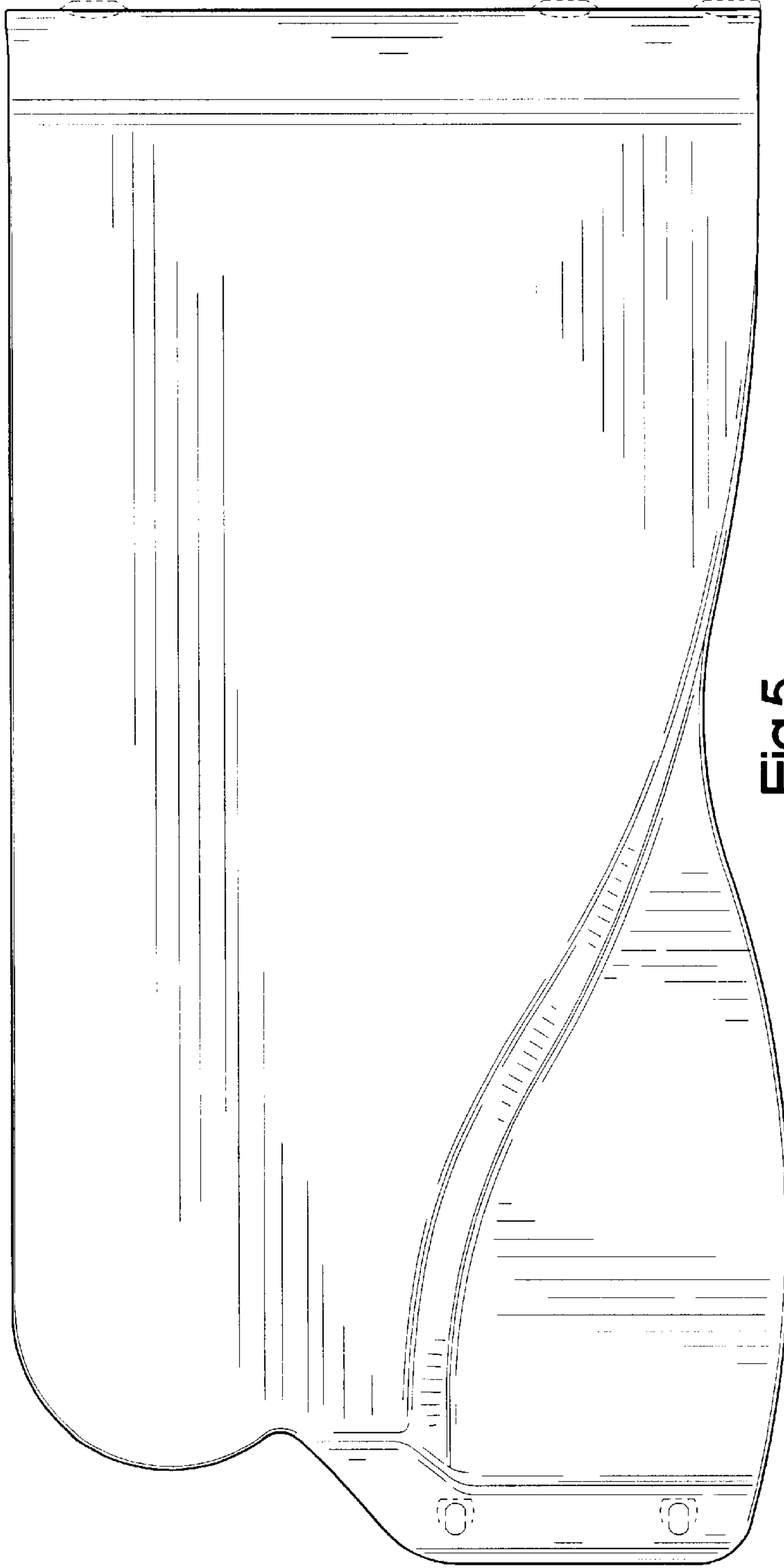

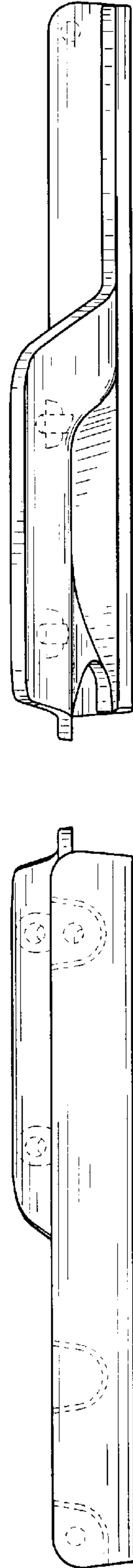

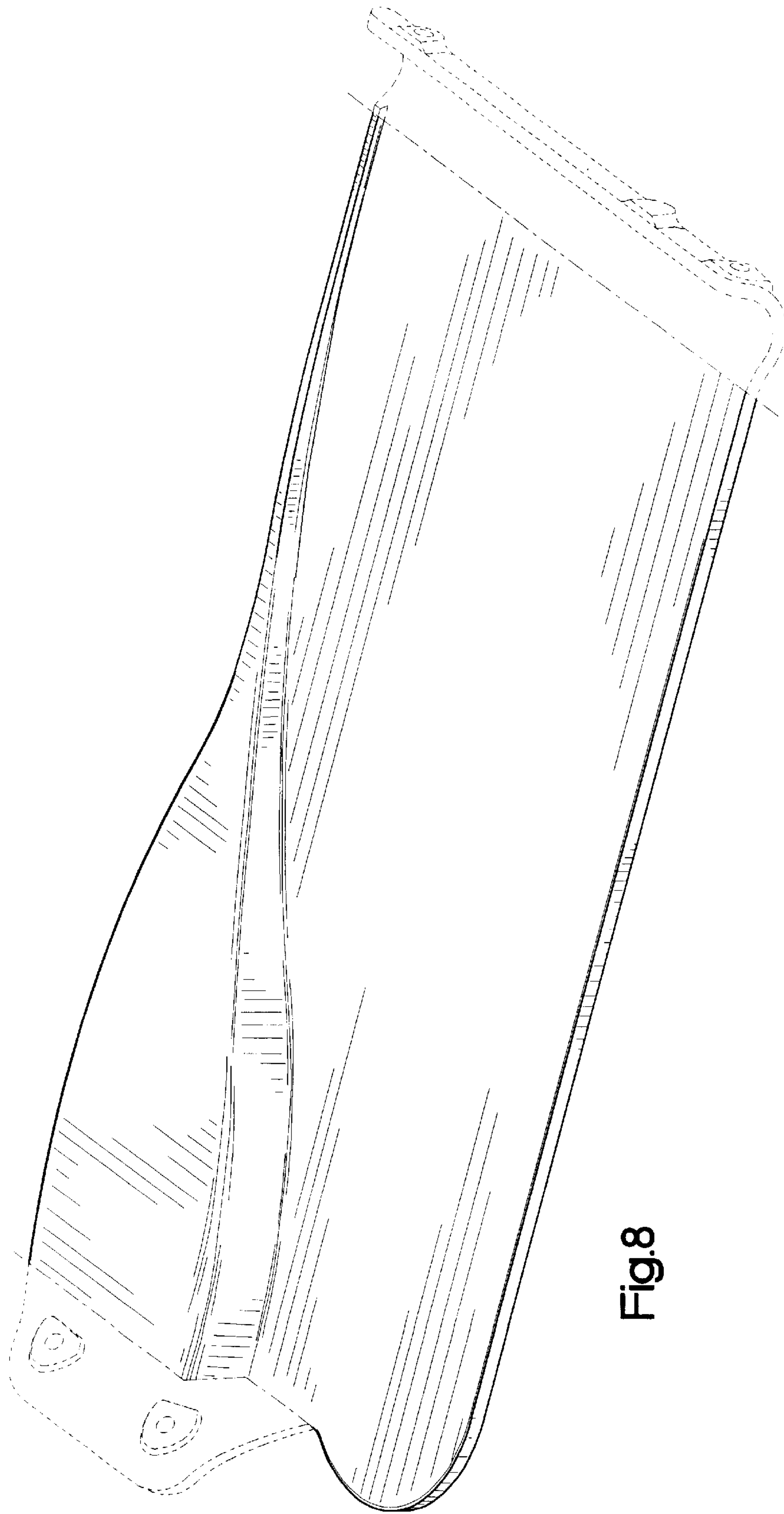

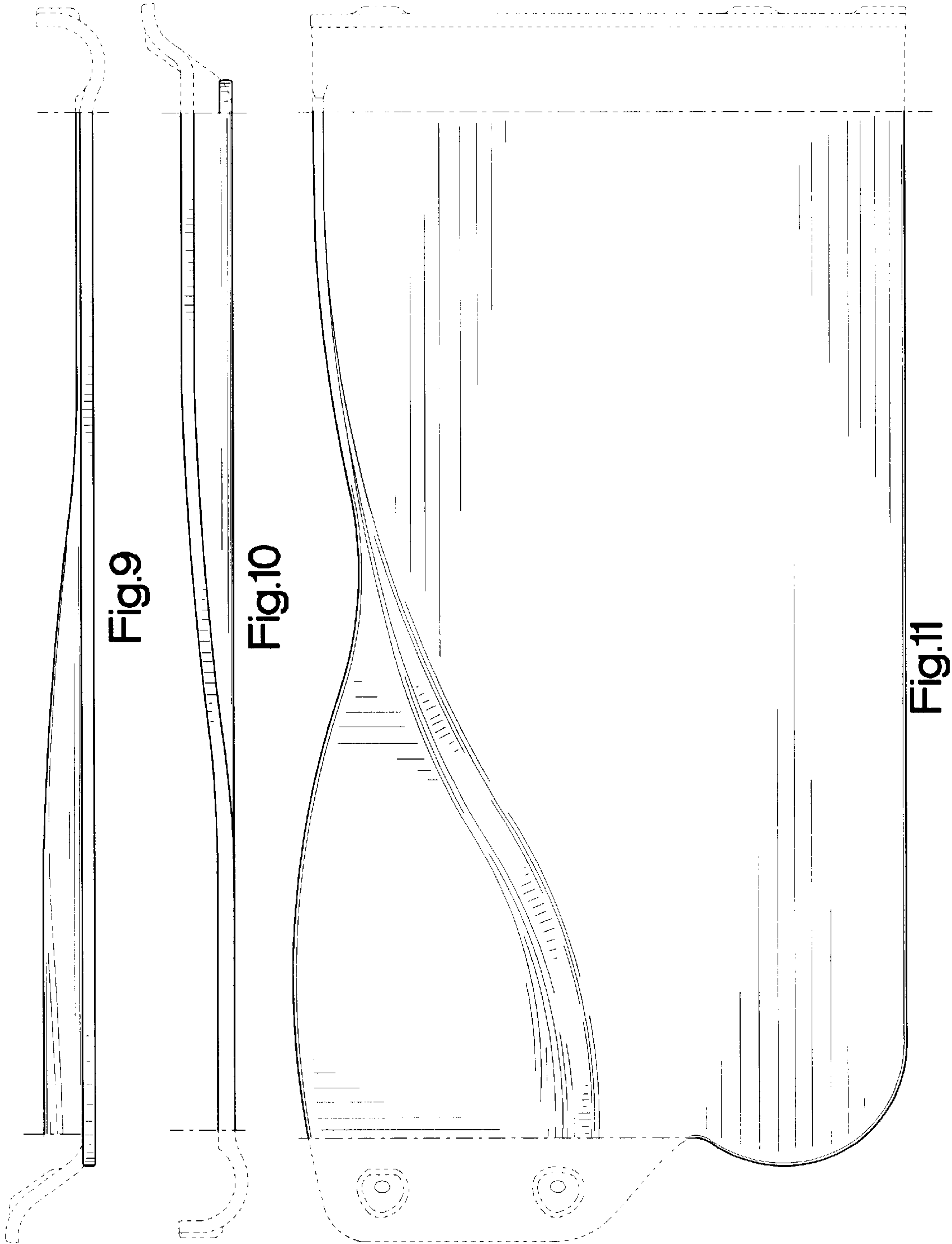

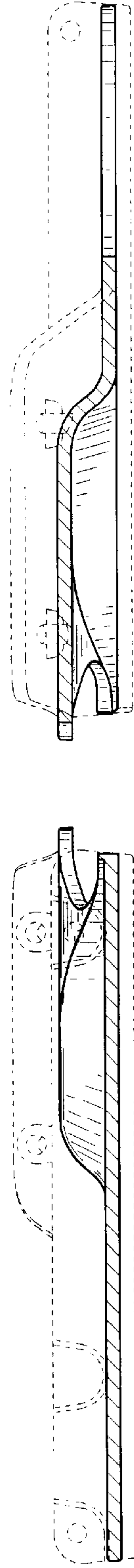
