DESCRIPTION

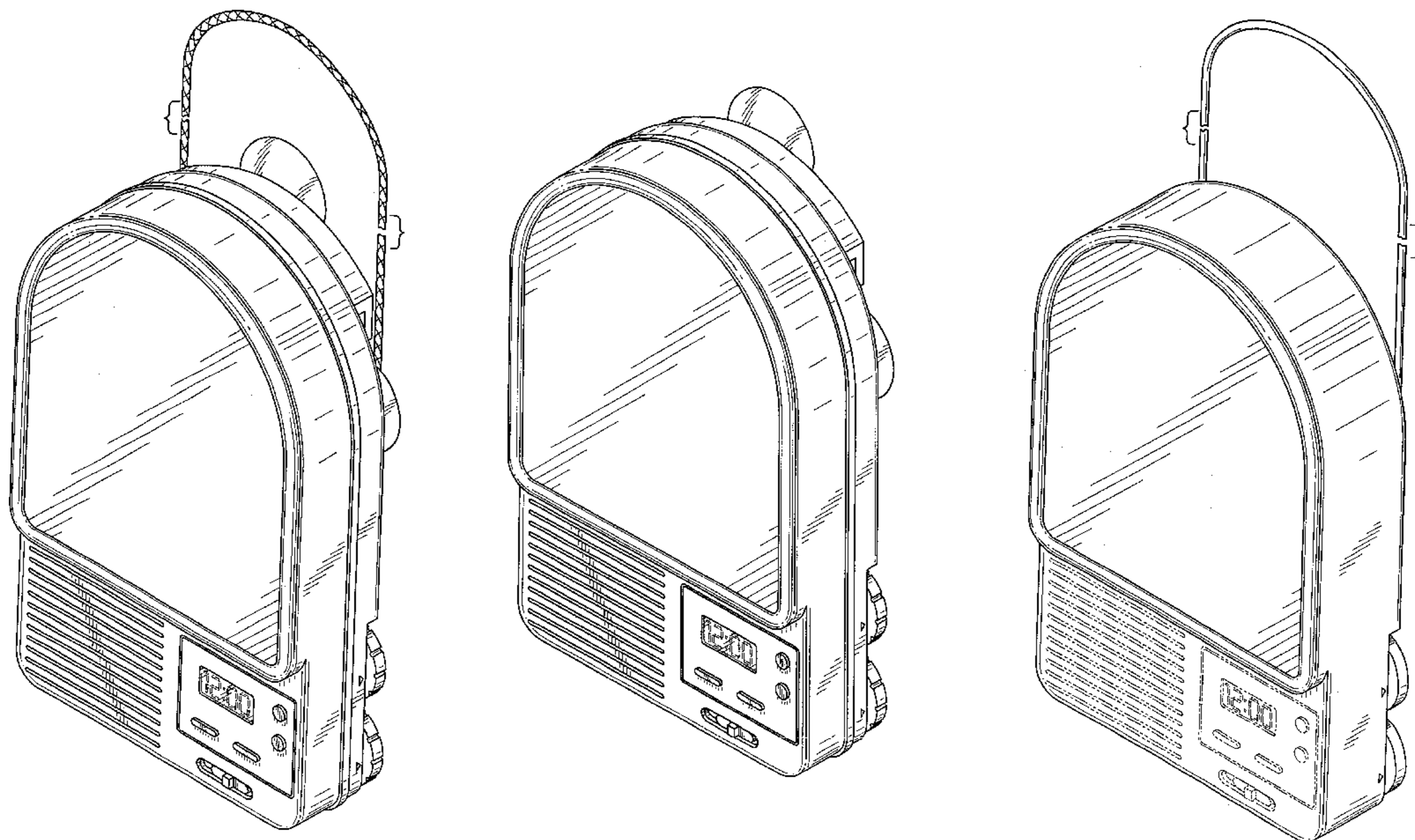

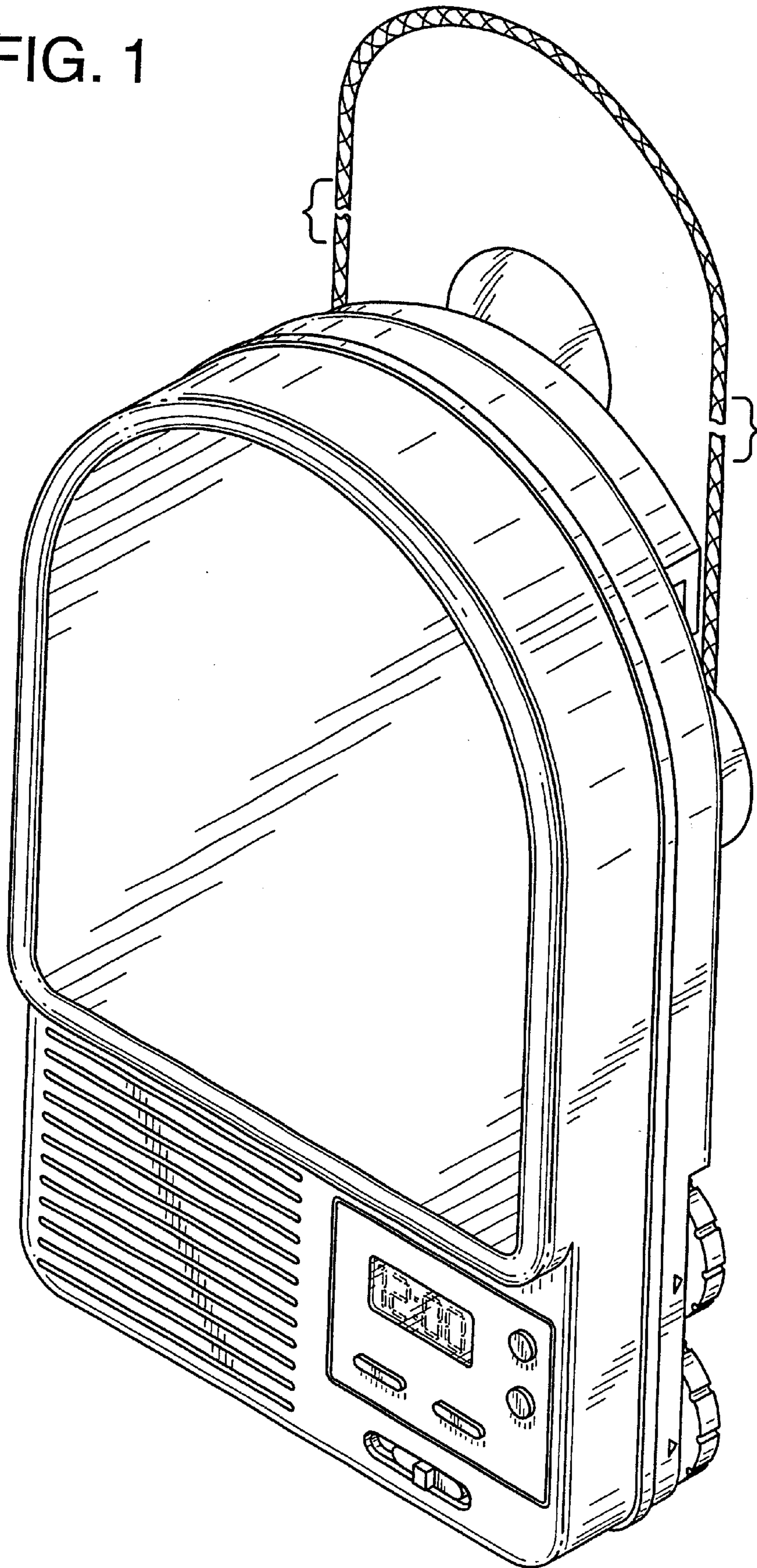

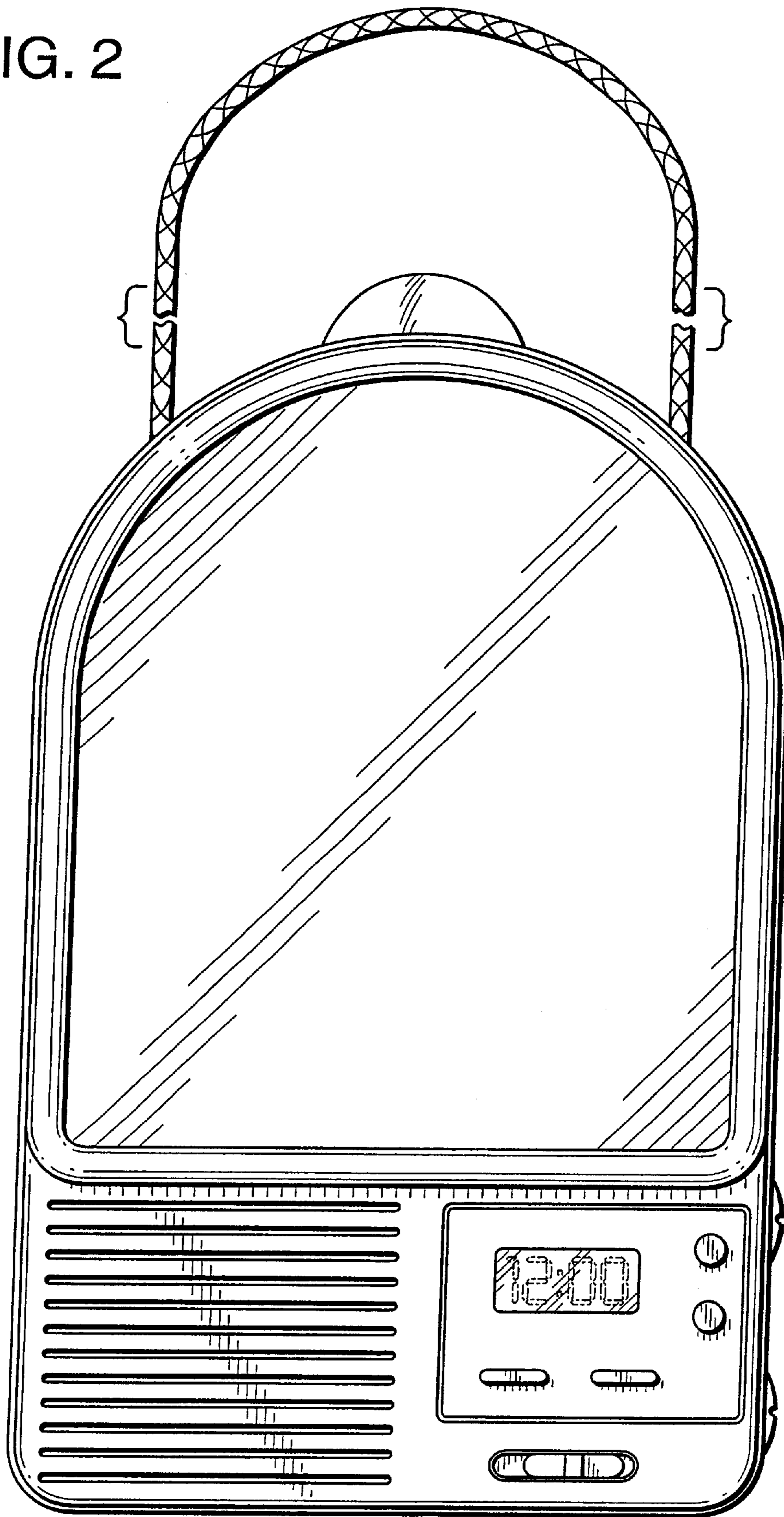

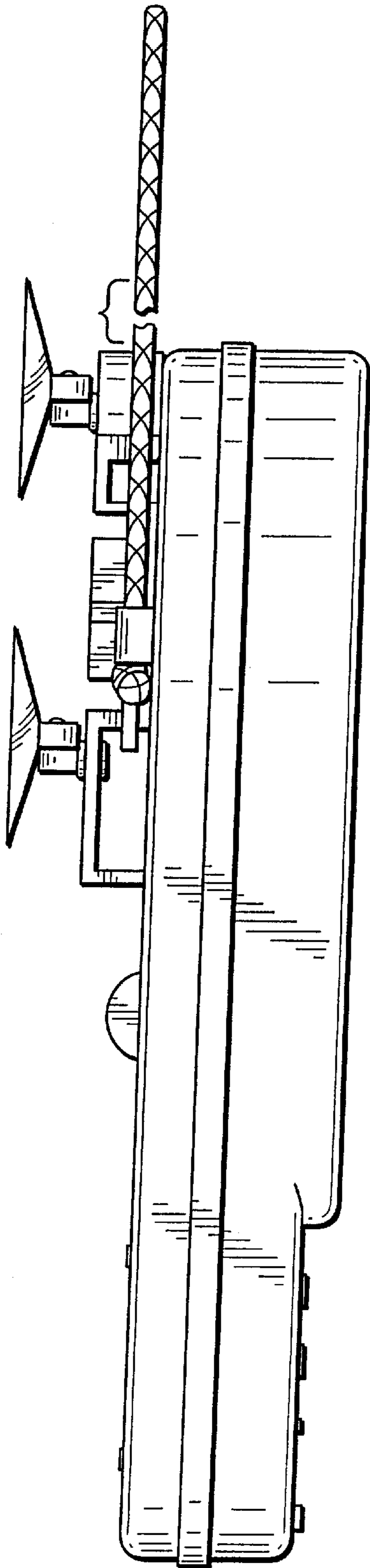

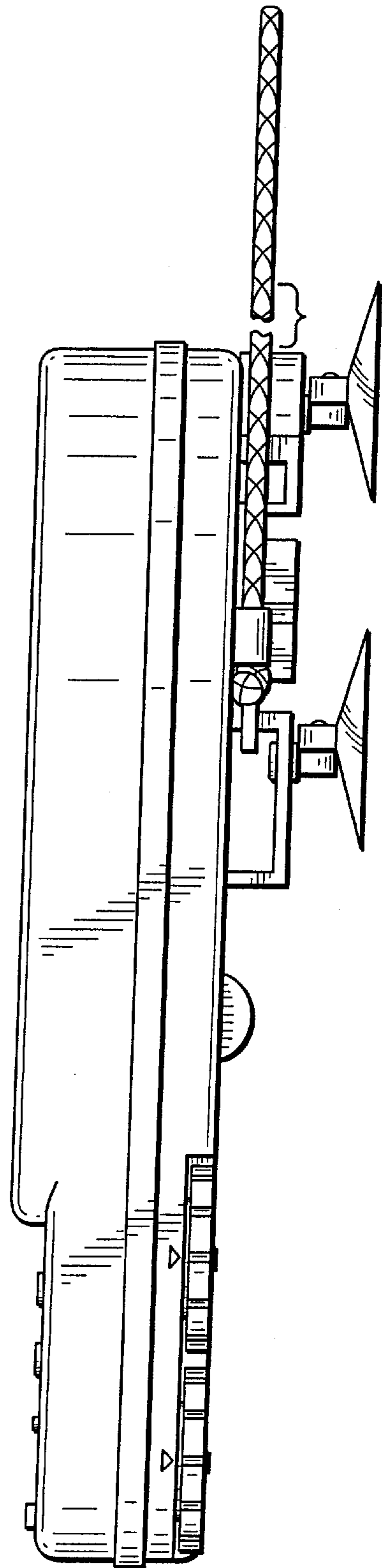

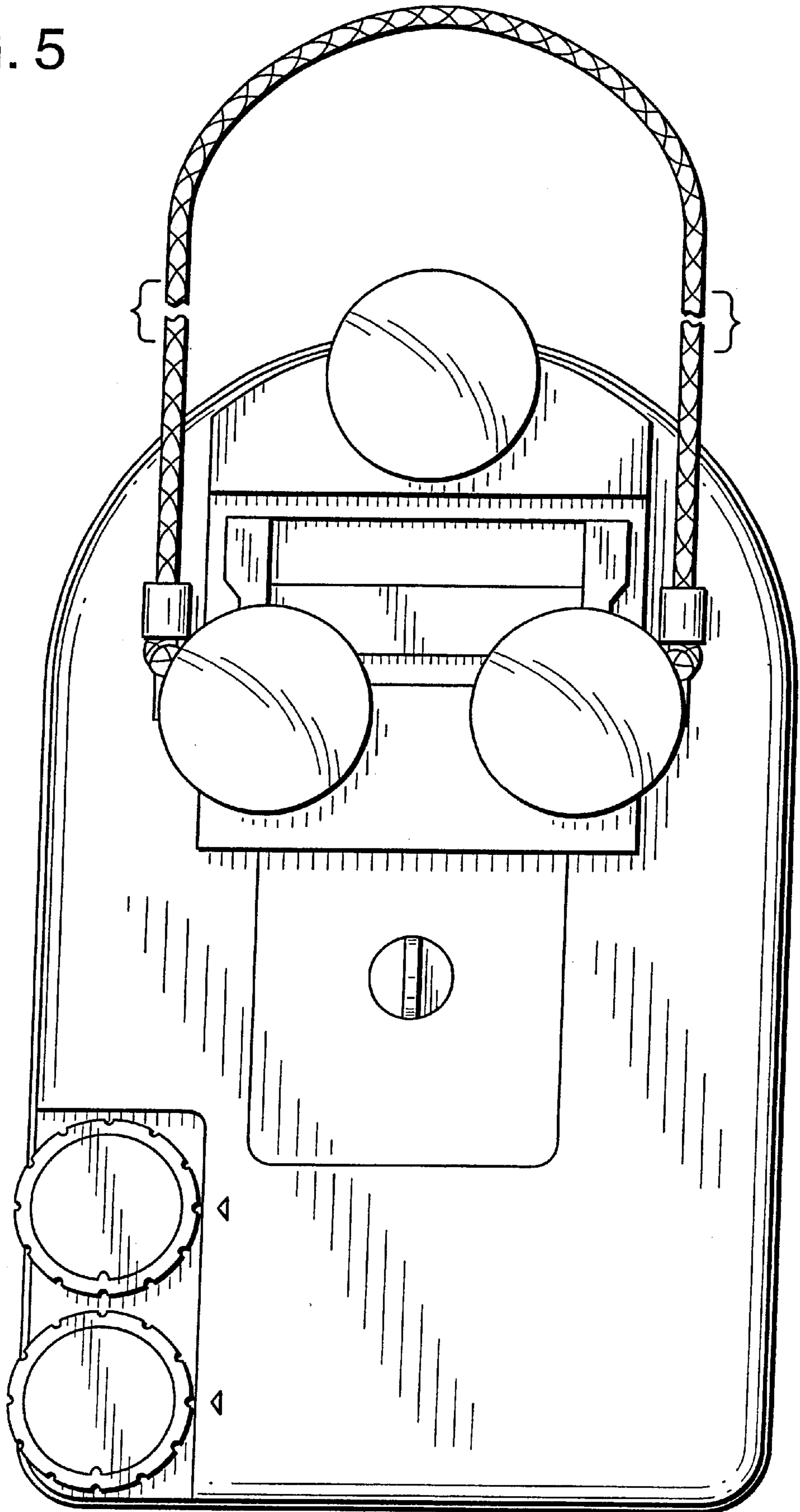

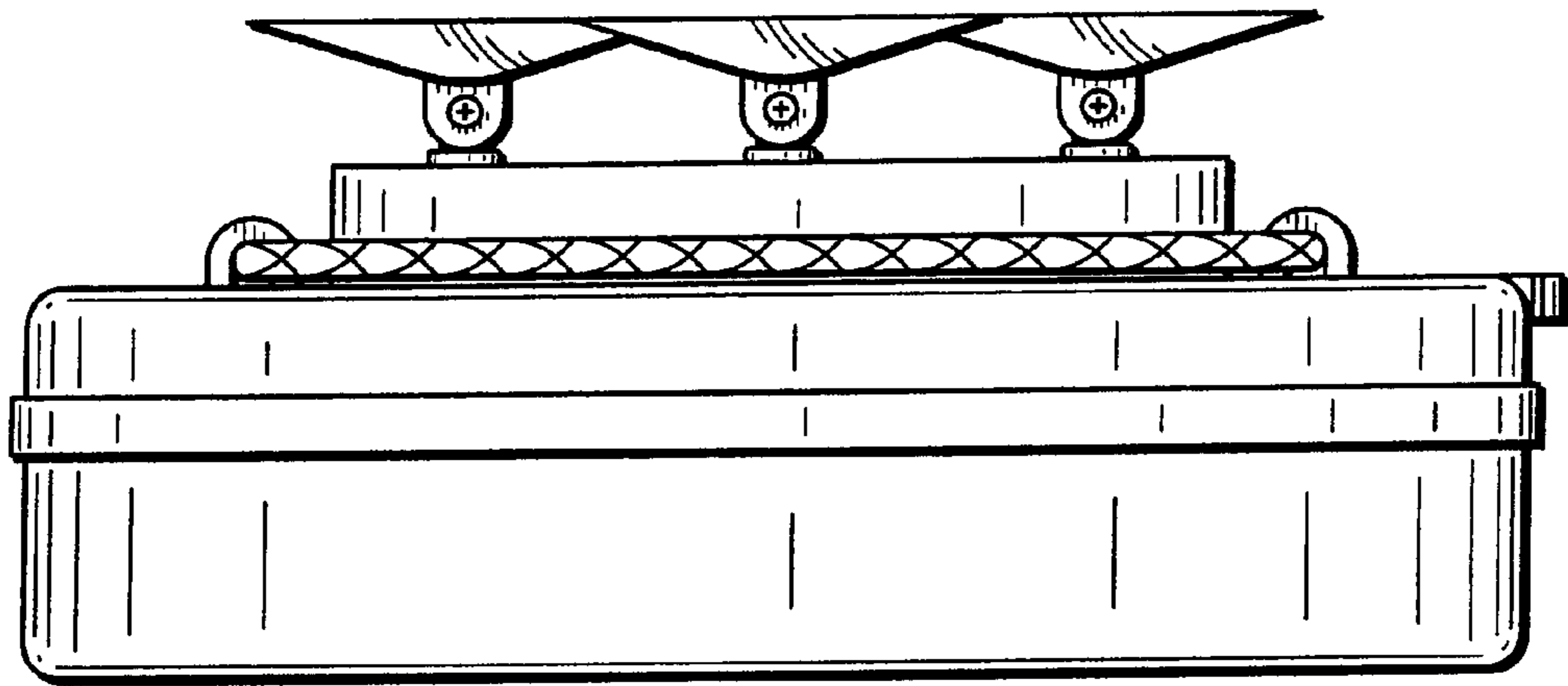

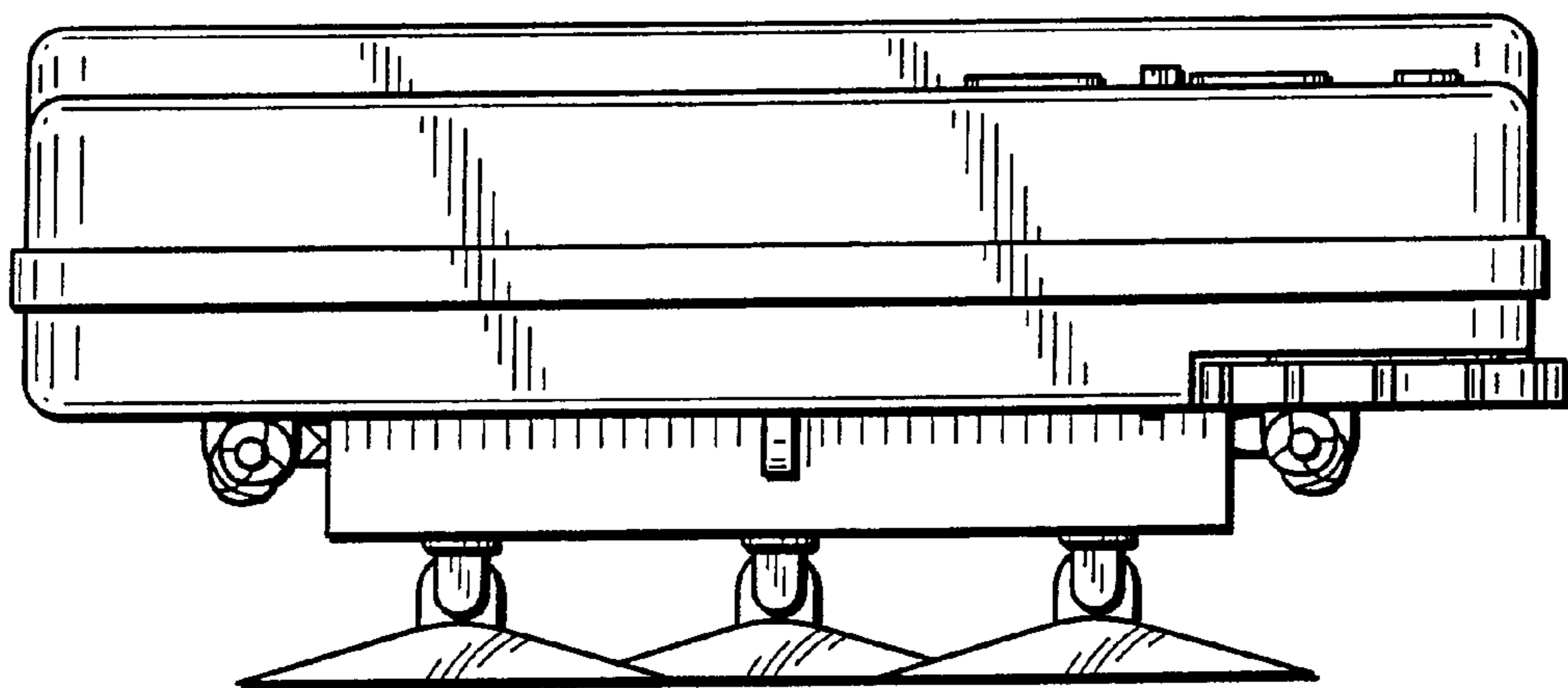

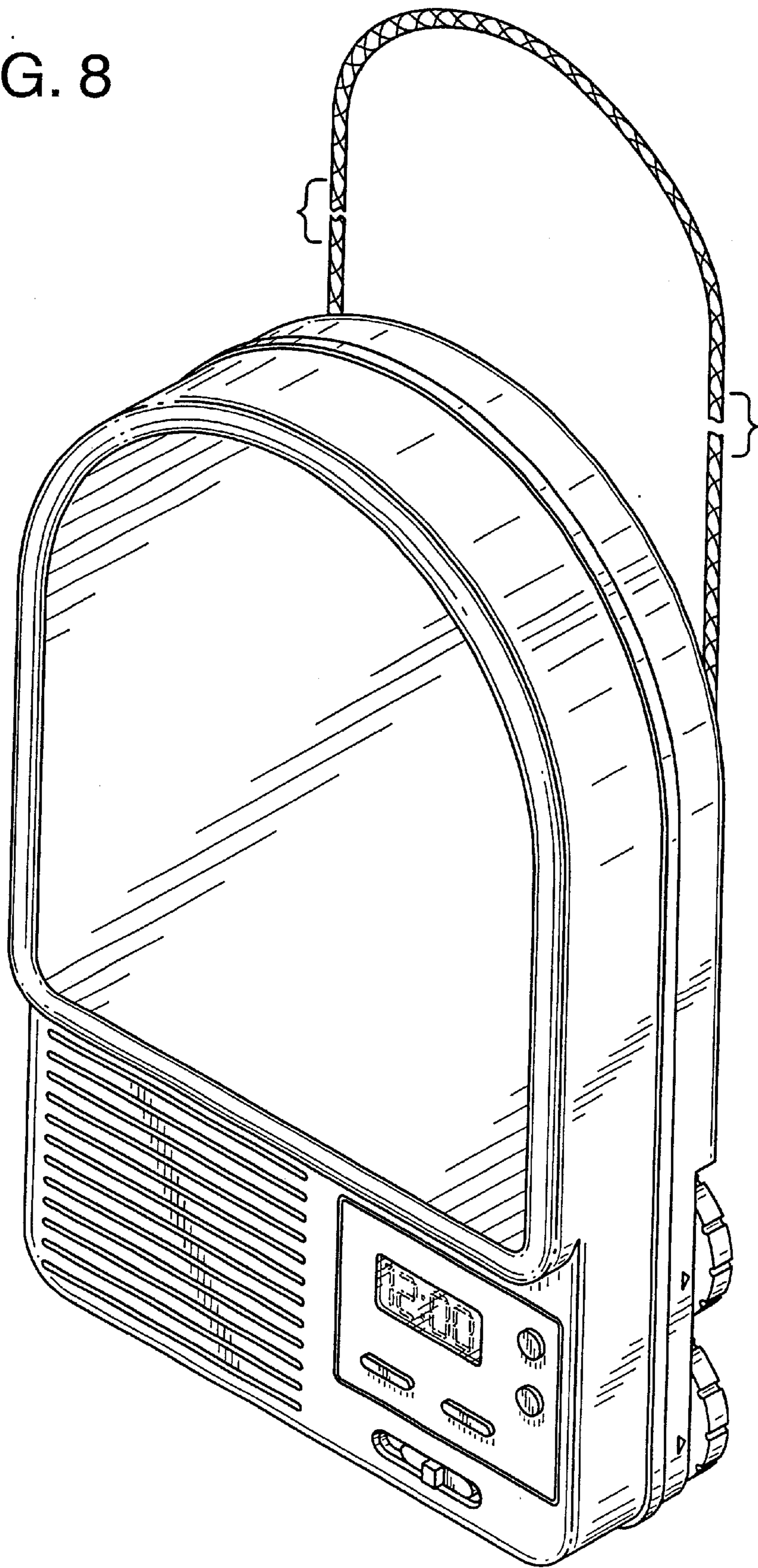

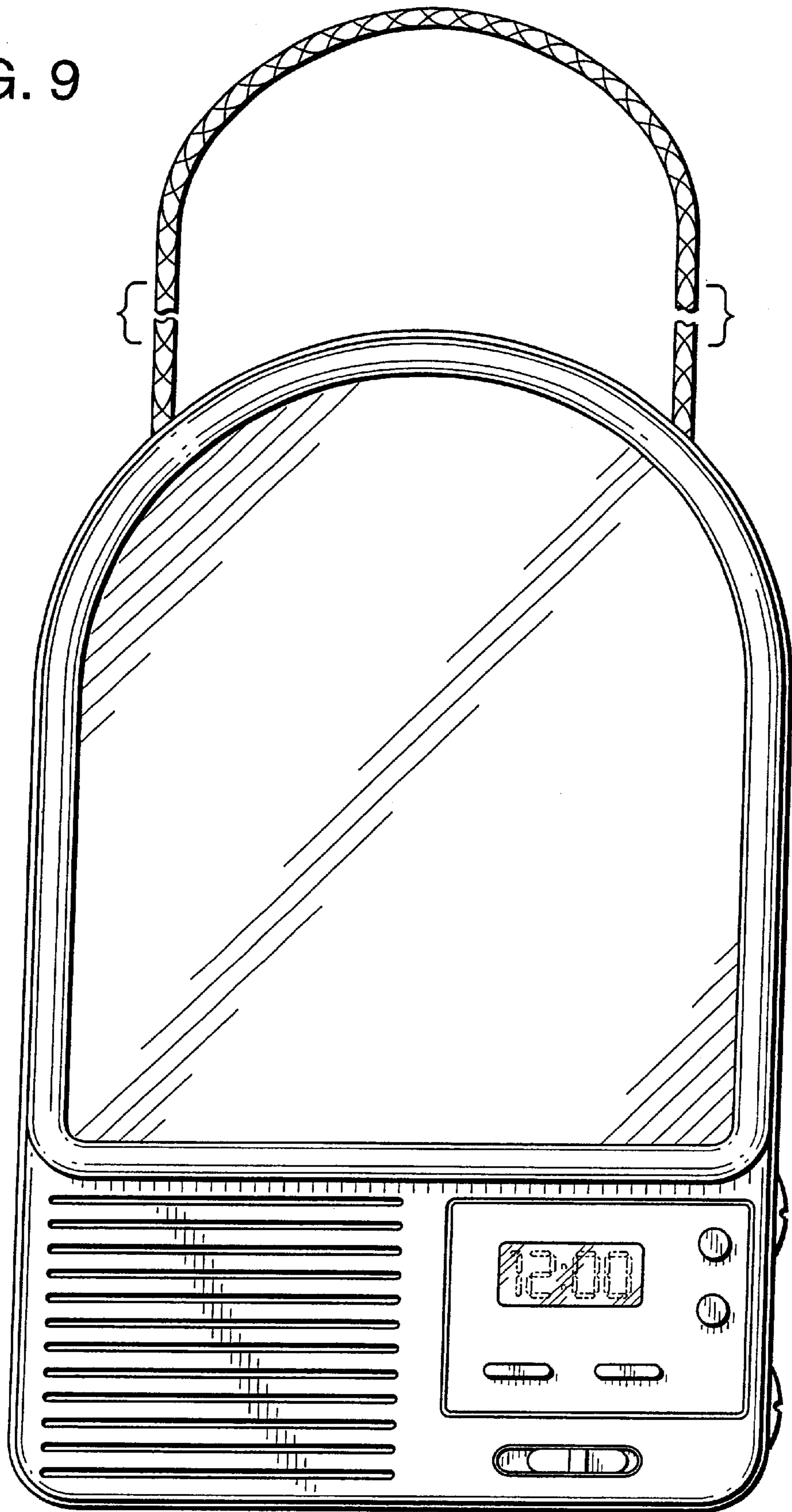

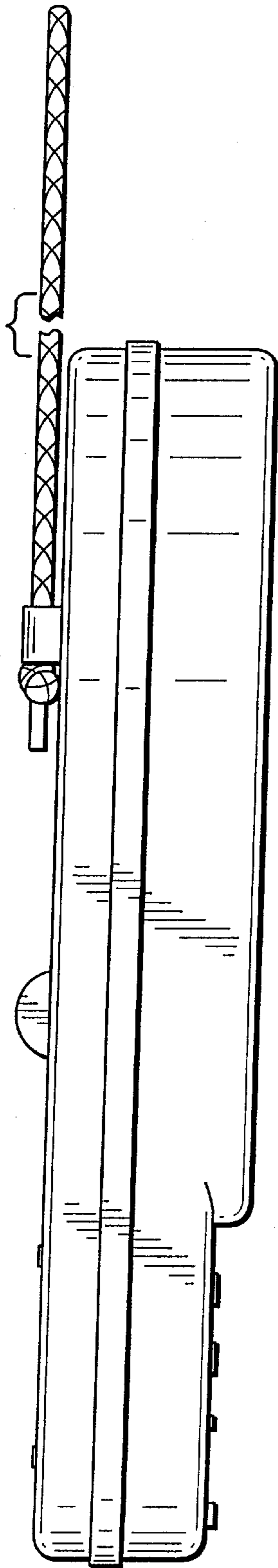

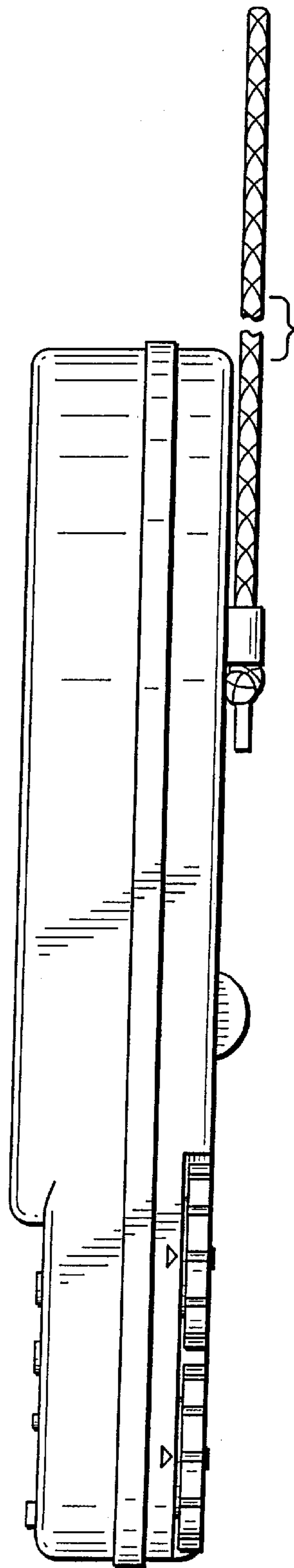

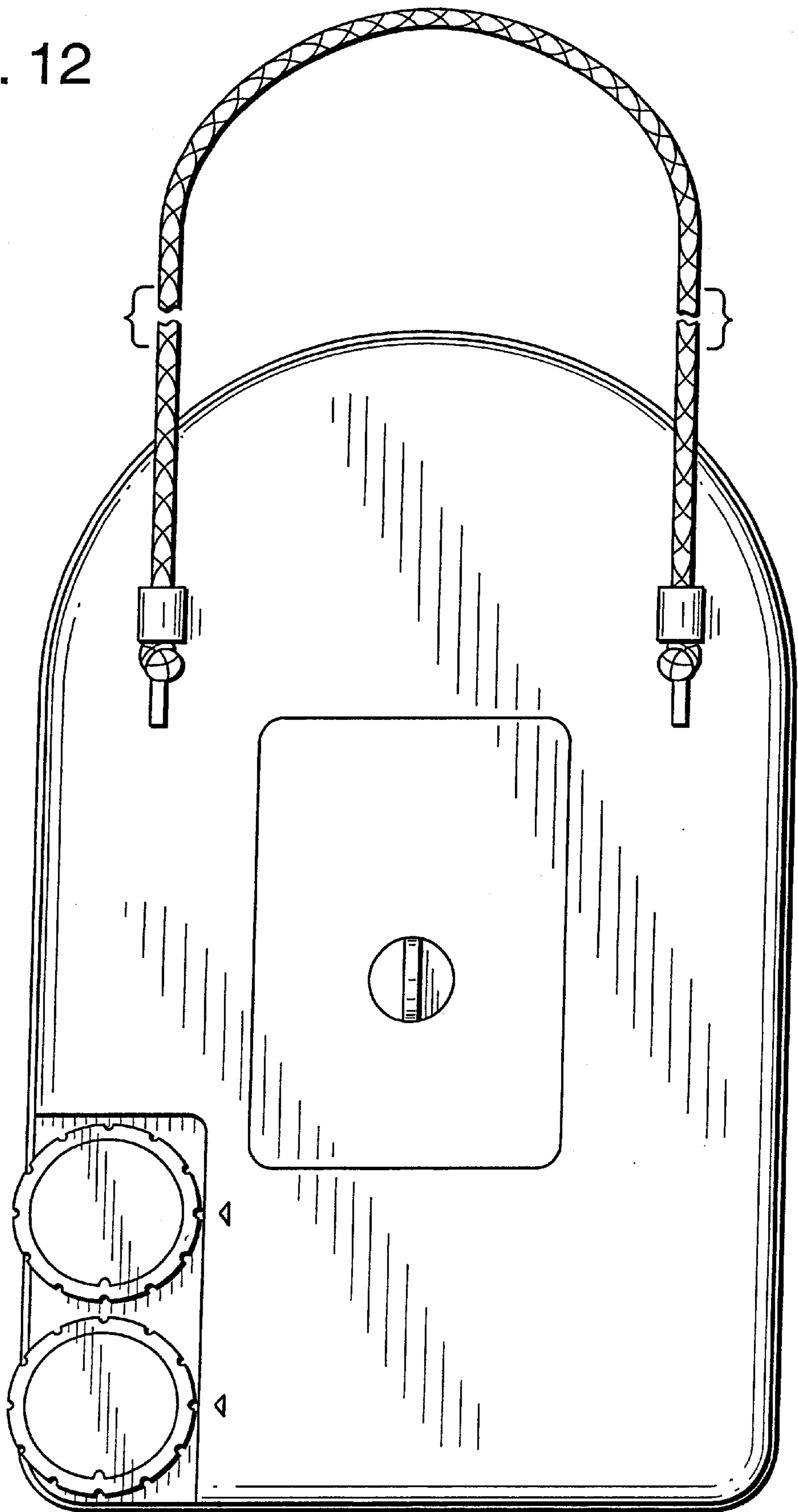

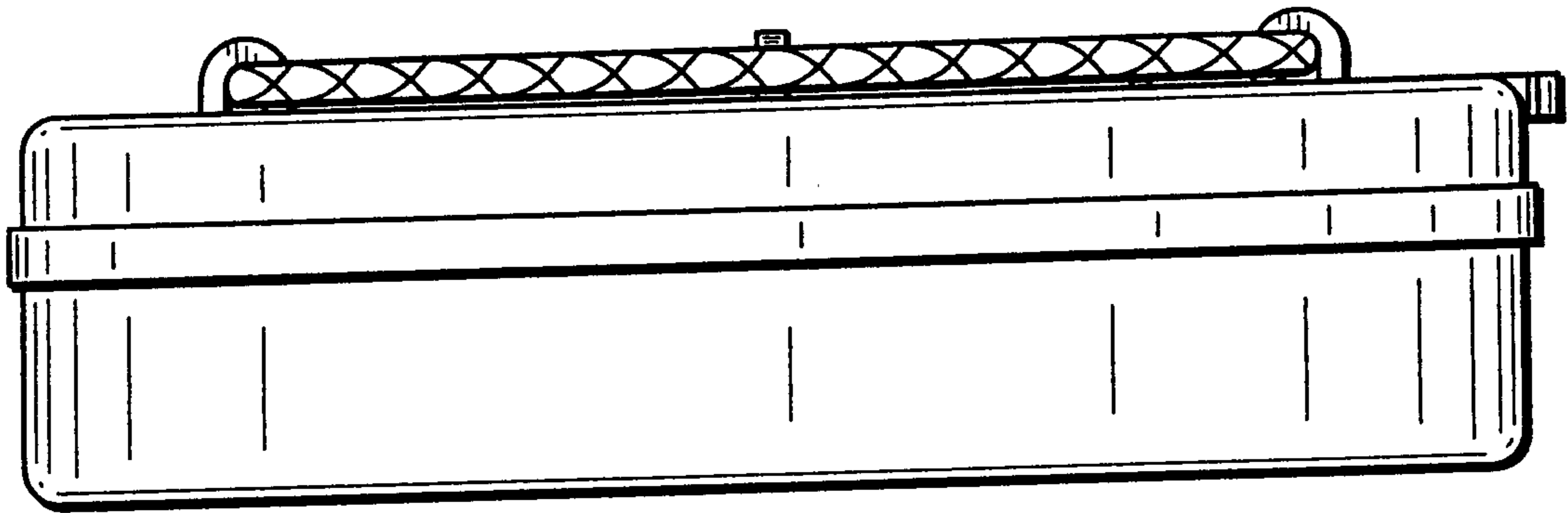

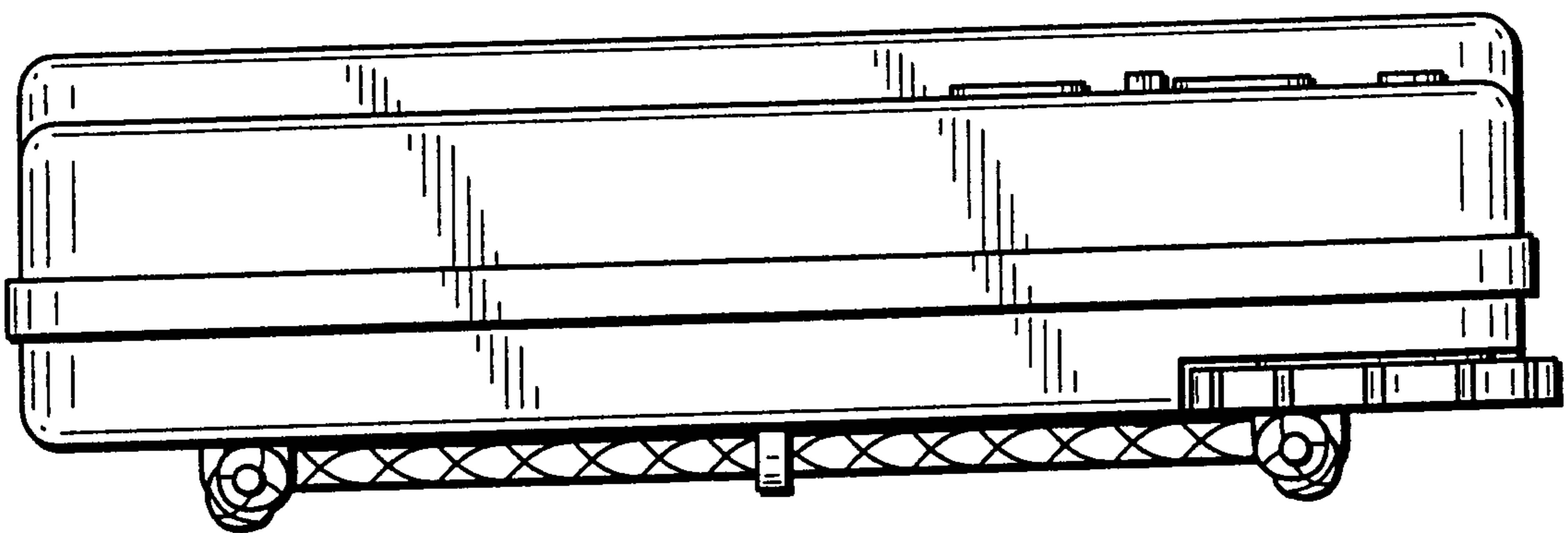

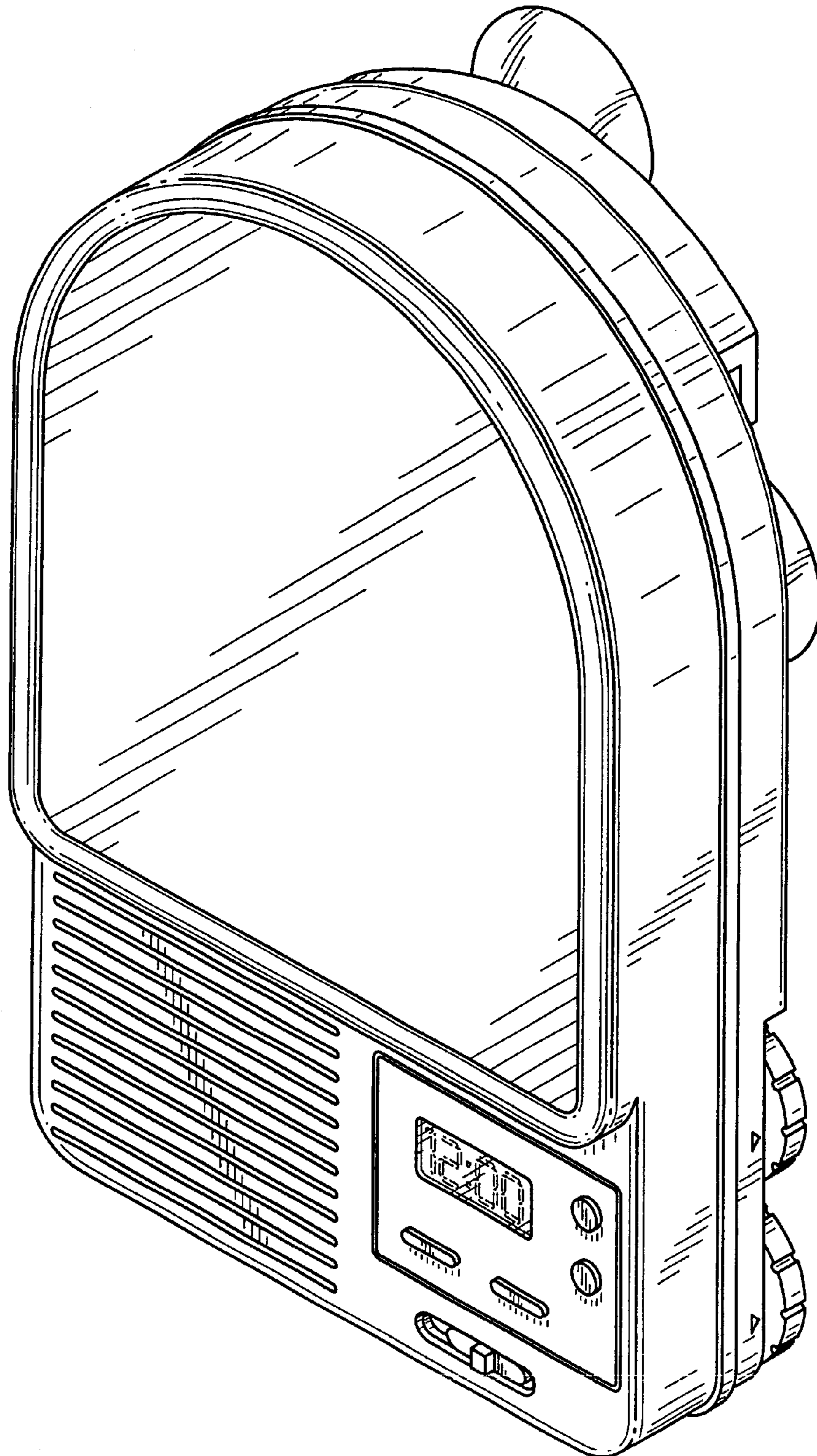

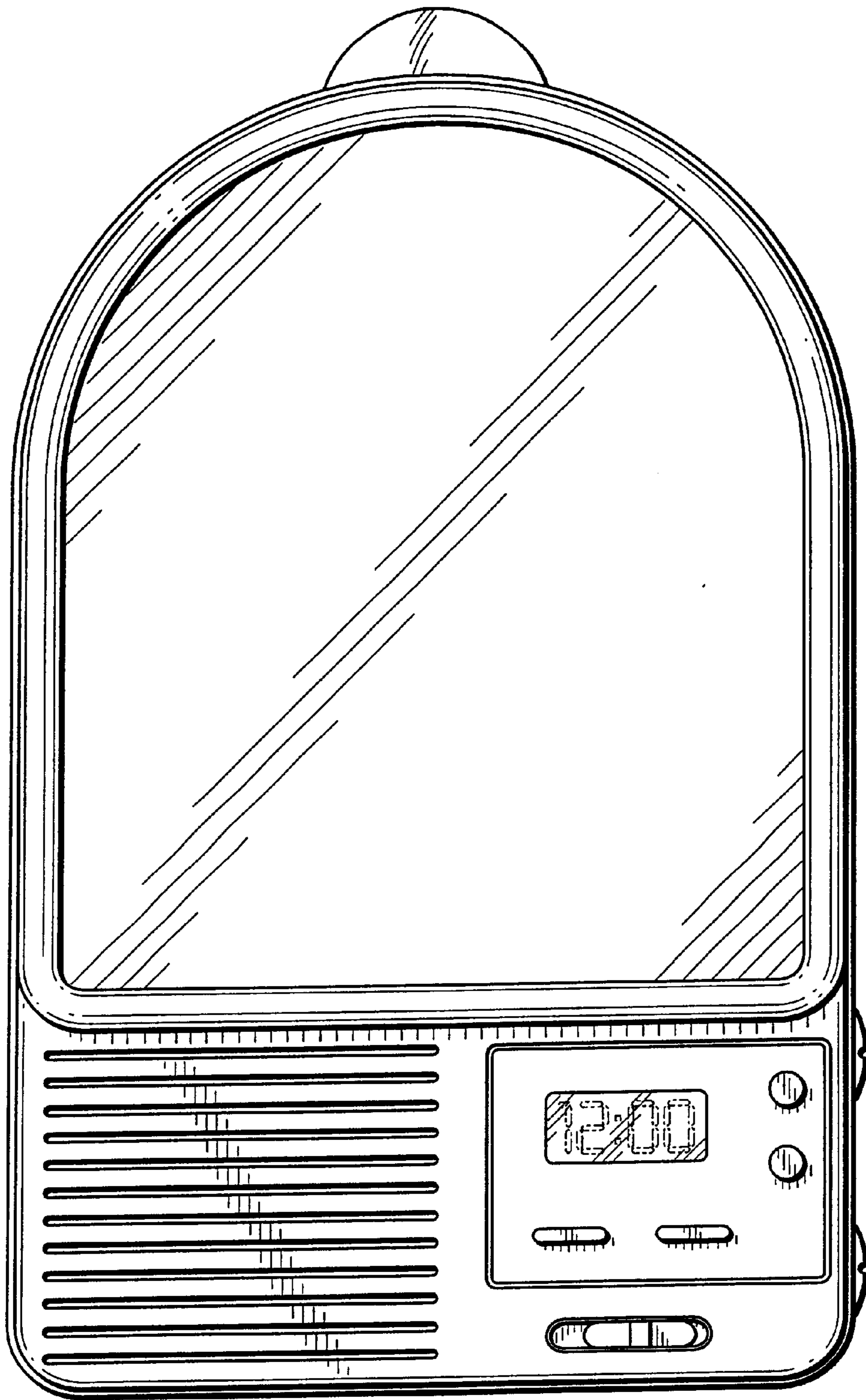

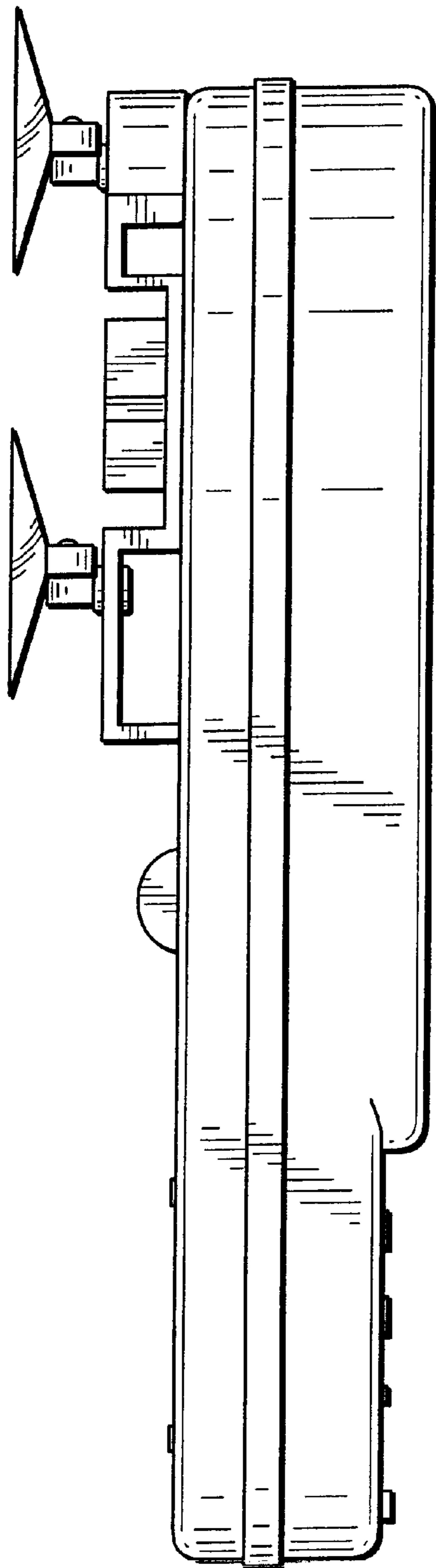

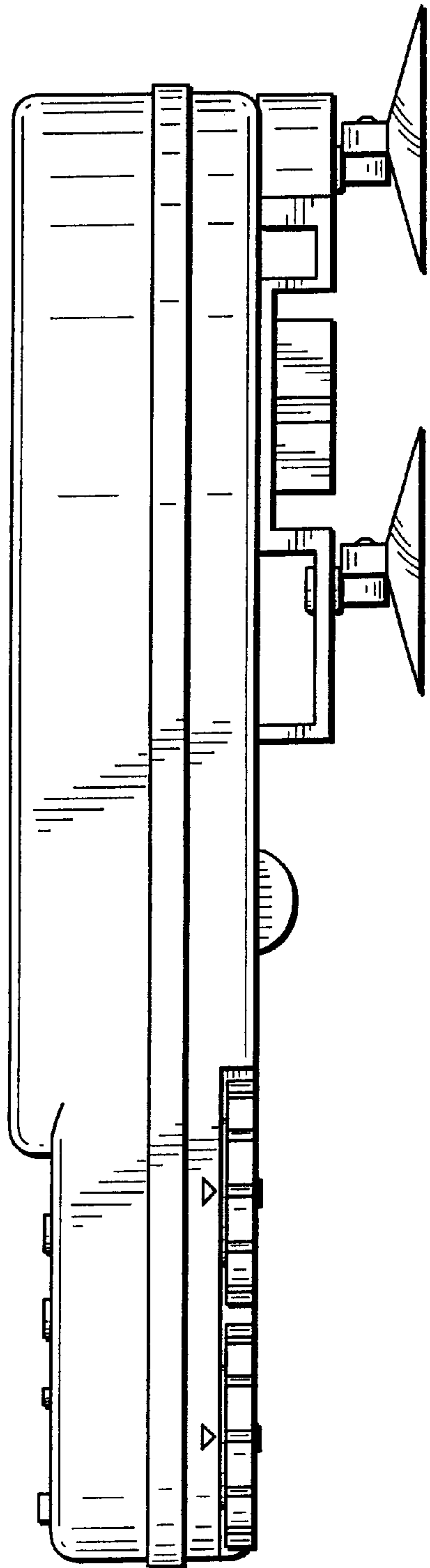

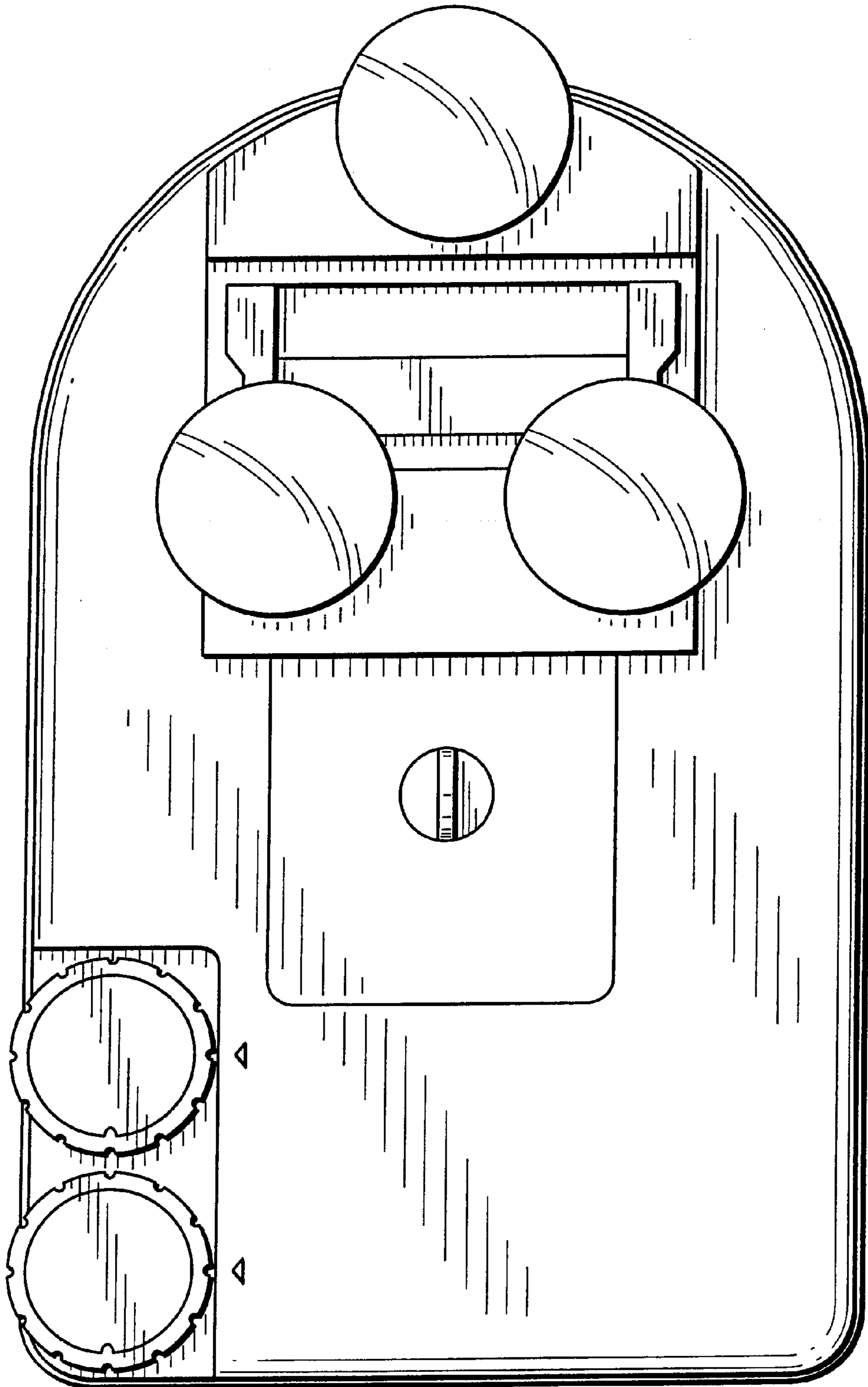

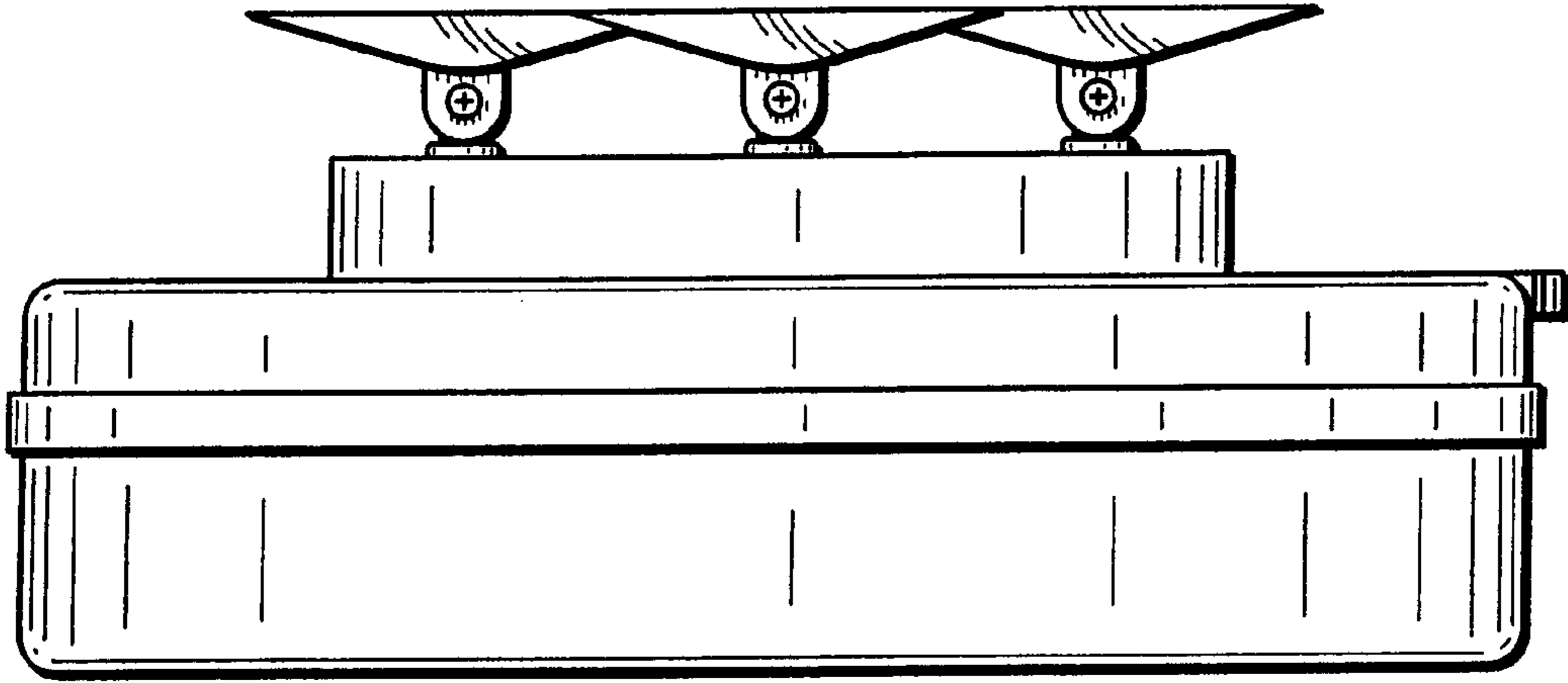

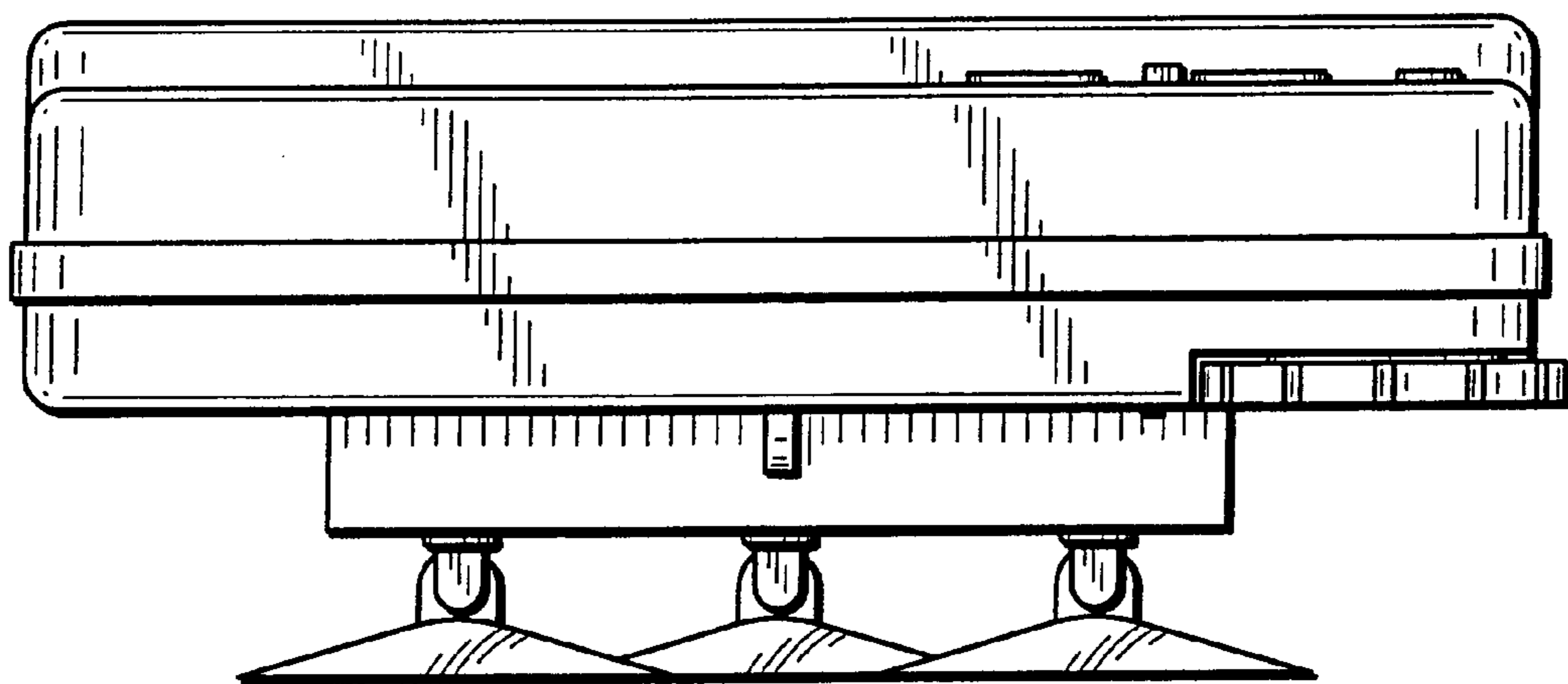

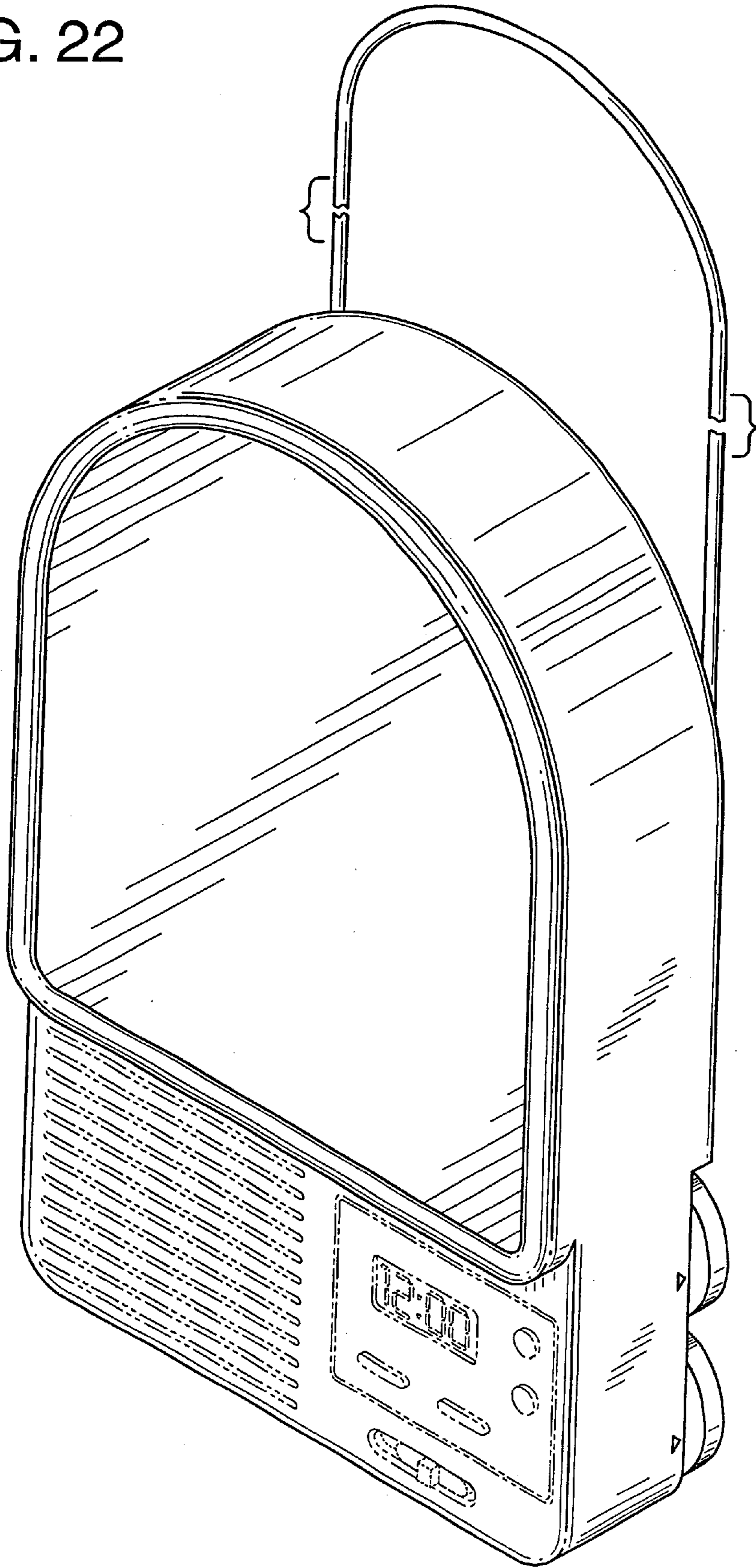

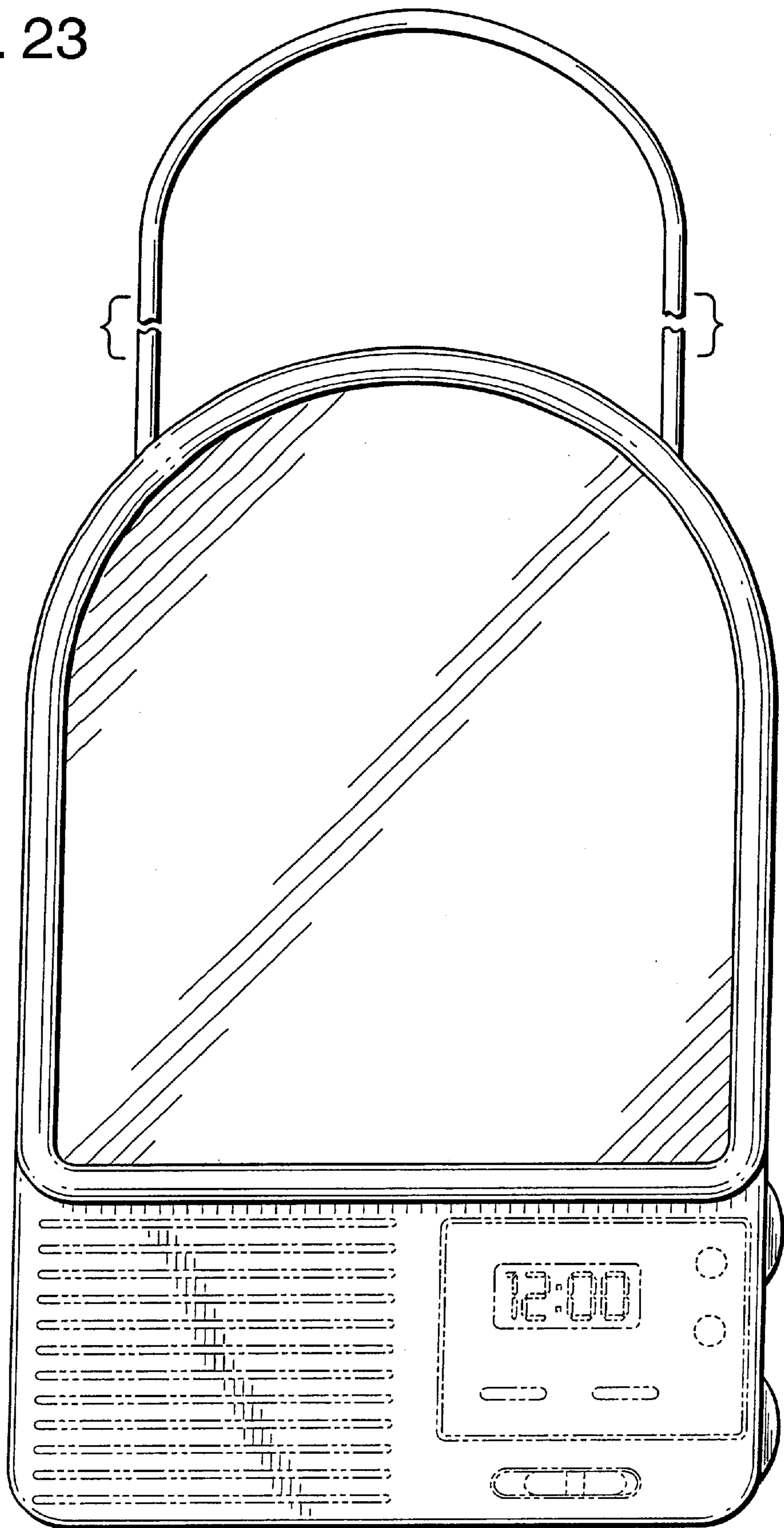

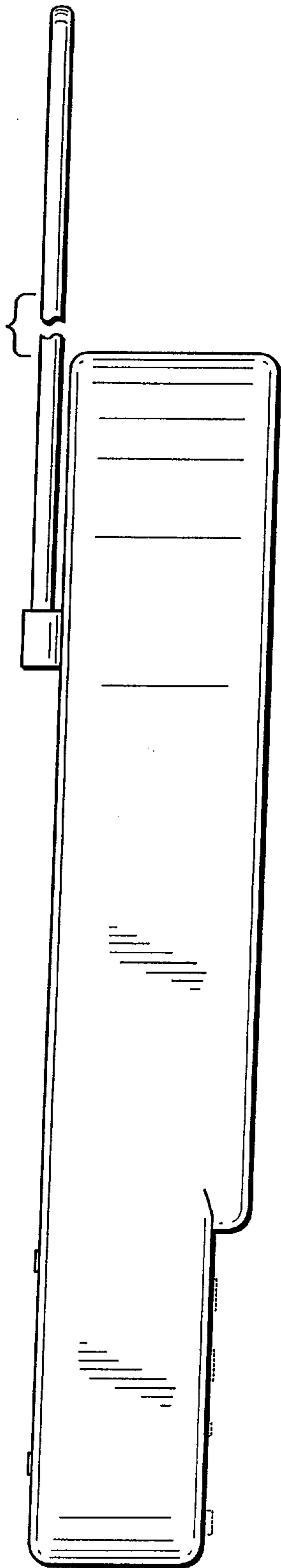

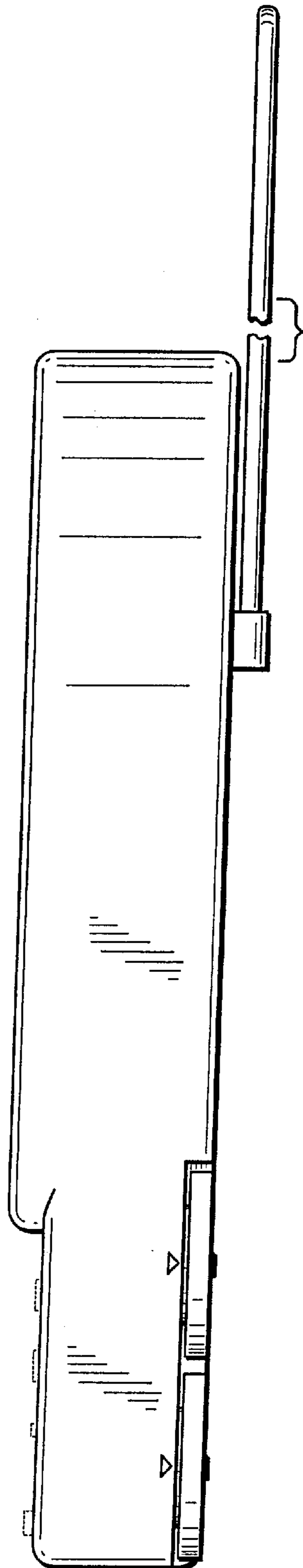

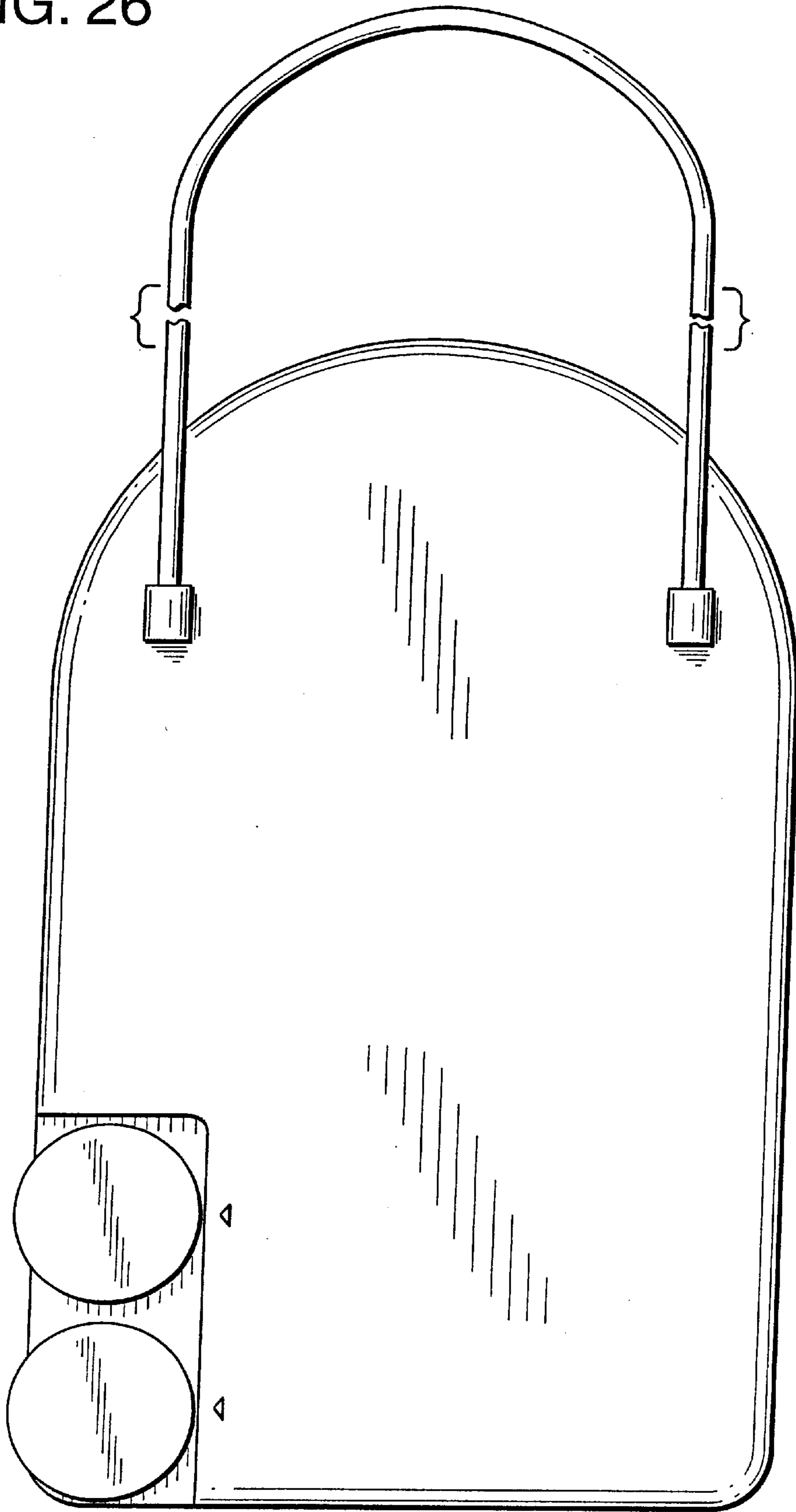

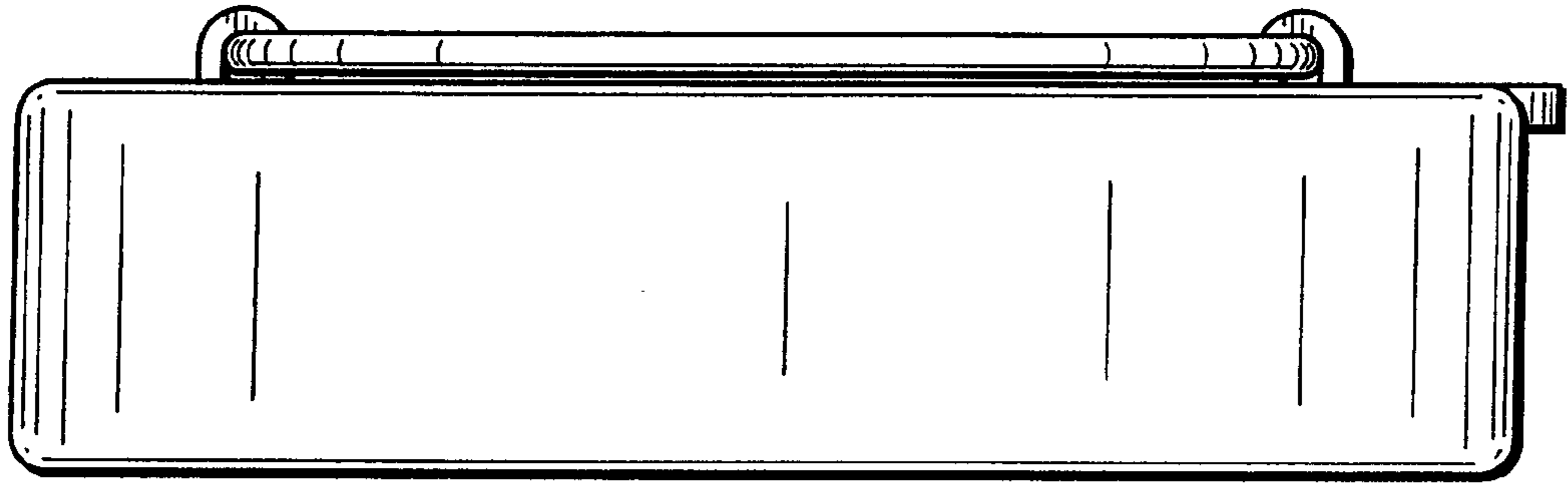
