The ornamental design for a combined disc player, radio receiver and clock, as shown.

**DESCRIPTION**

FIG. 1 is a perspective view of a combined disc player, radio receiver and clock showing my new design;

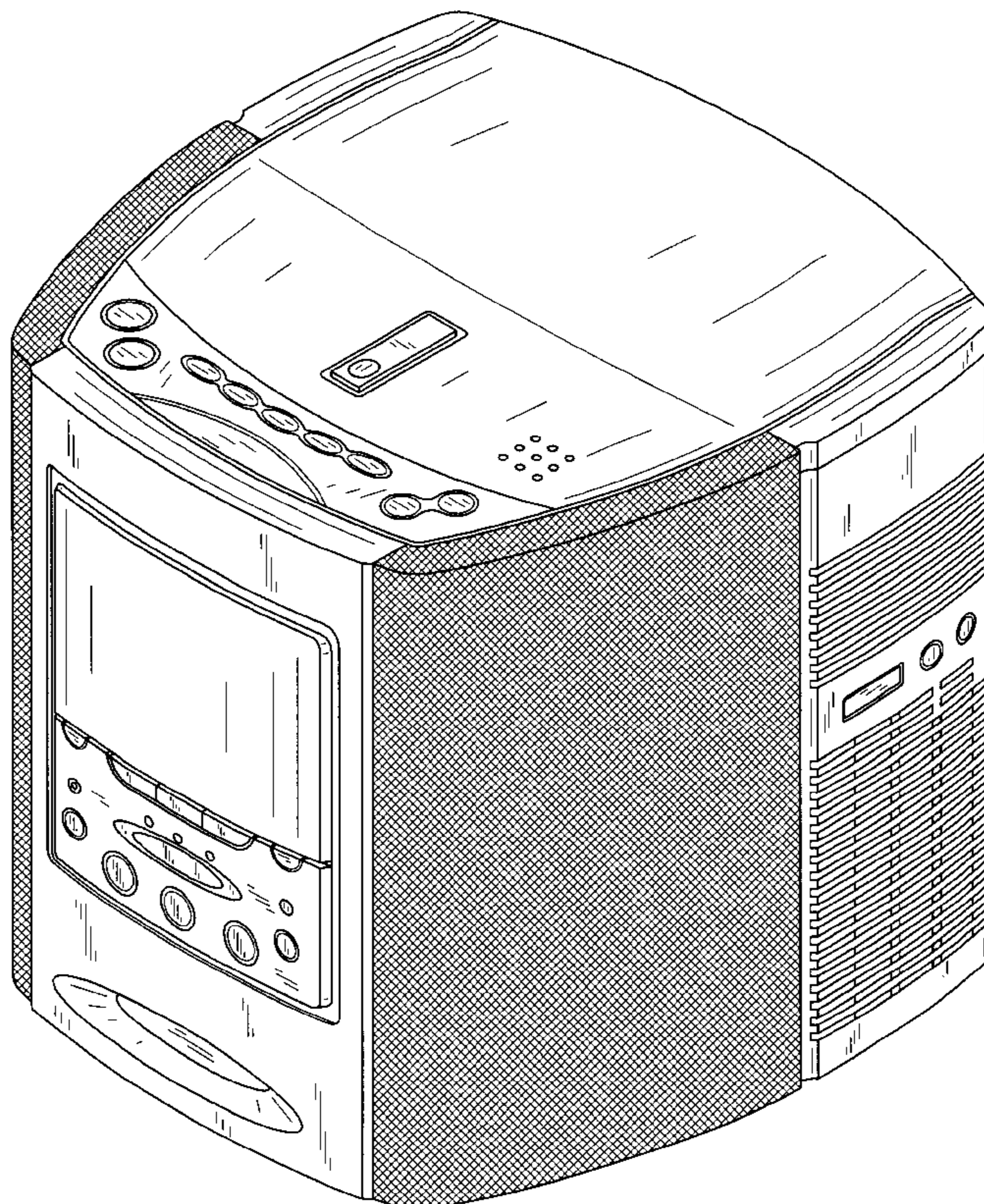

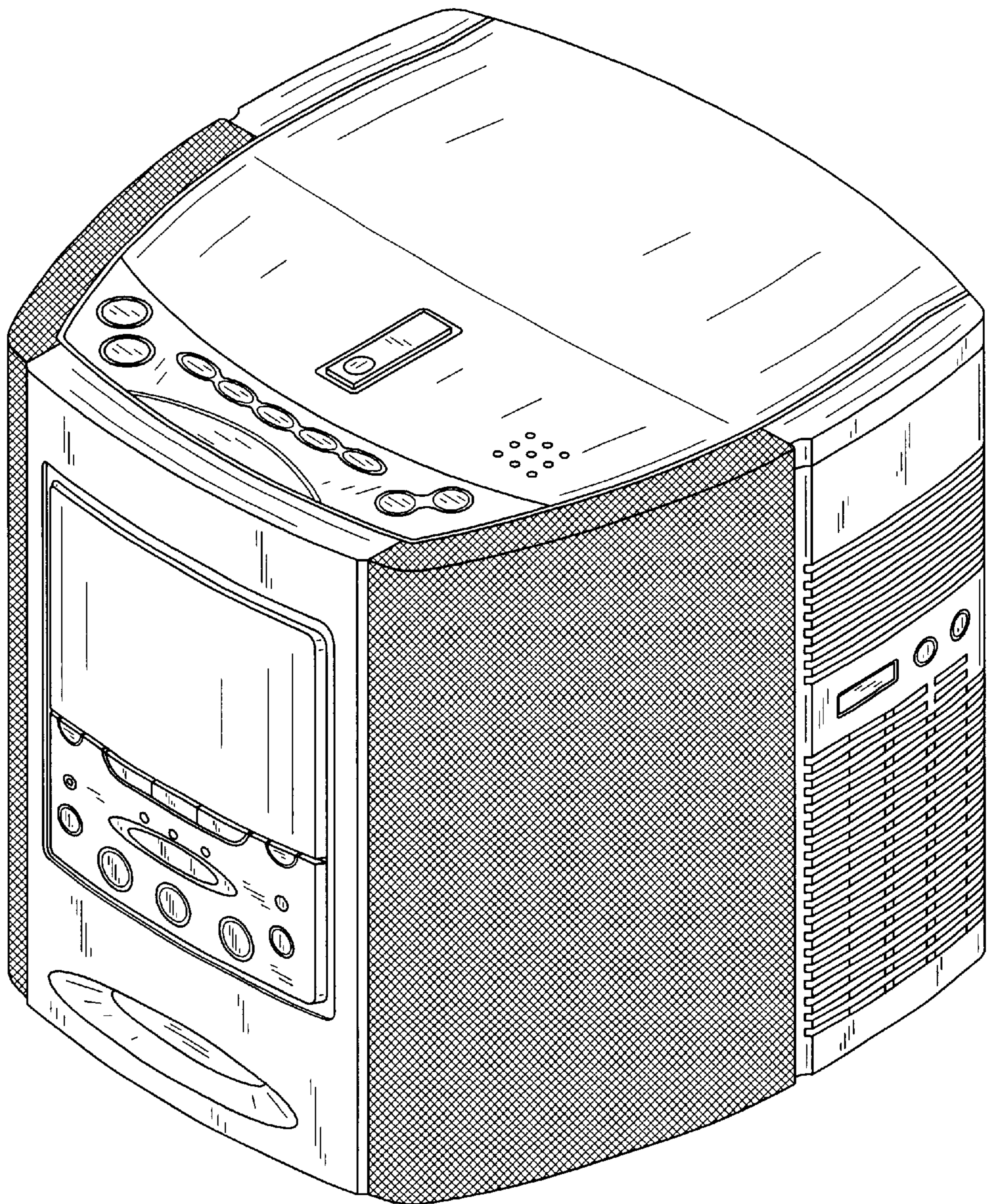

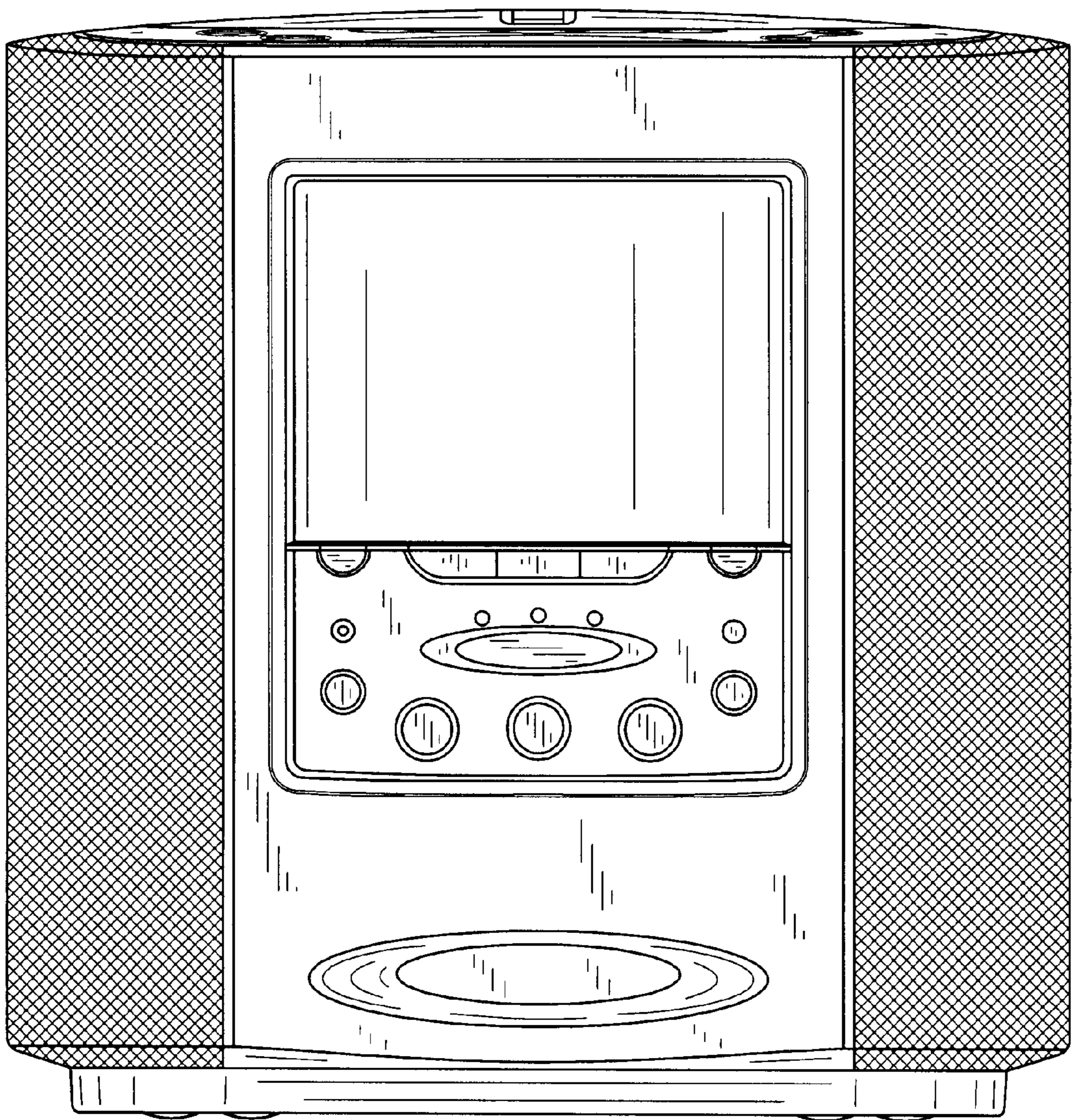

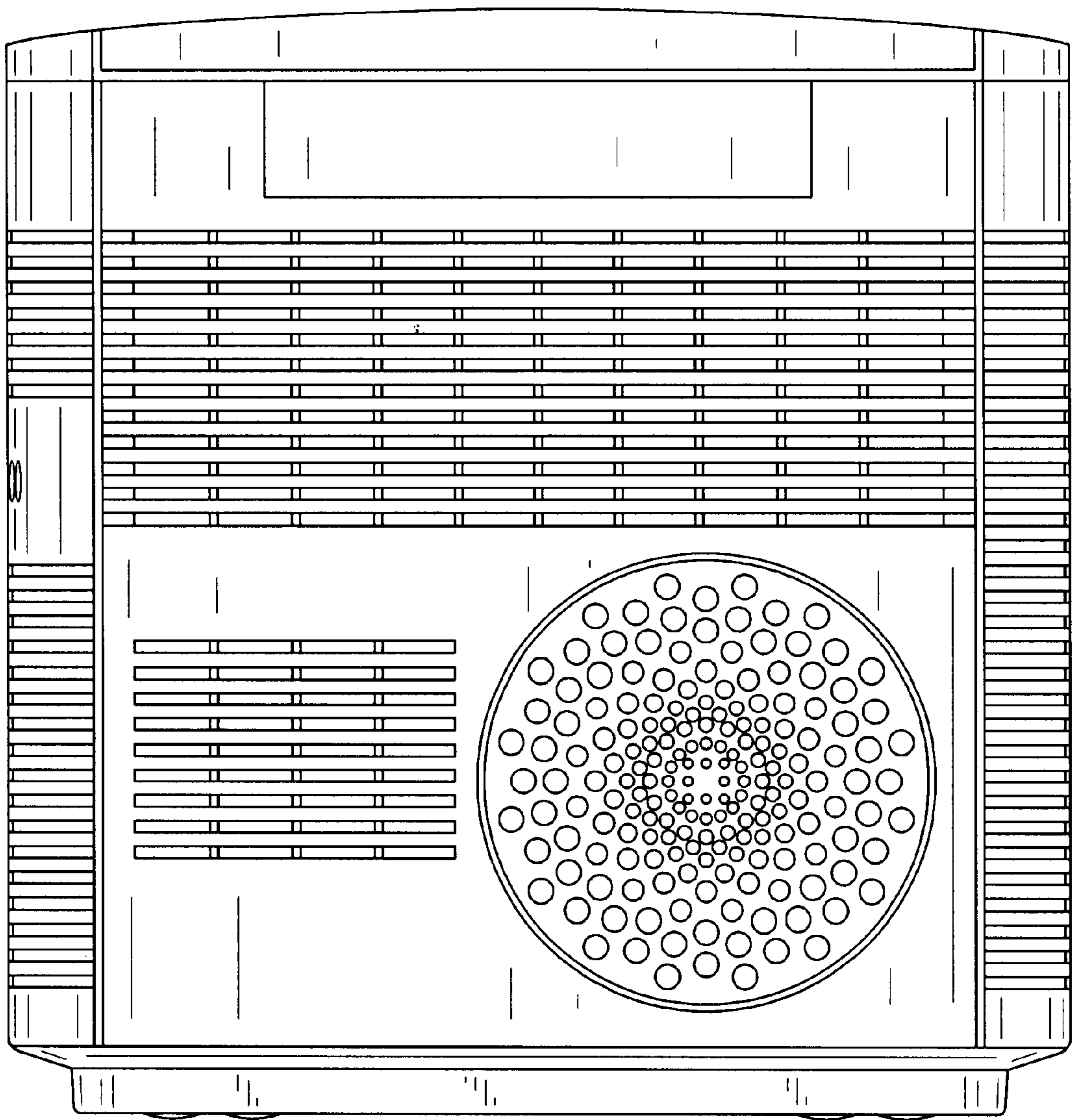

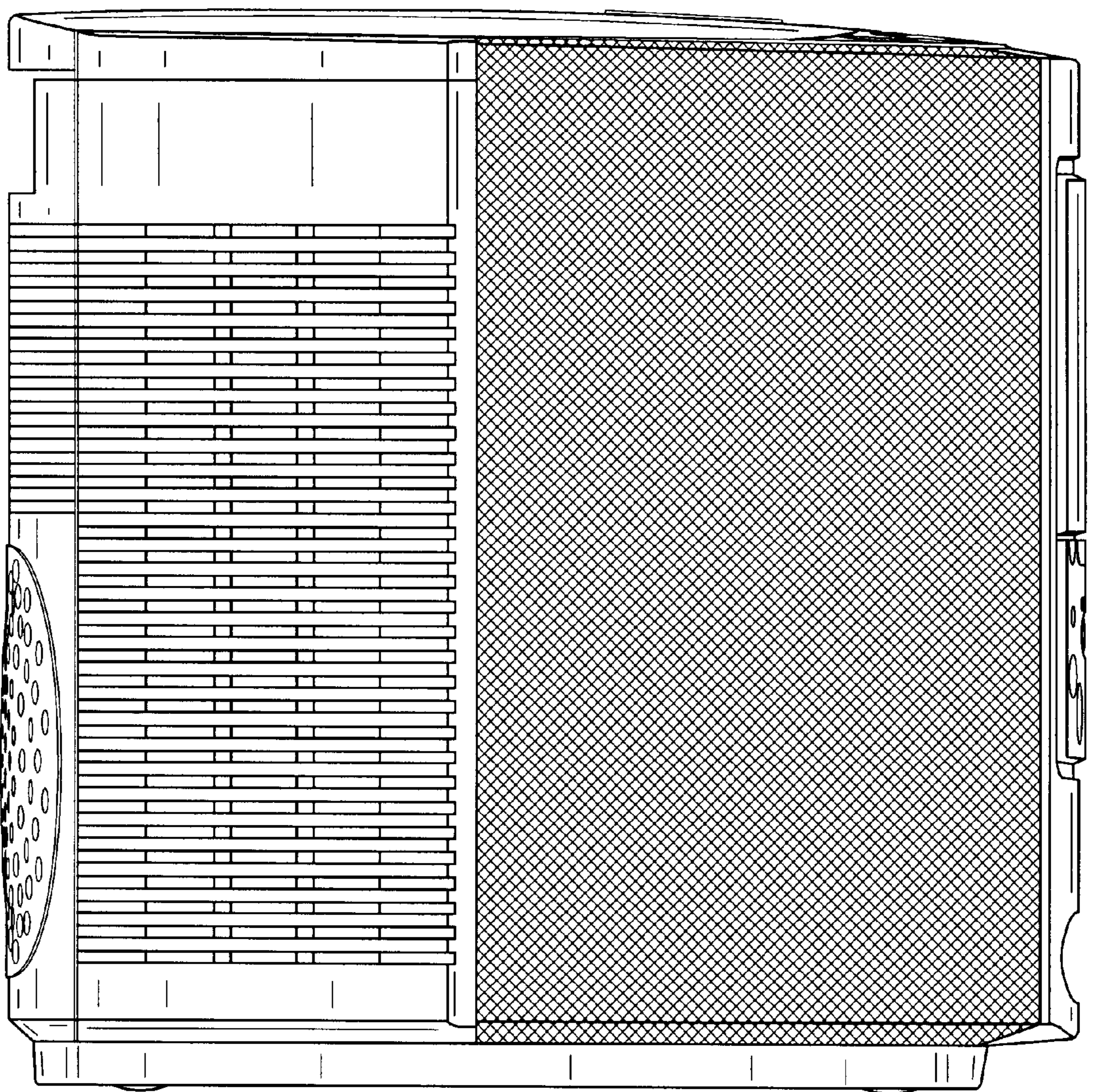

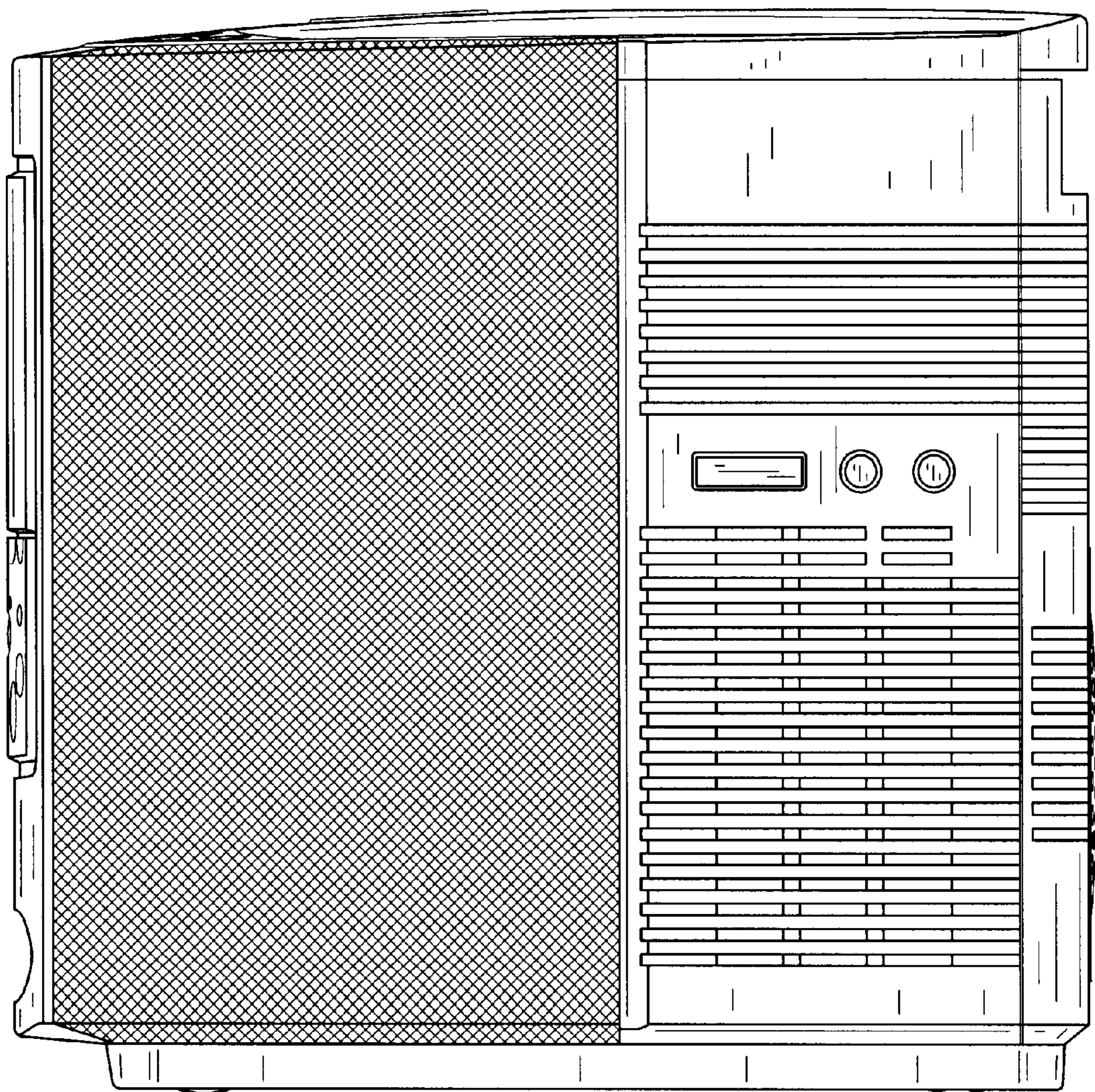

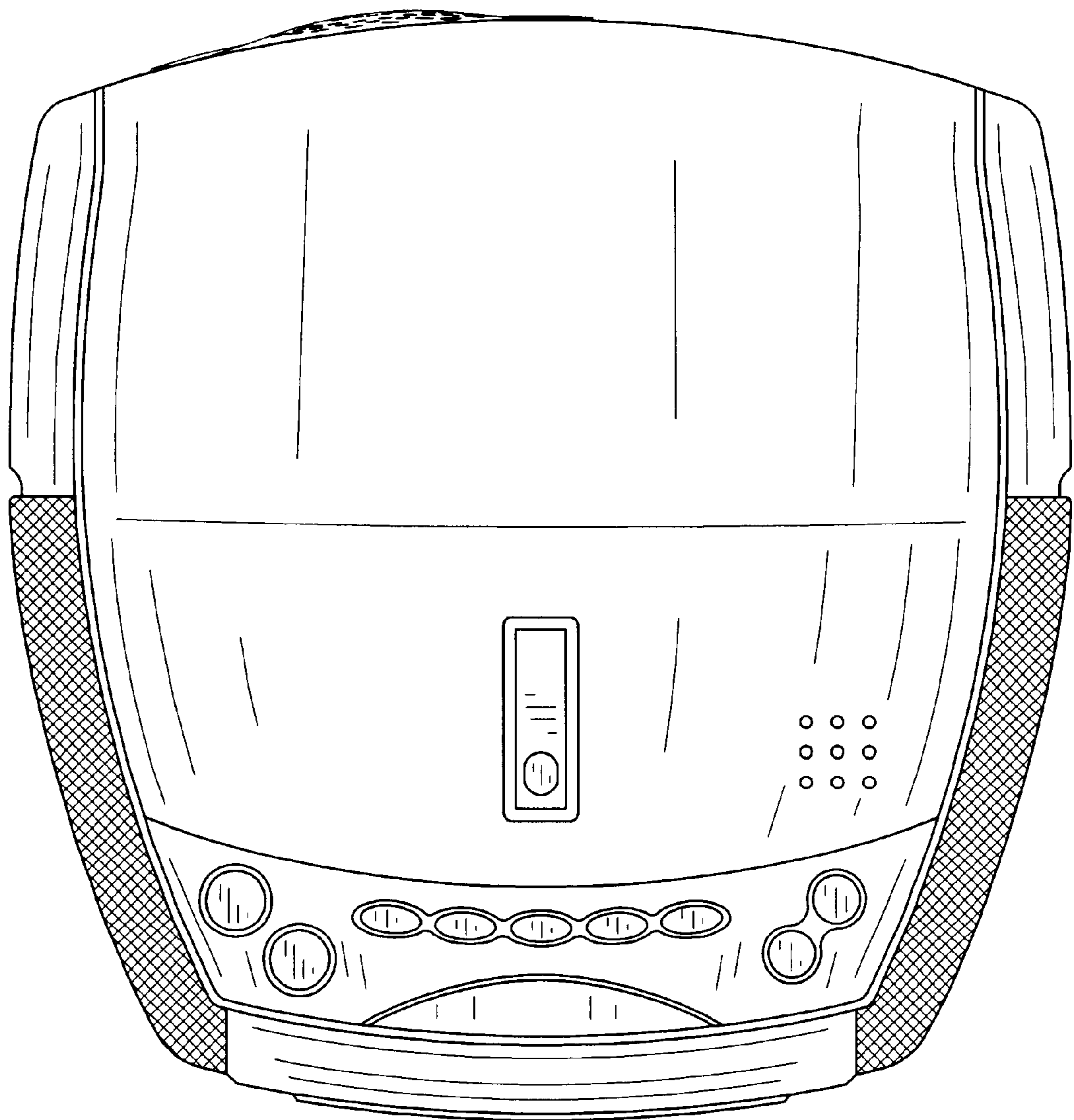
