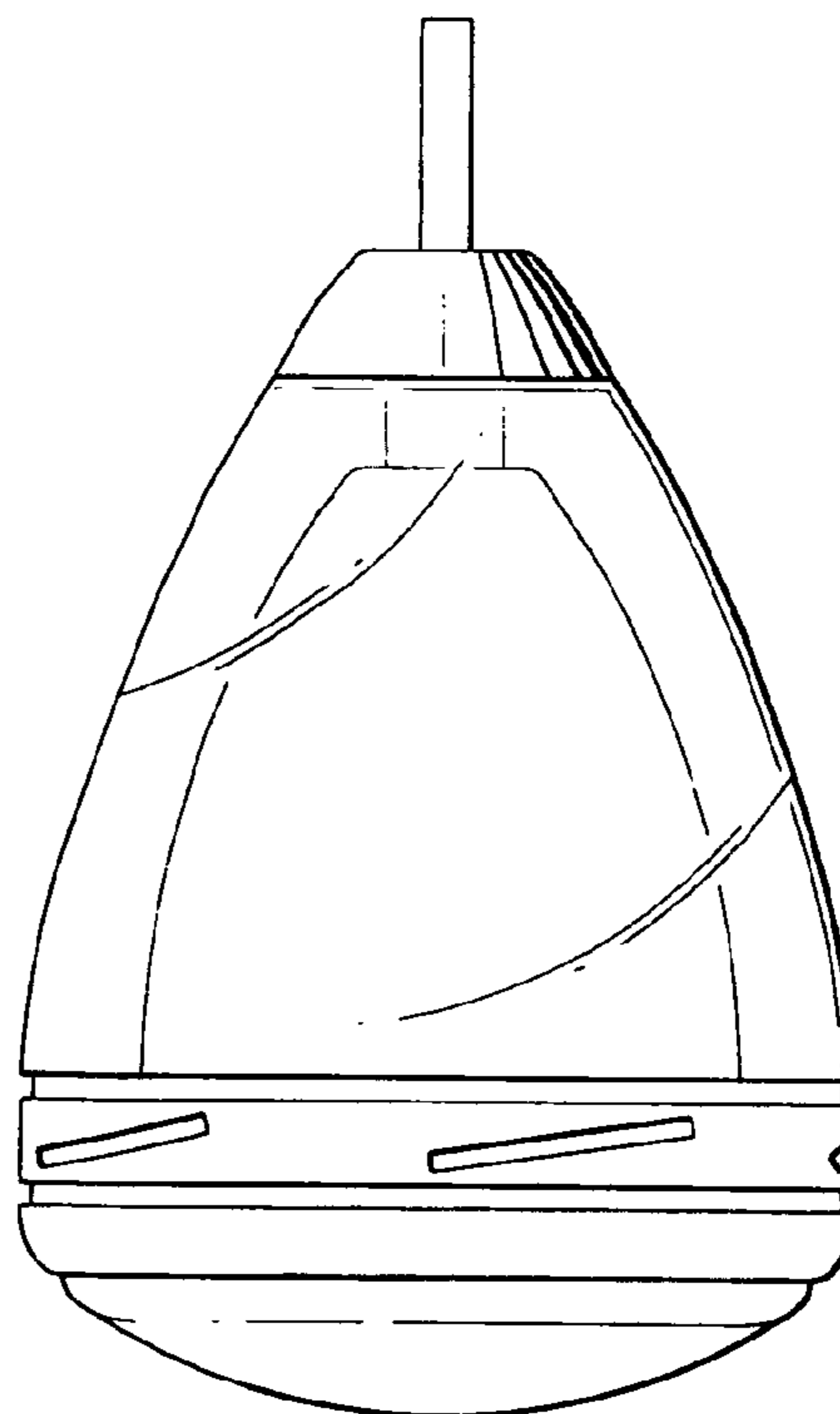
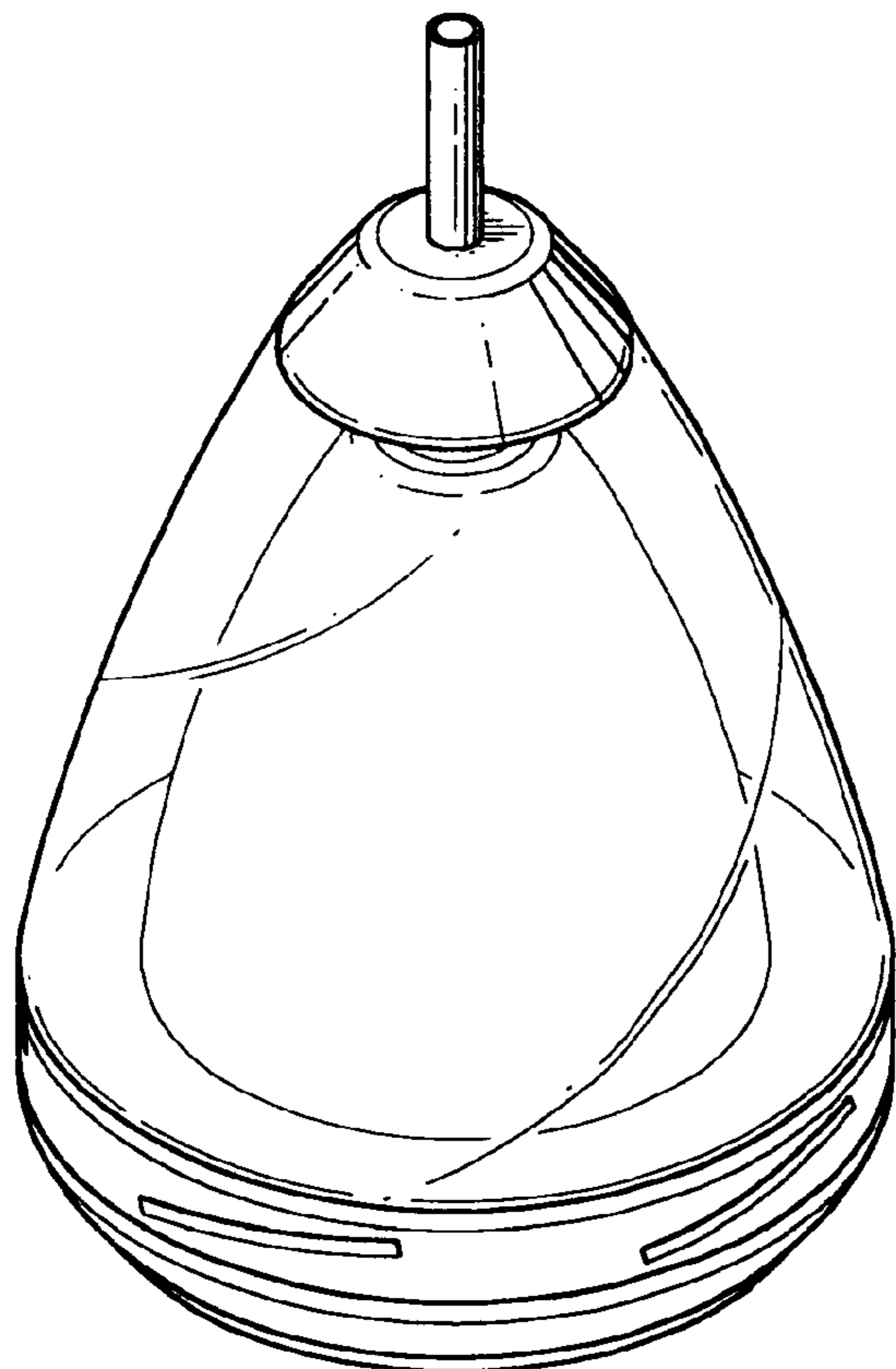
FIG. 8 is a perspective view on a reduced scale body of ceiling fan, the broken lines shown are for illustrative purposes only and form no part of the claimed design; and,

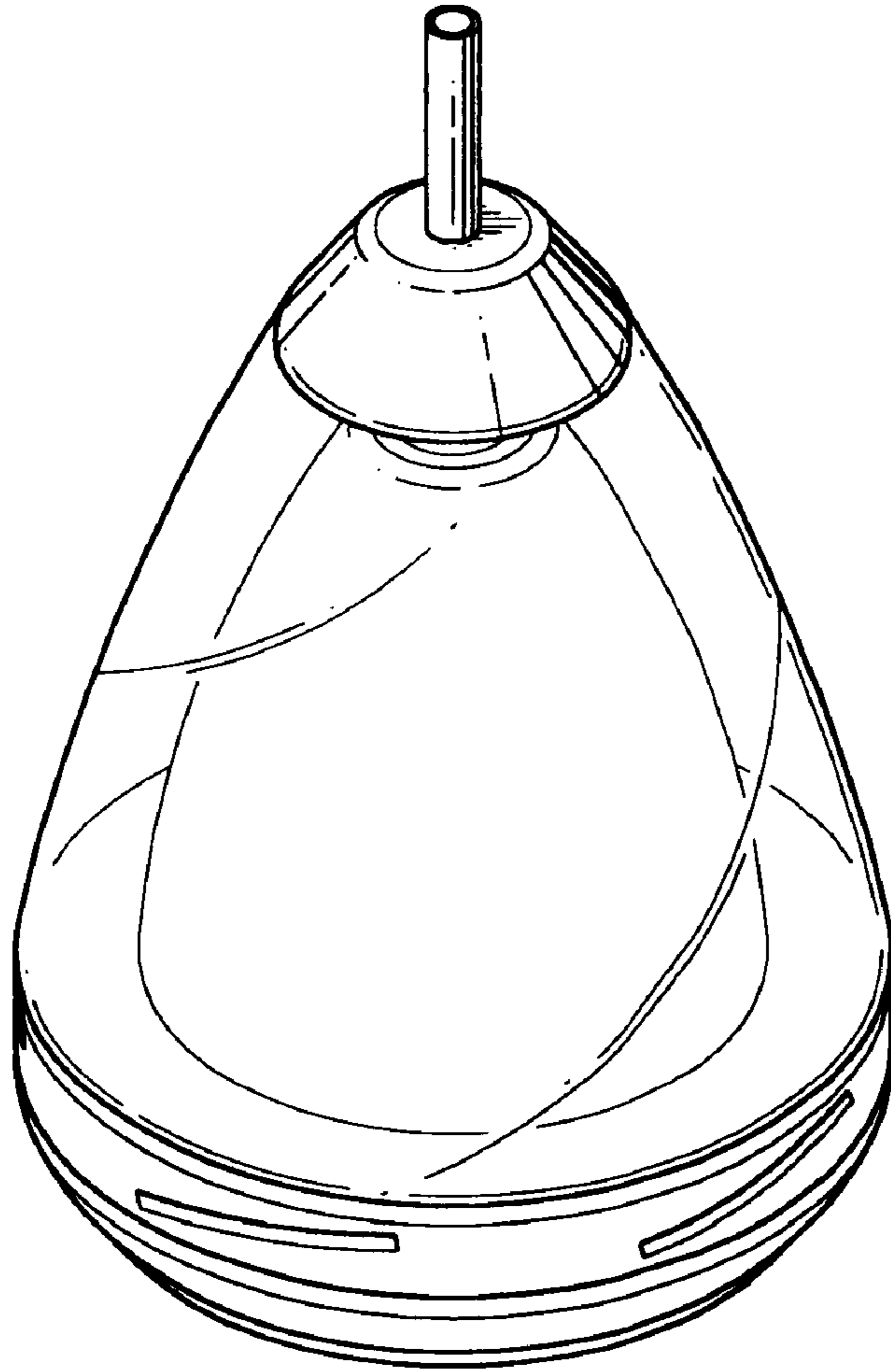

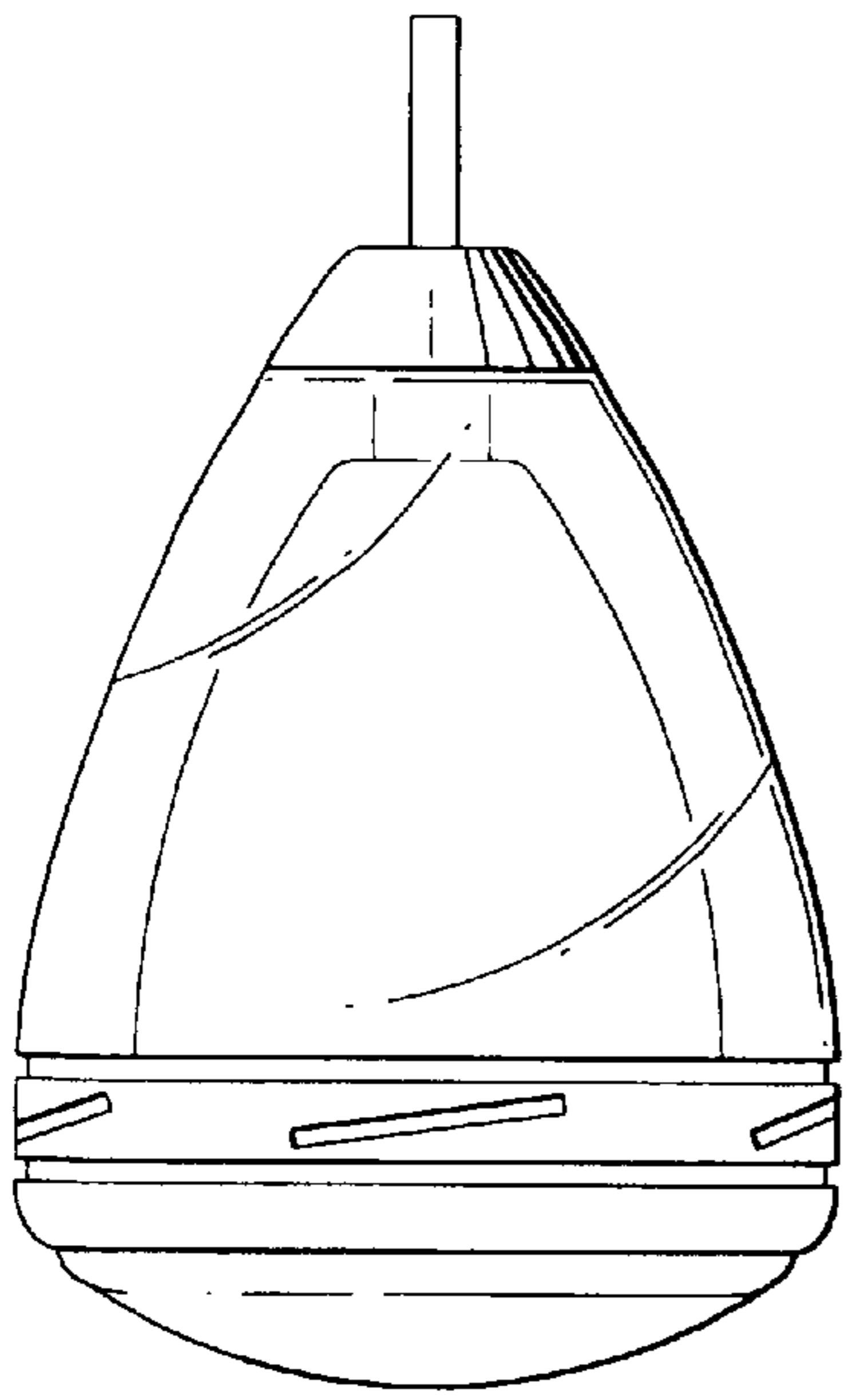

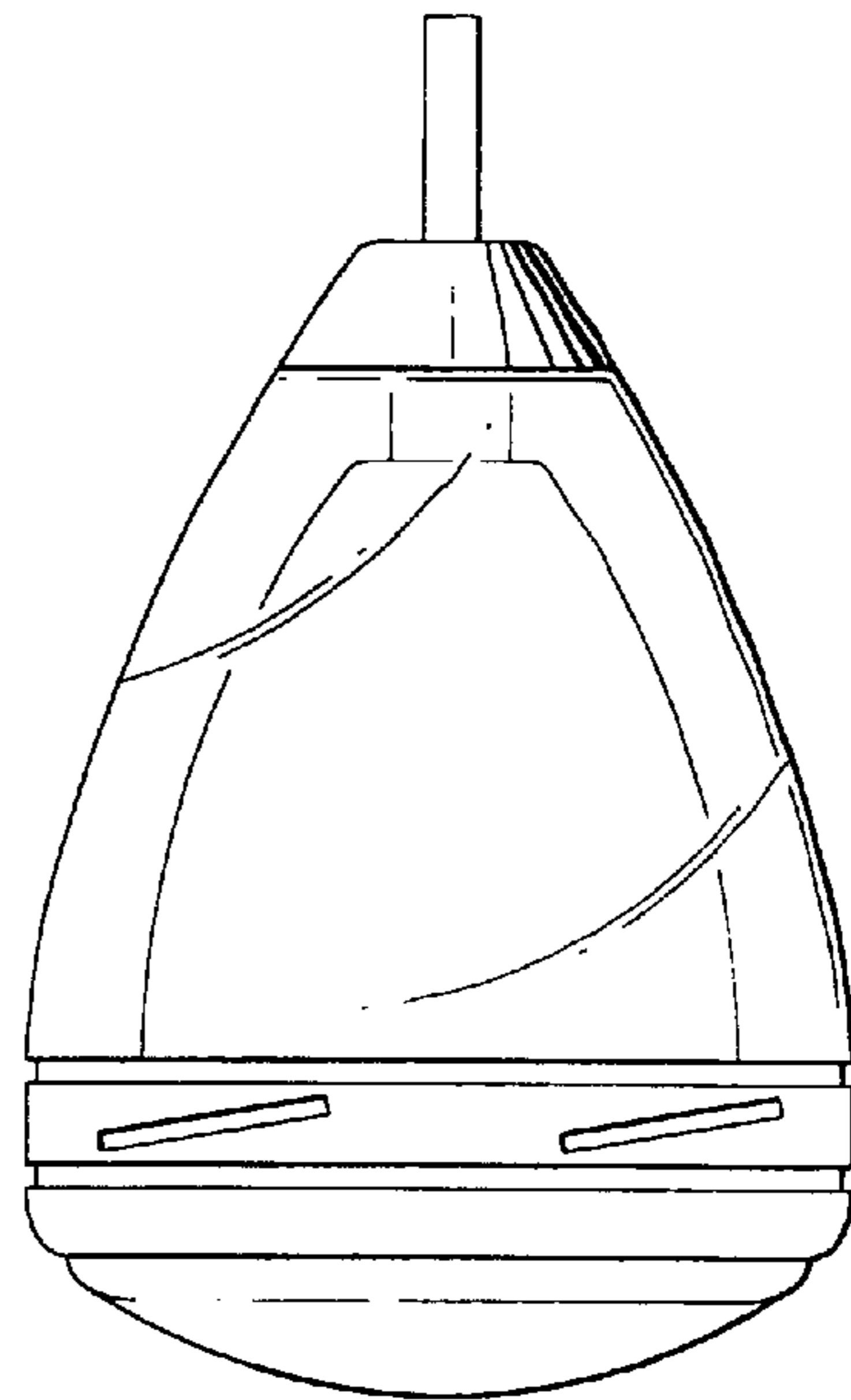

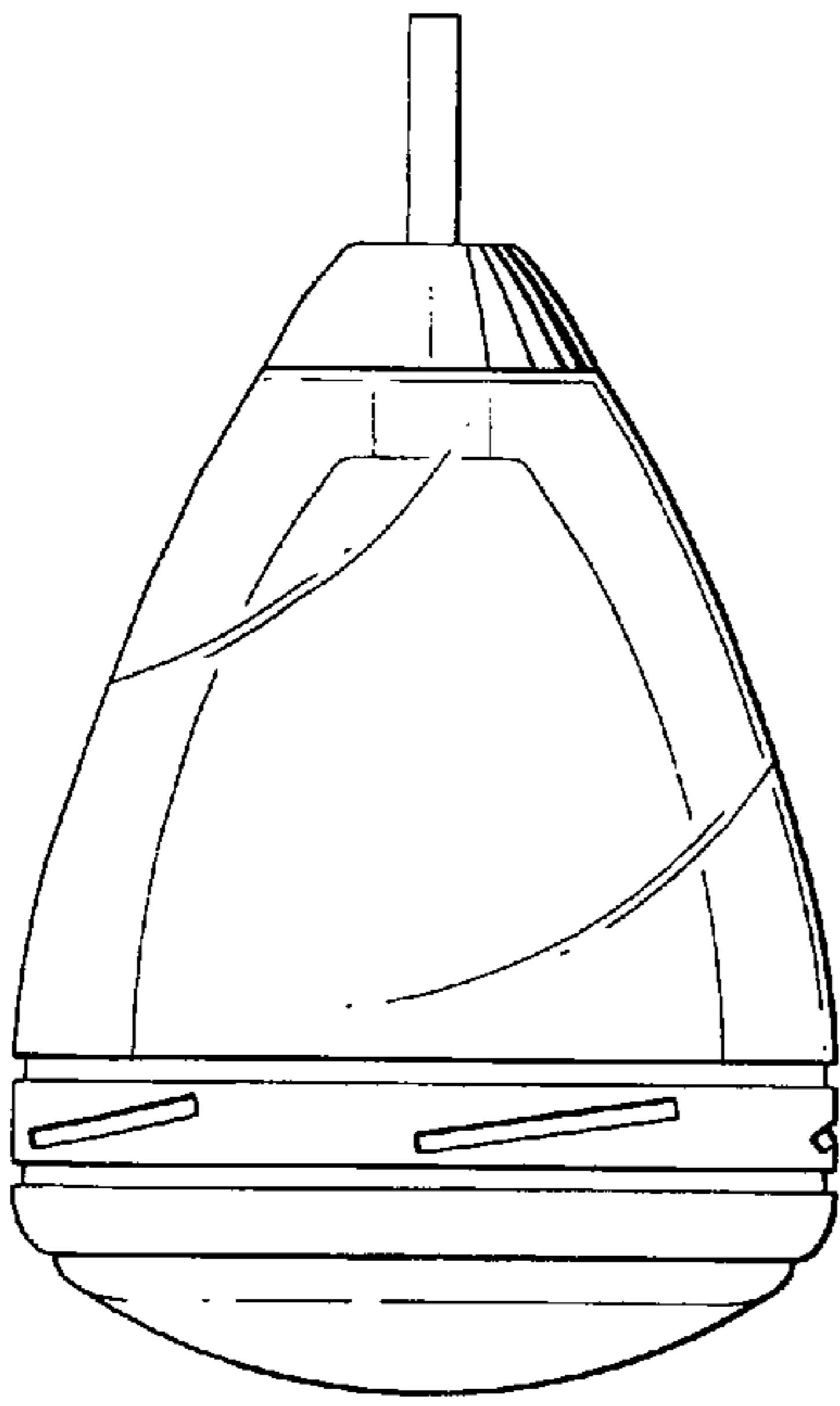

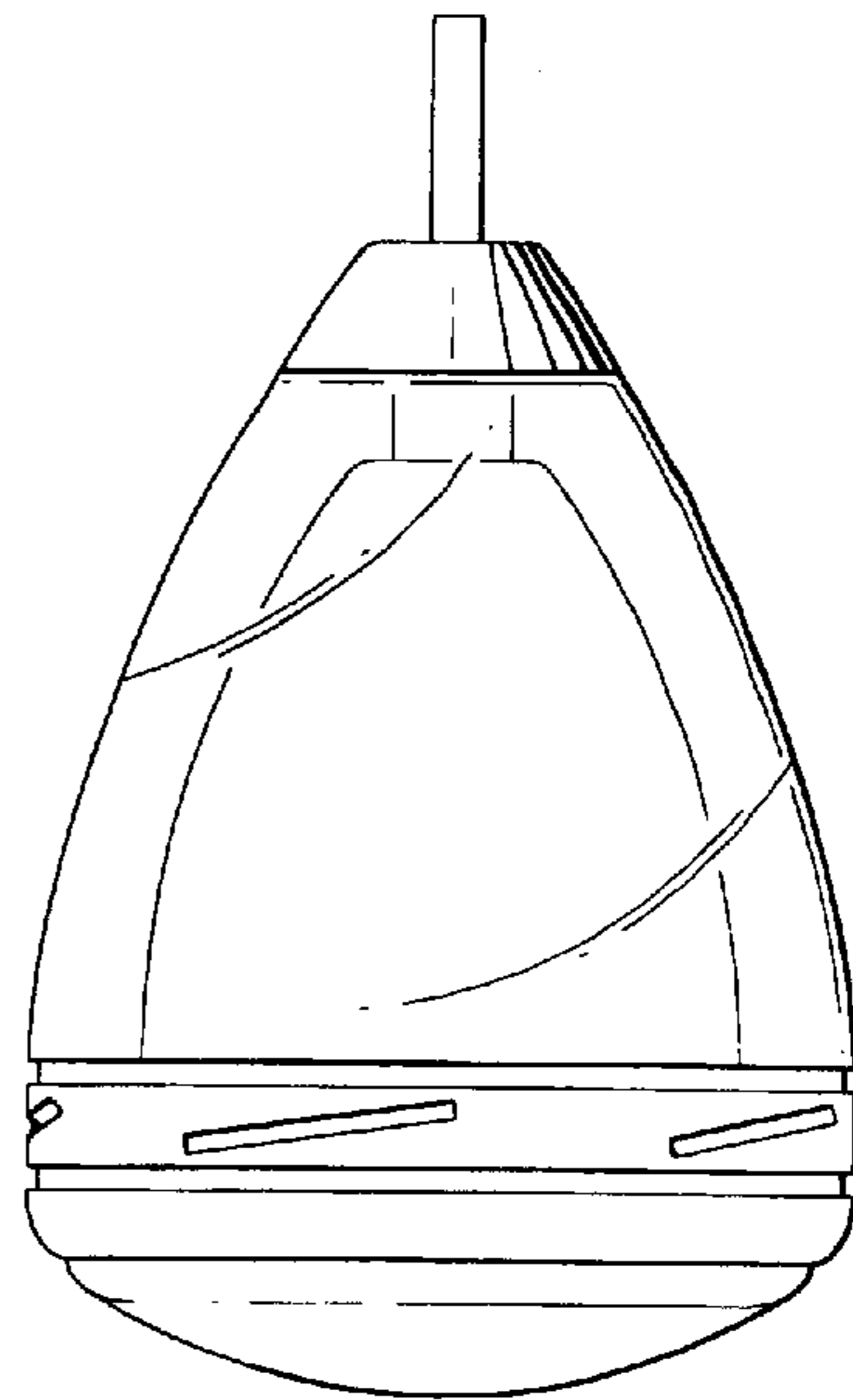

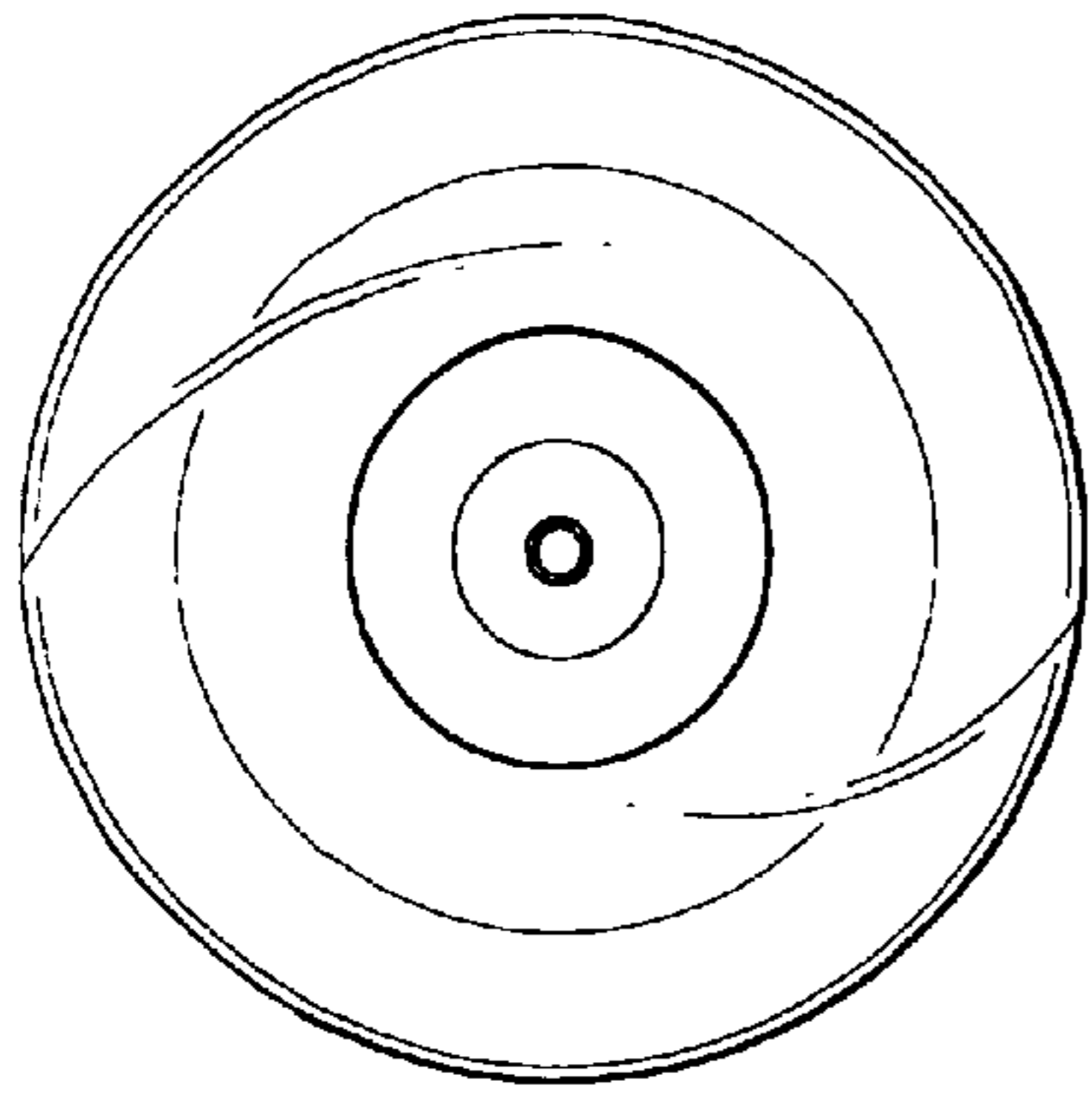

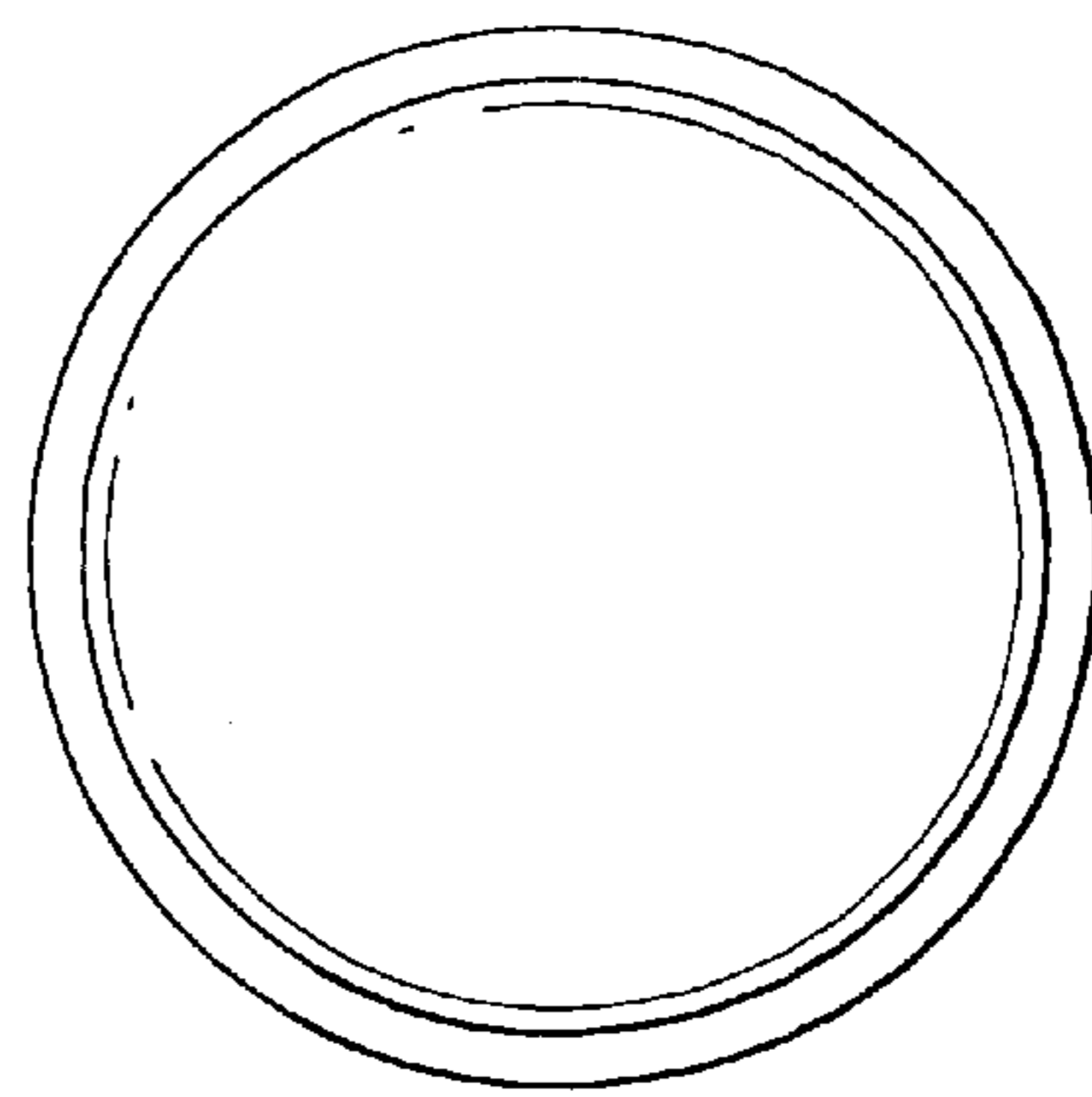
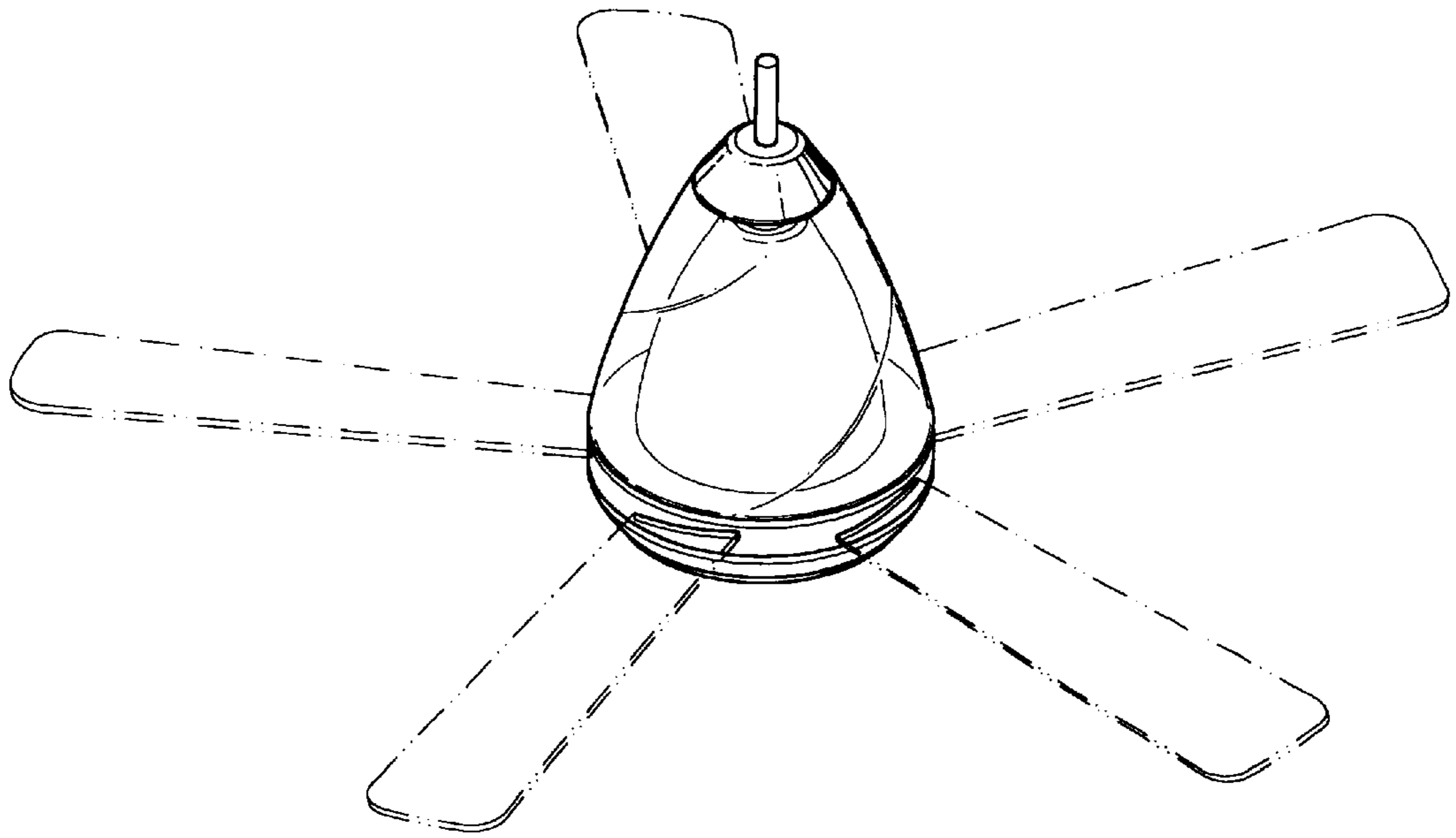

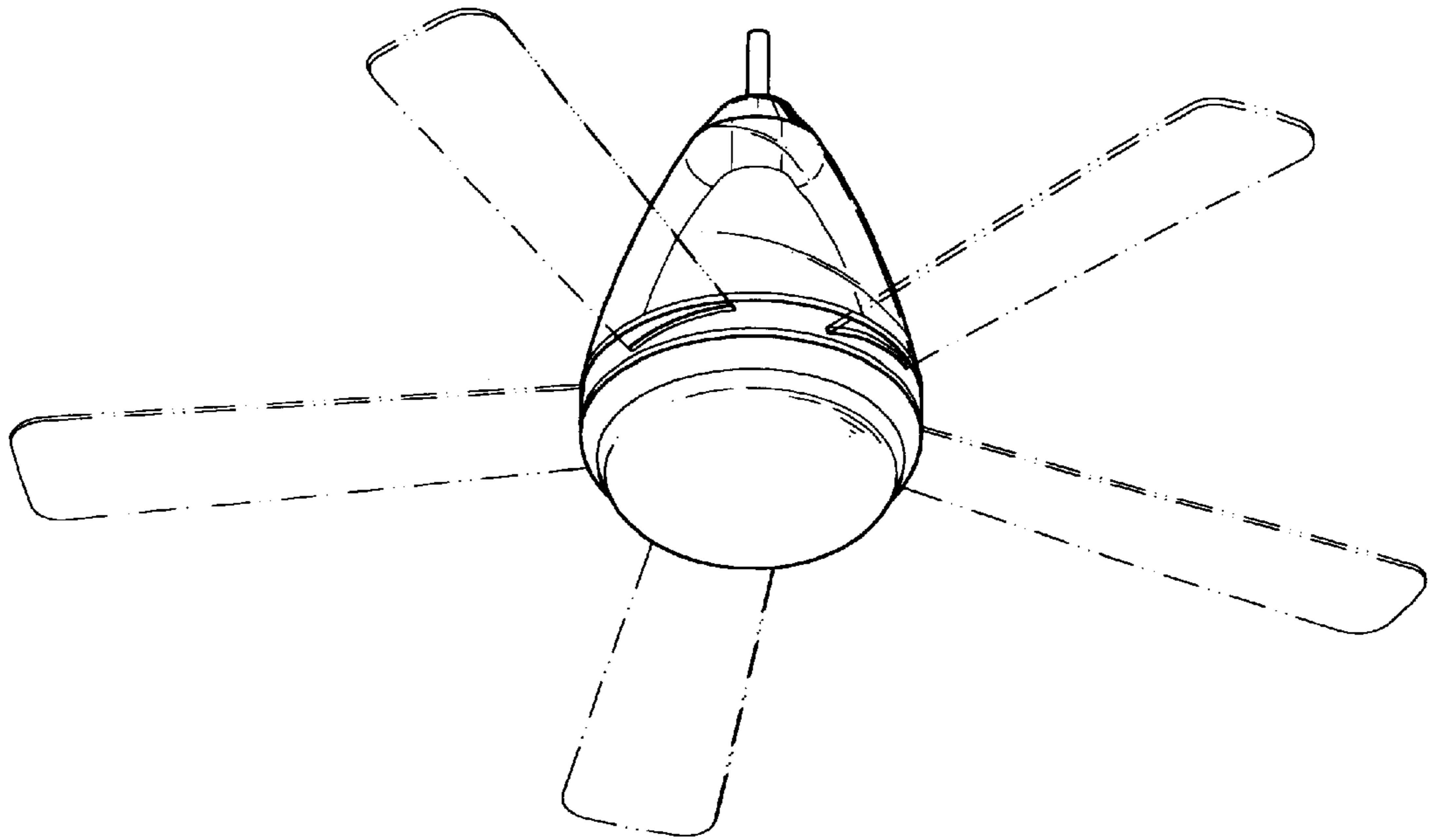
