FIG. 5 is front view of the FIG. 1 embodiment;

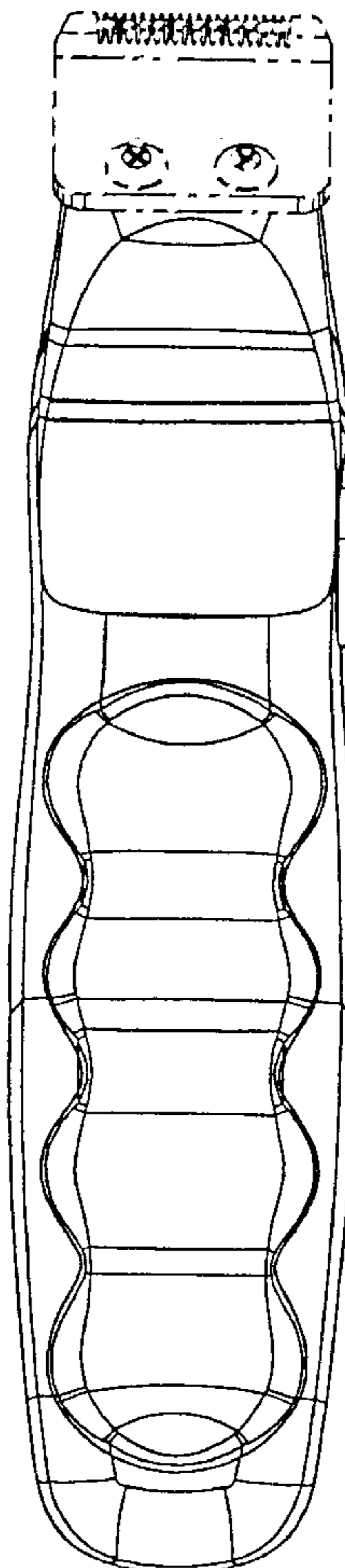
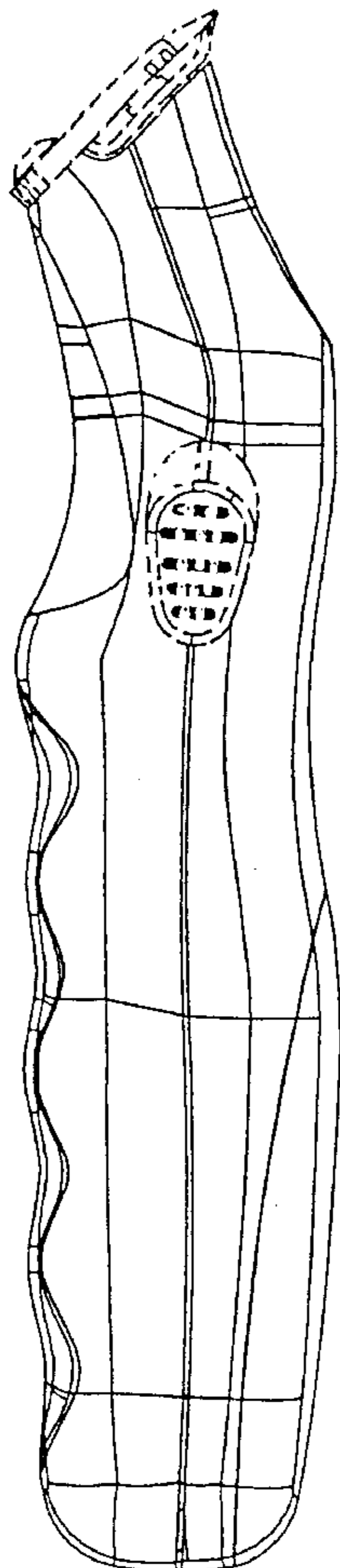
FIG. 6 is a top view of the FIG. 1 embodiment;

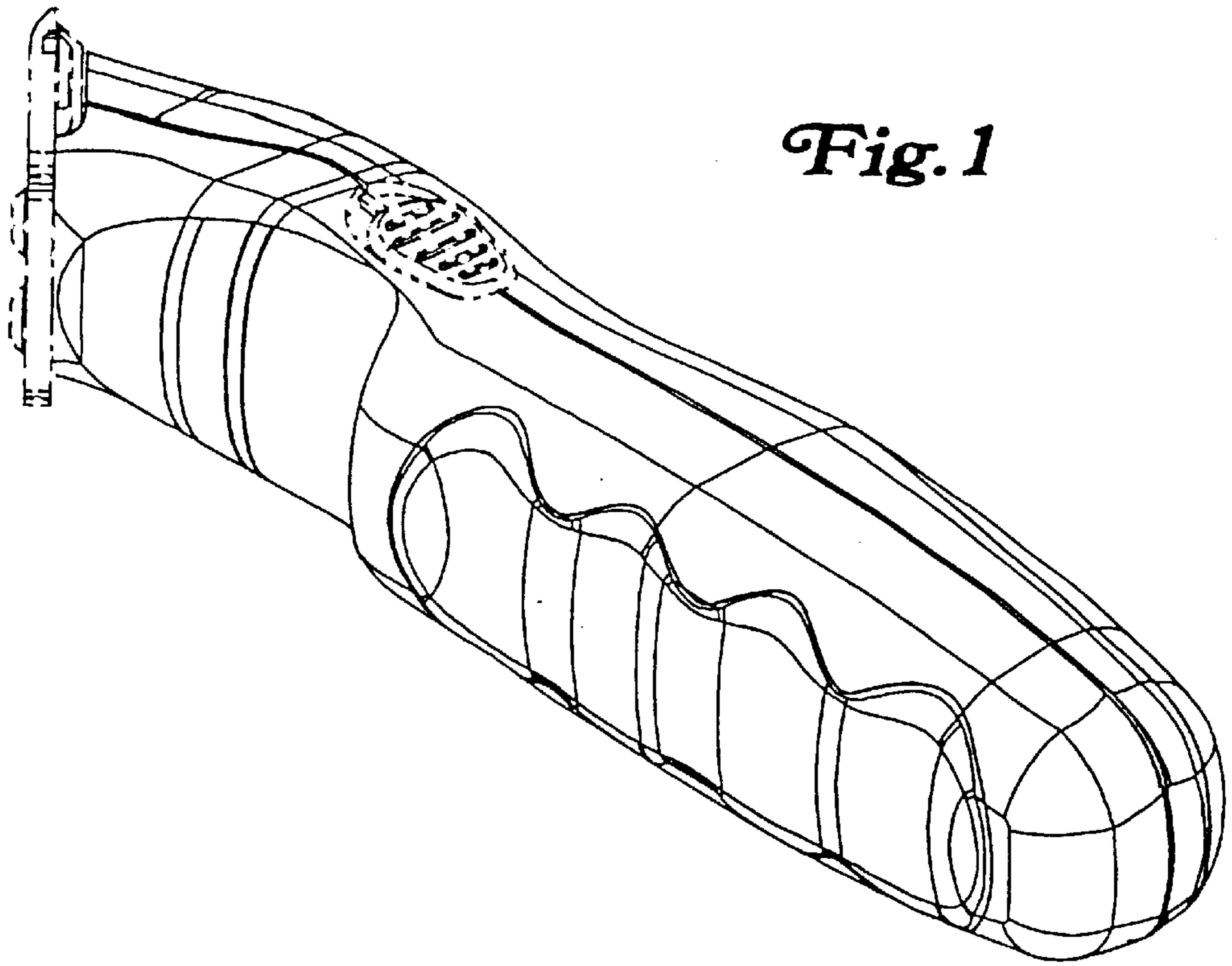
FIG. 7 is a bottom view of the FIG. 1 embodiment; and,

FIG. 8 is a right view of the FIG. 1 embodiment.

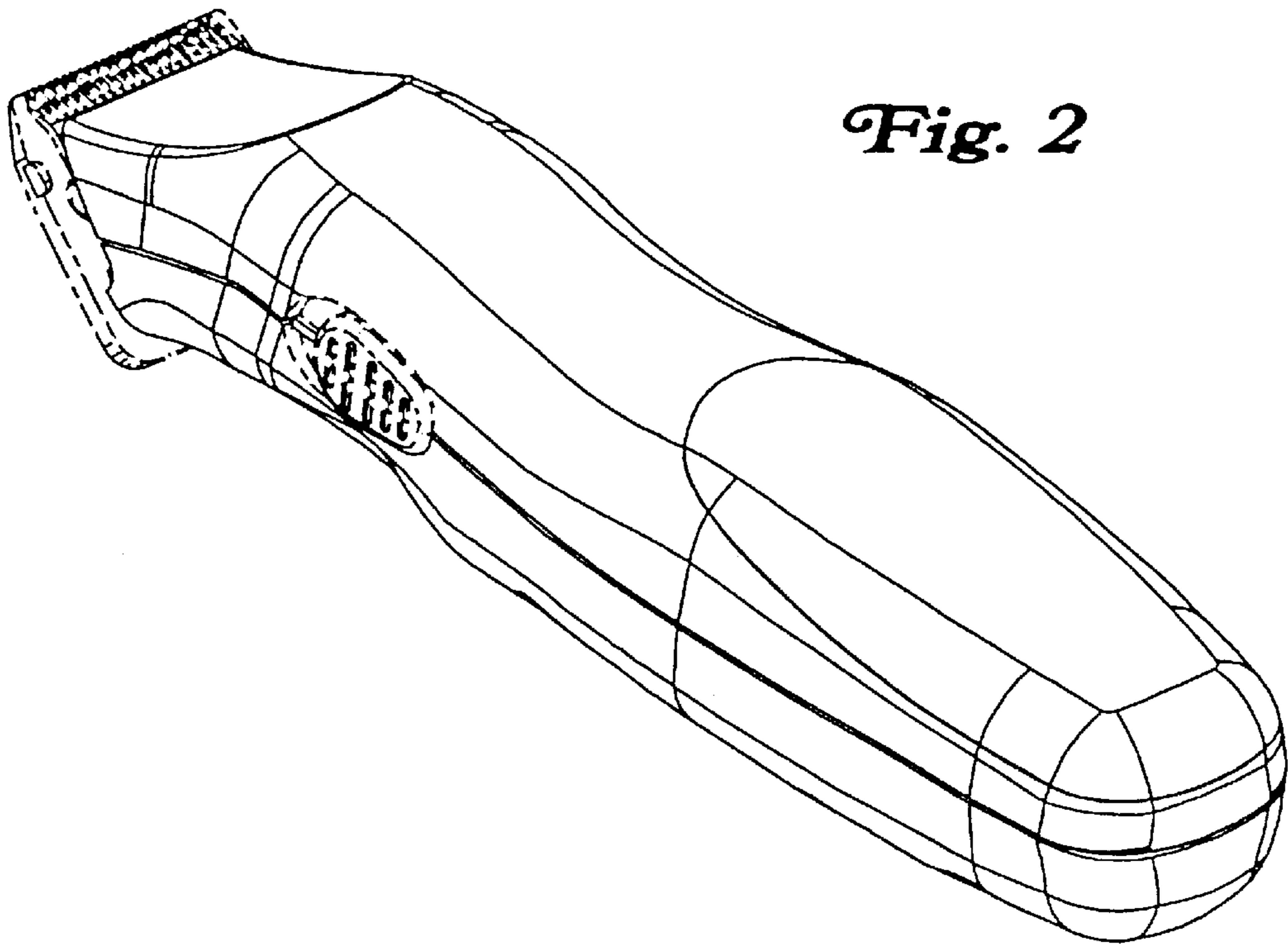

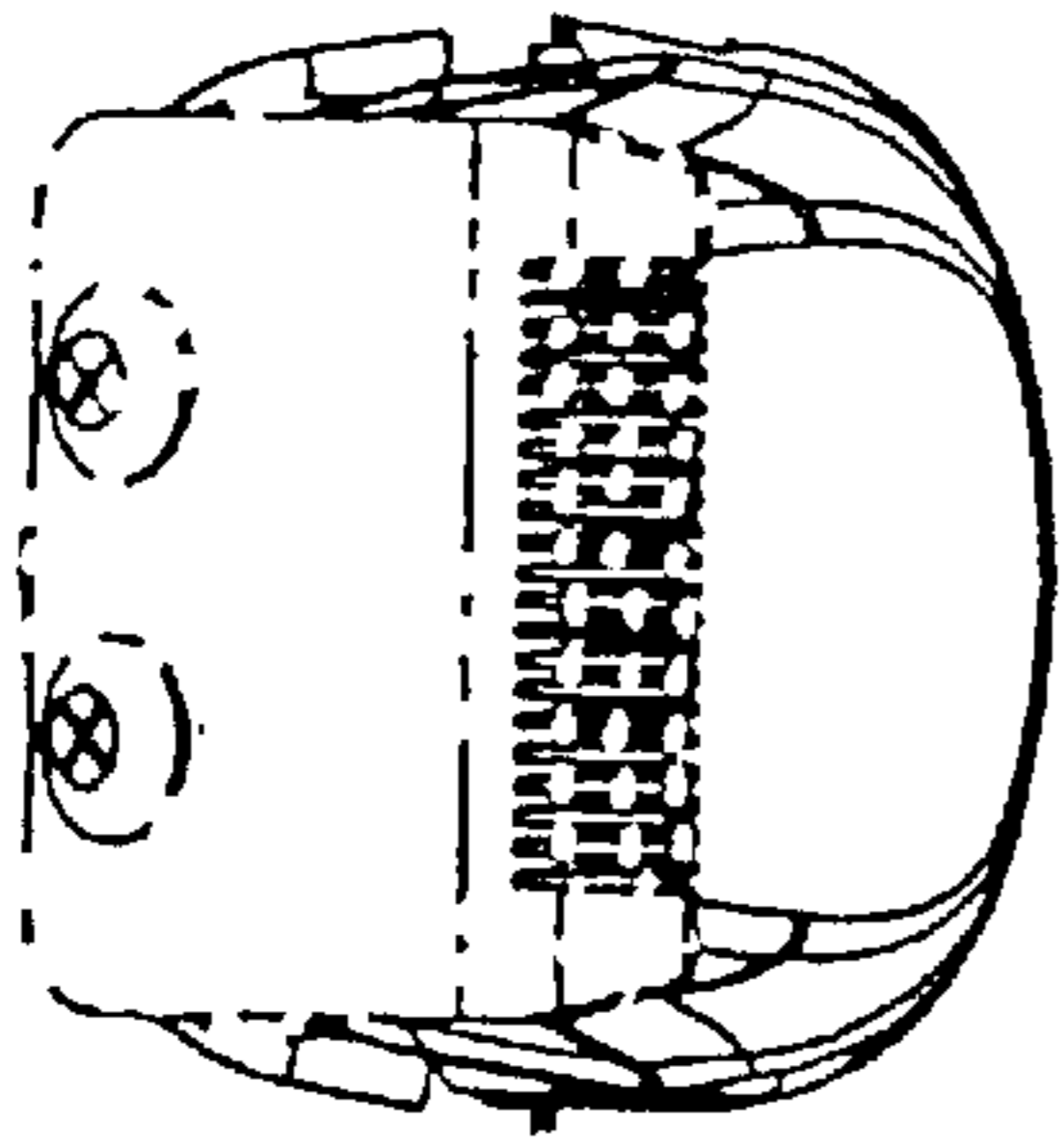




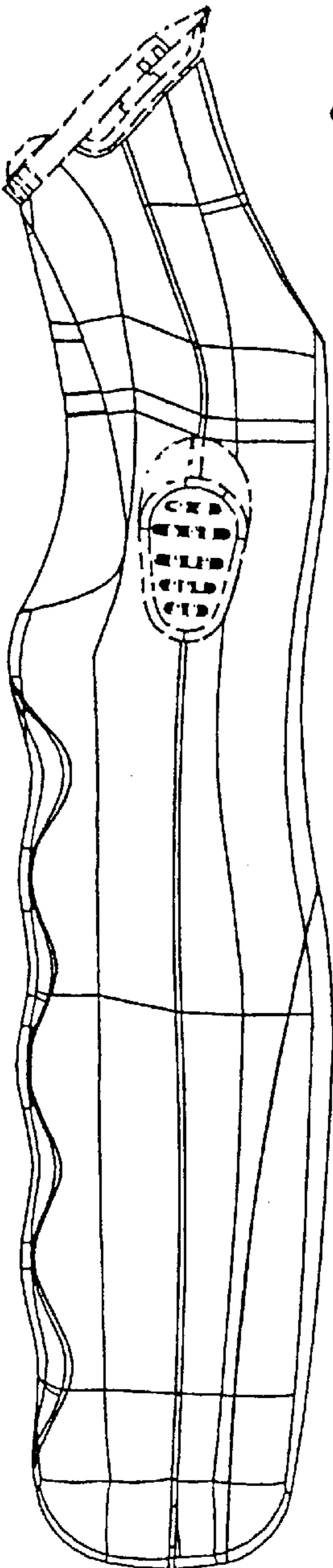

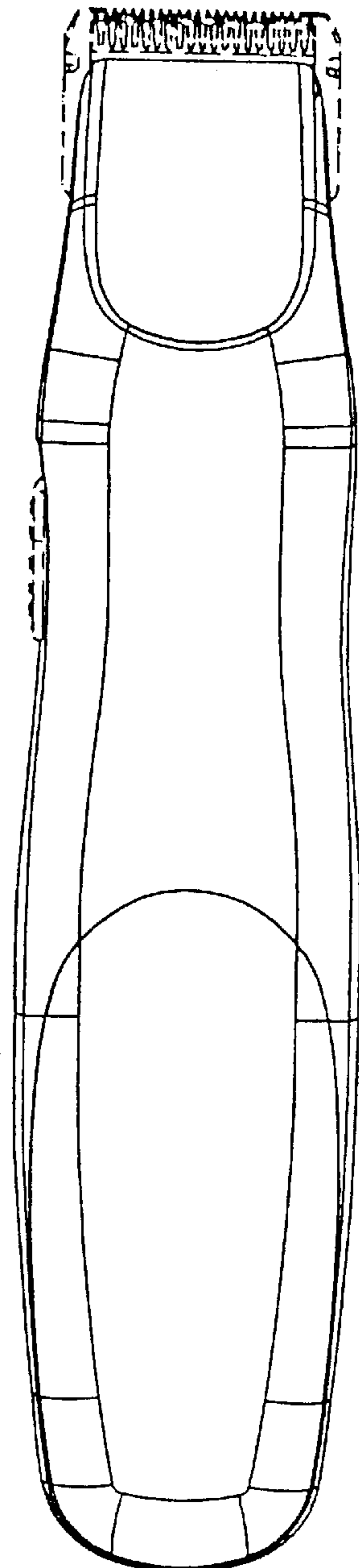


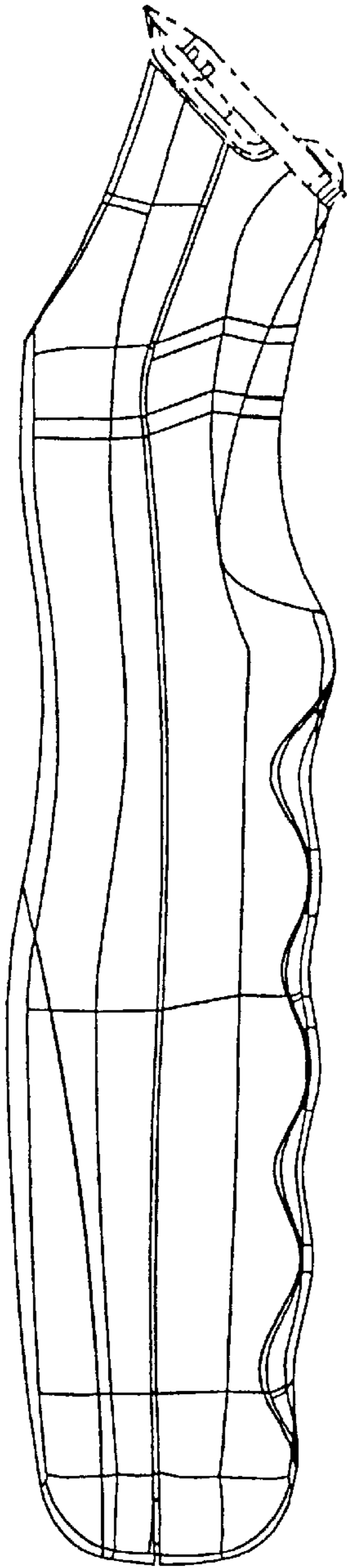

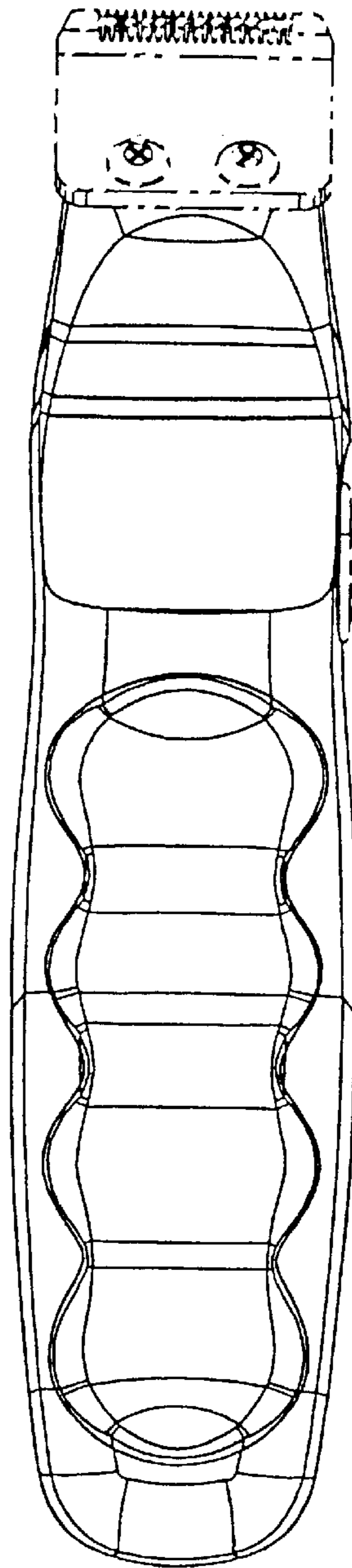

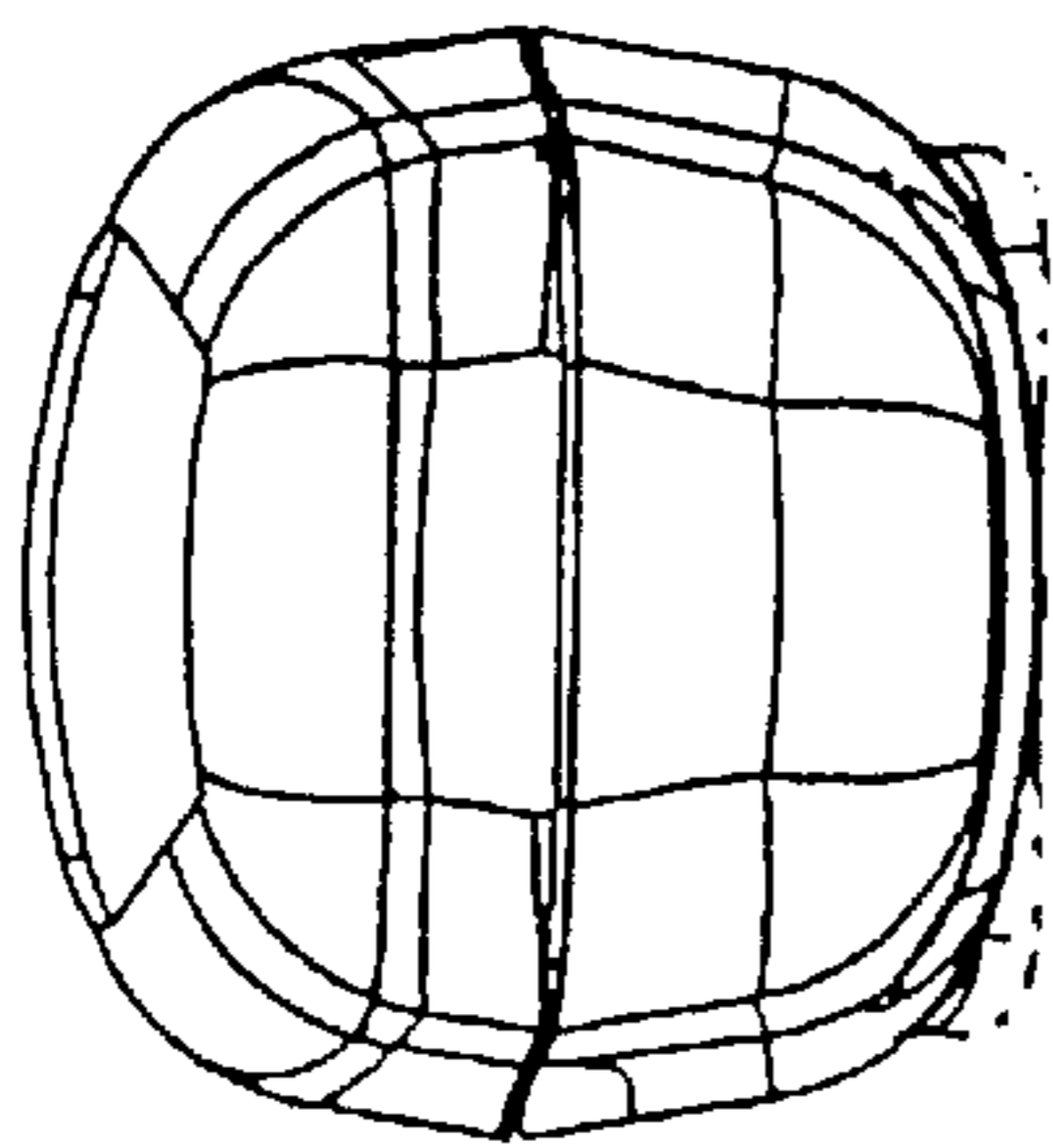
