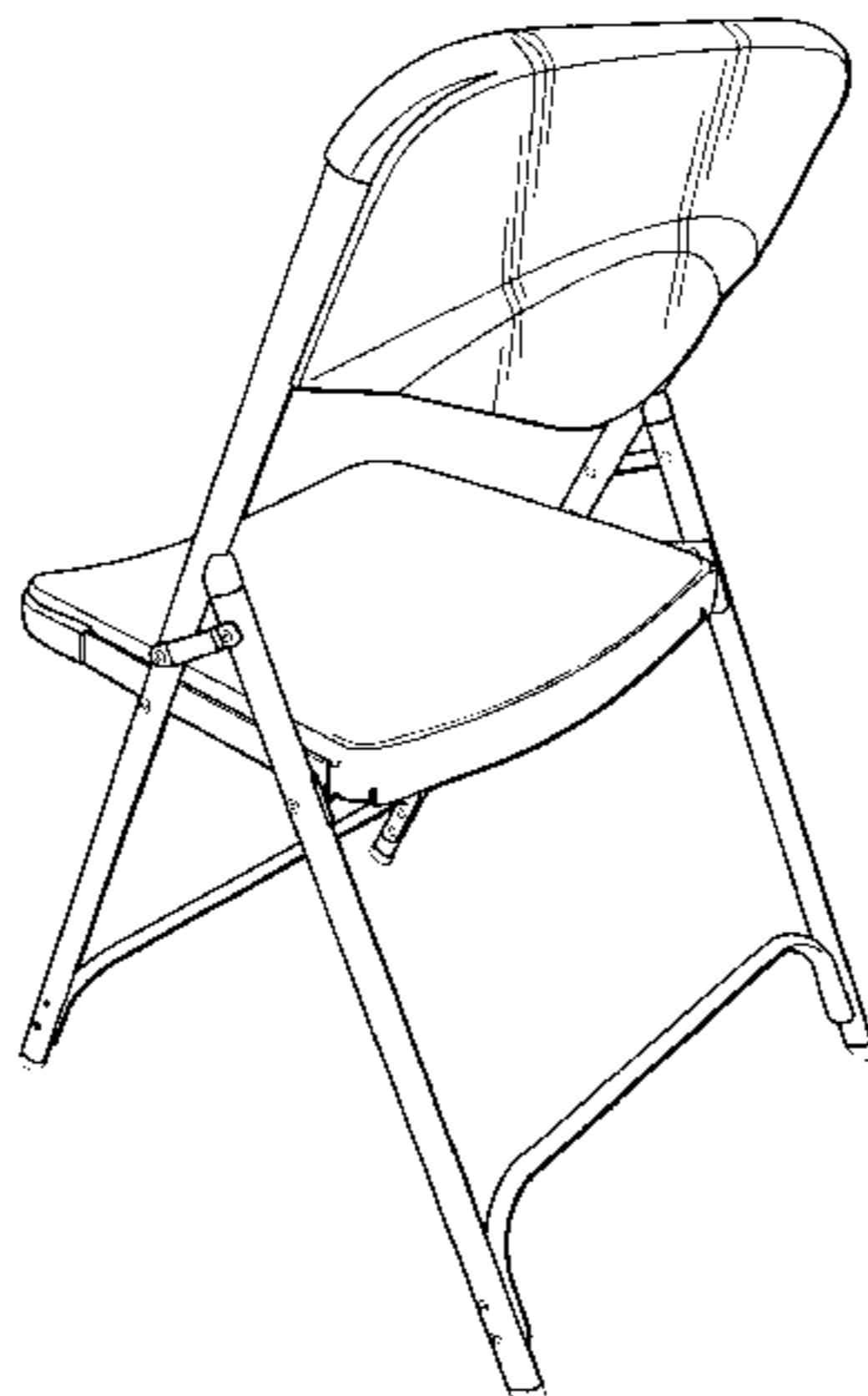
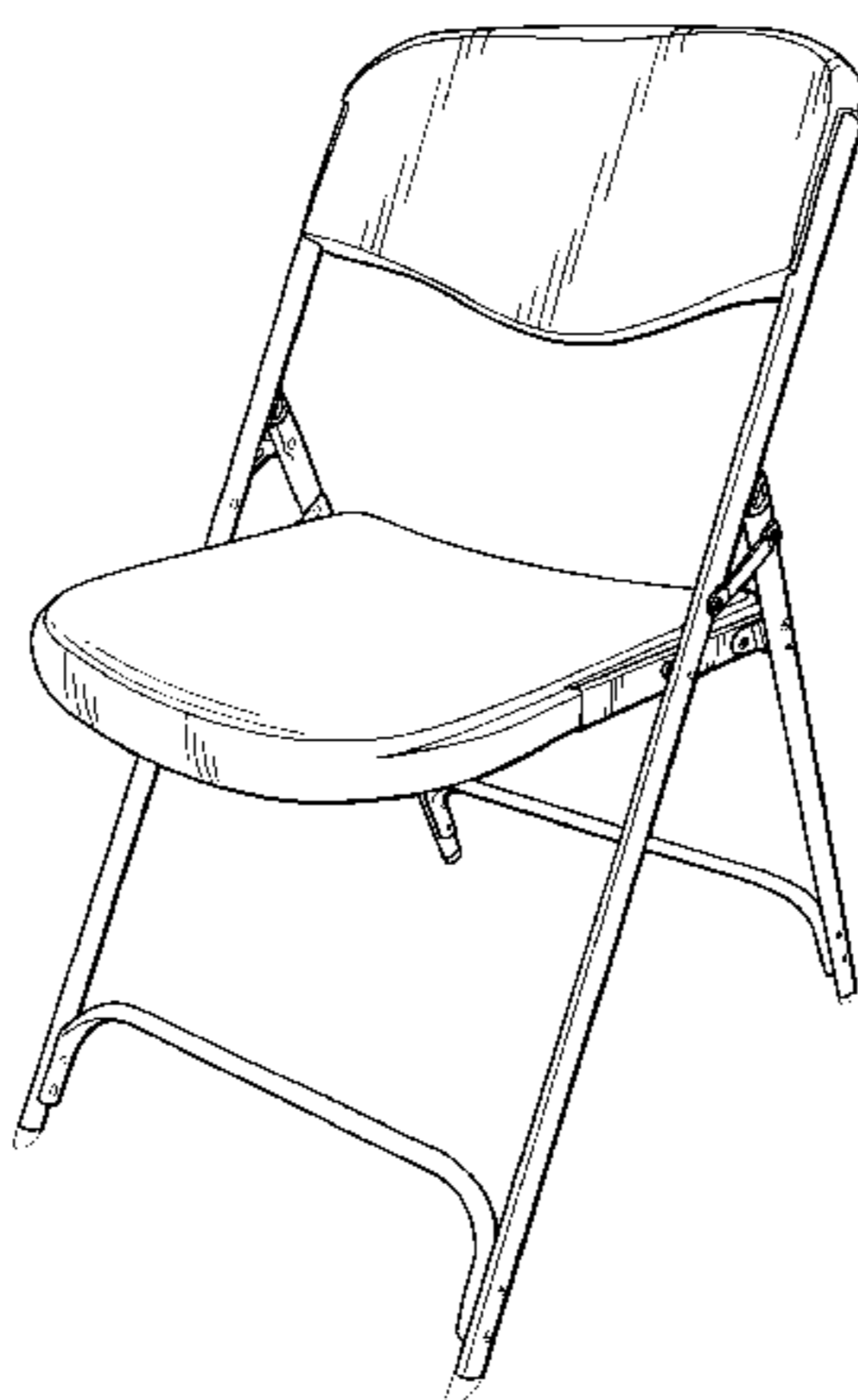

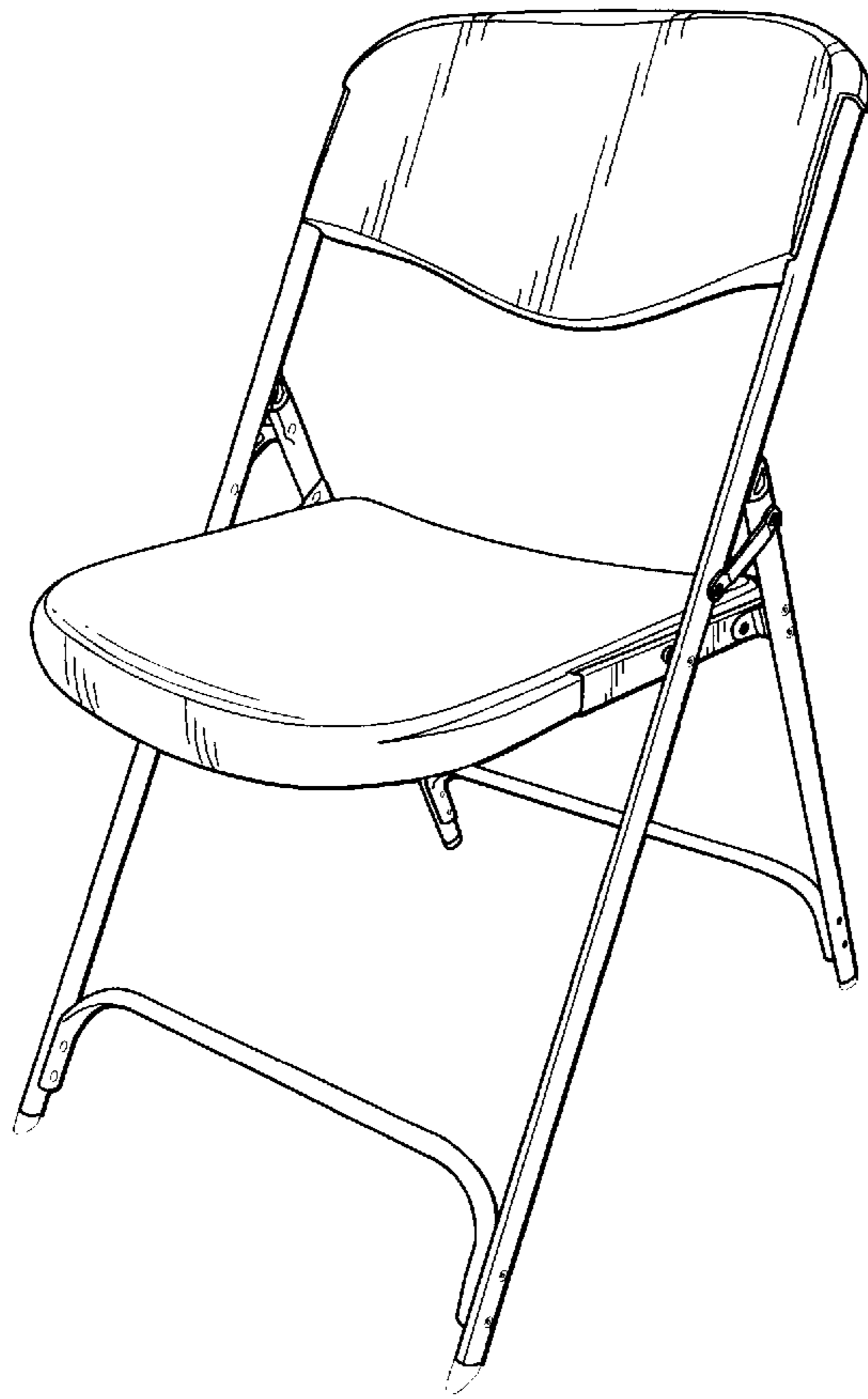
The ornamental design for a folding chair, as shown and described.

**DESCRIPTION**

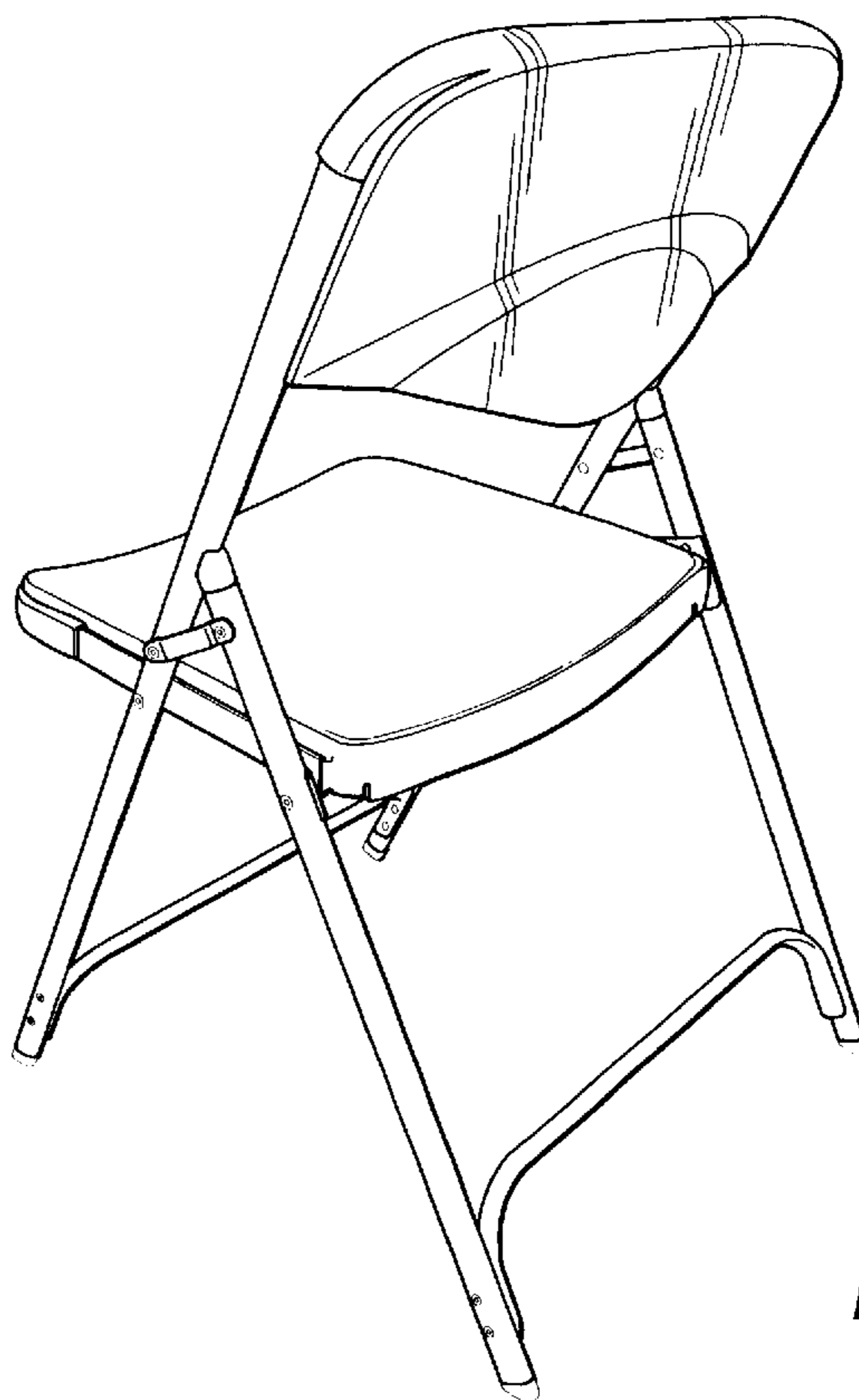
FIG. 1 is a front perspective view of a folding chair of the present invention;

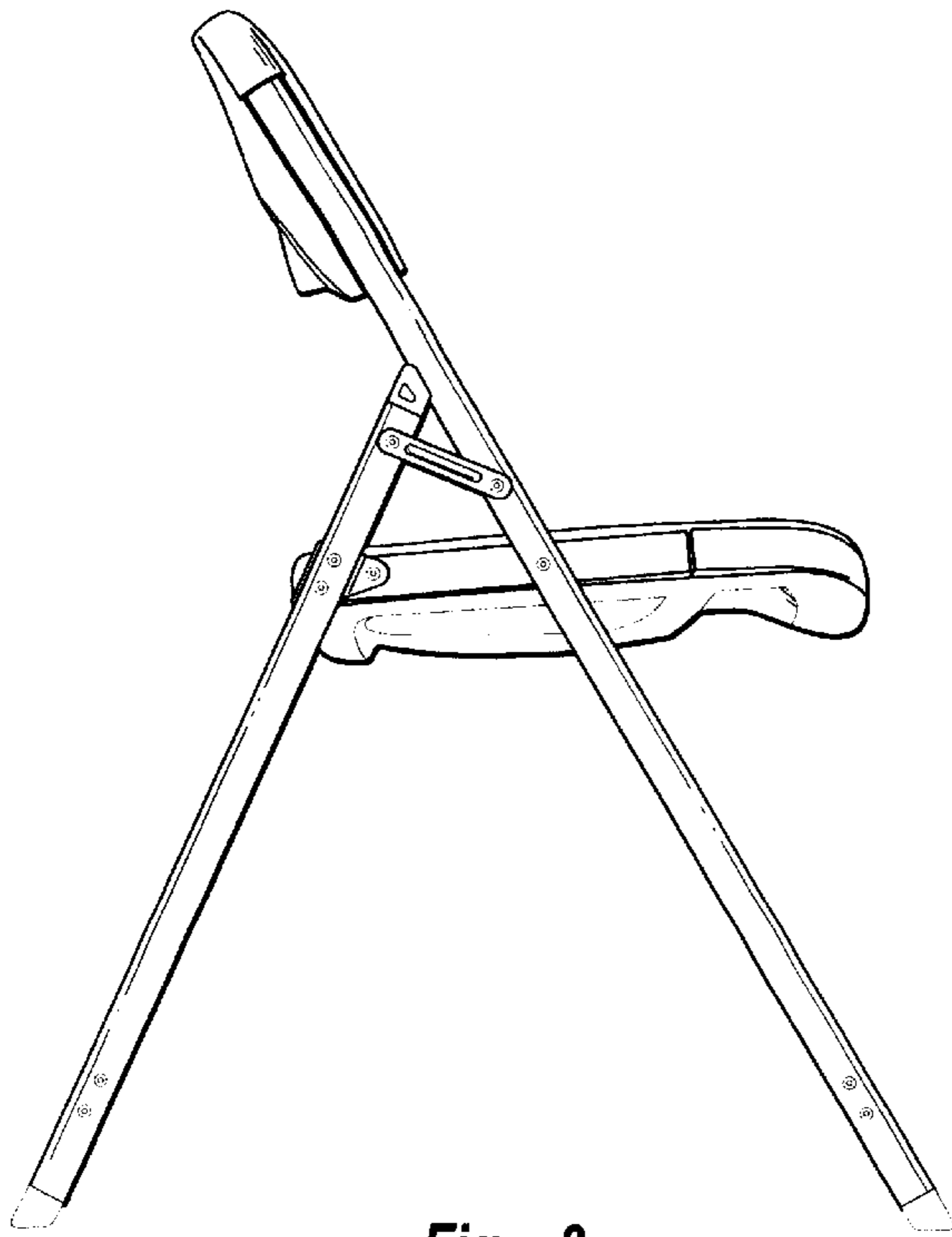




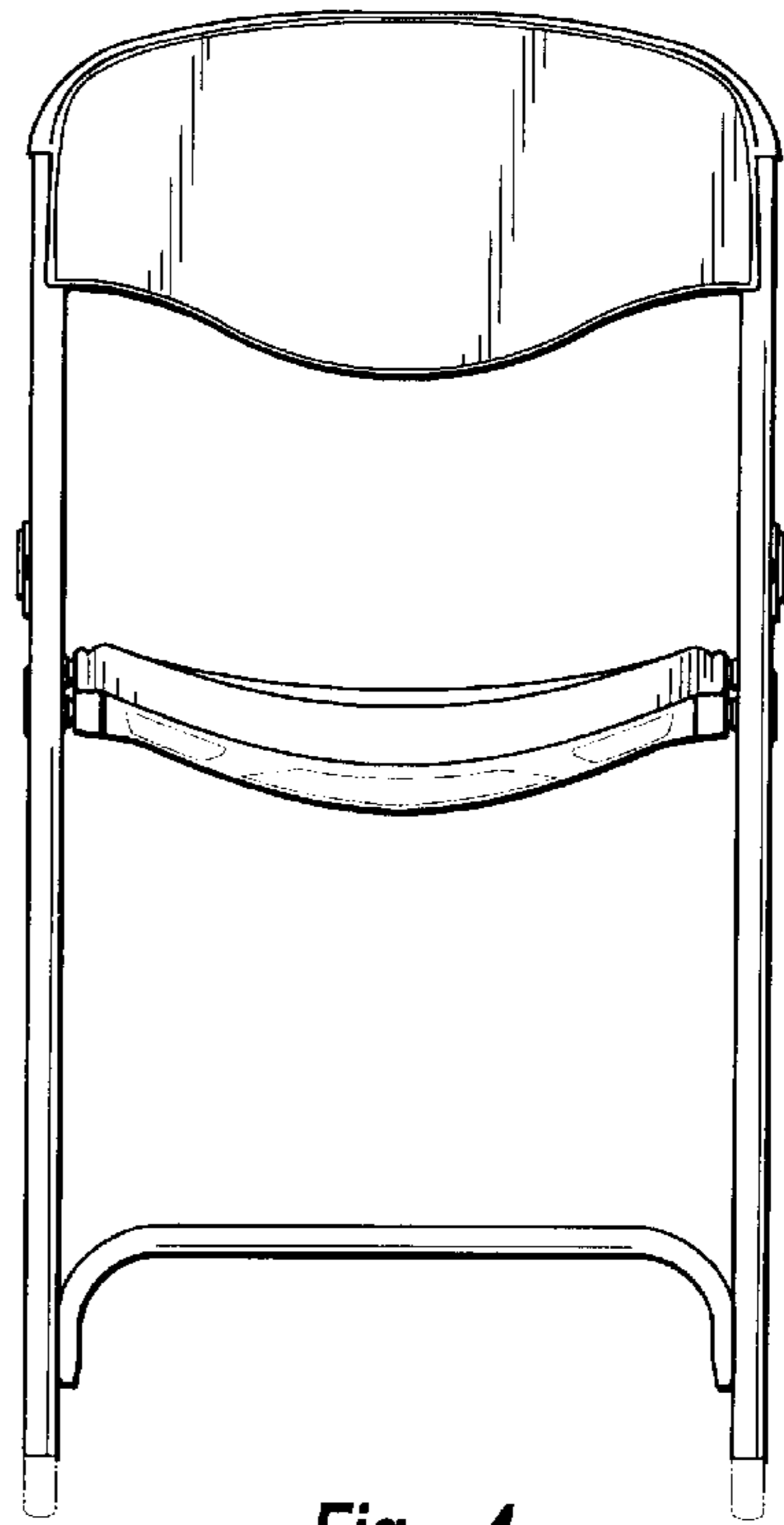

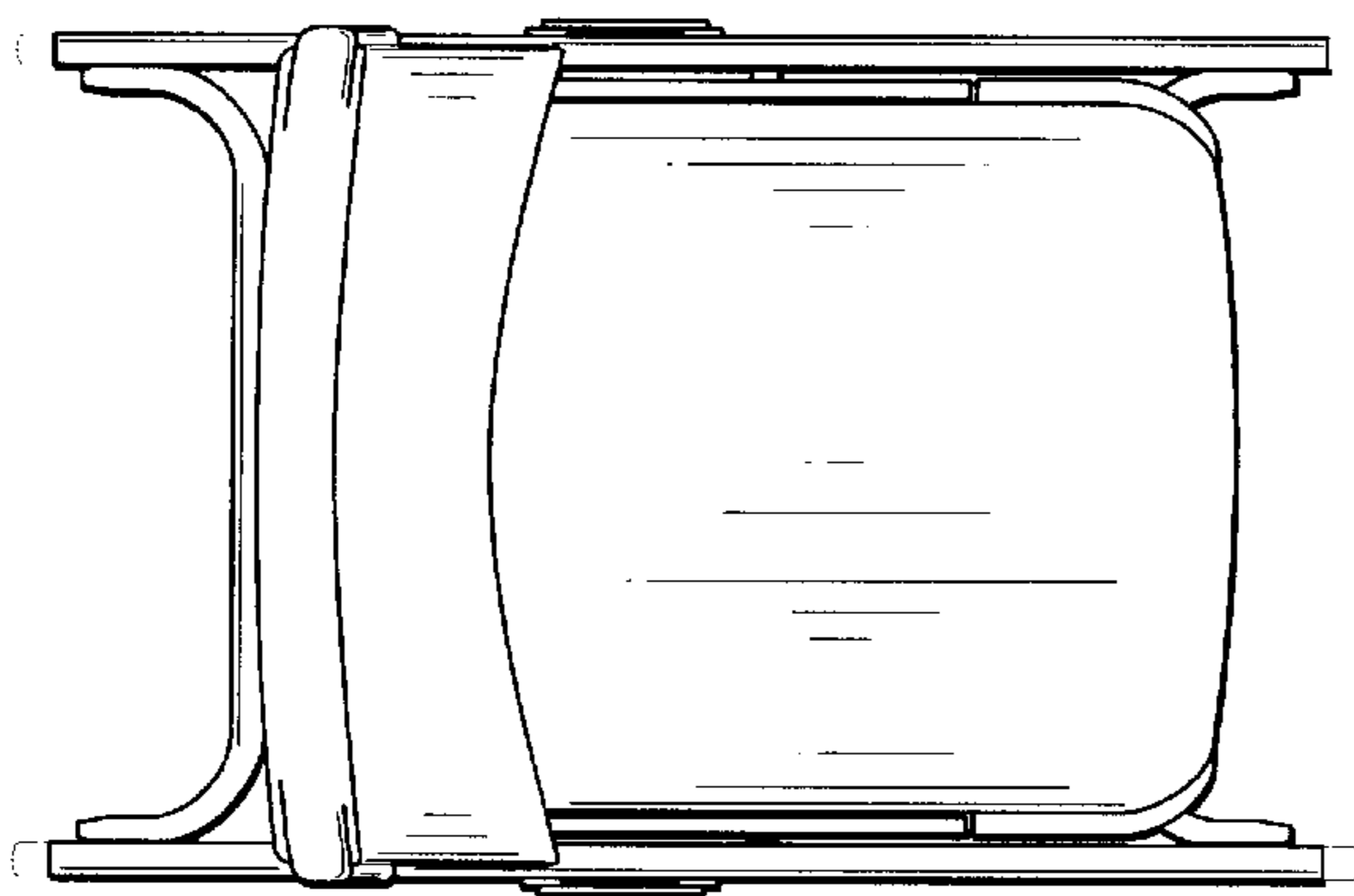

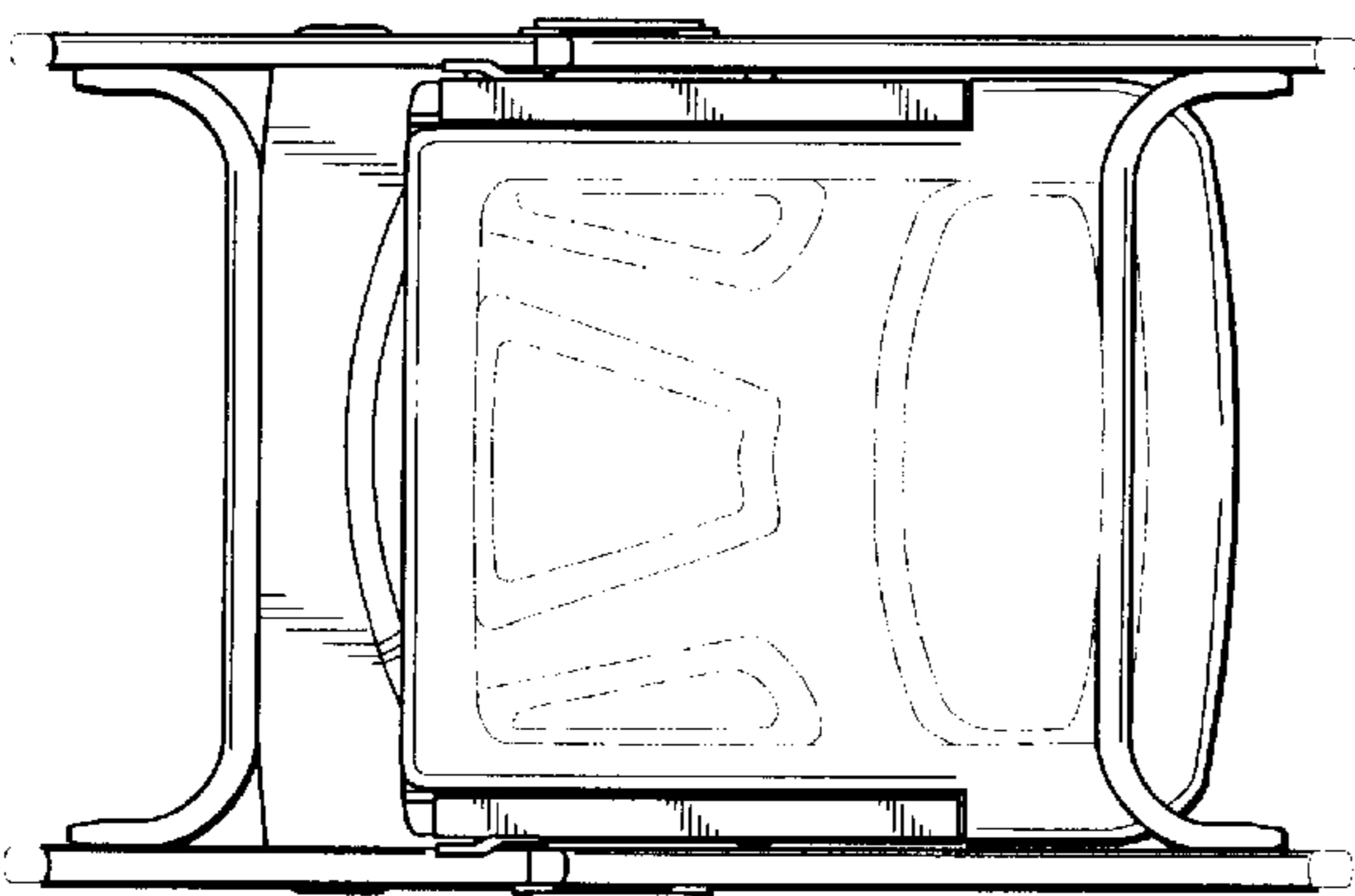

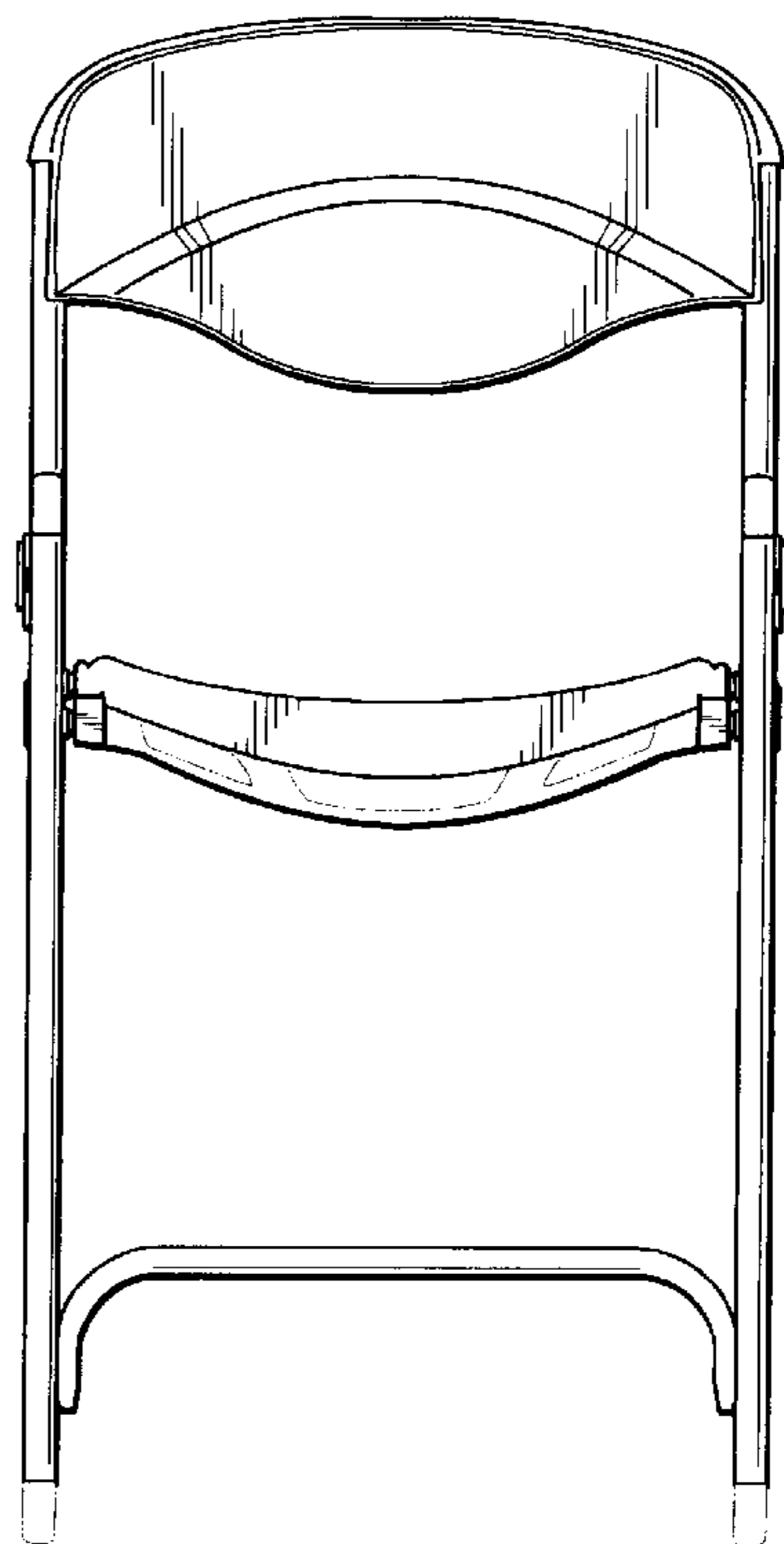
