(57) **CLAIM**

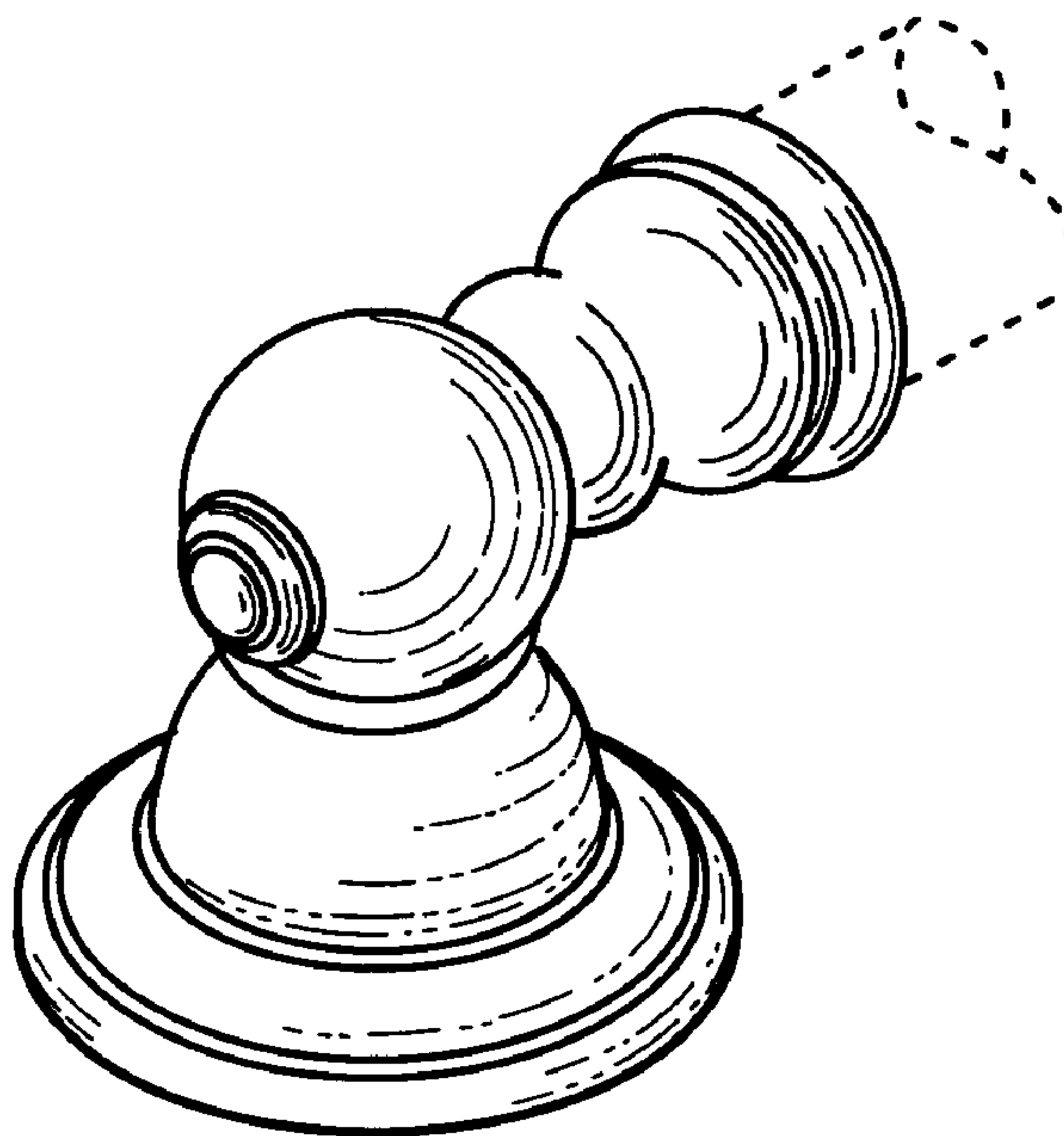
The ornamental design for a grab bar bracket, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of my new design for a grab bar bracket;
FIG. 2 is a front elevation view;

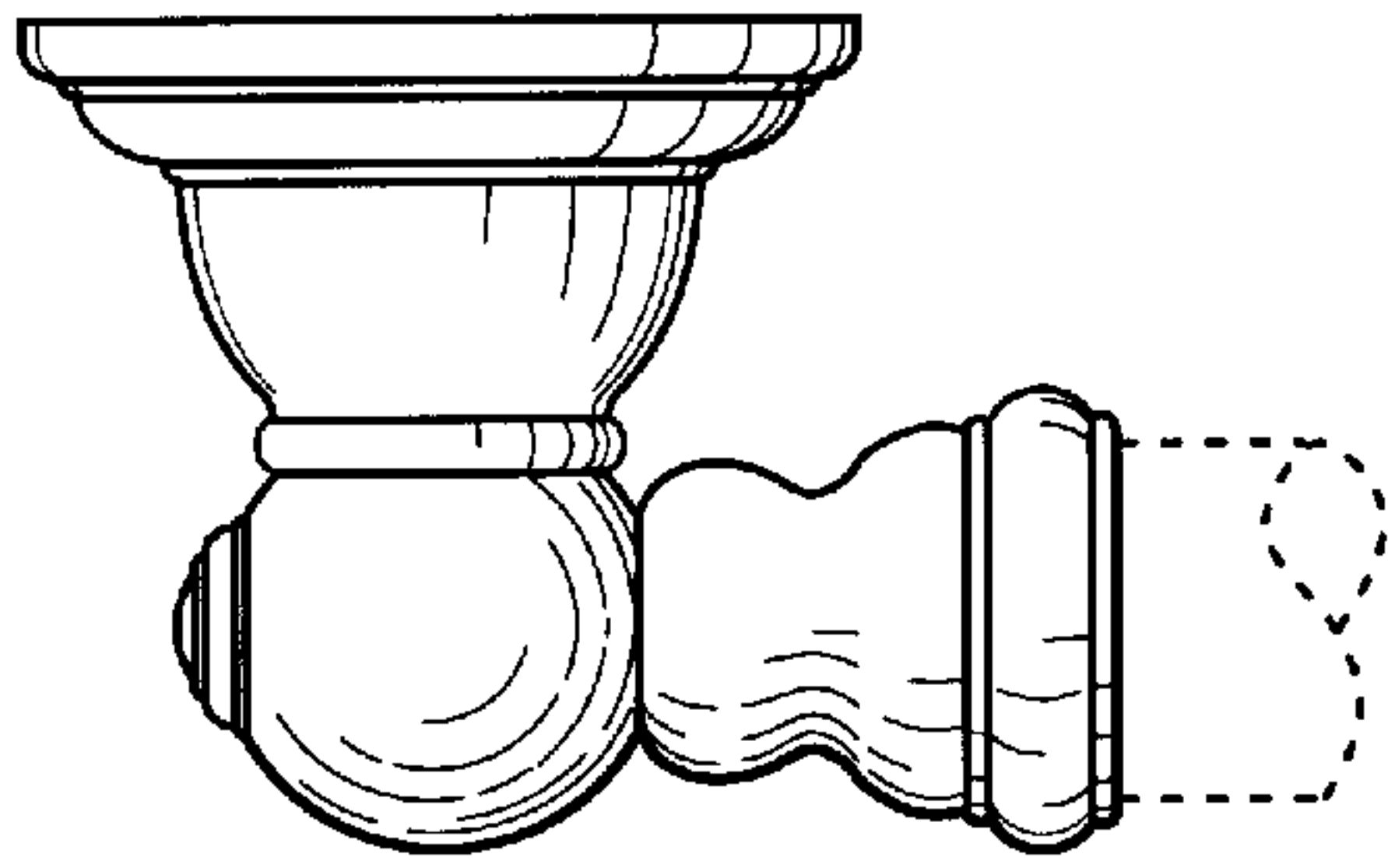

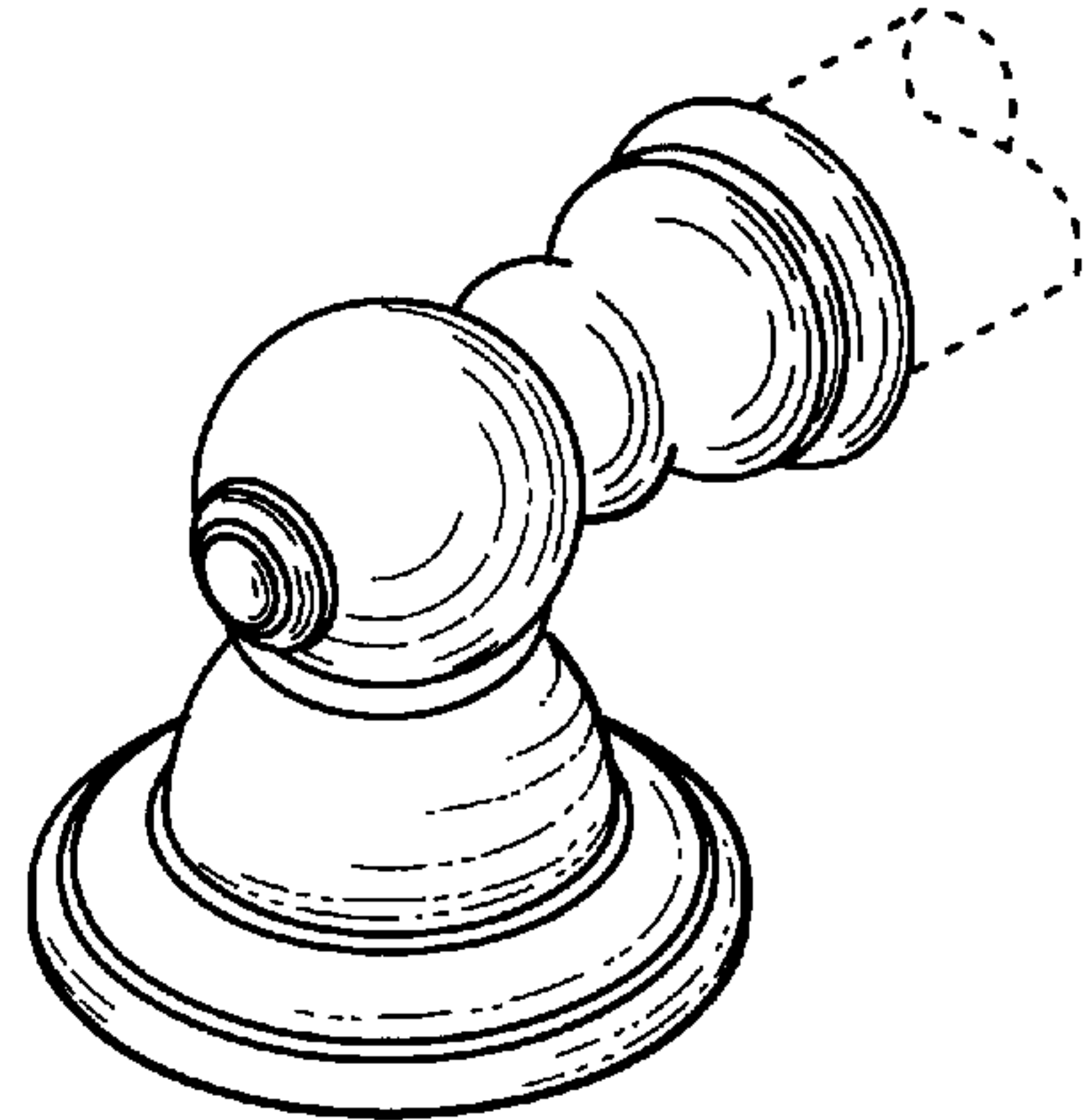

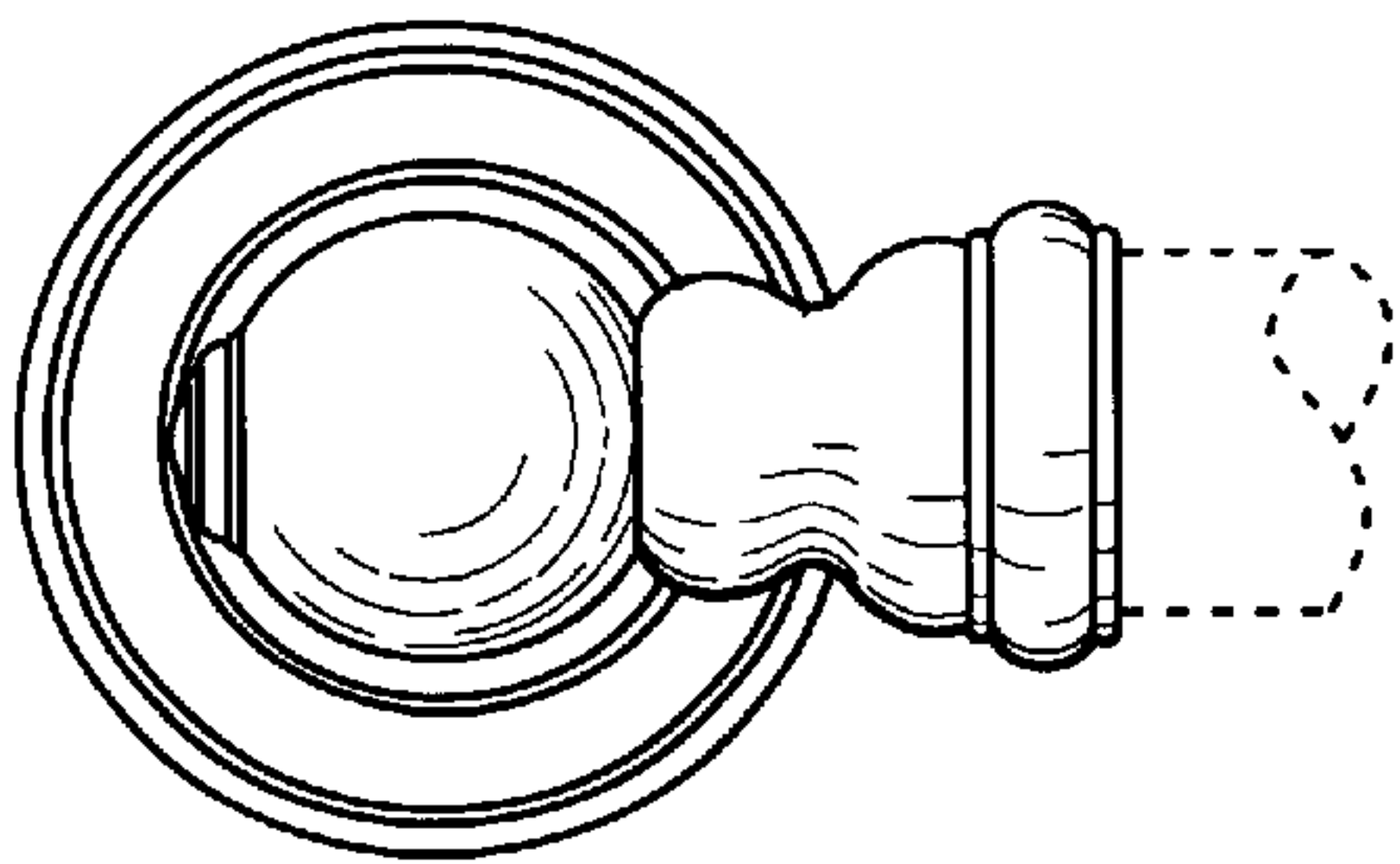

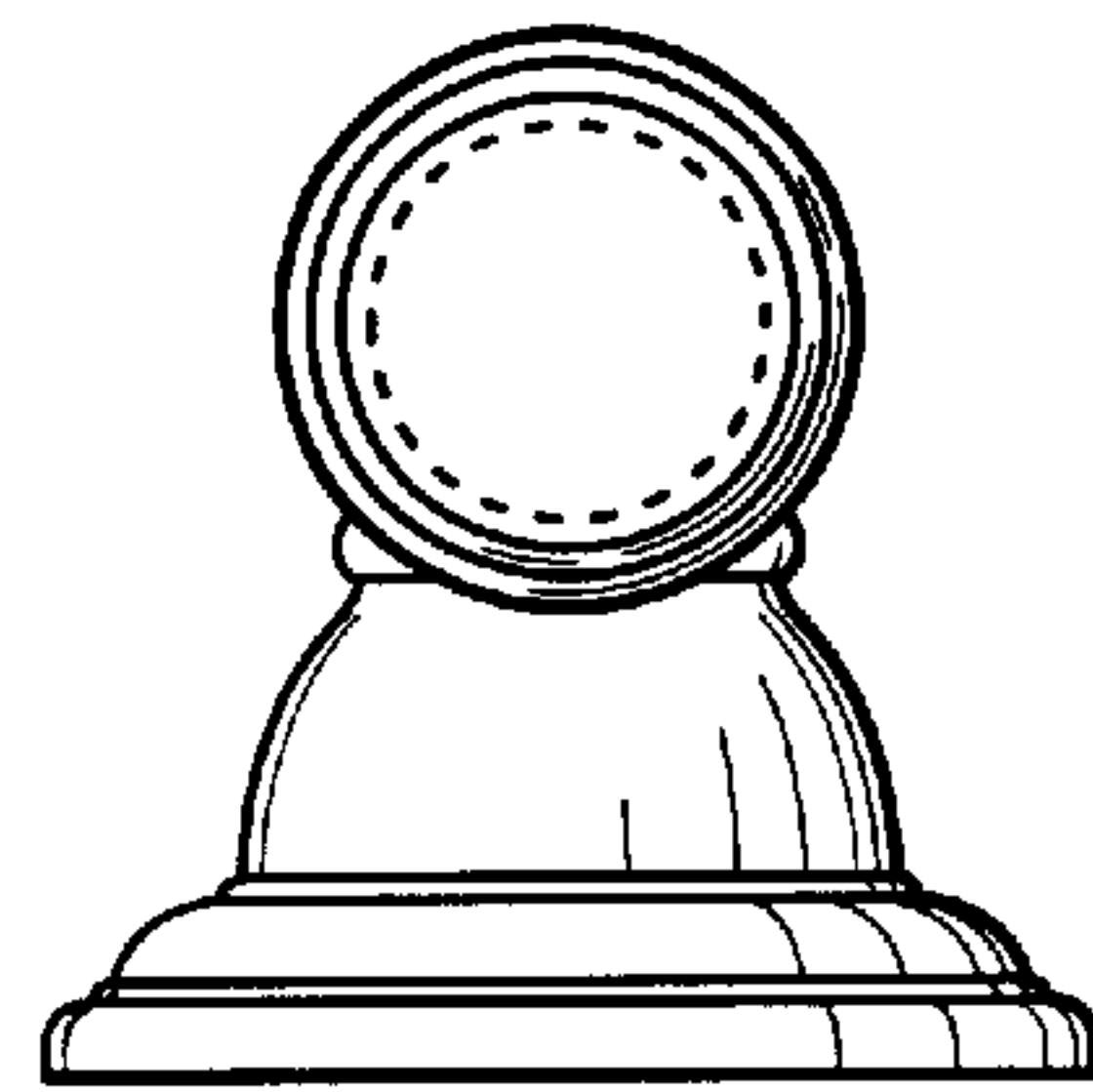

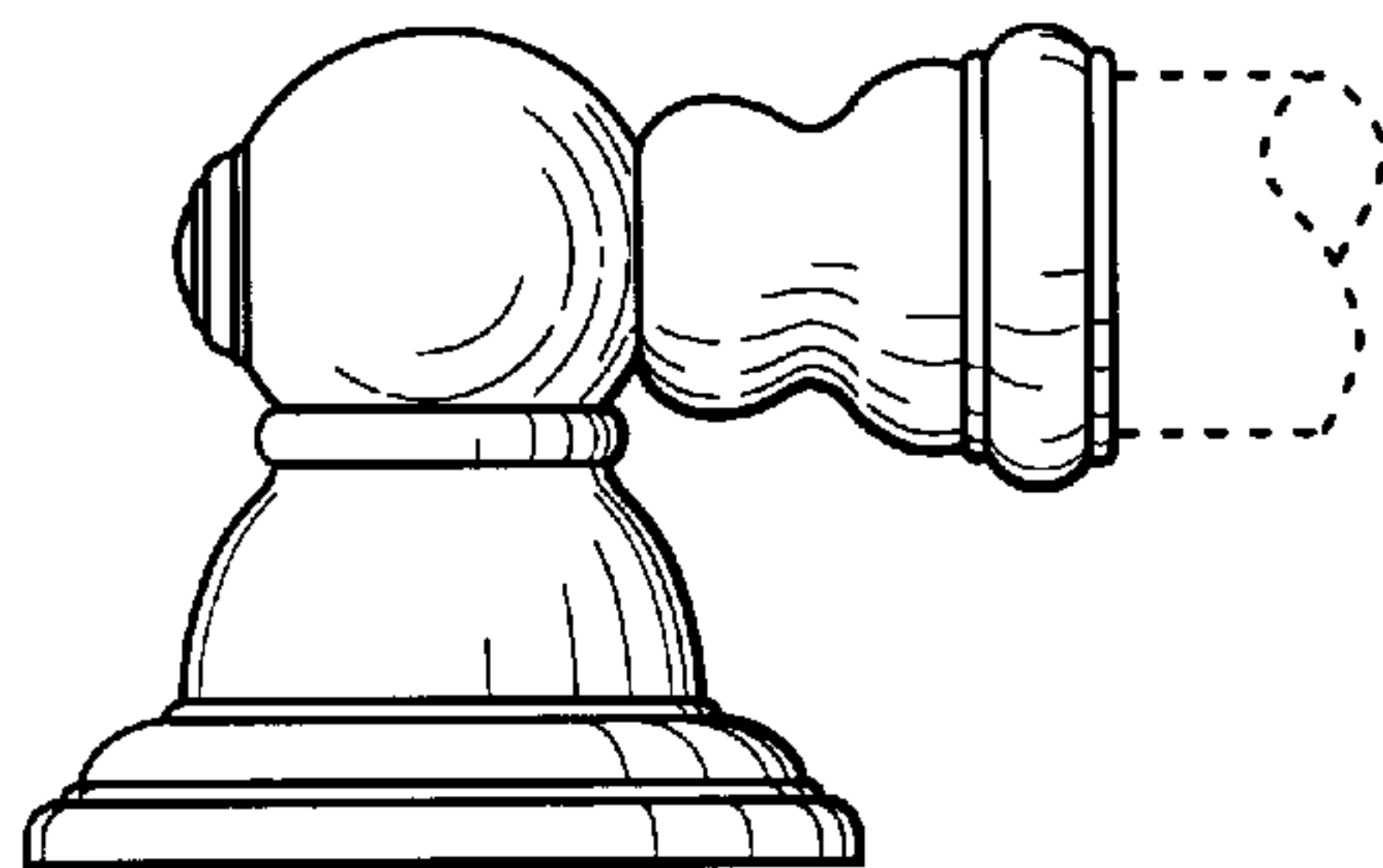

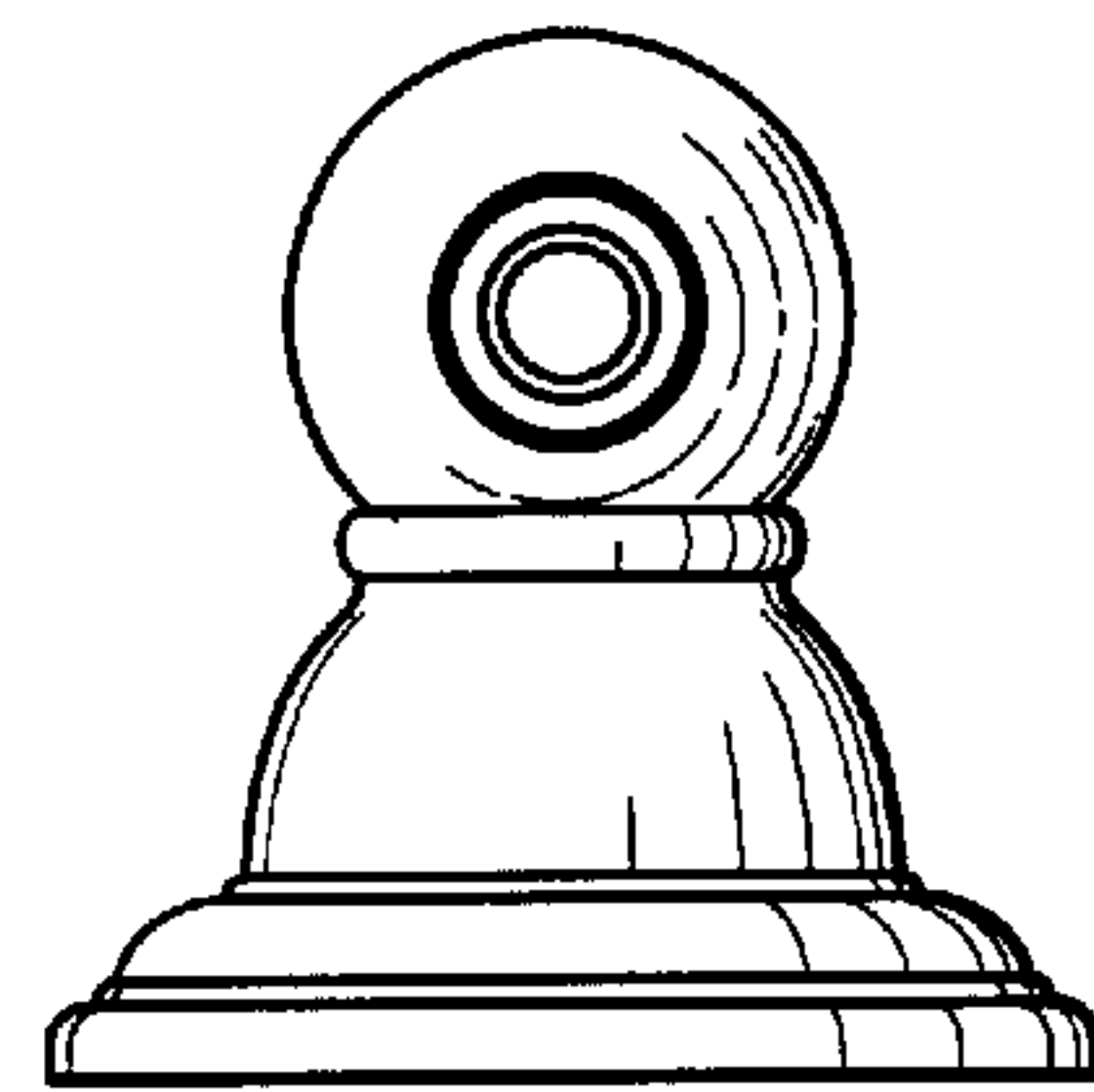

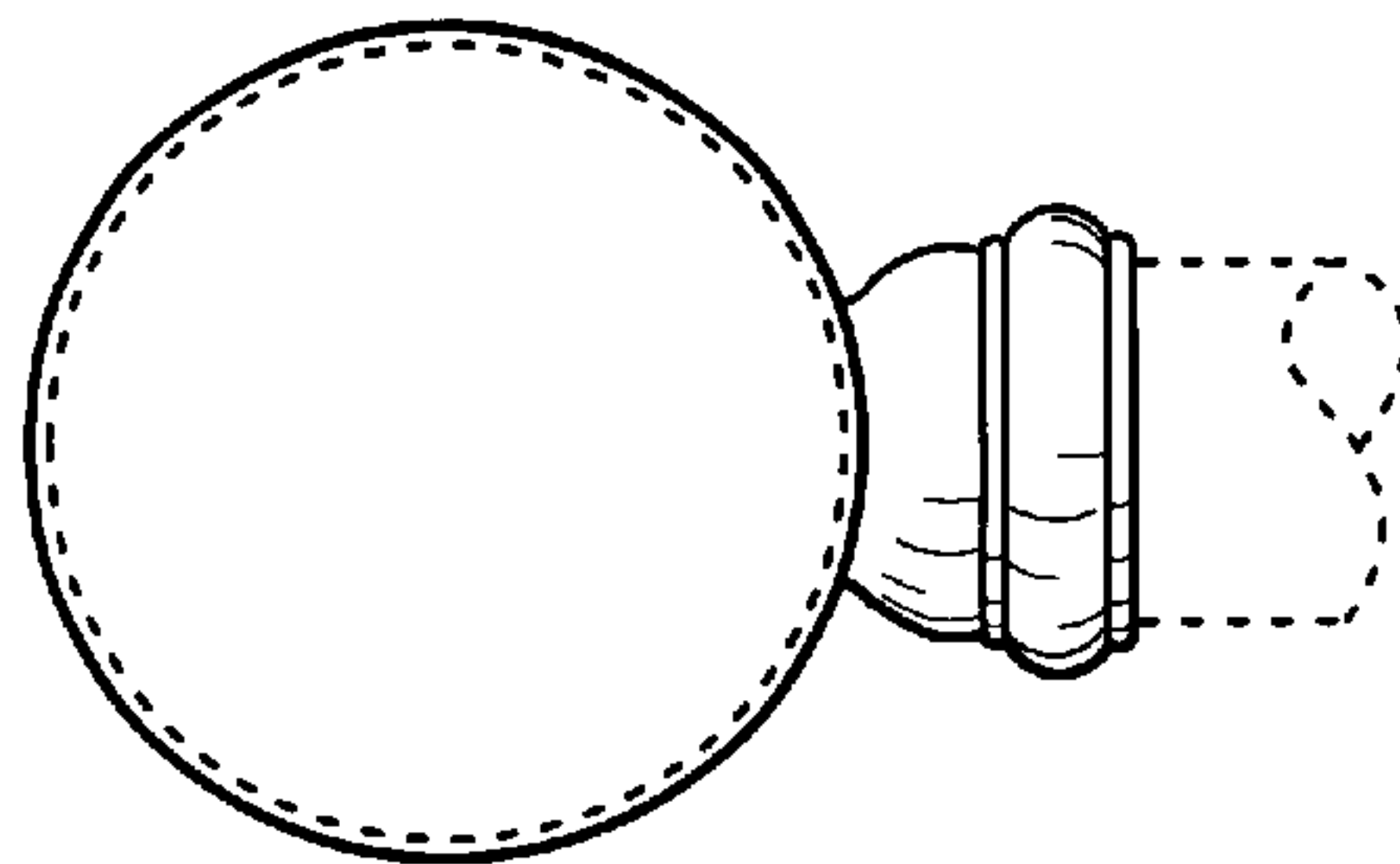
