(57) **CLAIM**

The ornamental design for a combined cosmetic powder container and cap, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view showing my new design with its cap in a closed position;

FIG. 2 is a top perspective view showing the cap in its open position;

FIG. 3 is a front end elevational view showing the cap in its closed position; the back end, right side and left side elevational views being identical thereto, except for the threads;

FIG. 4 is a top plan view showing the cap in its closed position; and,

FIG. 5 is a bottom plan view.

The broken line showing in FIGS. 1-3 is for illustrative purposes only and forms no part of the claimed design.

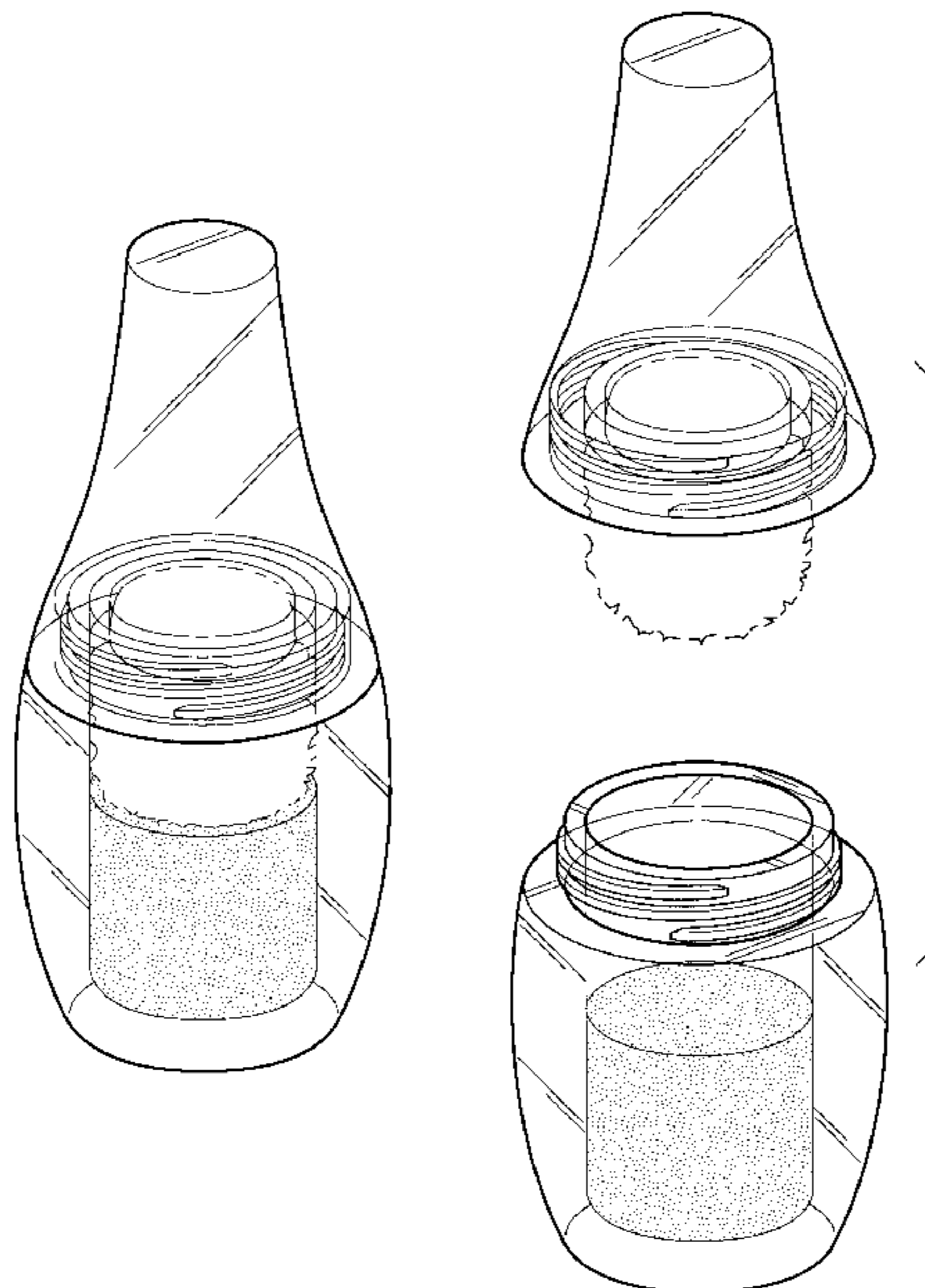

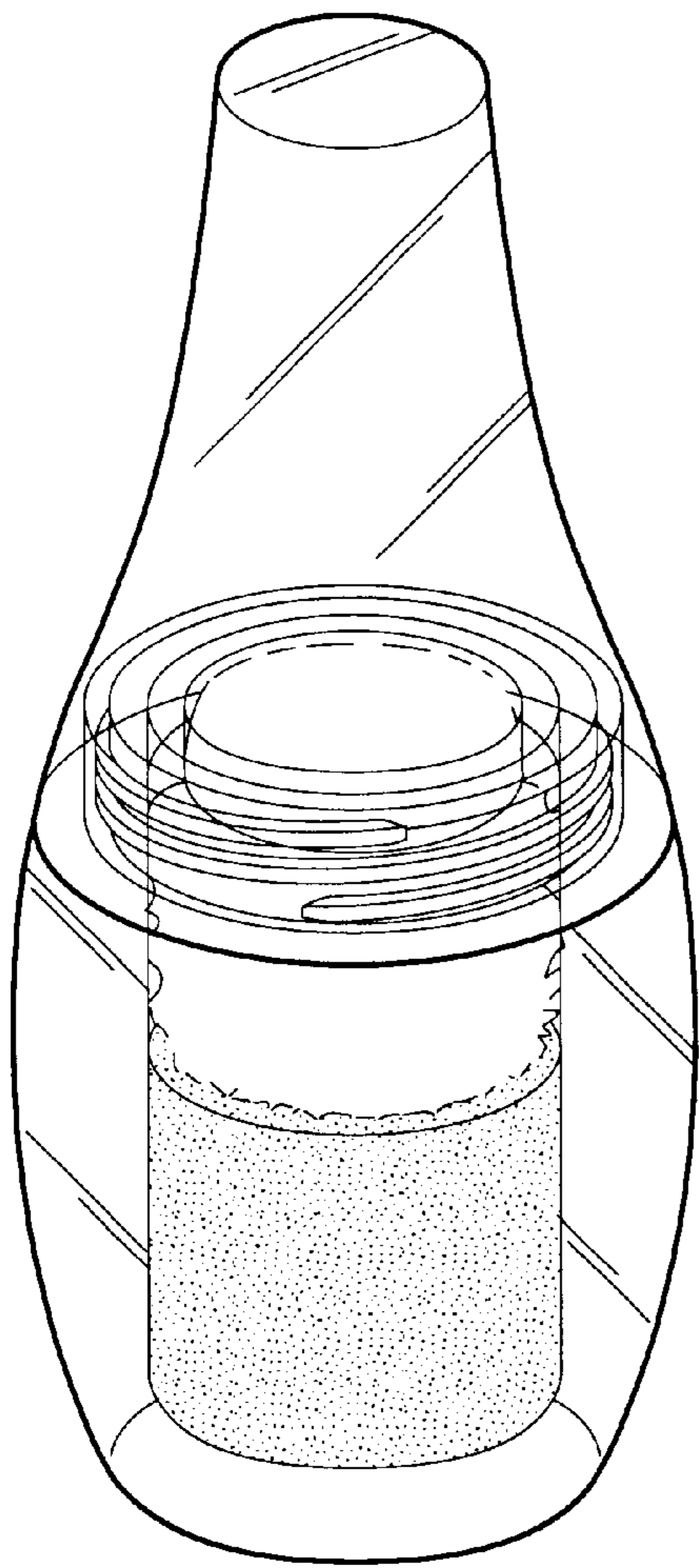
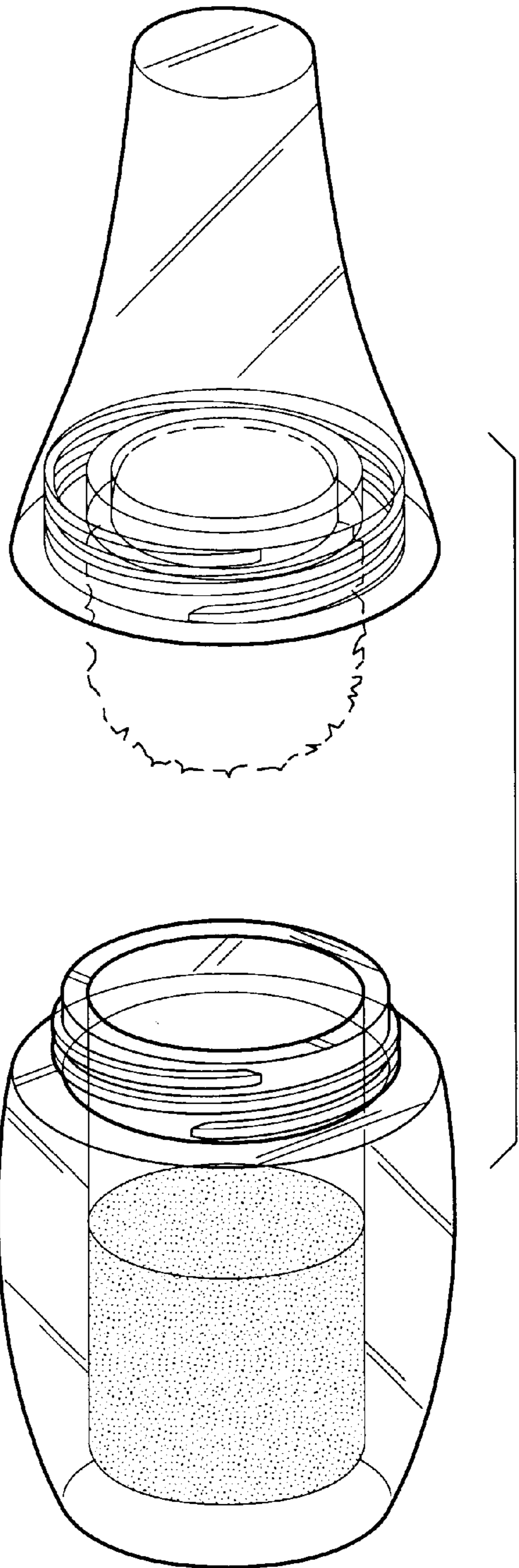
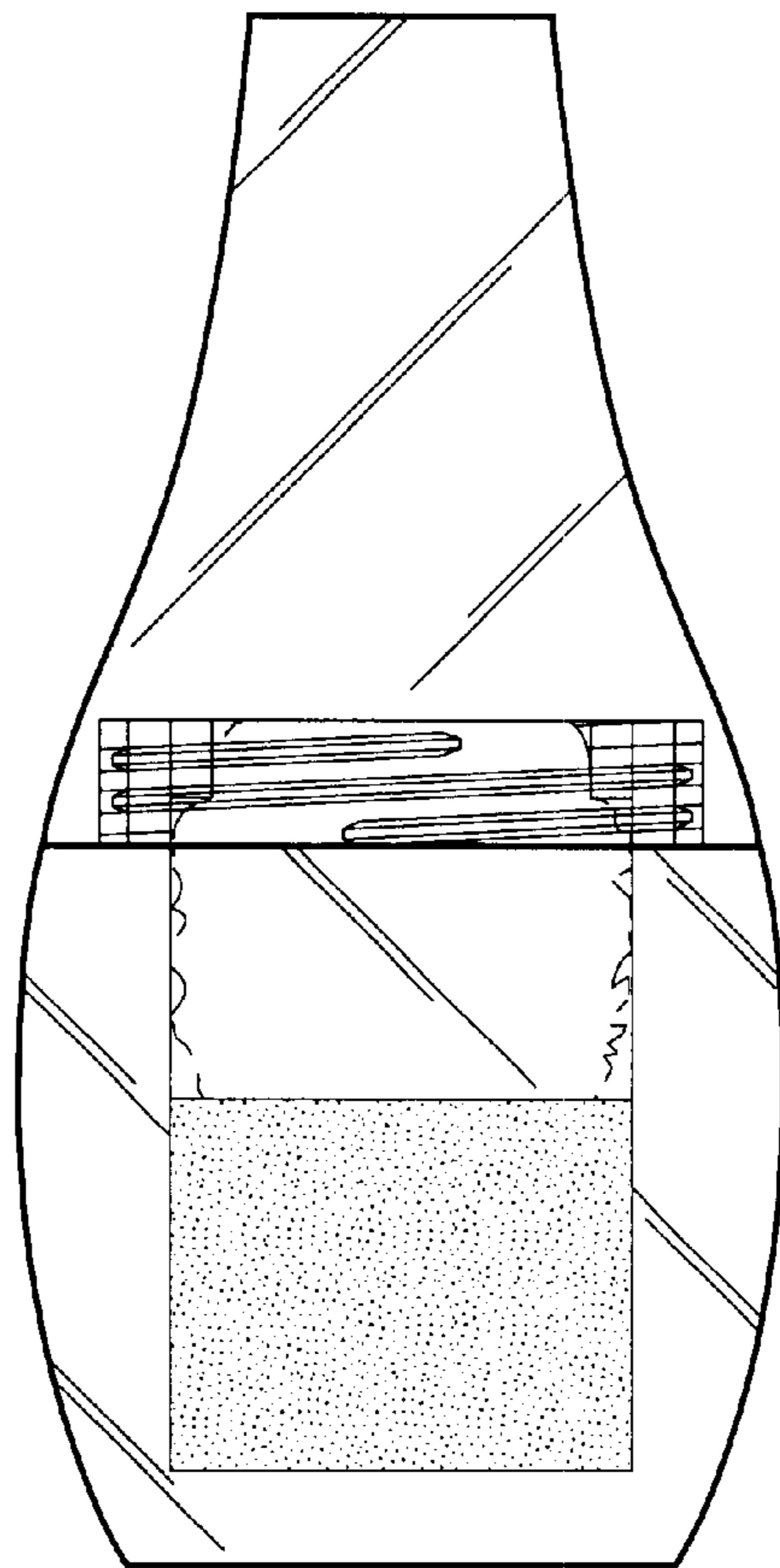


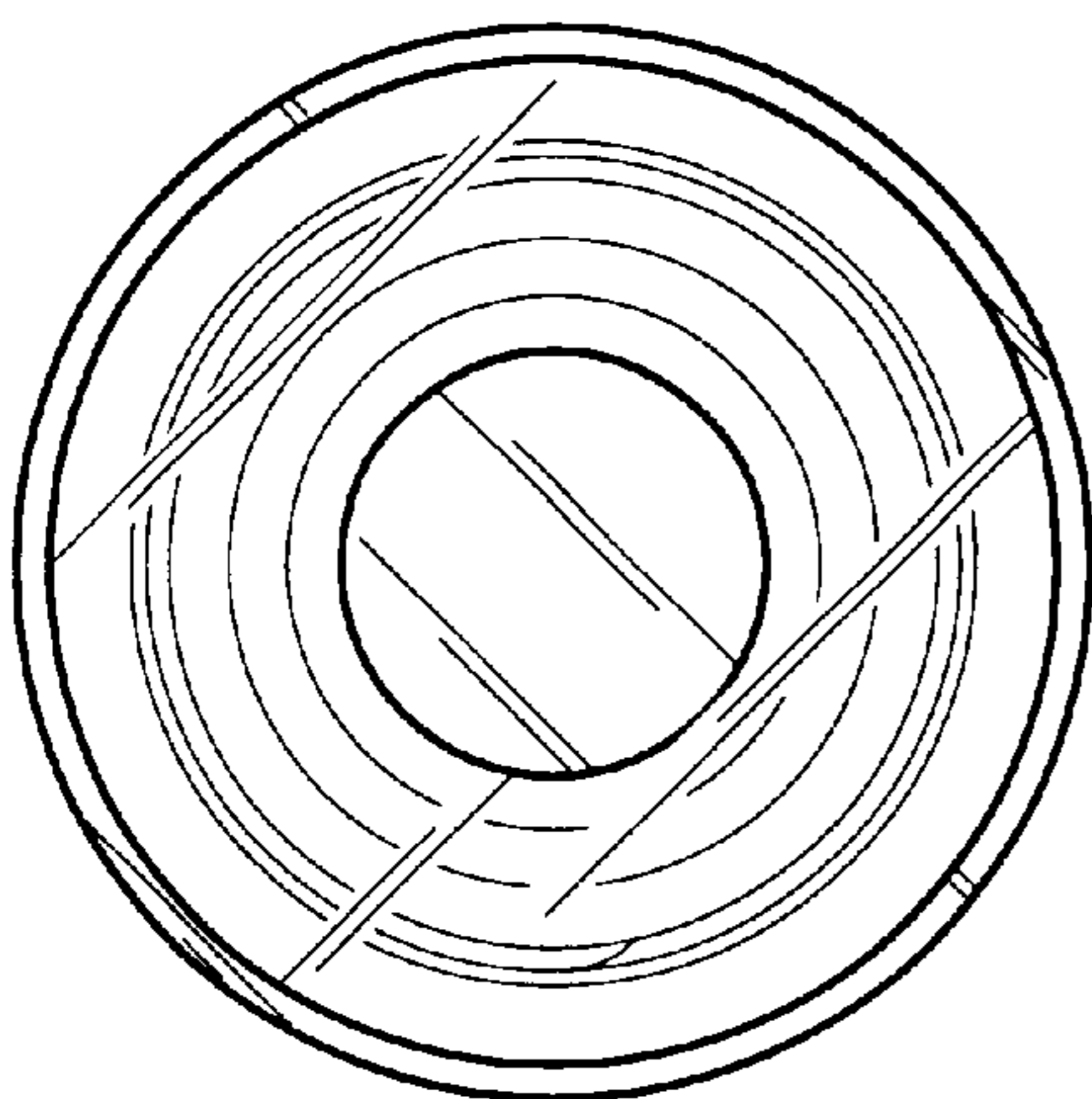
