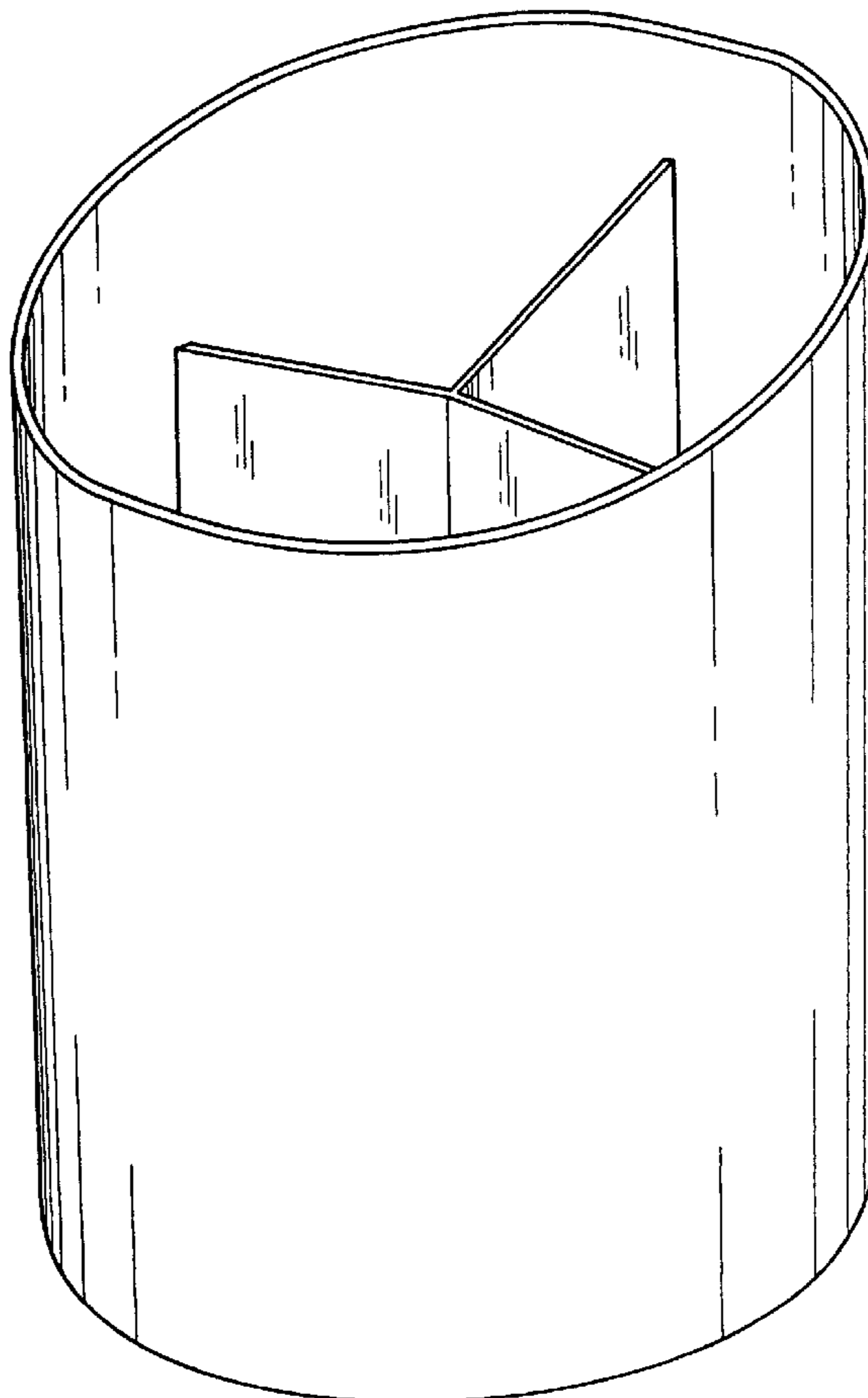

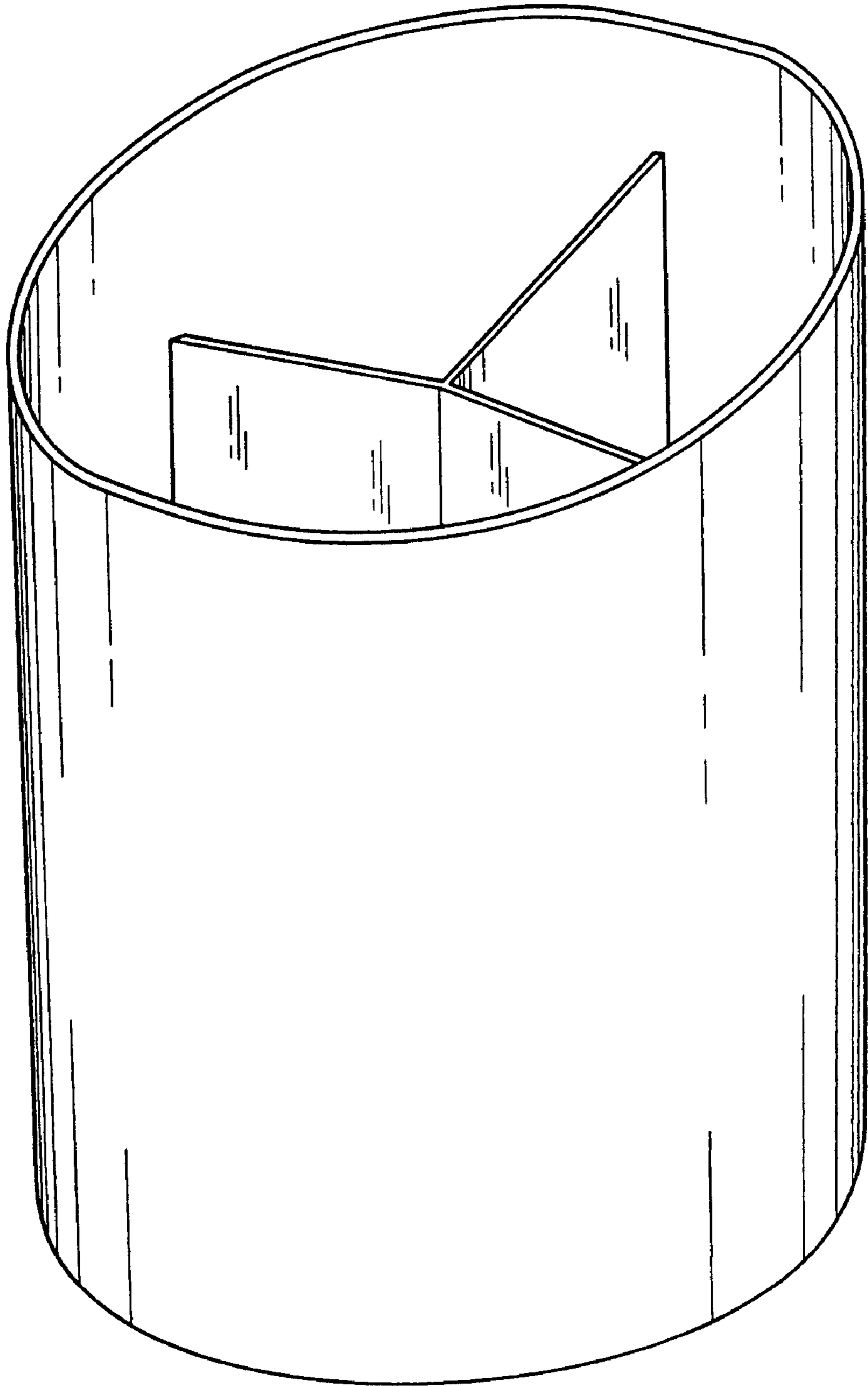
The ornamental design for the pencil holder, as shown.

**DESCRIPTION**

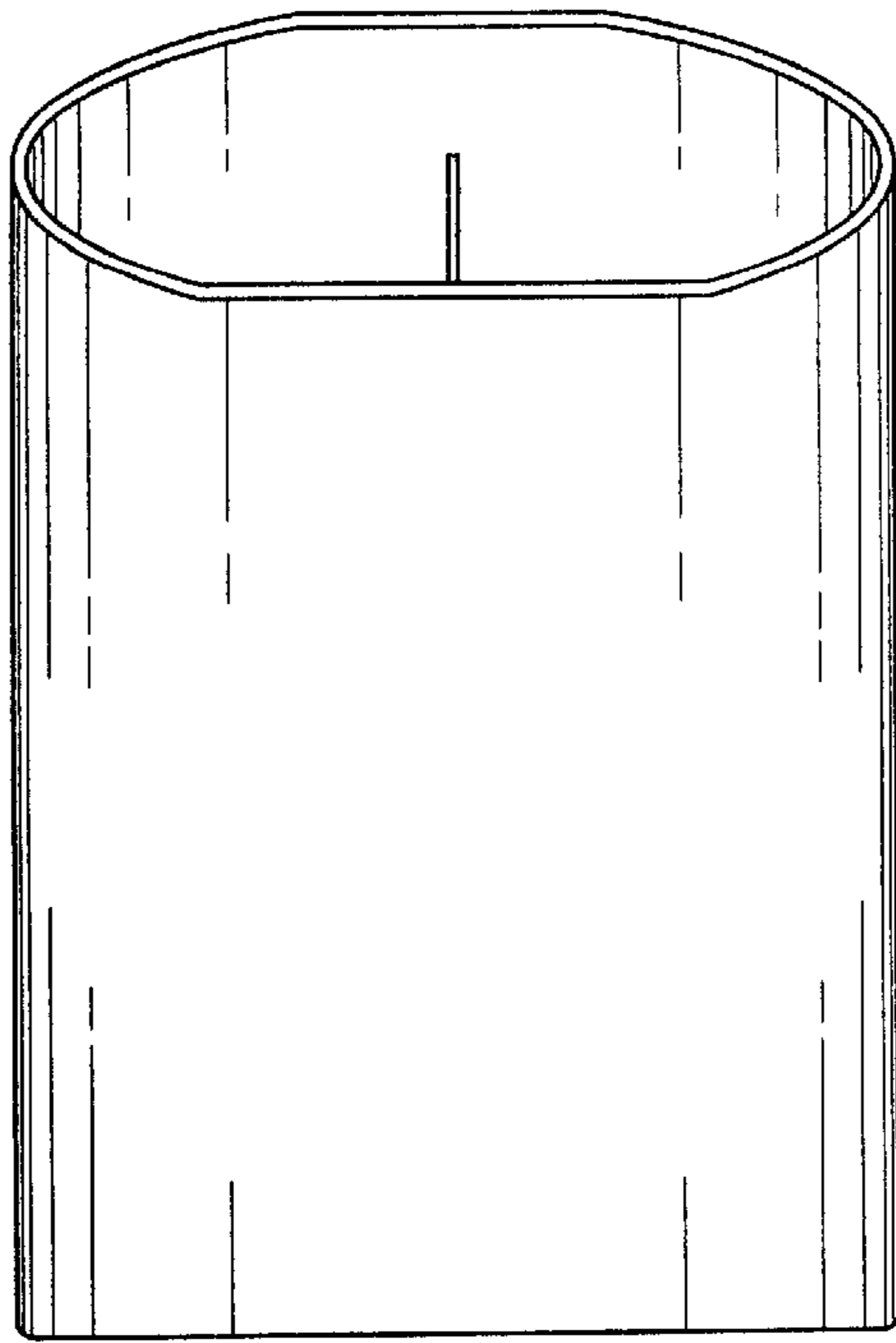
FIG. 1 is a front perspective view of the pencil holder showing the design;

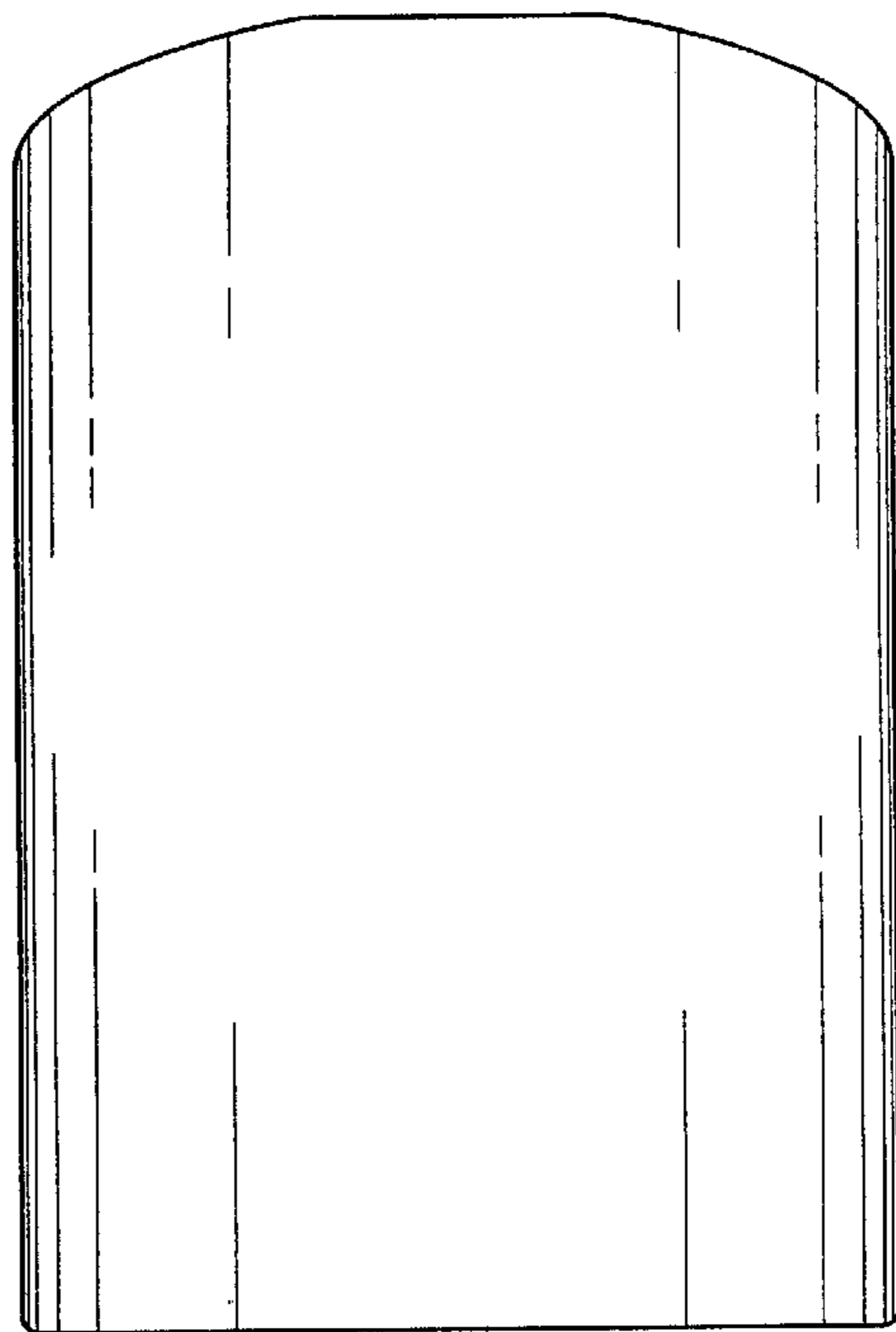




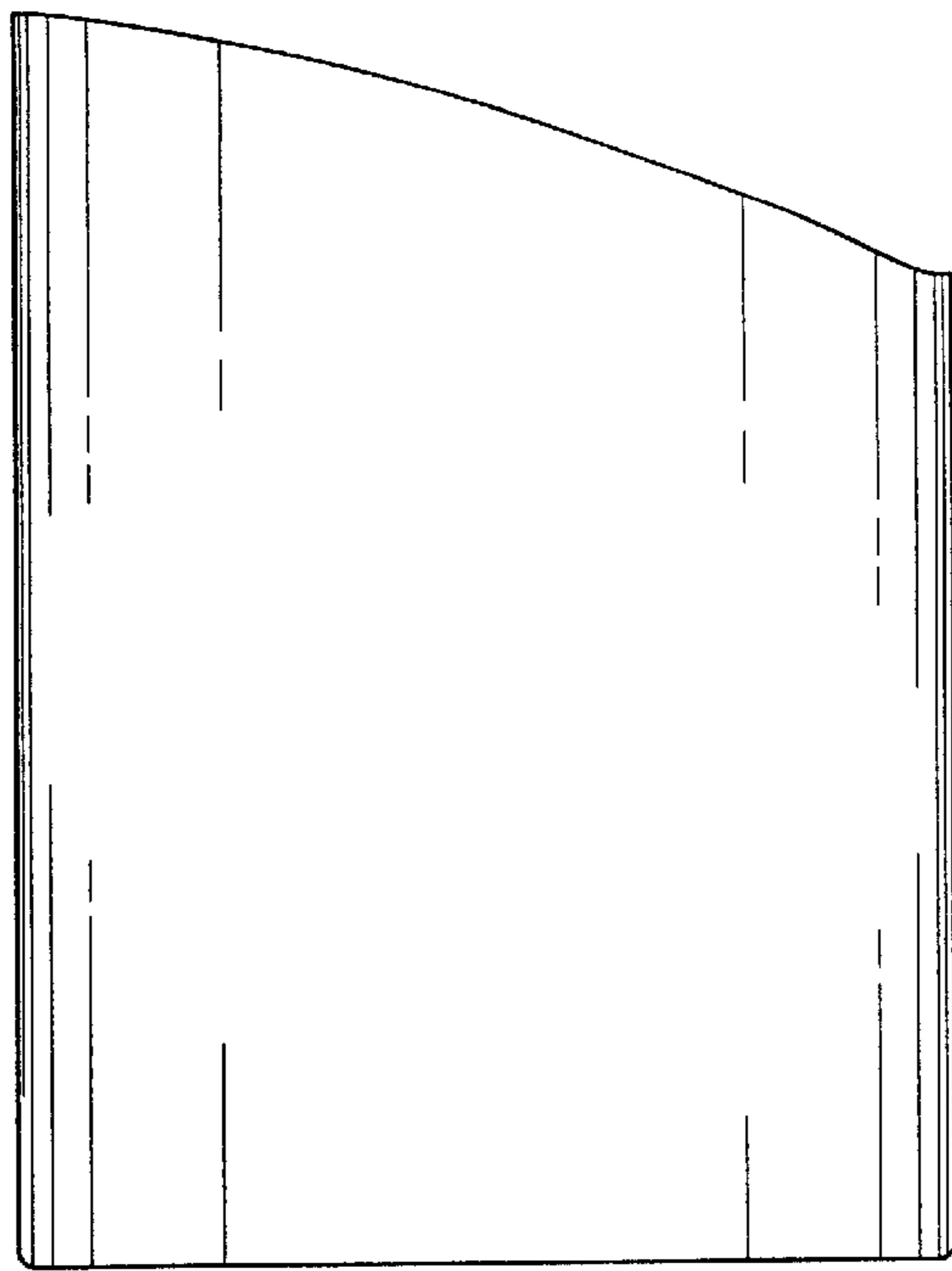

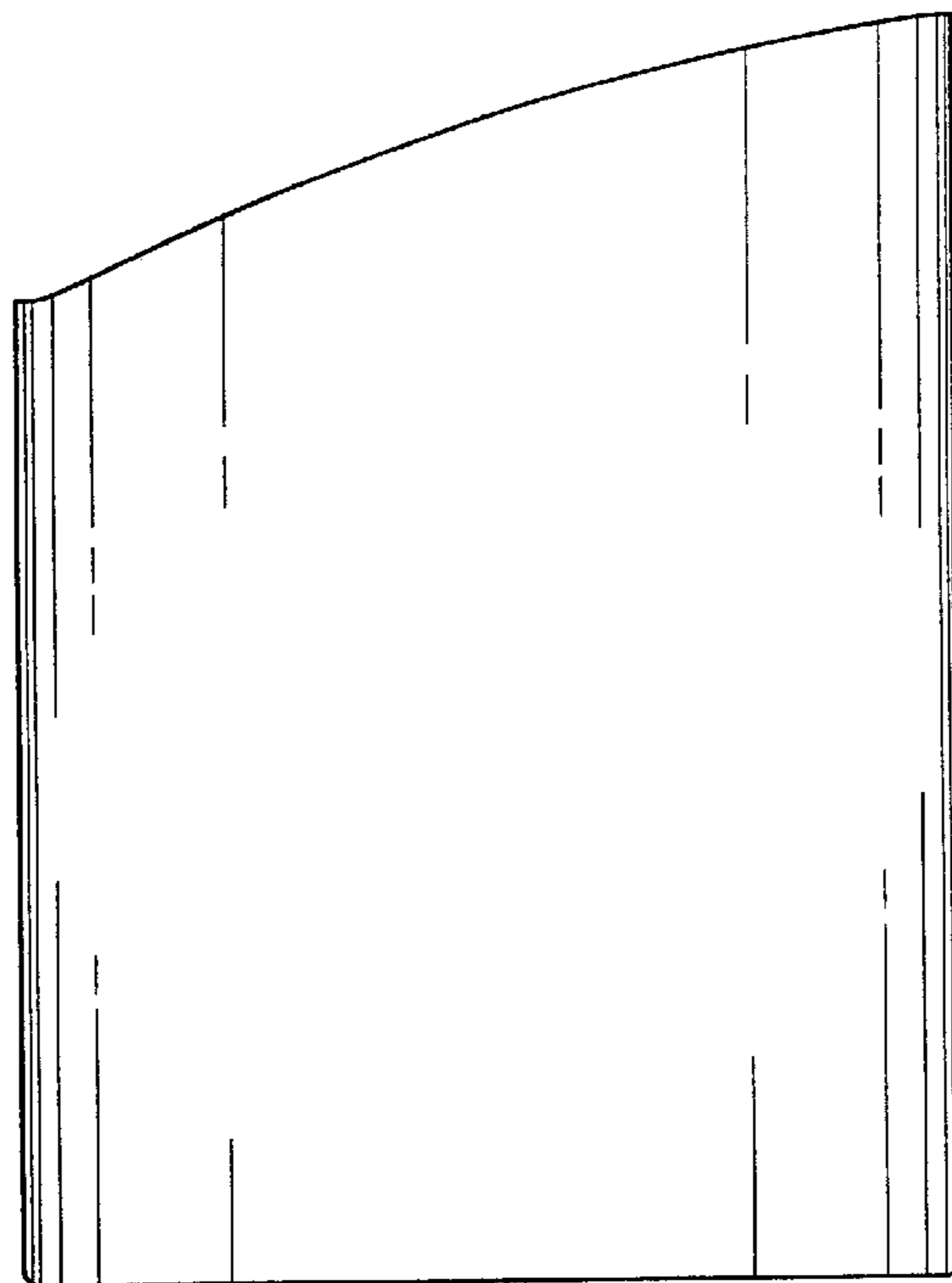

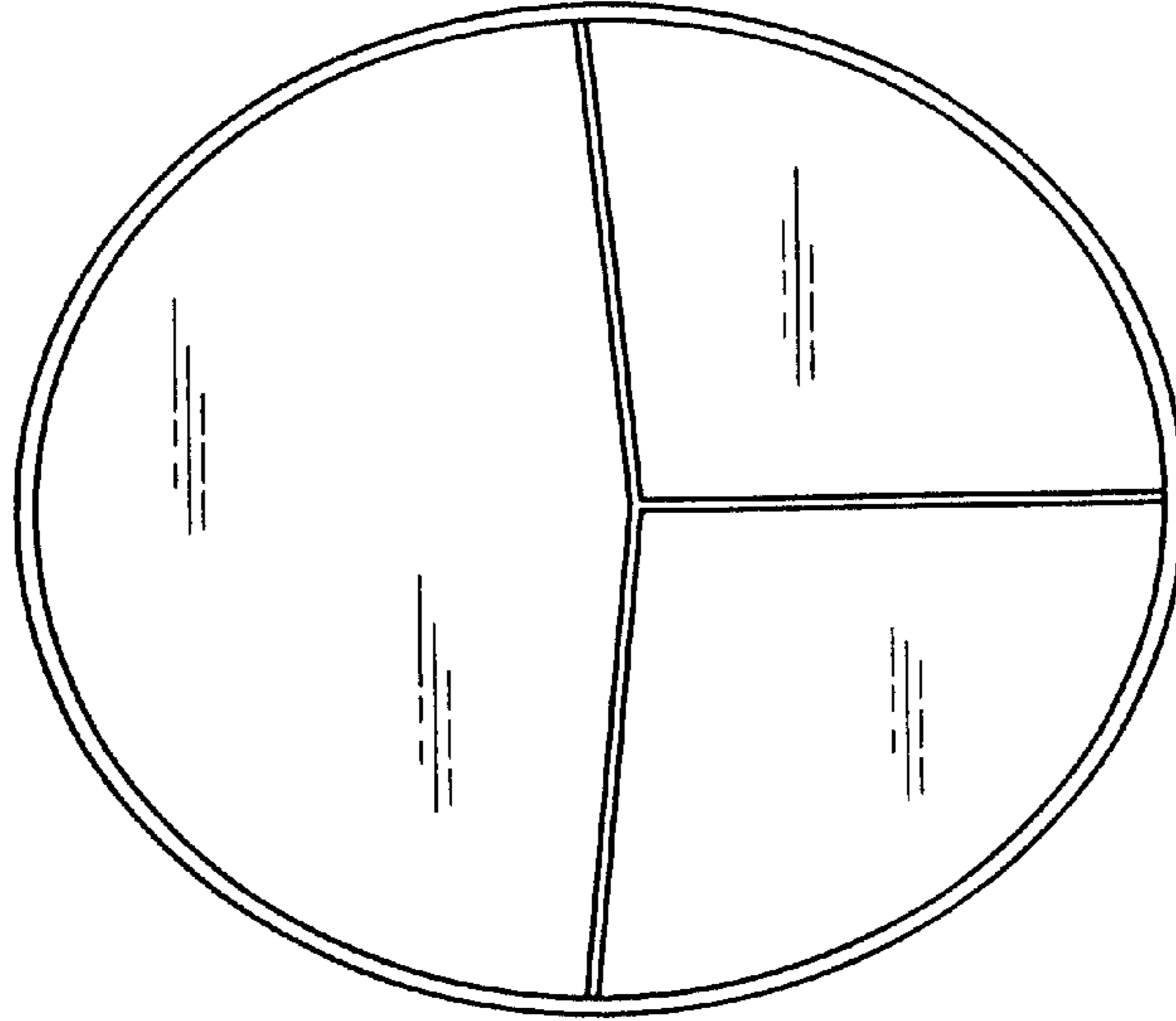

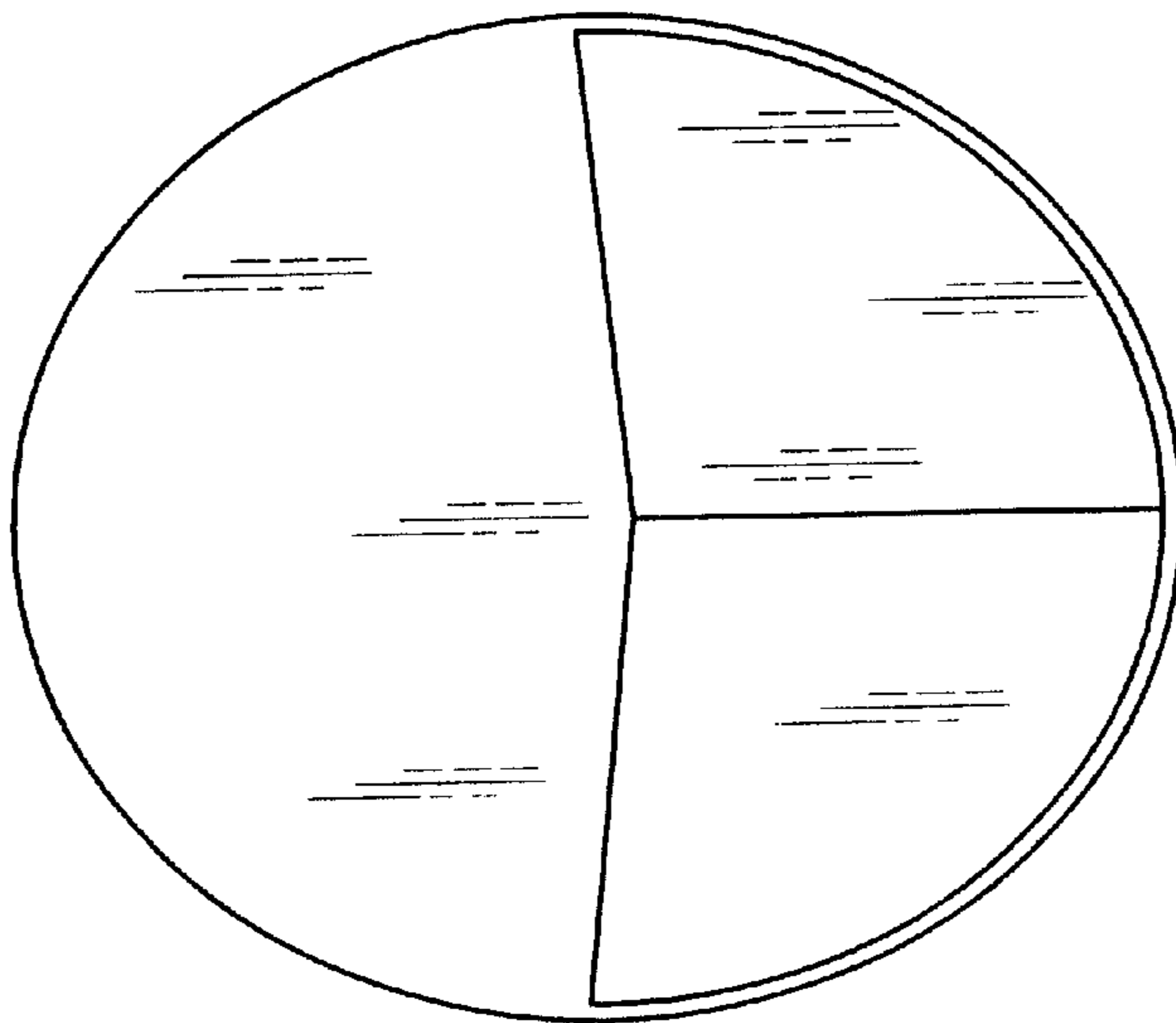
