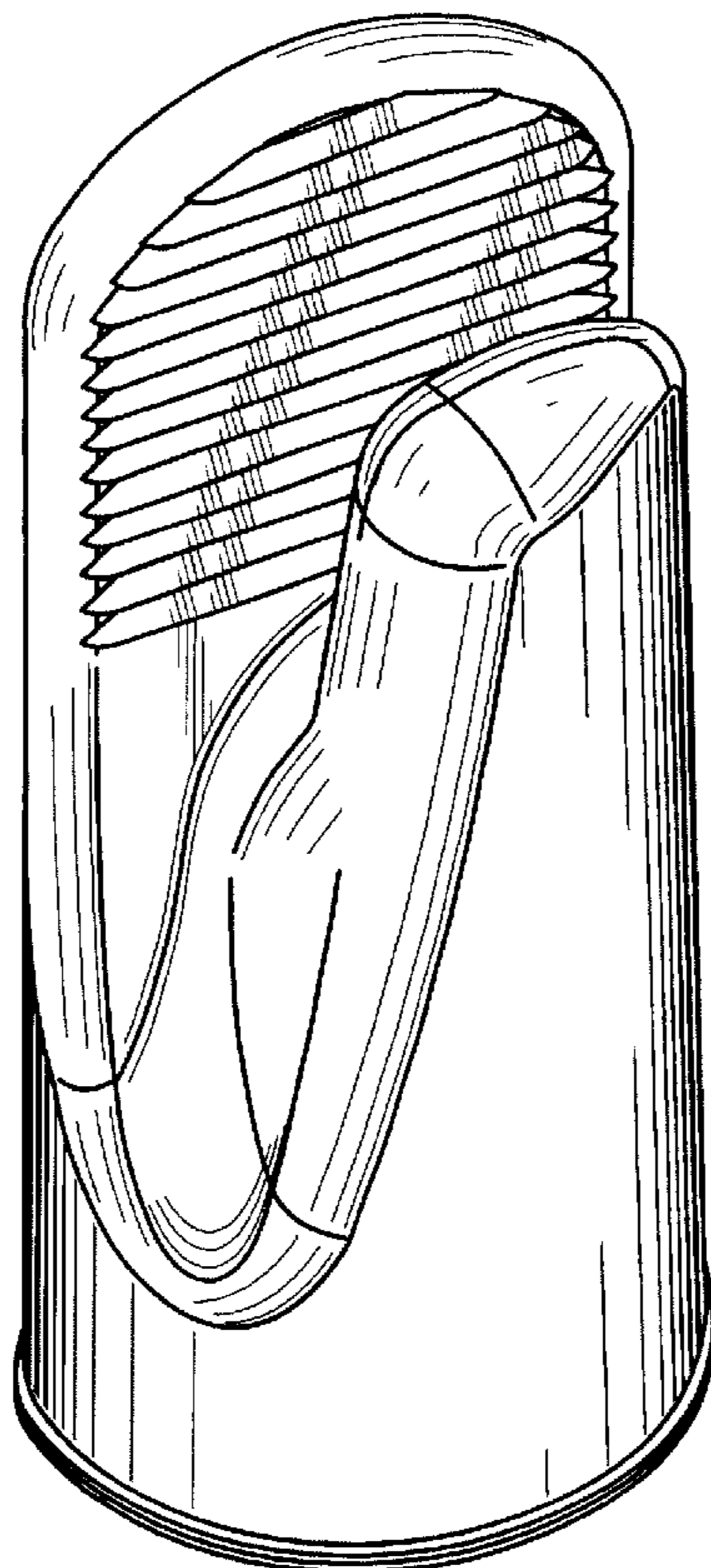

DESCRIPTION

FIG. 1 is a perspective view of a right hand embodiment of the new silicone glove;
FIG. 2 is a right side view thereof;
FIG. 3 is a left side view thereof;
FIG. 4 is a front view thereof;
FIG. 5 is a back view thereof; and,
FIG. 6 is a top view thereof.
The left hand embodiment not shown is a mirror image of the right hand embodiment shown in FIGS. 1–6.

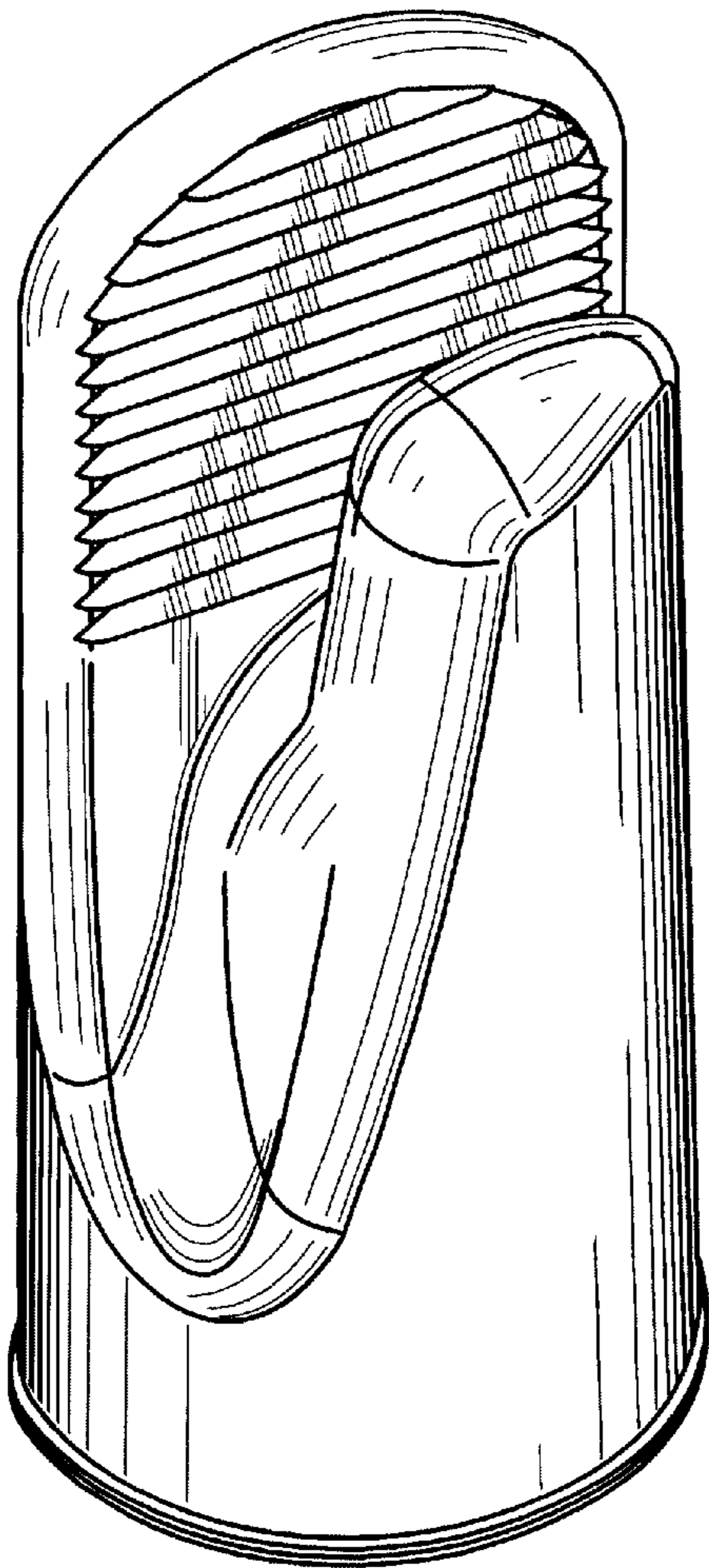

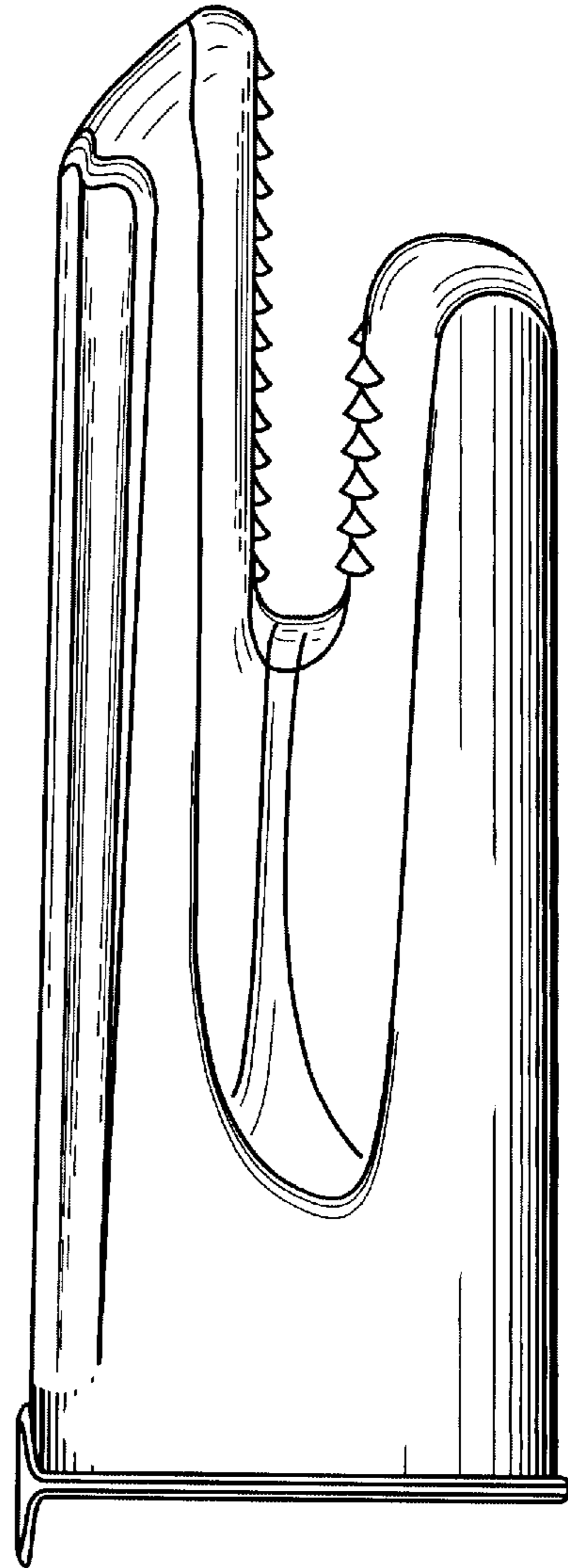

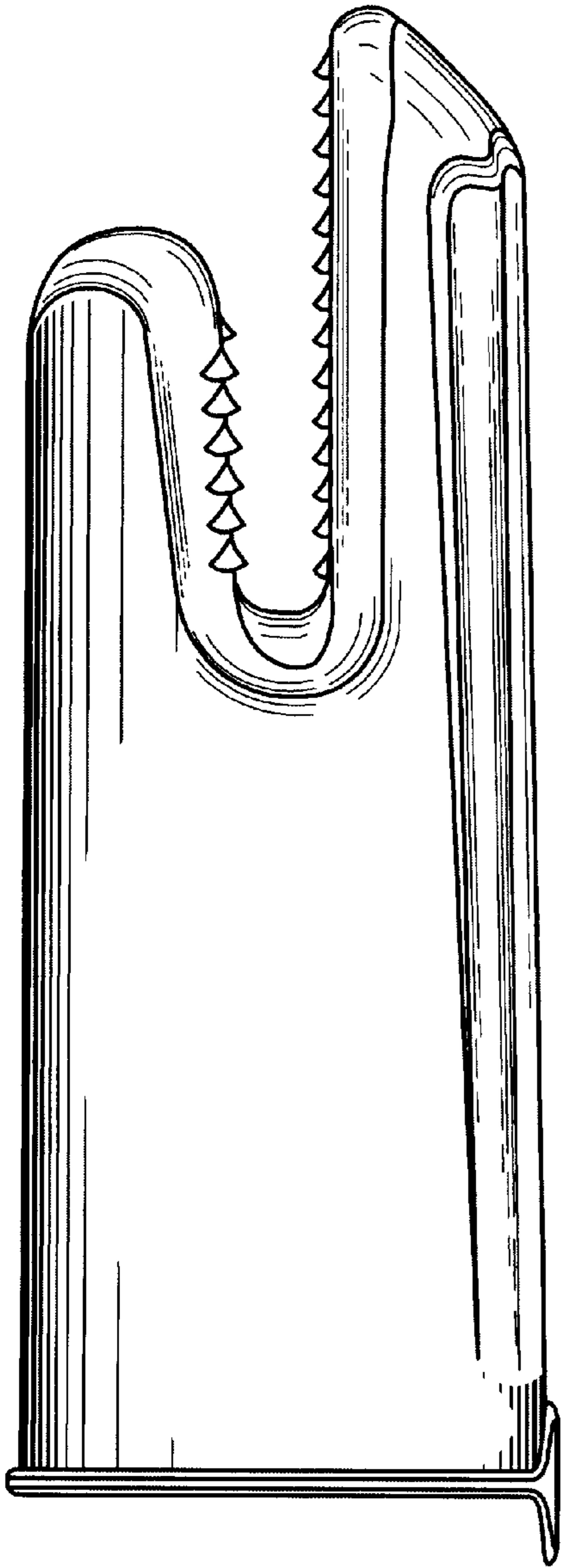

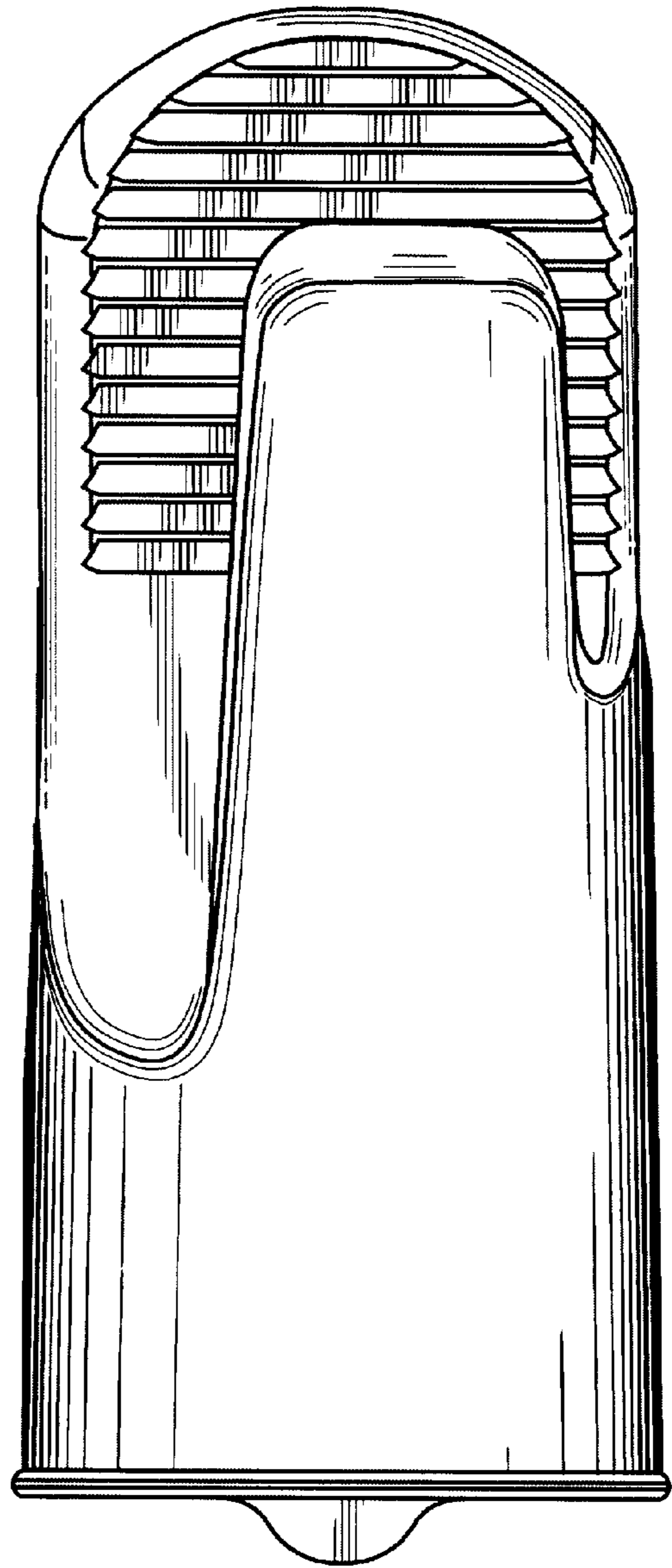

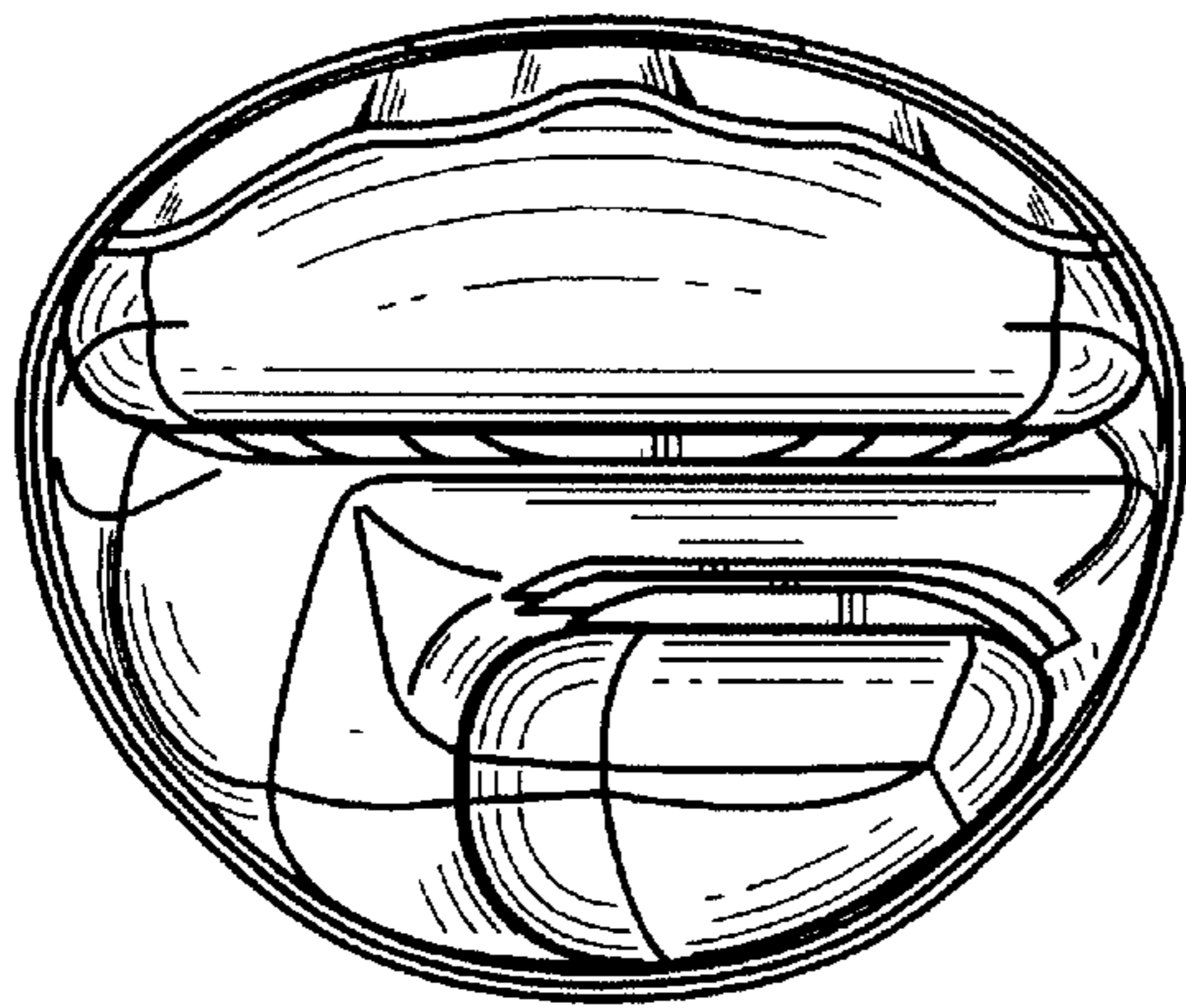
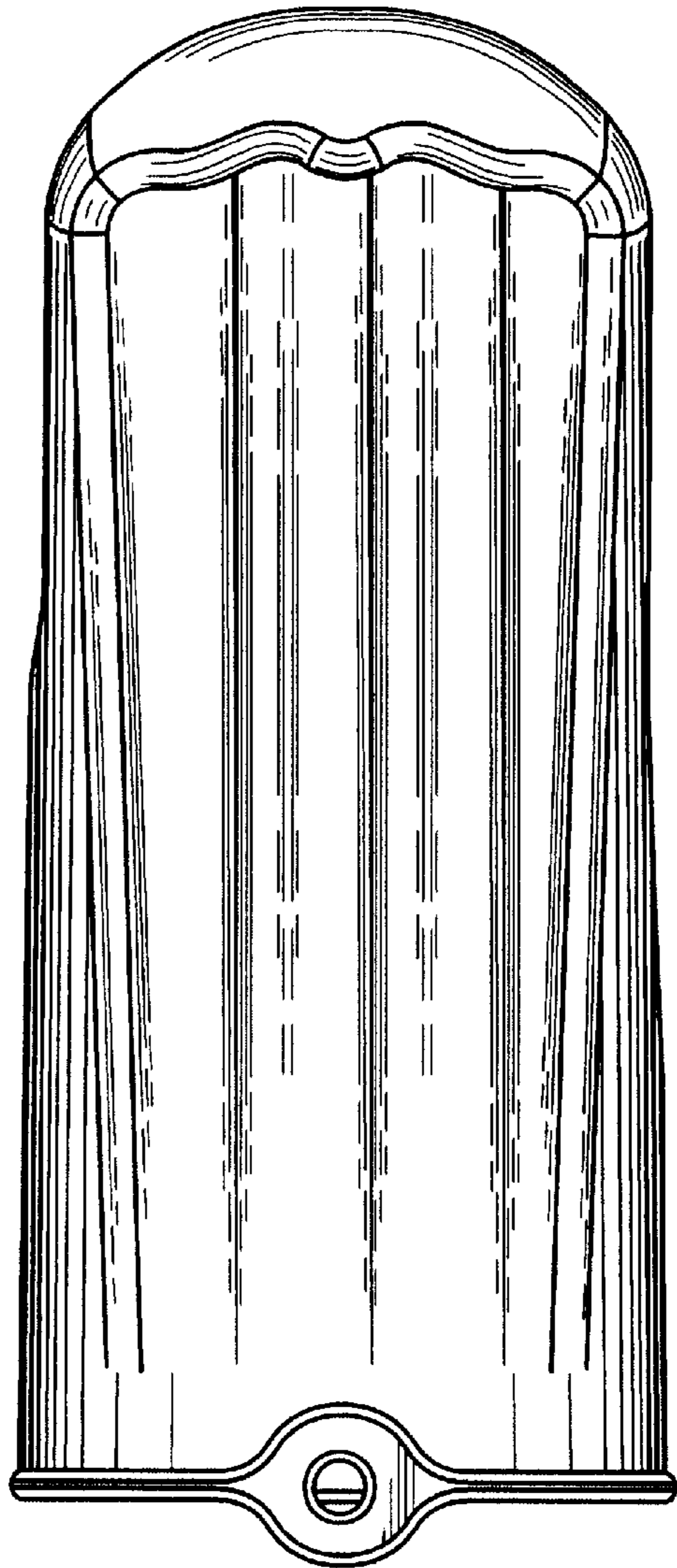
